DESCRIPTION

FIG. 1 is an upper perspective view of a shrimp deveiner design;

FIG. 8 is a lower perspective view of the deveiner design of FIG. 1.

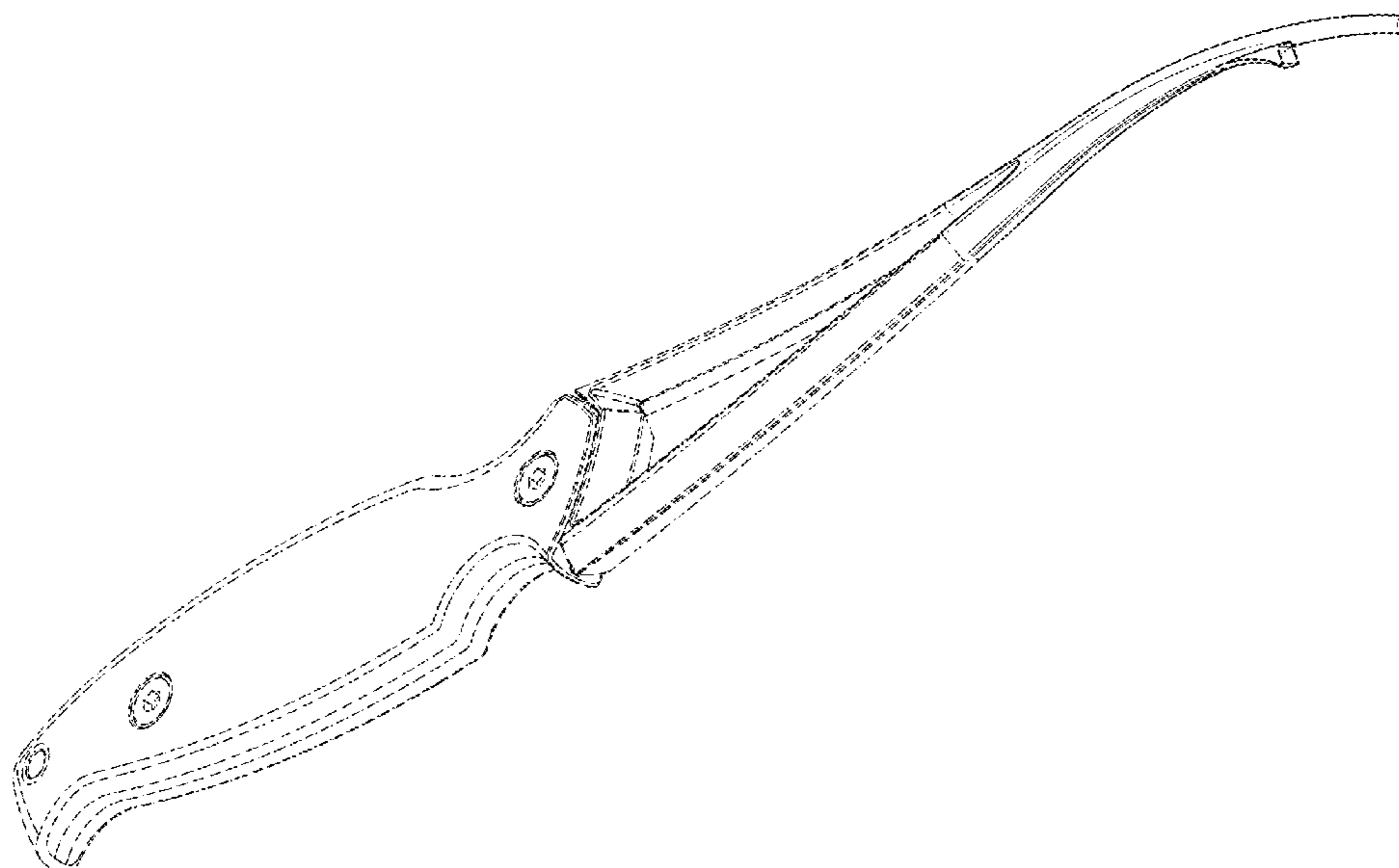
The broken line disclosure represents unclaimed portions of the deveiner in which the design is embodied.

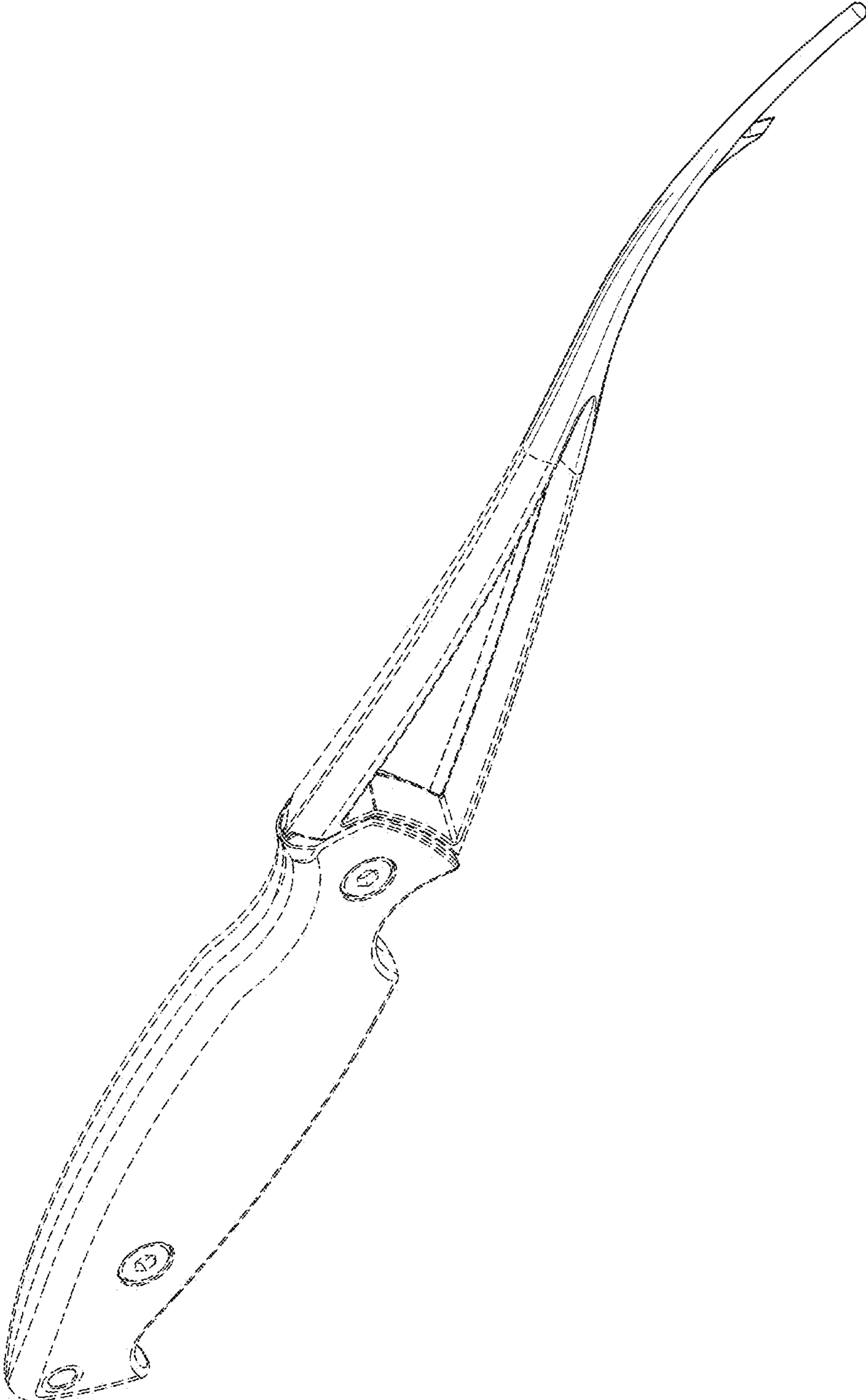

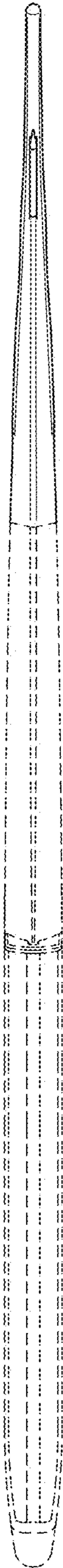

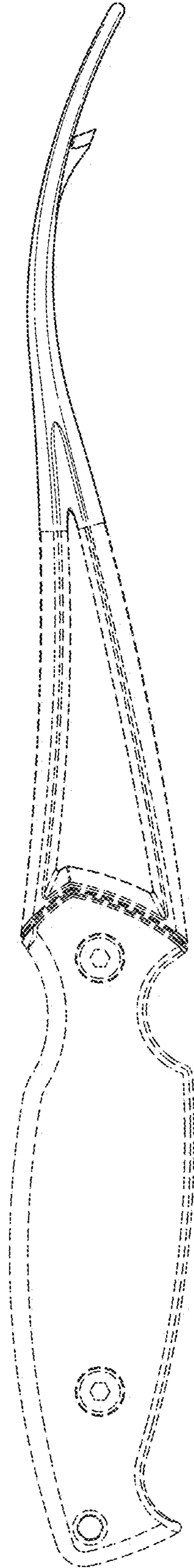

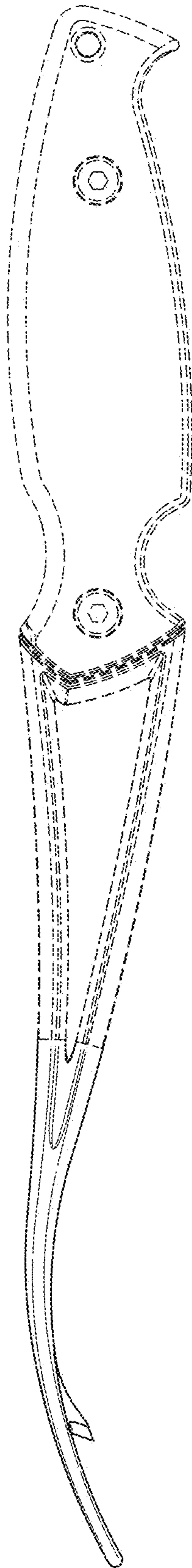

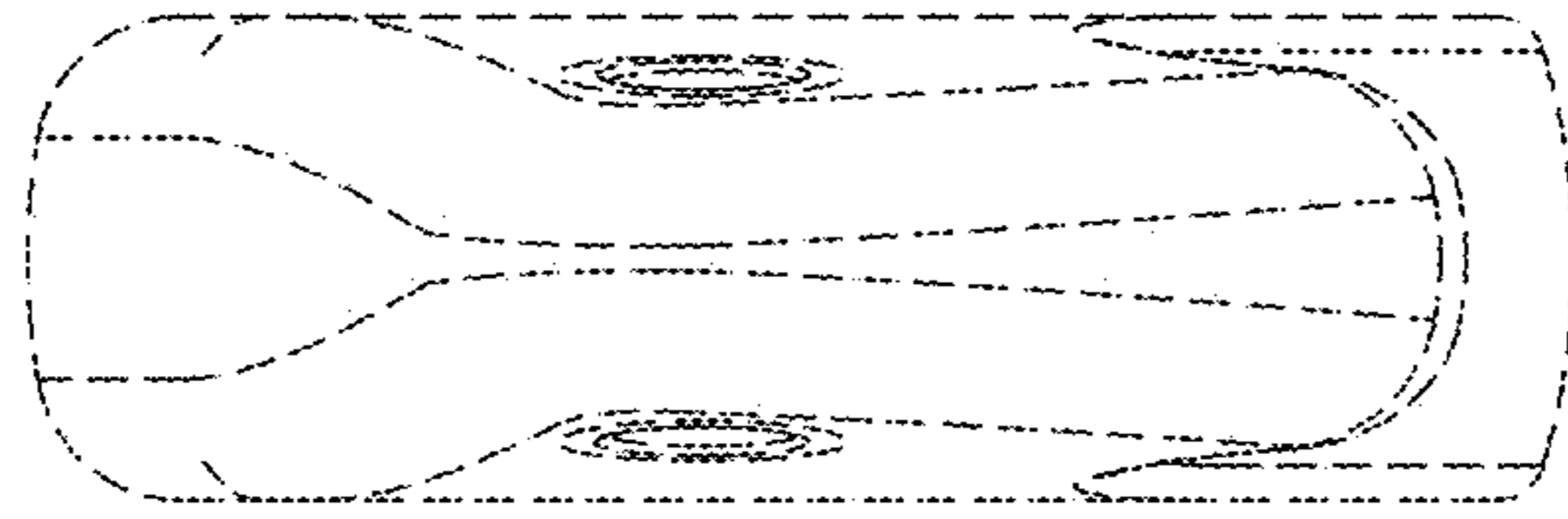

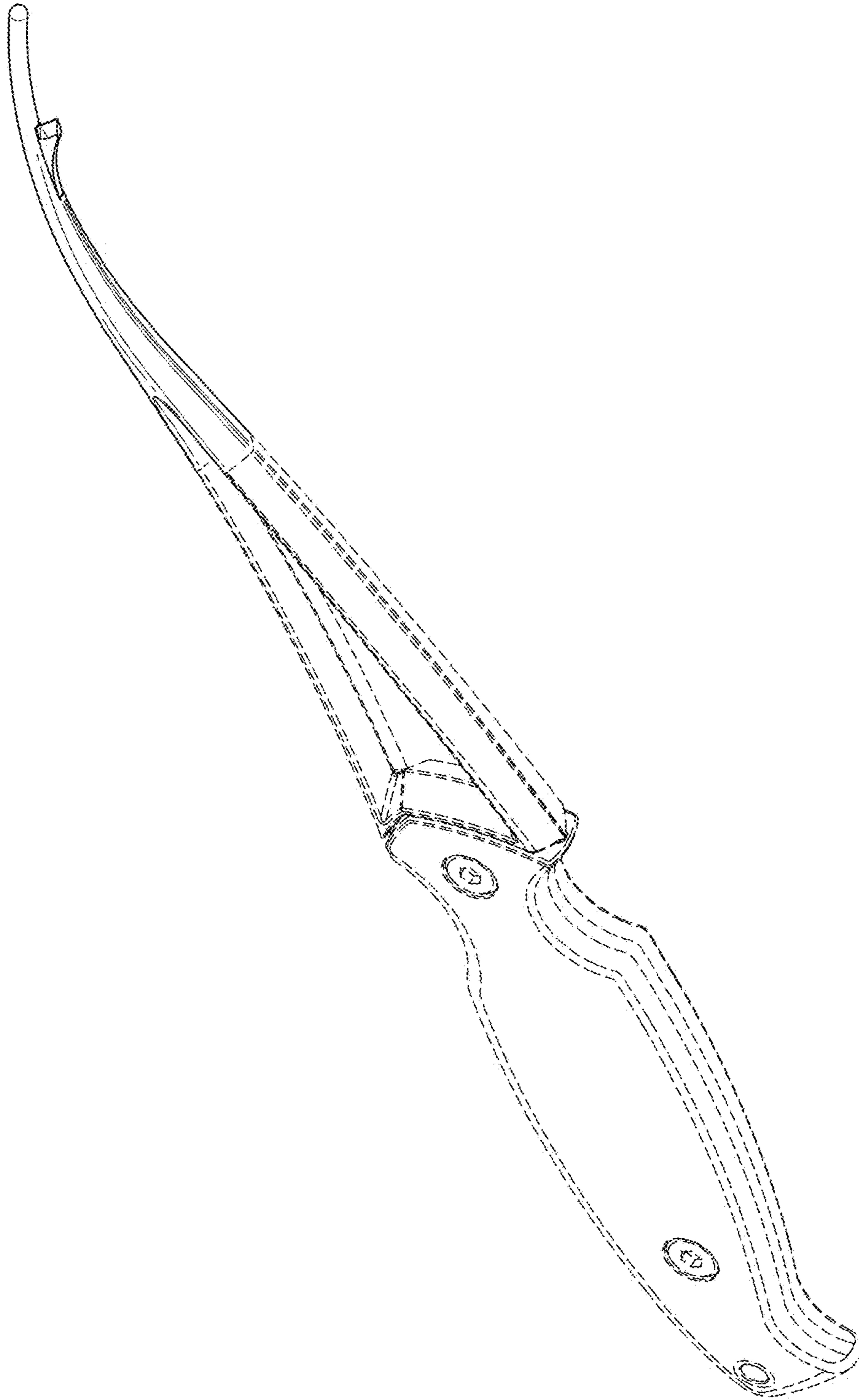
