FIG. 5 is a rear view thereof;

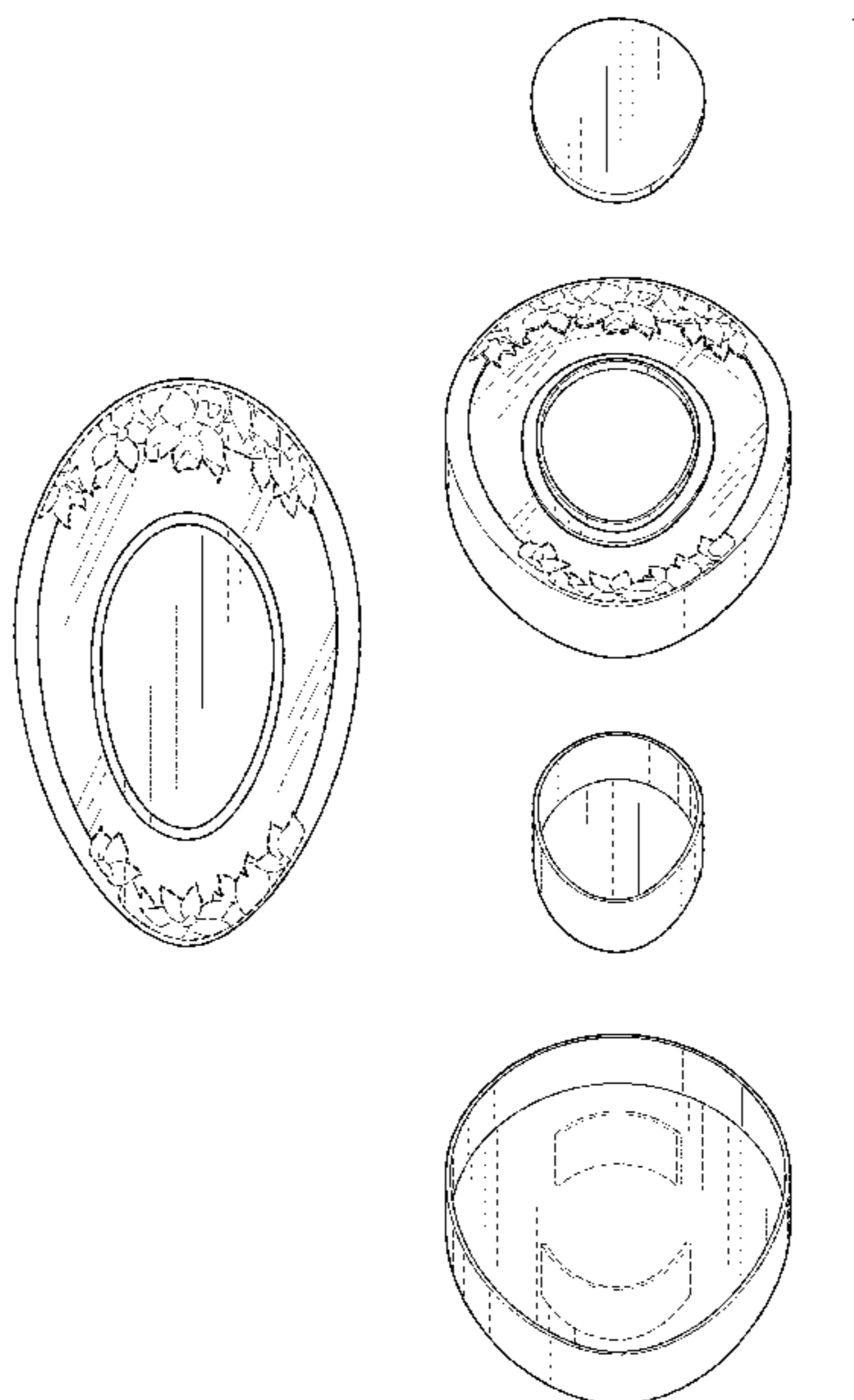
FIG. 6 is a side view thereof;

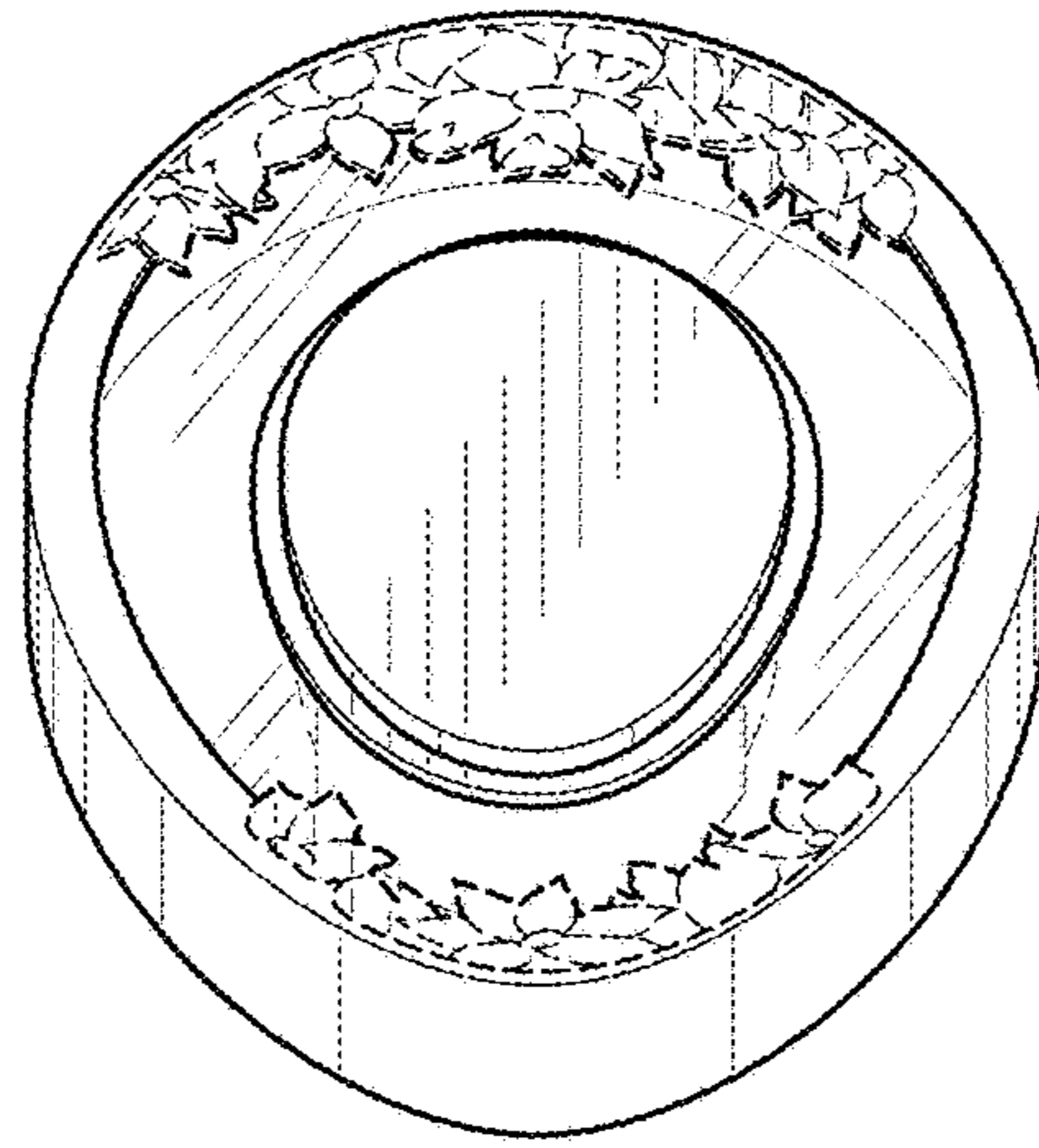

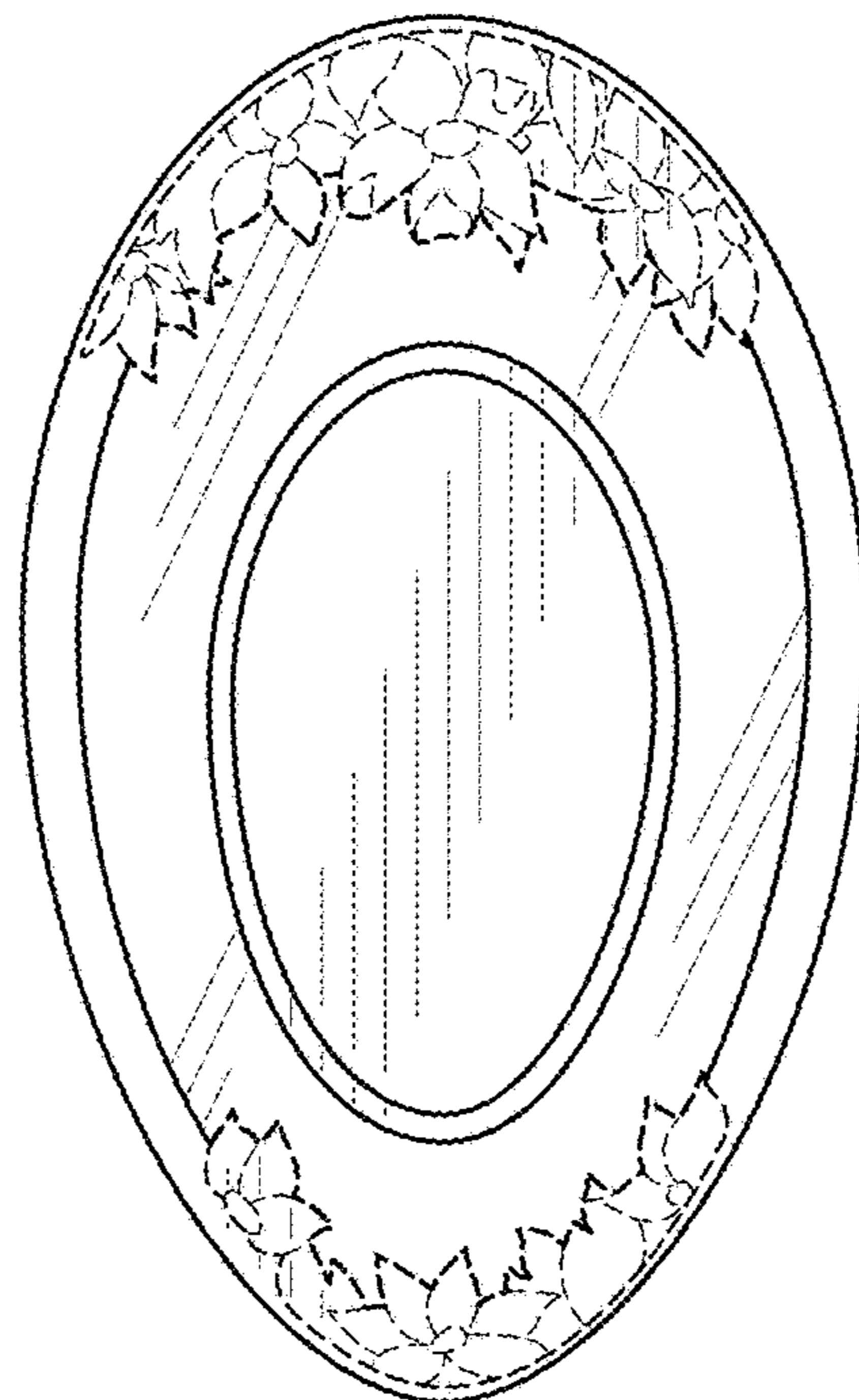

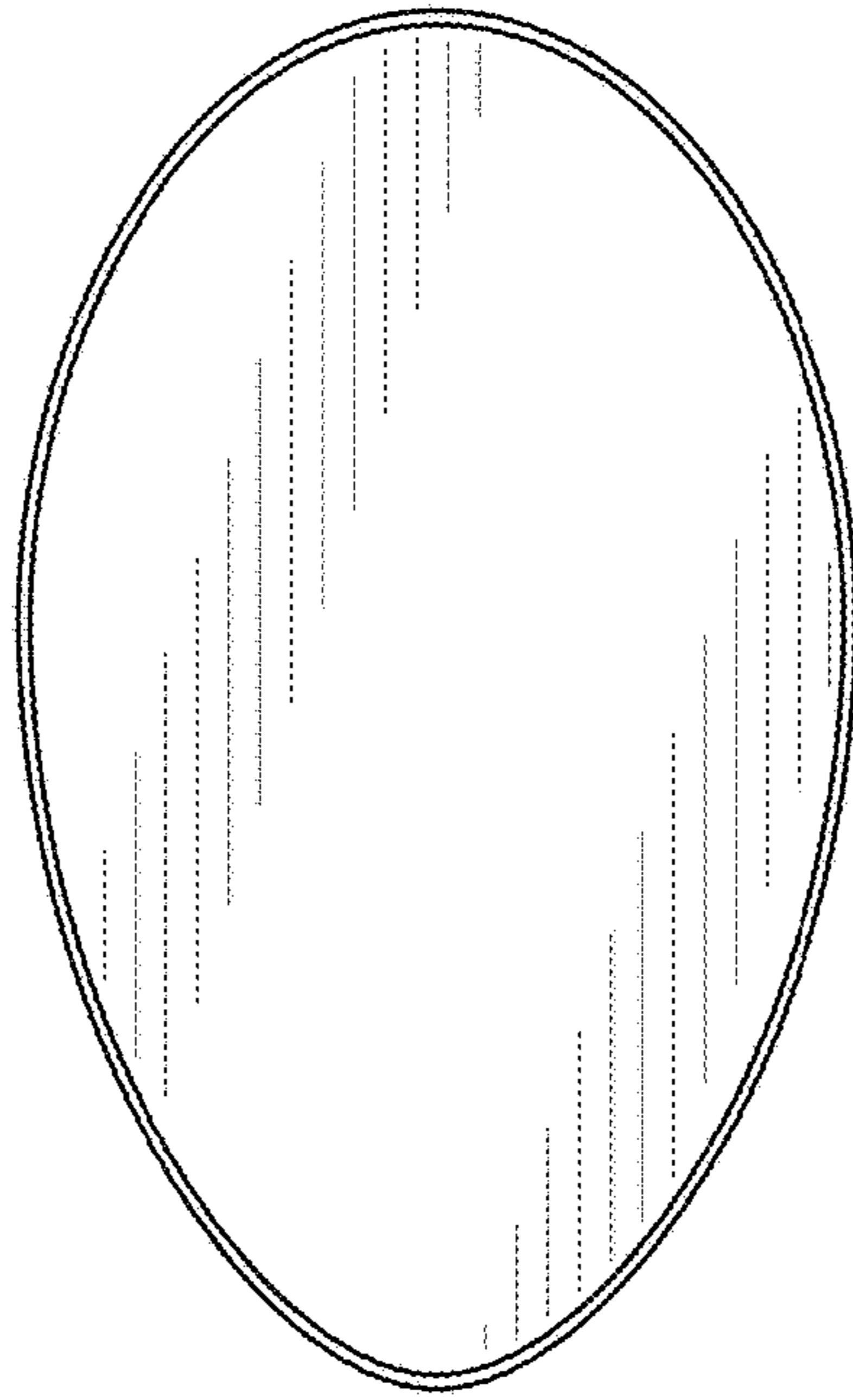

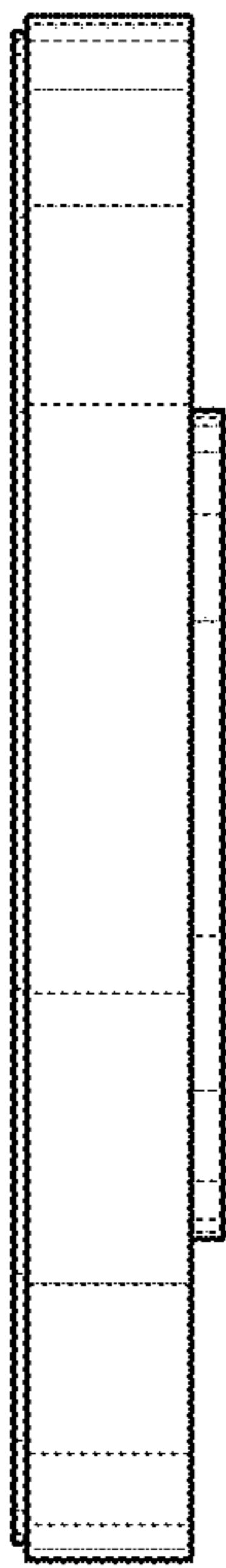

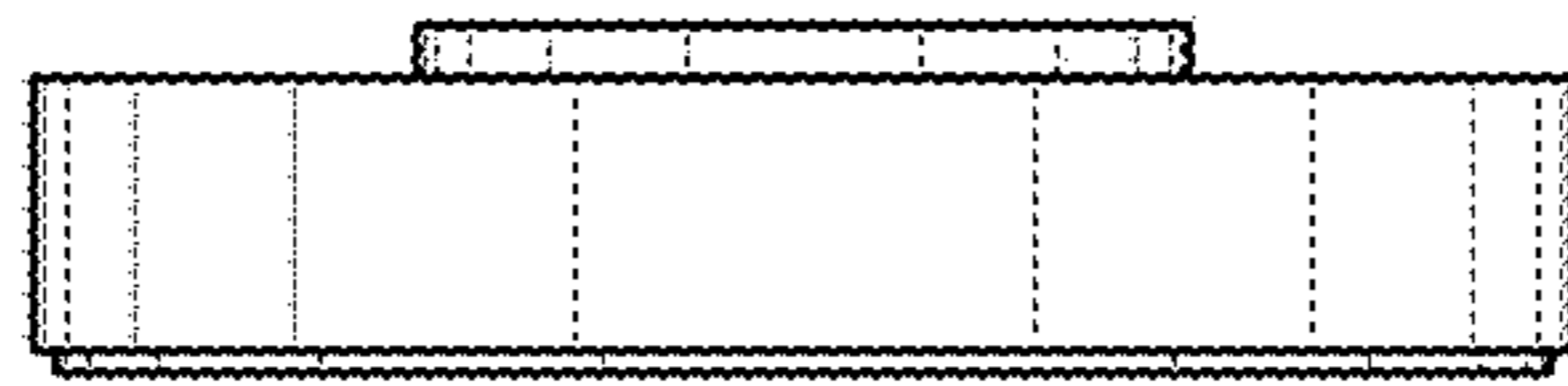

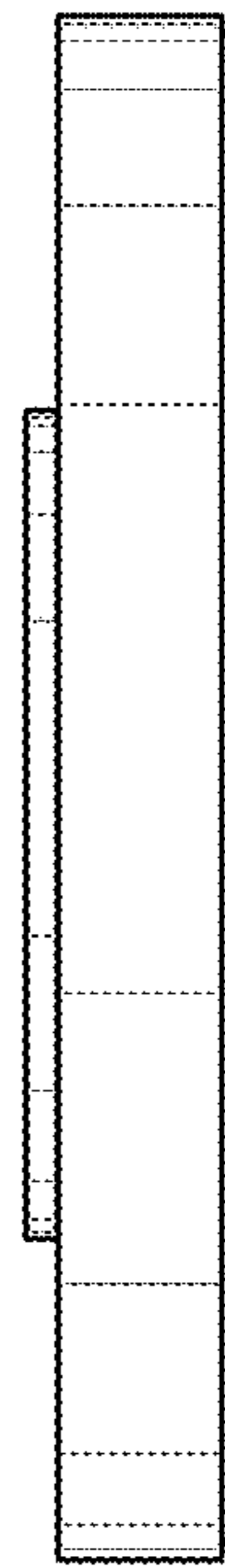

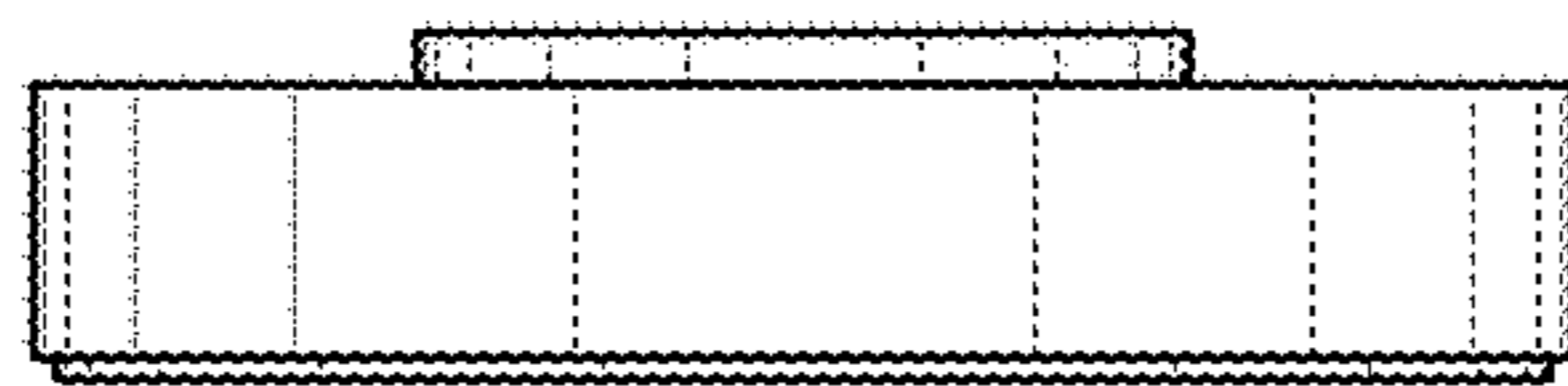
