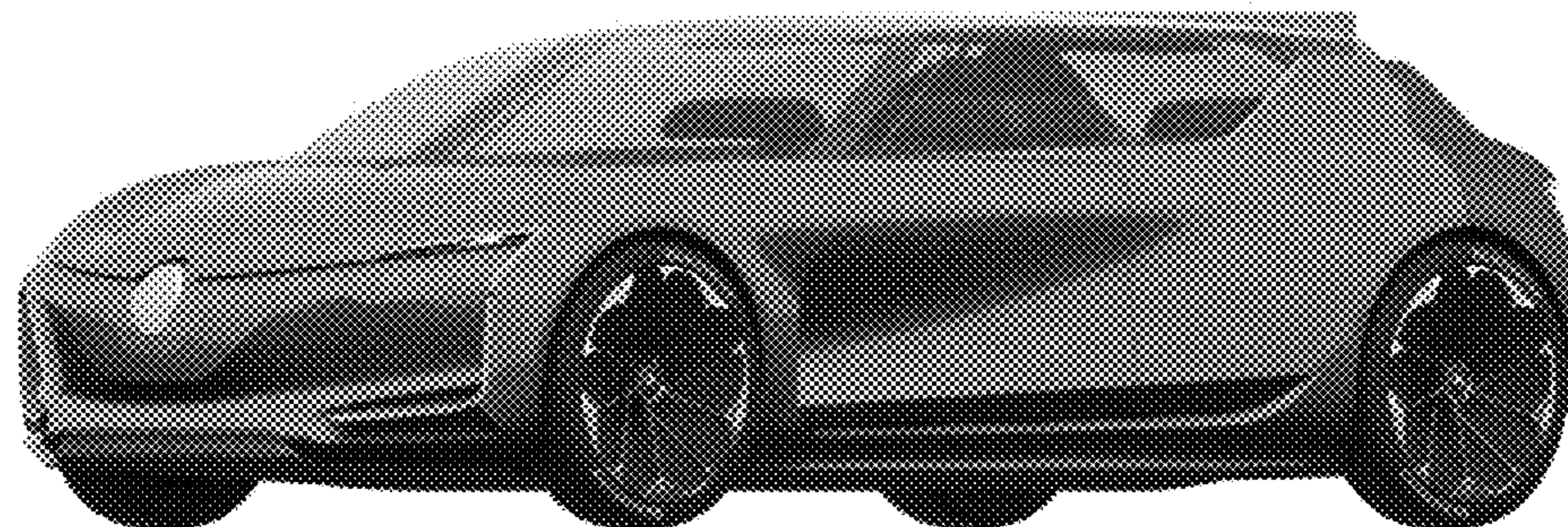
1. Motor vehicle

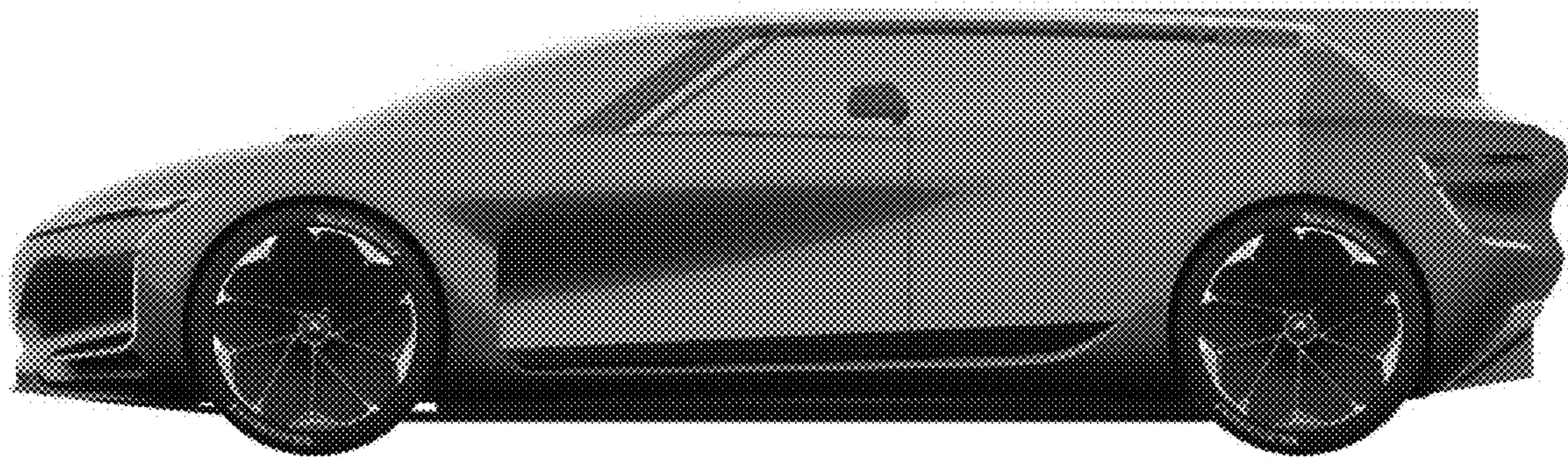

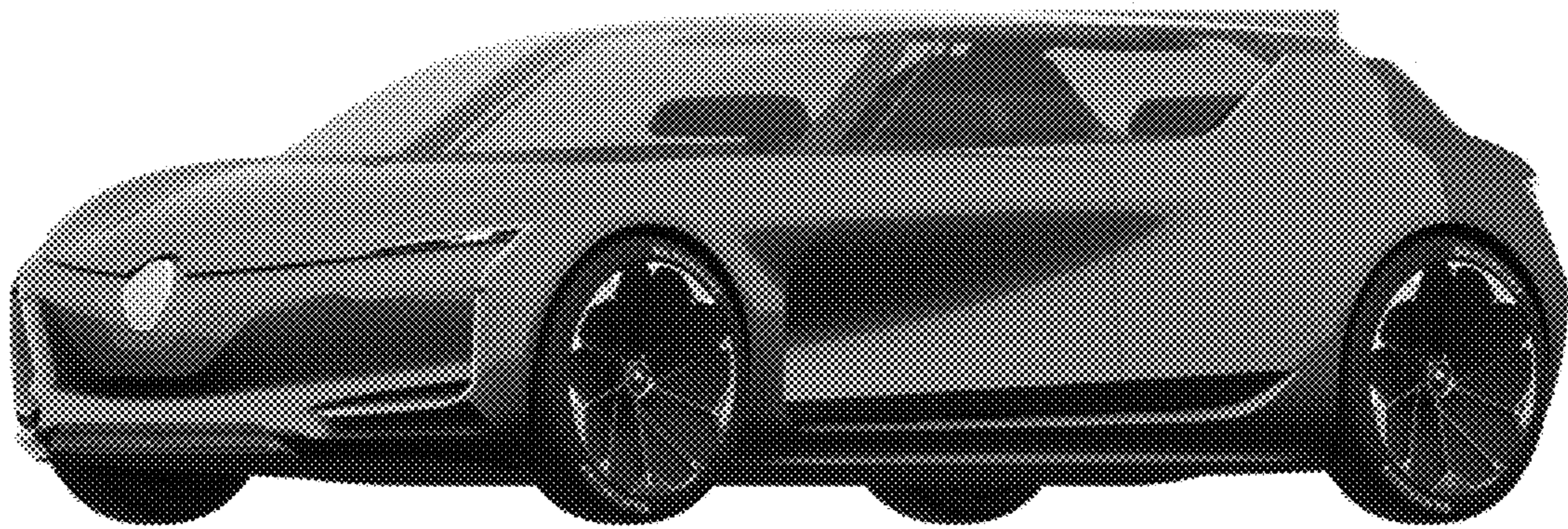

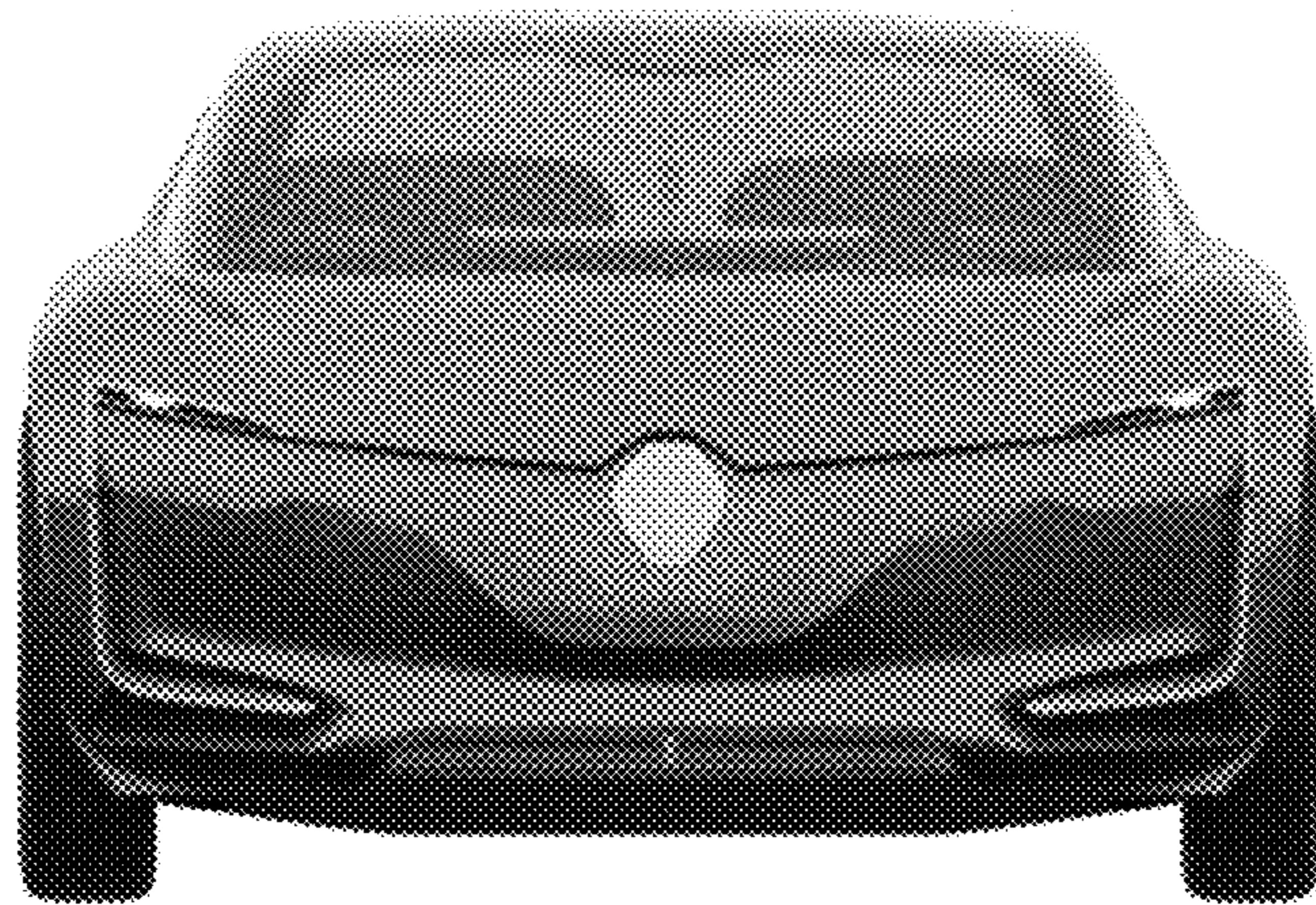

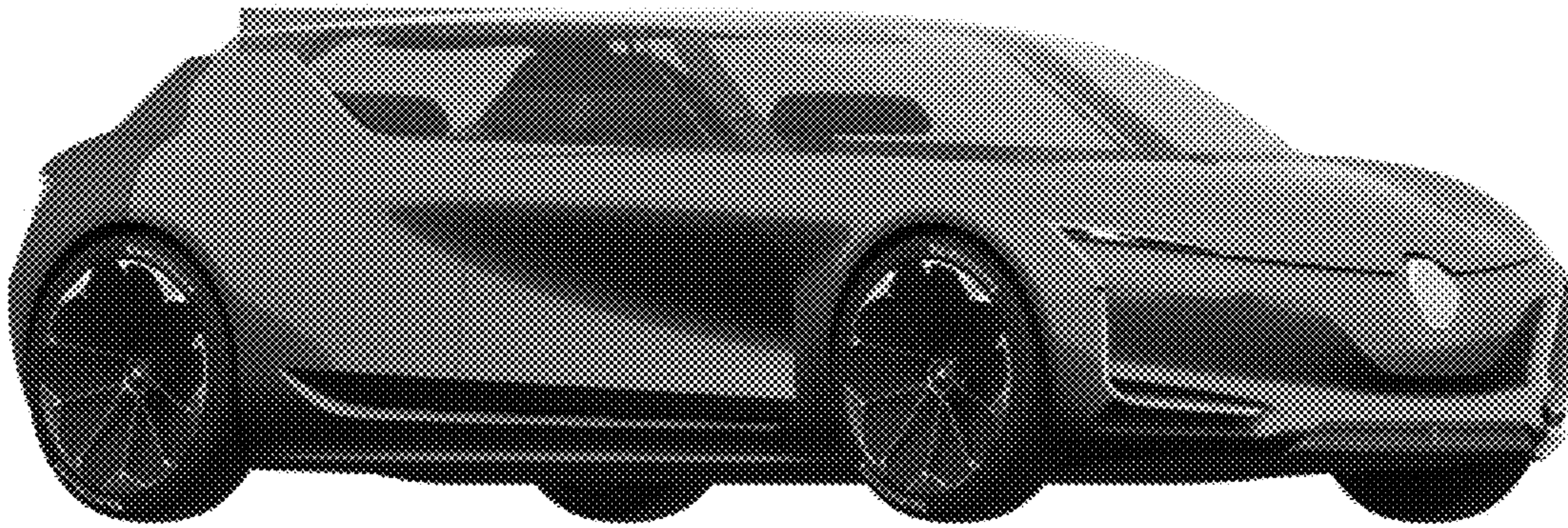

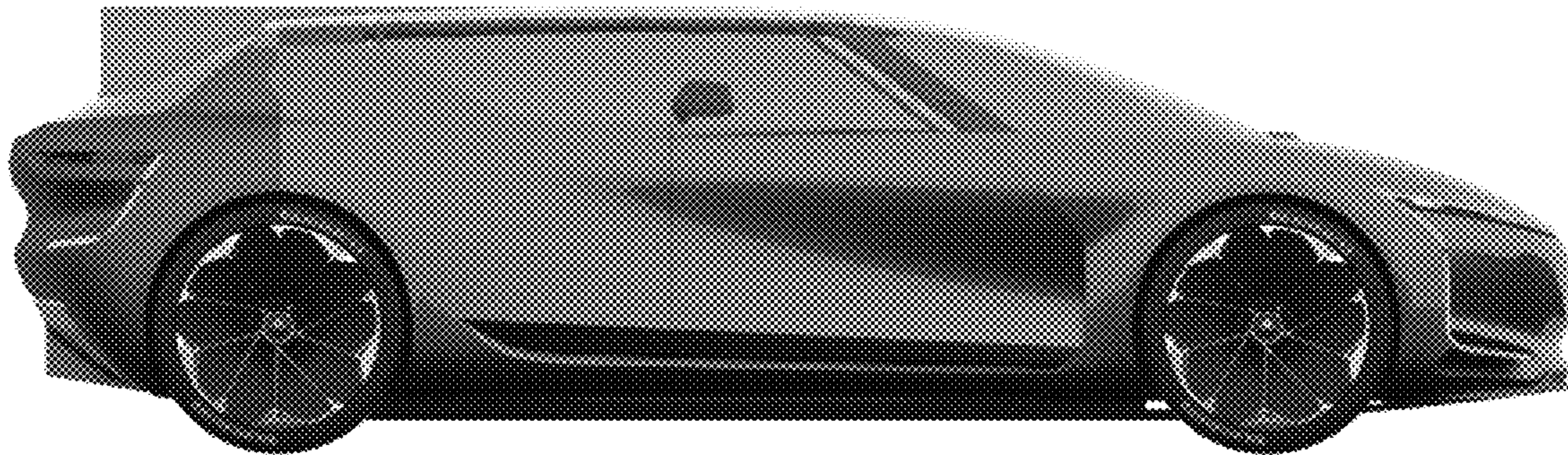

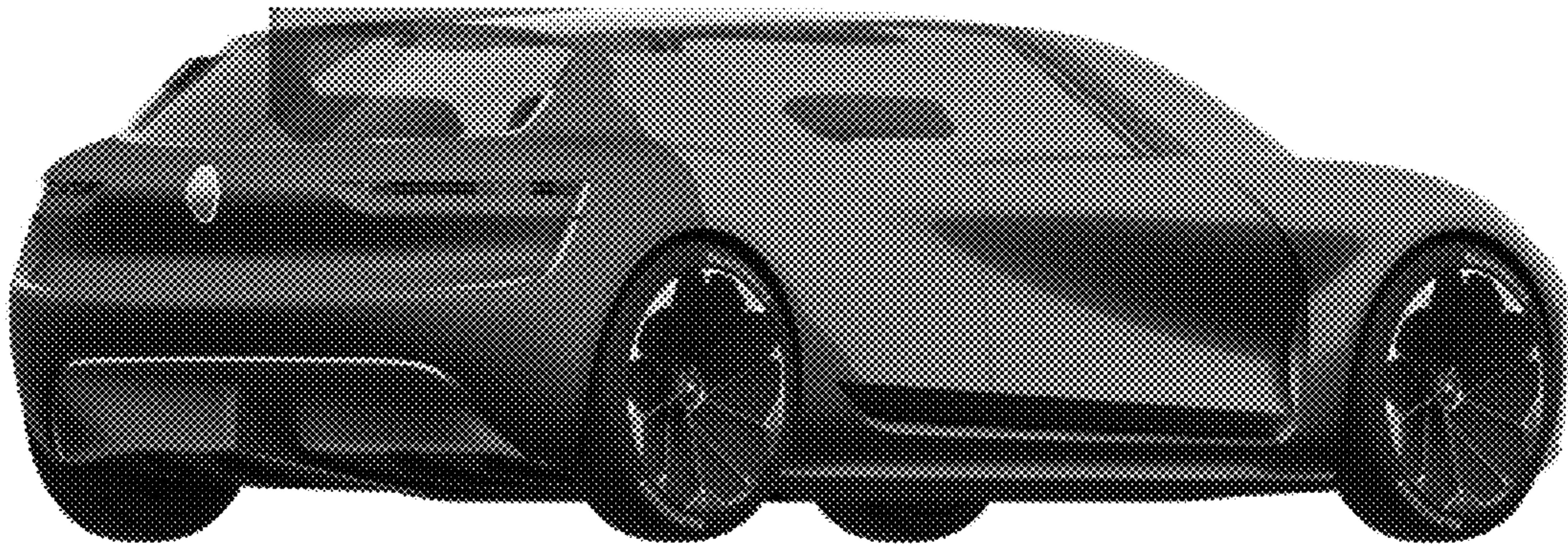

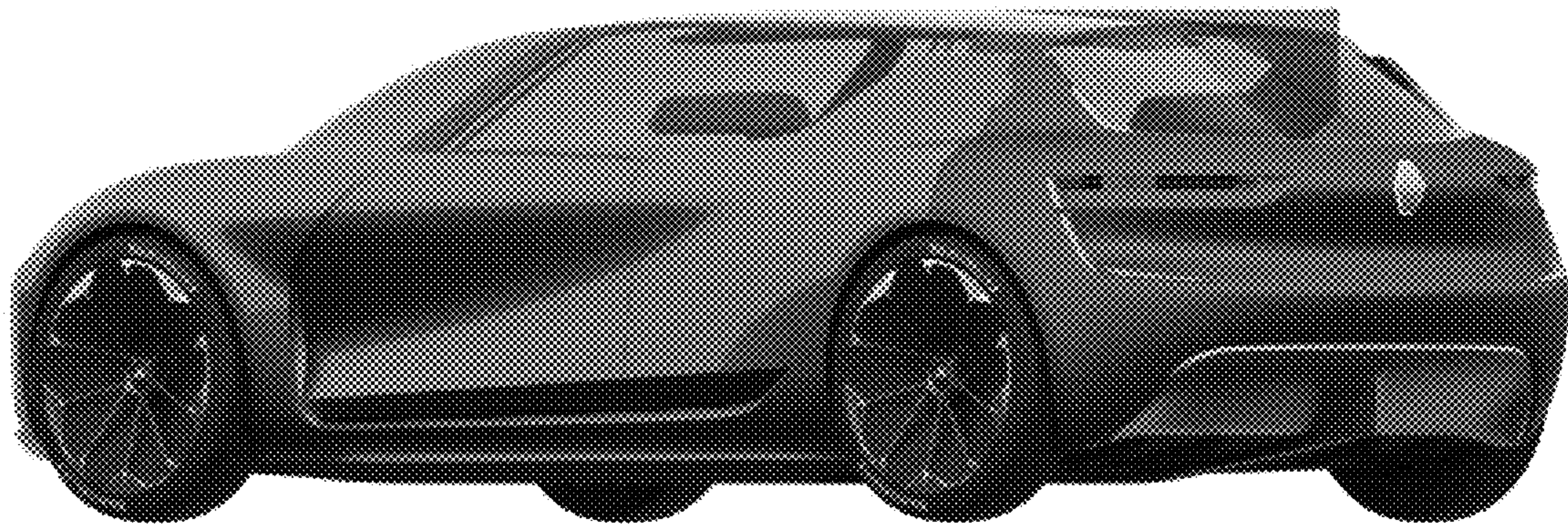

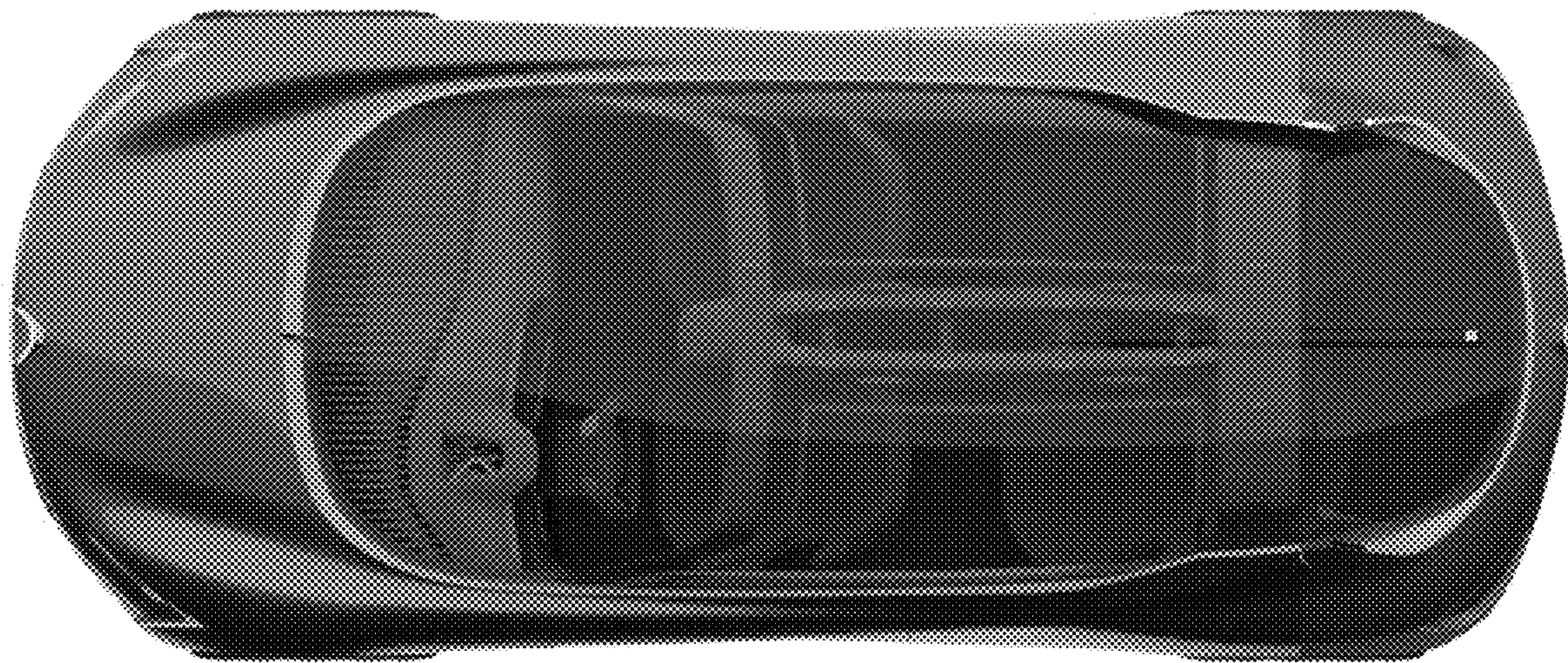
