(57) **CLAIM**

The ornamental design for a tire tread, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the tire tread showing my design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a first side view thereof;

FIG. 5 is a second side view thereof;

FIG. 6 is a close up view of a portion thereof in the rectangular area 6 in FIG. 11;

FIG. 7 is a sectional view taken along line 7-7 in FIG. 10;

FIG. 8 is a sectional view taken along line 8-8 in FIG. 10;

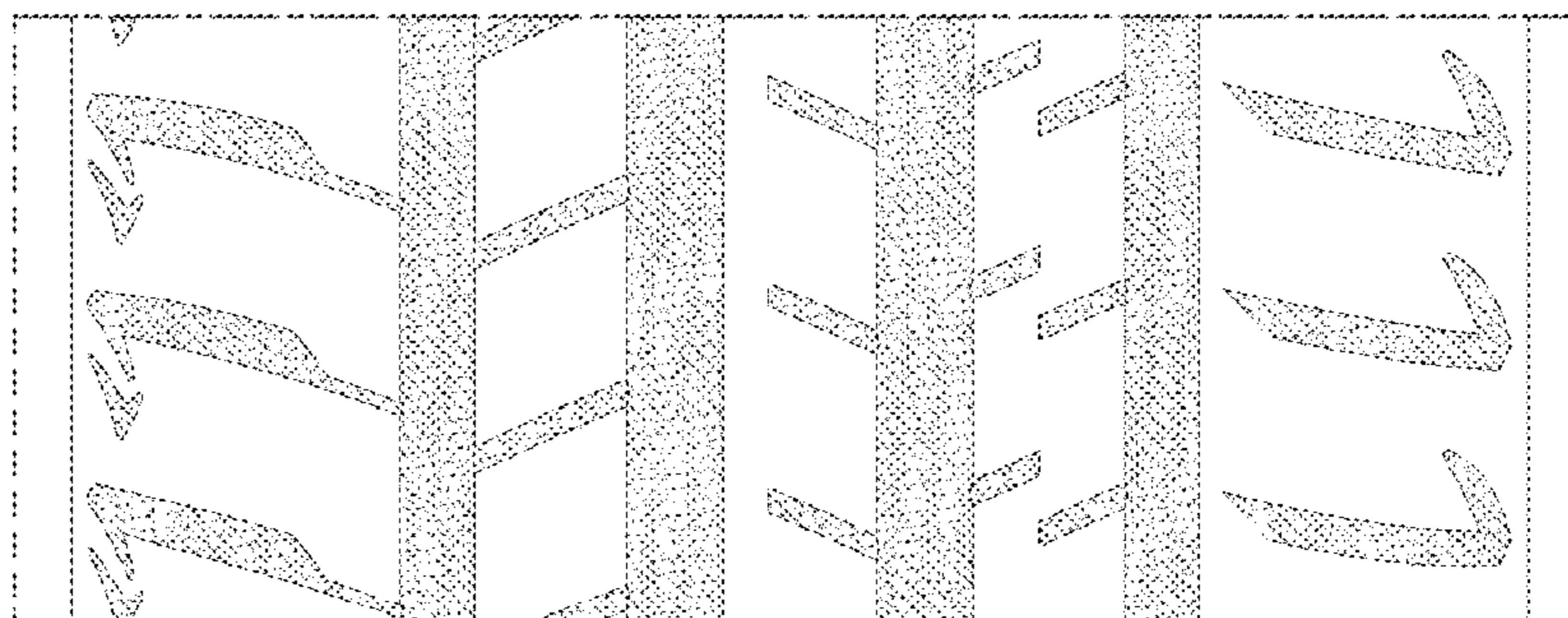
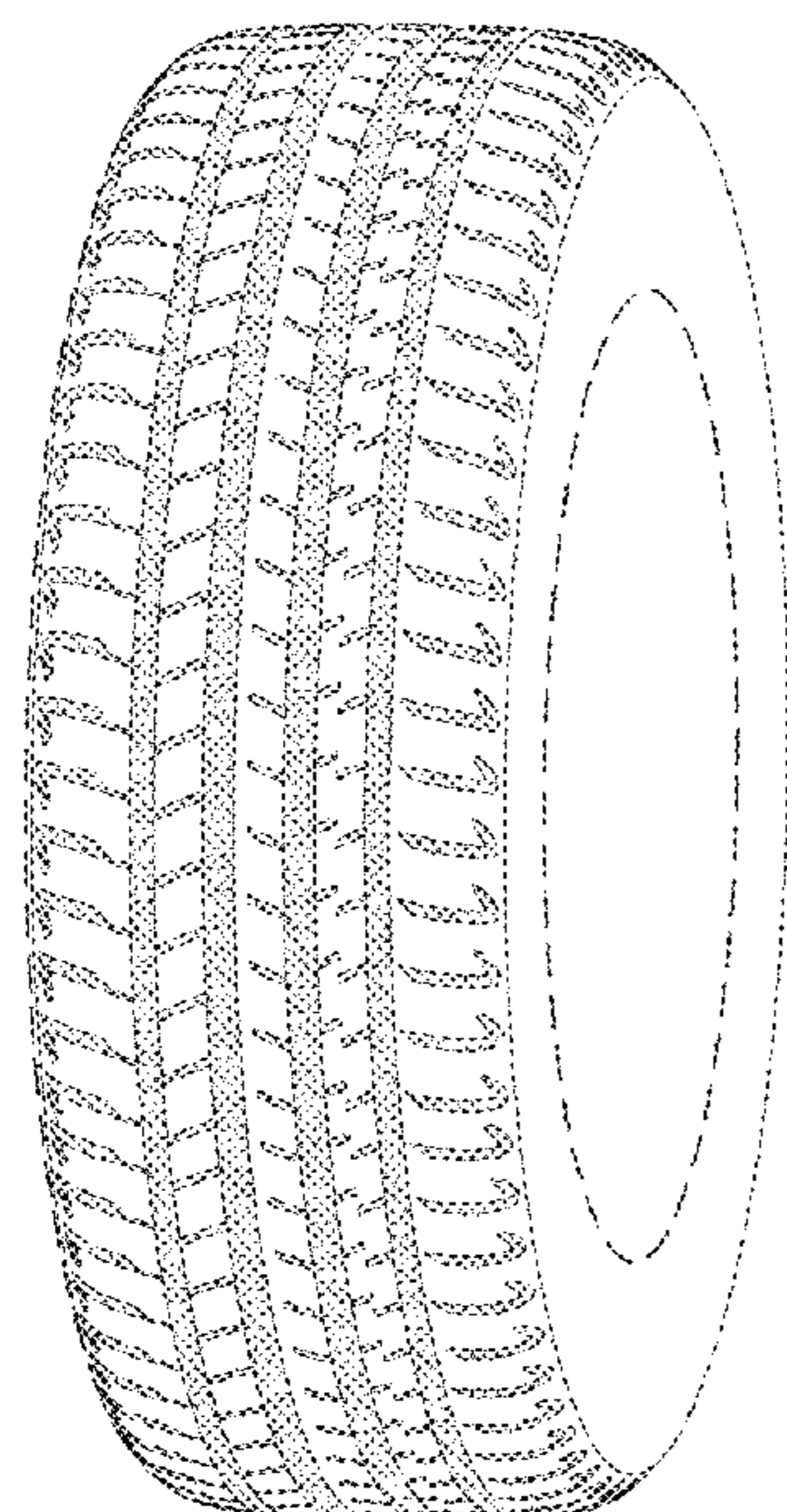
FIG. 9 is a sectional view taken along line 9-9 in FIG. 10;

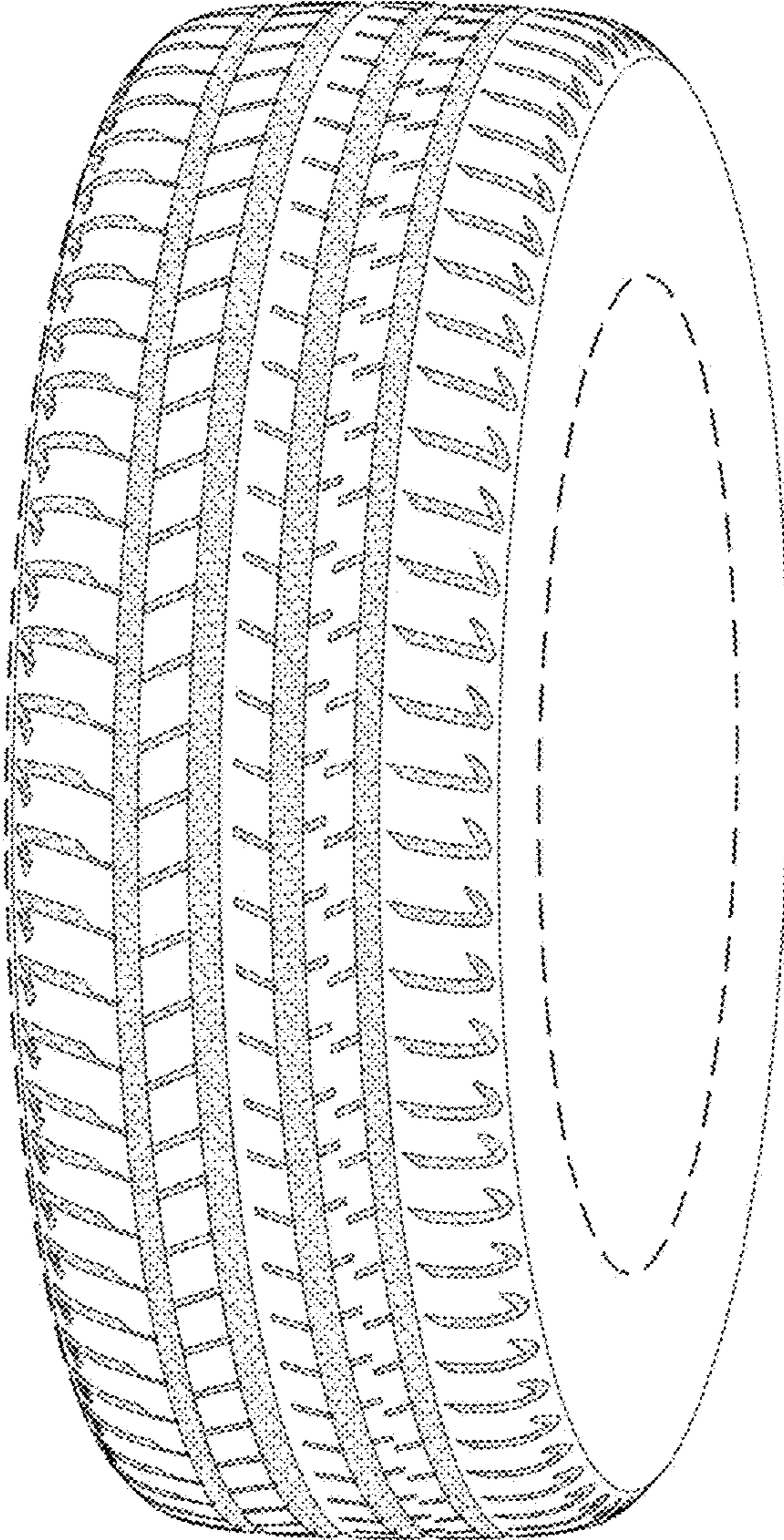

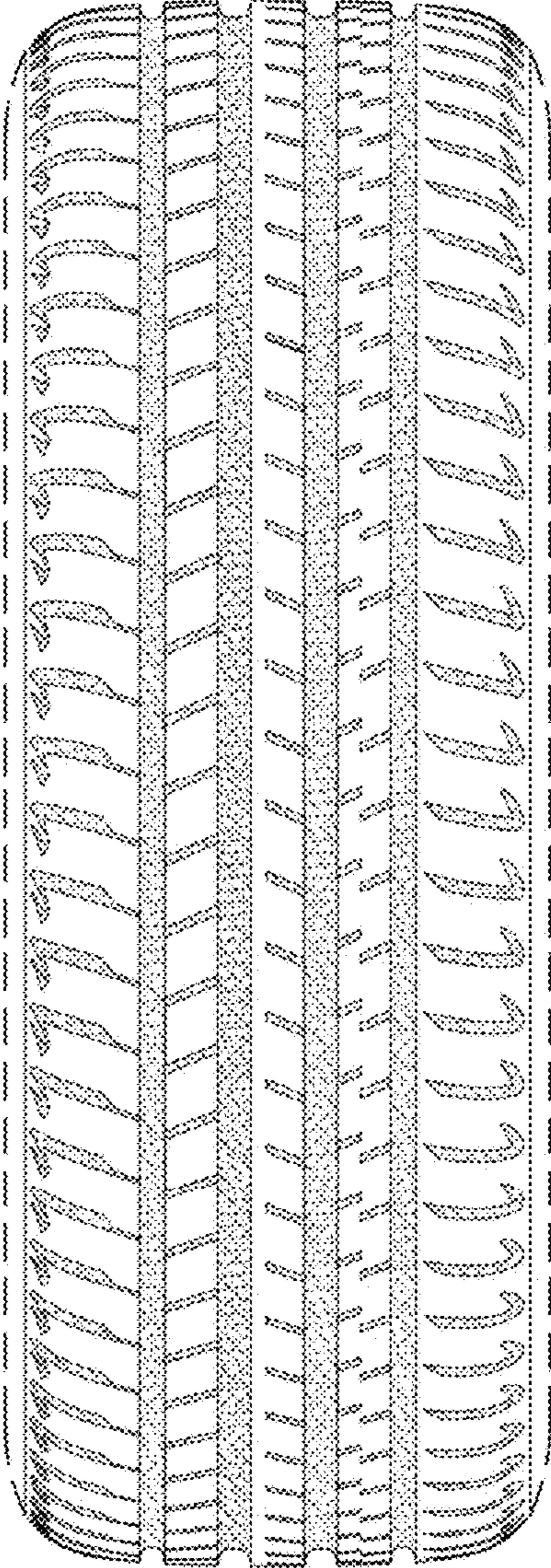

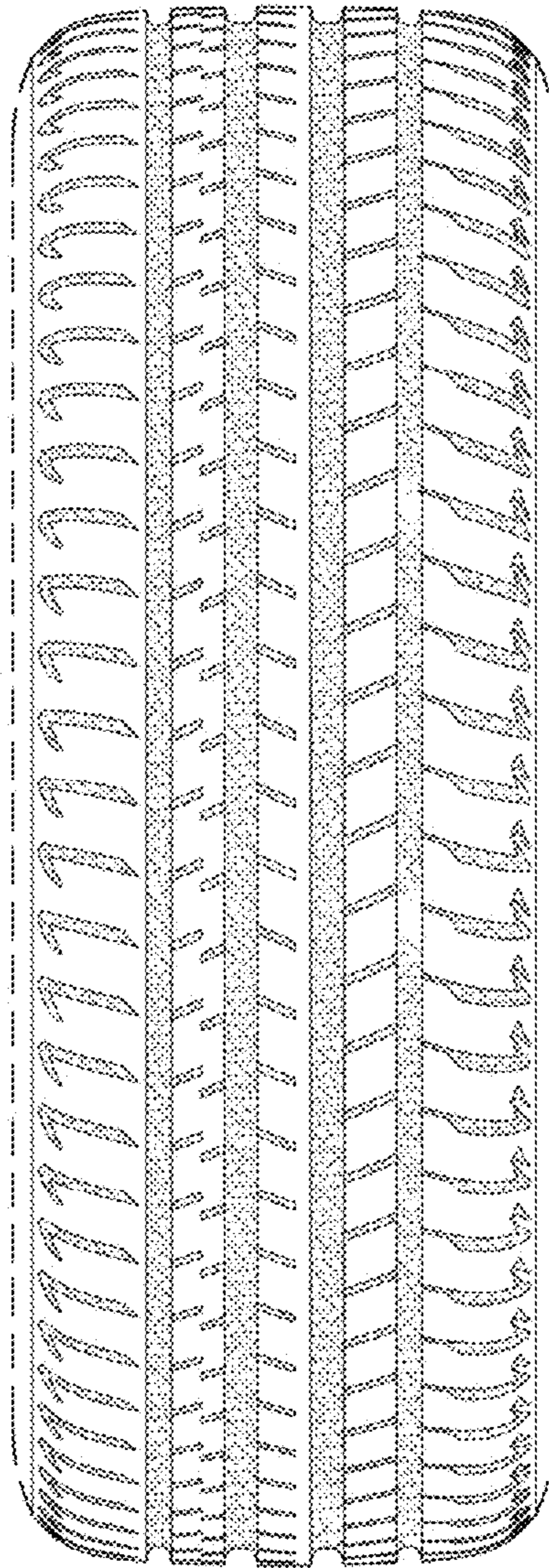

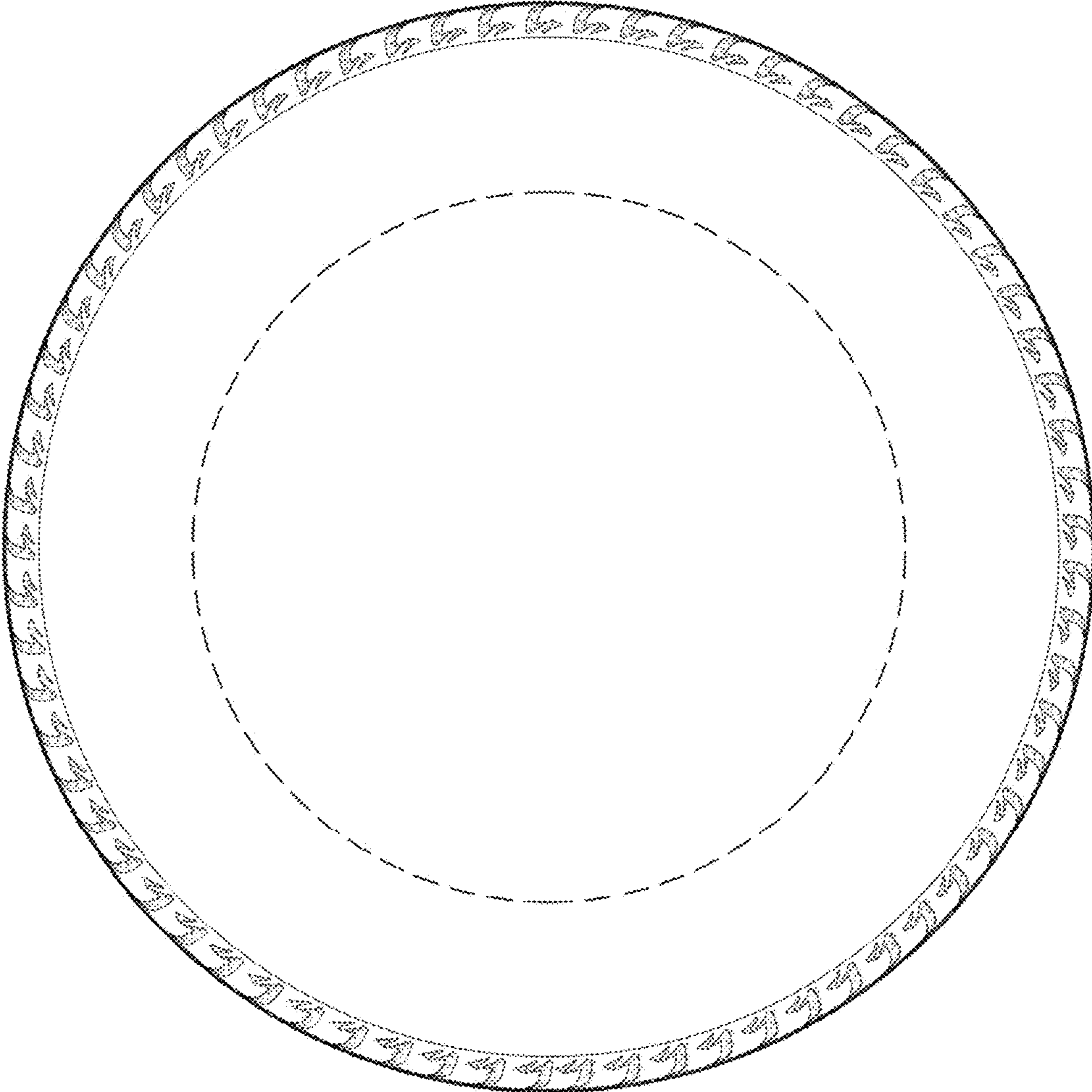

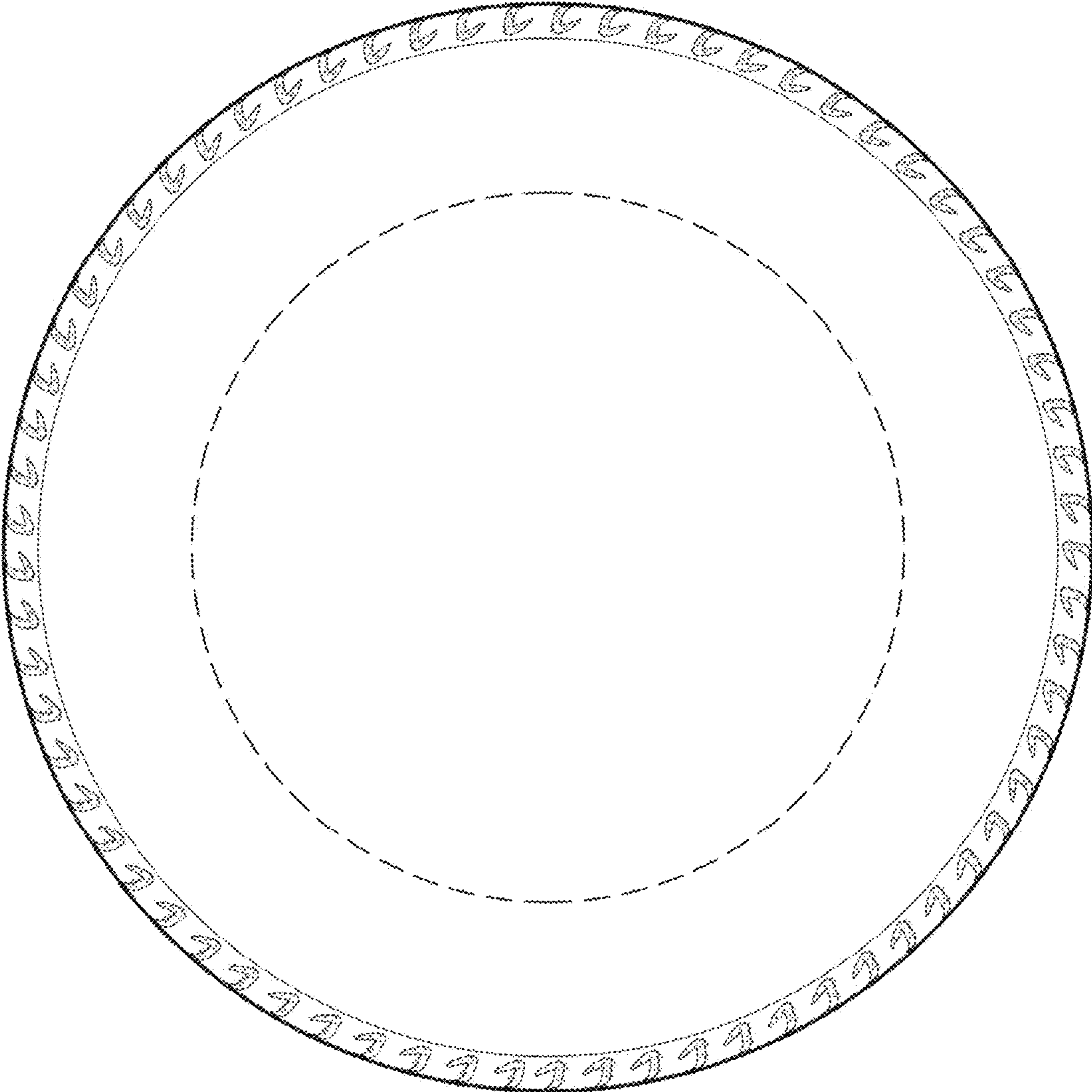

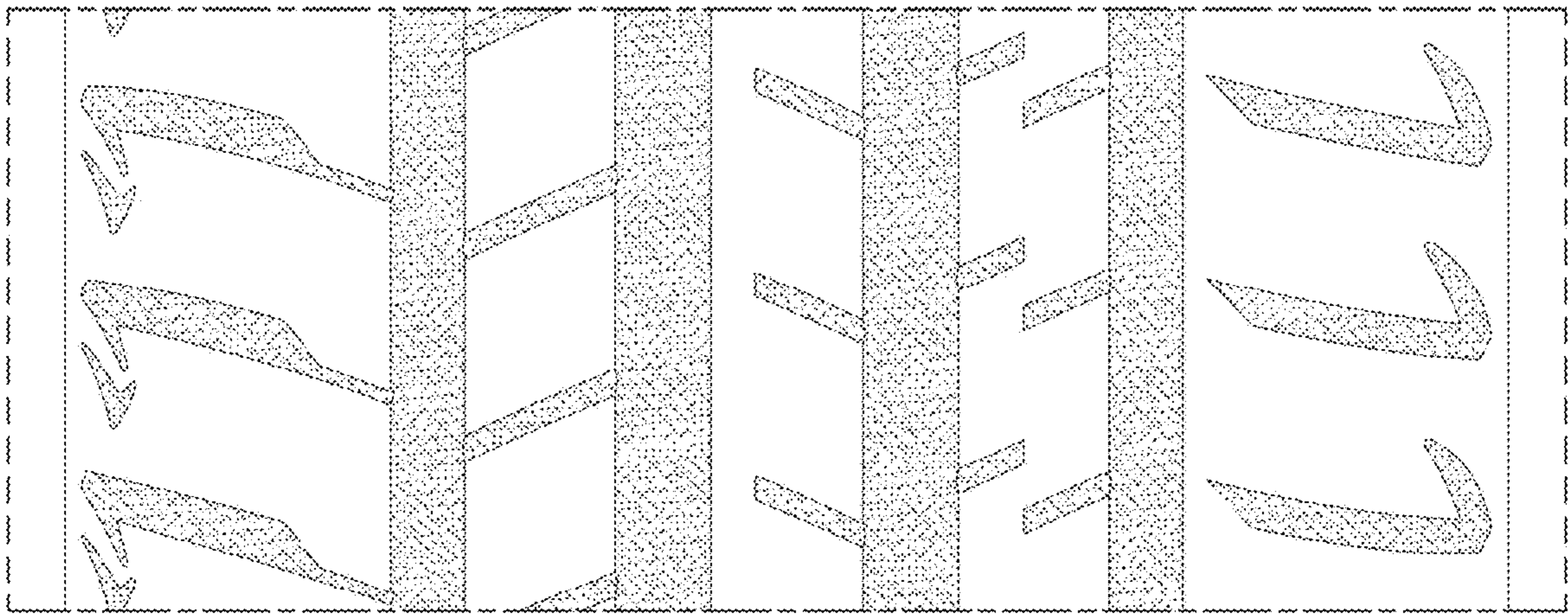

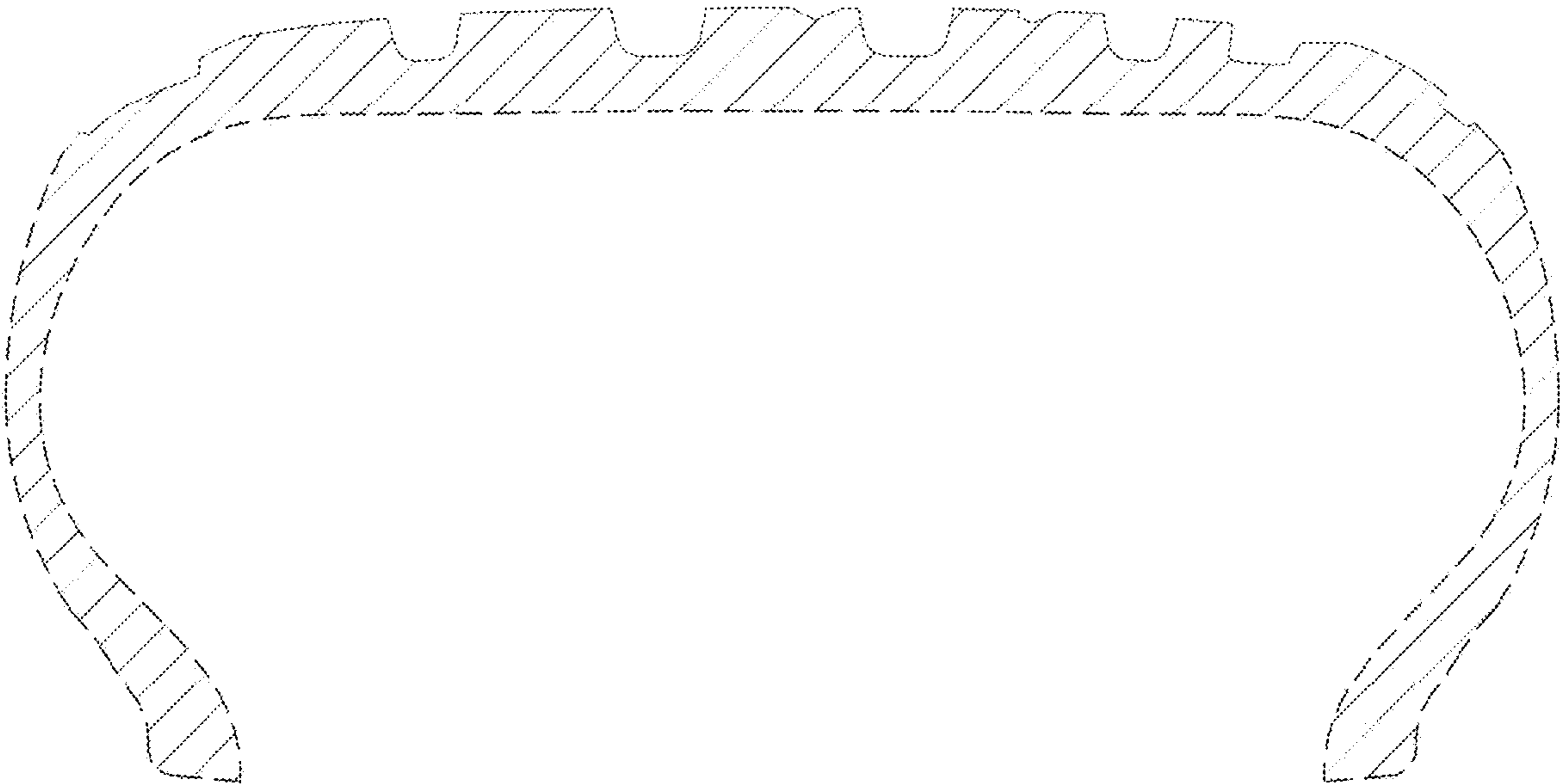

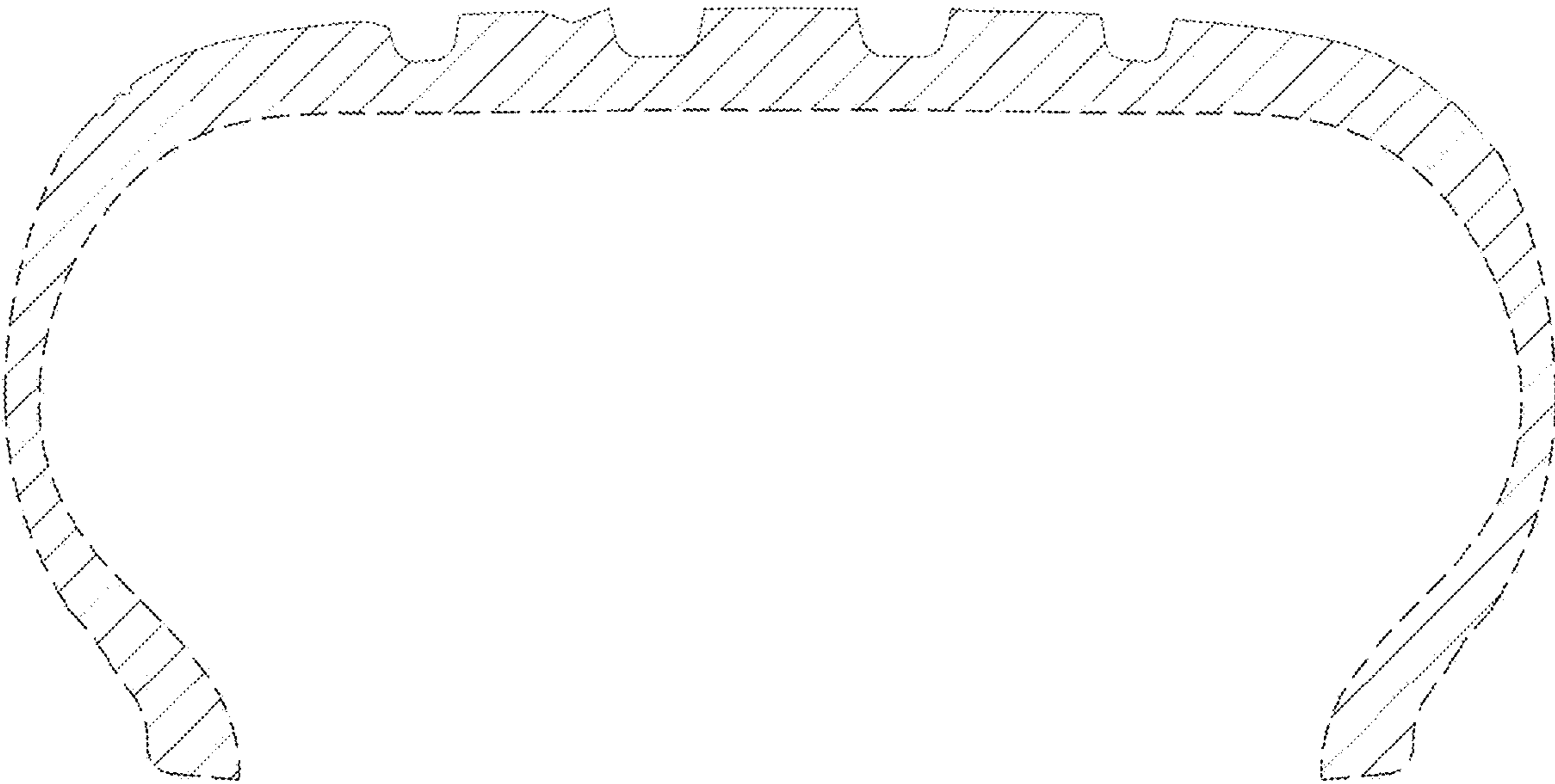

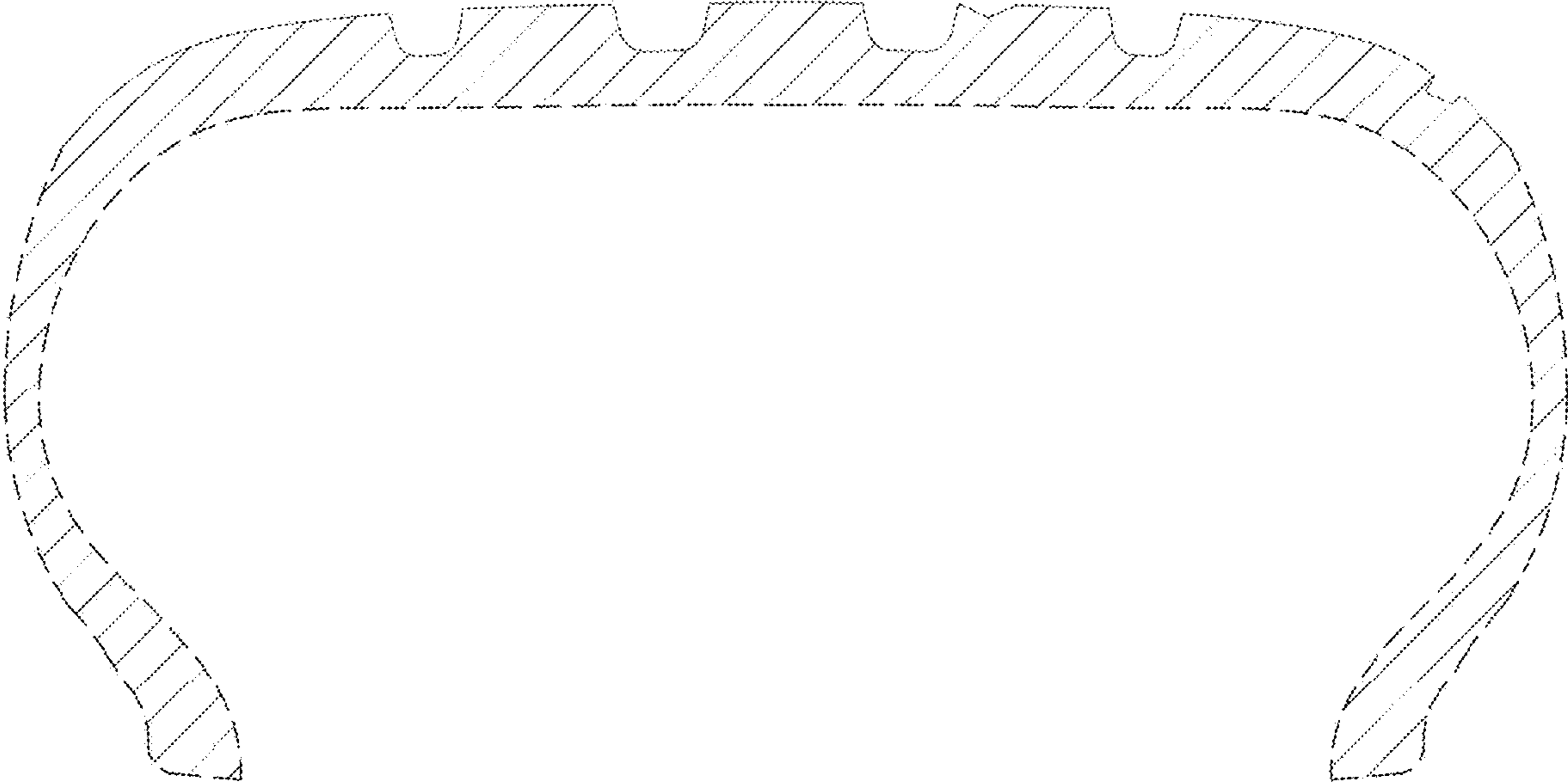

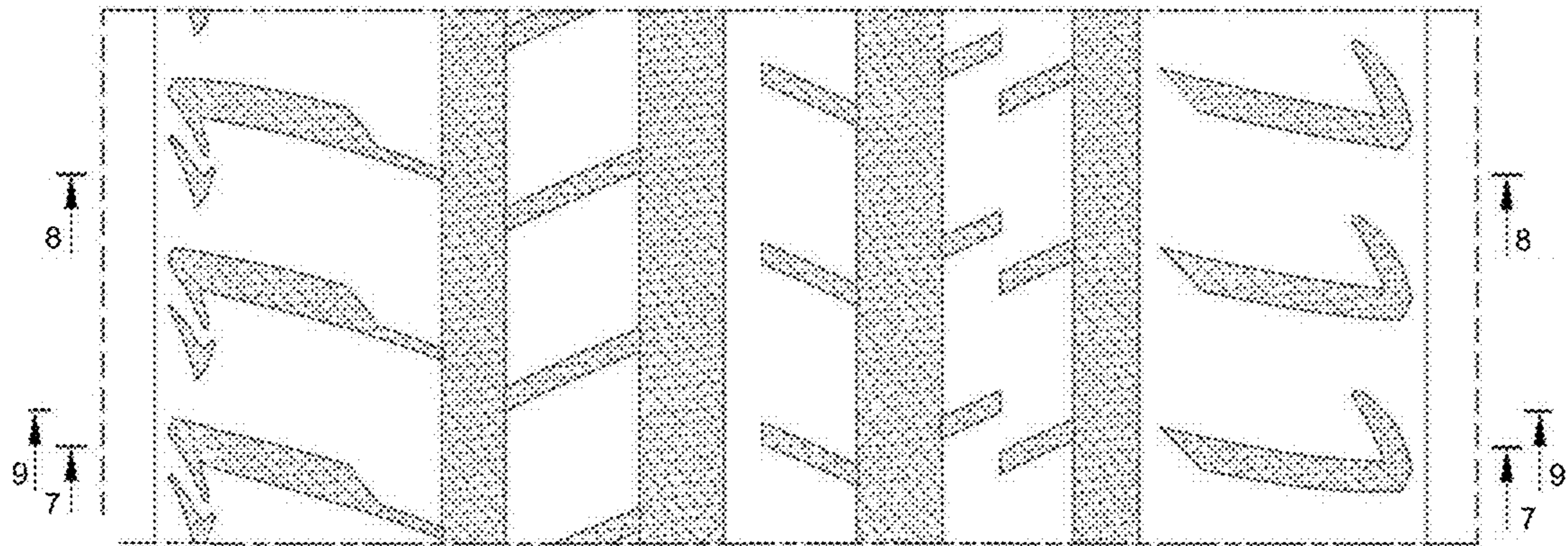

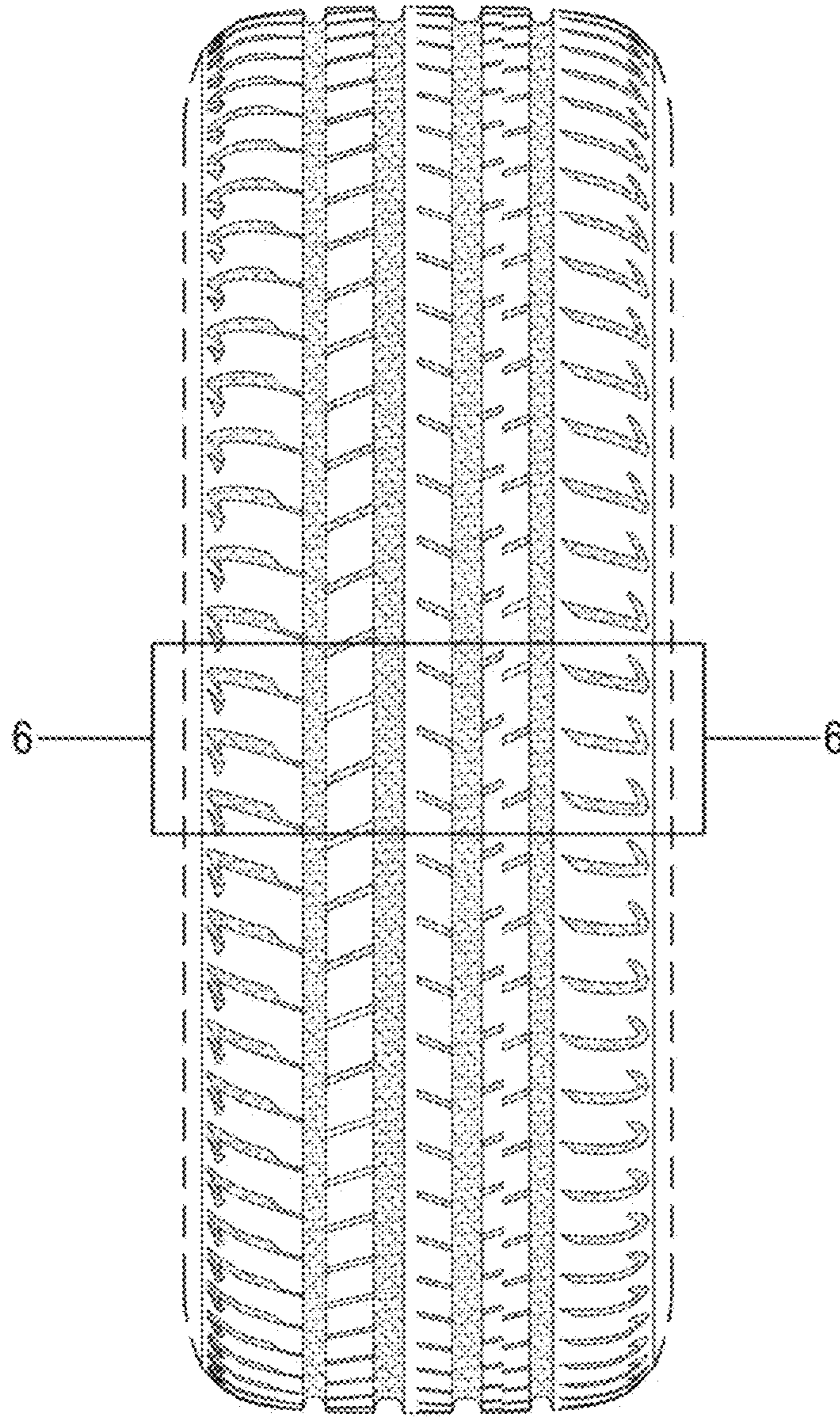
