DESCRIPTION

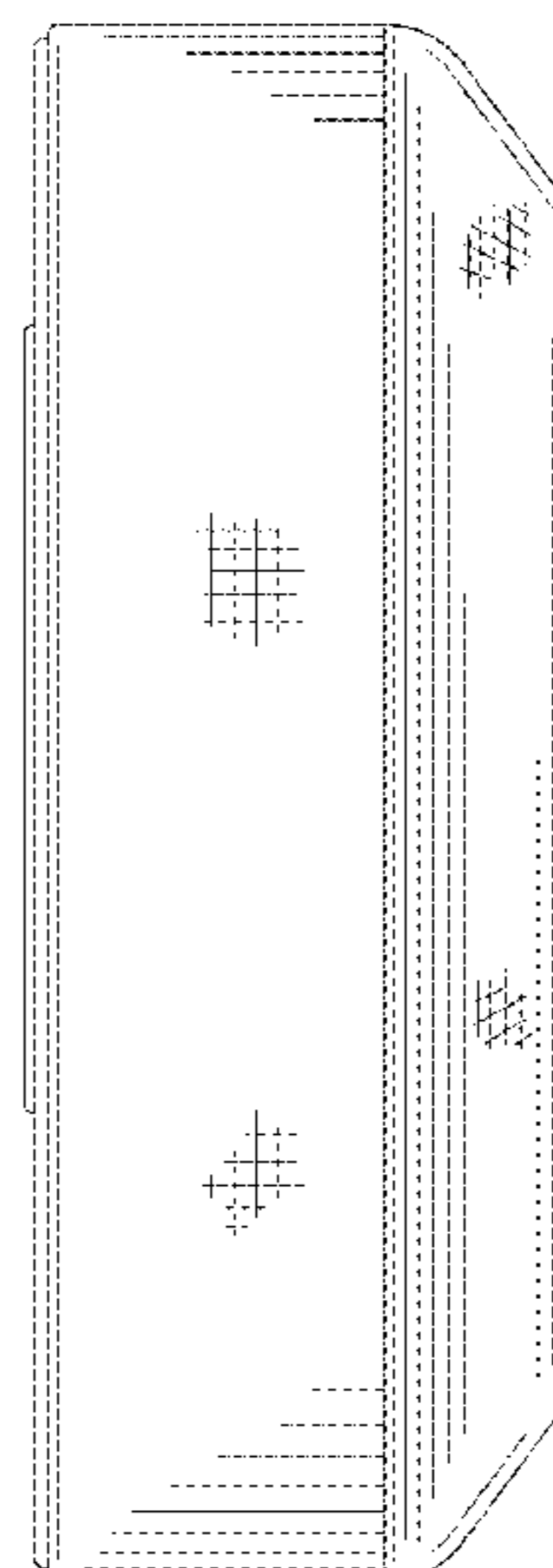
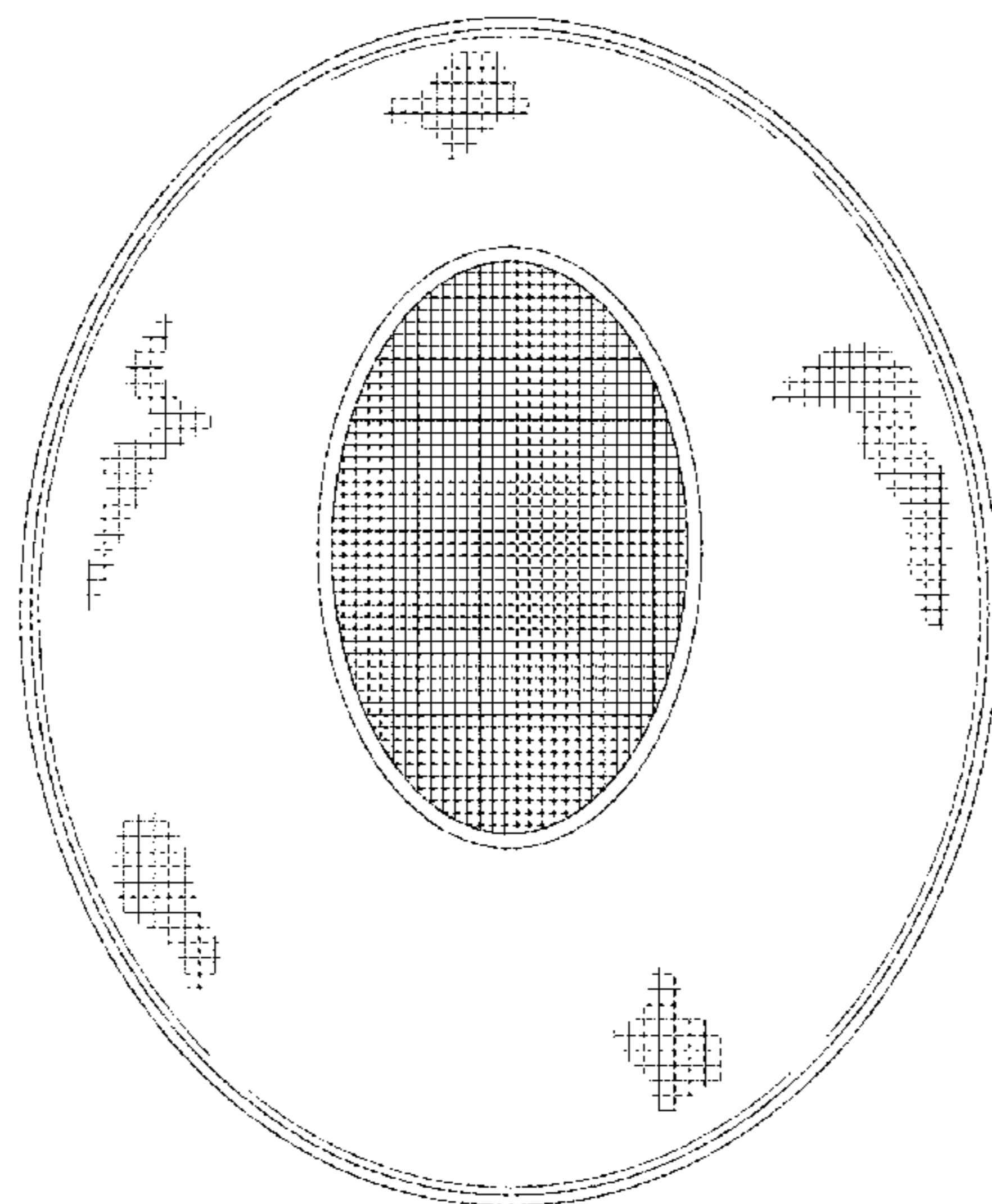
FIG. 1 is a perspective view of the headphone cover showing my new design in use;

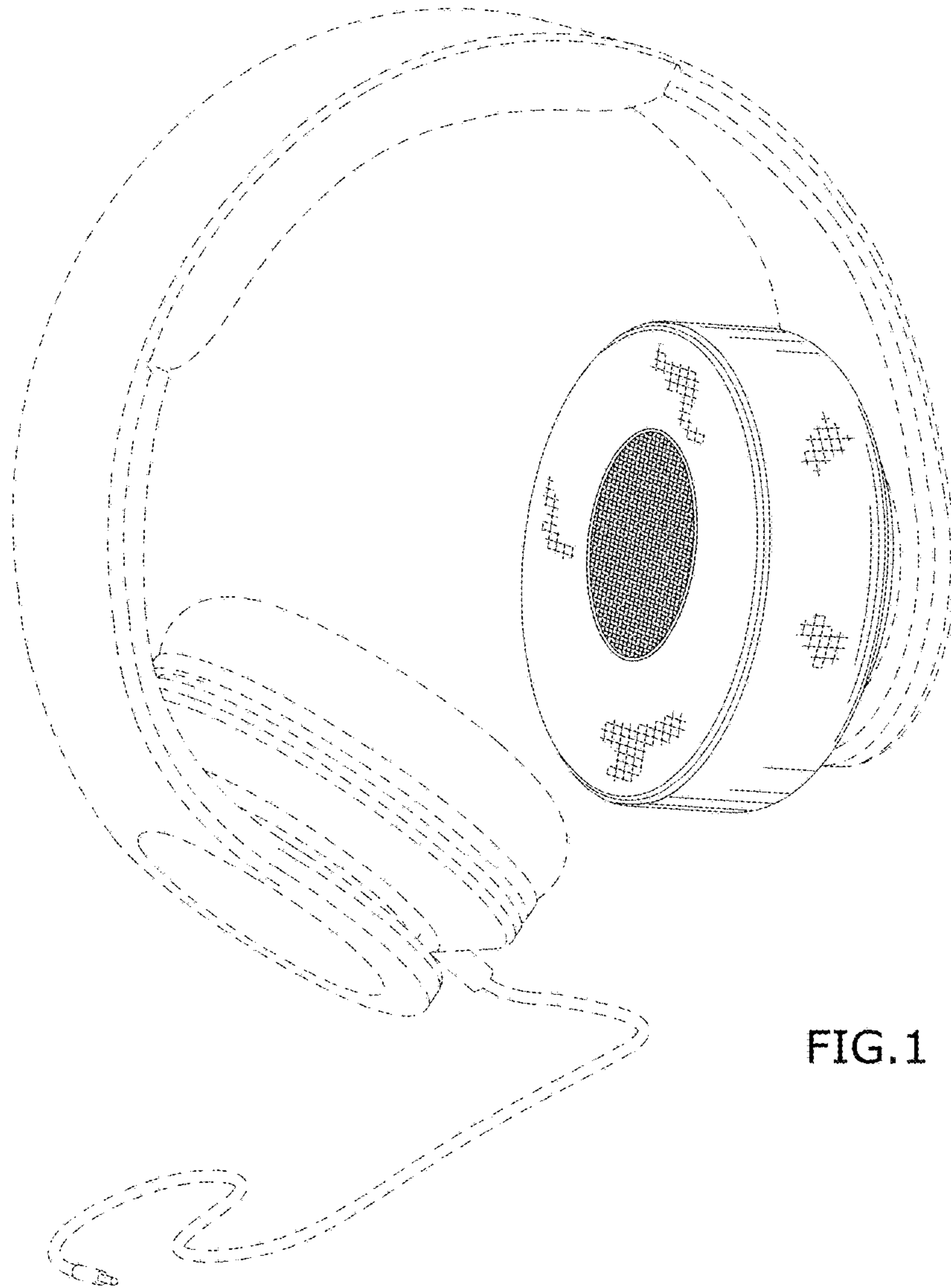

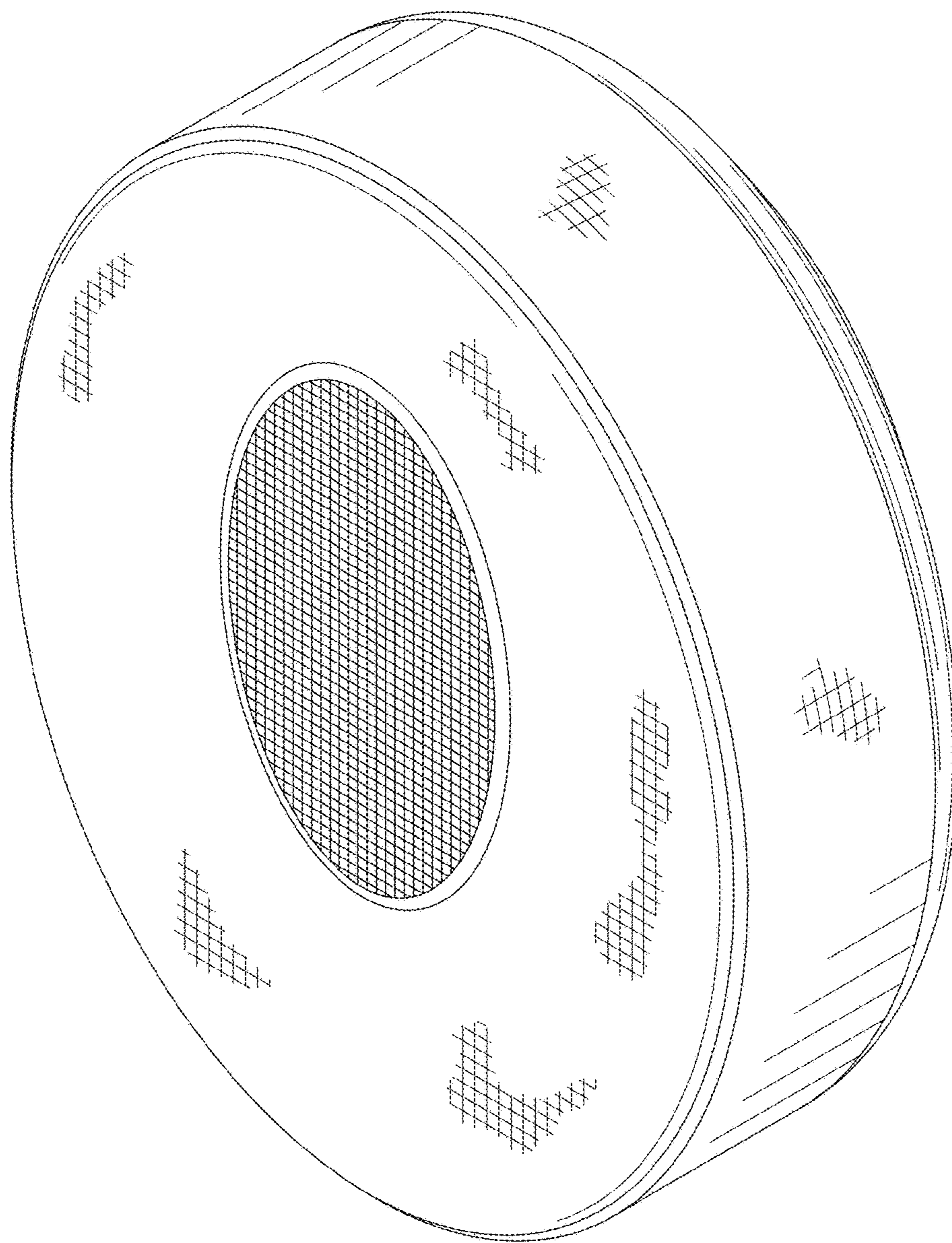

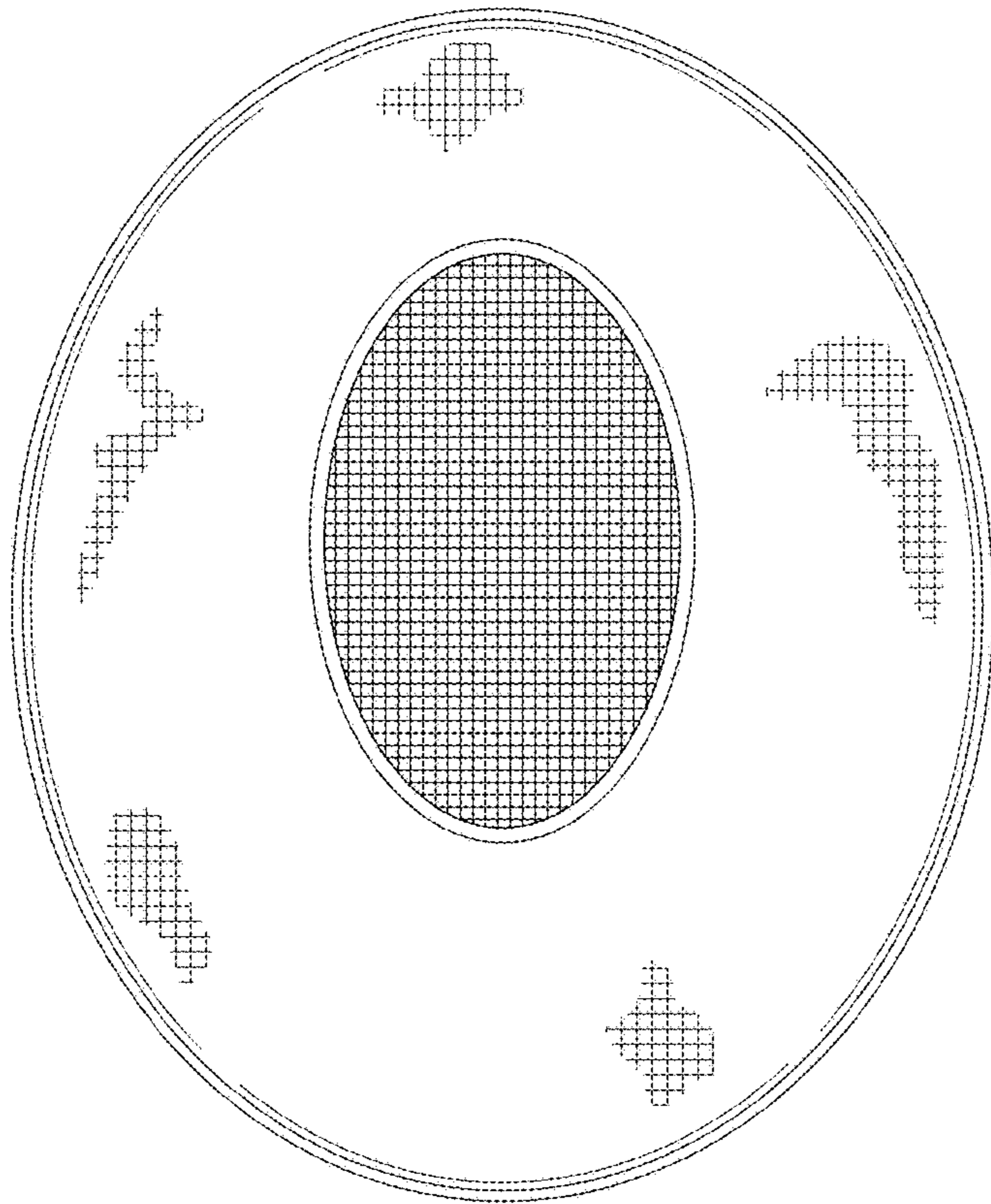

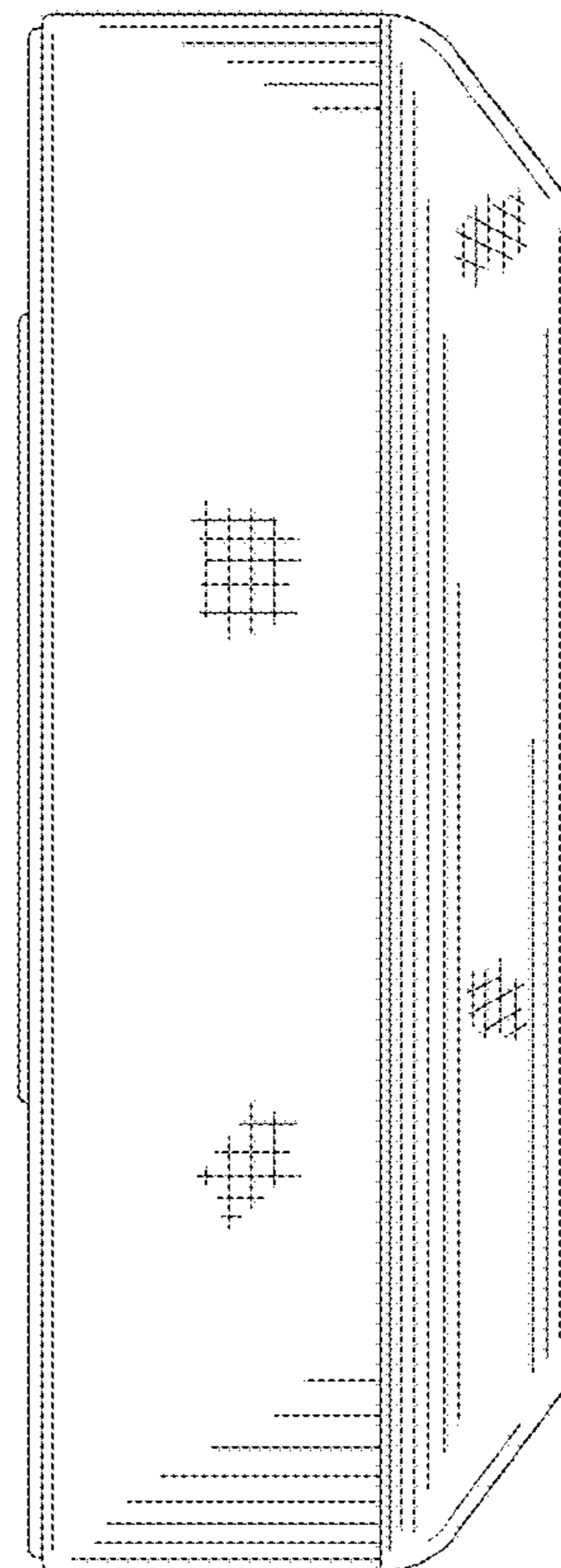

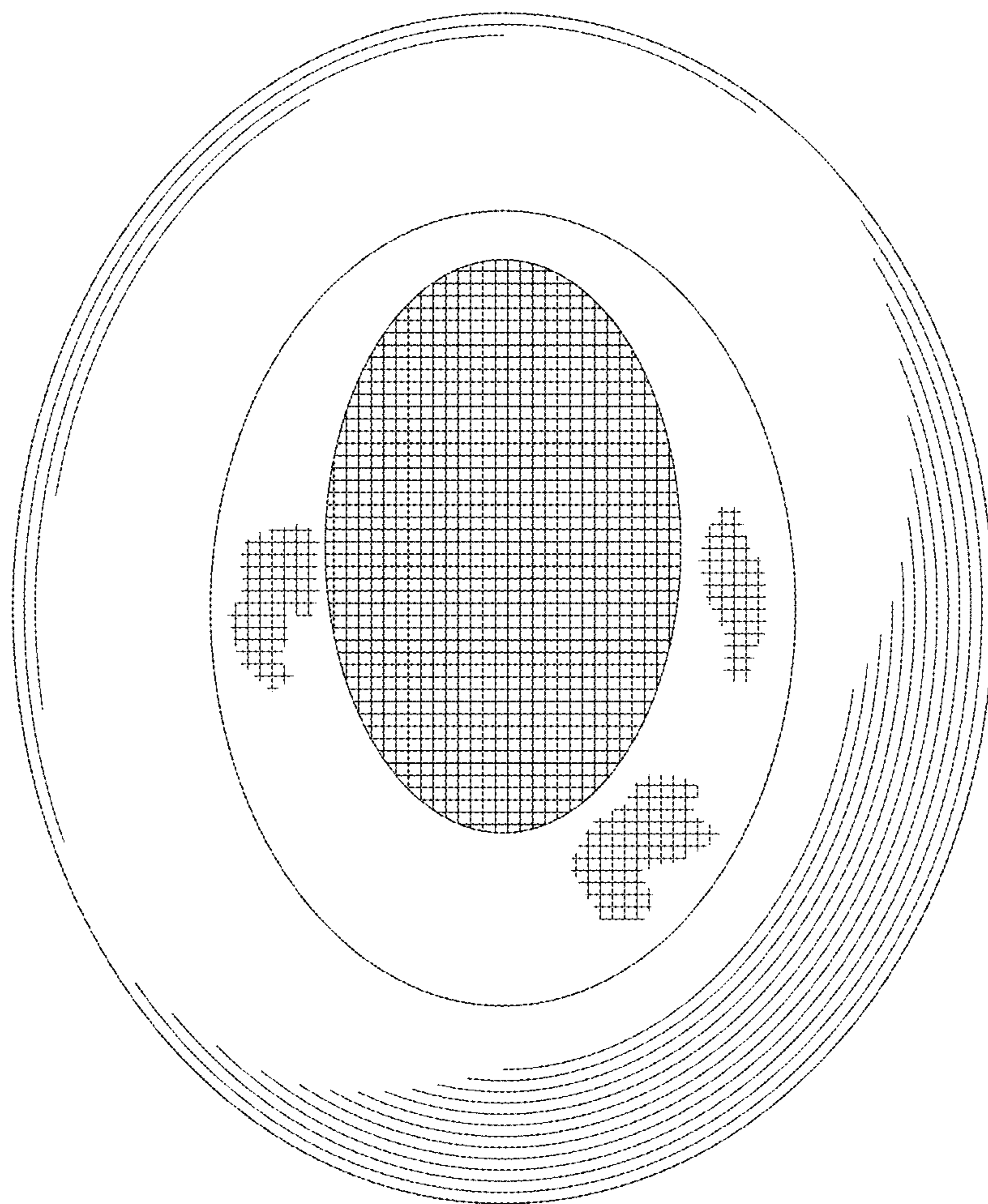

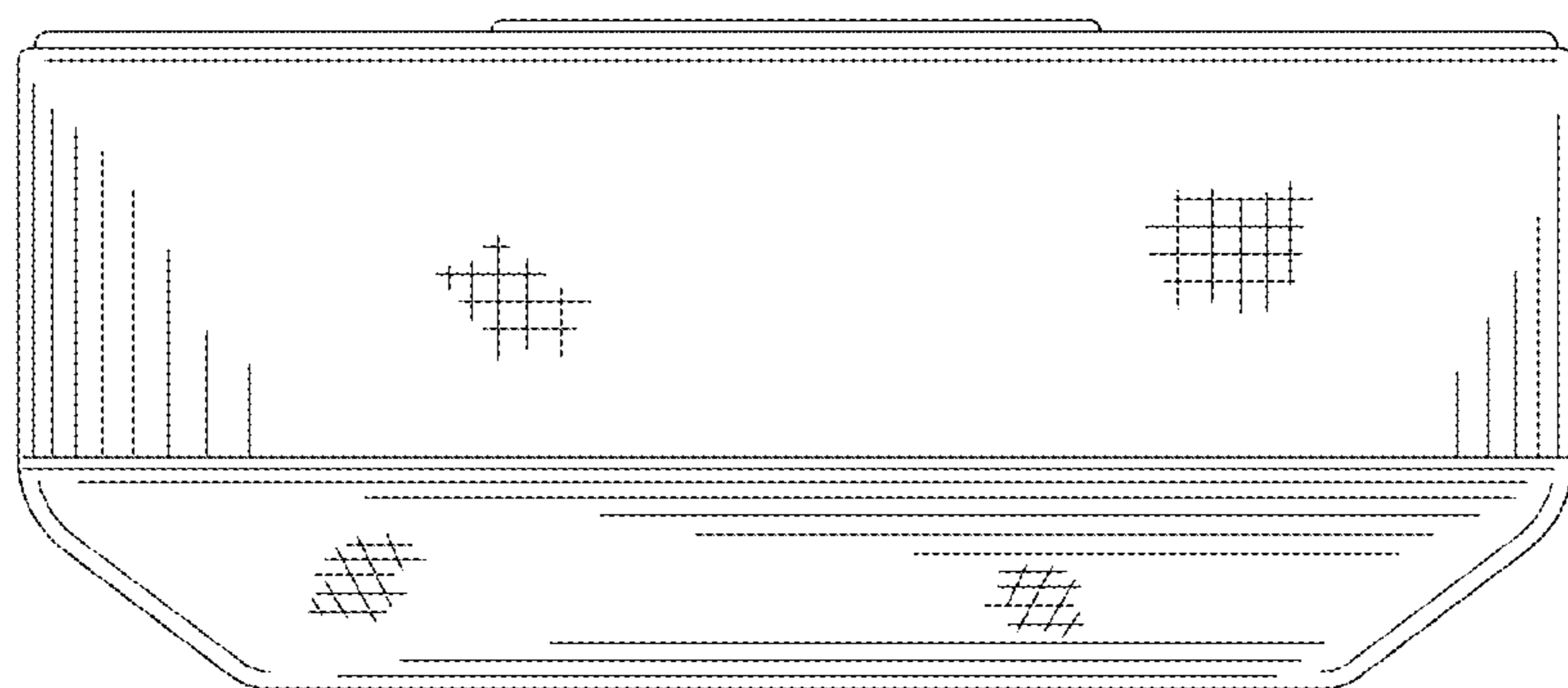
