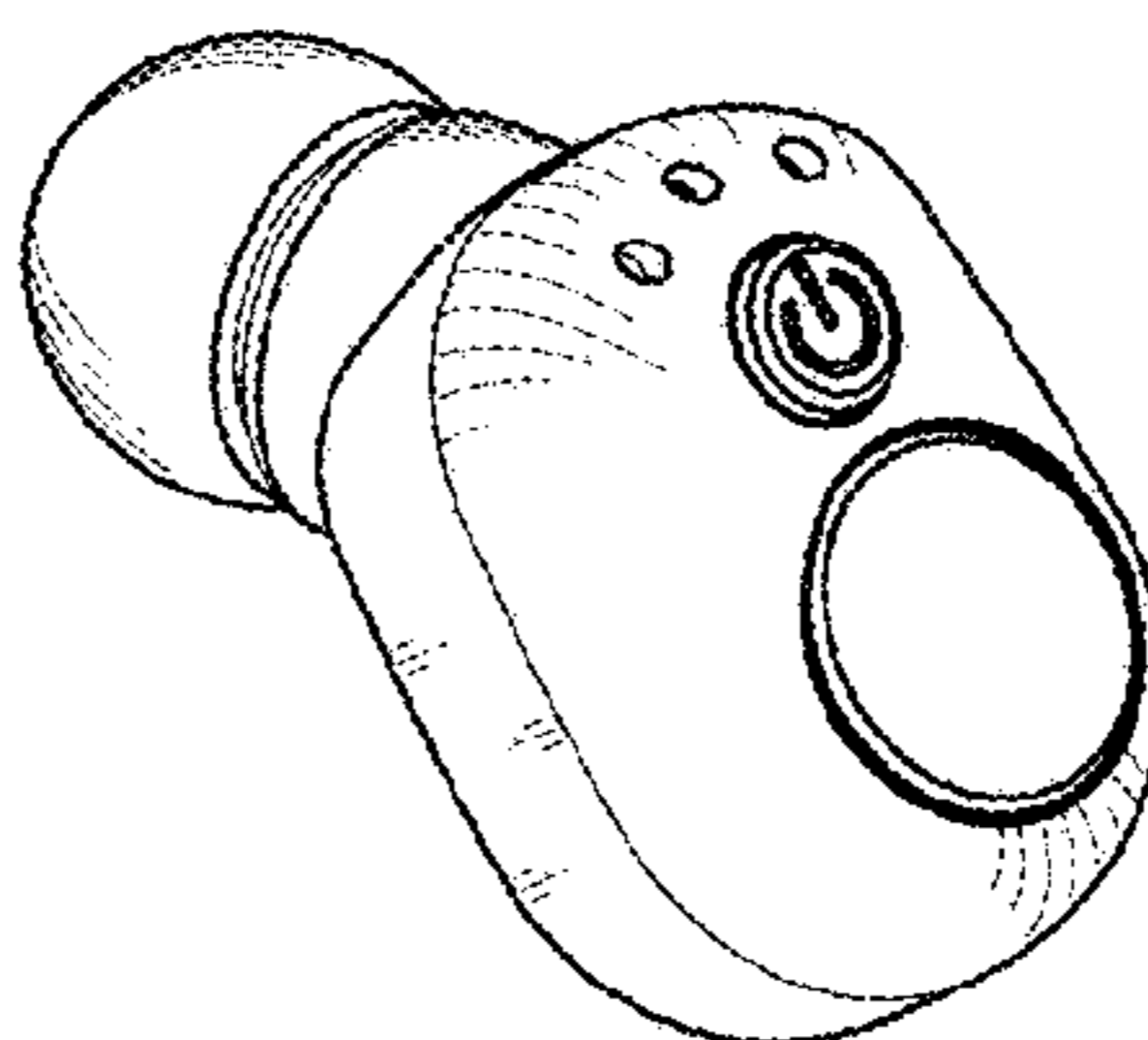
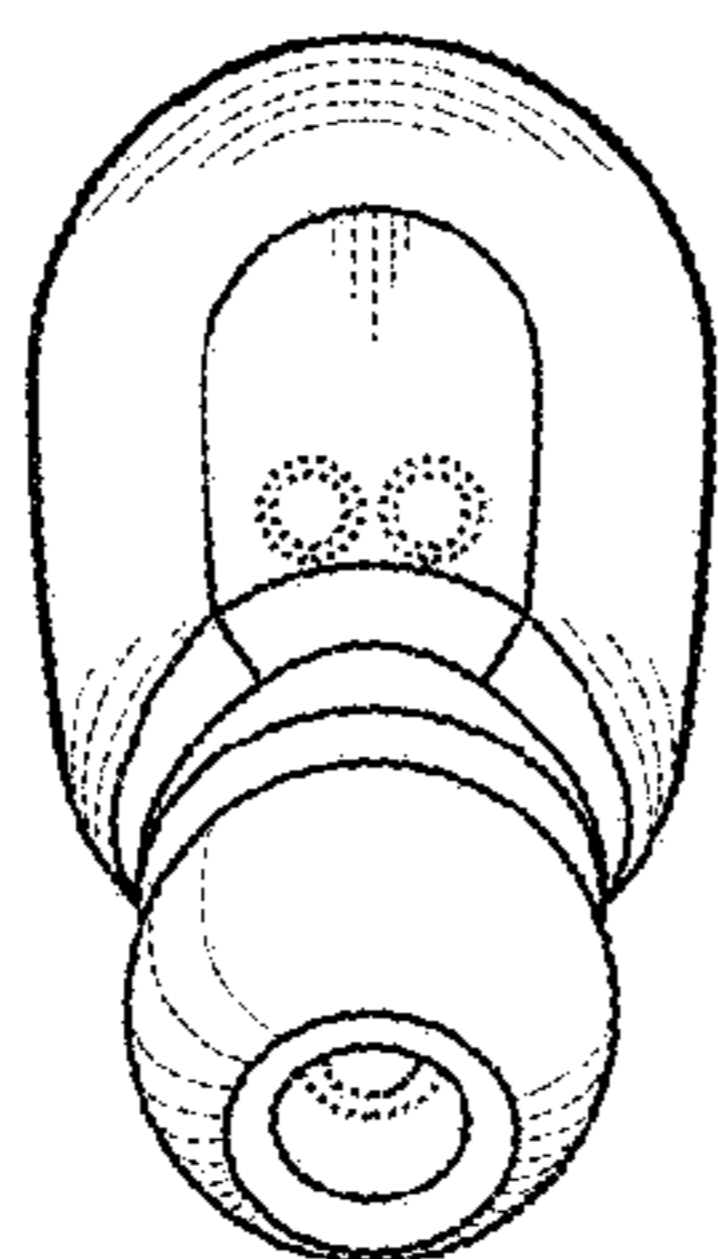
The ornamental design for a wireless earset, as shown and described.

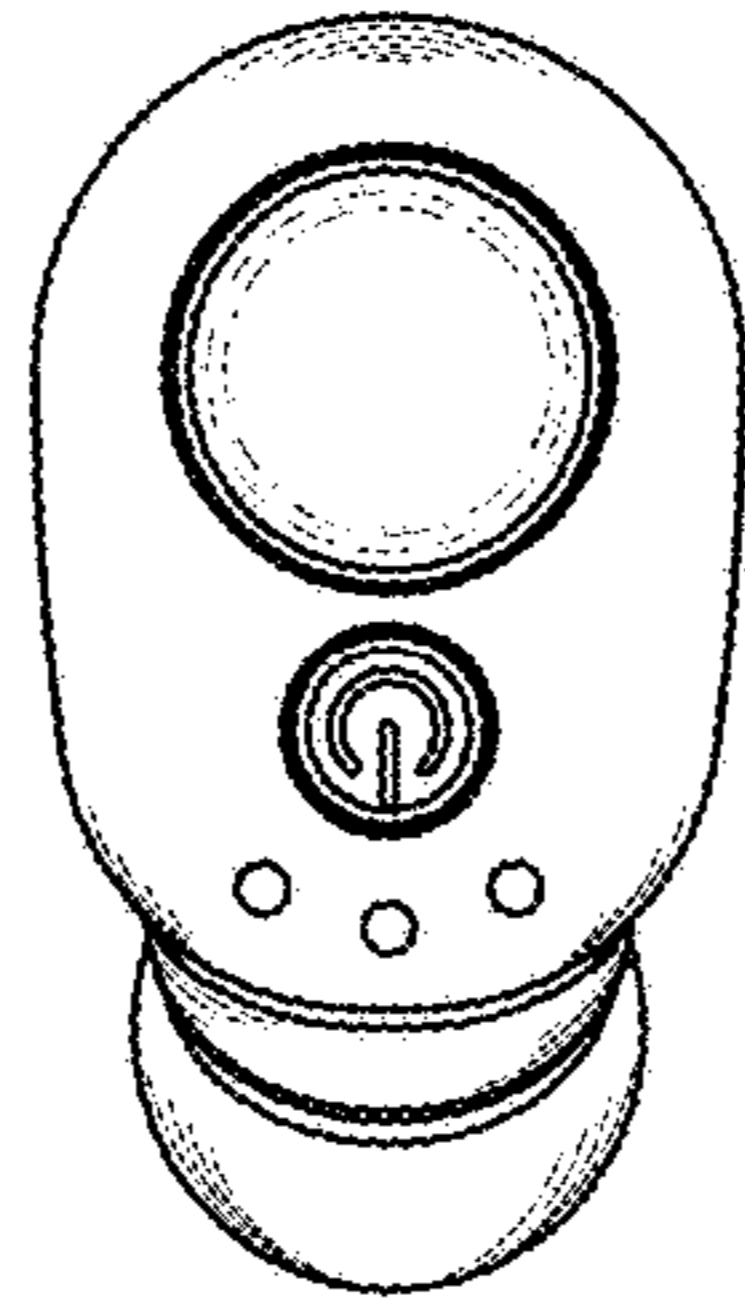

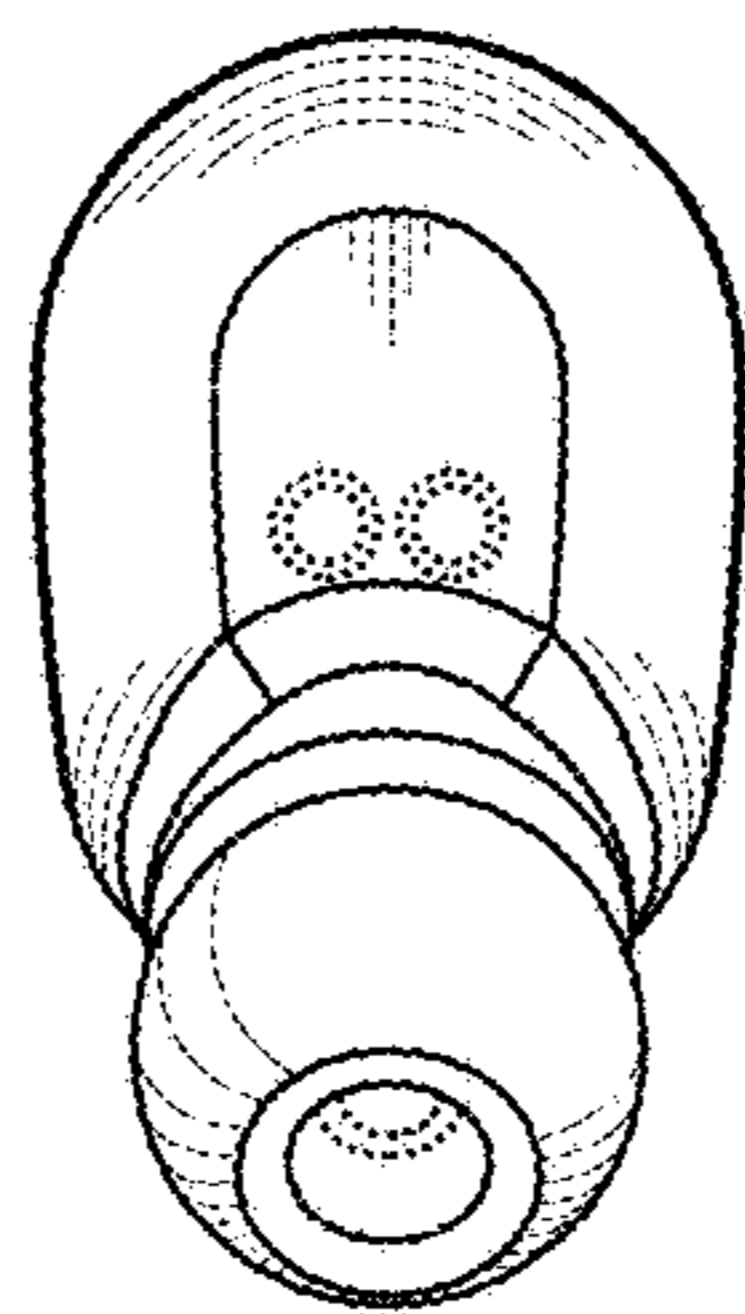

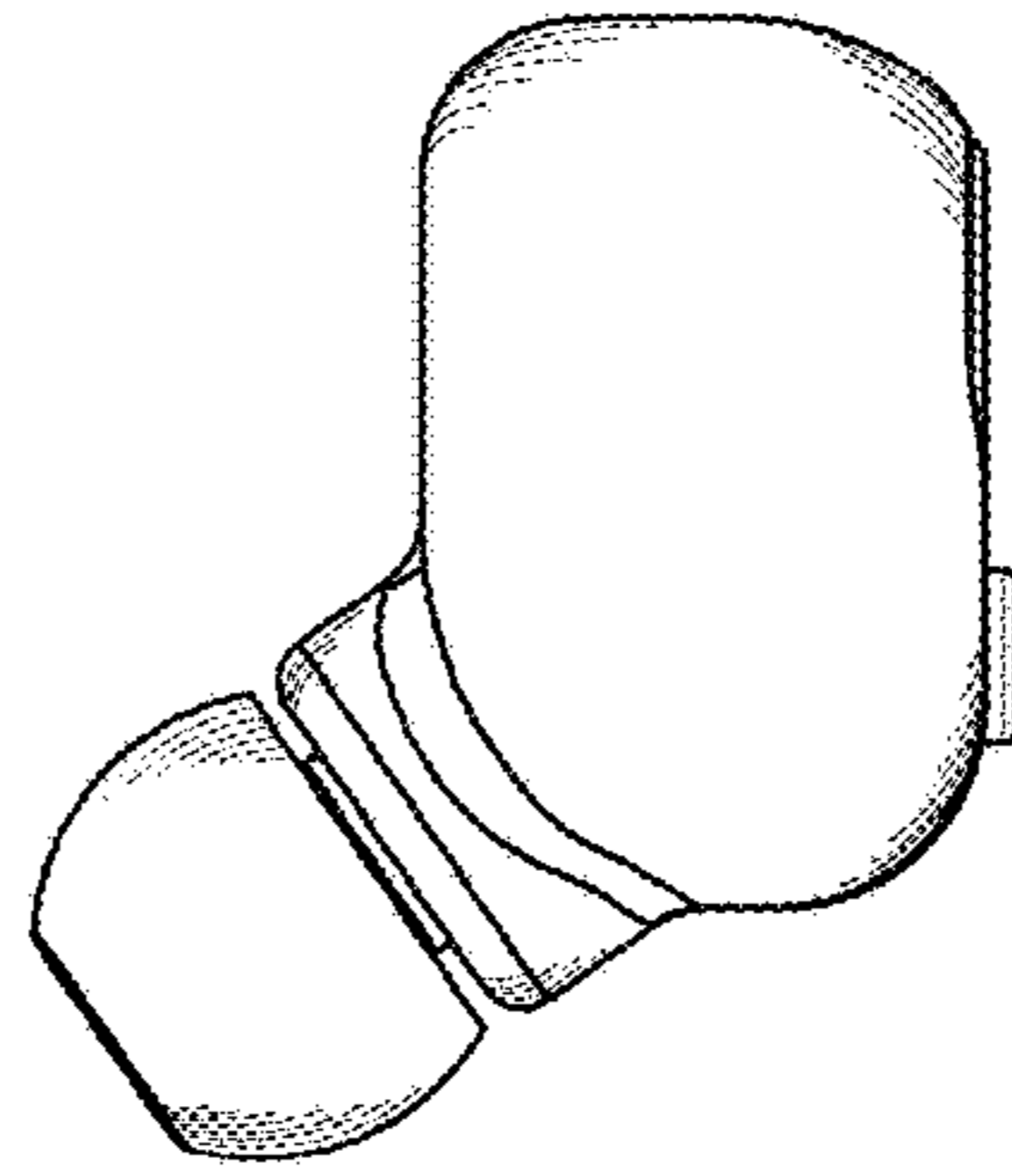

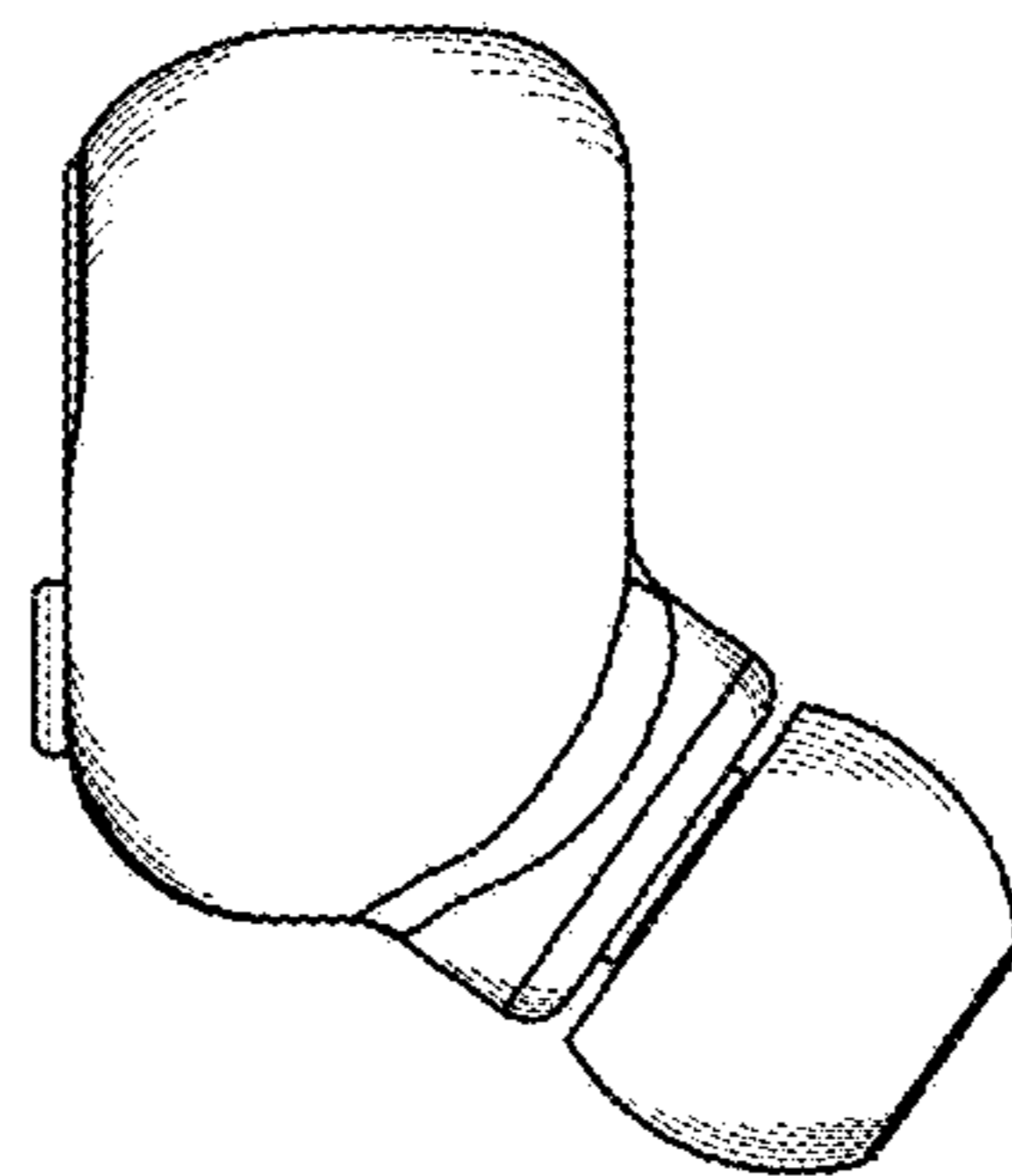

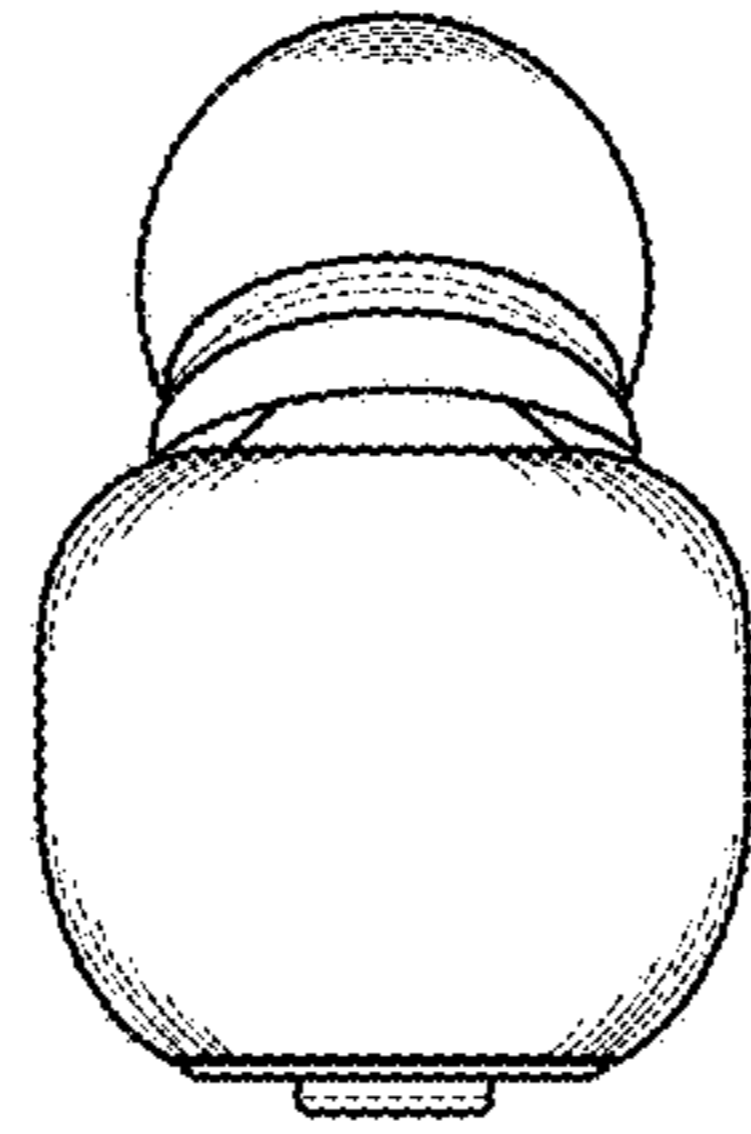

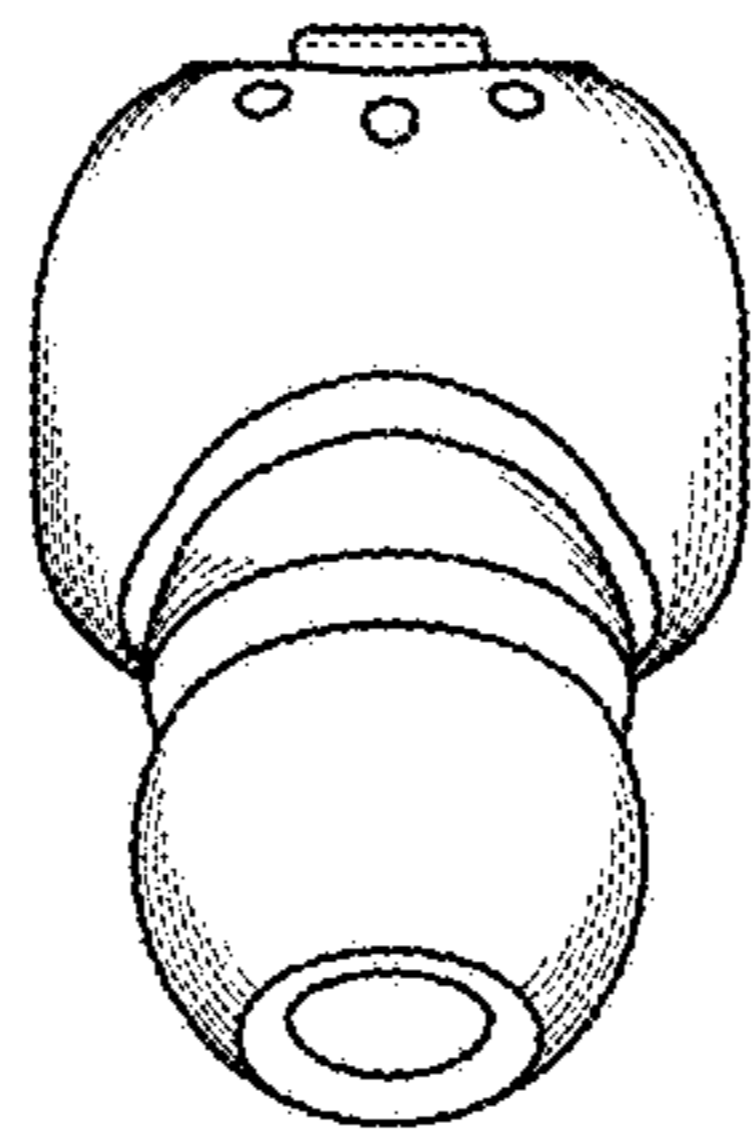

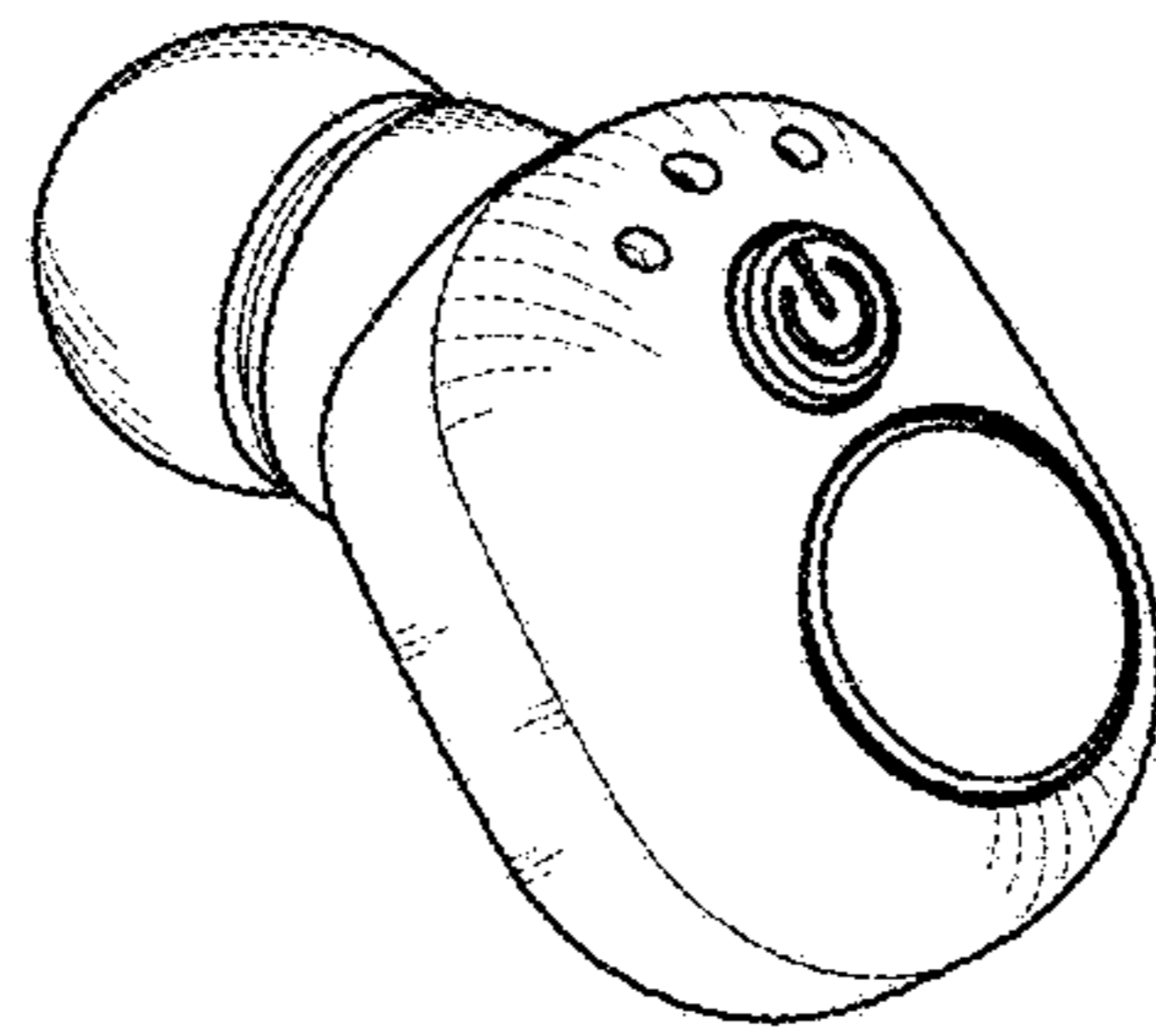
