FIG. 9 is a third image thereof;

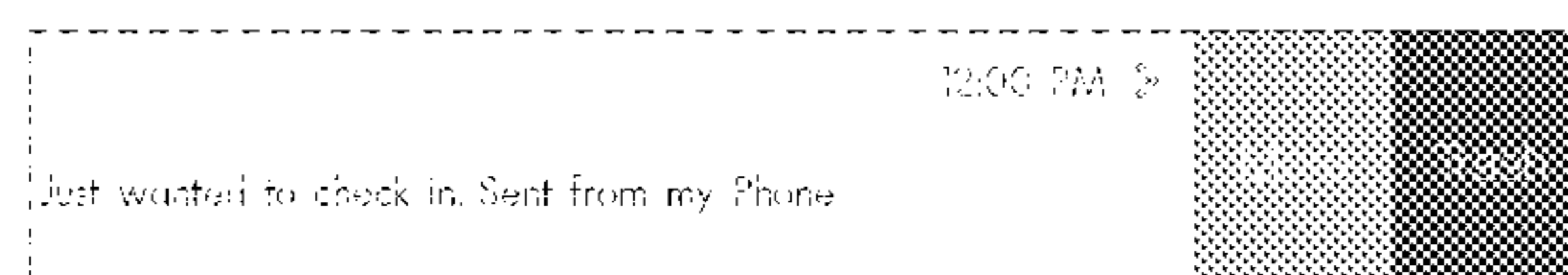
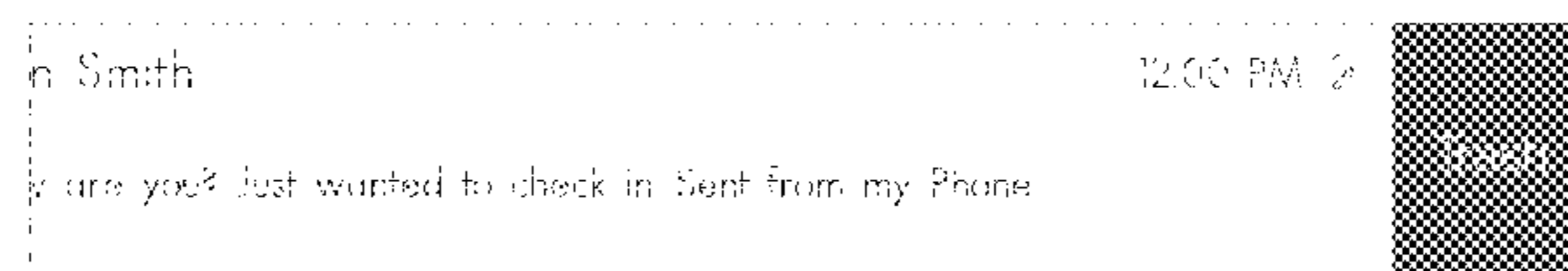
FIG. 10 is a front view of a display screen or portion thereof with animated graphical user interface showing a first image of a fourth embodiment of the claimed design;

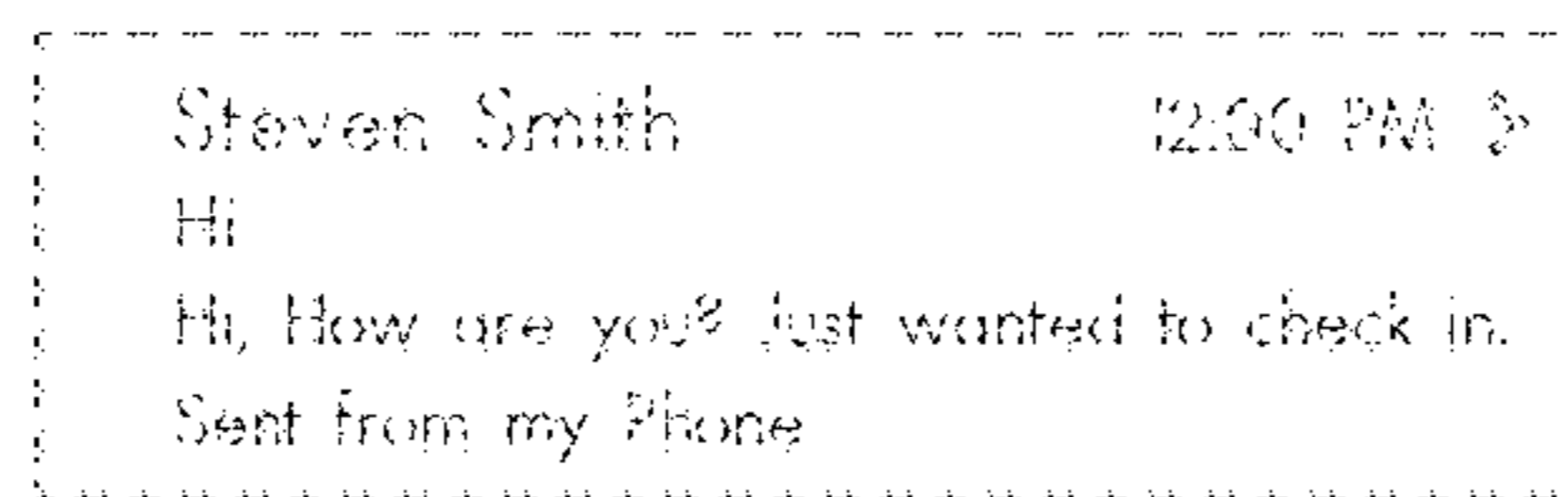

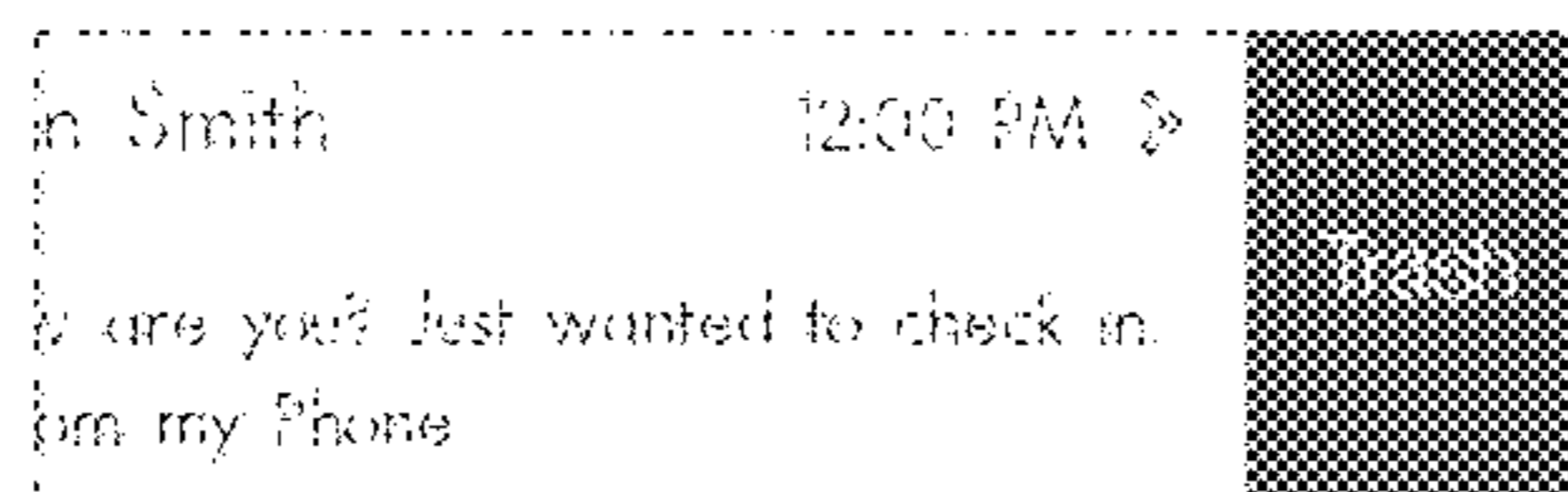

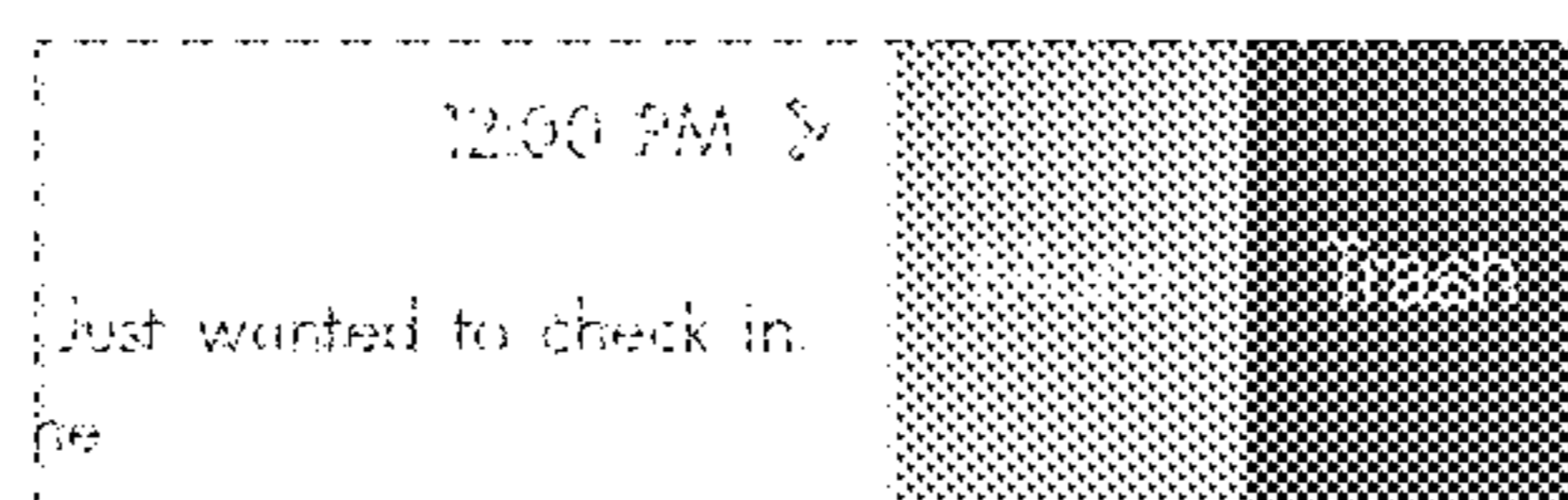

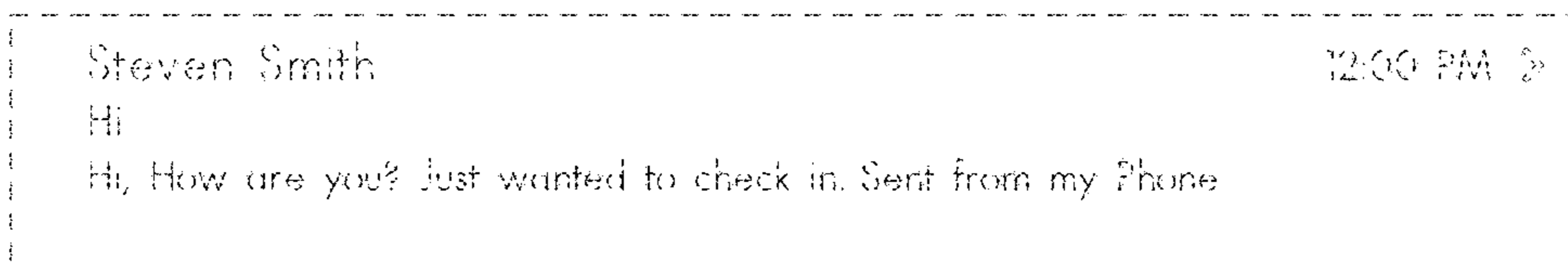

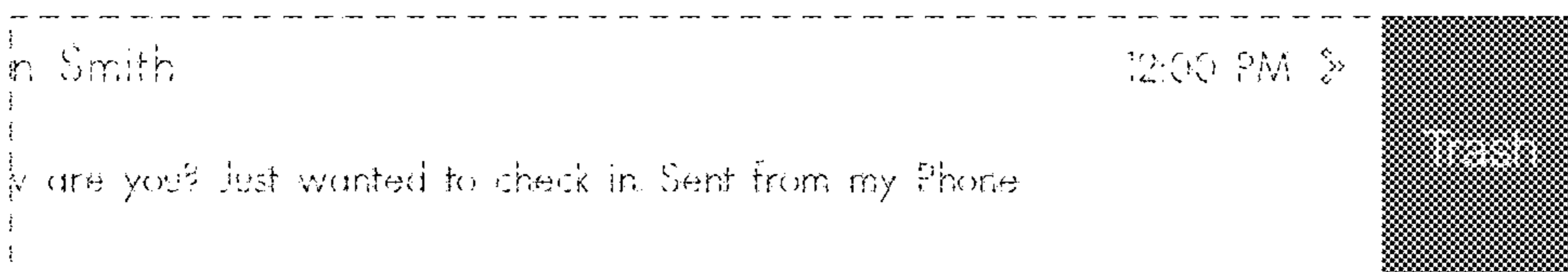

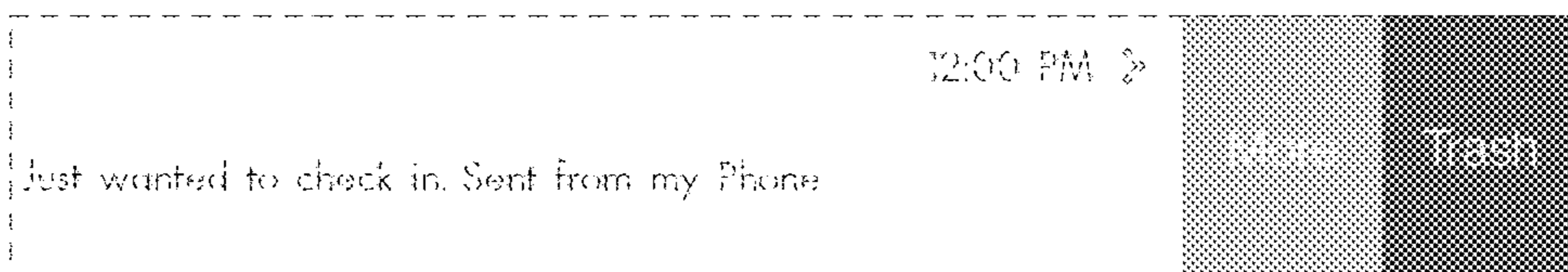
