(57) **CLAIM**

The ornamental design for a display screen with wheel of recognition graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 illustrates a front view of a display screen with wheel of recognition graphical user interface showing the new design;

FIG. 4 illustrates a third icon depicted in the GUI set forth in FIG. 1;

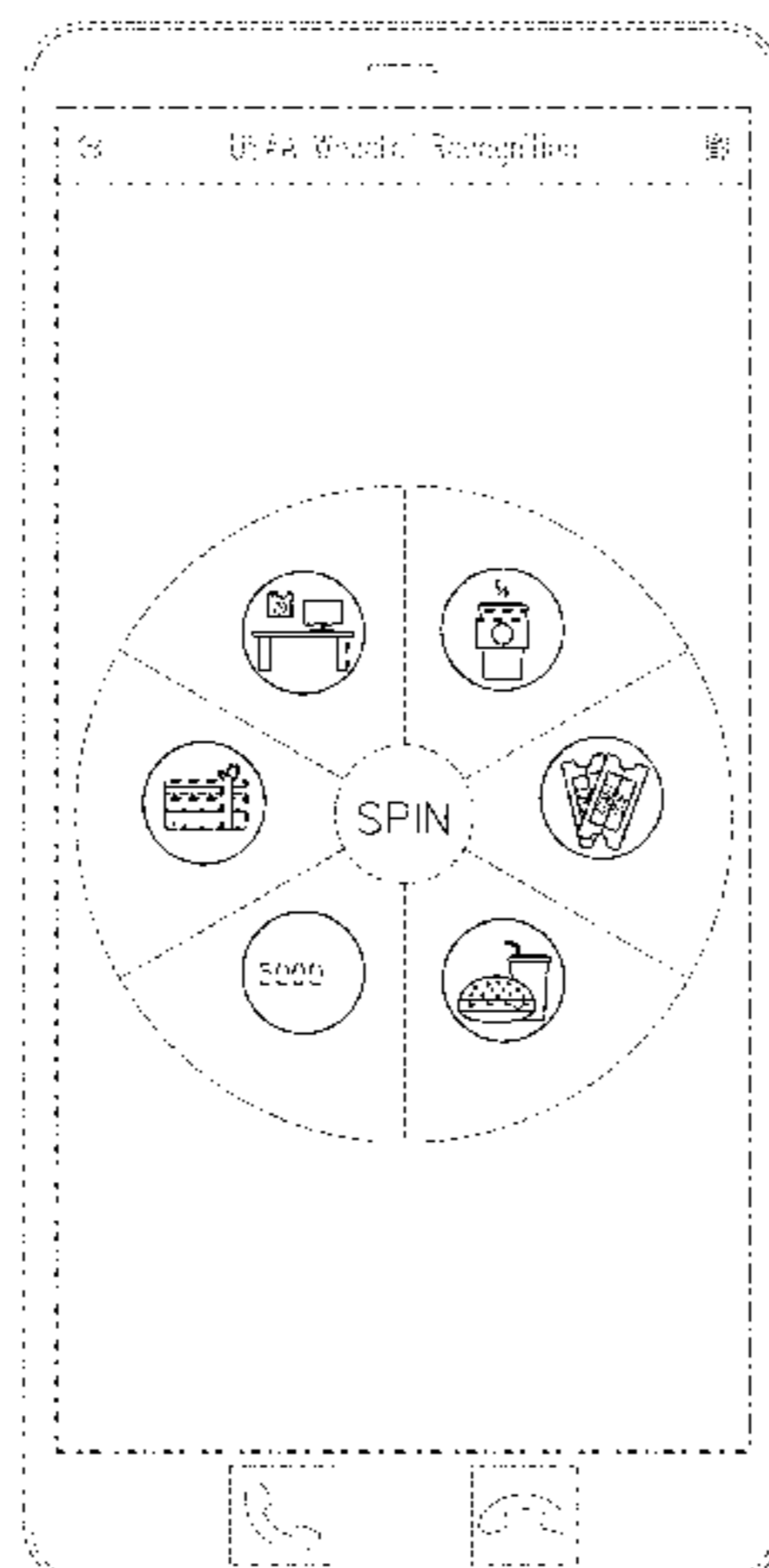
FIG. 5 illustrates a fourth icon depicted in the GUI set forth in FIG. 1;

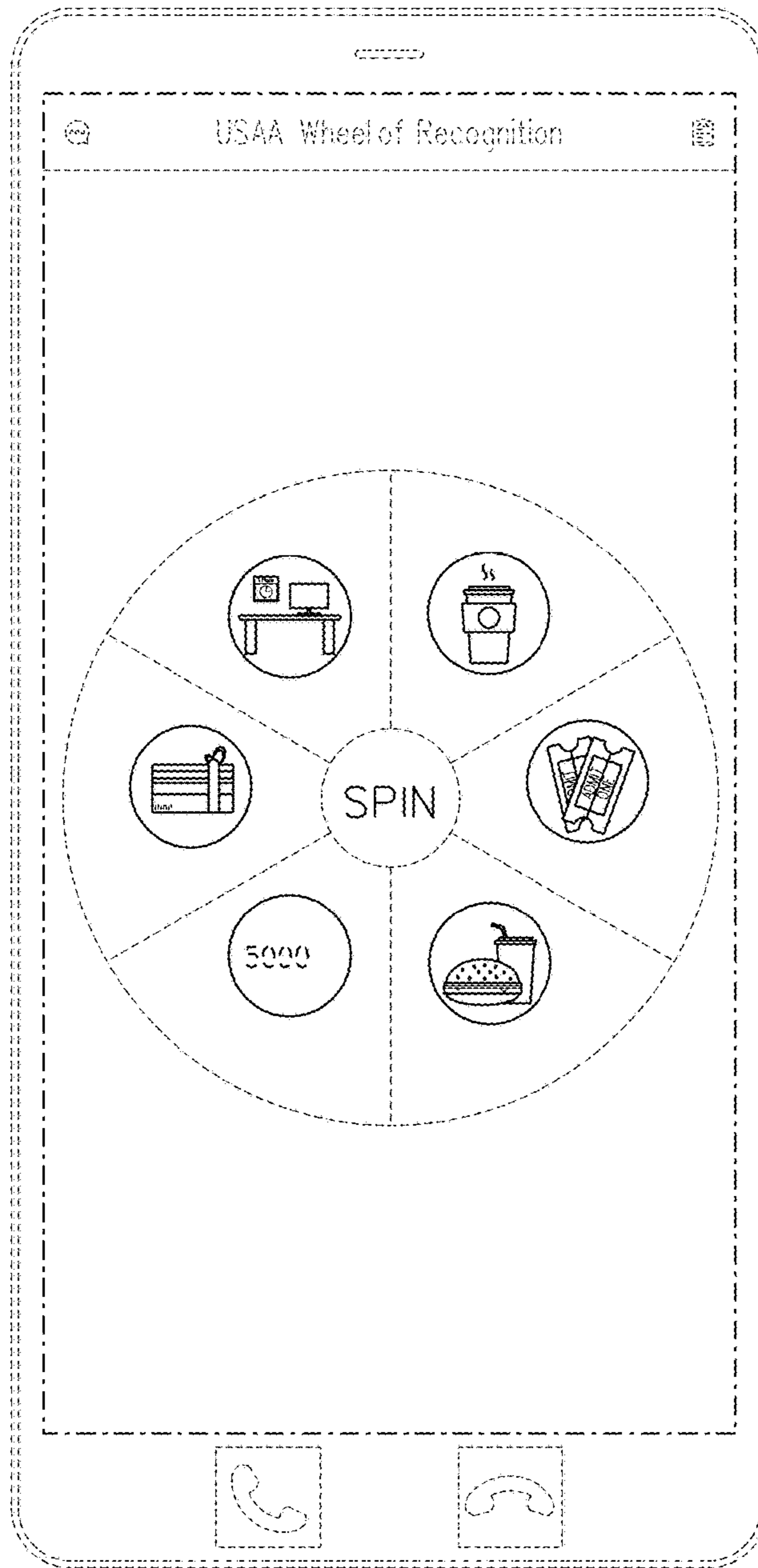

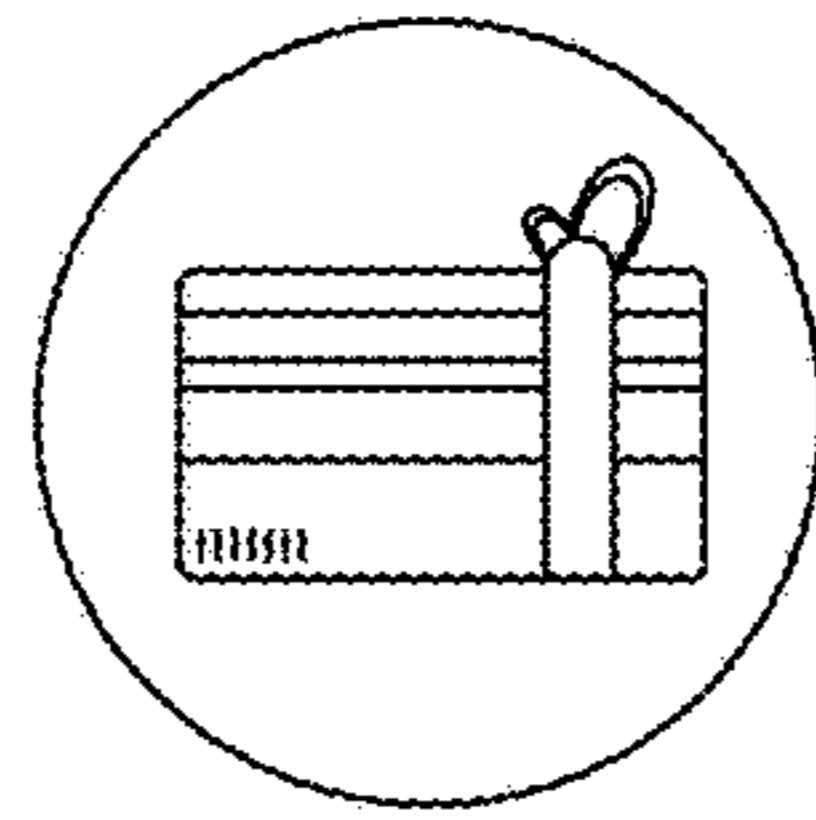

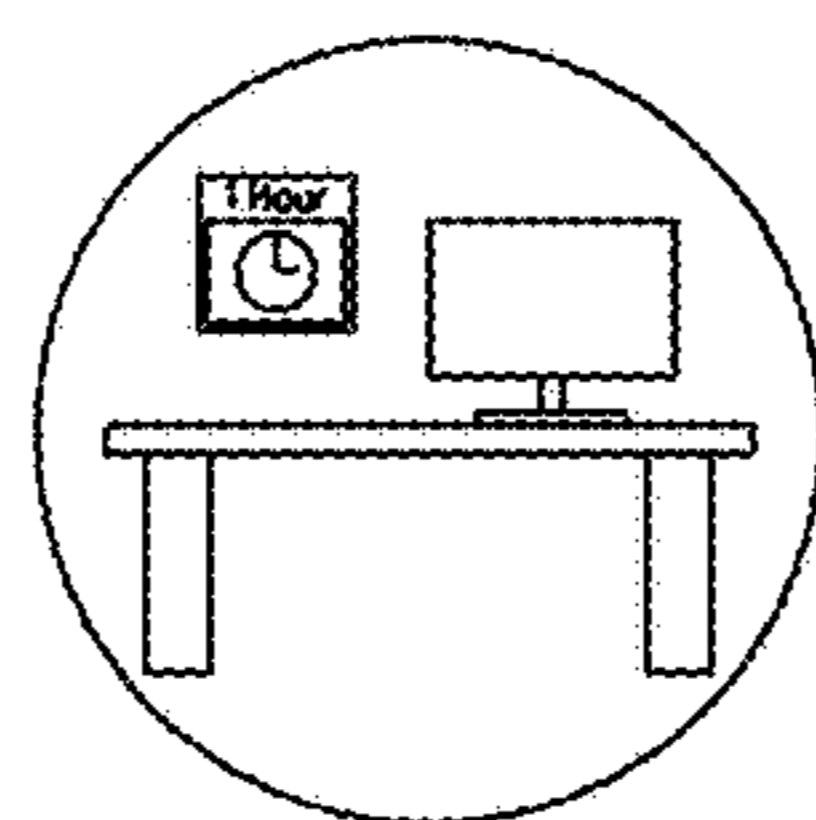

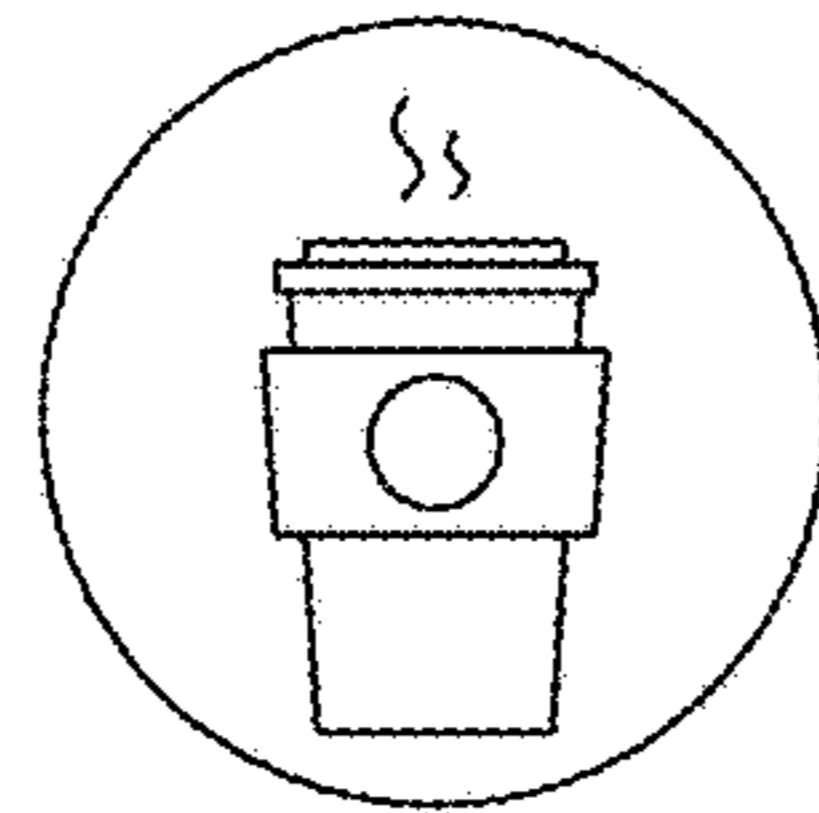

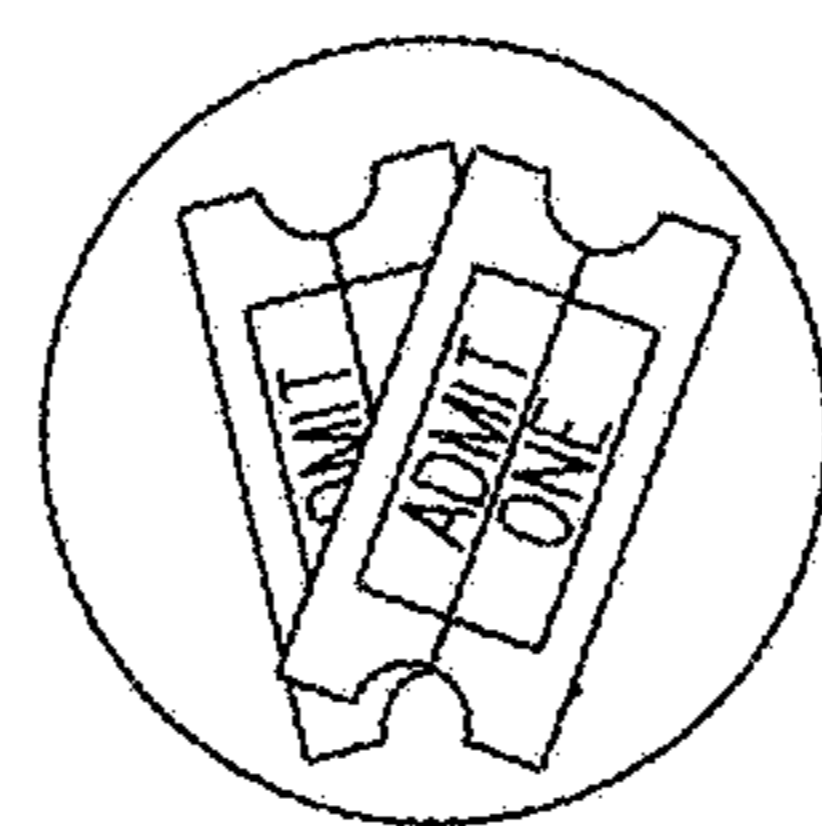

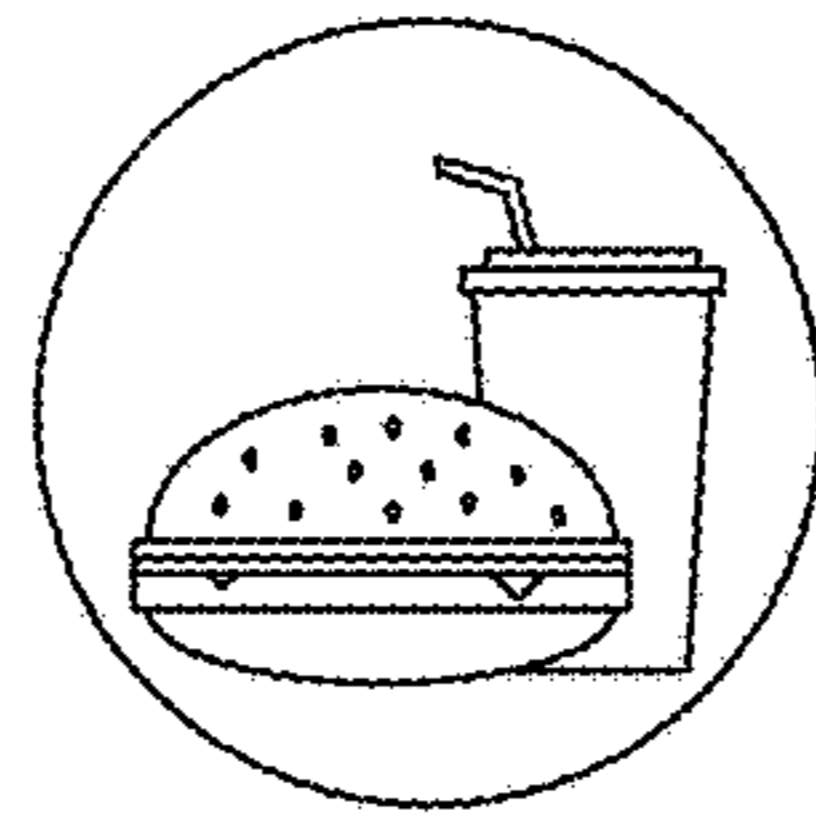

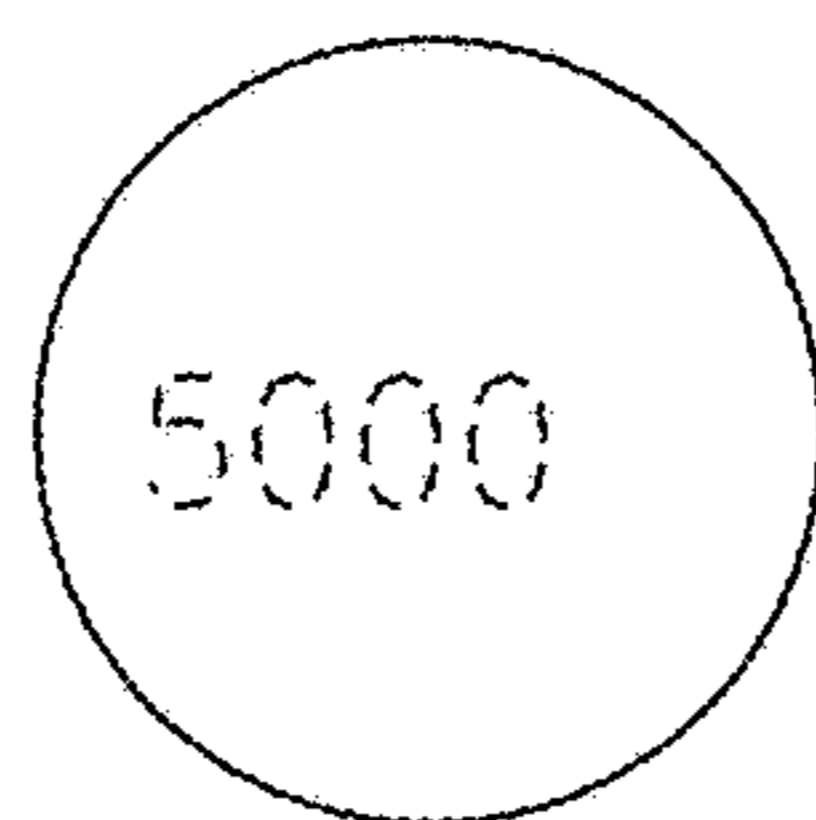
