(57) **CLAIM**

The ornamental design for a display screen with graphical user interface, as shown and described.

DESCRIPTION

The FIGURE is a front view of a display screen with graphical user interface. The stippled and hatched shading shows contrasting appearance.

The outermost broken line rectangle illustrates a display screen portion and forms no part of the claimed design. All other broken lines show portions of the graphical user interface and form no part of the claimed design.
