The ornamental design for portion of a display panel with a computer icon image, as shown and described.

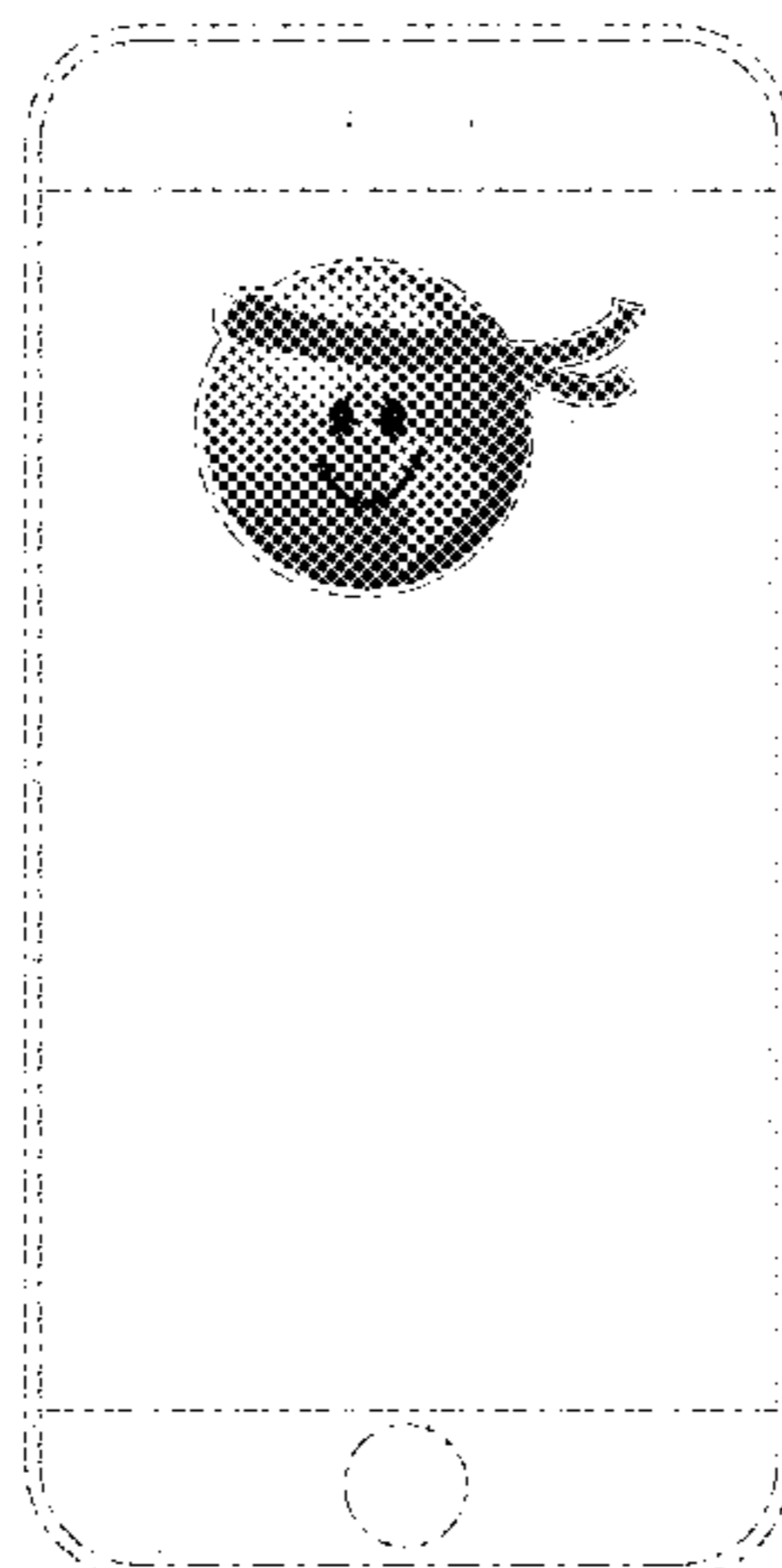
DESCRIPTION

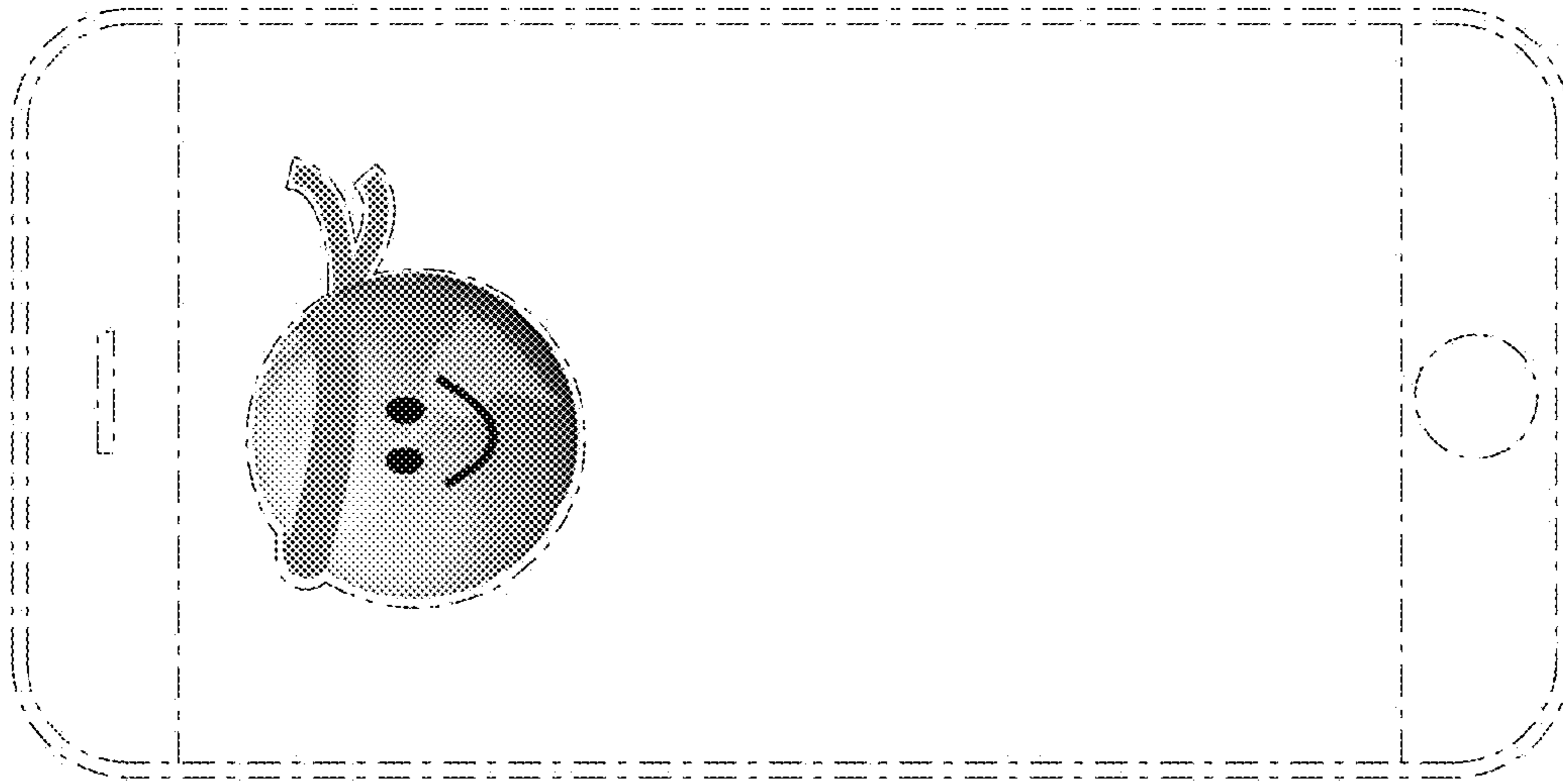

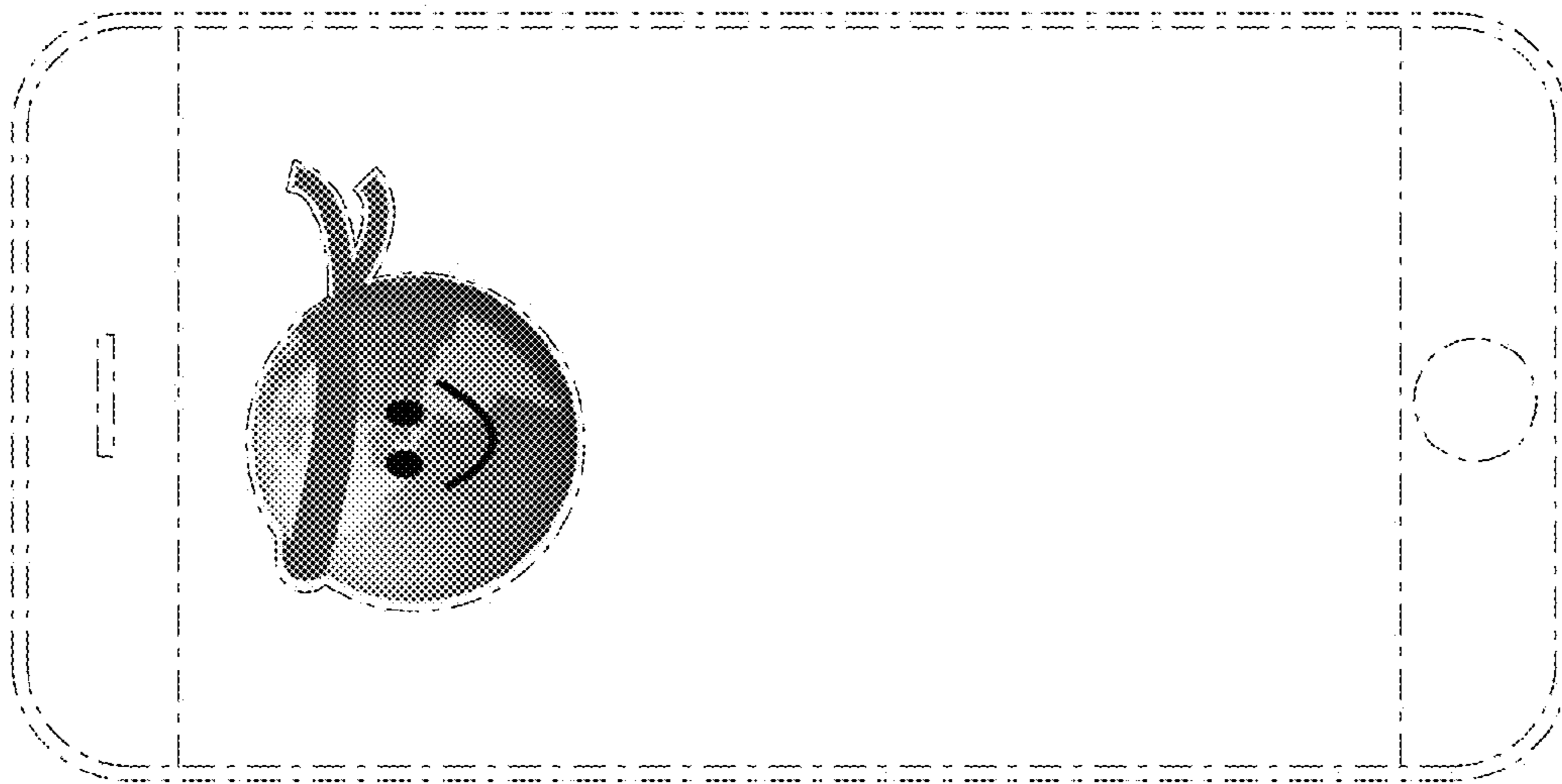
