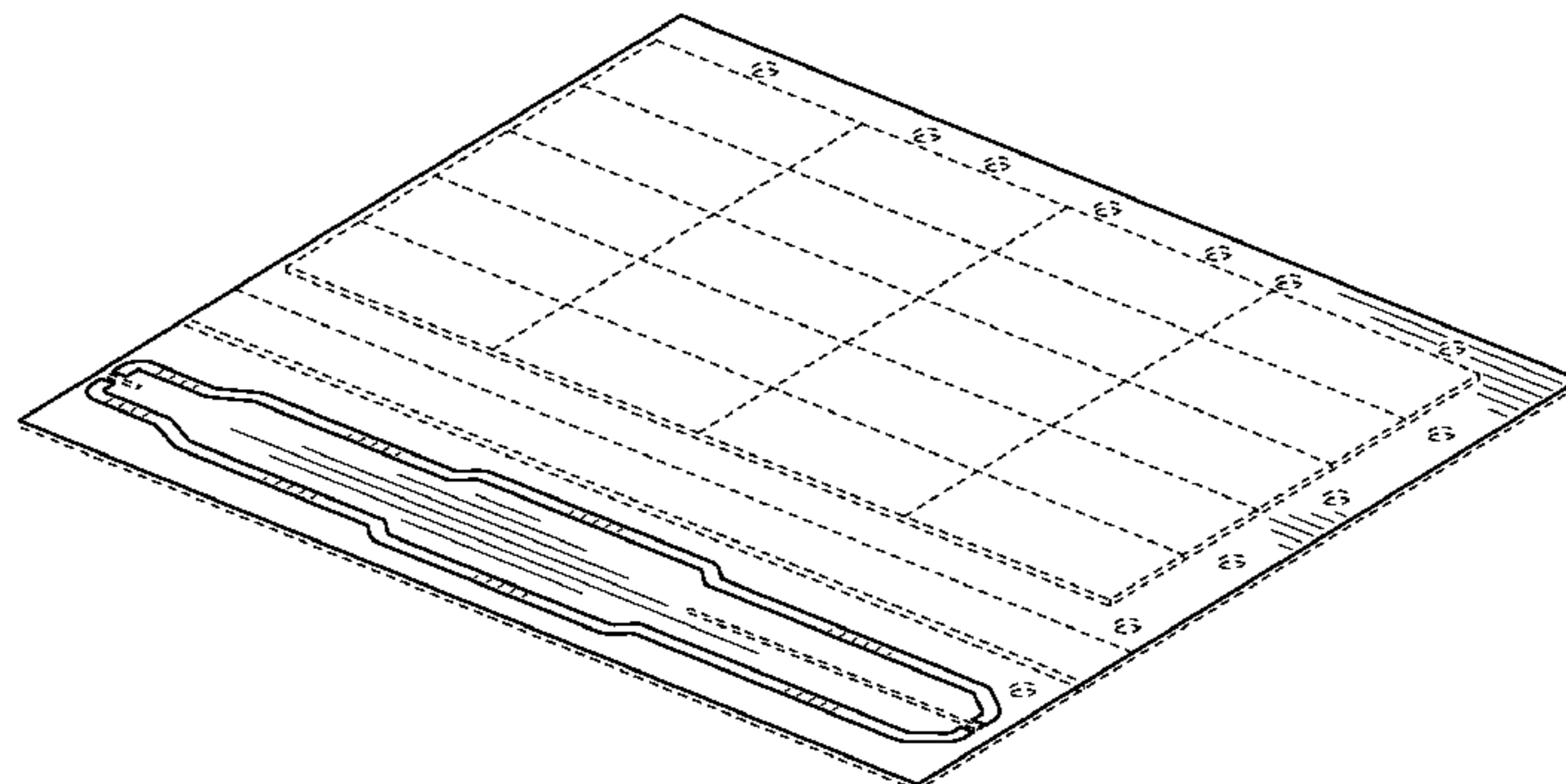
The ornamental design for a sheet with a wristband, as shown and described.

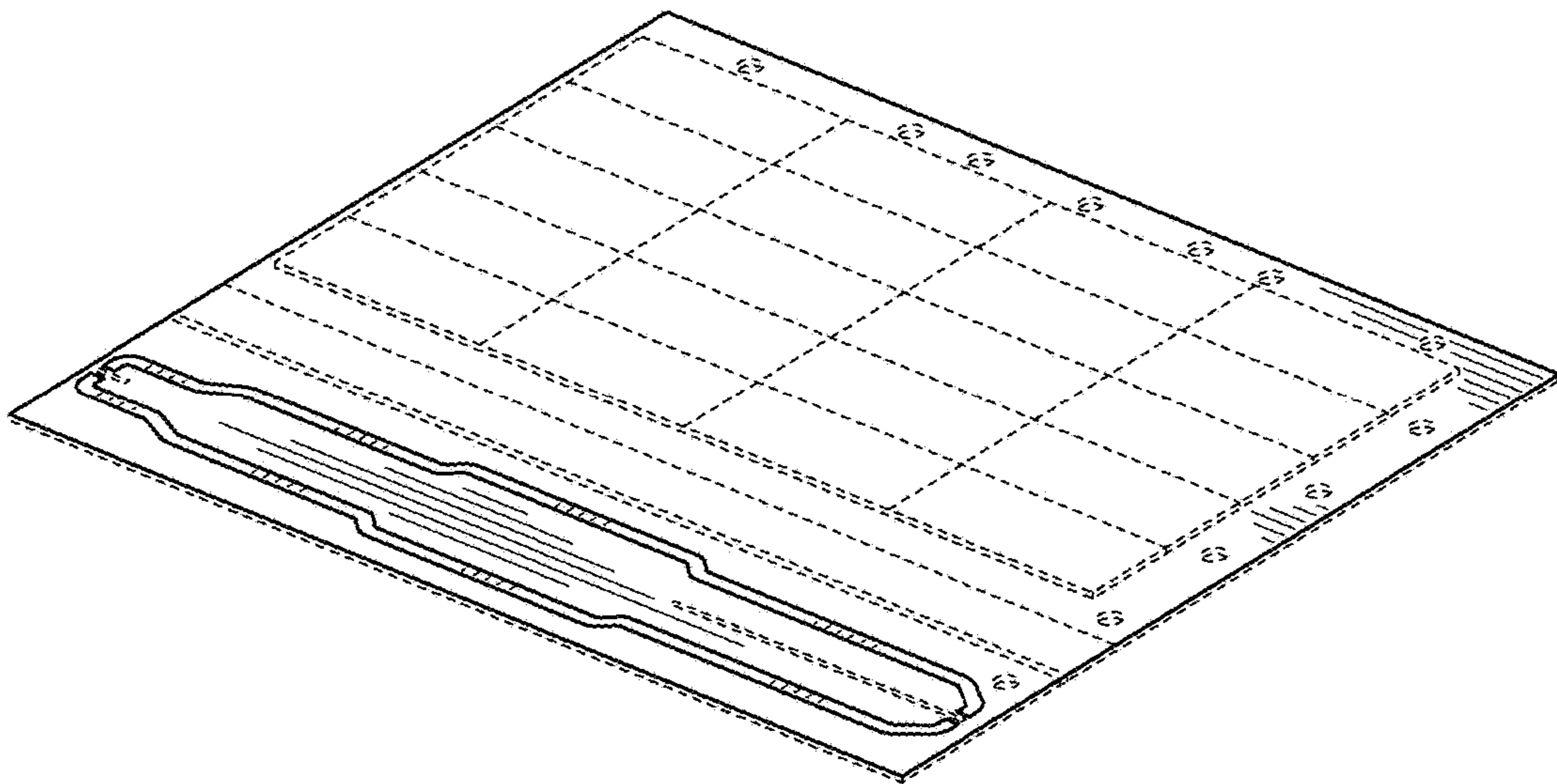

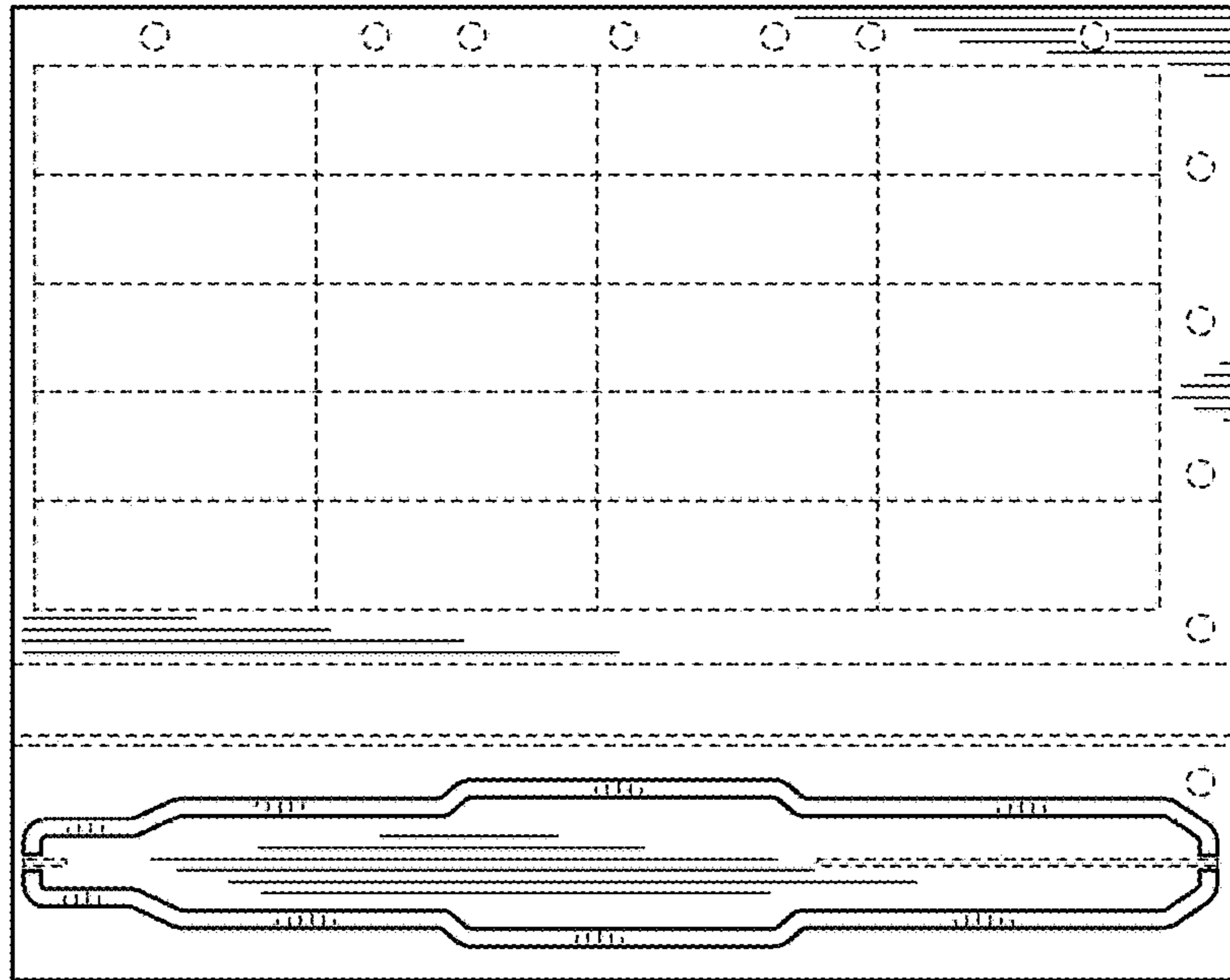

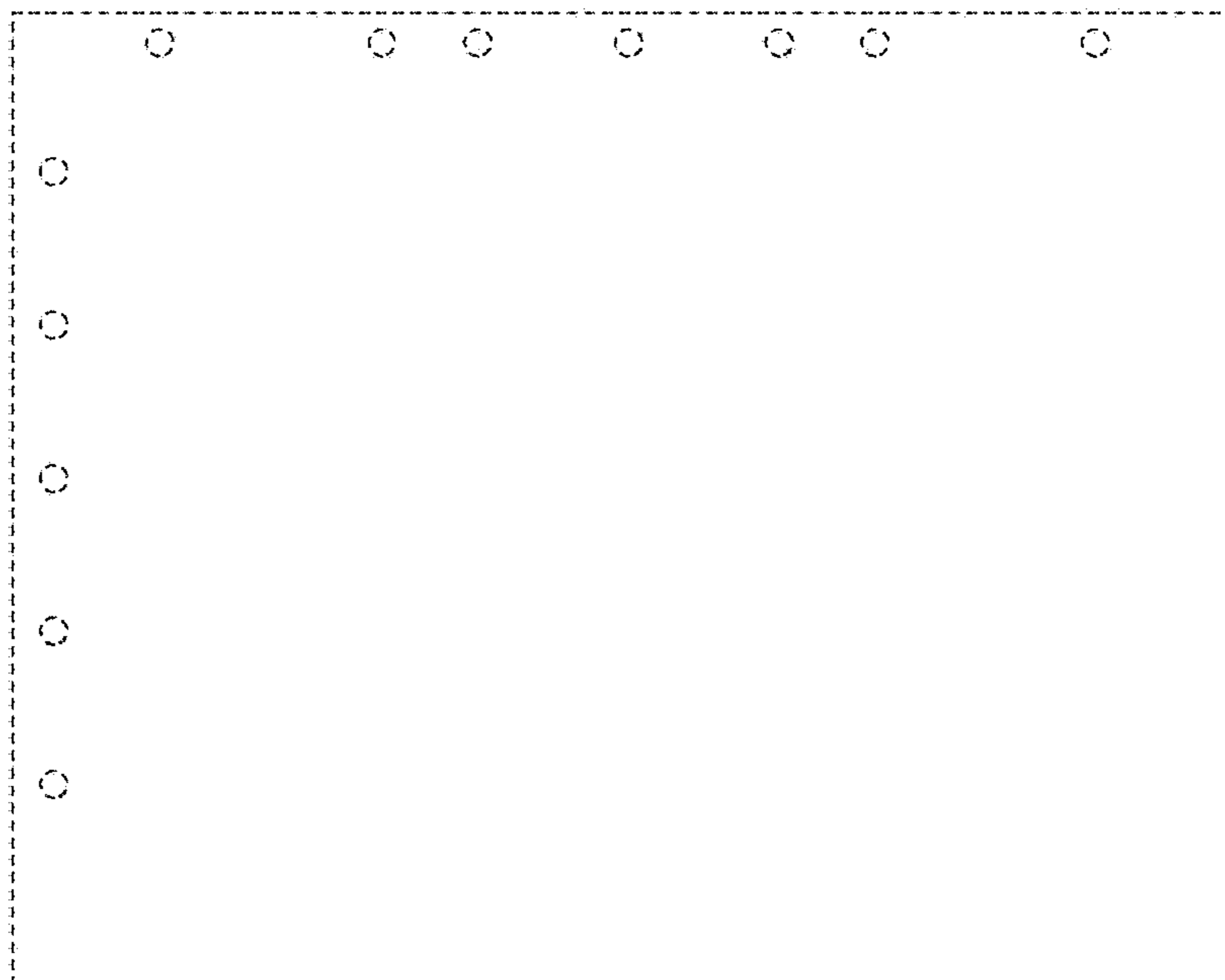

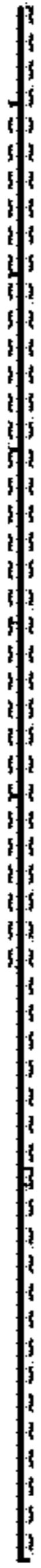

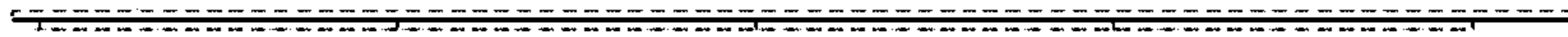

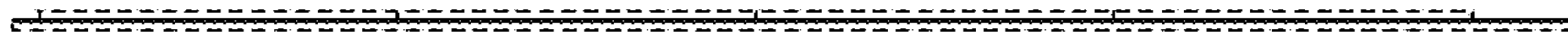
