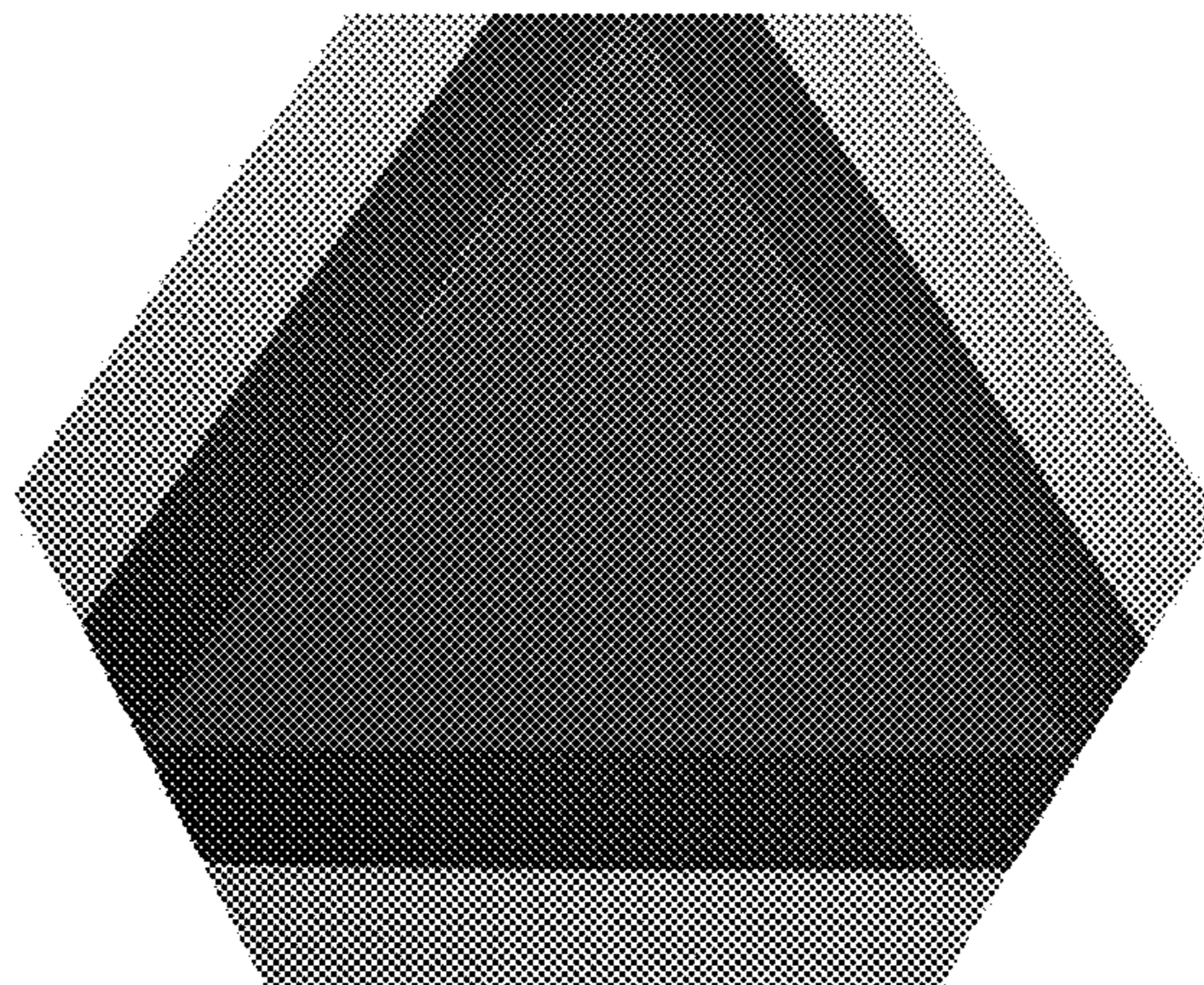
The ornamental design for cautionary signage, substantially as shown and described above.
