(57) **CLAIM**

The ornamental design for a spinning top toy, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the spinning top toy showing our design;

FIG. 2 is a left side view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is right side view thereof;

FIG. 5 is a top view thereof;

FIG. 6 is a bottom view thereof;

FIG. 7 is a perspective view thereof;

FIG. 8 is a front elevational view of the transparent portion of the design shown in isolation for clarity of disclosure;

FIG. 9 is a front view of the spinning top toy, corresponding to FIG. 1 but showing contour shading to the exterior parts and with the interior parts omitted;

FIG. 10 is a left side view thereof corresponding to FIG. 2 but showing contour shading to the exterior parts and with the interior parts omitted for clarity of disclosure;

FIG. 11 is a rear view thereof corresponding to FIG. 3 but showing contour shading to the exterior parts and with the interior parts omitted for clarity of disclosure;

FIG. 12 is right side view thereof corresponding to FIG. 4 but showing contour shading to the exterior parts and with the interior parts omitted for clarity of disclosure;

FIG. 13 is a top view thereof corresponding to FIG. 5 but showing contour shading to the exterior parts and with the interior parts omitted for clarity of disclosure;

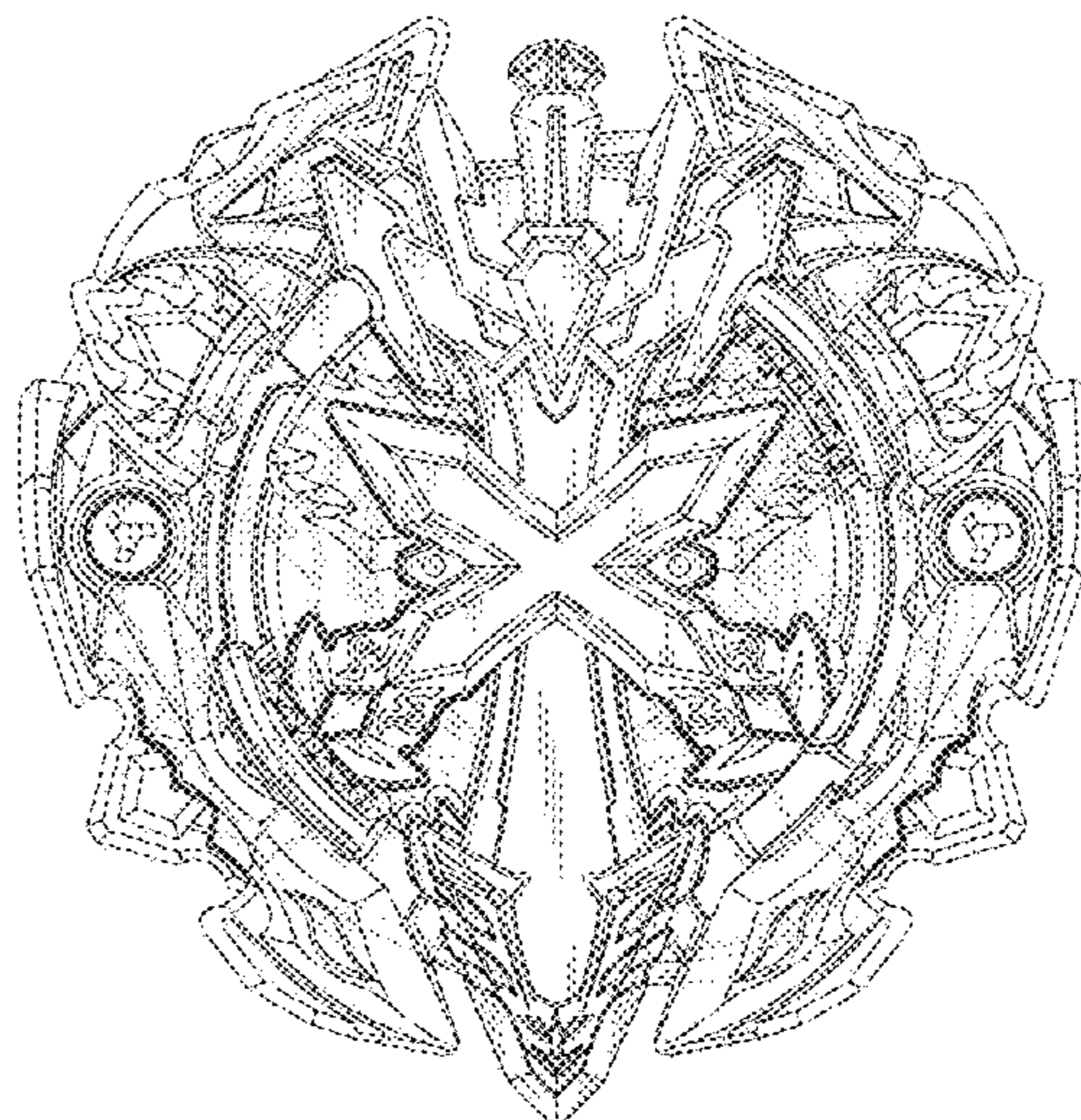
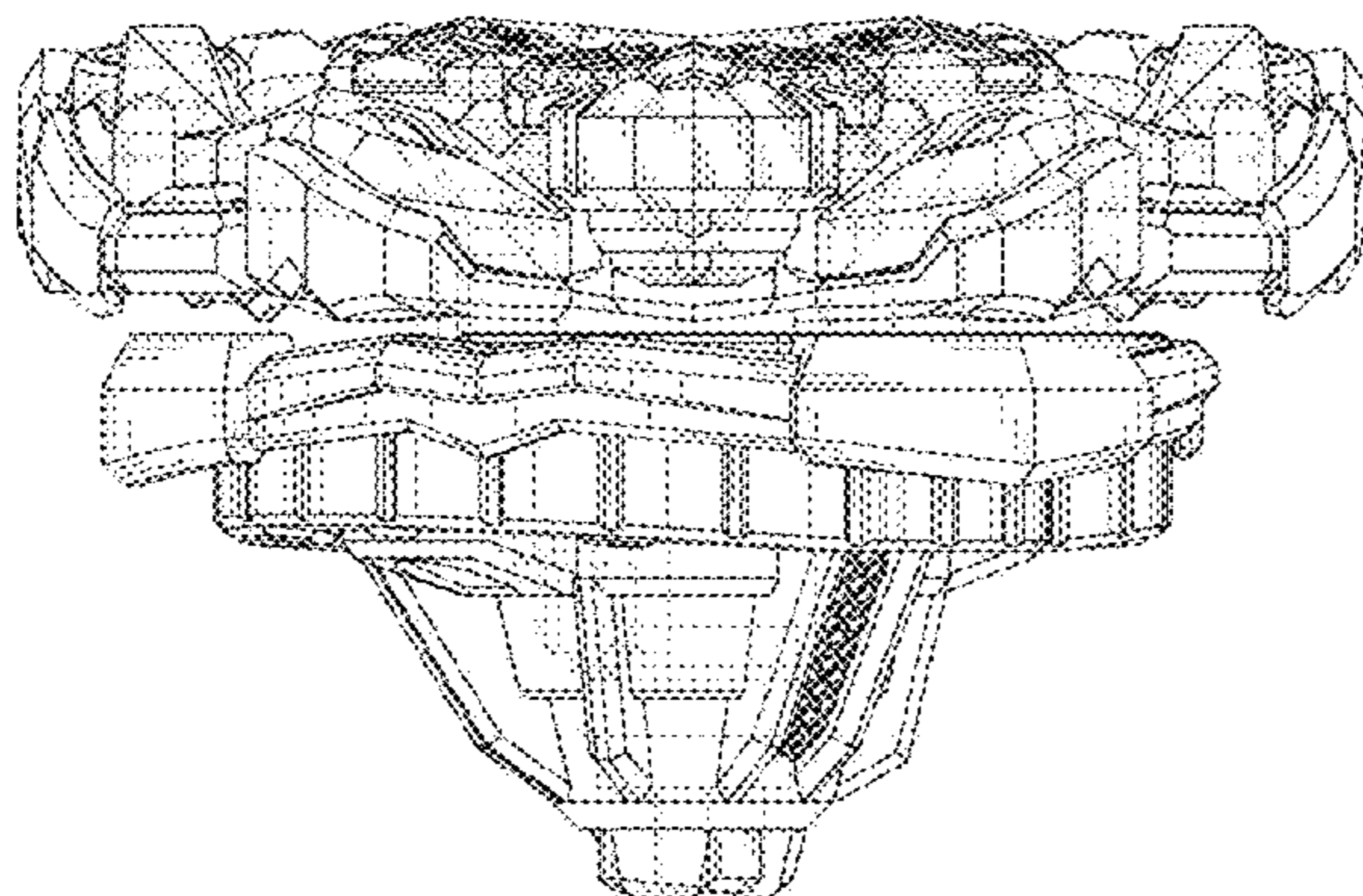

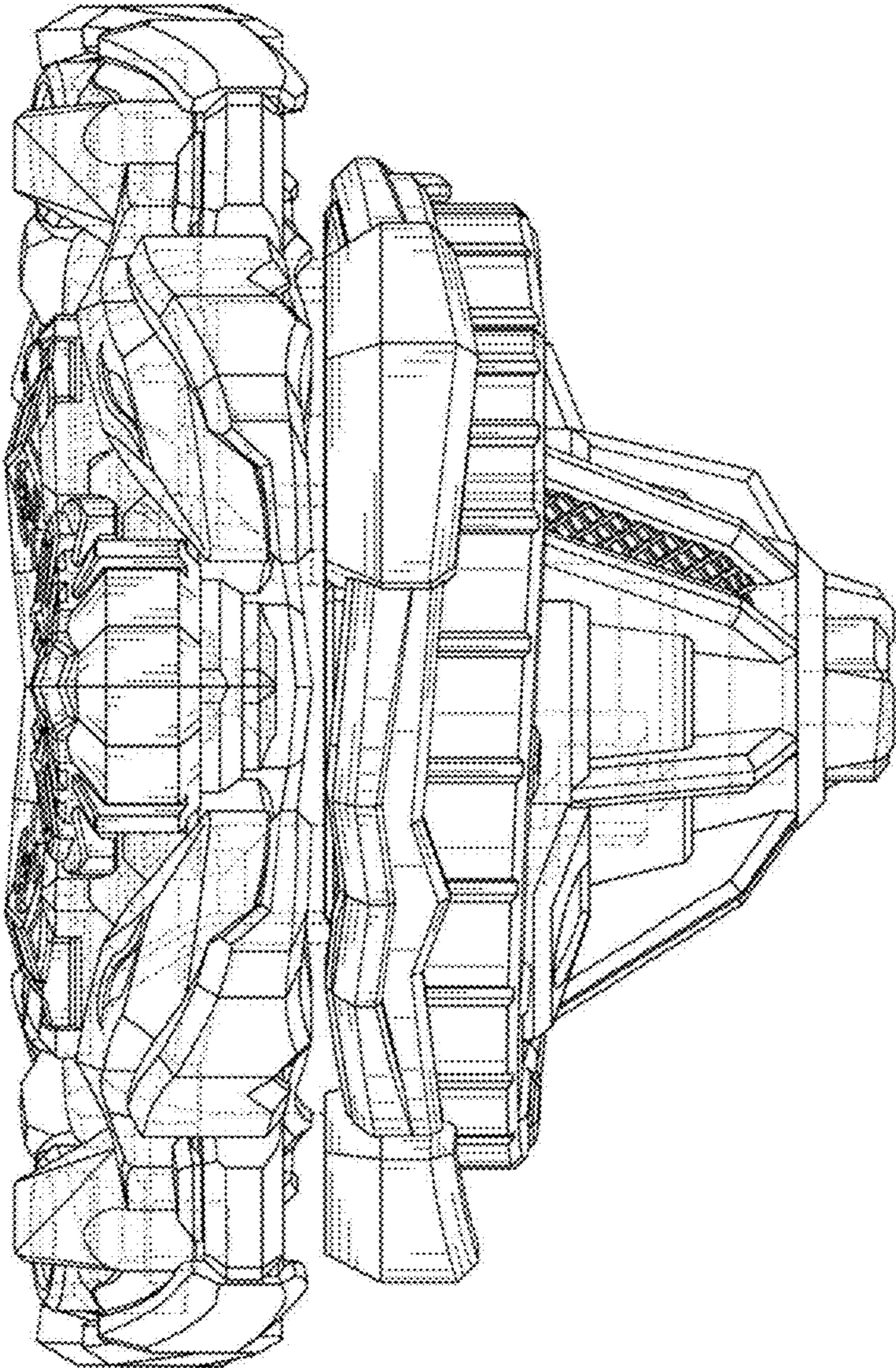

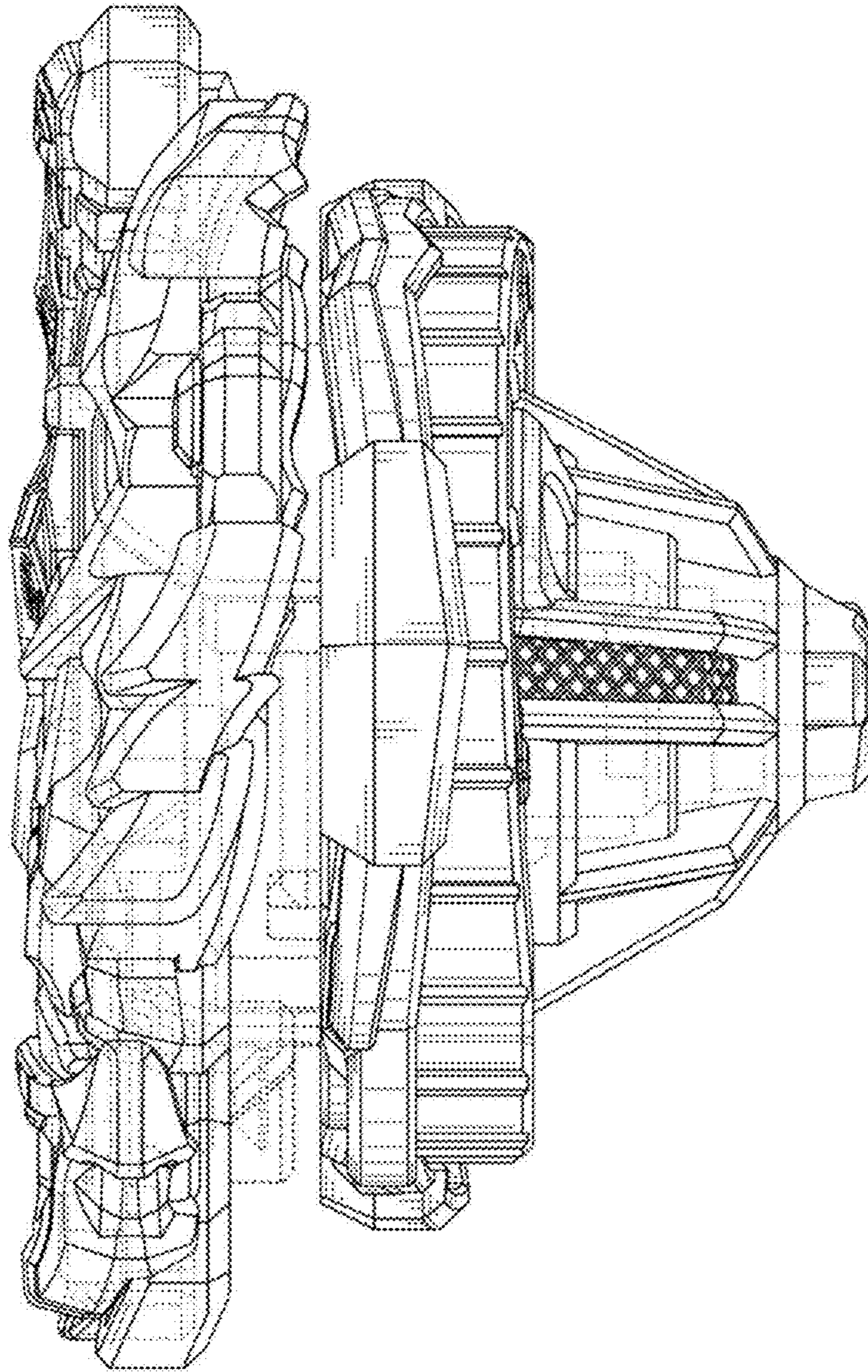

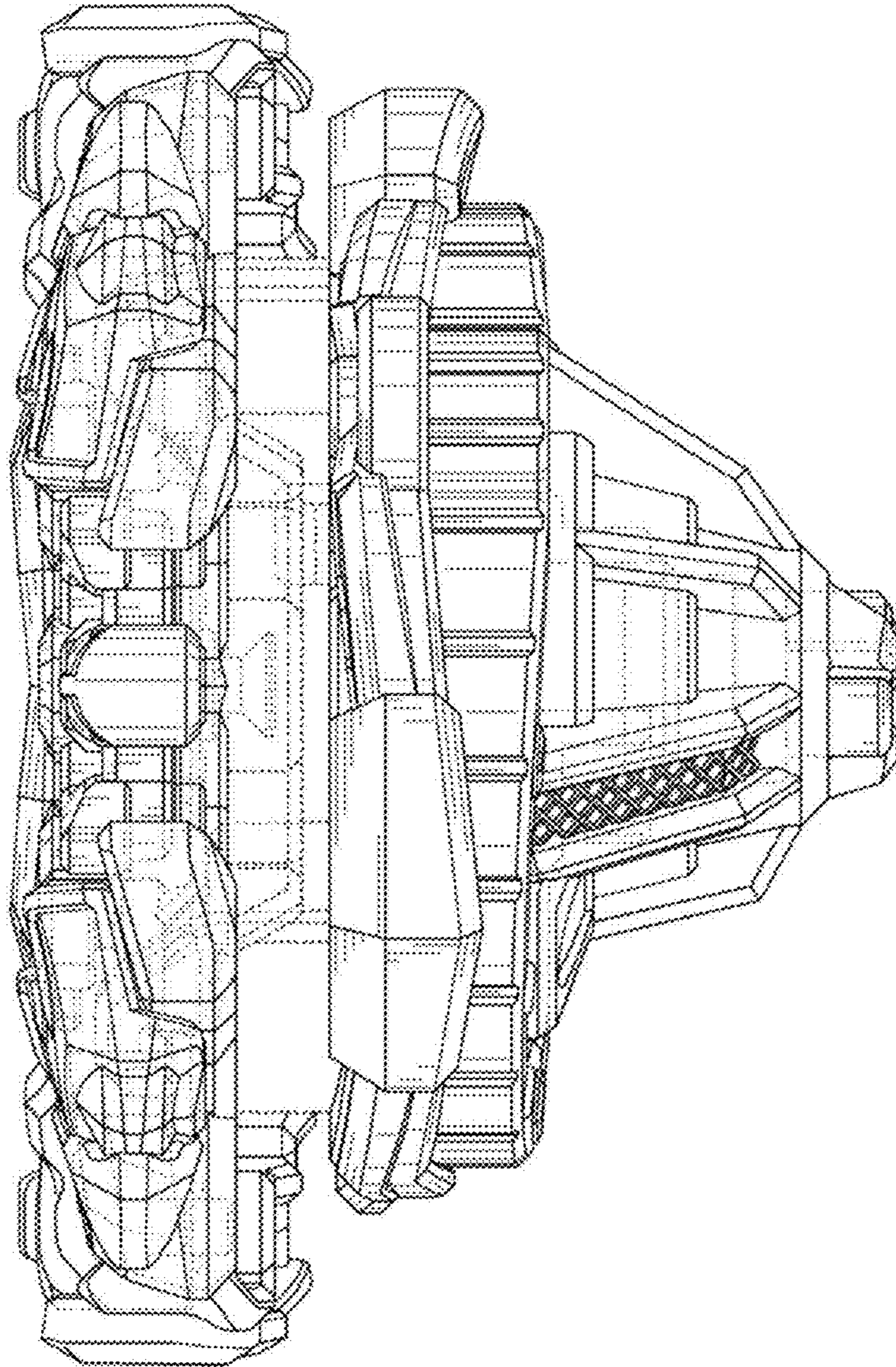

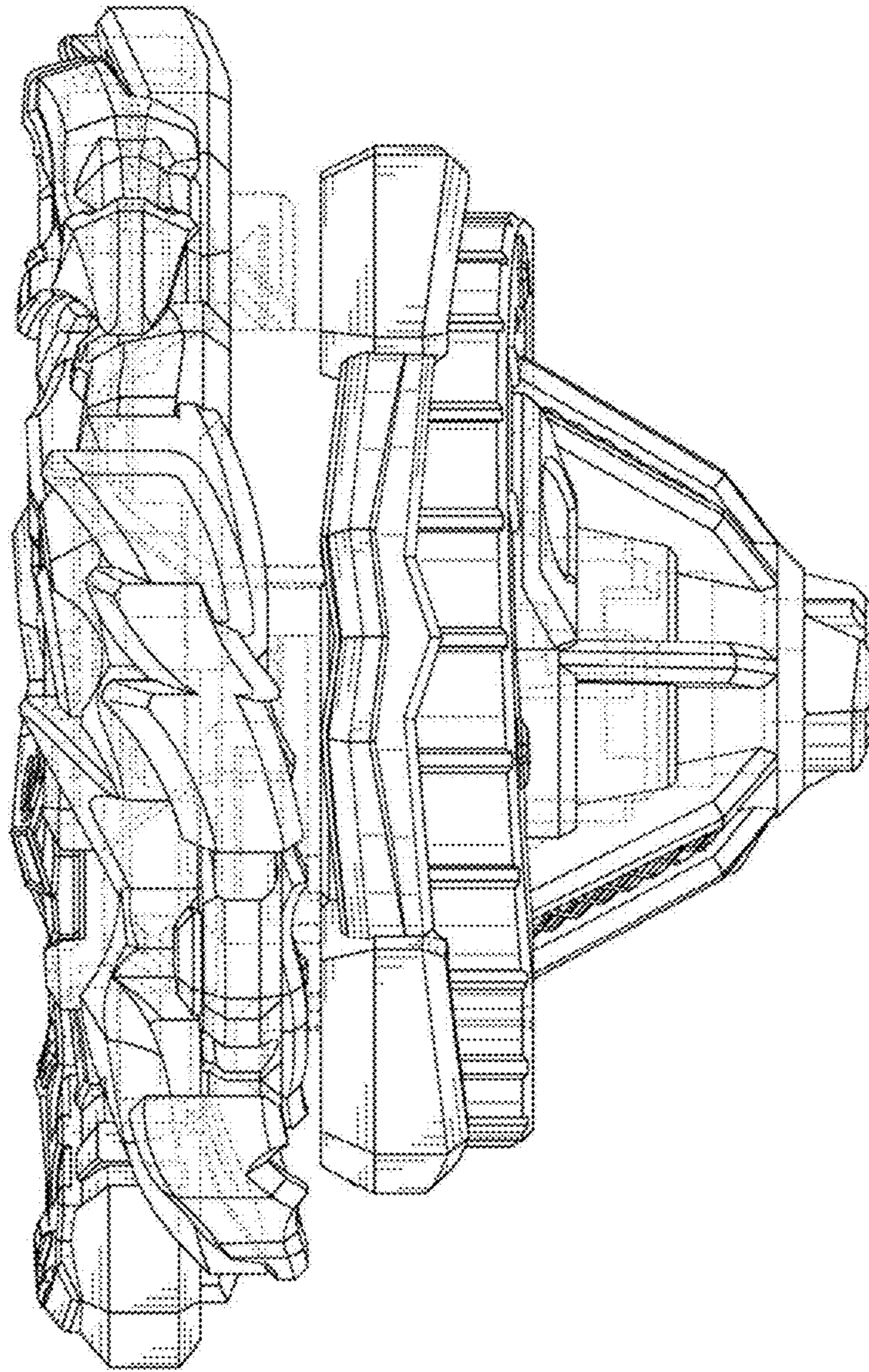

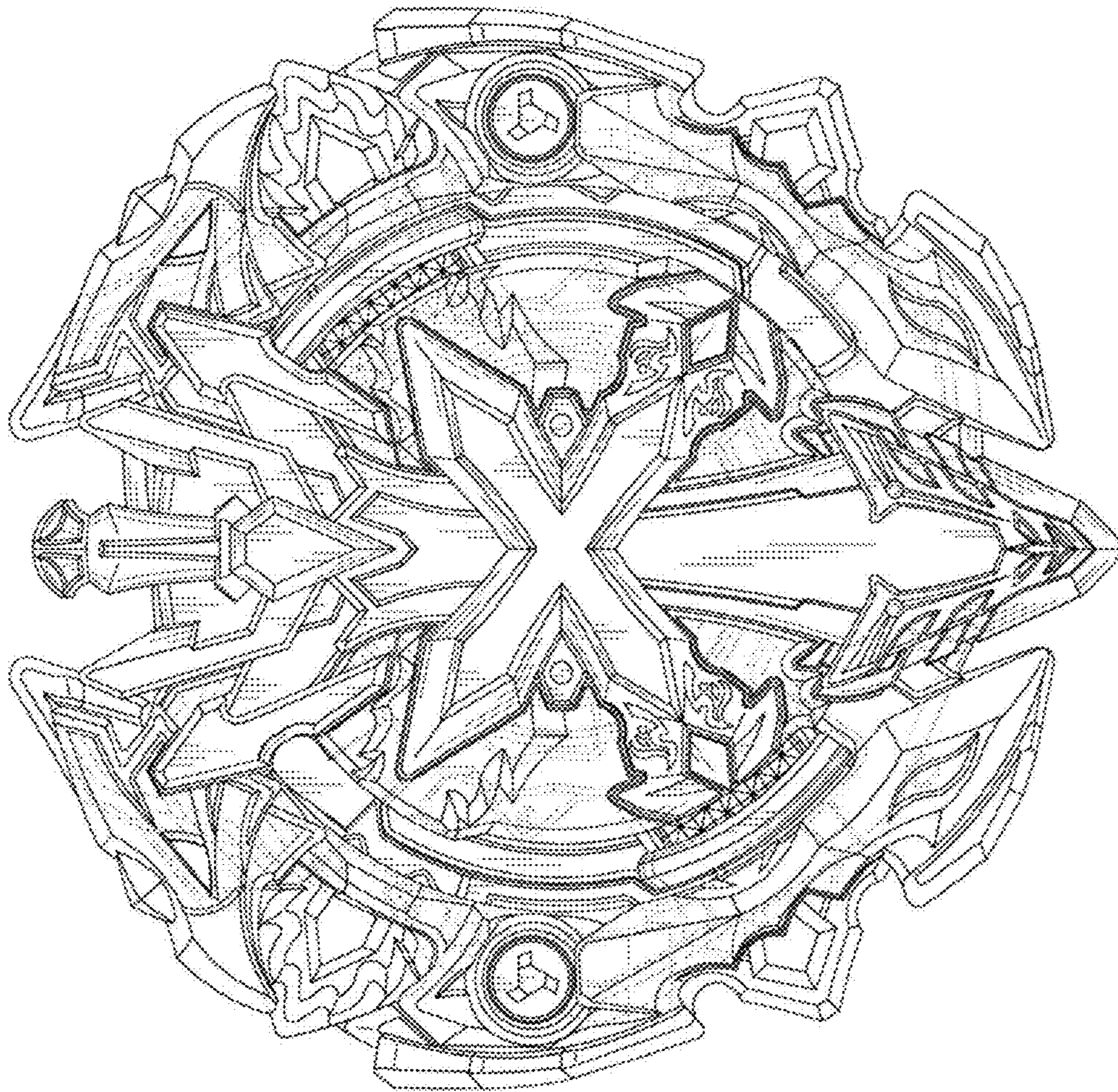

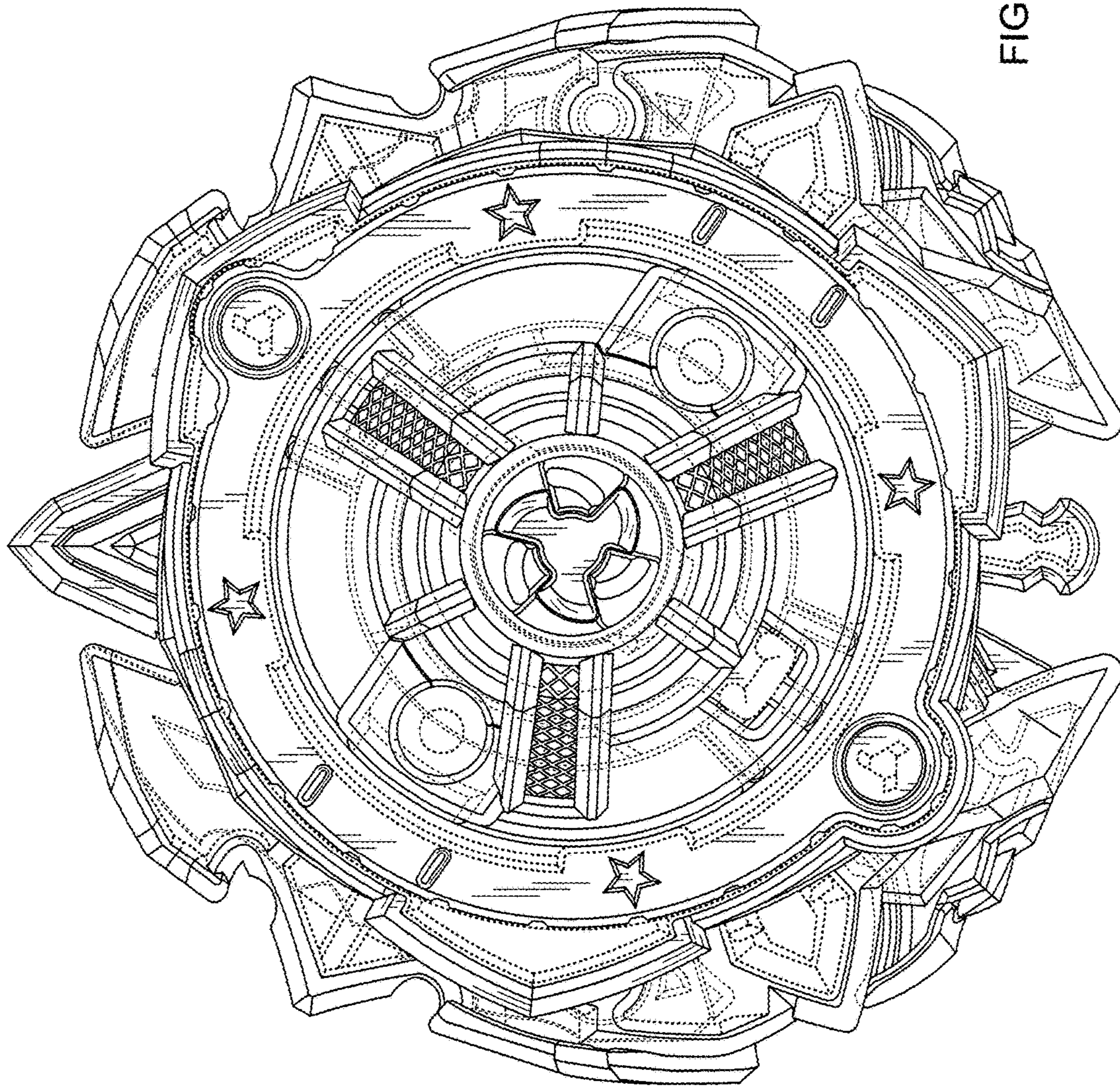

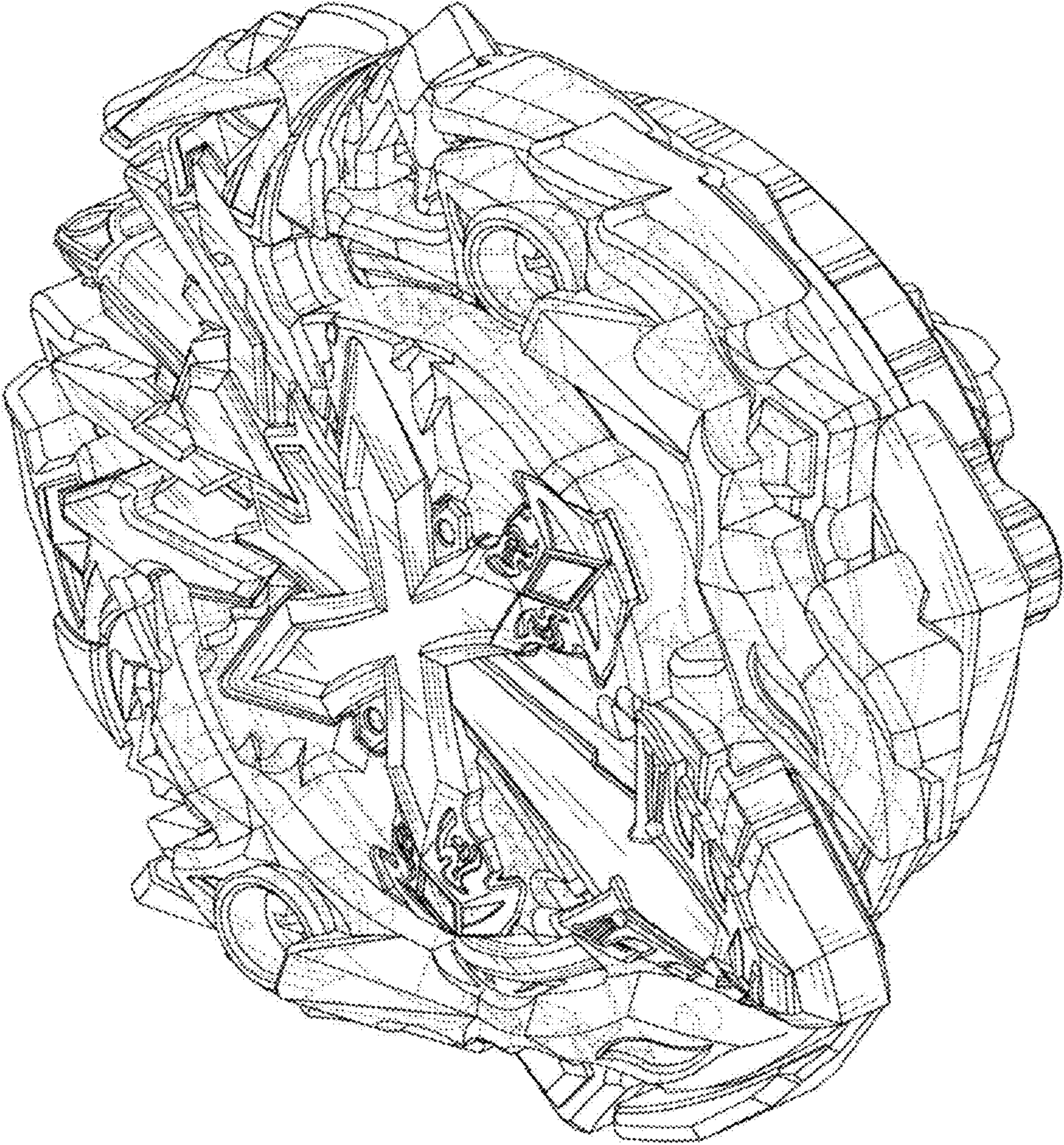

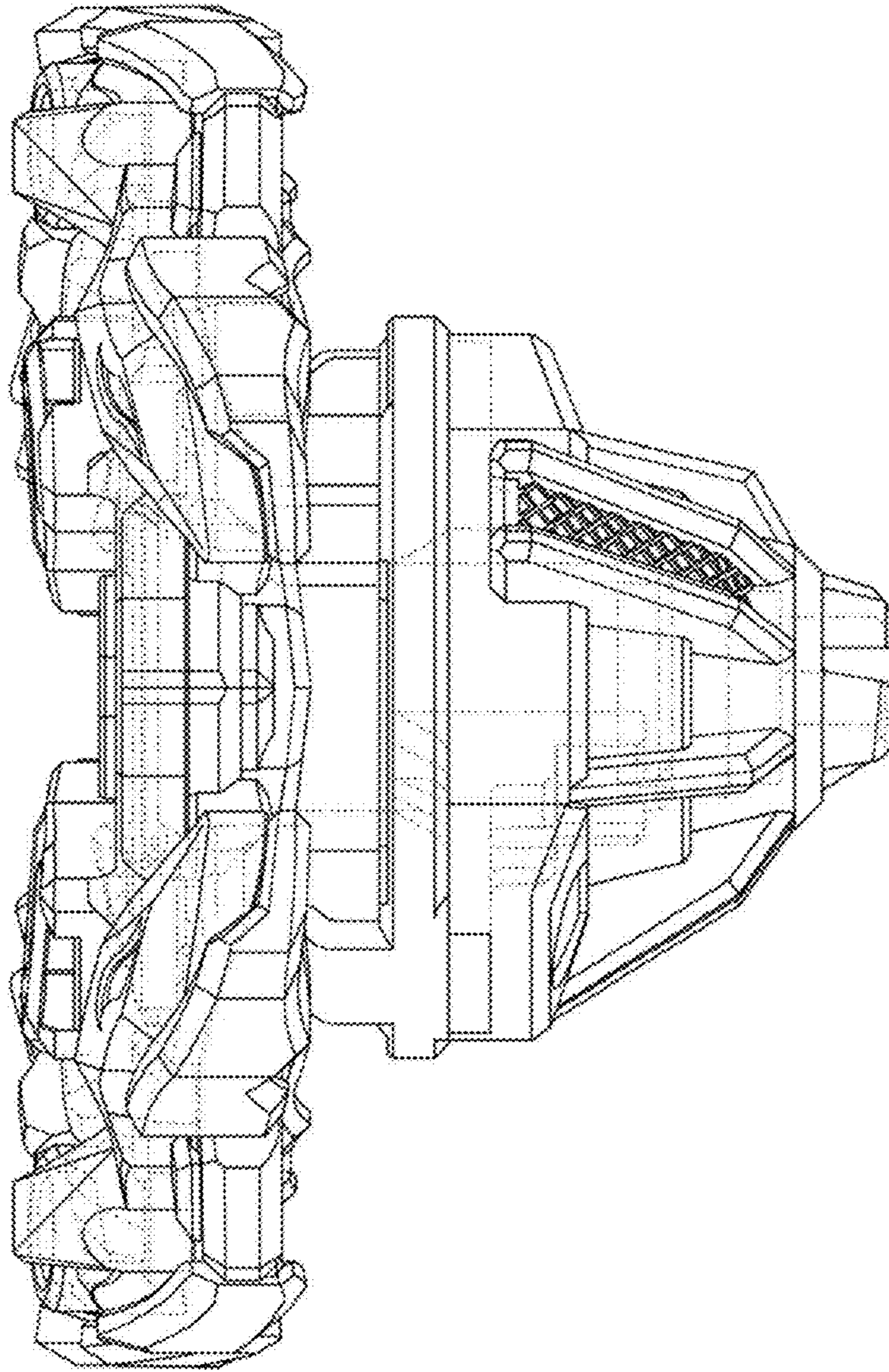

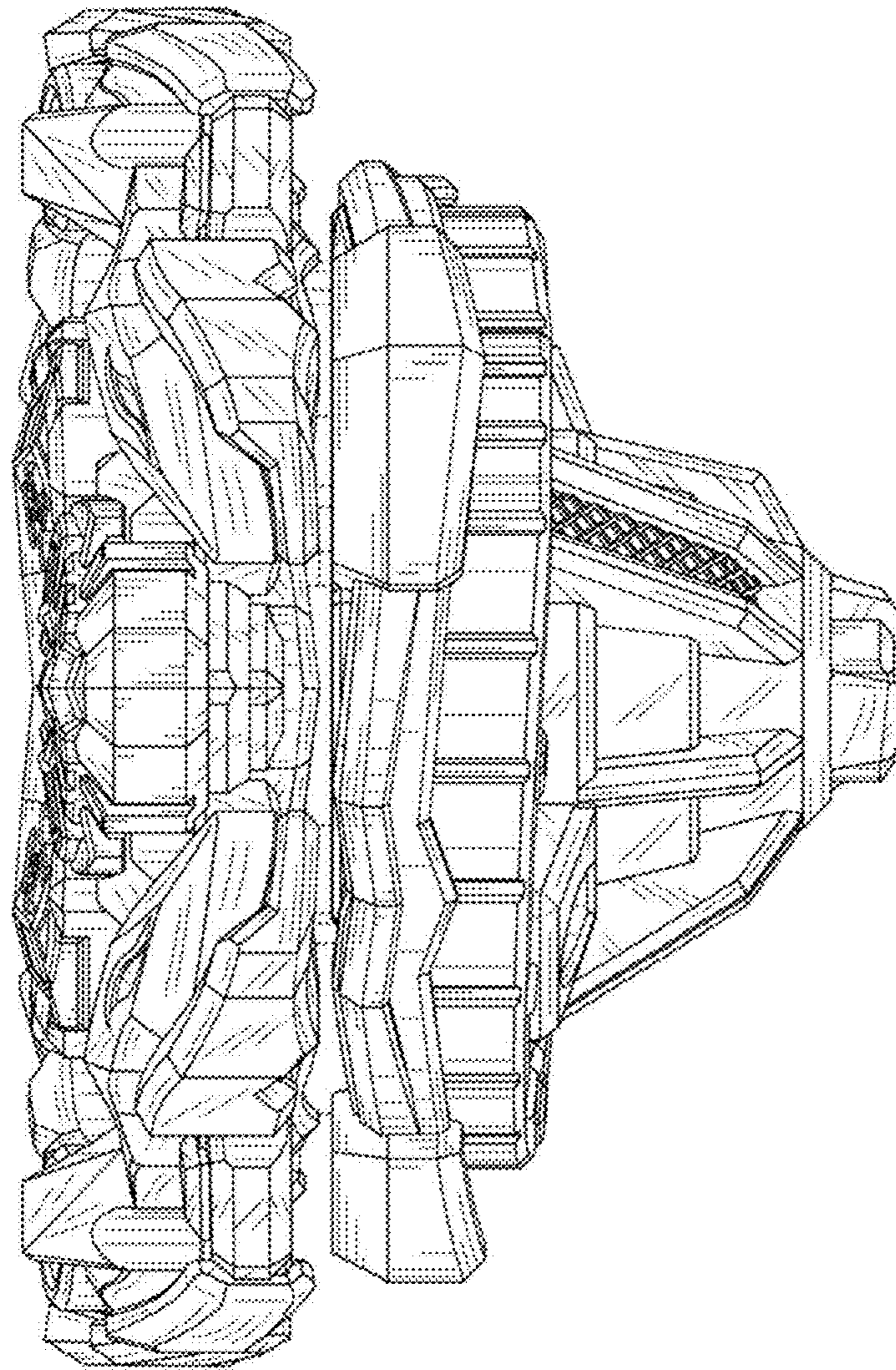

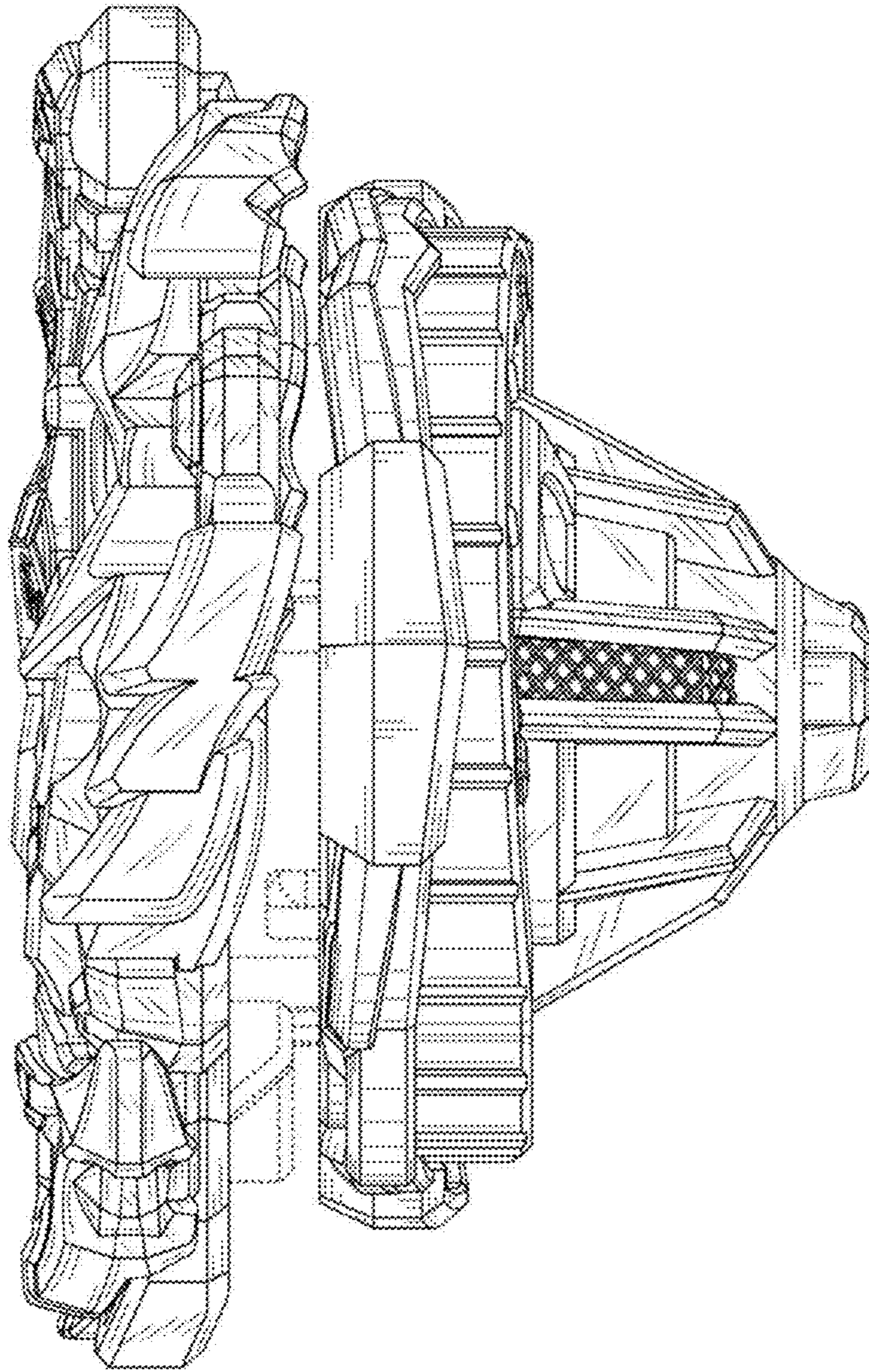

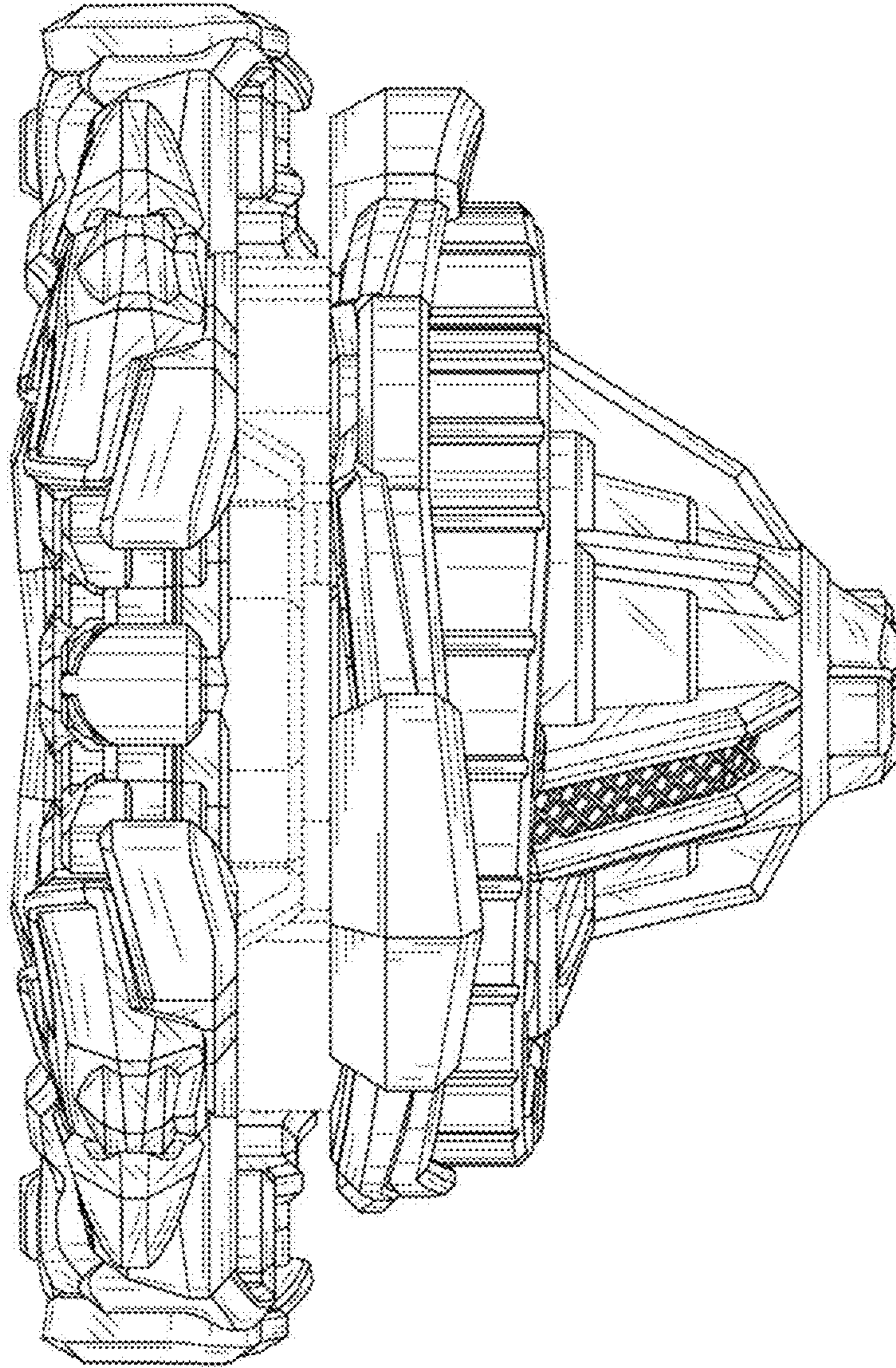

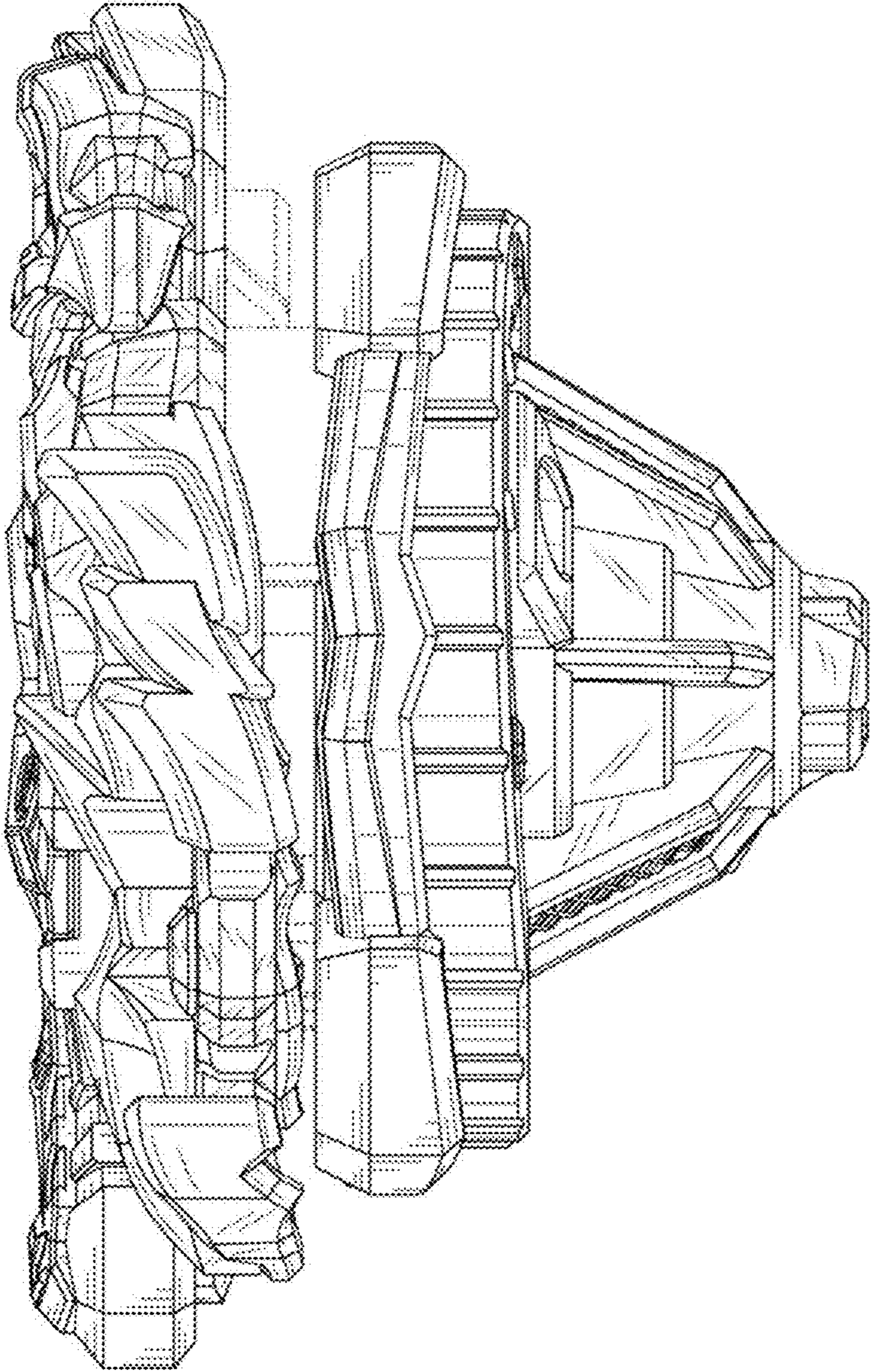

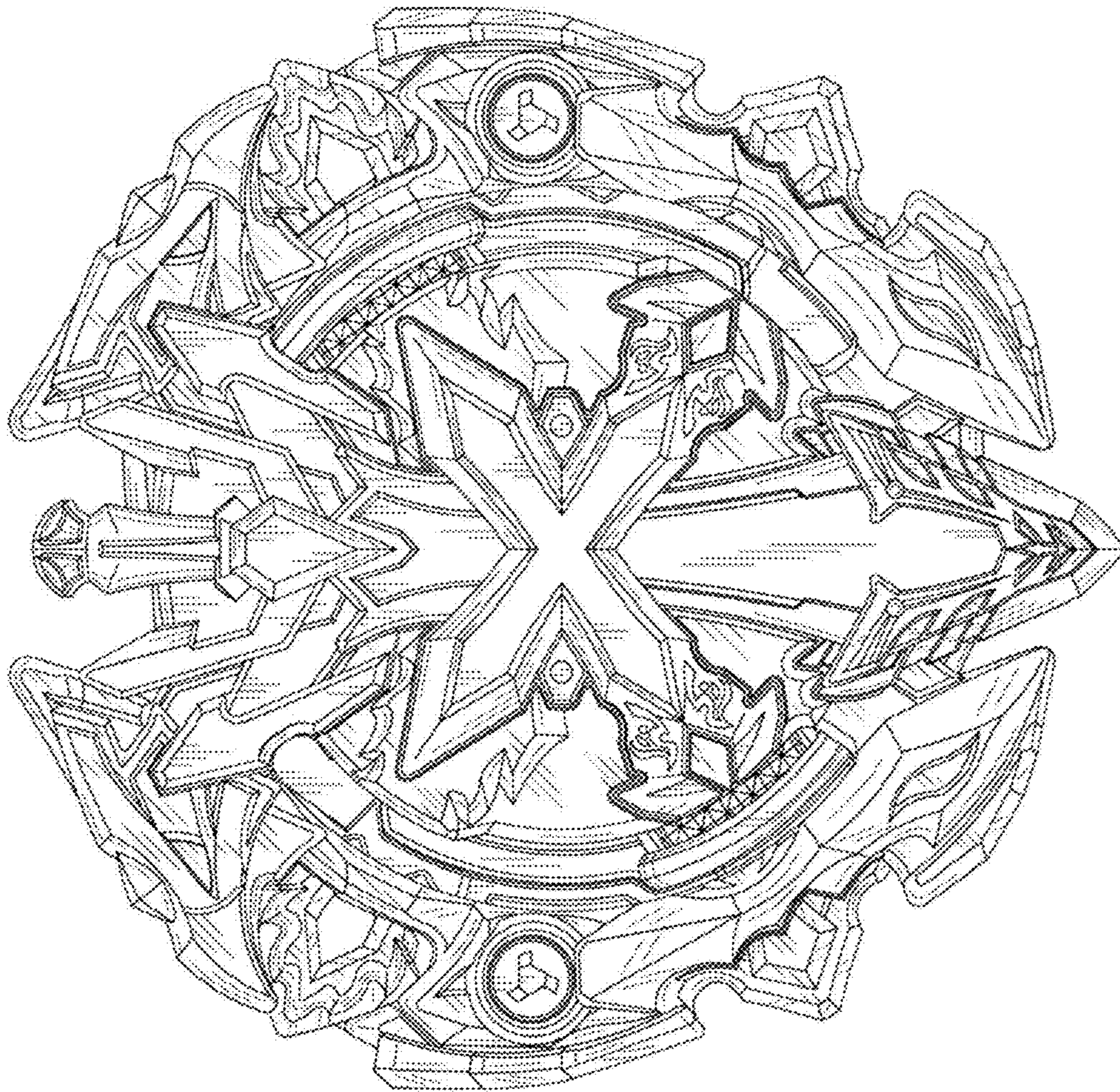

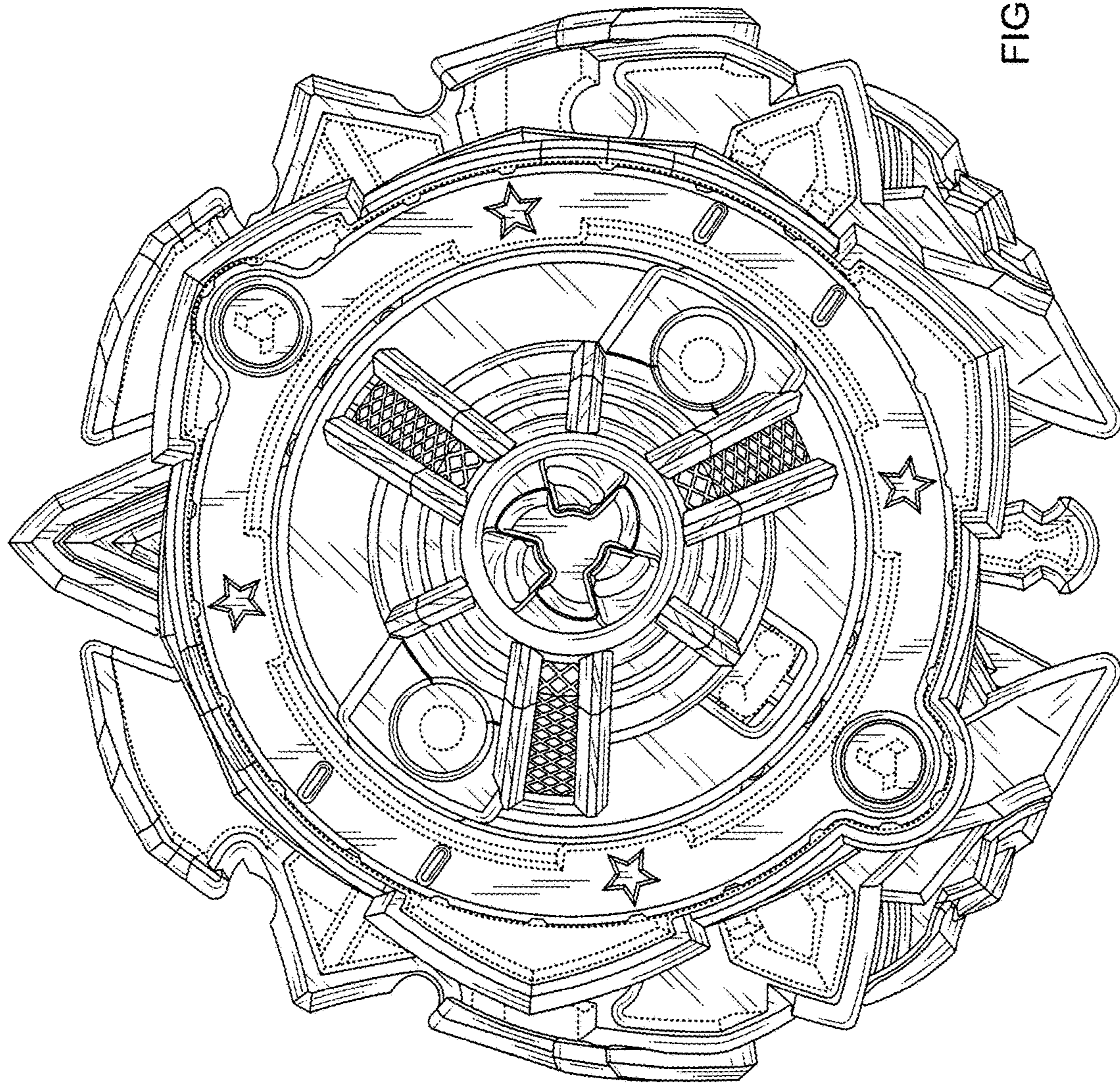

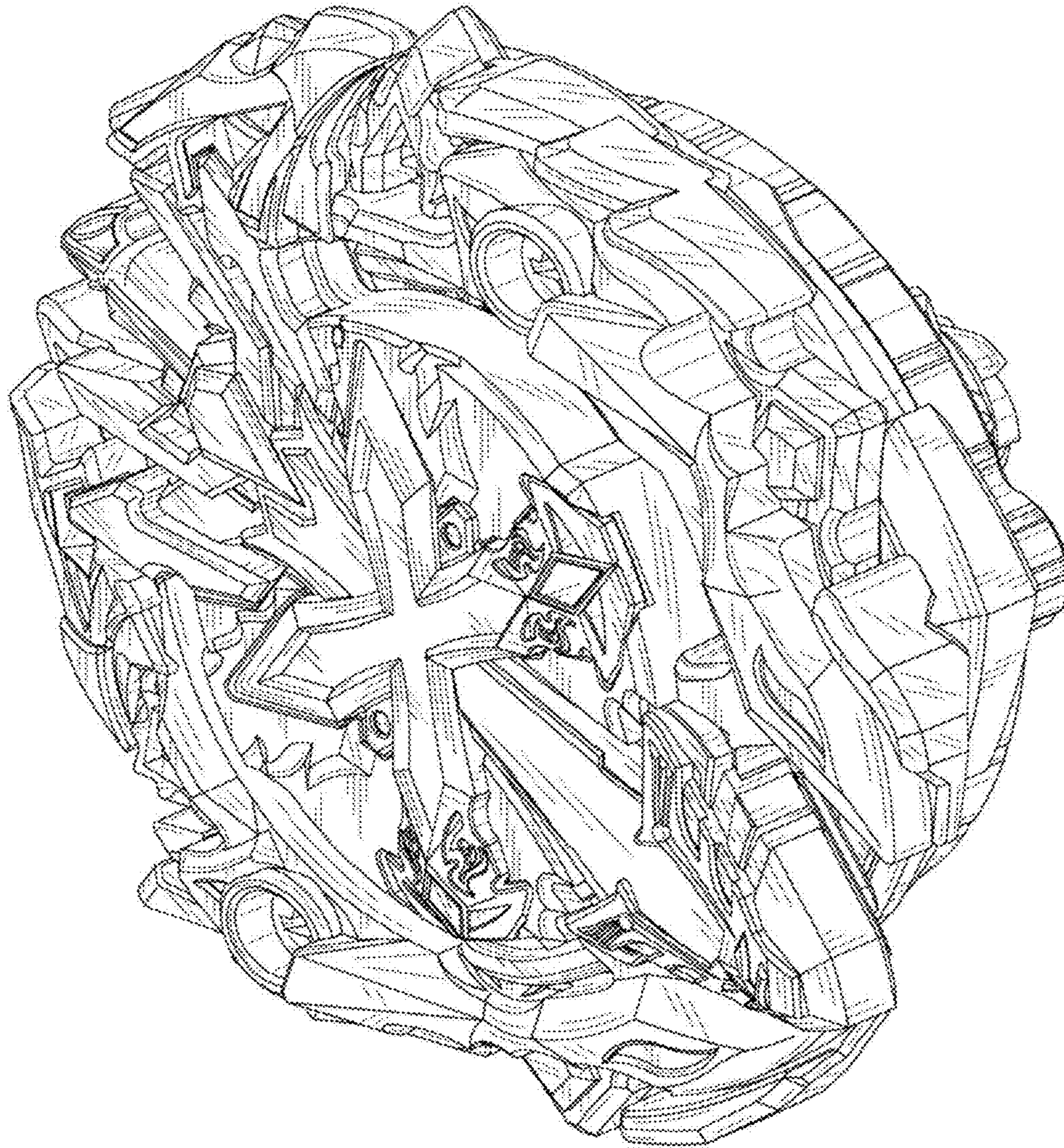

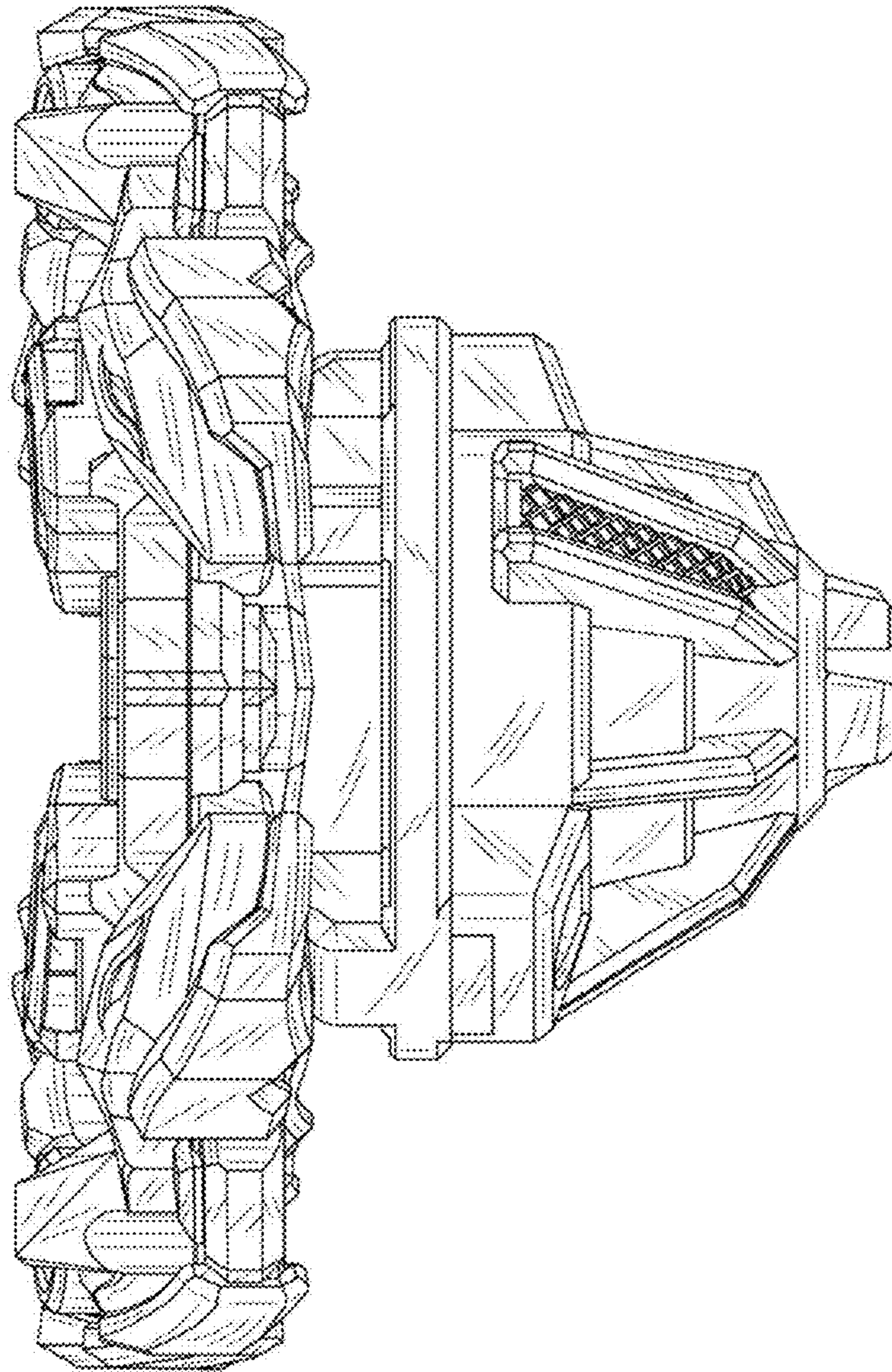
