(57) **CLAIM**

I claim the ornamental design for a toy train, as shown and described.

DESCRIPTION

FIG. 1 is a right side view of a toy train, having an engine, handcar, passenger car and caboose.

FIG. 2 is a front perspective view of the engine of the toy train of FIG. 1.

FIG. 3 is a front view of the engine of the toy train of FIG. 2.

FIG. 4 is a rear view of the engine of the toy train of FIG. 2.

FIG. 5 is a top view of the engine of the toy train of FIG. 2.

FIG. 6 is a bottom view of the engine of the toy train of FIG. 2.

FIG. 7 is a side view of the left side of the engine of the toy train of FIG. 2.

FIG. 8 is a side view of the right side of the engine of the toy train of FIG. 2.

FIG. 9 is a front perspective view of the handcar of the toy train of FIG. 1.

FIG. 10 is a front view of the handcar of the toy train of FIG. 9.

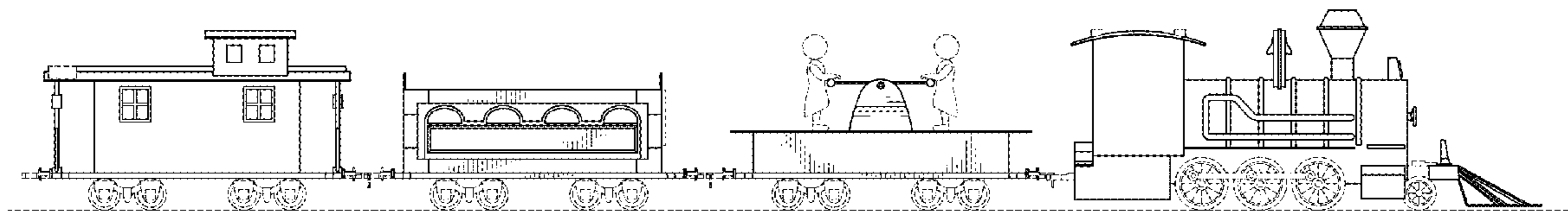


FIG. 25 is a rear view of the caboose of the toy train of FIG. 23.

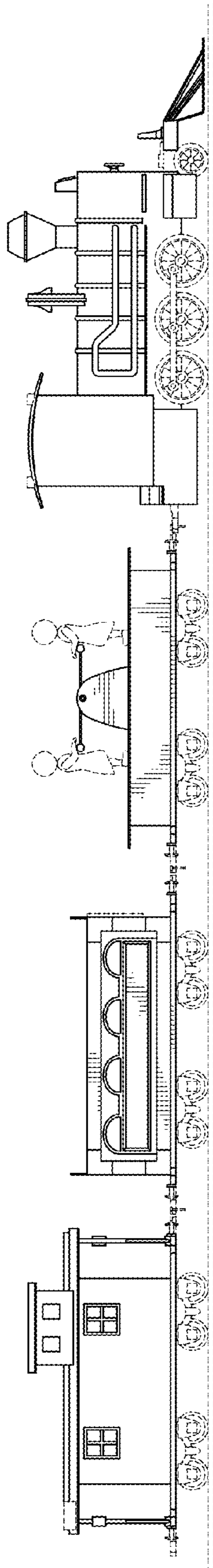
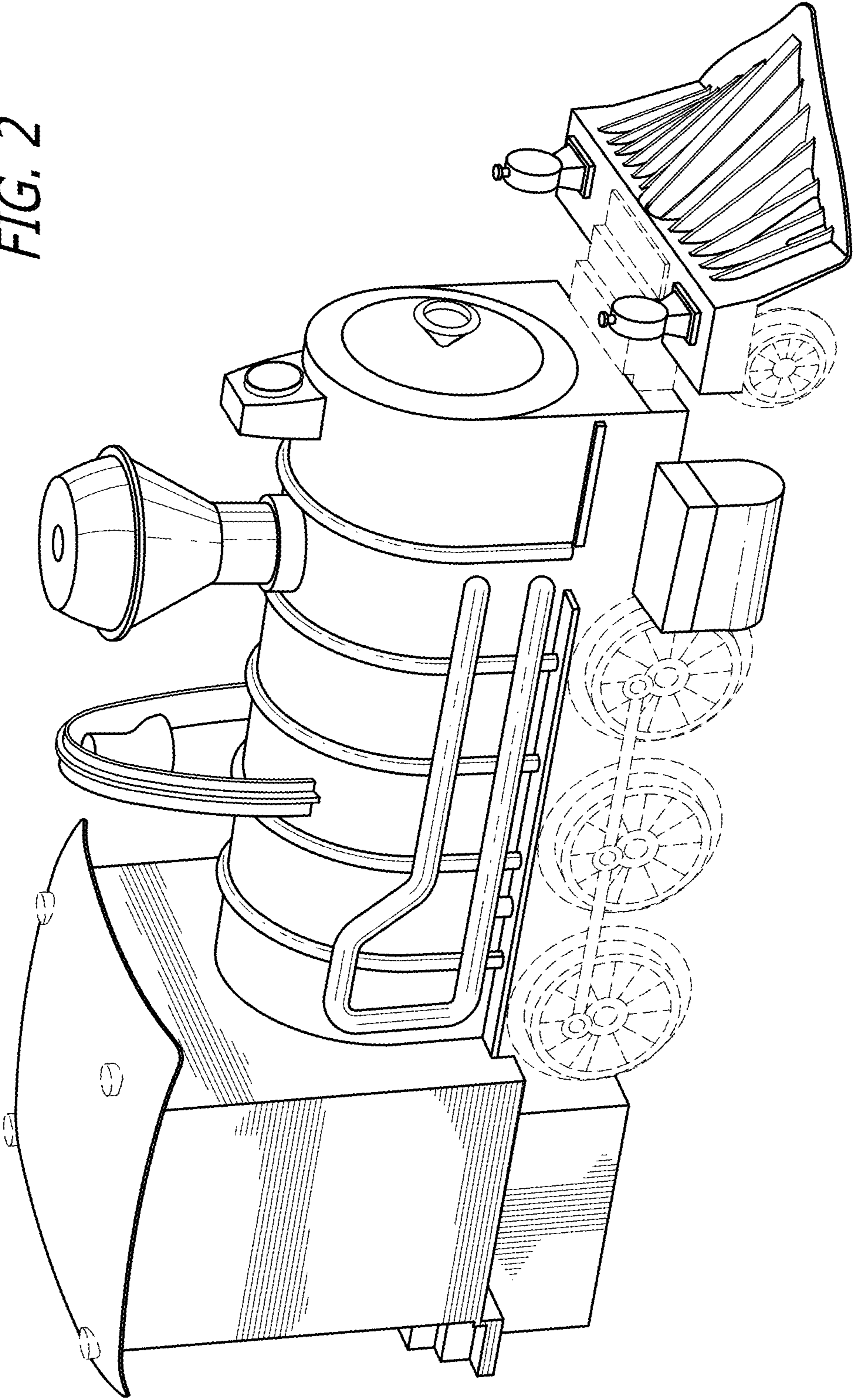

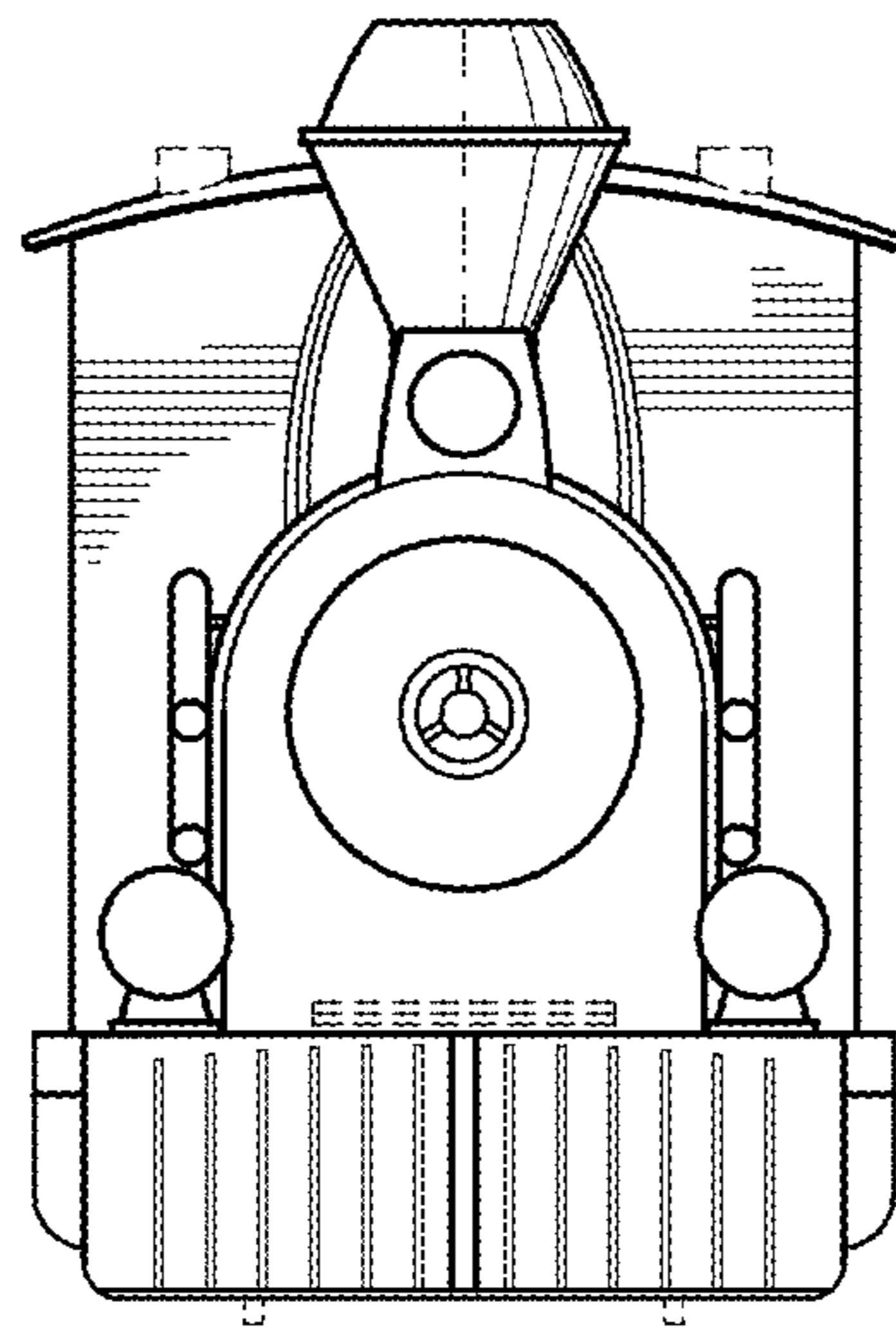

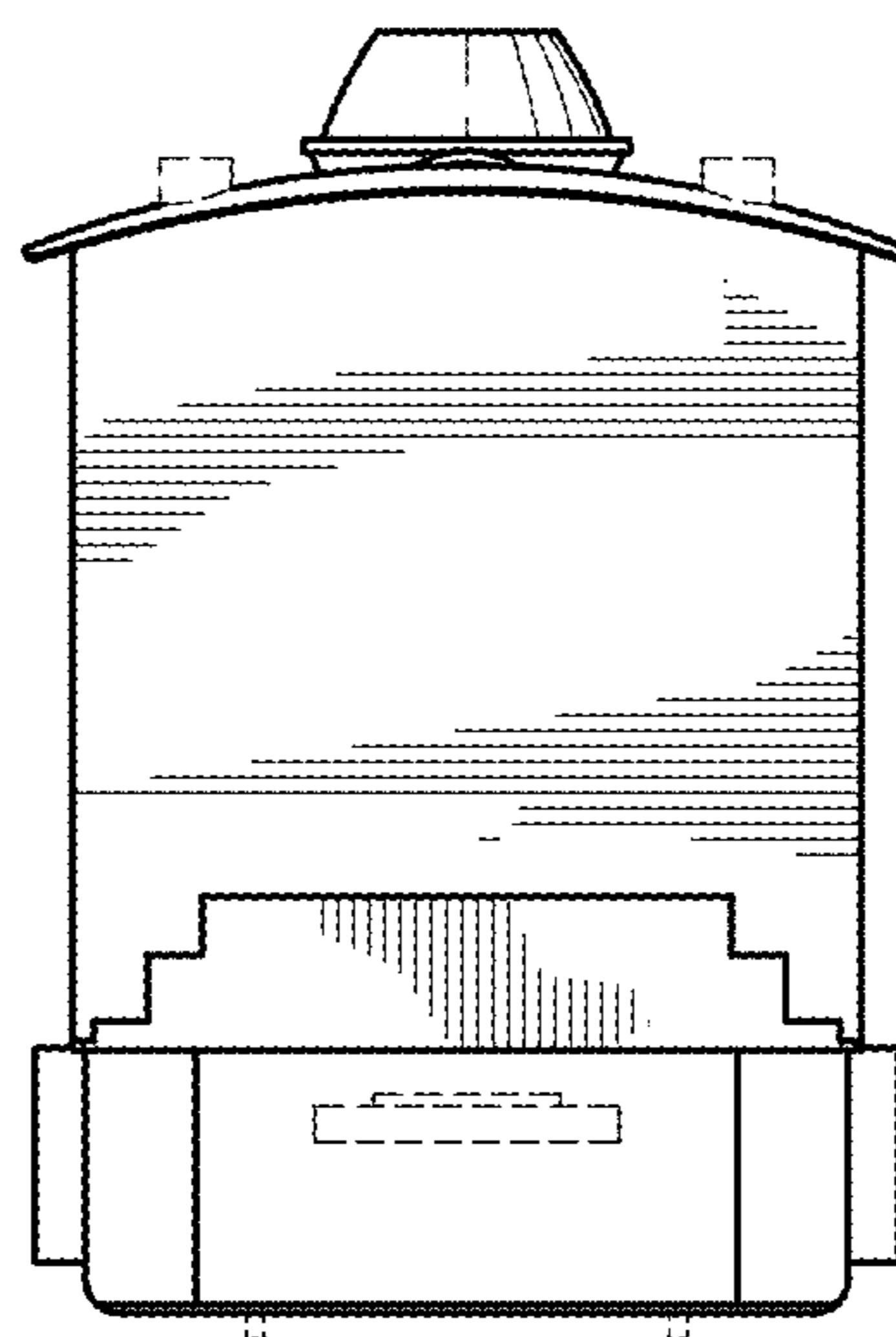

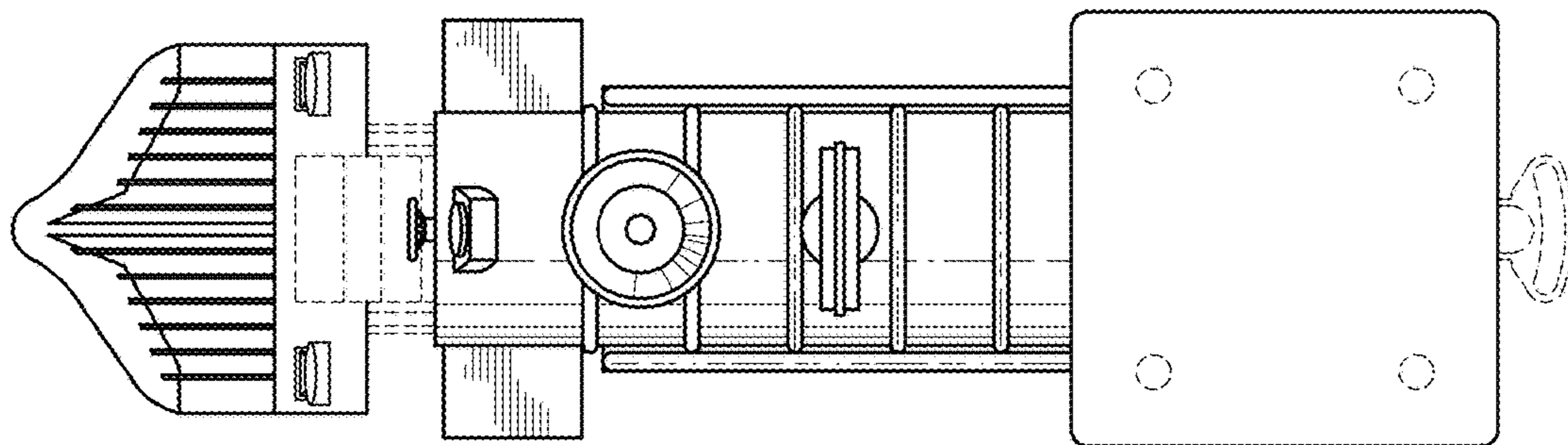

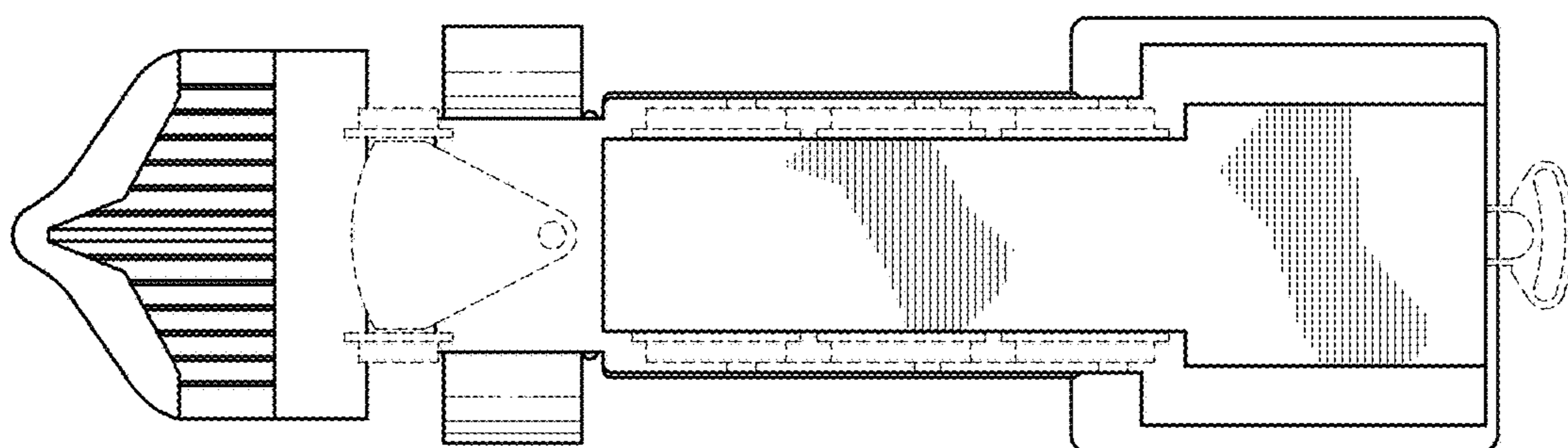

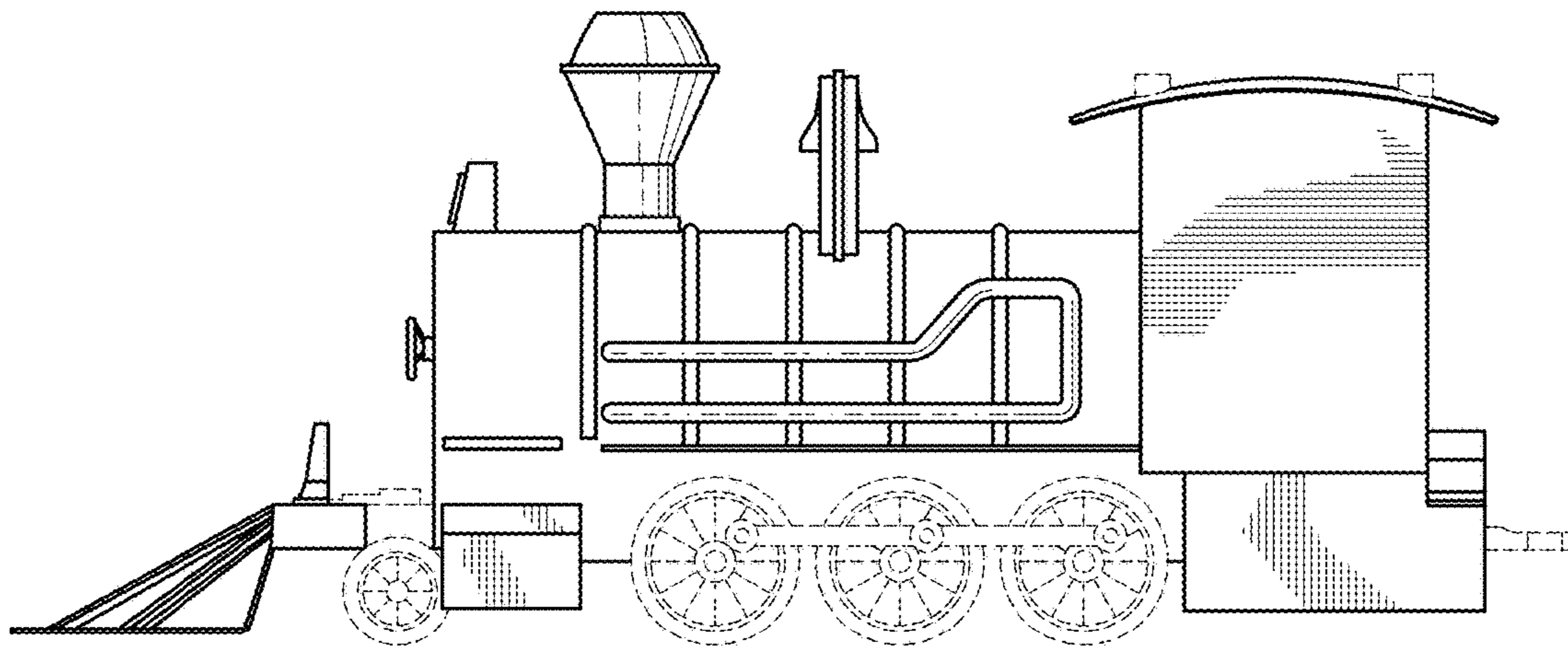

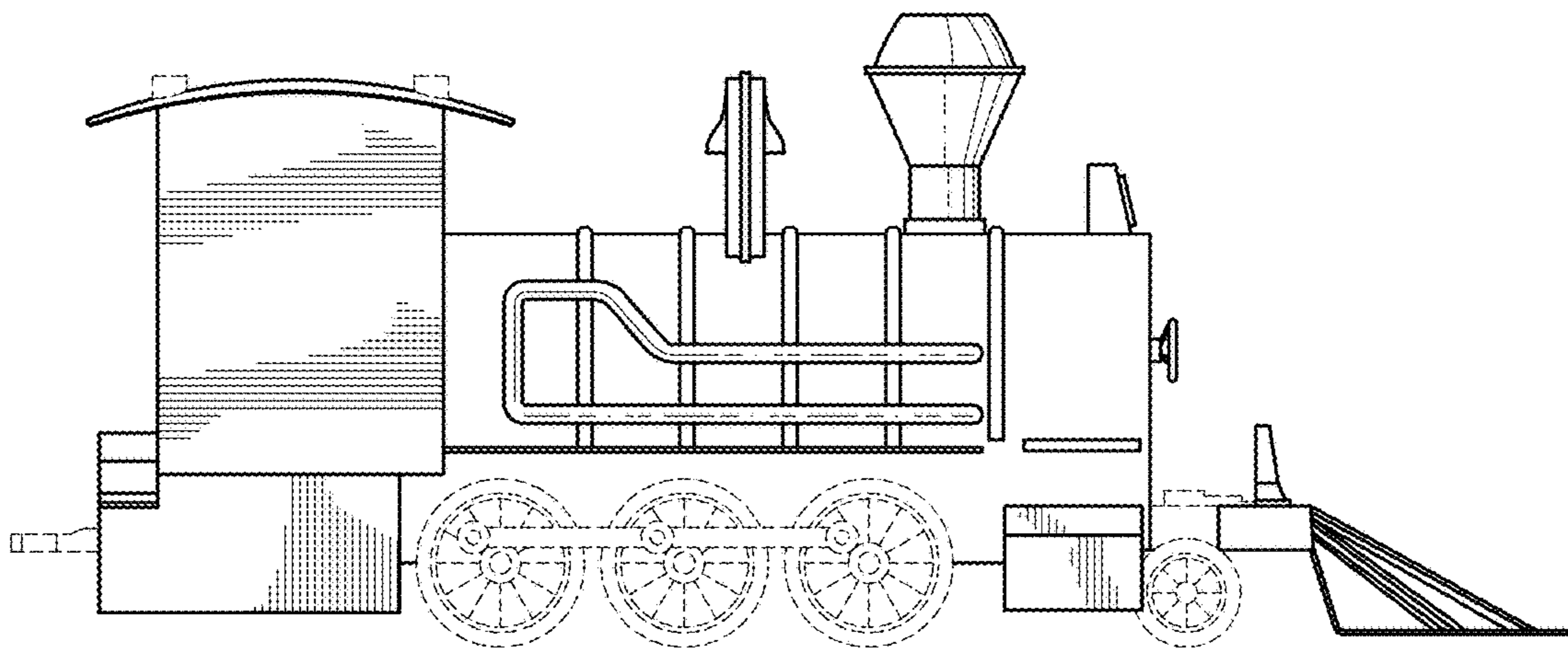

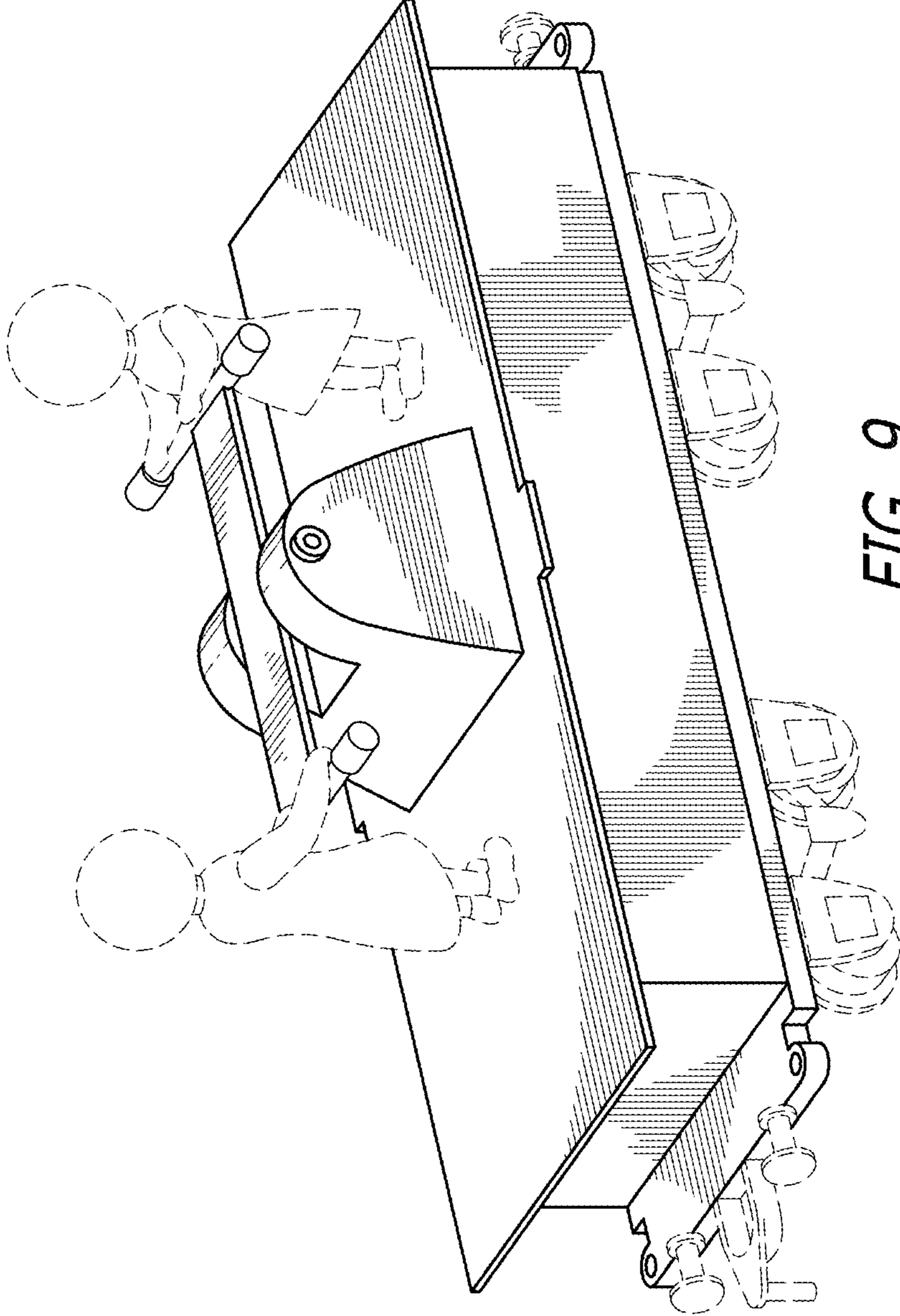

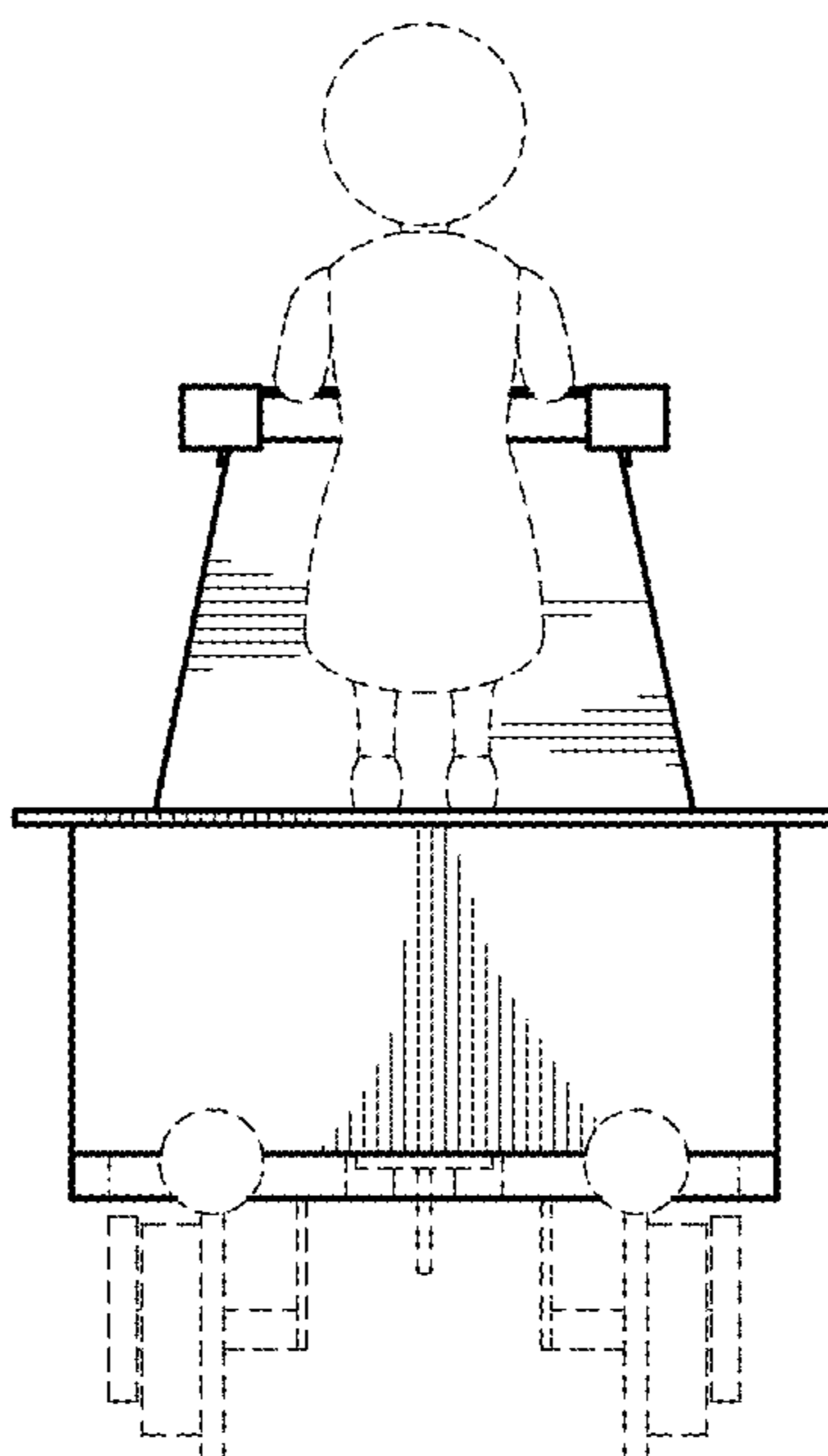

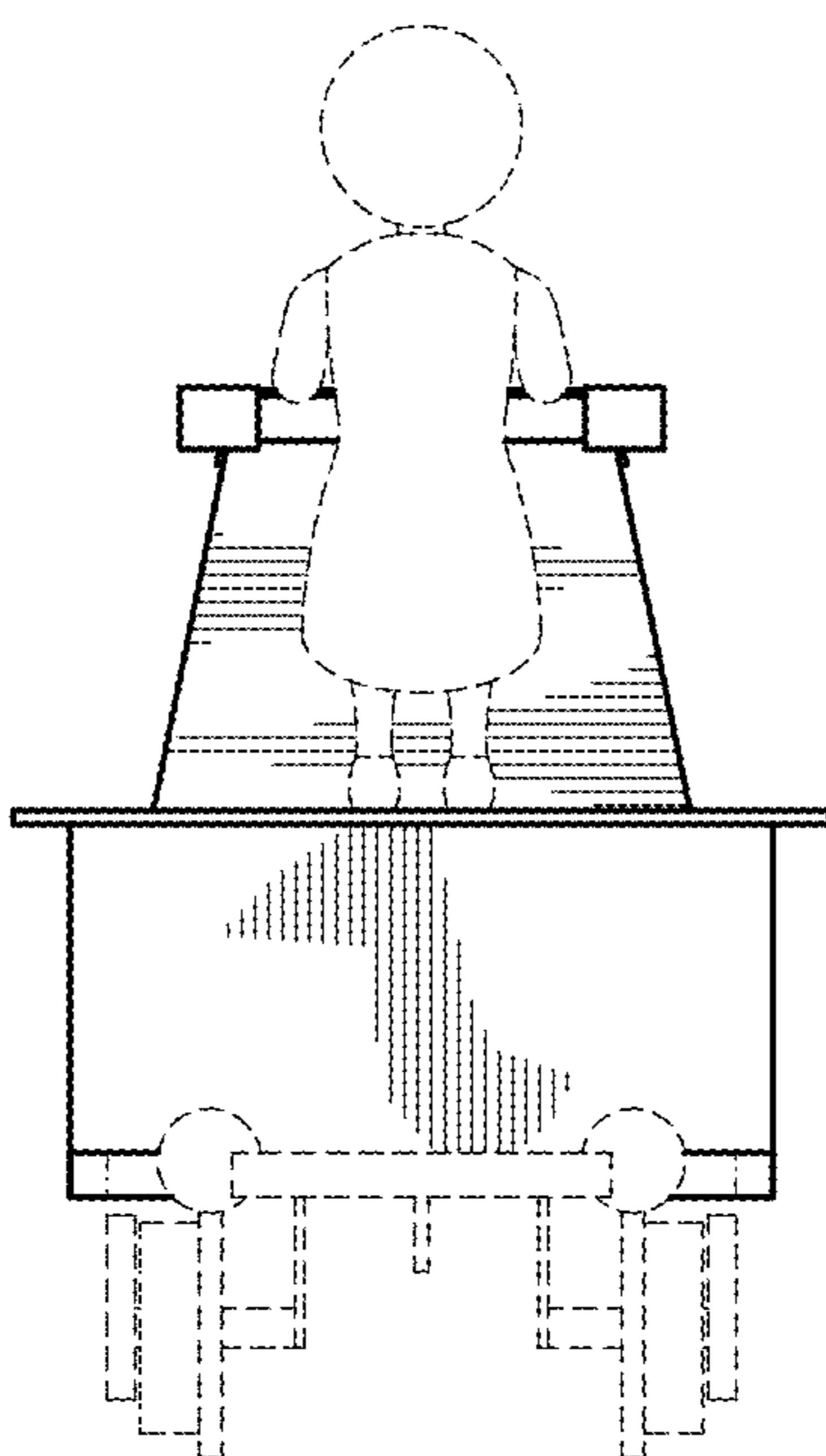

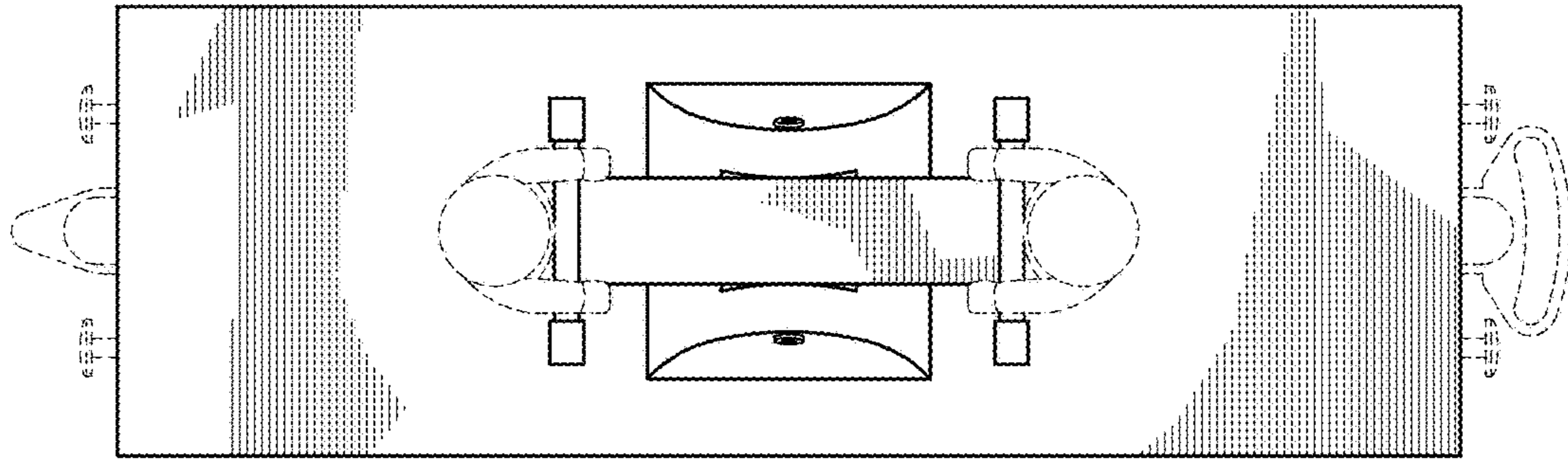

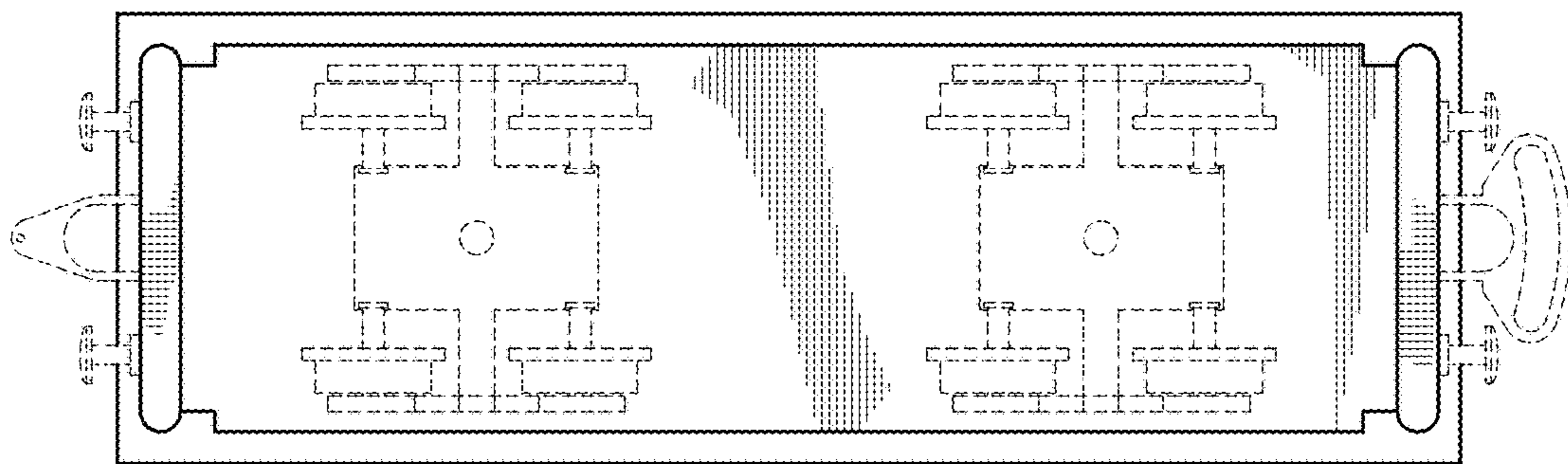

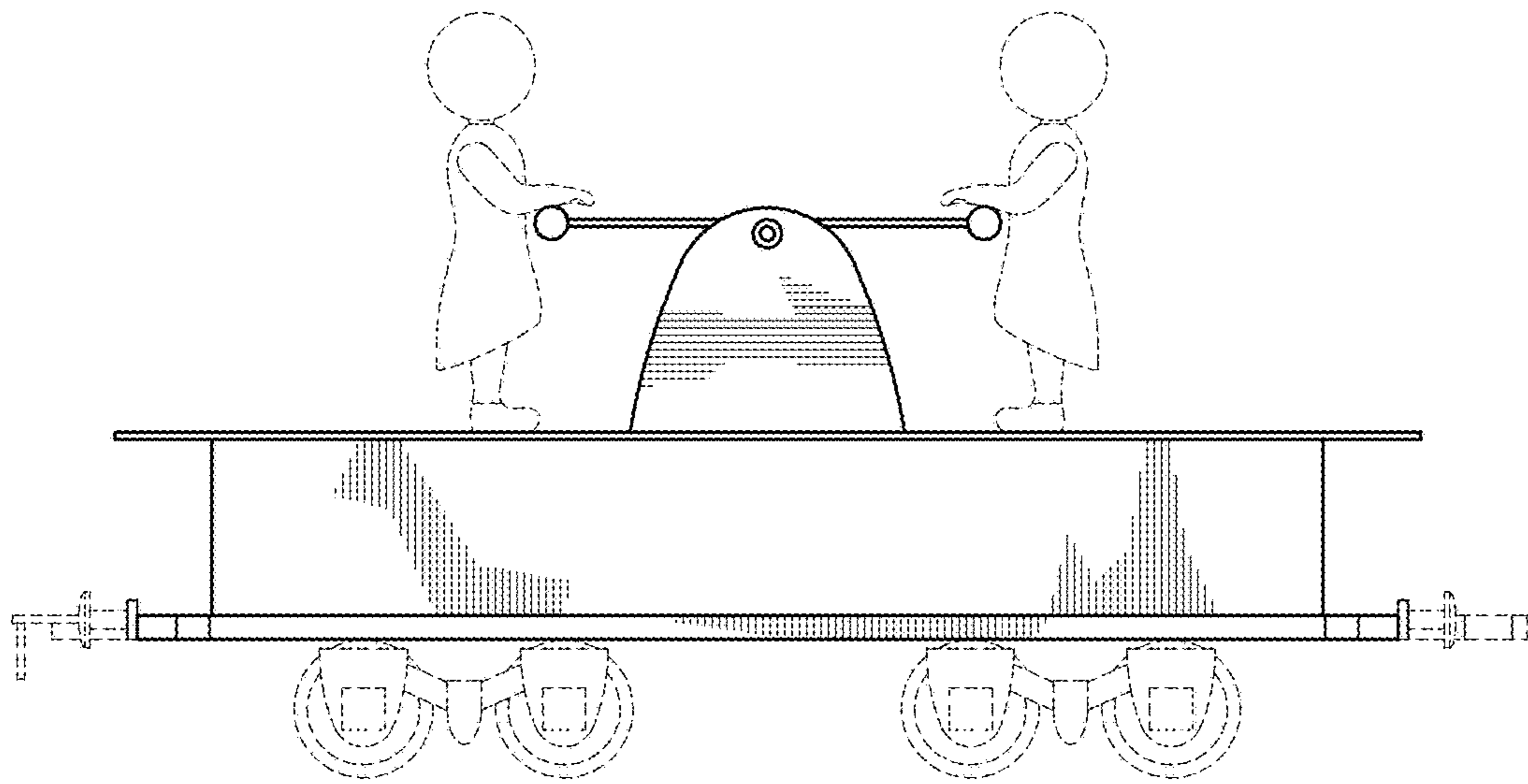

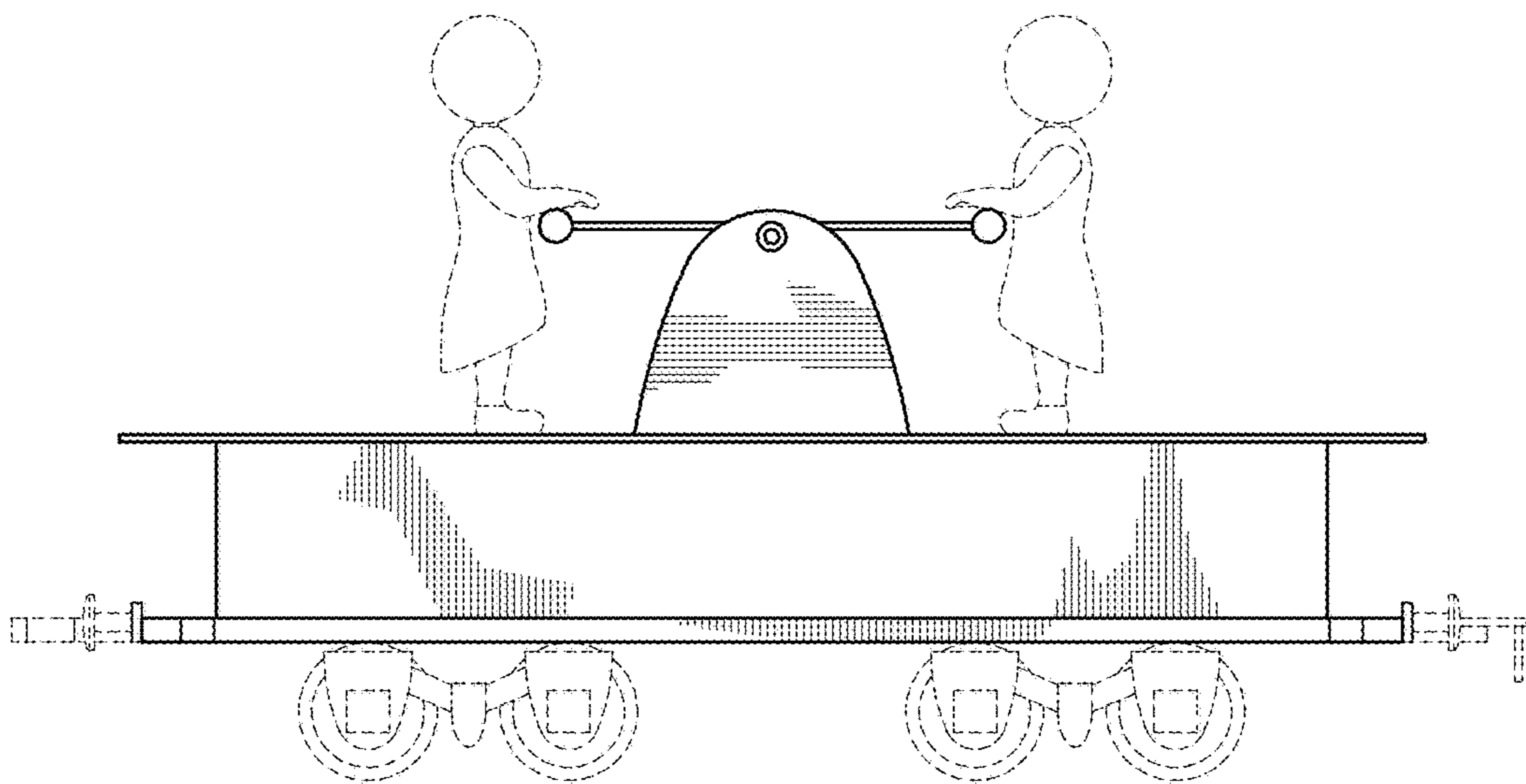
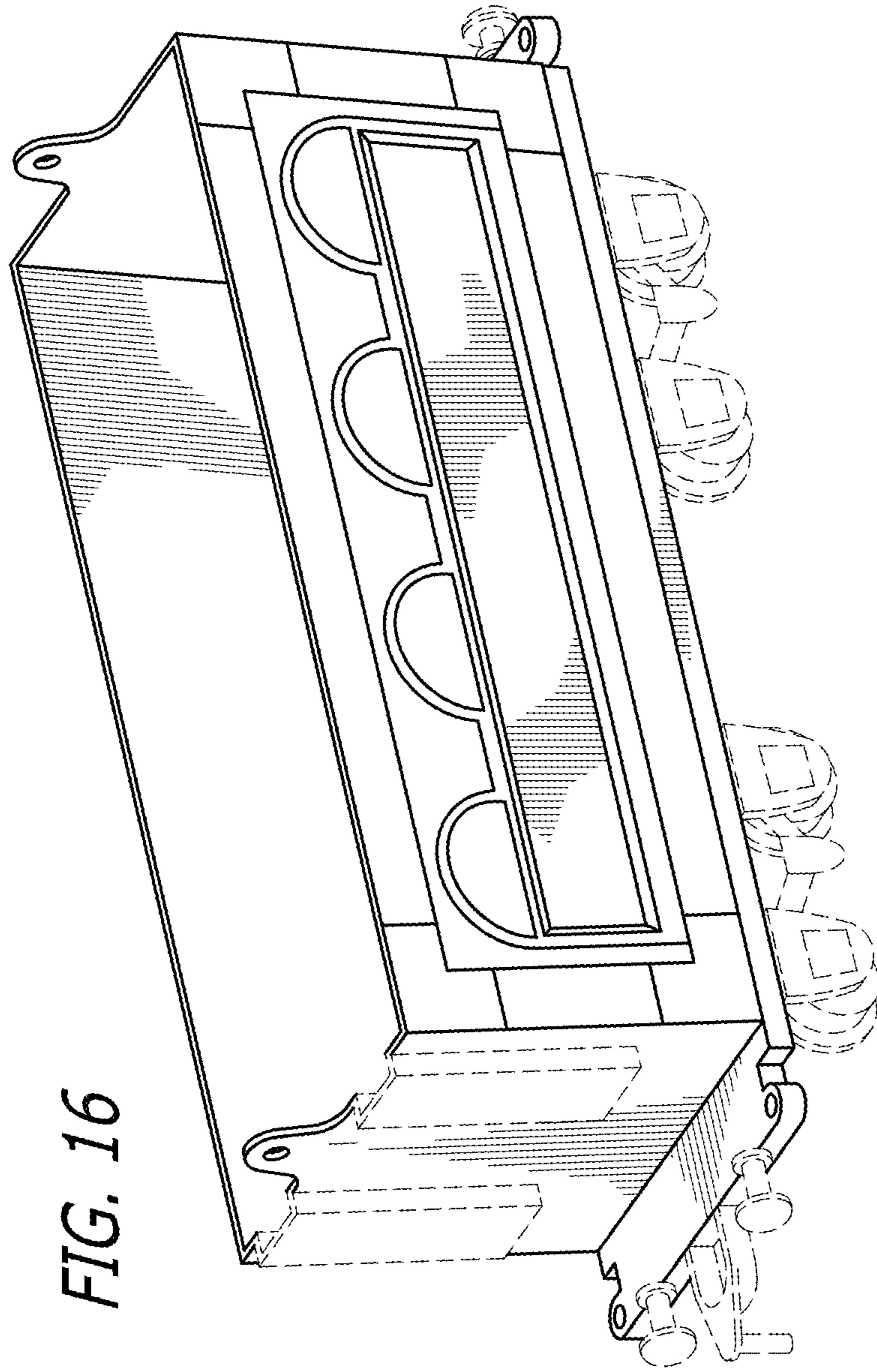

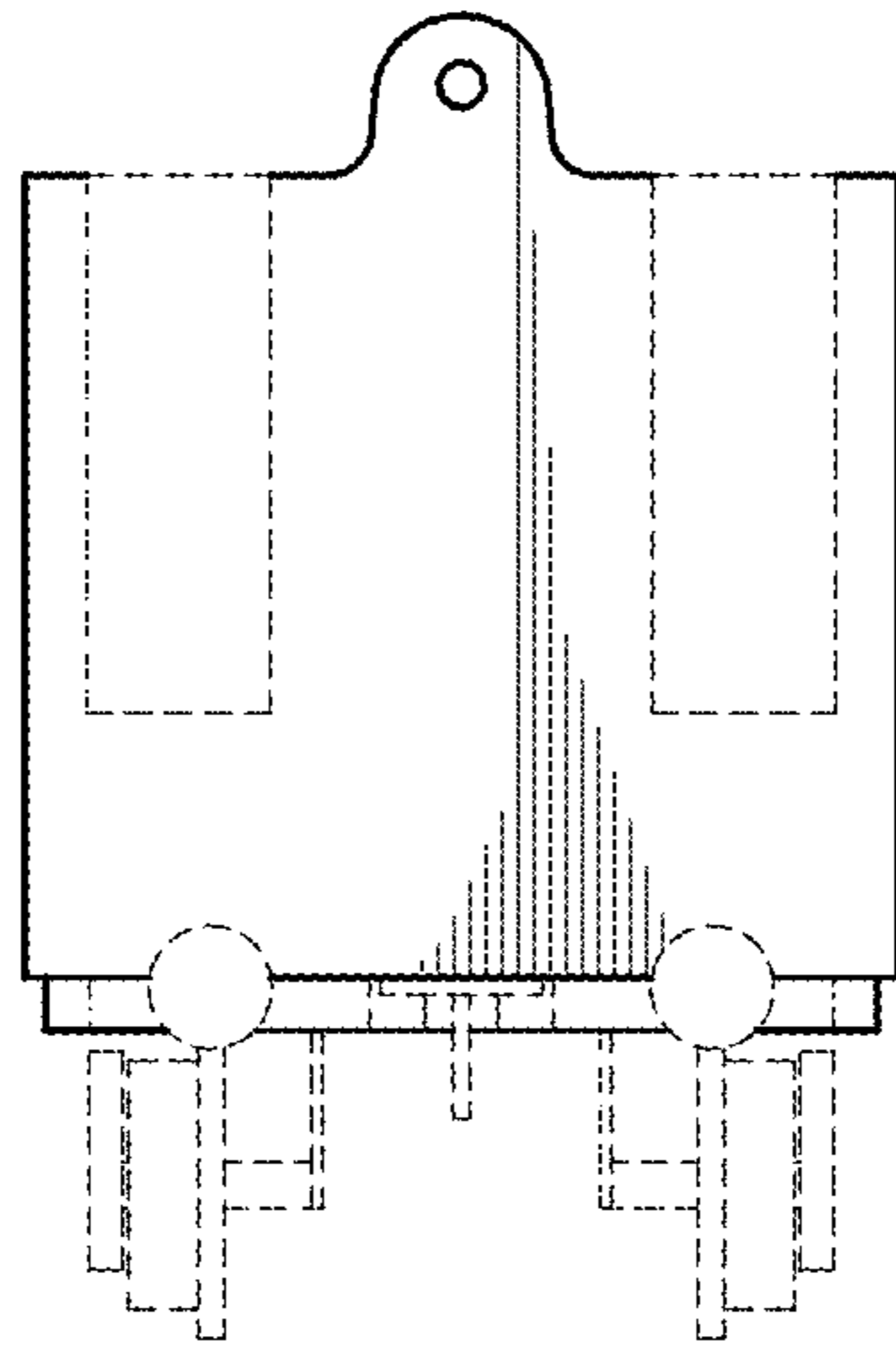

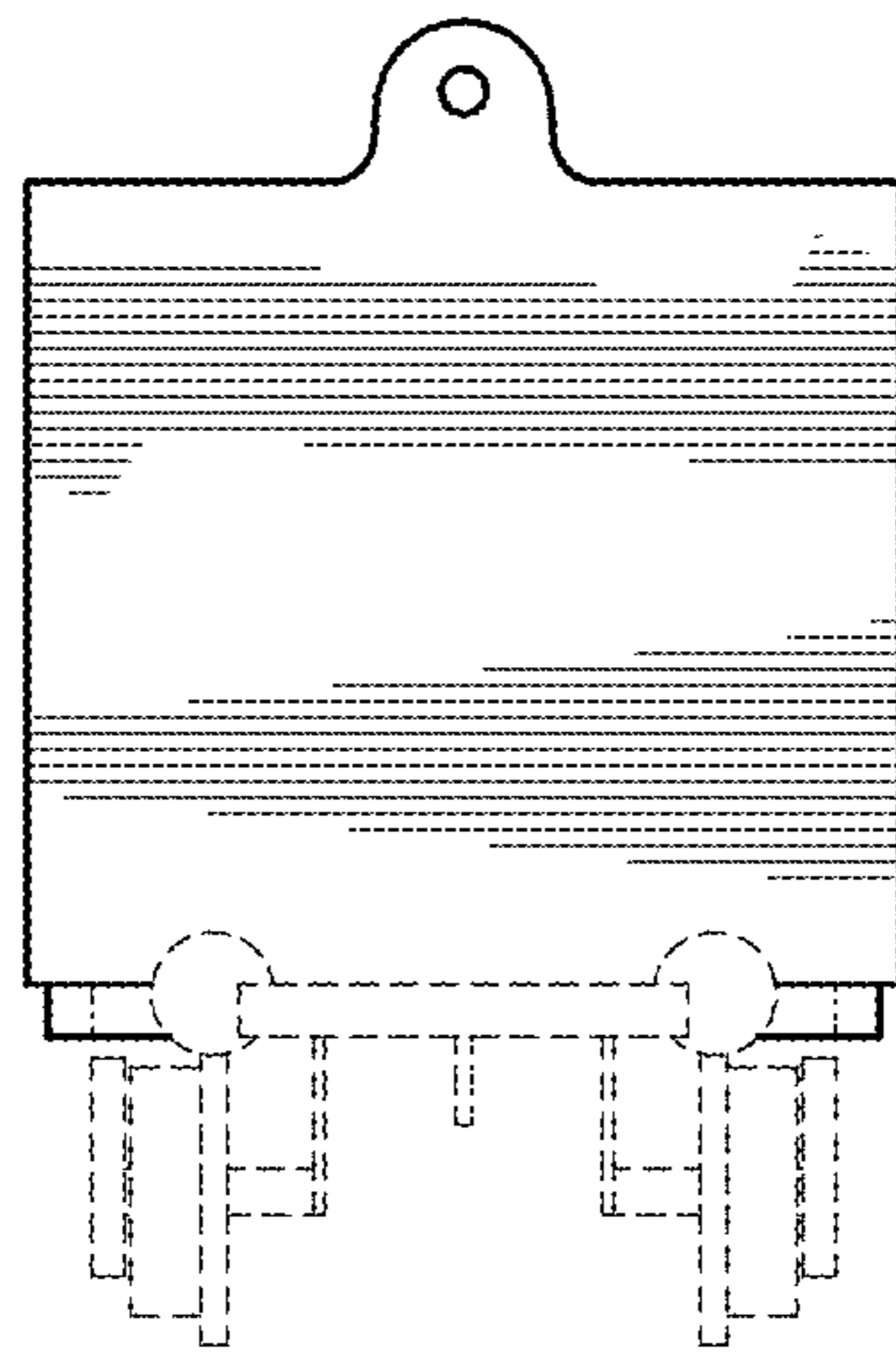

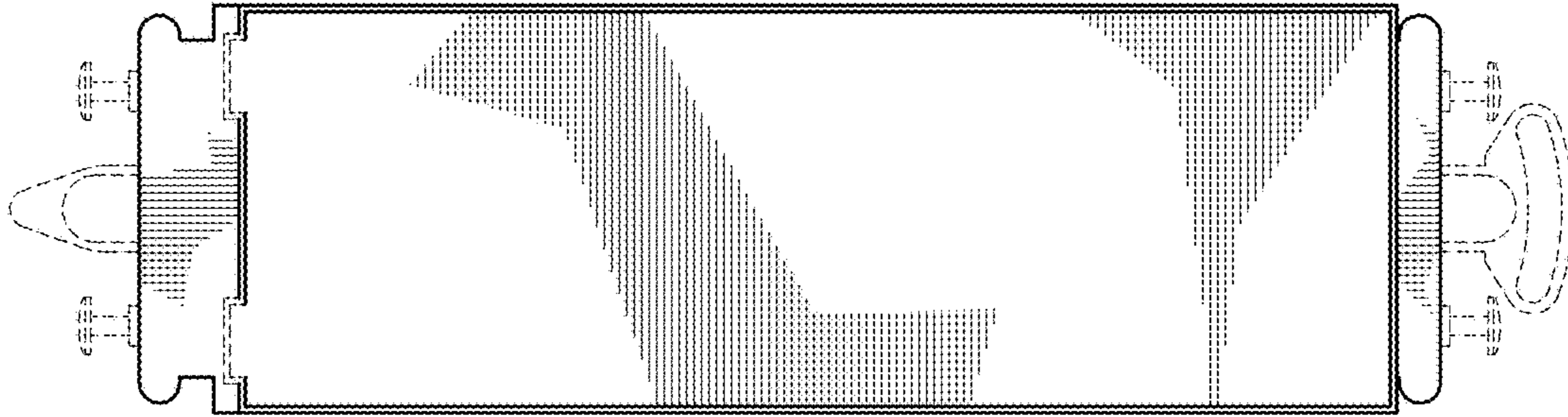

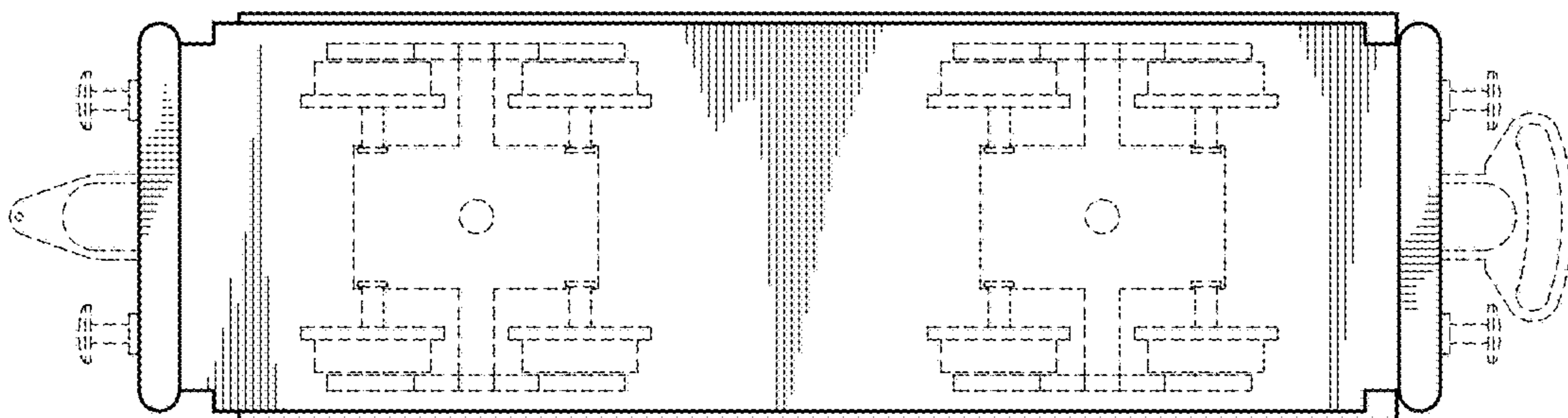

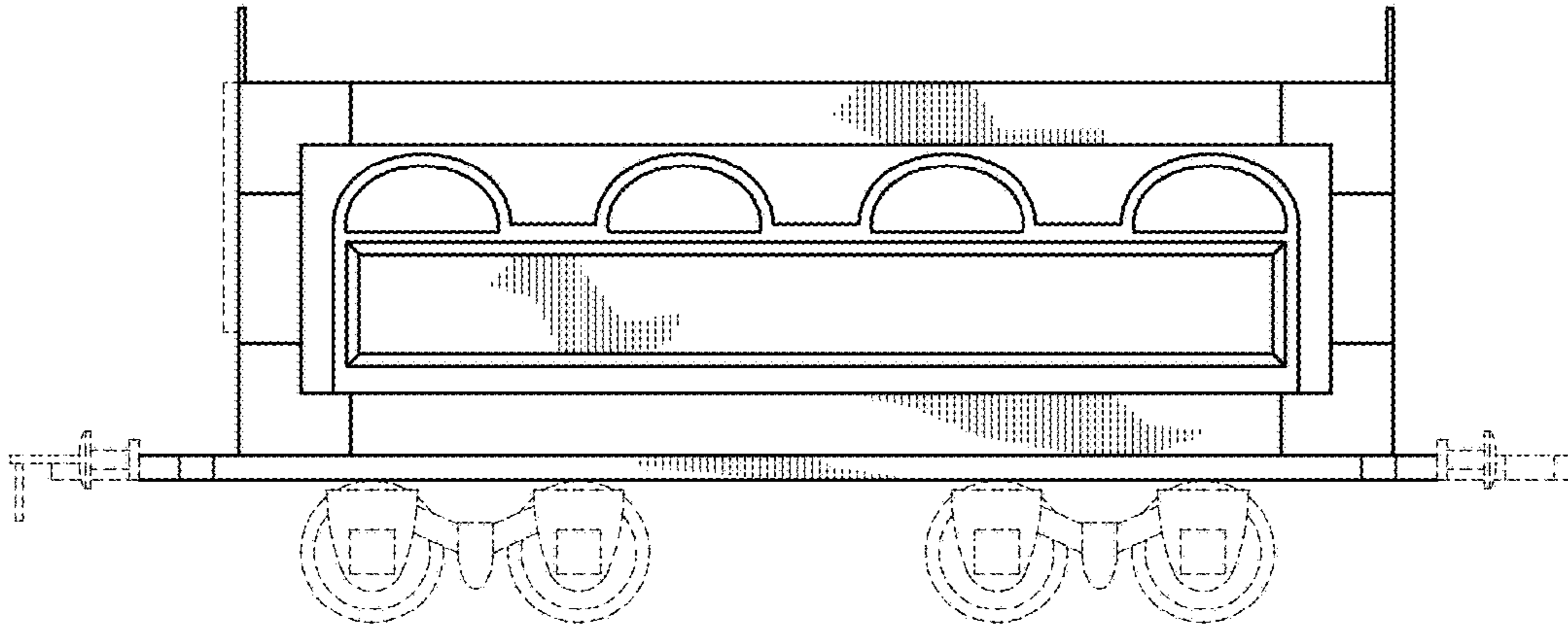

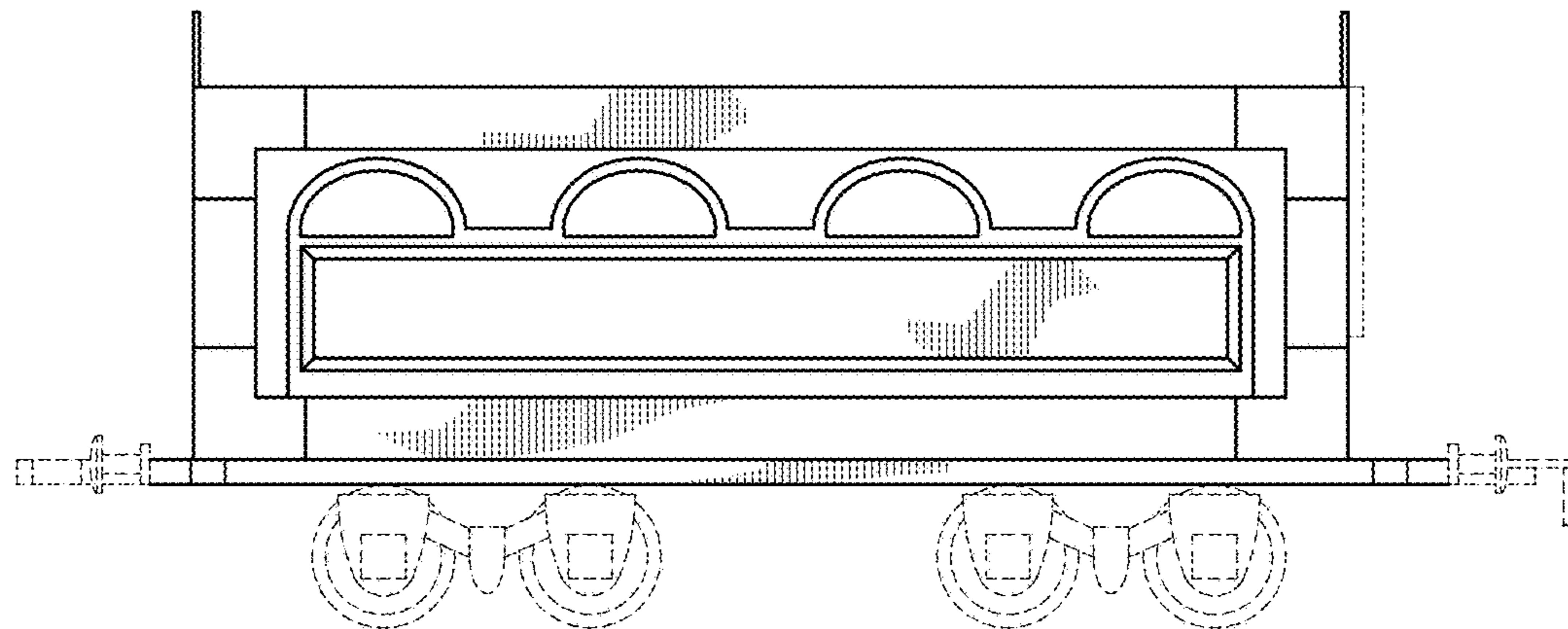

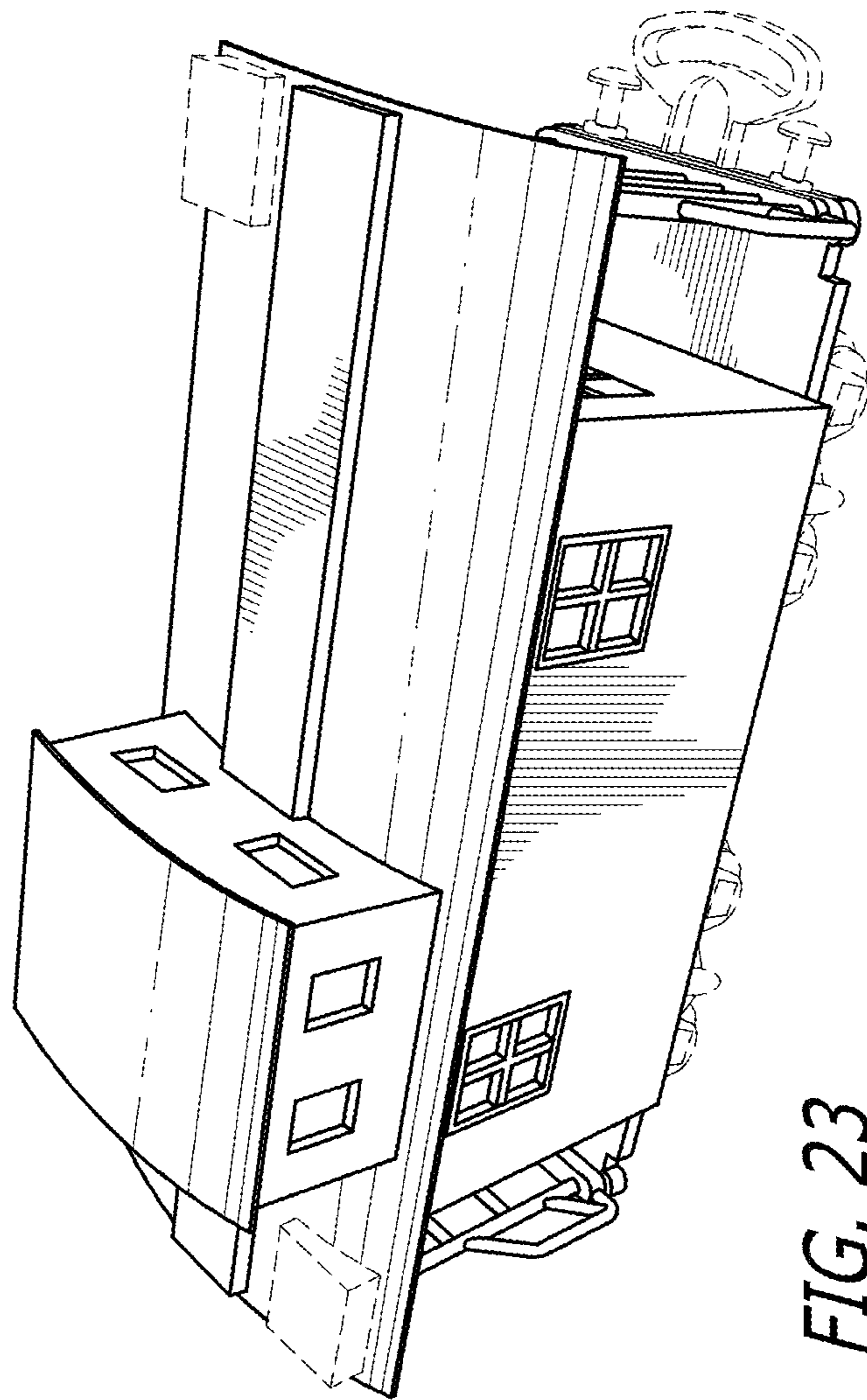

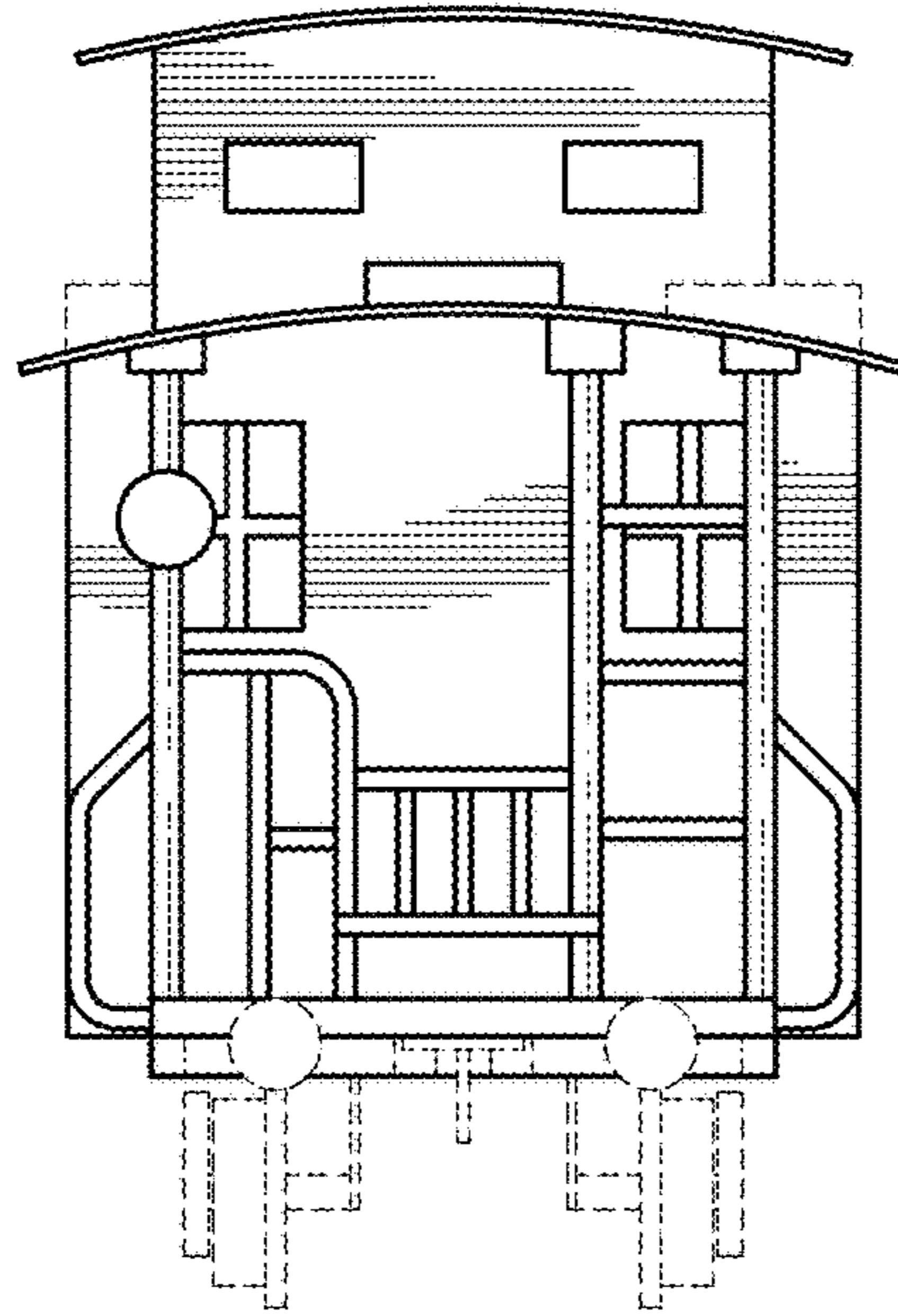

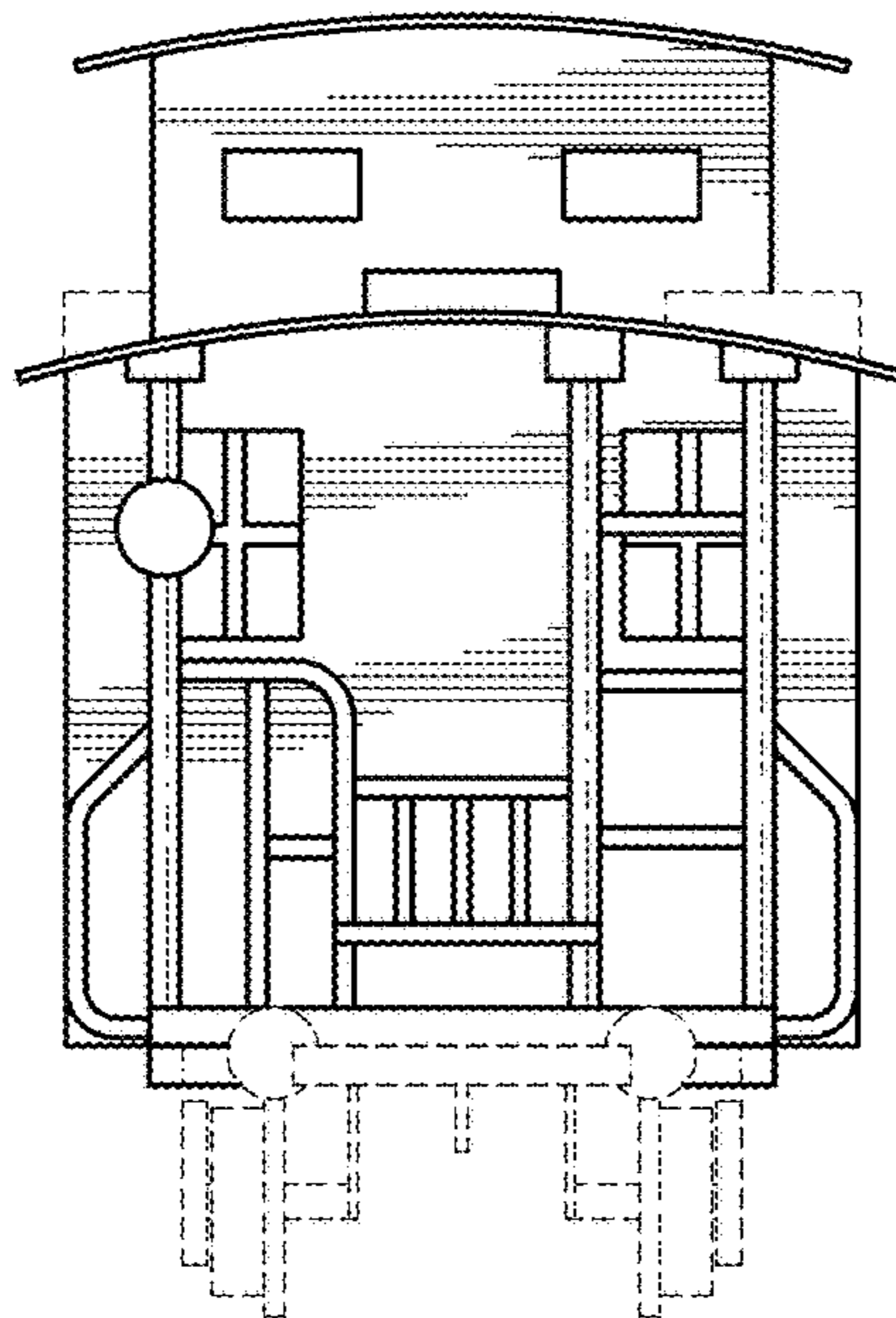

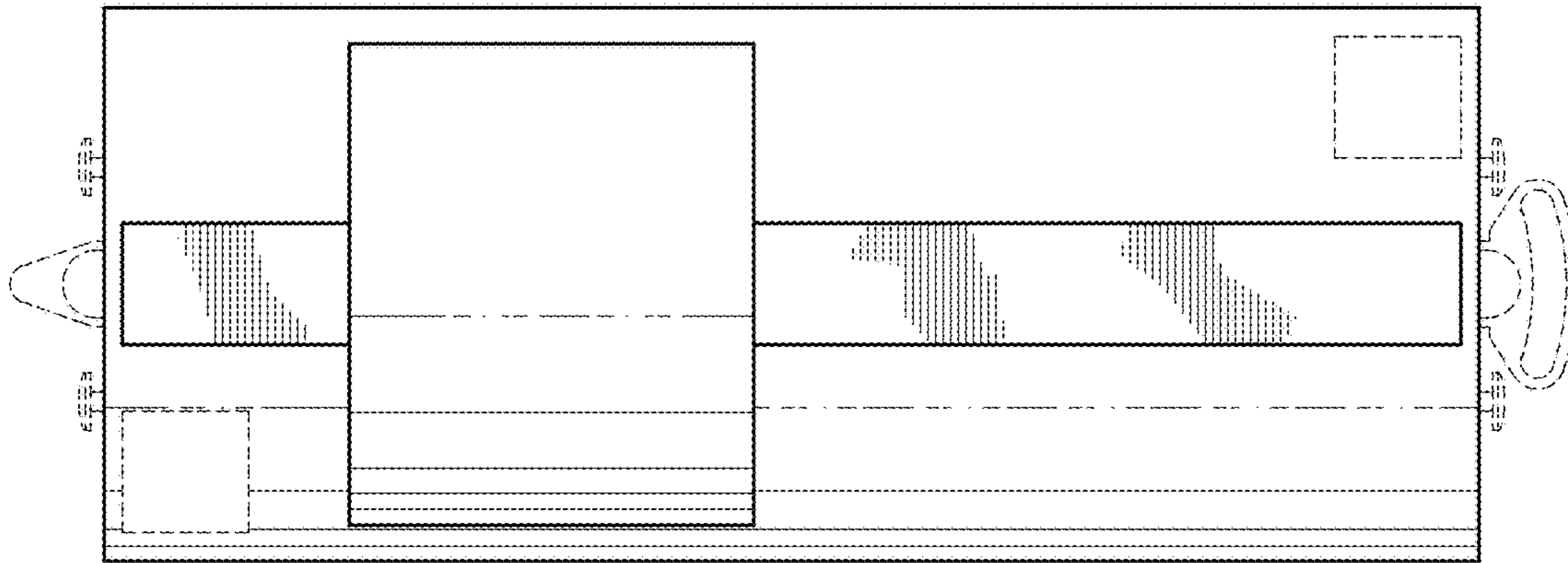

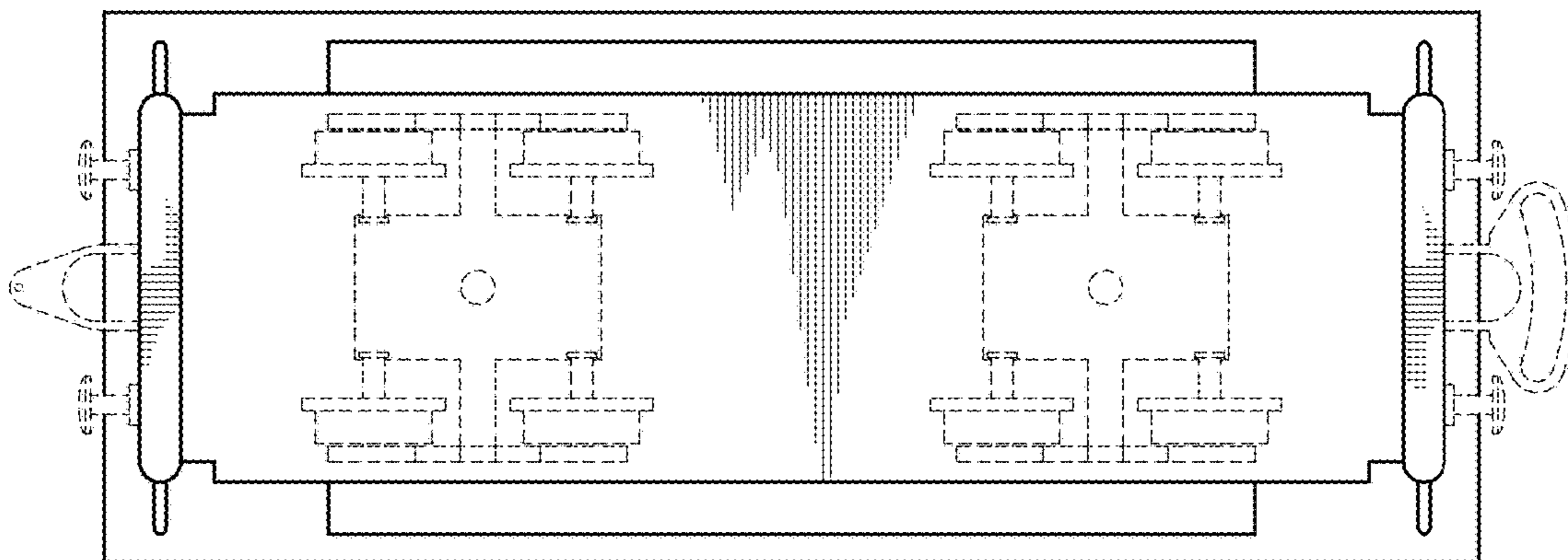

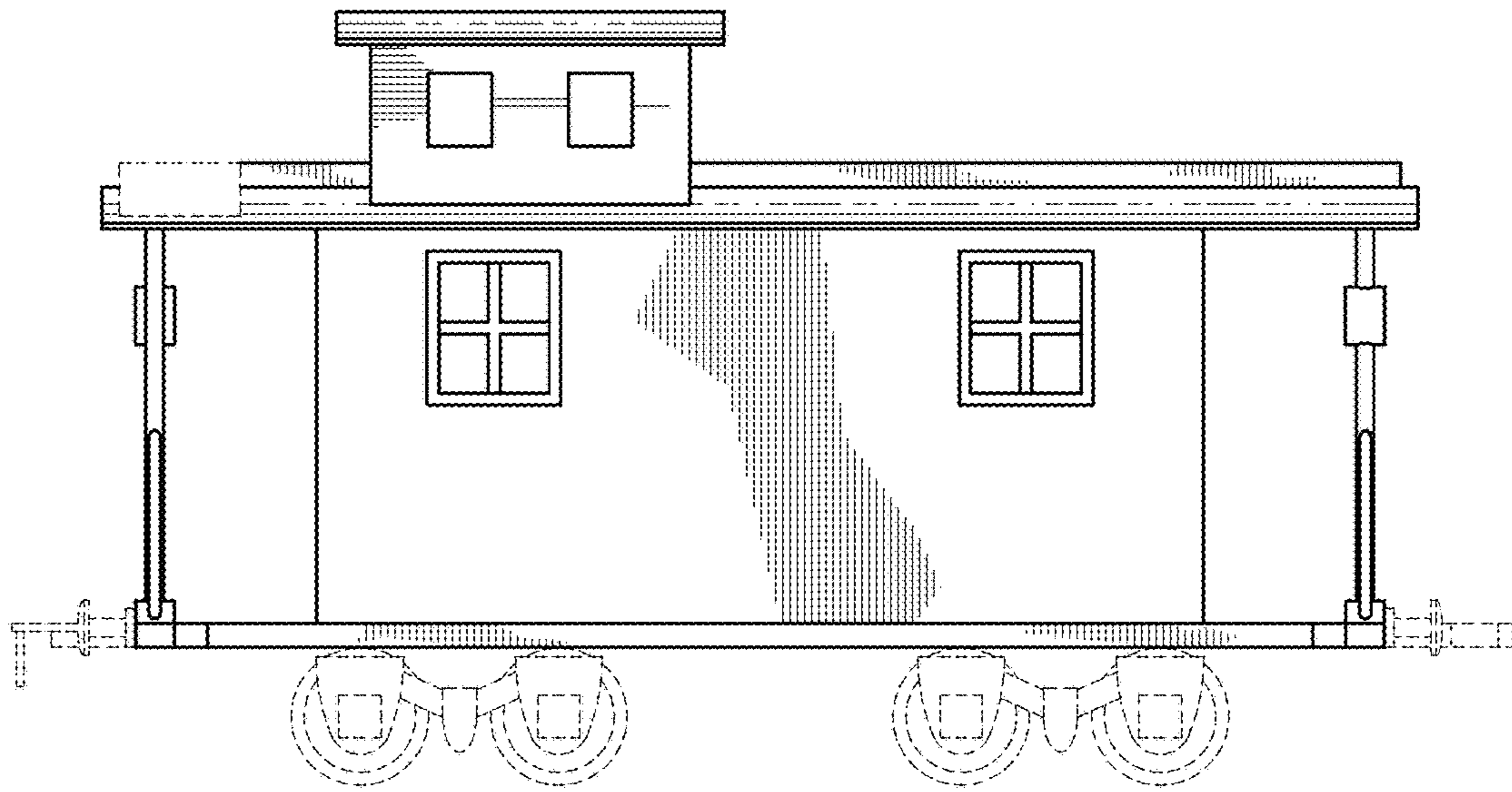

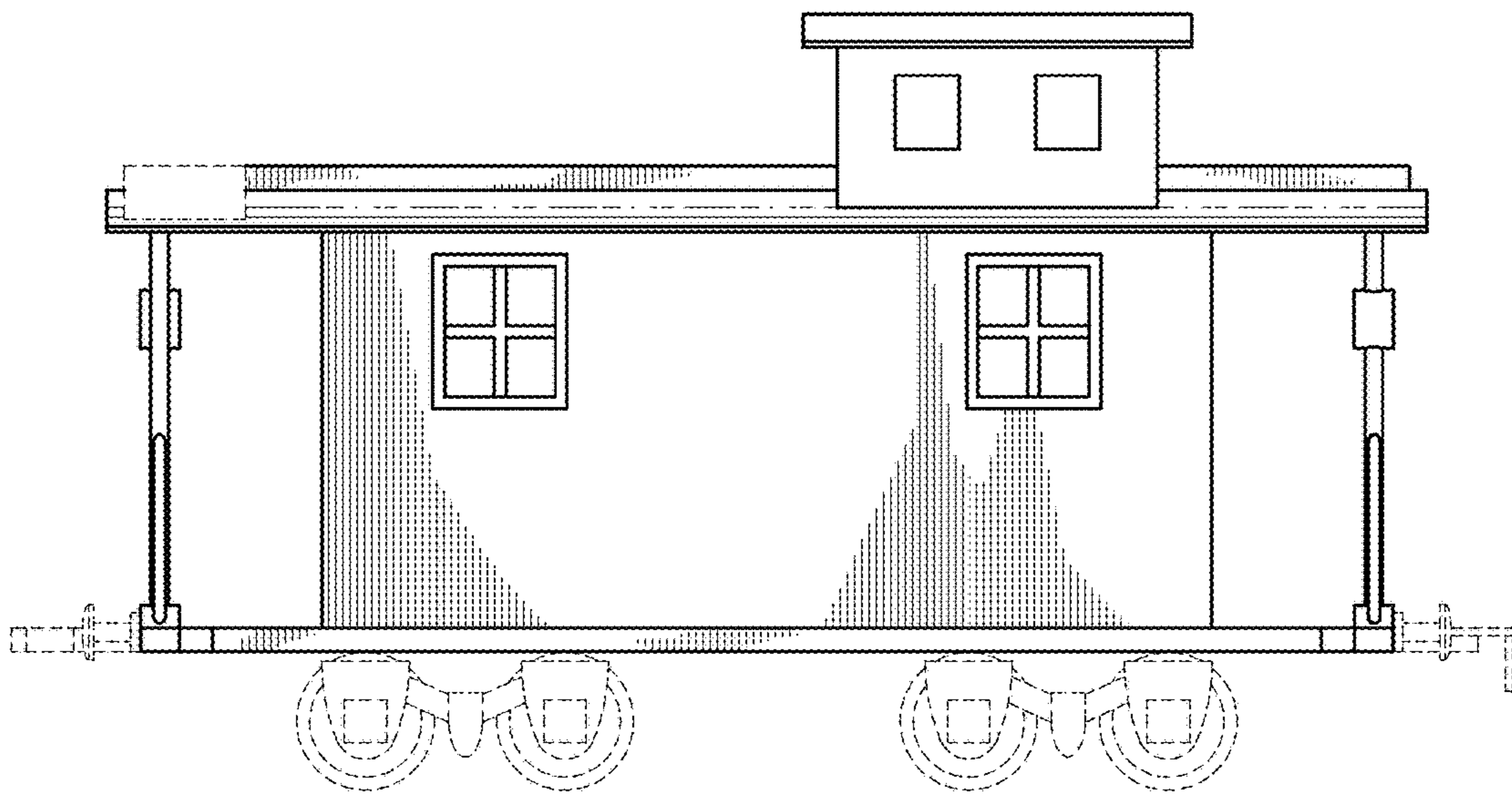
