I claim the ornamental design for a broadhead arrow quiver, as shown and described.

DESCRIPTION

FIG. 1 is a Top perspective view of a broadhead arrow quiver showing my new design. When taken from the same angle from above, from the opposite side, the interior features have the same appearance.

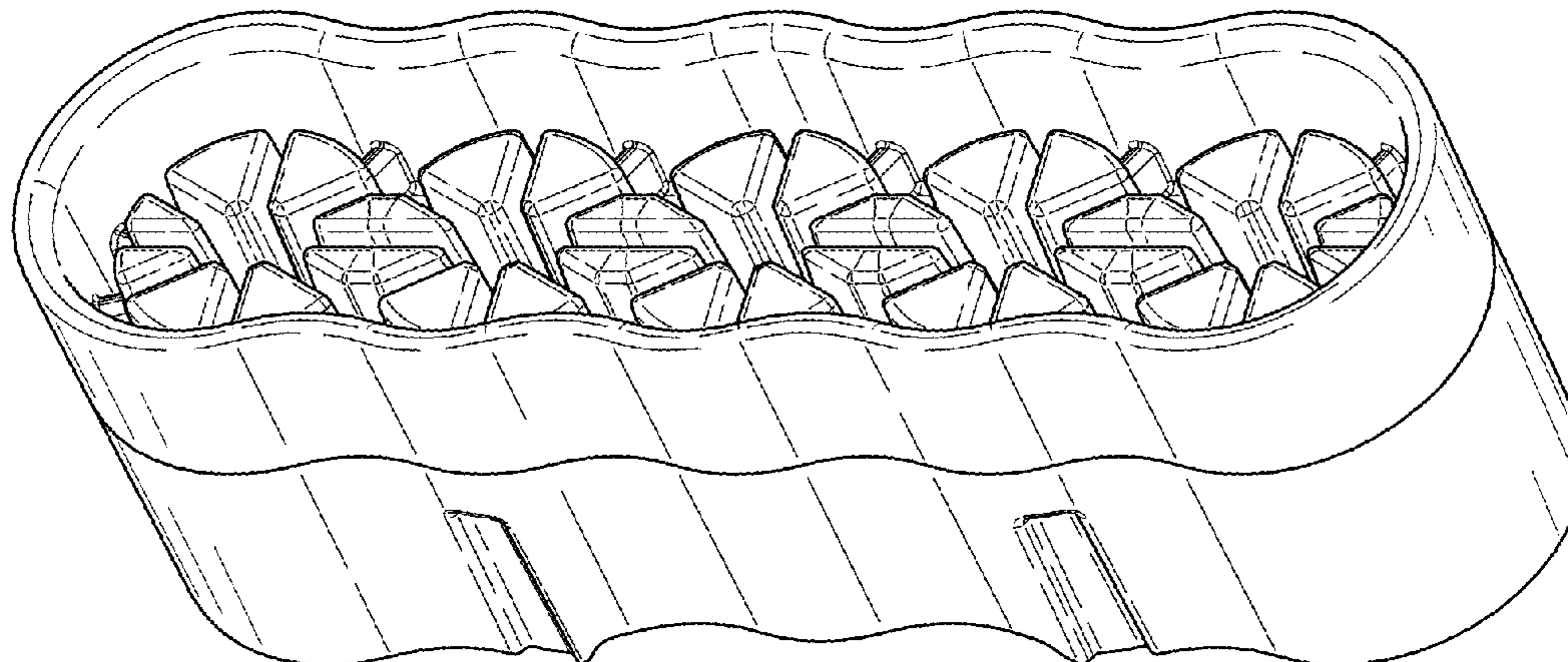
FIG. 2 is a Side view thereof;

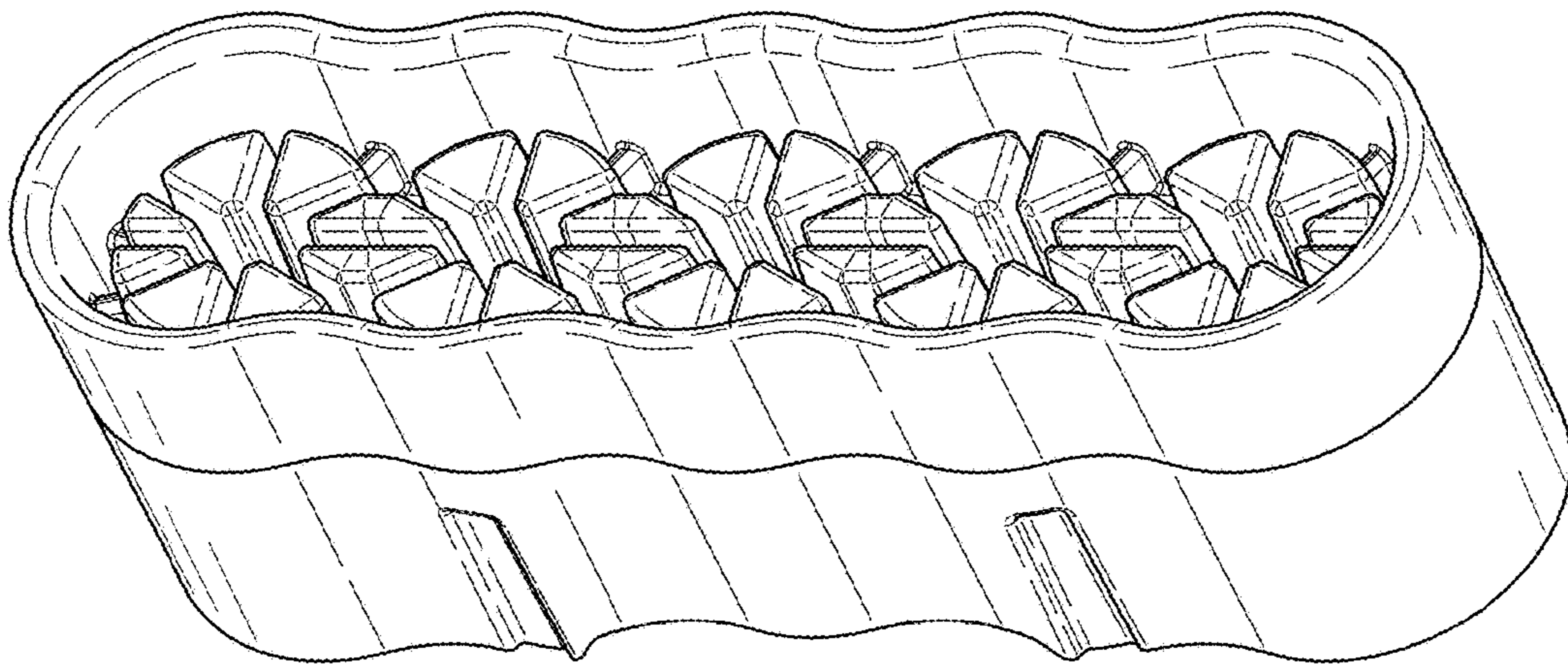

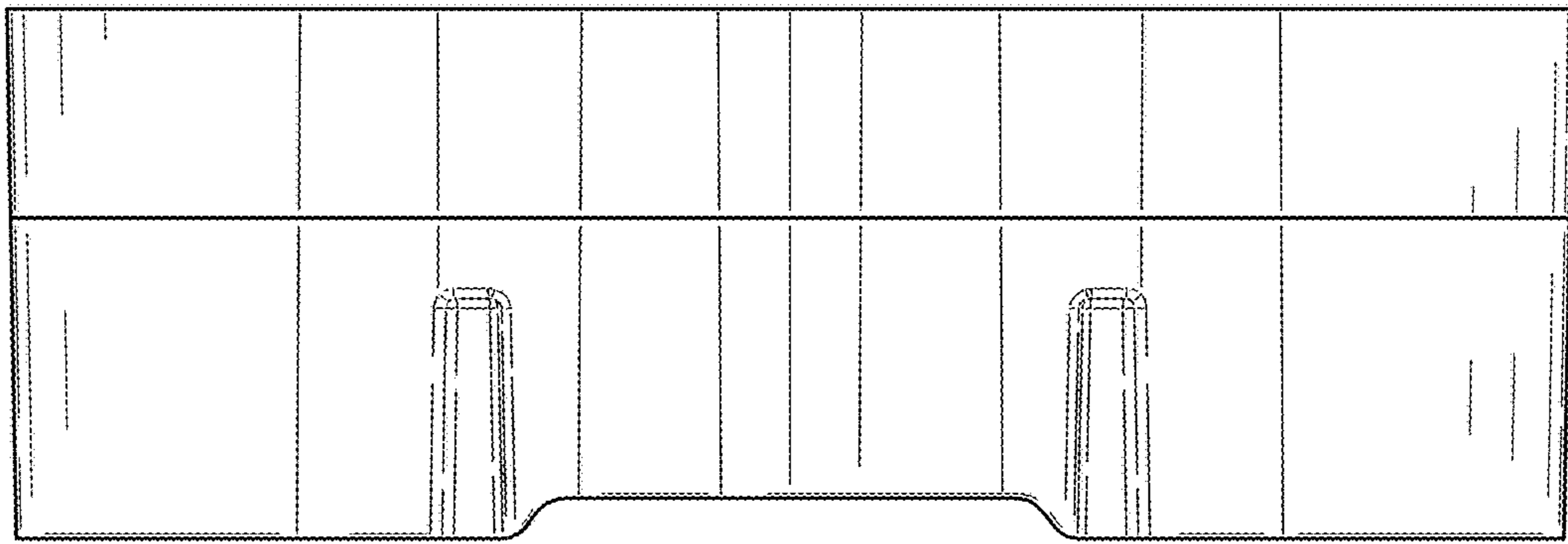

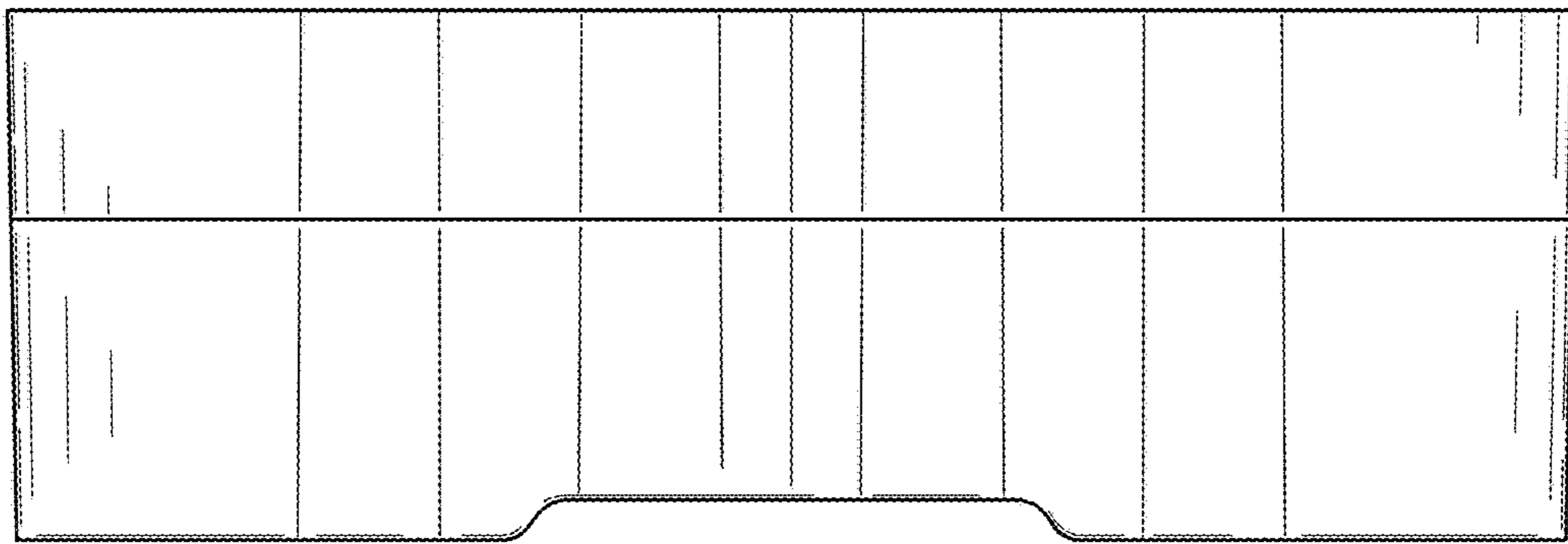

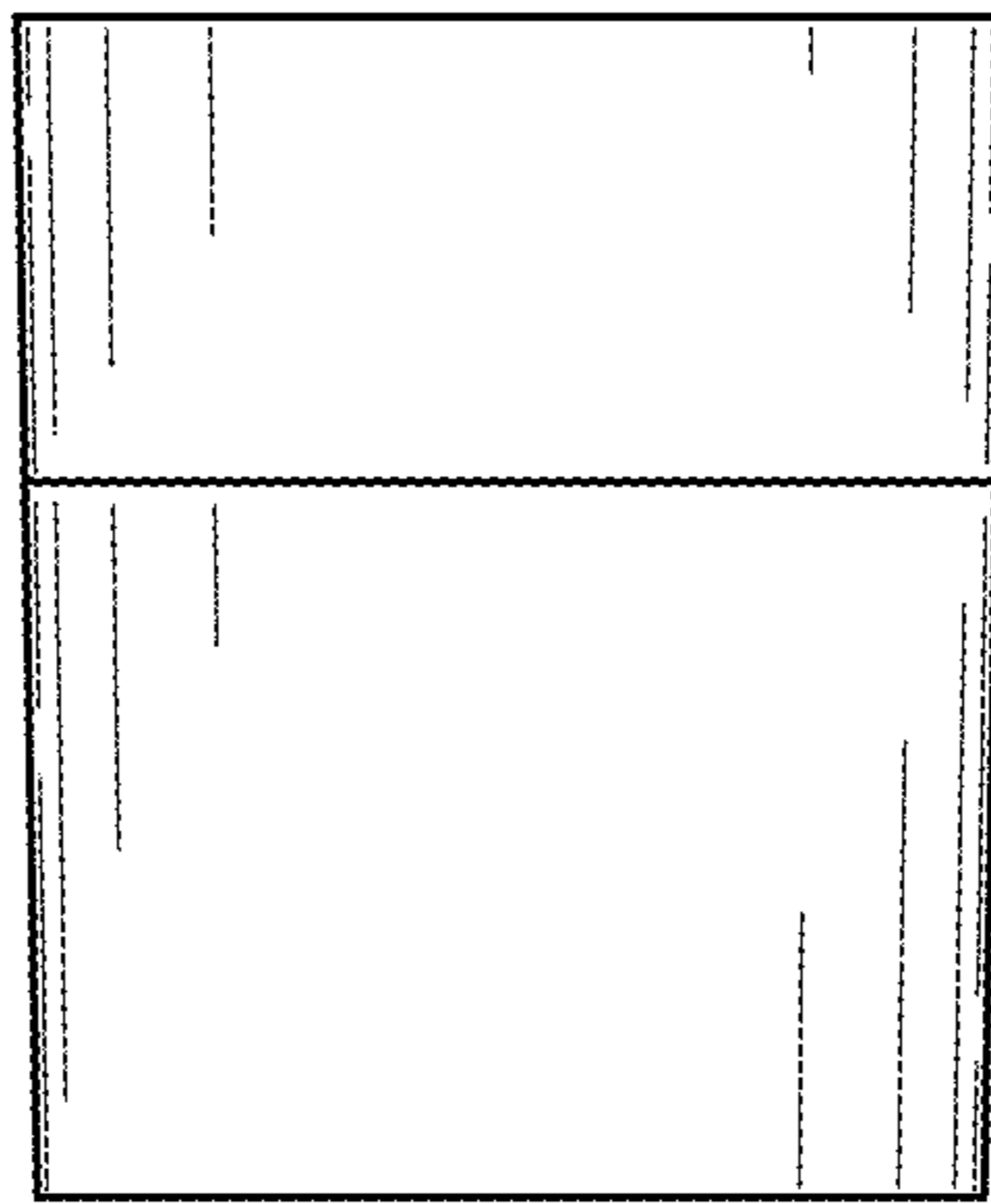

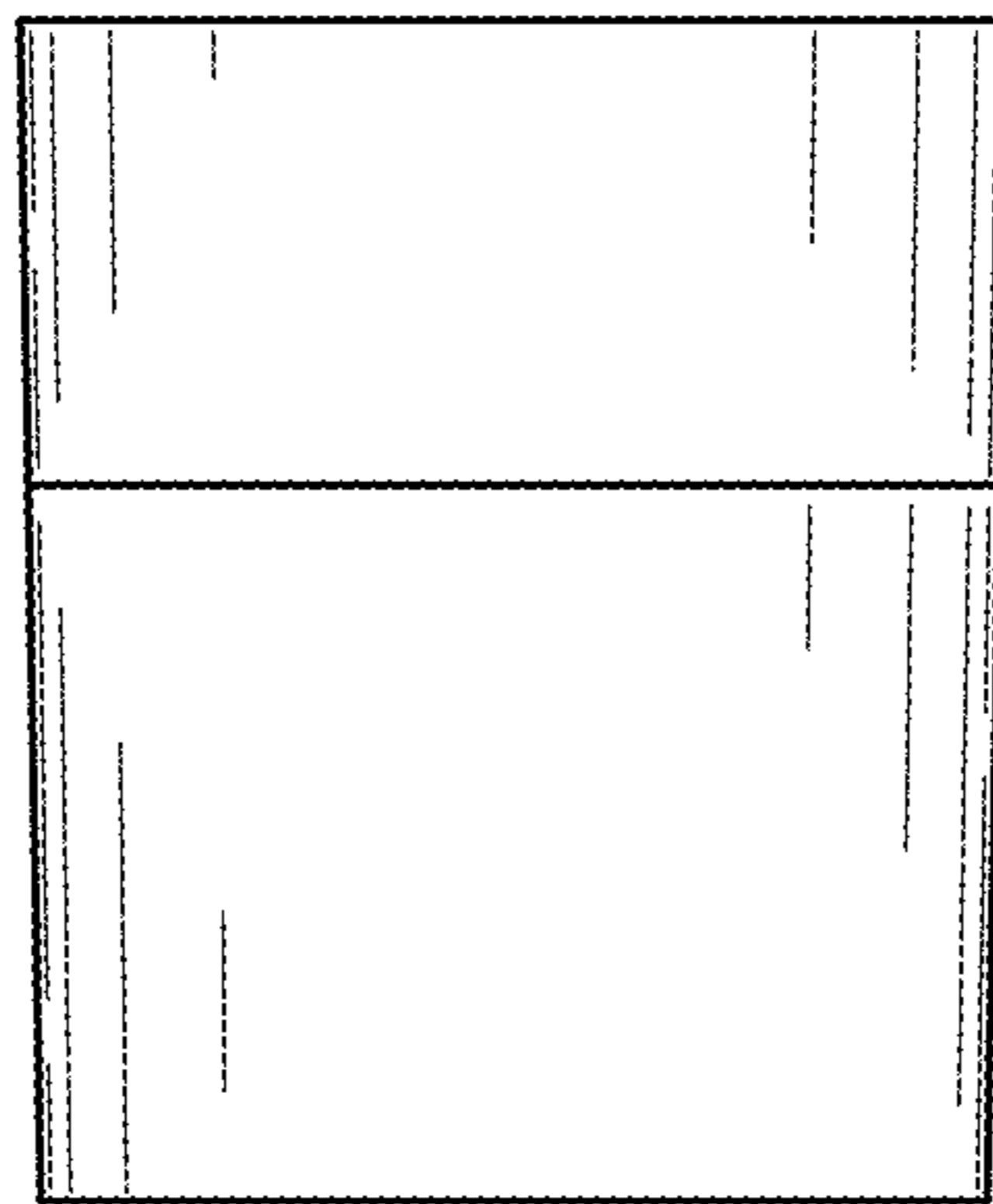
