(57) **CLAIM**

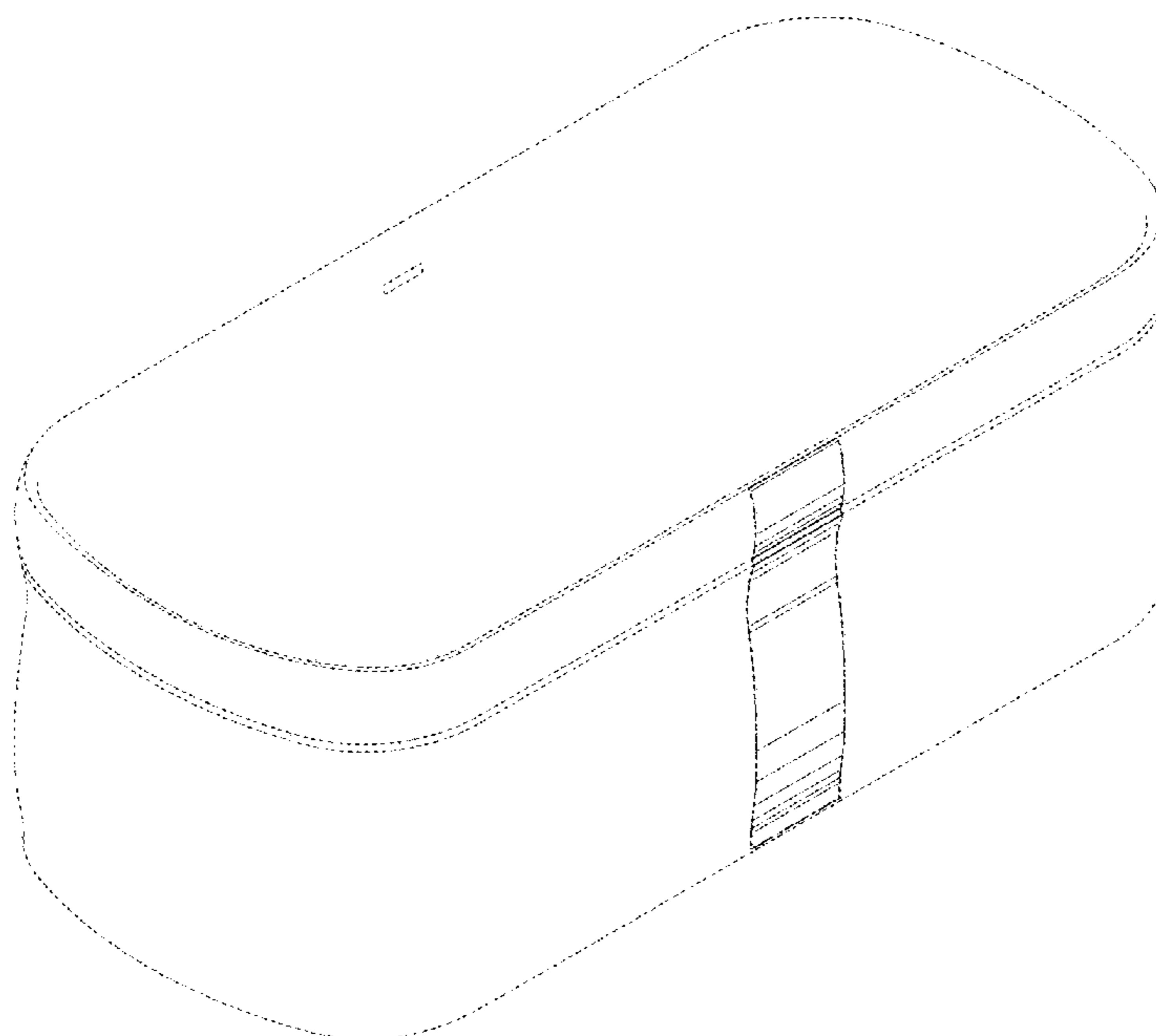
We claim the ornamental design for a bathtub, as shown and described.

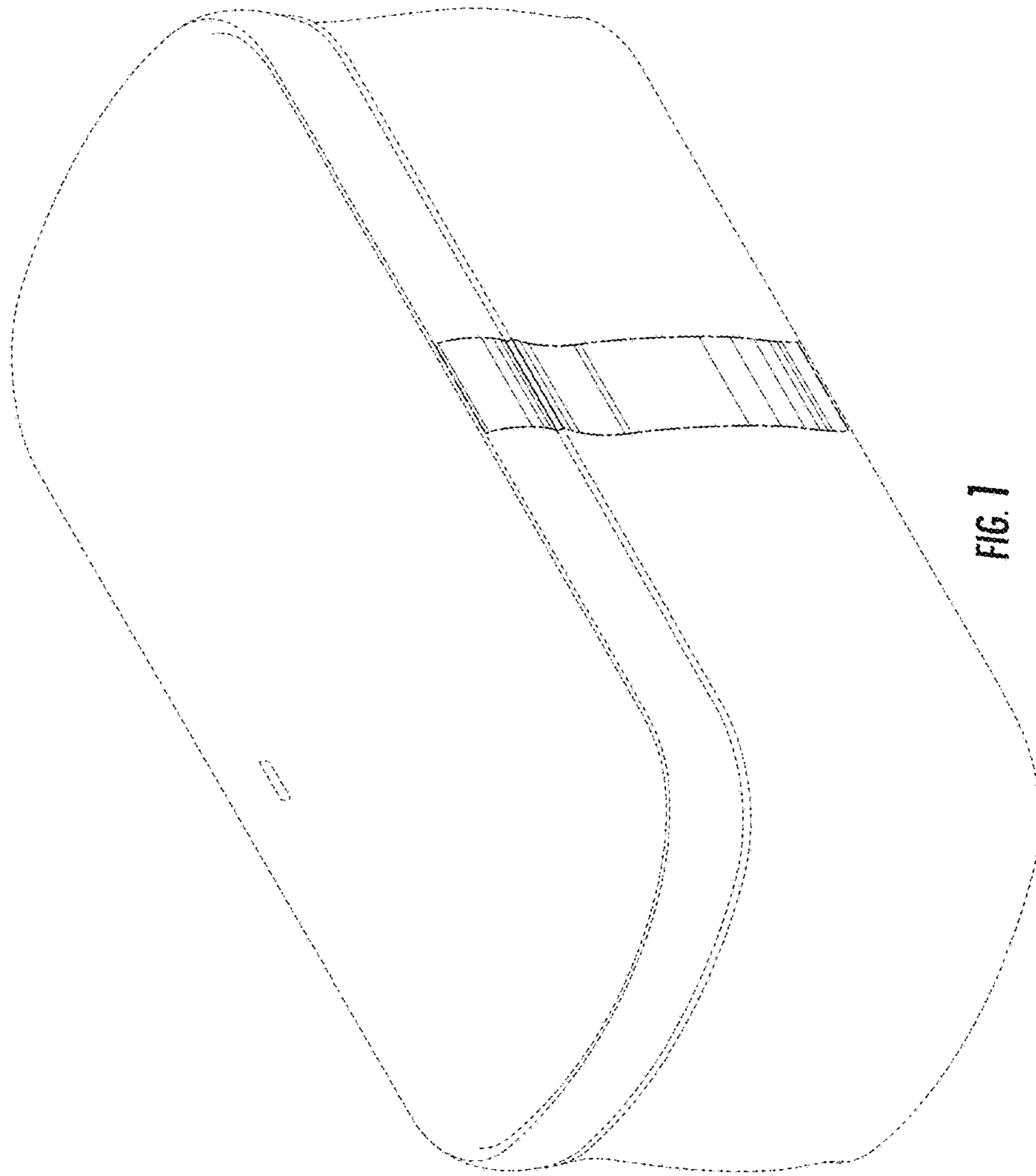
**DESCRIPTION**

FIG. 1 is a top, front, left, perspective view of an embodiment of the claimed design;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a left side elevation view thereof;  
FIG. 5 is a right side elevation view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof;  
FIG. 8 is a cross-sectional view thereof taken across line 8-8 of FIG. 6; and,  
FIG. 9 is a cross-sectional view thereof taken across line 9-9 of FIG. 6.

Broken lines formed by equal length dashes show unclaimed subject matter. Broken lines formed by unequal length dashes (i.e., dash-dot) define bounds of the claimed design. 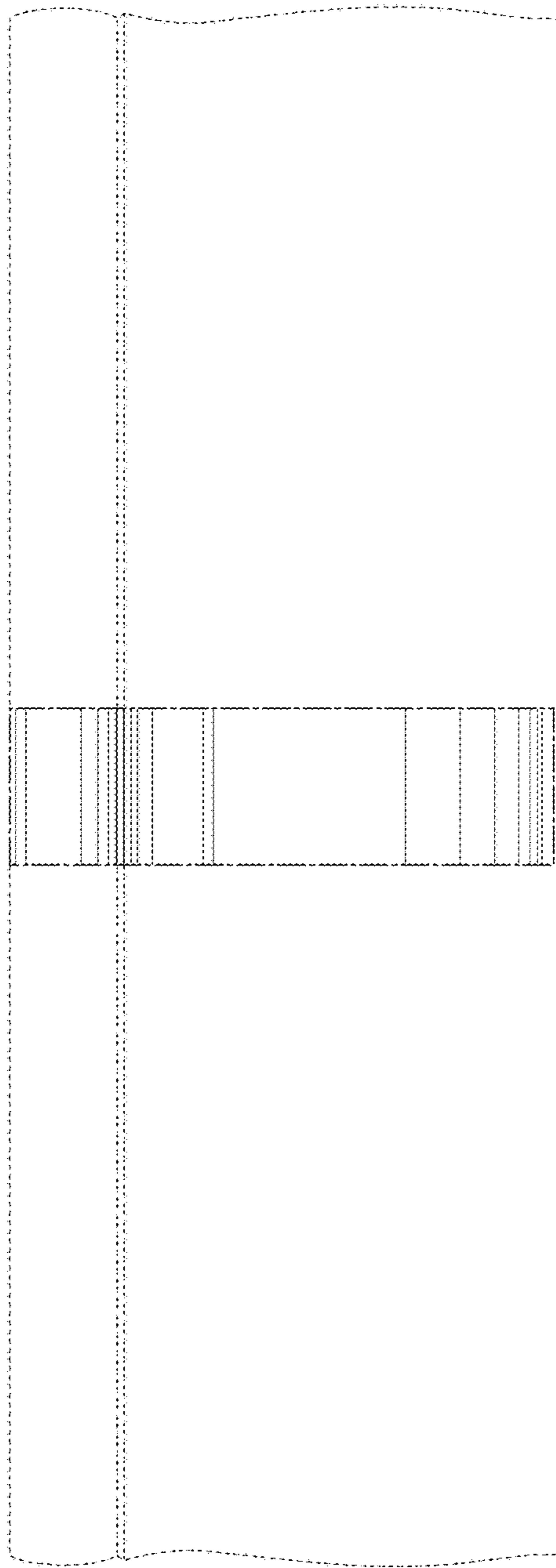

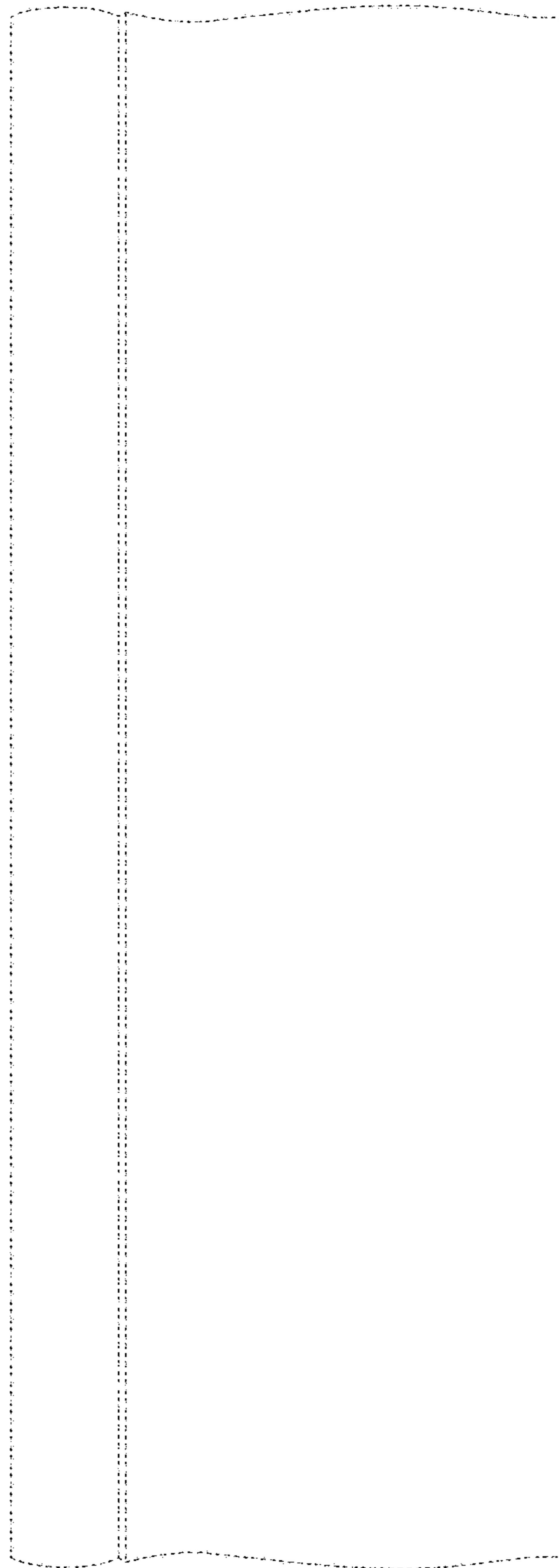

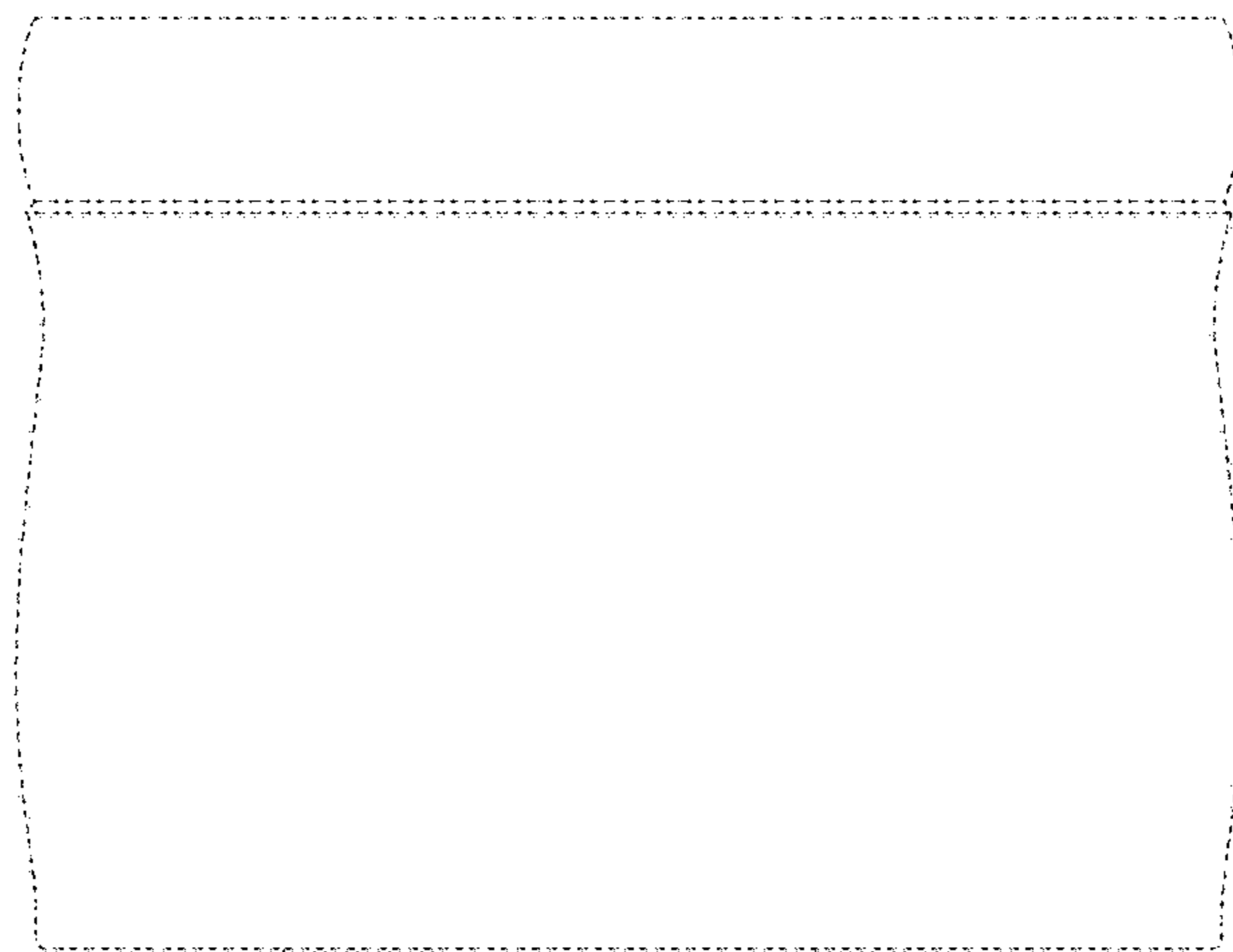

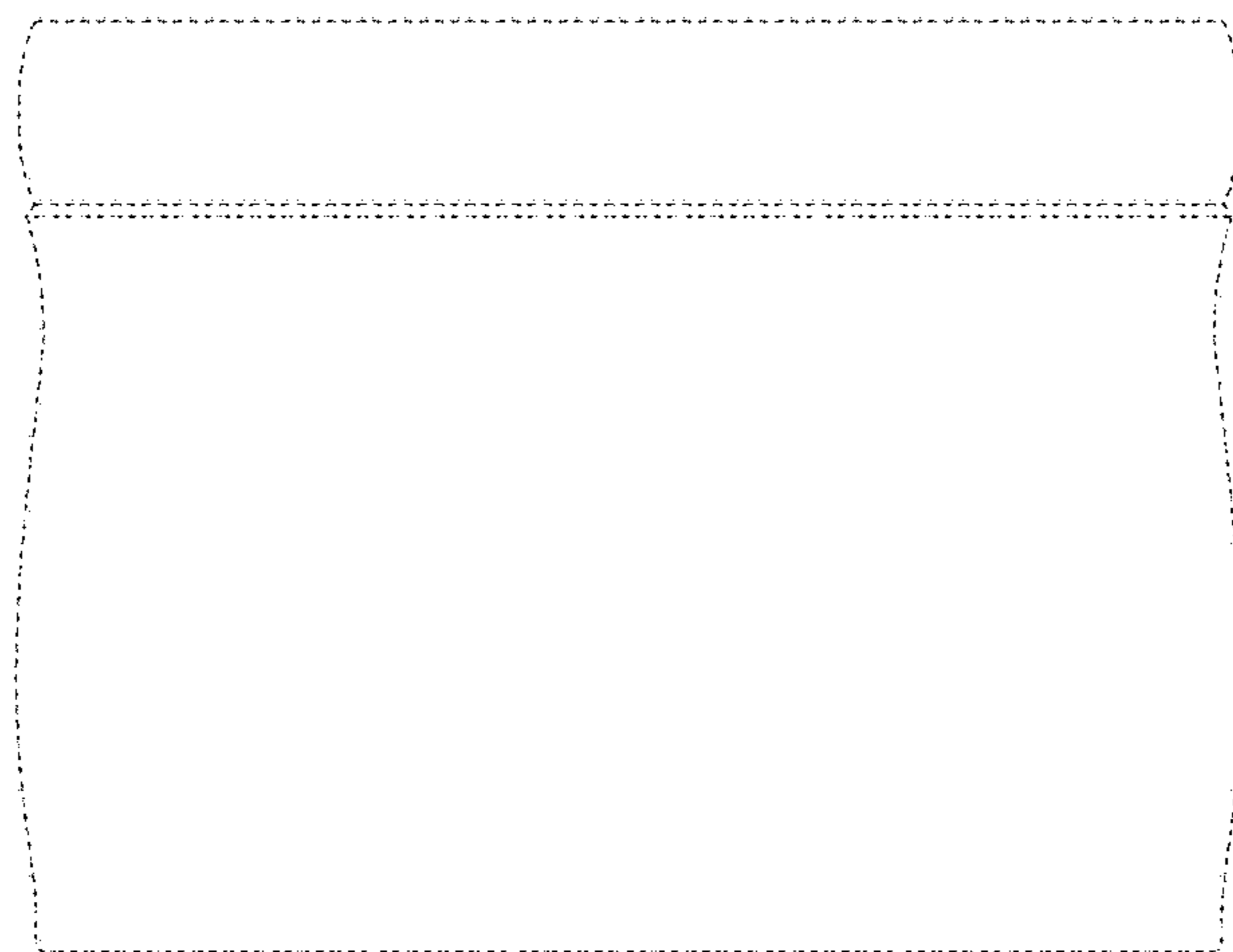

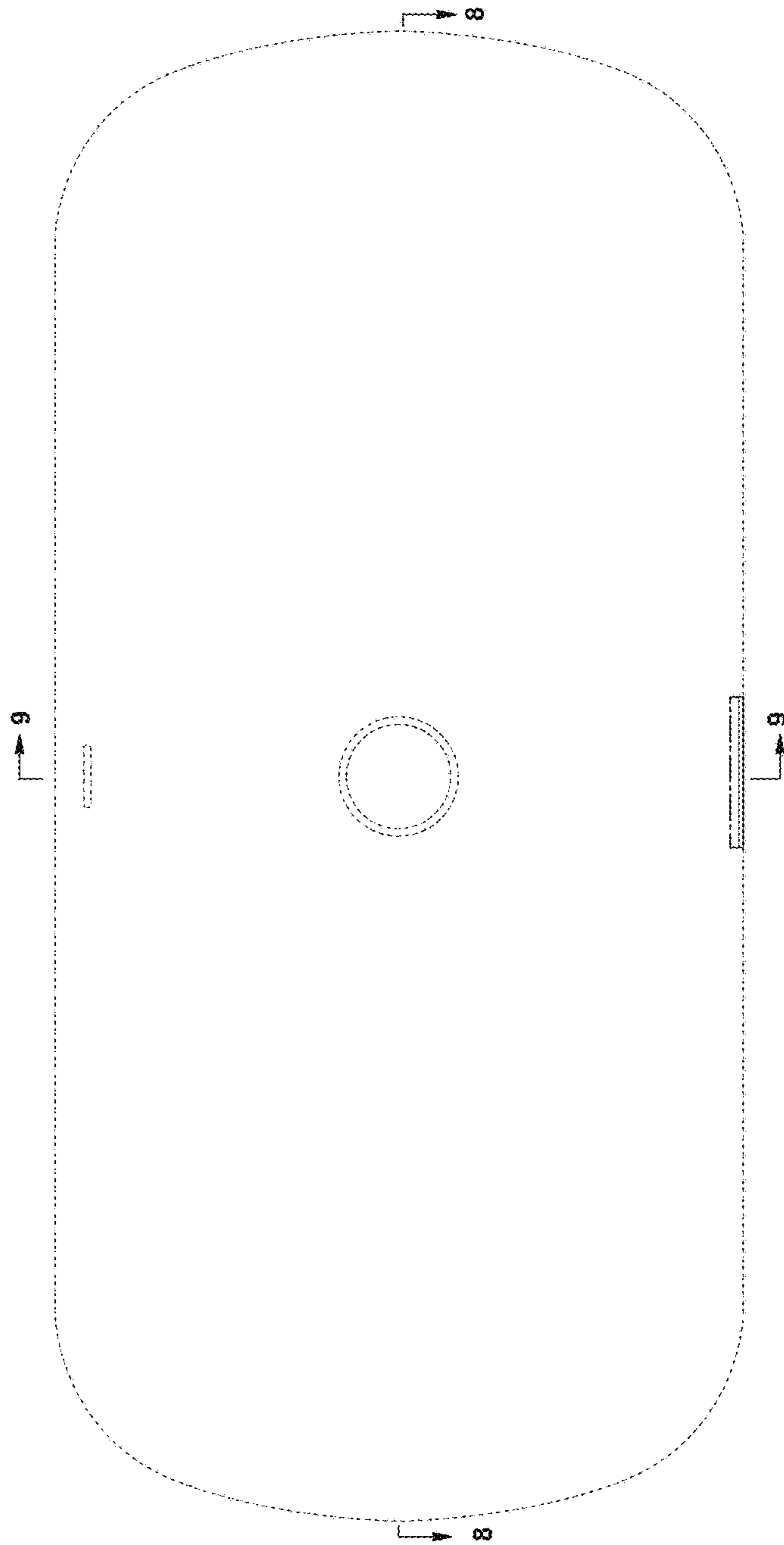

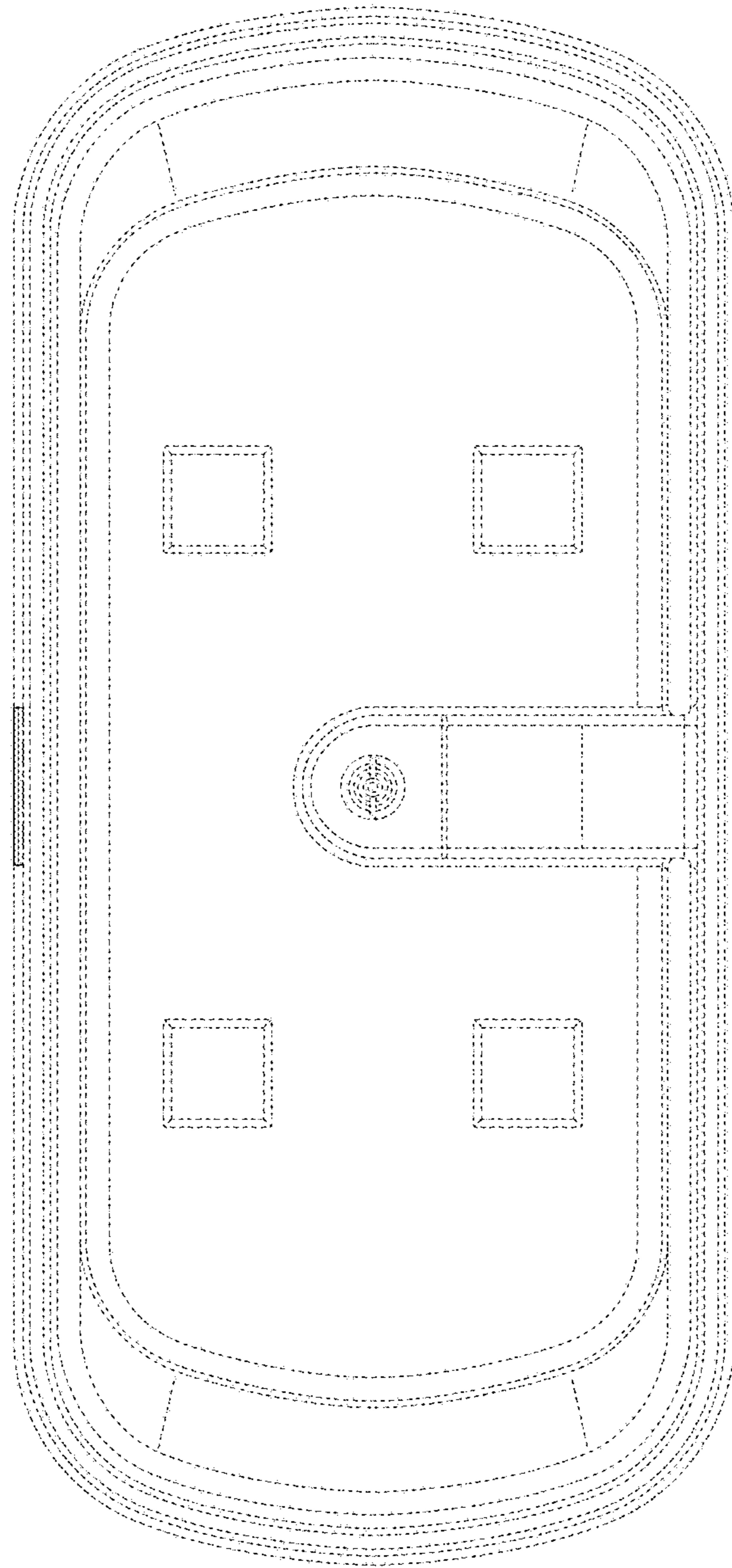

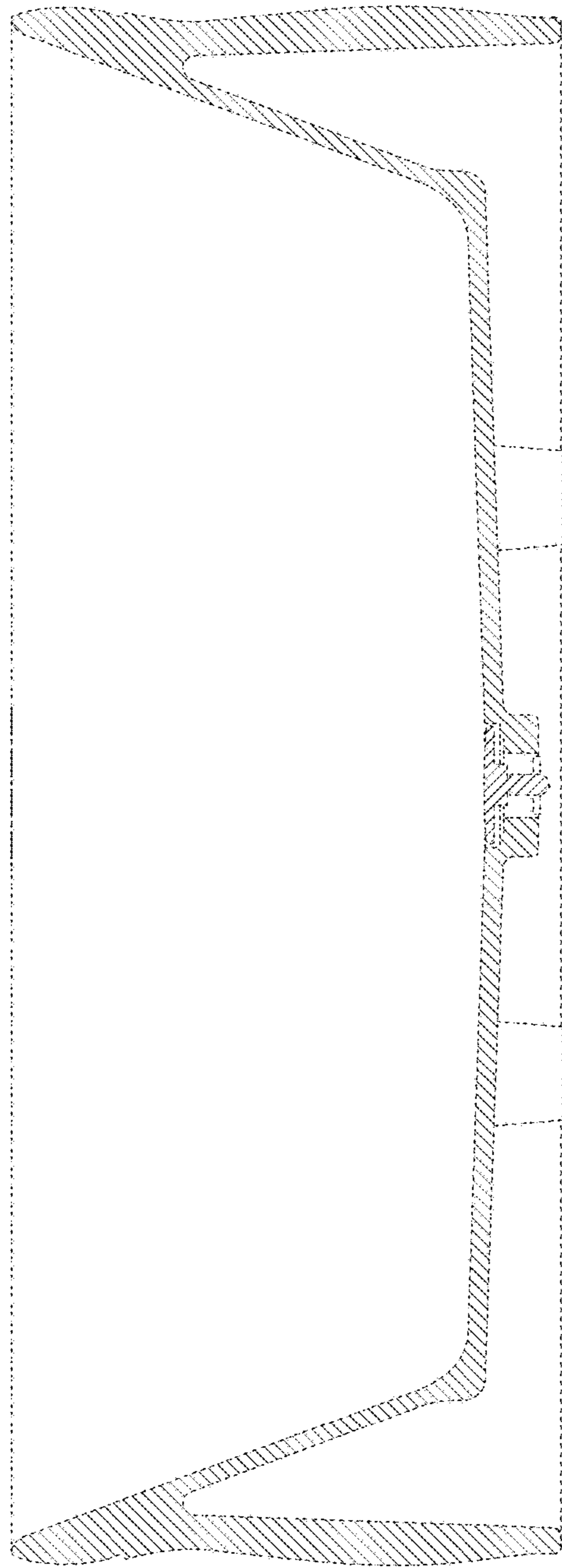

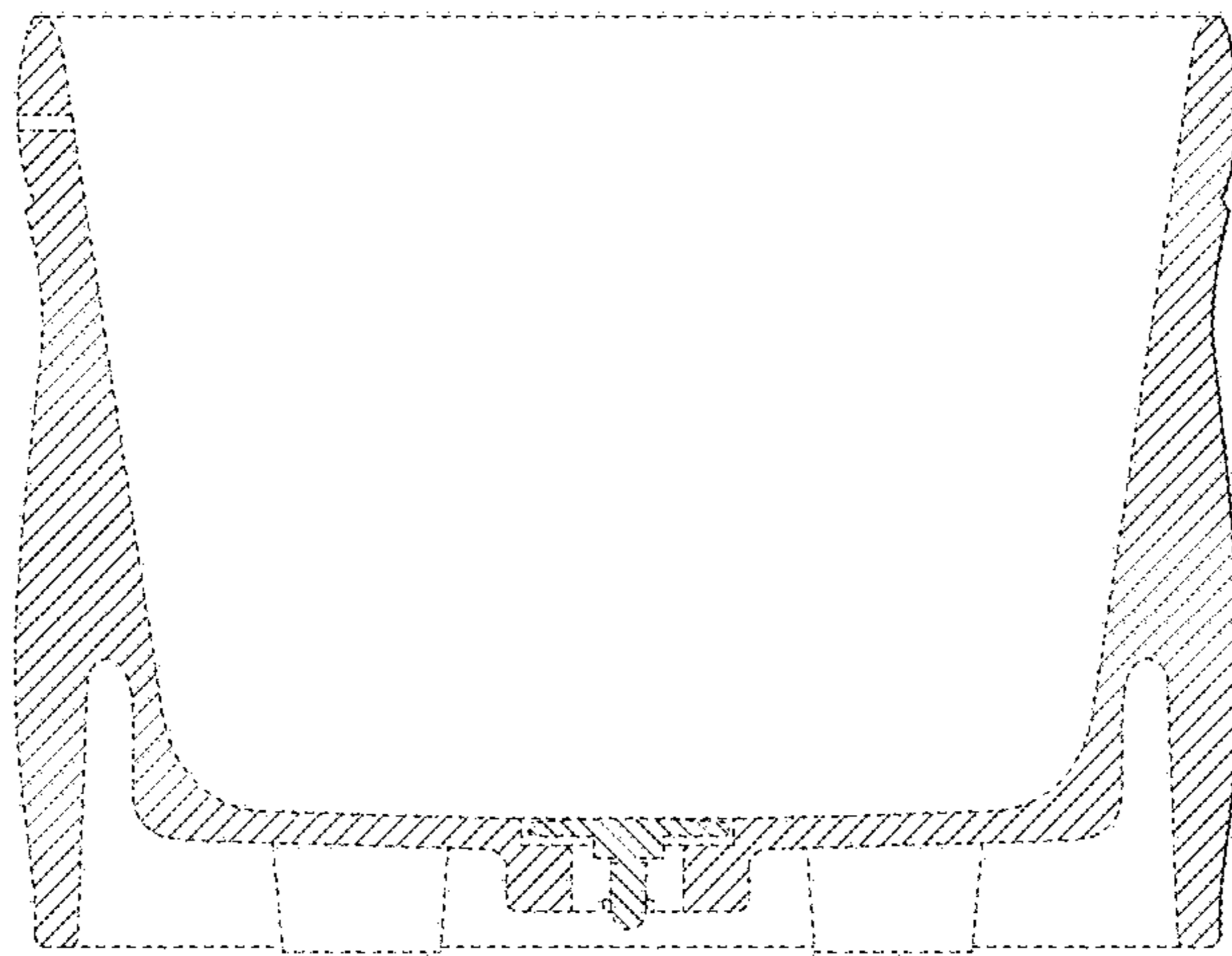
