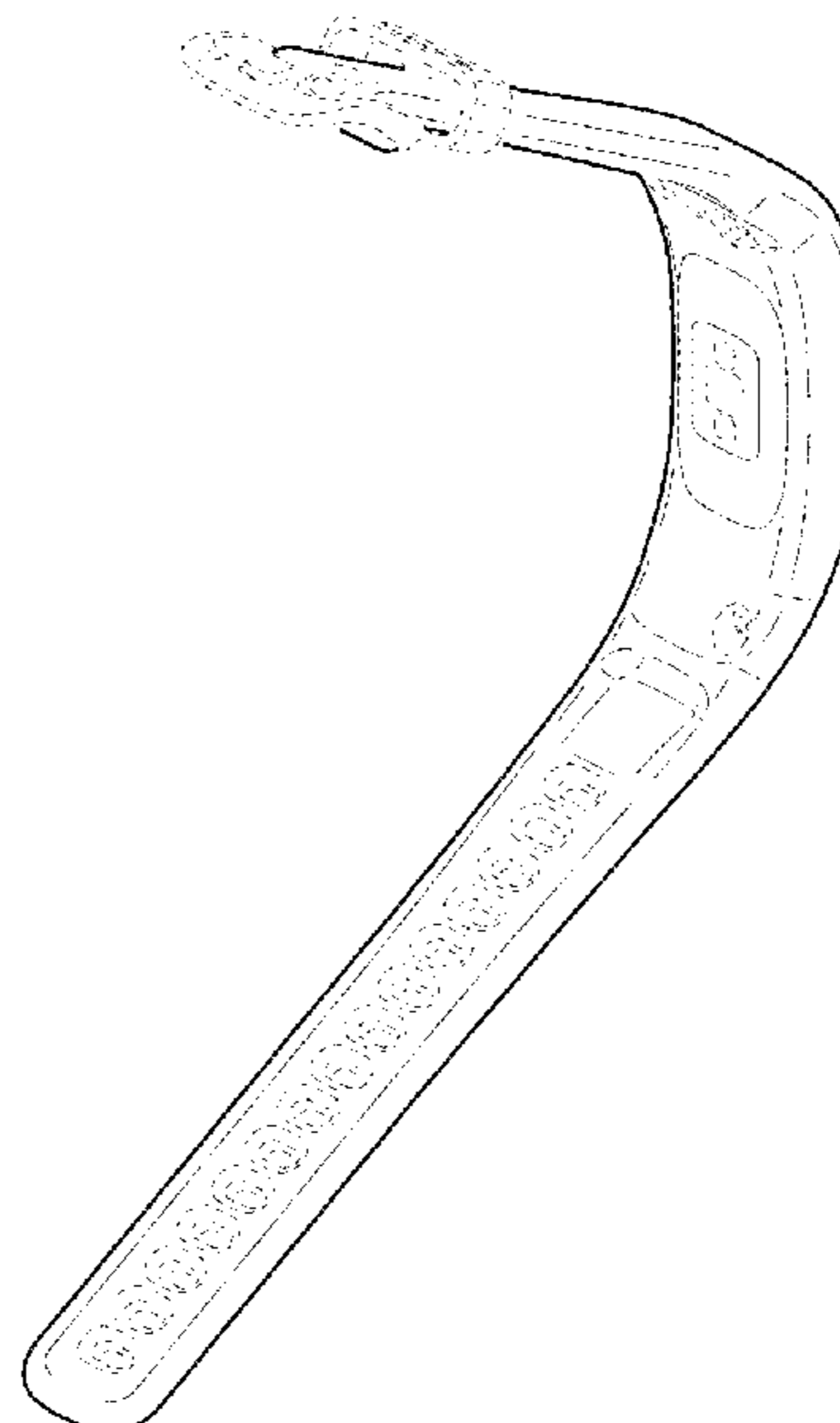
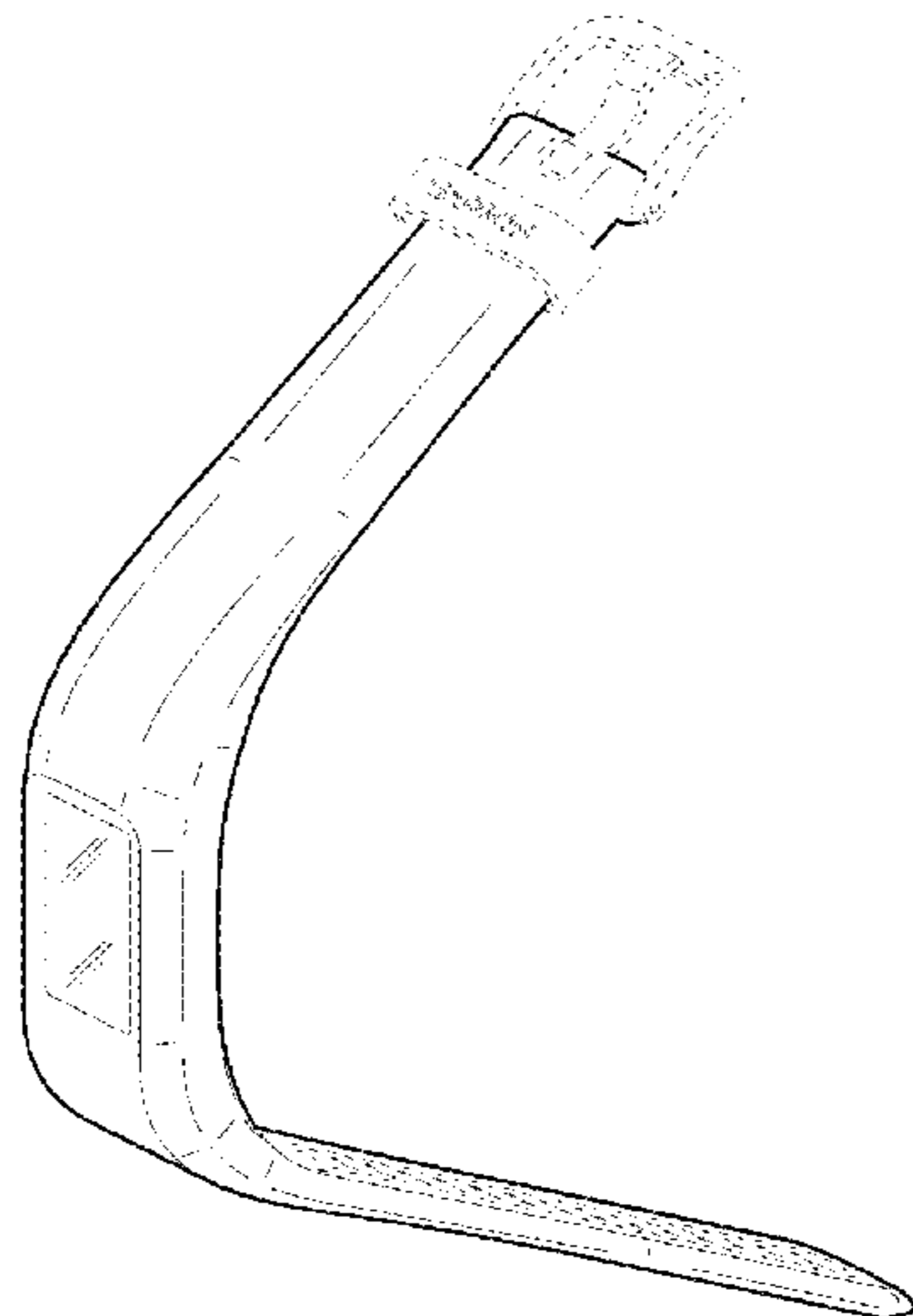
(57) **CLAIM**

The ornamental design for a fitness device with display, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a fitness device with display according to the present invention;
FIG. 2 is a rear perspective view of the fitness device with display;

FIG. 4 is a front view of the fitness device with display;

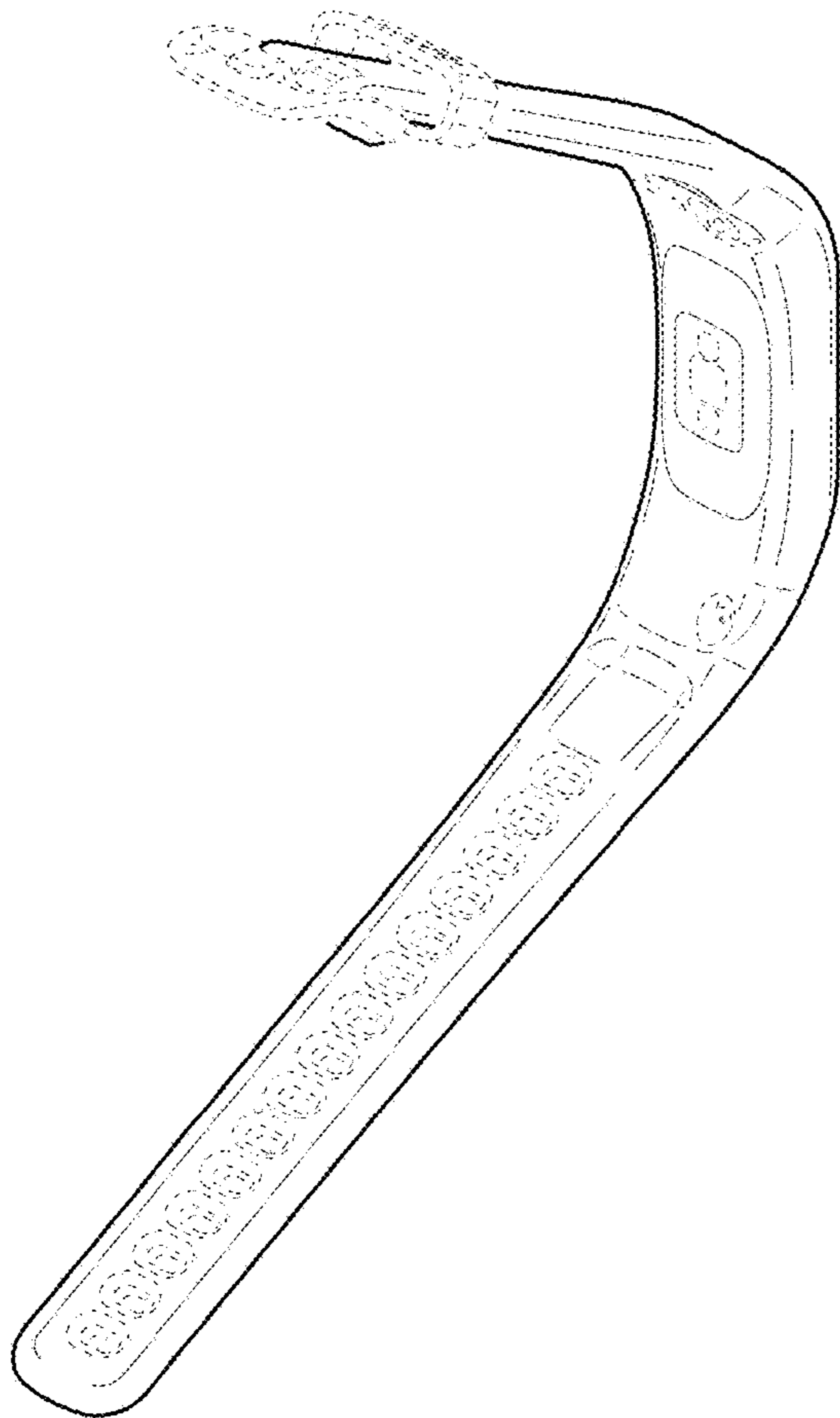
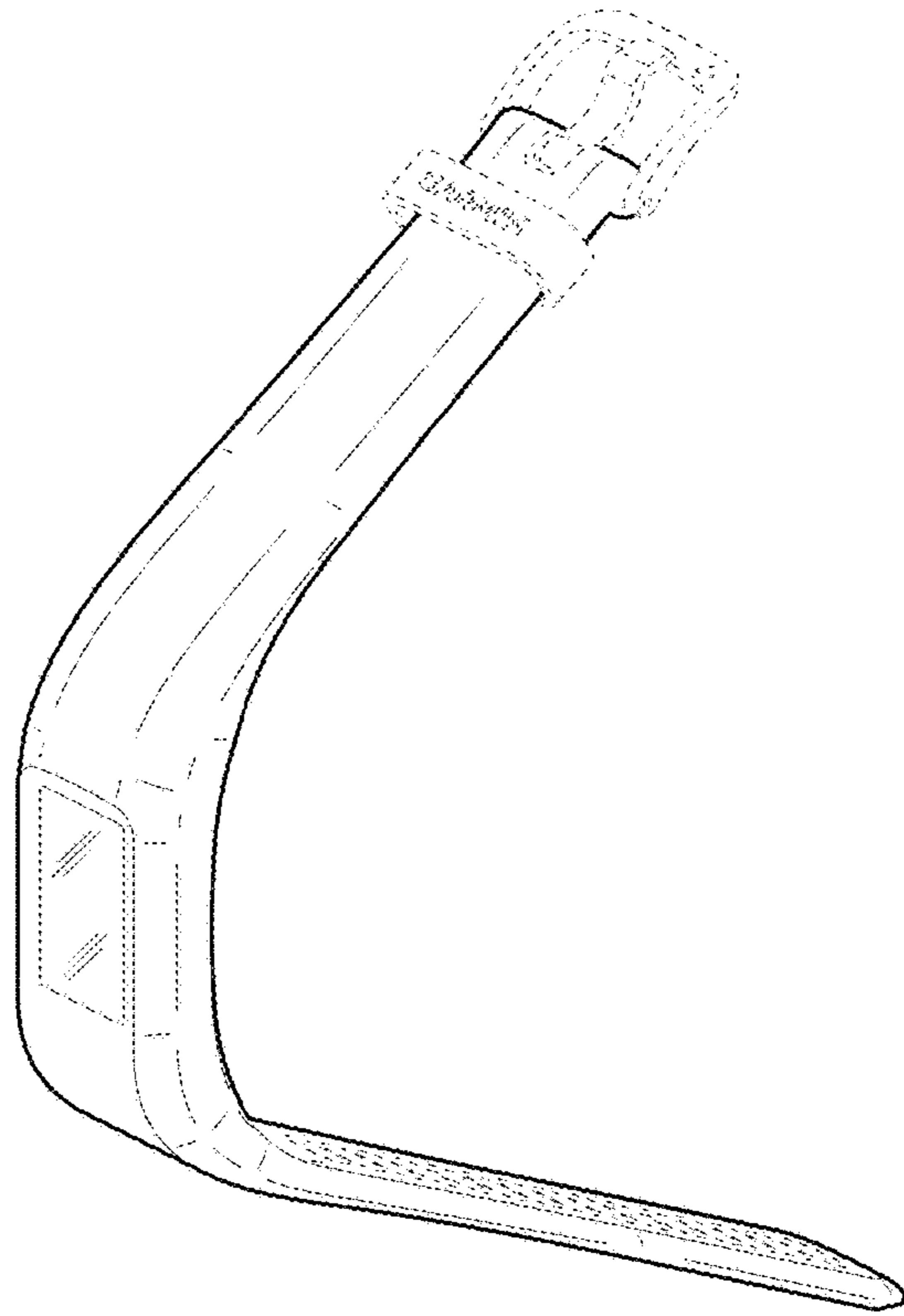

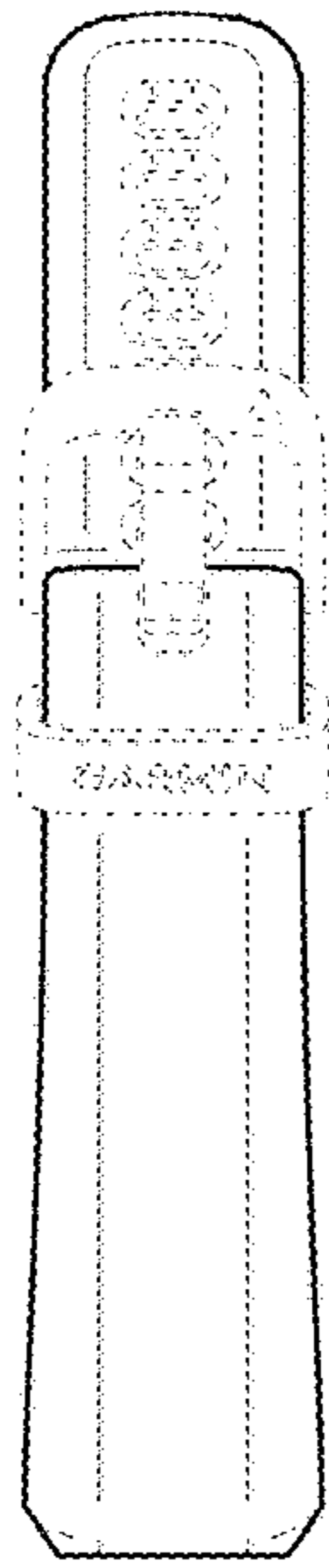

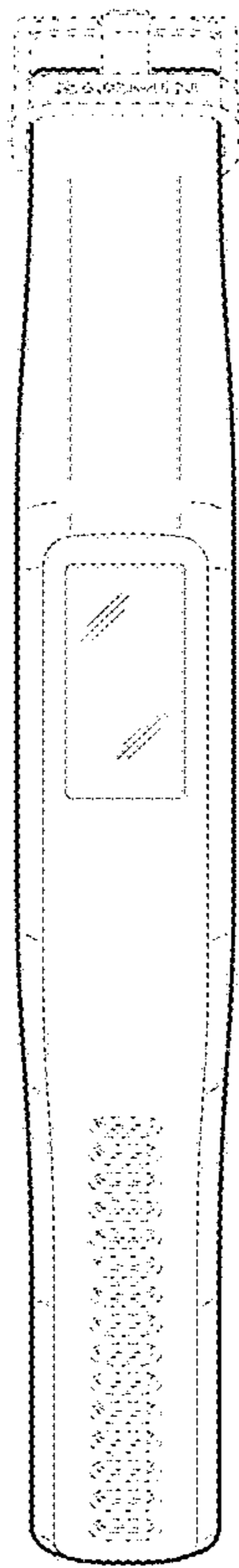

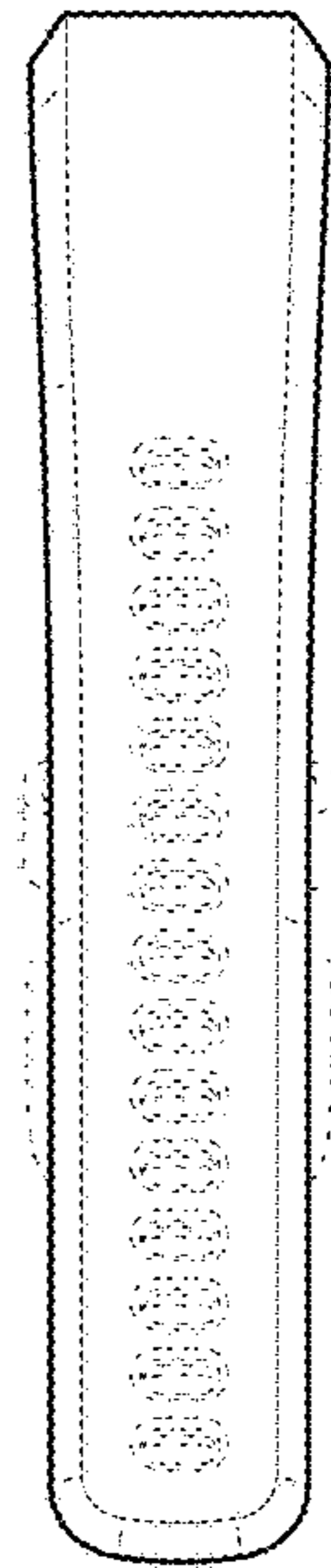

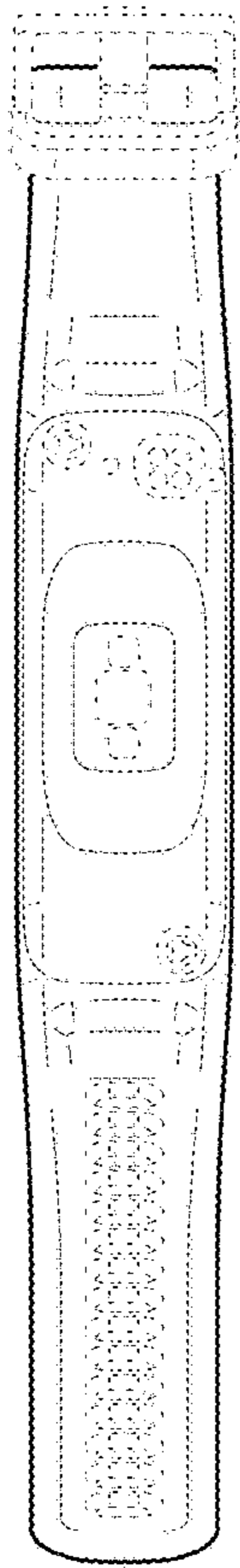

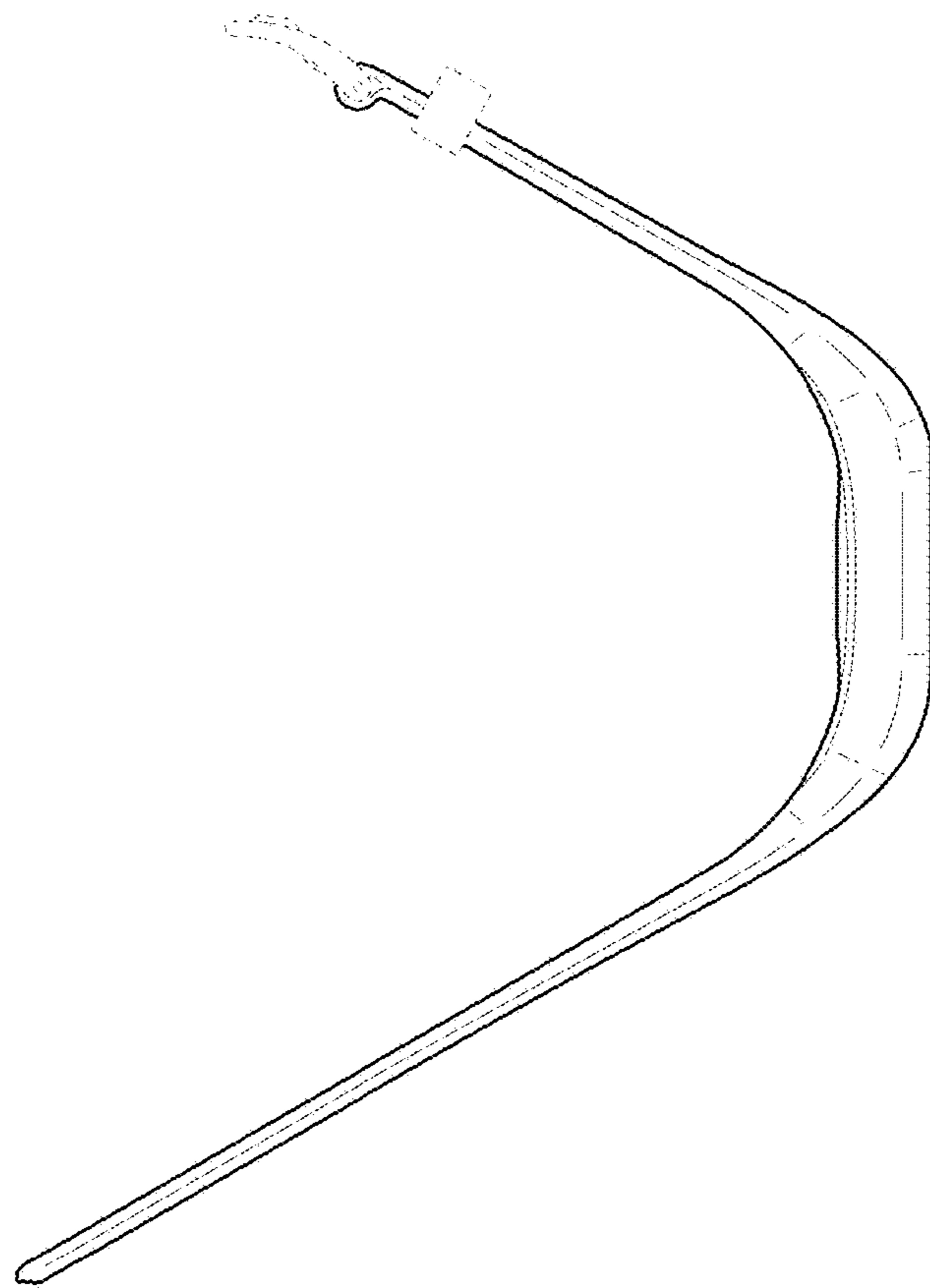

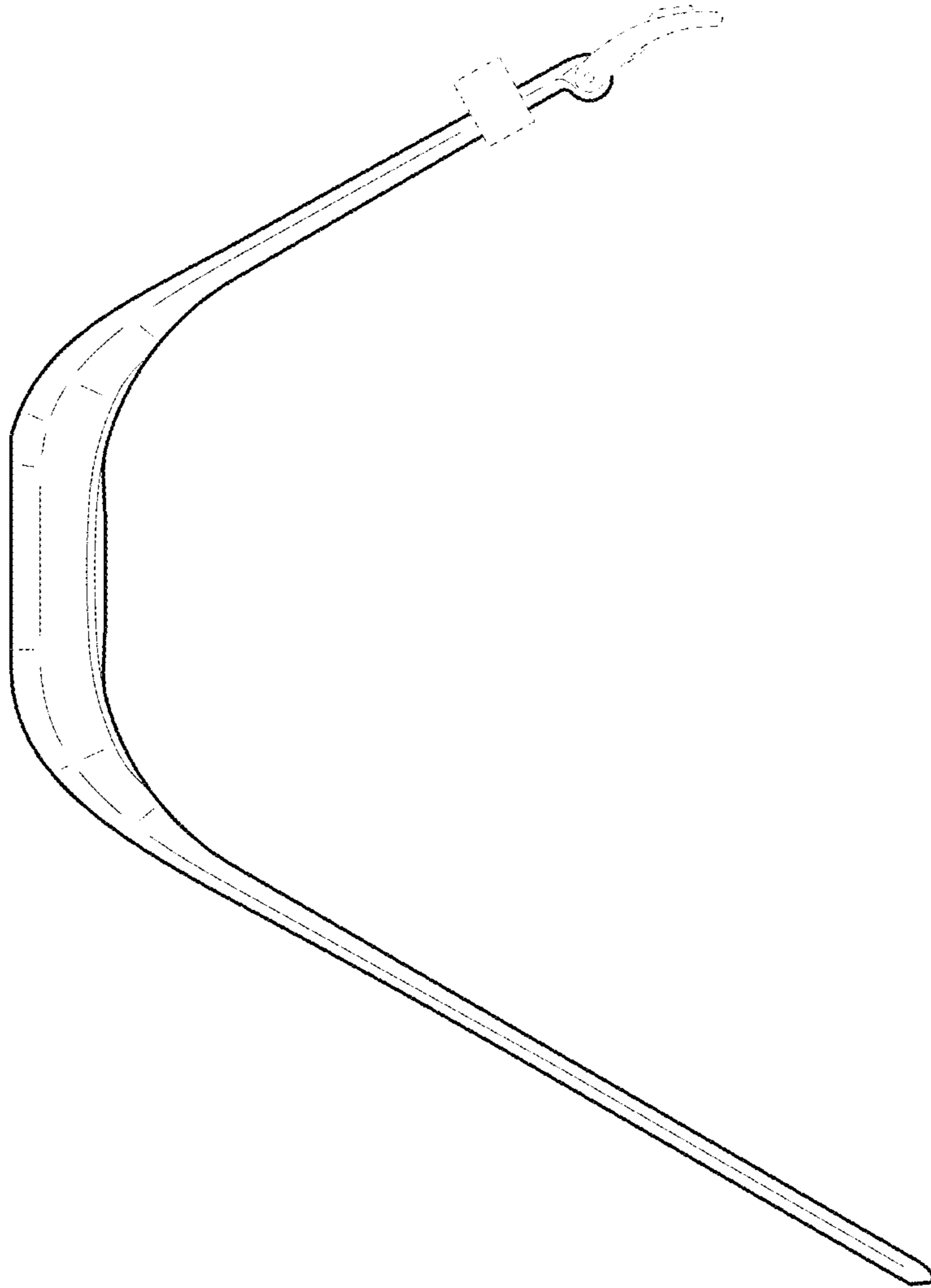
