FIG. 2 is a rear view of a carrot shaped teething toy for infant;

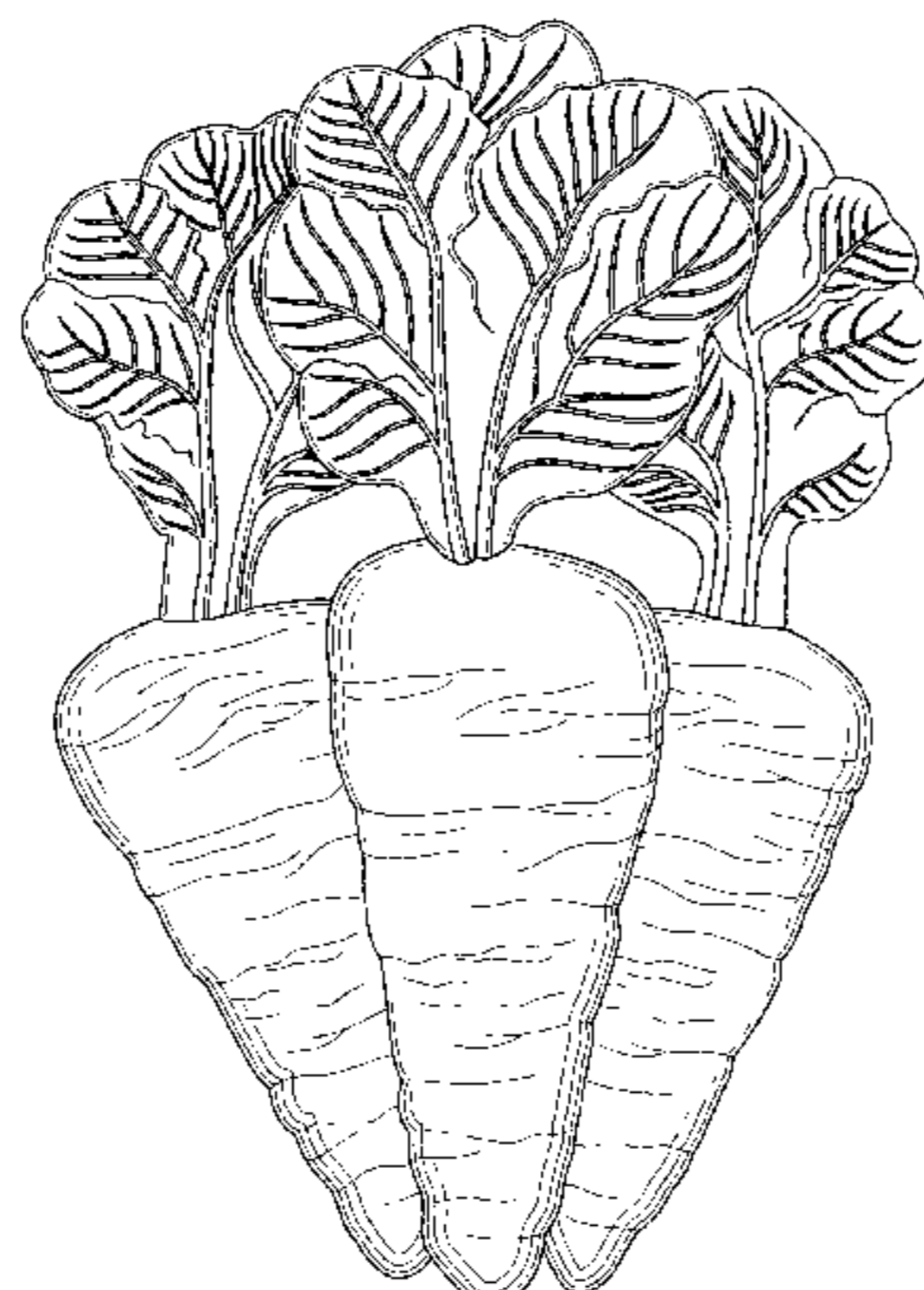
FIG. 3 is a left view of a carrot shaped teething toy for infant;

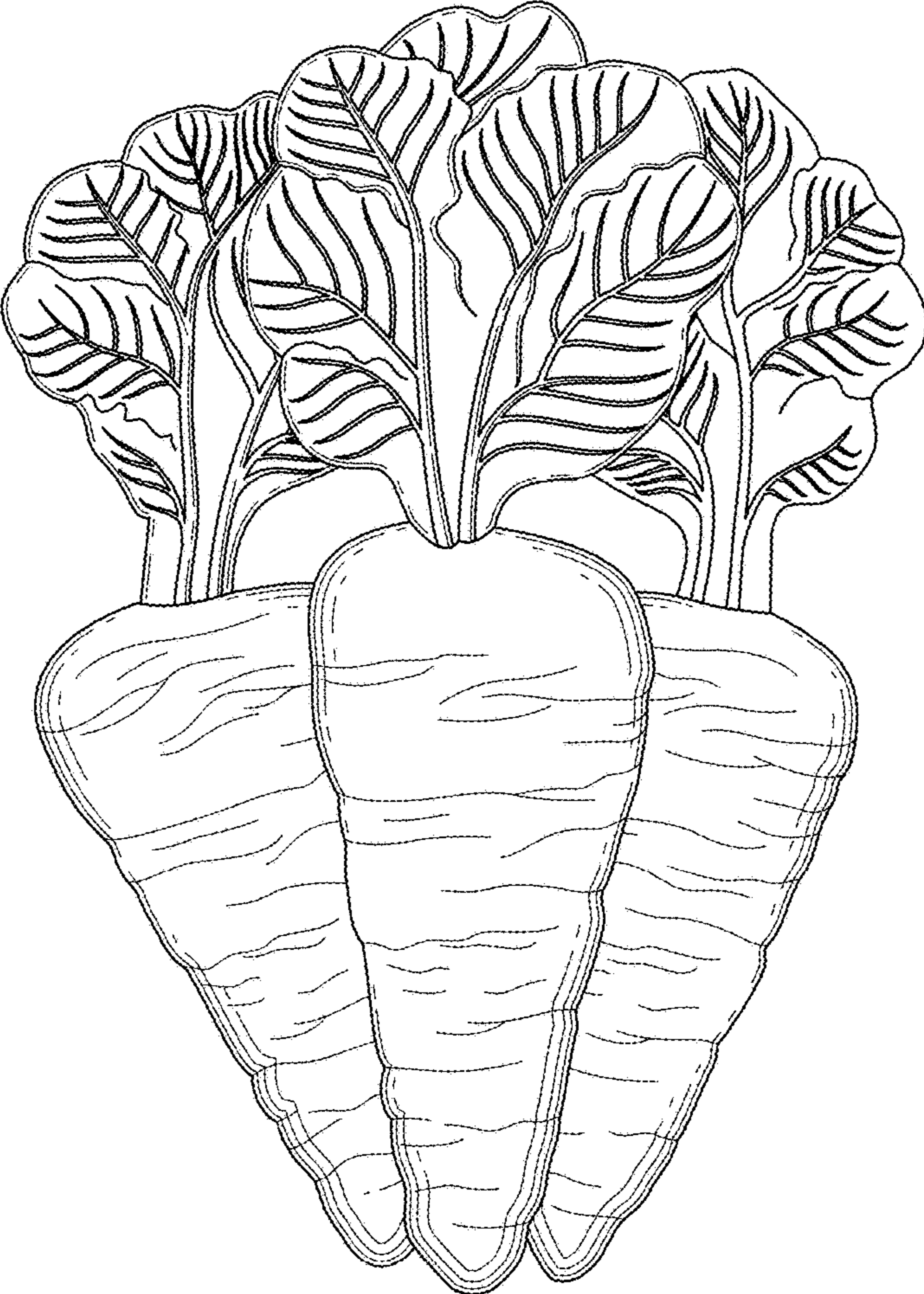

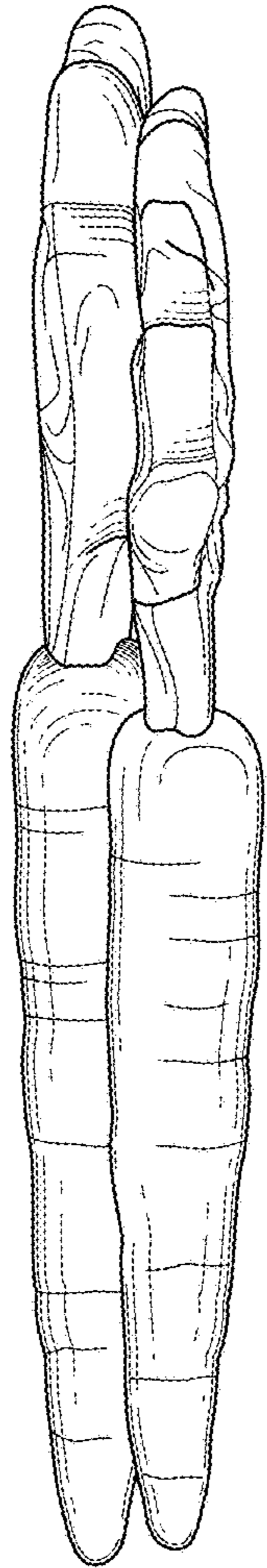

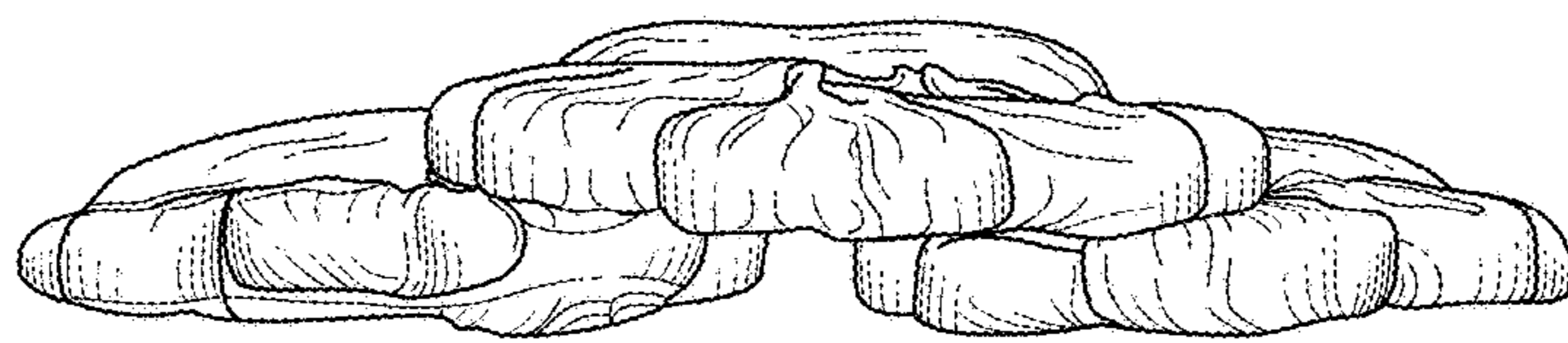

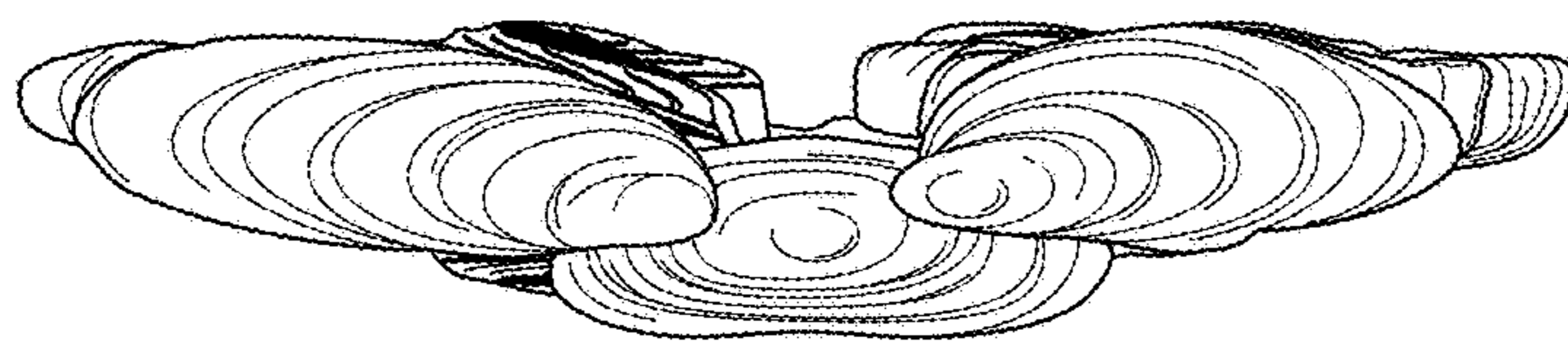
