The ornamental design for a nail cleaning assembly, as shown and described.

**DESCRIPTION**

FIG. 10 is a rear view thereof;

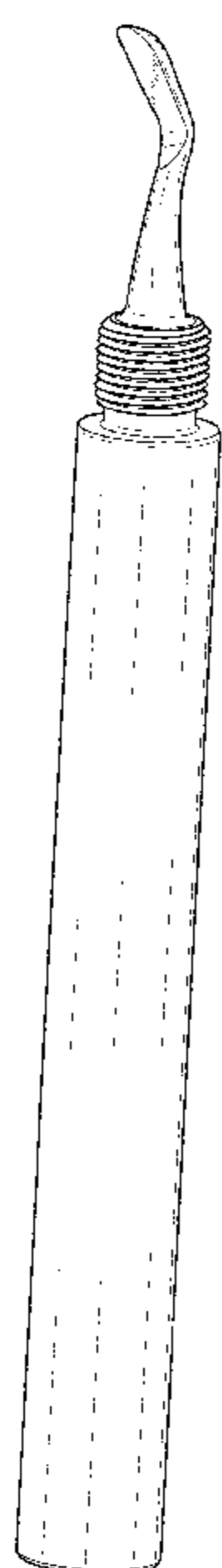
FIG. 11 is a right view thereof;

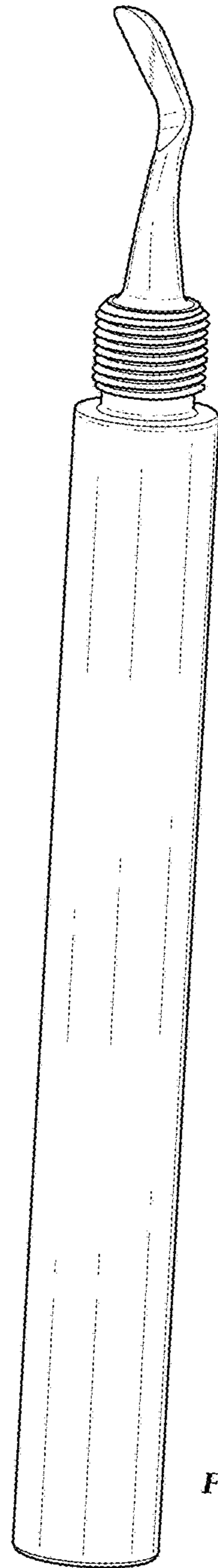
FIG. 12 is a left view thereof;

FIG. 13 is a top view thereof; and,

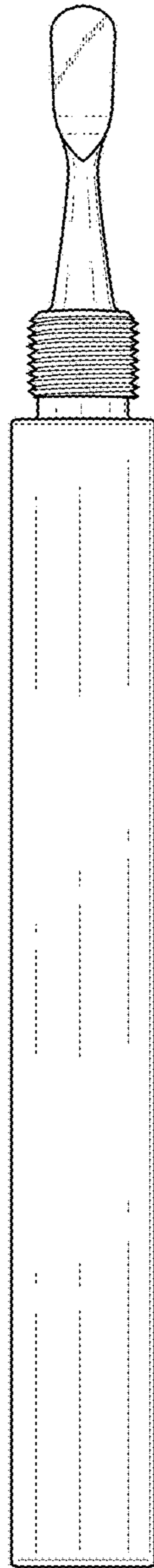
FIG. 14 is a bottom view thereof.

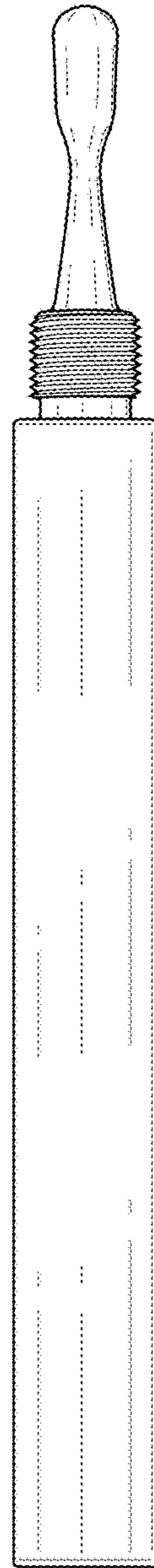

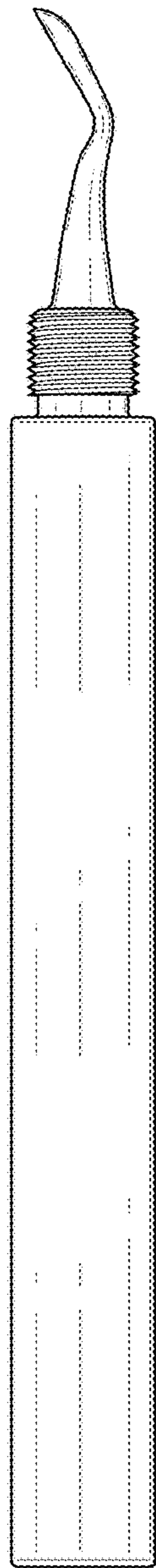

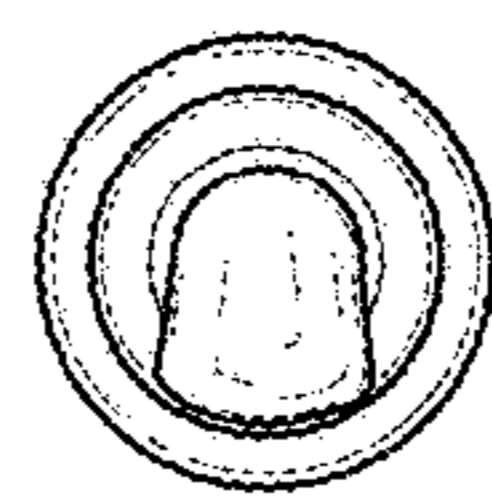

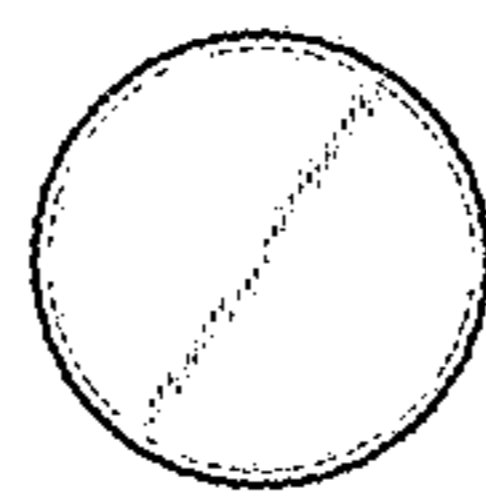

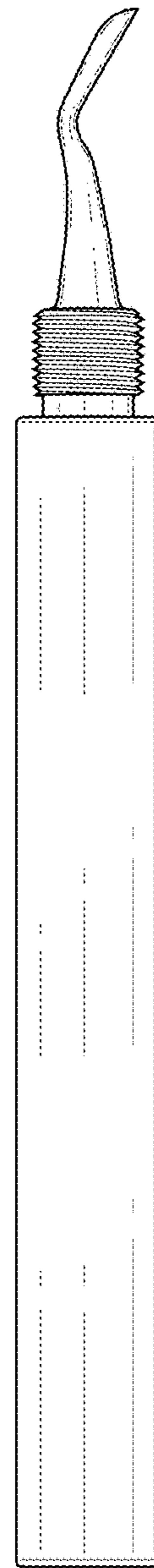
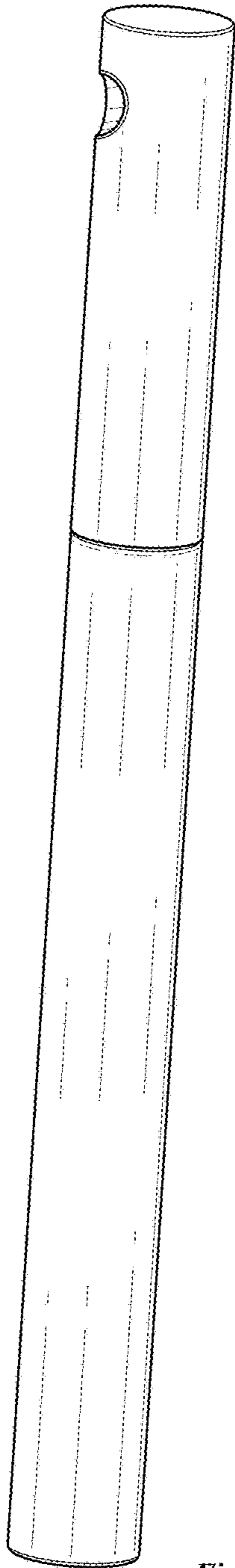

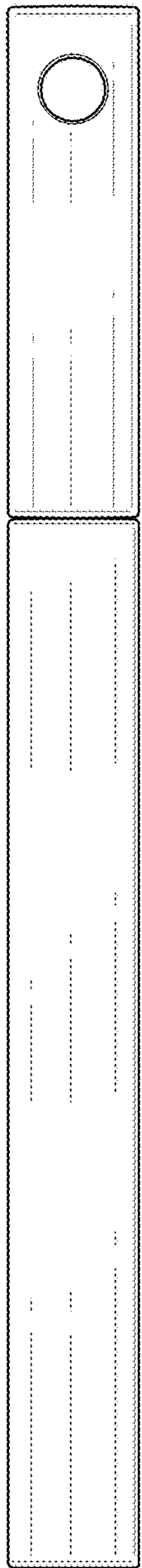

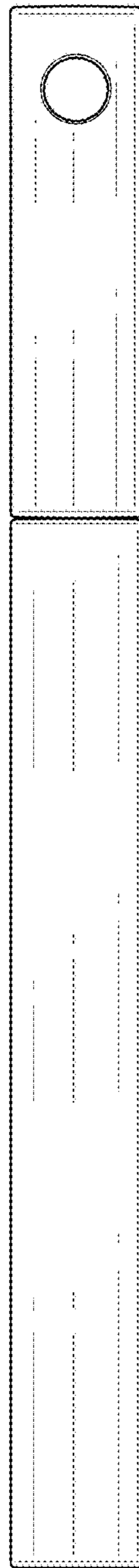
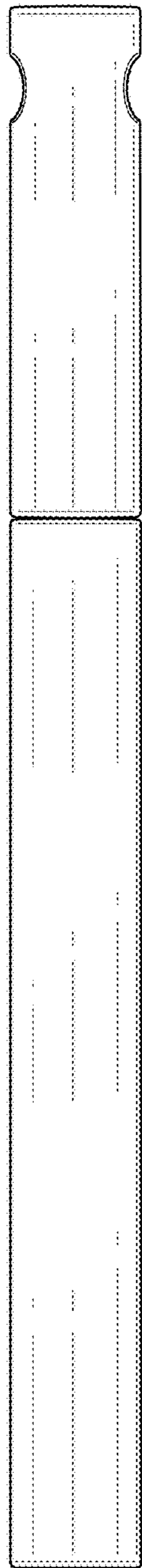
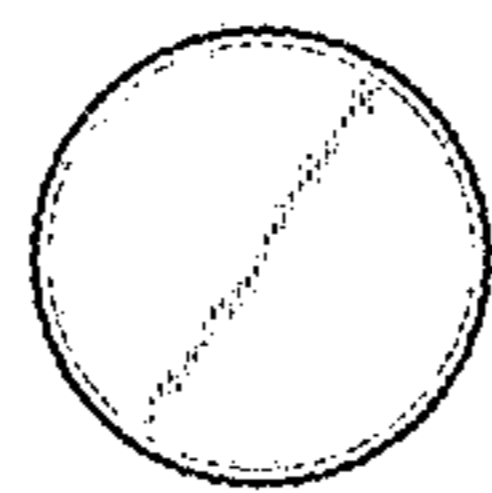


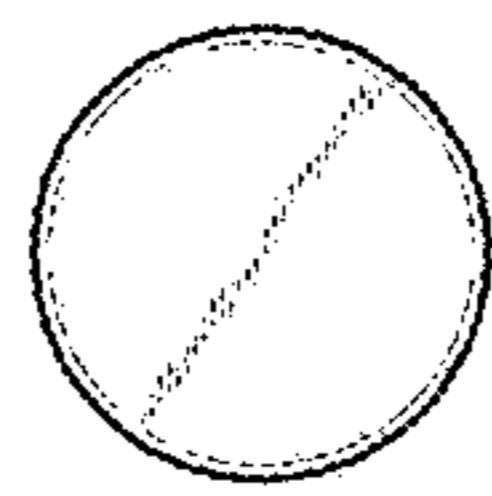

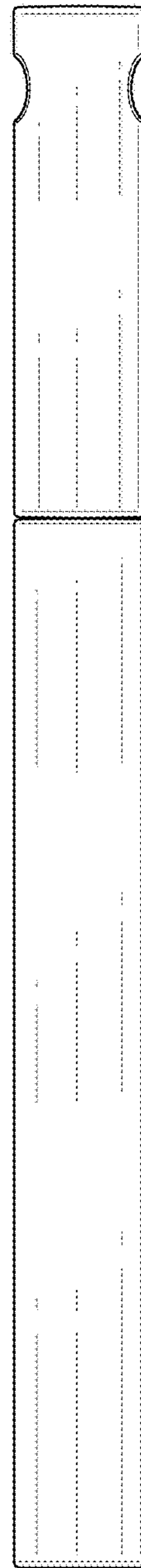
