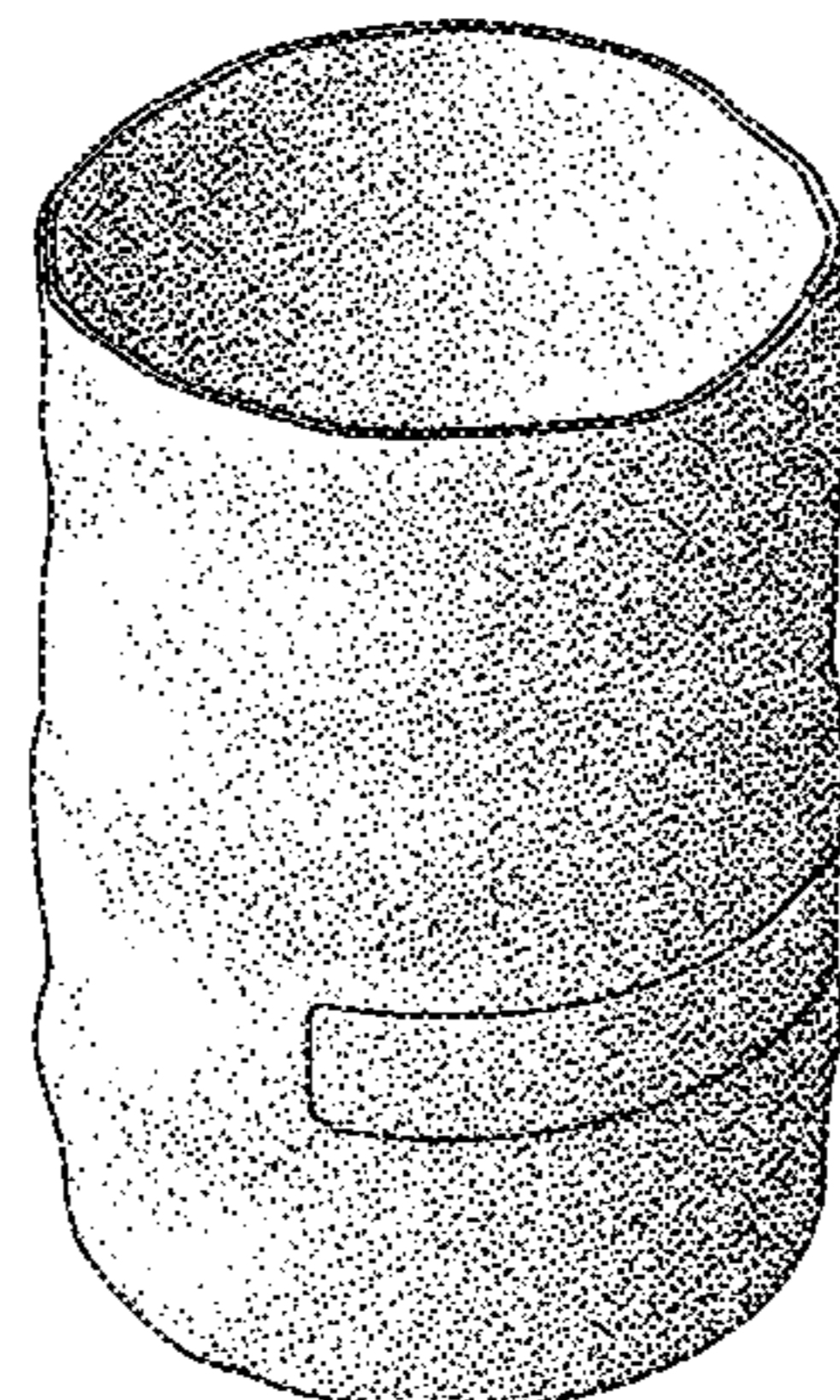
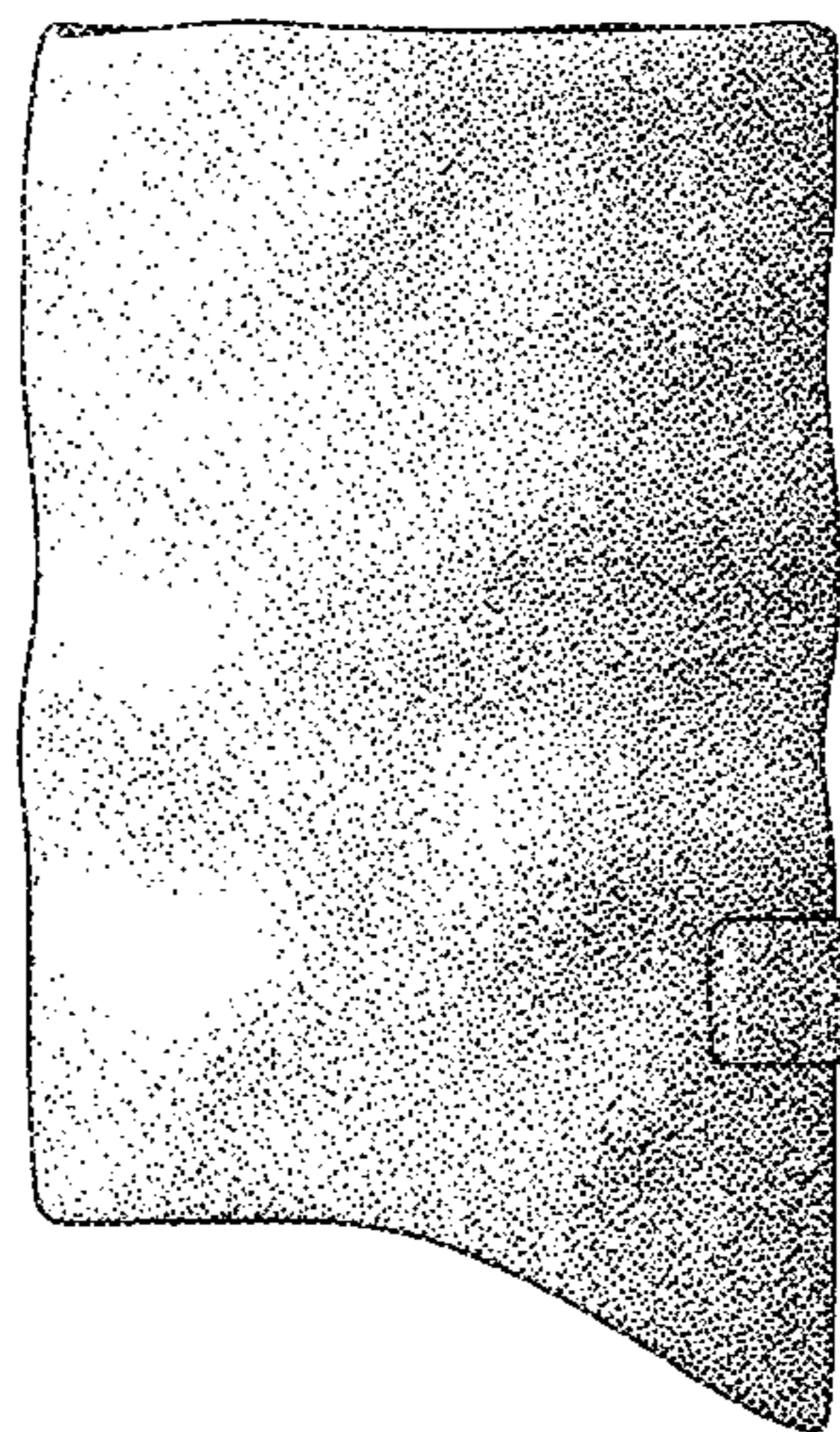
(57) **CLAIM**

The ornamental design for a neck warmer garment, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a user wearing one embodiment of a neck warmer garment showing our new design; FIG. 2 is a top perspective view of the neck warmer garment; FIG. 3 is a bottom perspective view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a rear view thereof; FIG. 6 is a left side view thereof; FIG. 7 is a front view thereof; FIG. 8 is a bottom view thereof; FIG. 9 is a perspective view of a second embodiment of a neck warmer garment showing our new design; FIG. 10 is a right side view thereof; FIG. 11 is a rear view thereof; FIG. 12 is a left side view thereof; and, FIG. 13 is a front view thereof. The broken line outline of the partial human figure assists in illustrating how the neck warmer garment may appear when worn, but forms no part of the claimed design.

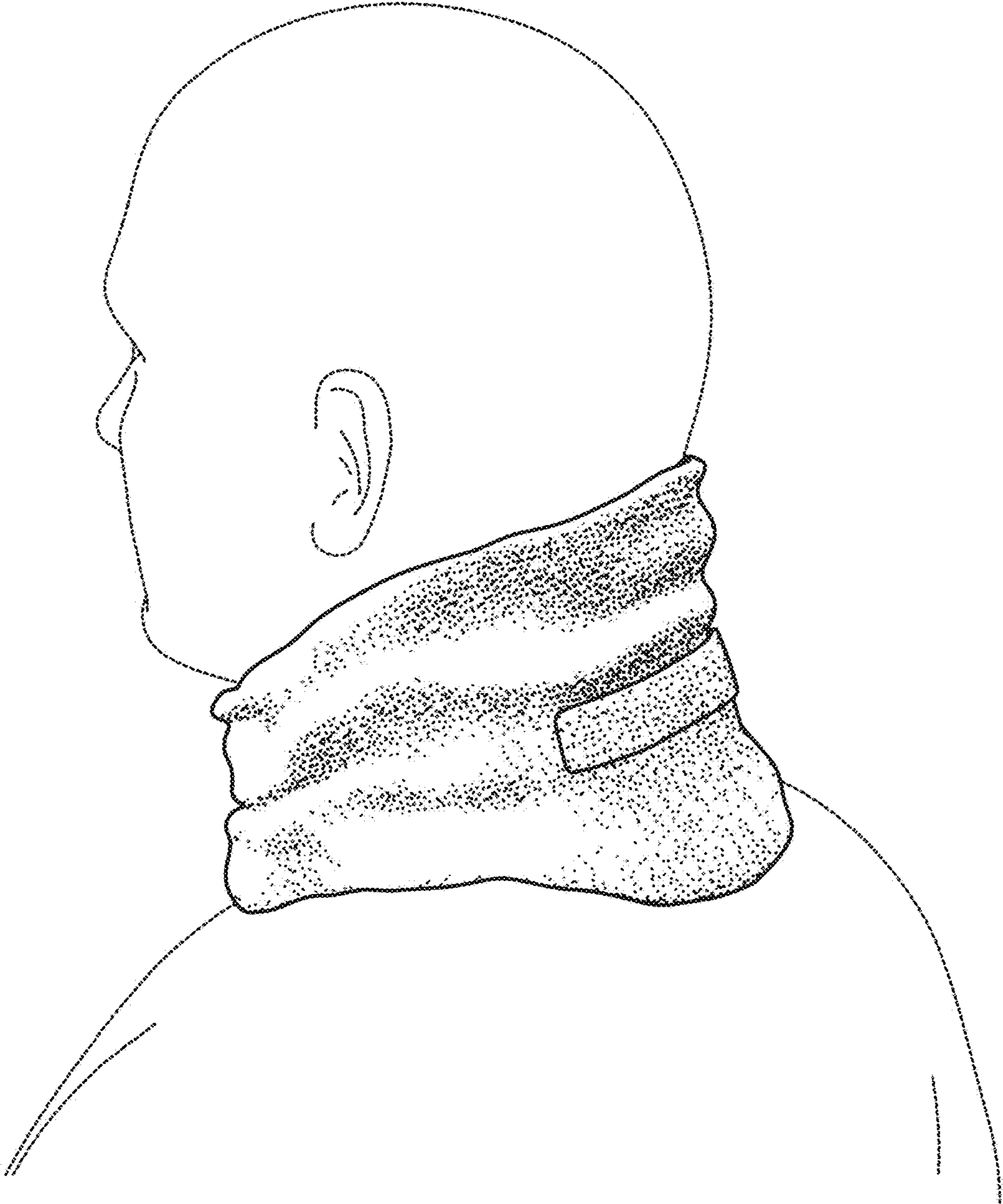

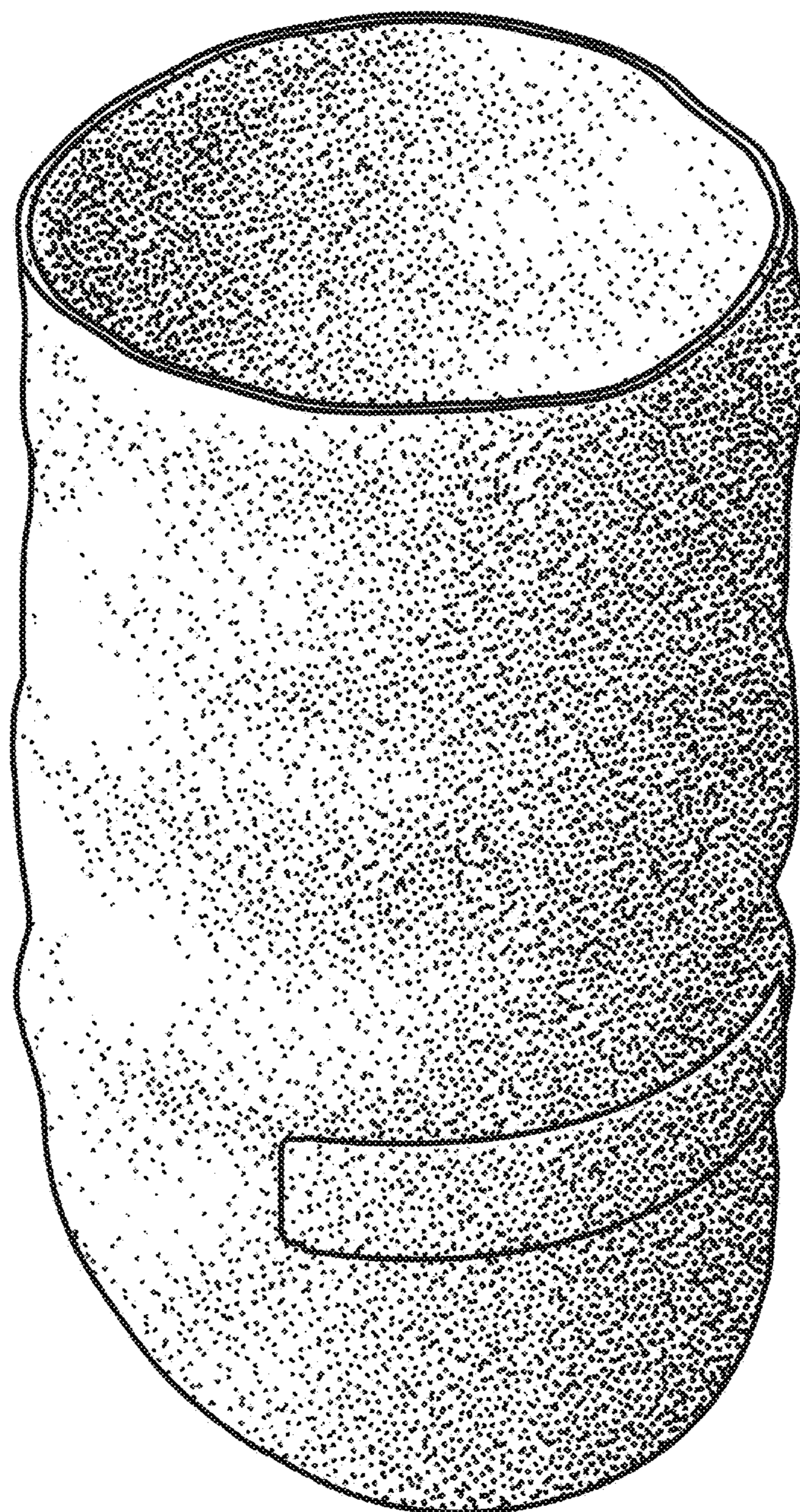

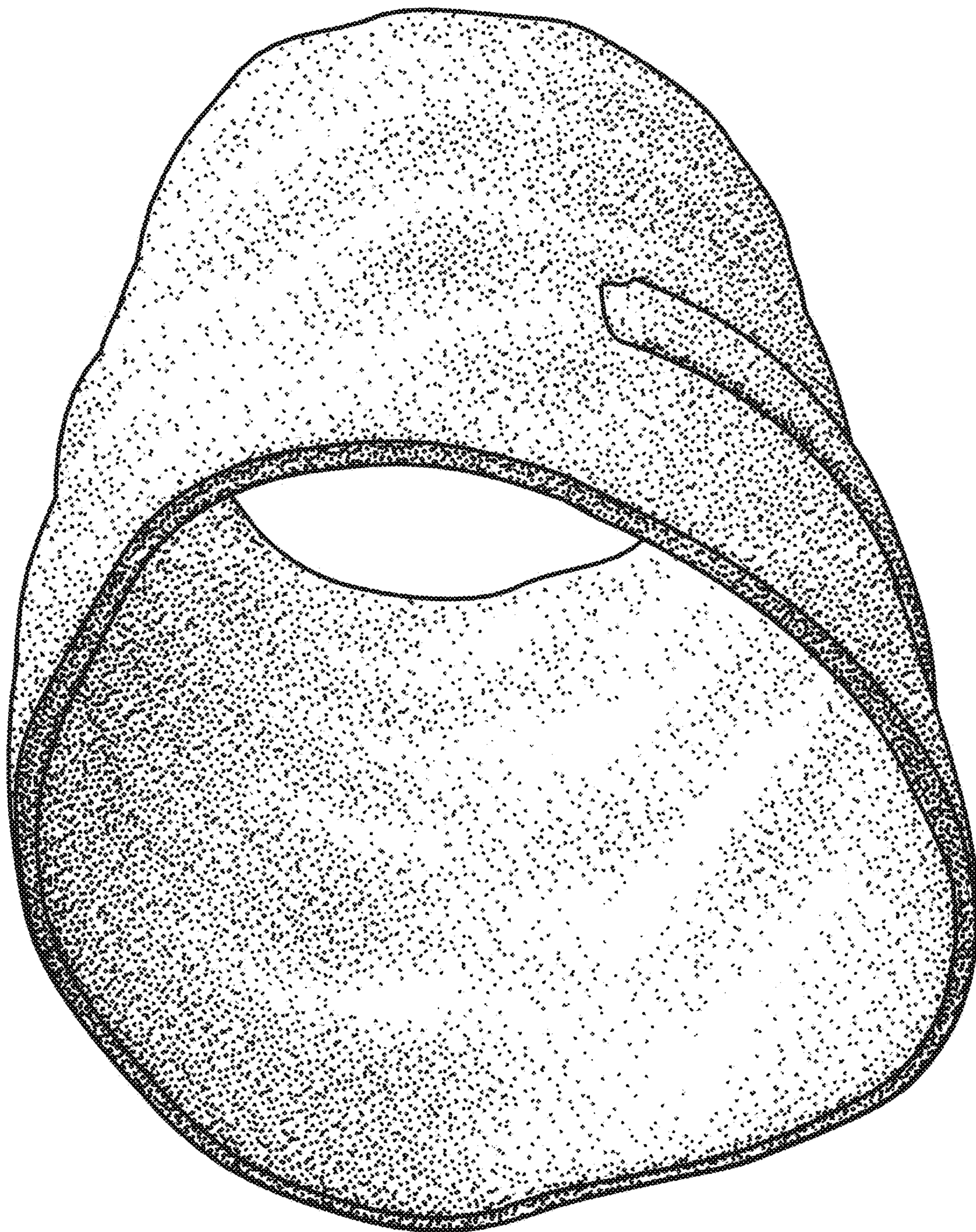

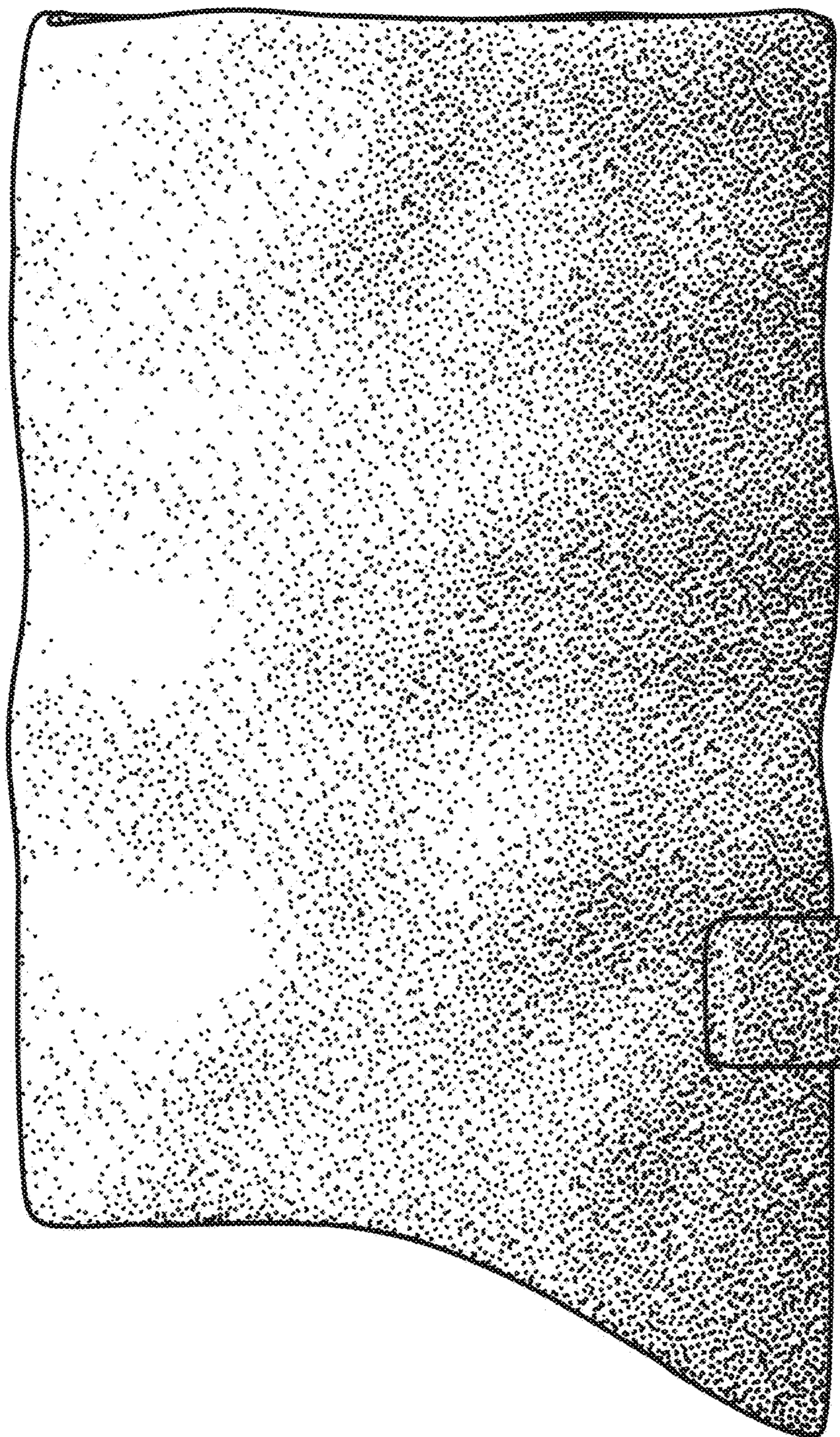

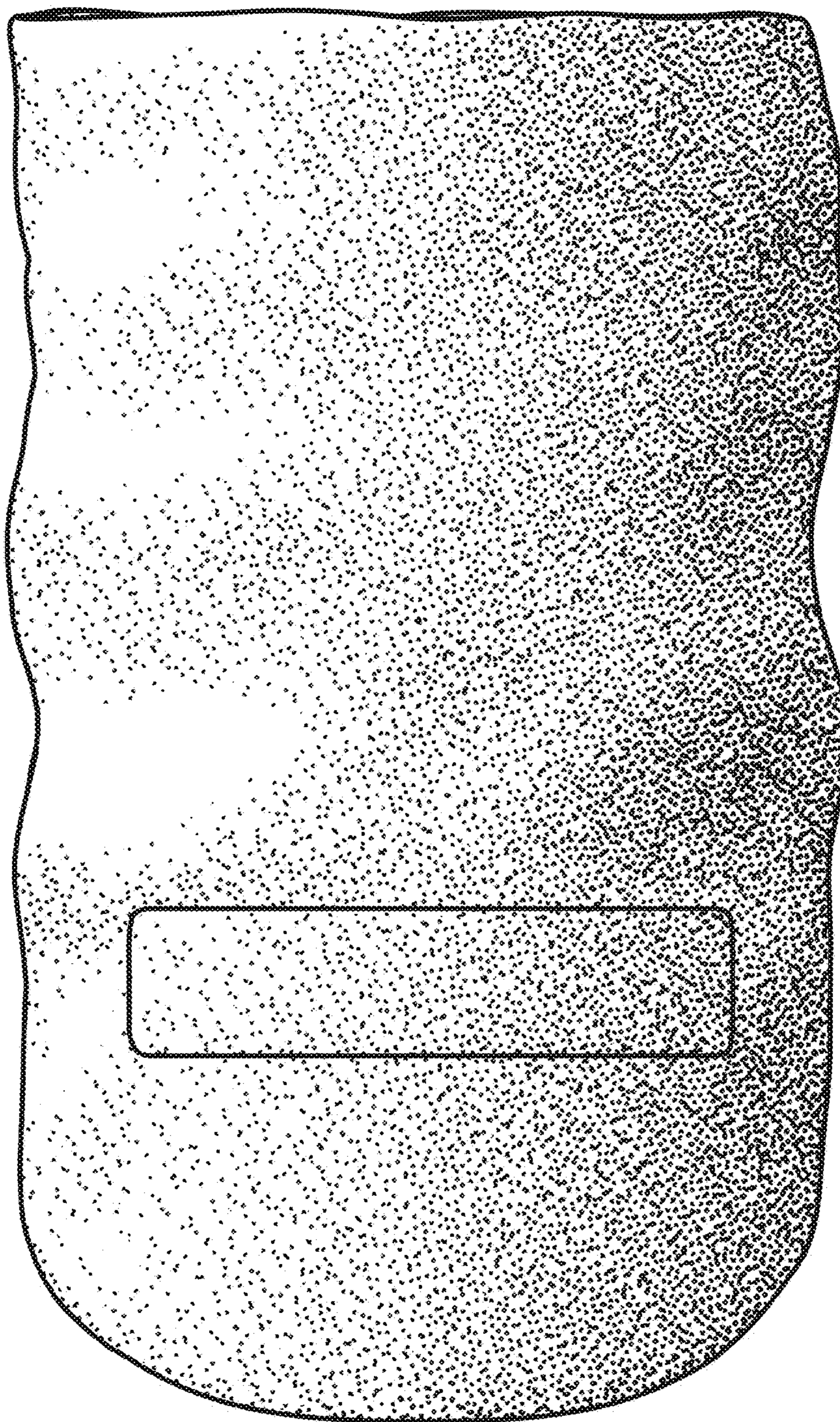

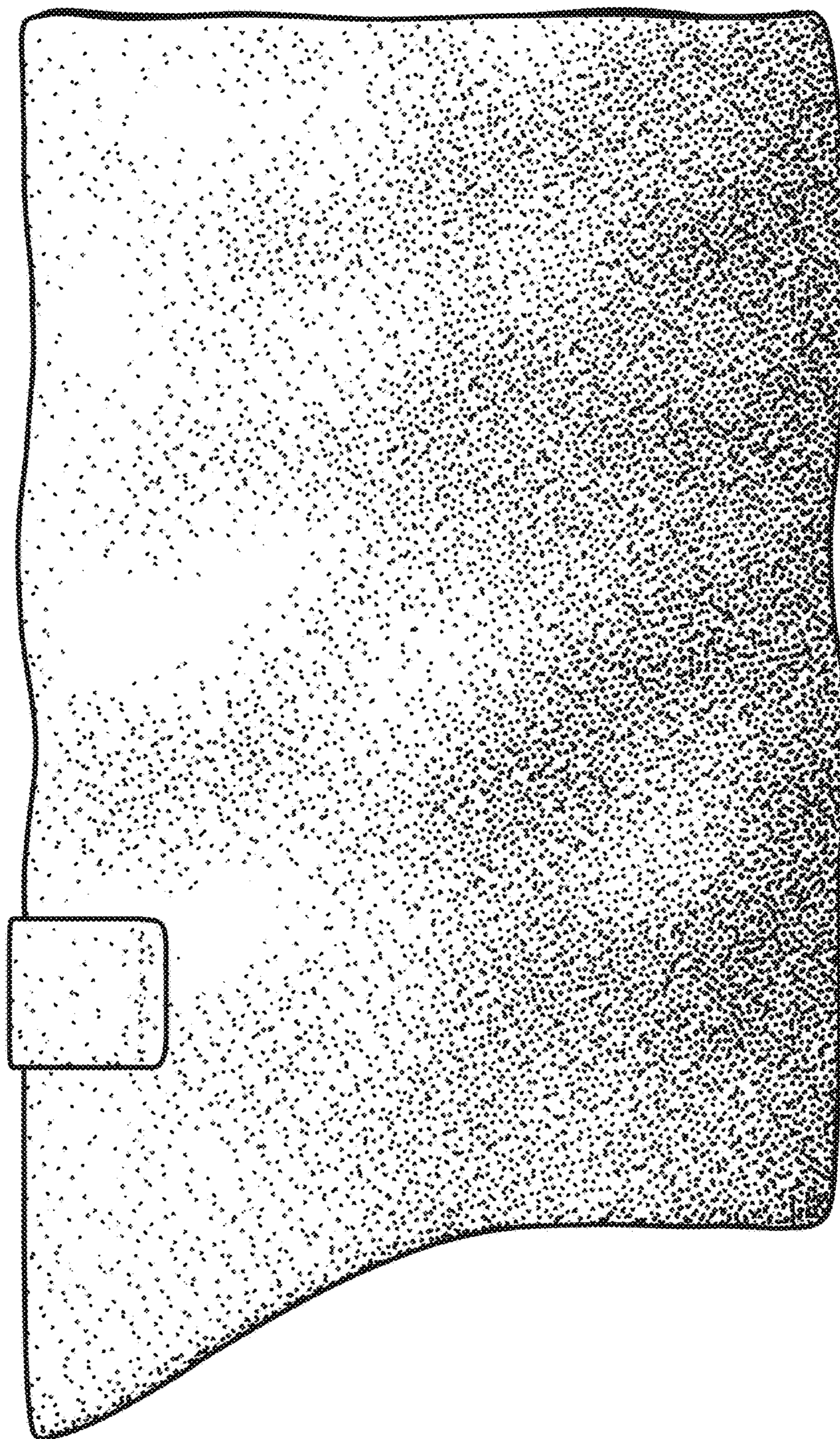

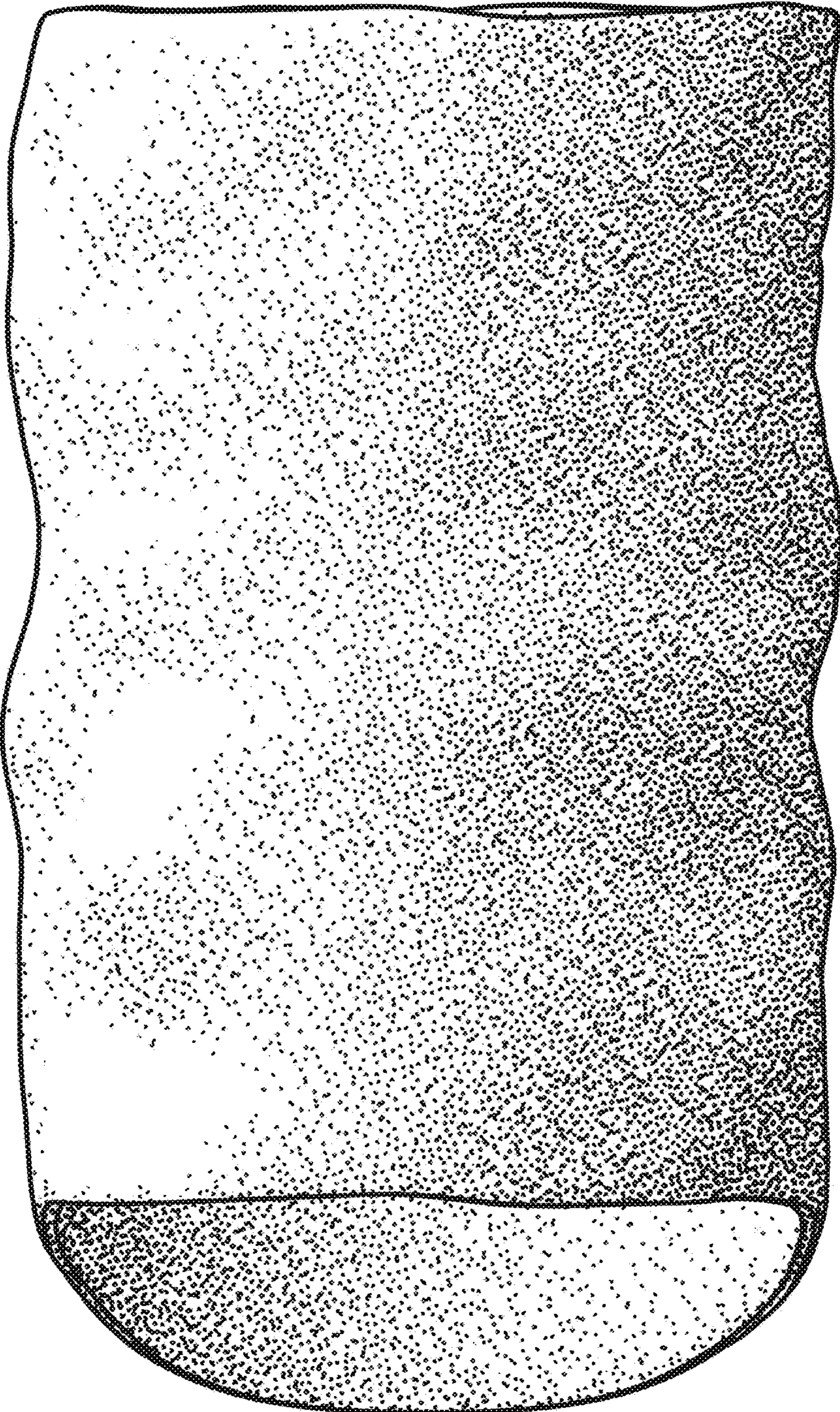

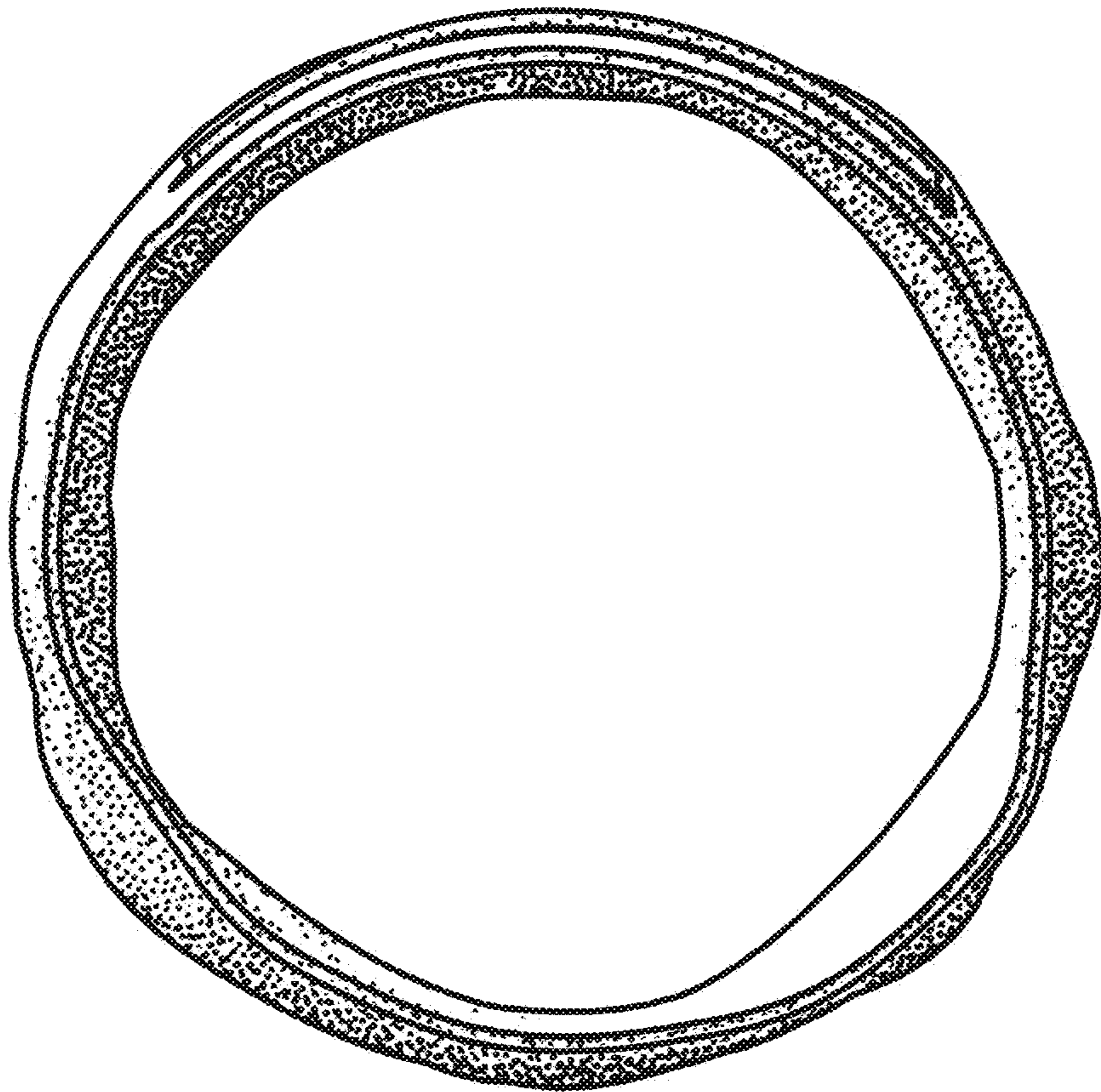

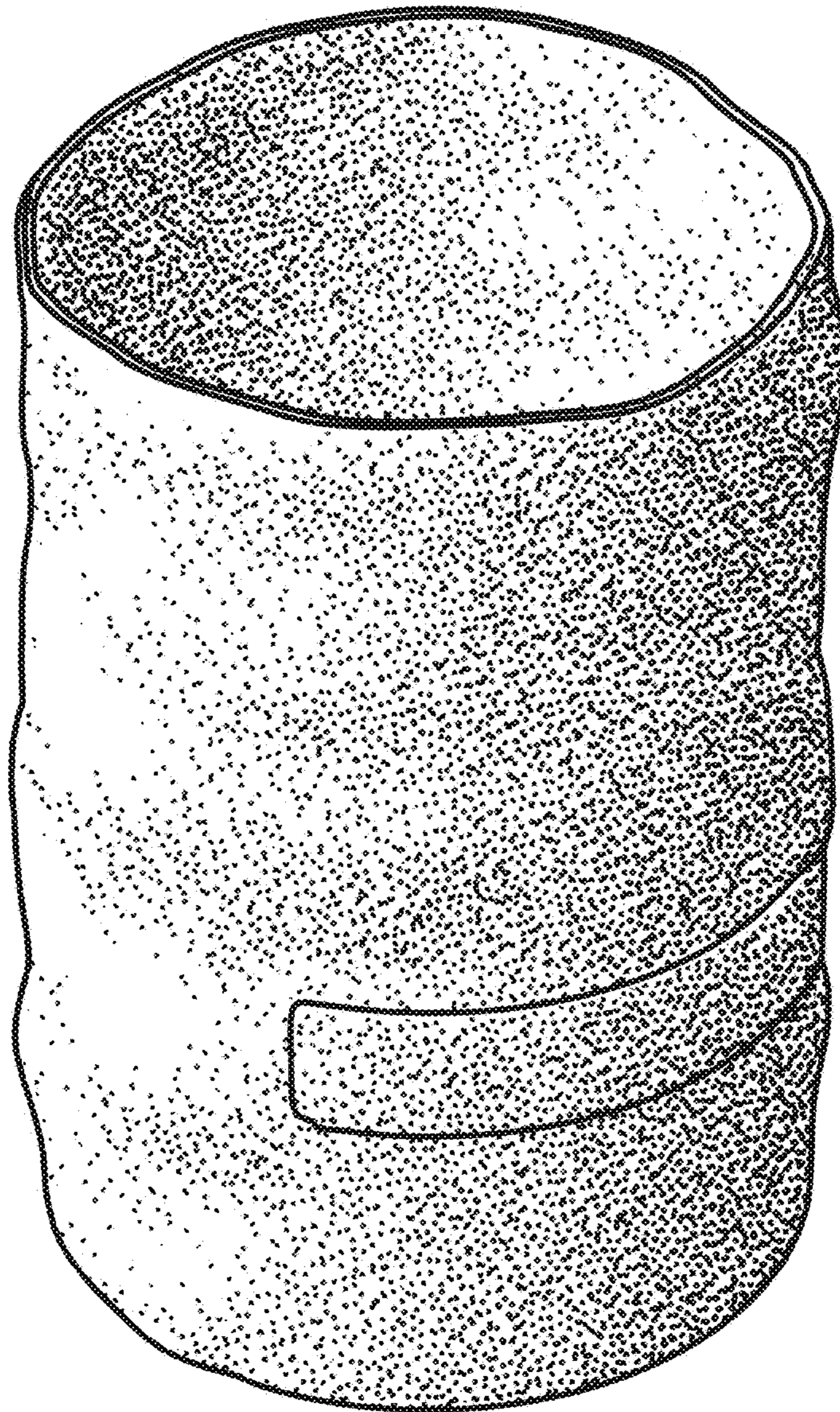

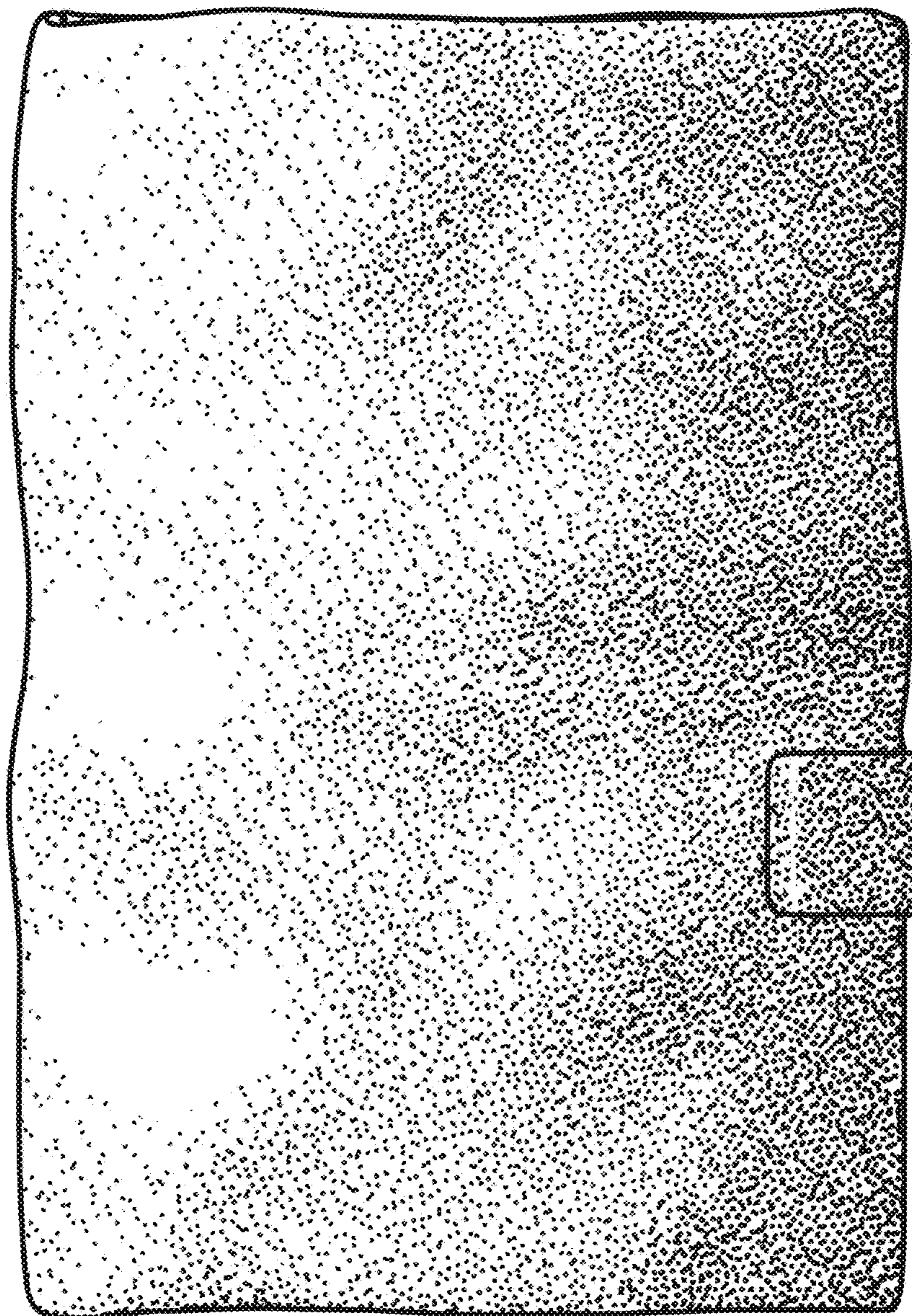

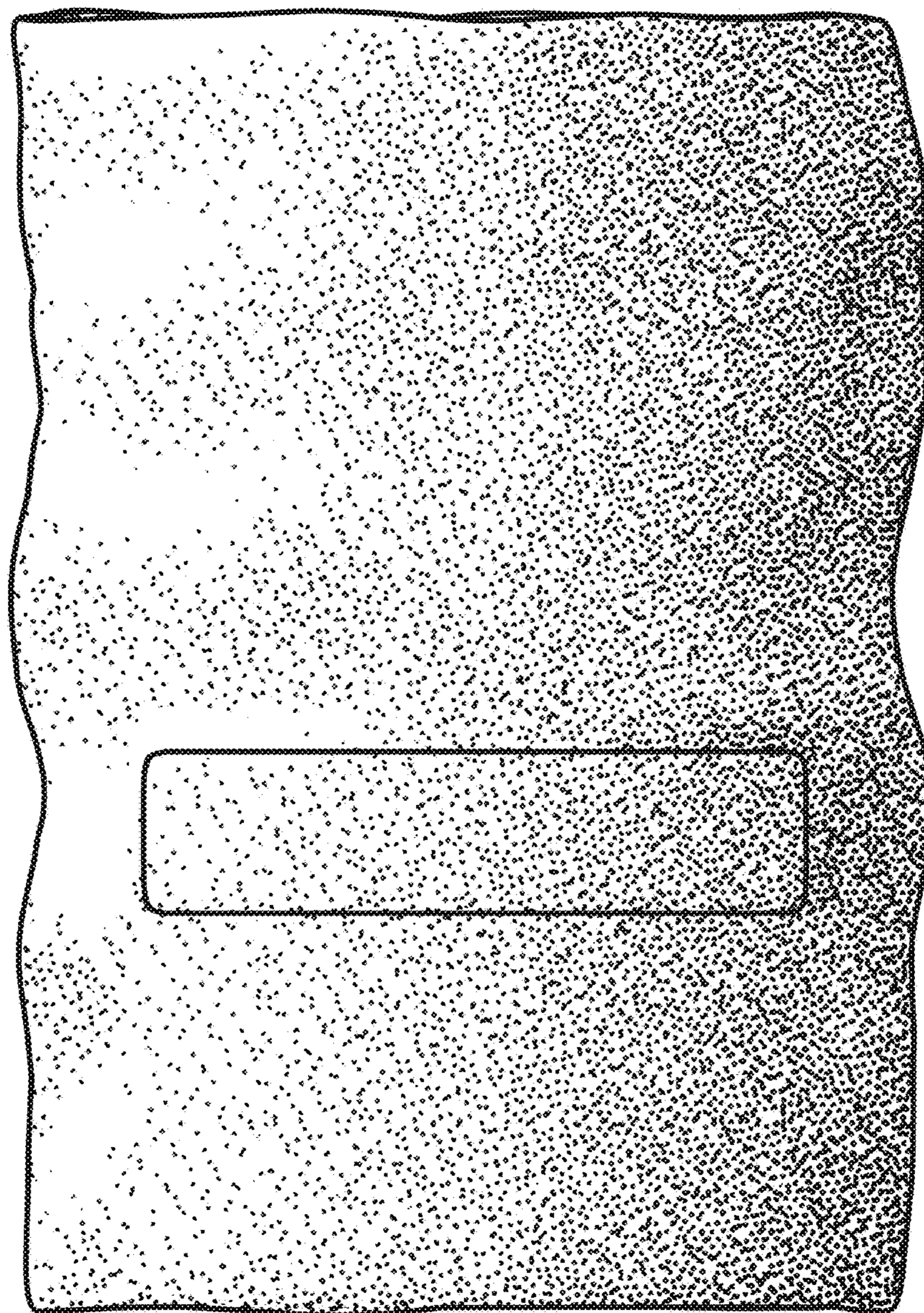

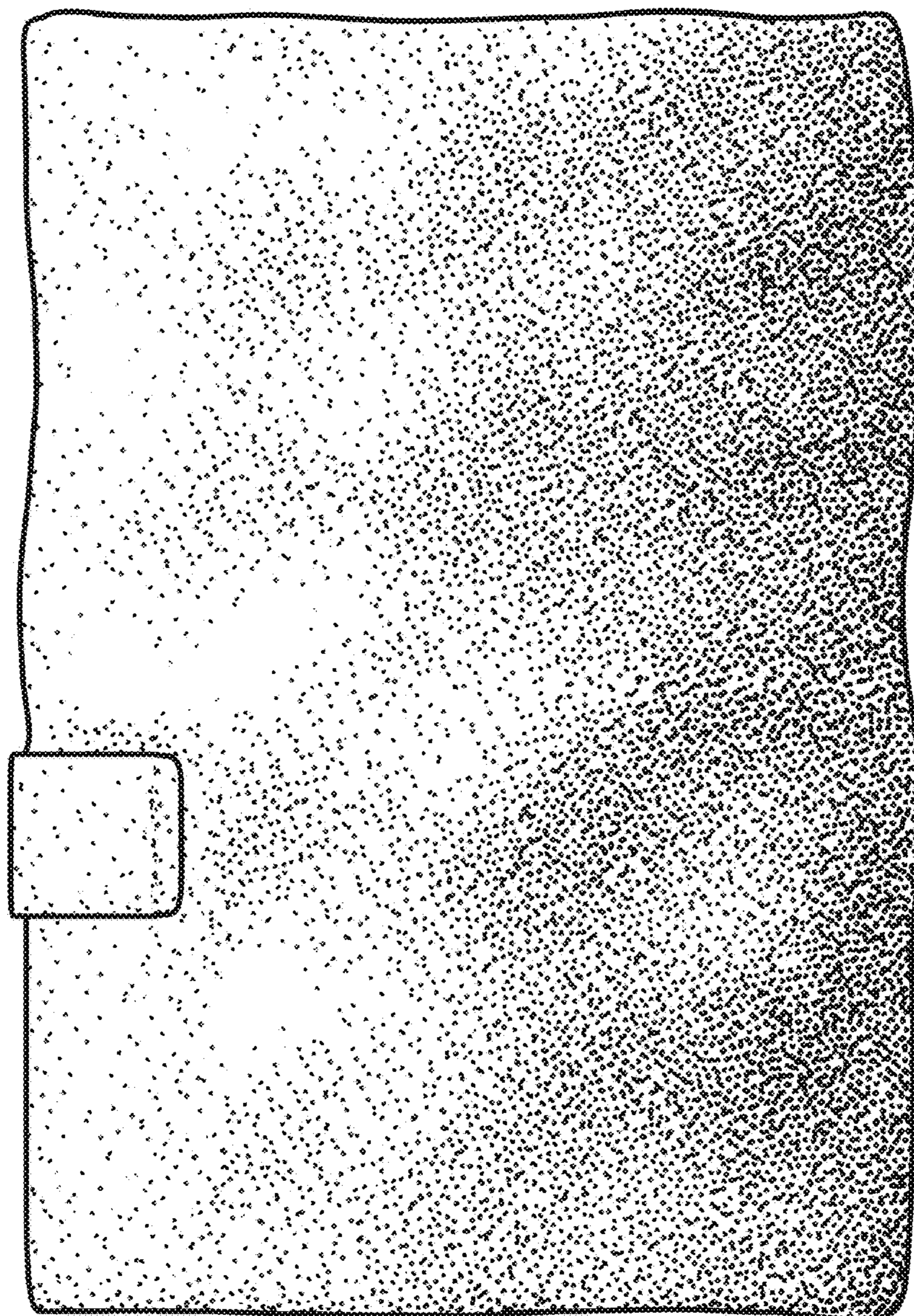

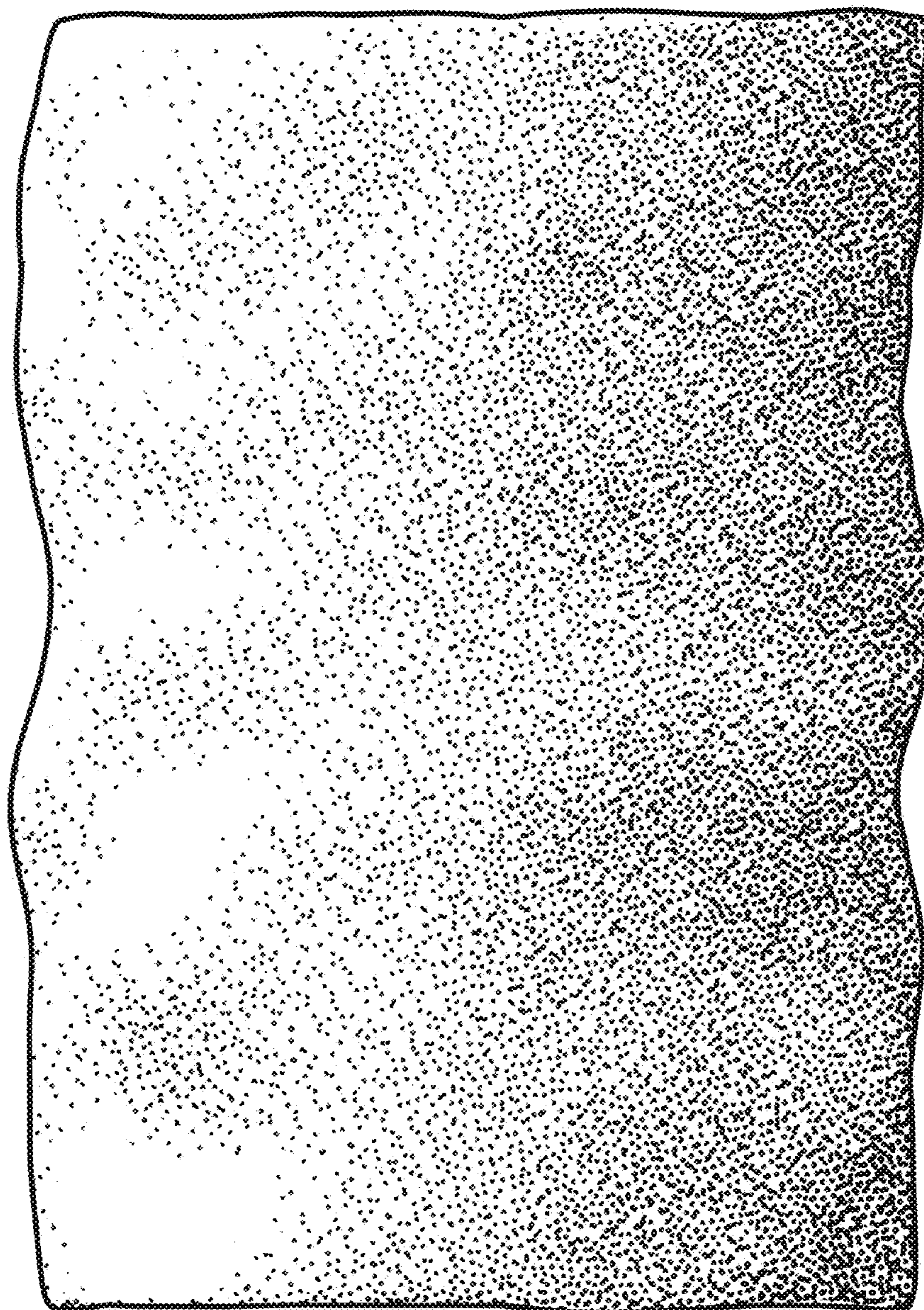
