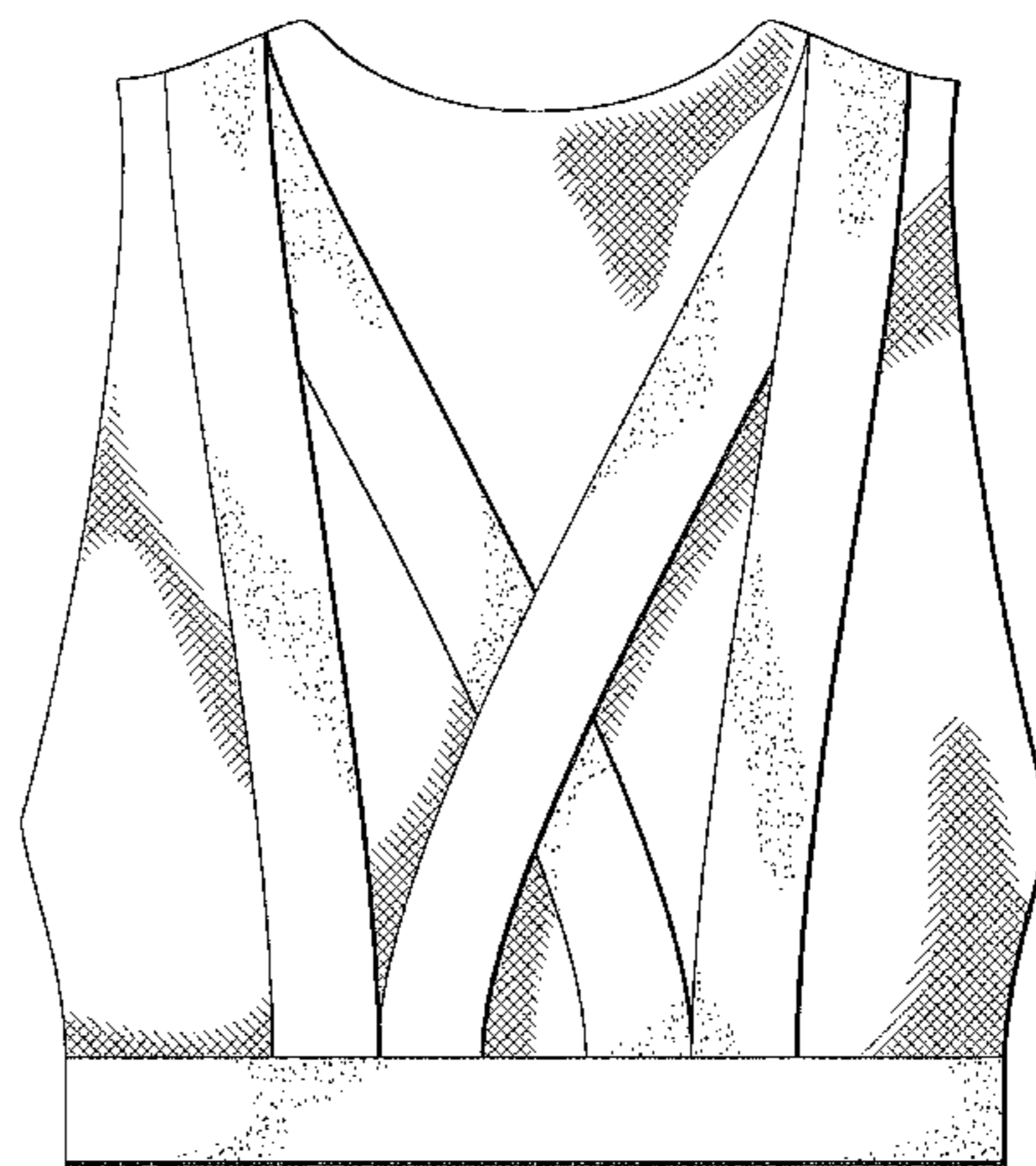
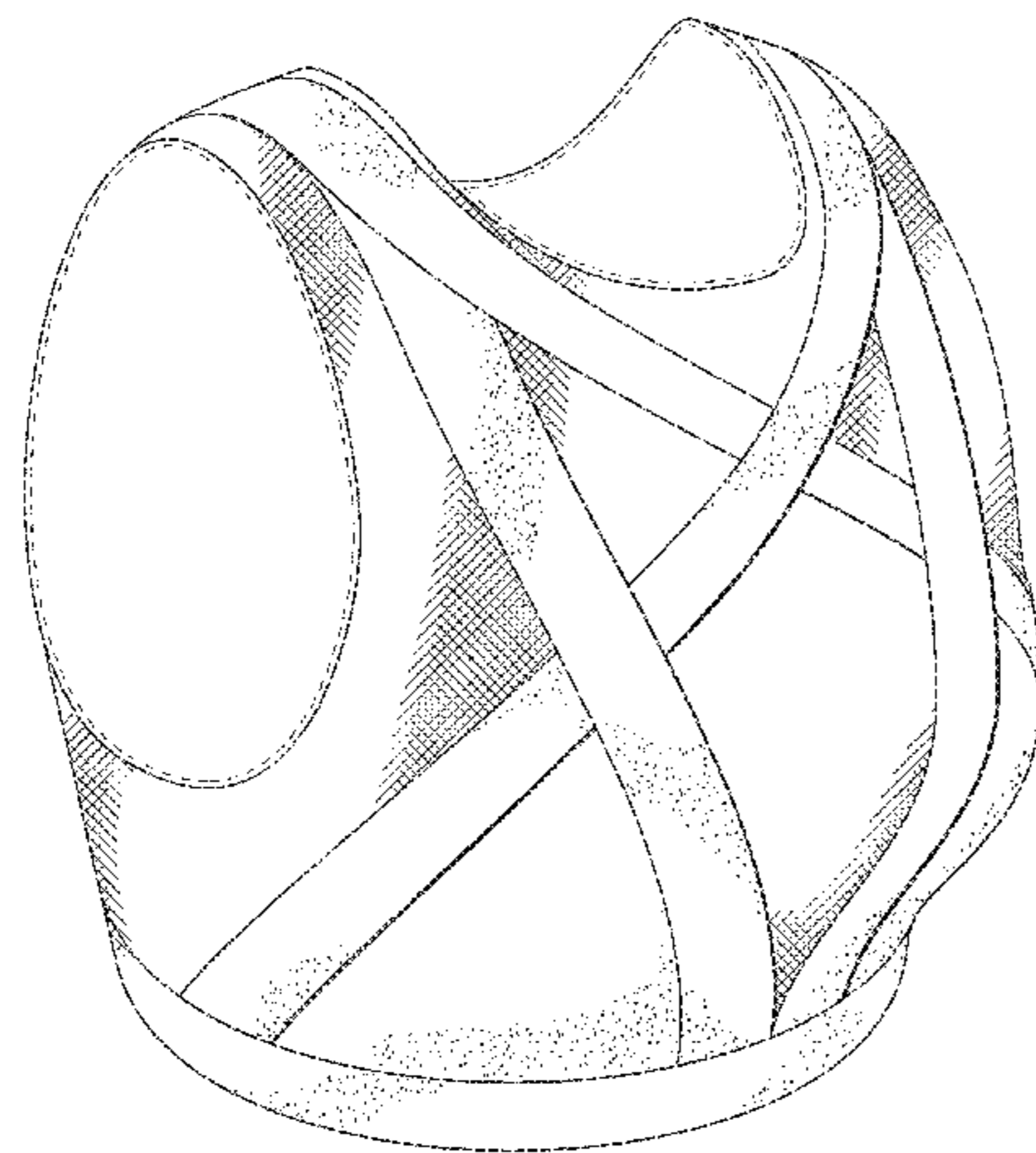
(57) **CLAIM**

The ornamental design for a sports bandage bra, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of the sports bandage bra;
 FIG. 2 is a front elevation view thereof;
 FIG. 3 is a rear elevation view thereof;
 FIG. 4 is a right side elevation view thereof, the left side view being a mirror image;
 FIG. 5 is a top plan view thereof; and,
 FIG. 6 is a bottom plan view thereof.
 The broken lines shown in the drawings represent stitching in the fabric.

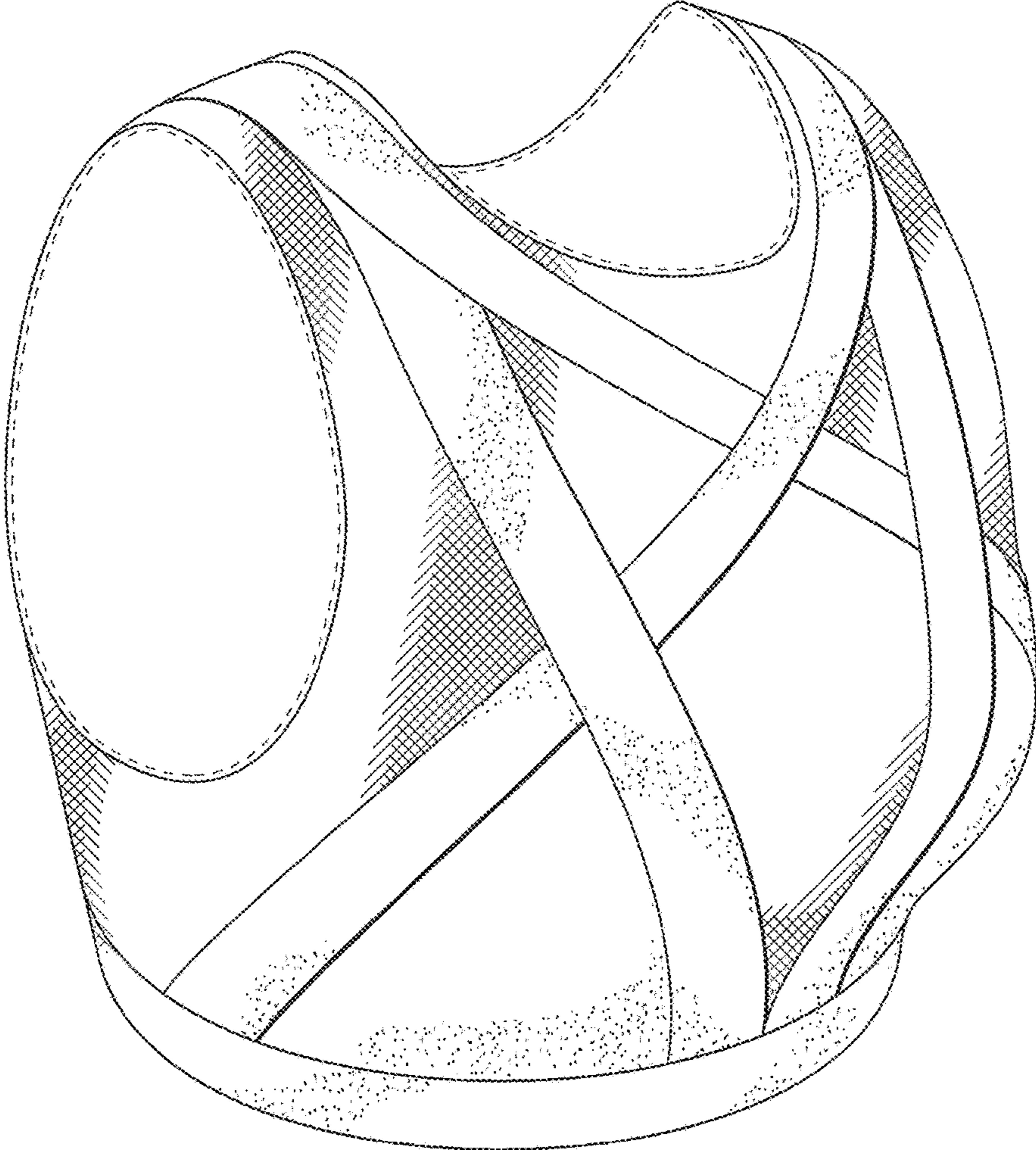

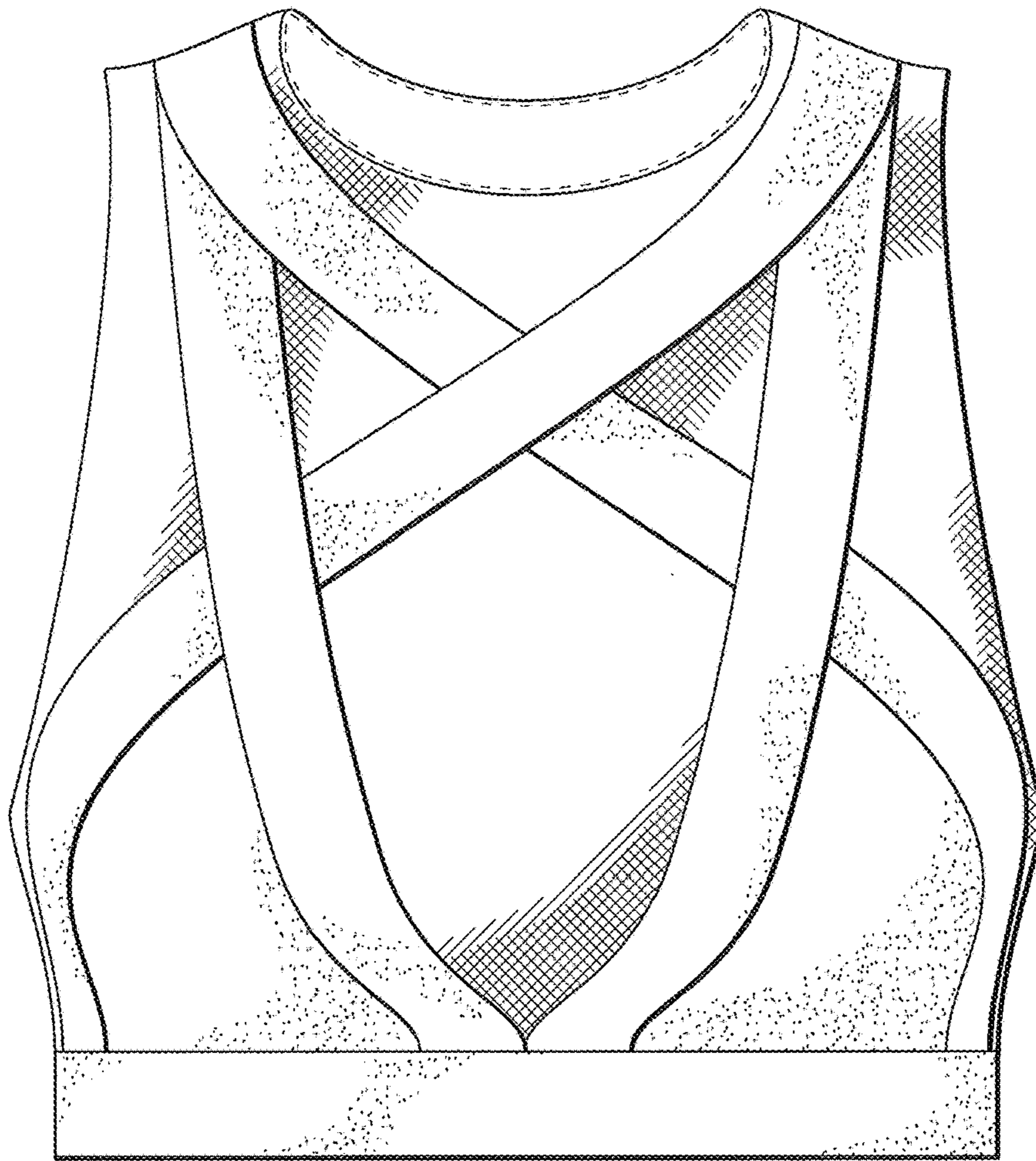

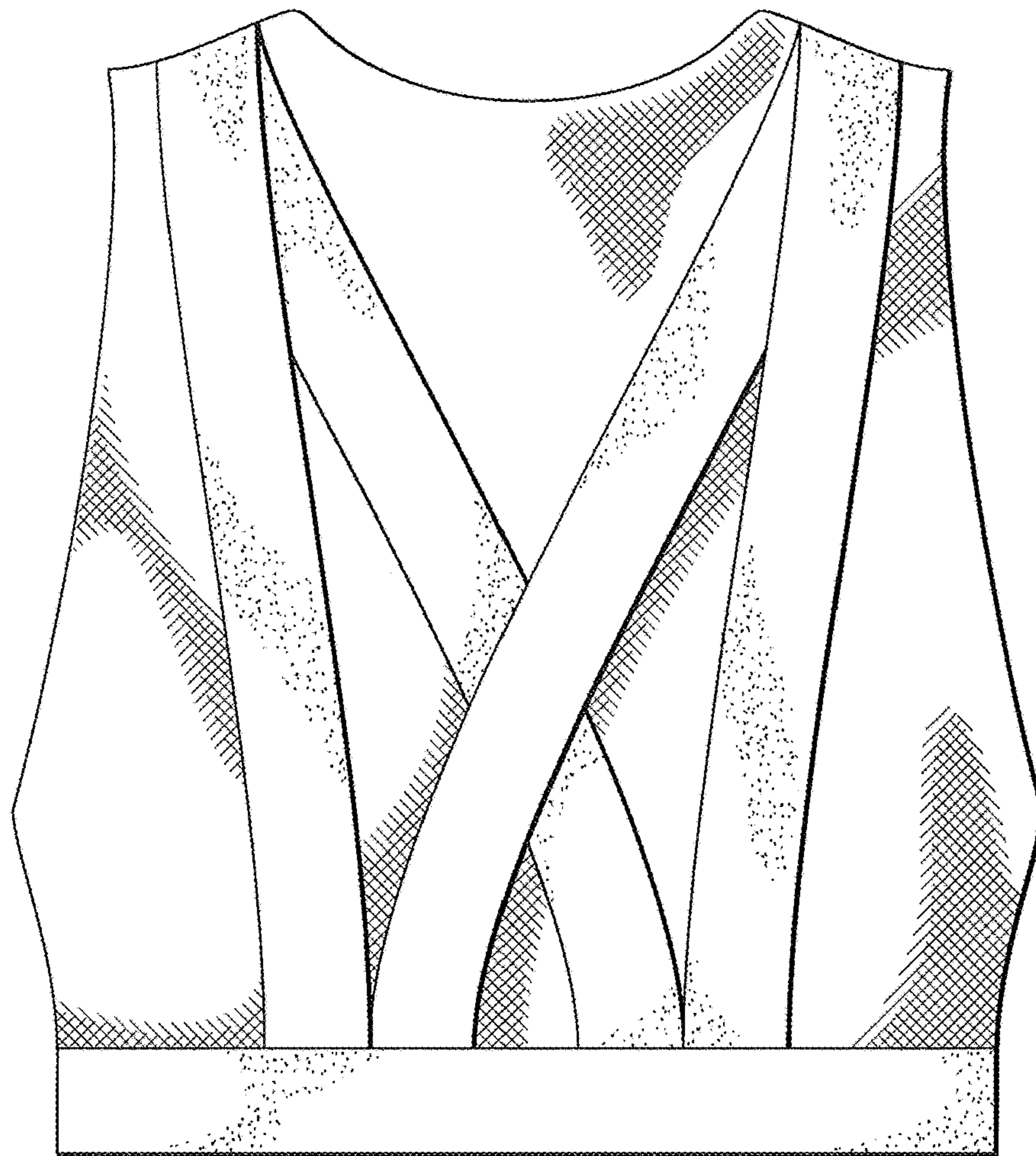

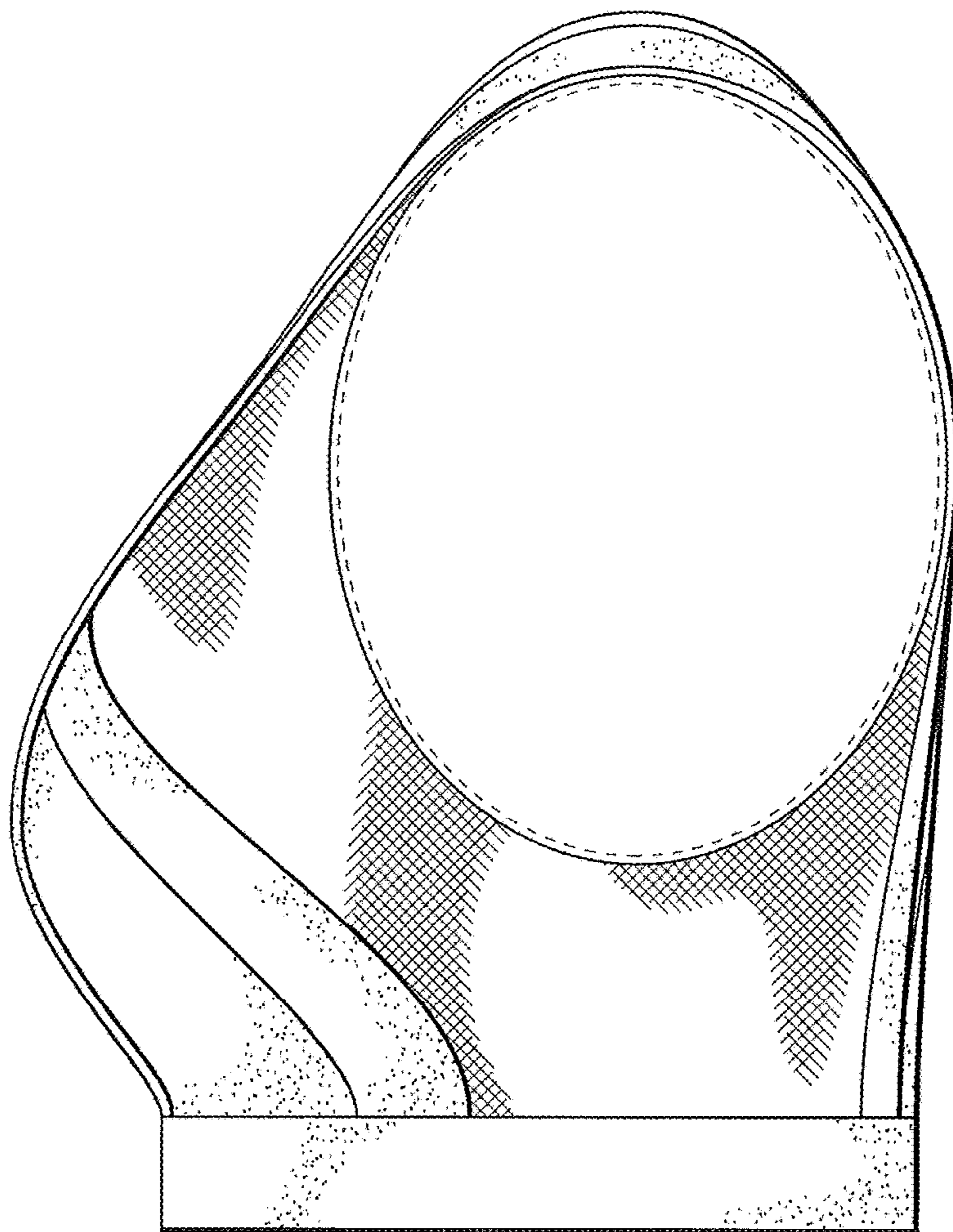

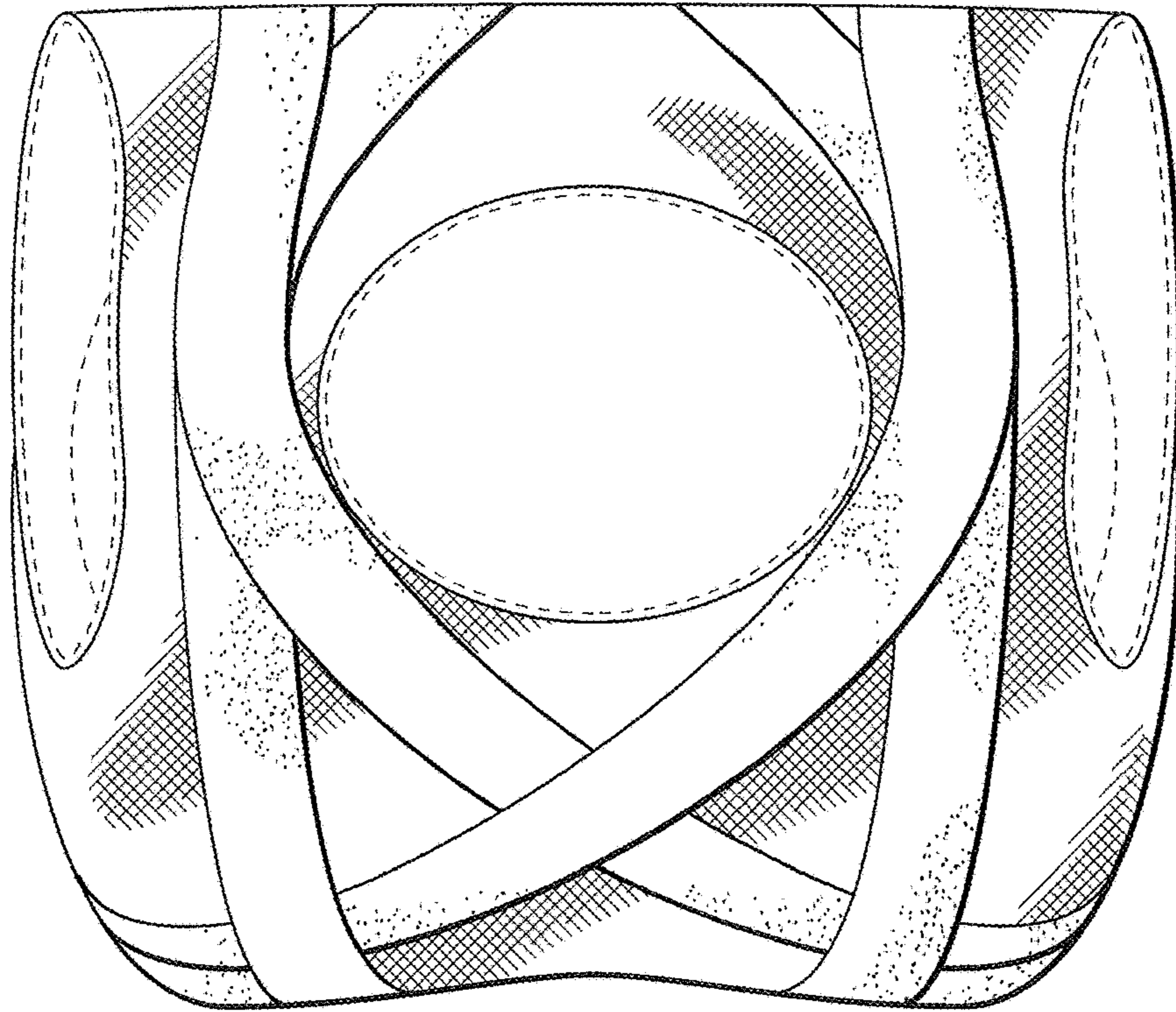

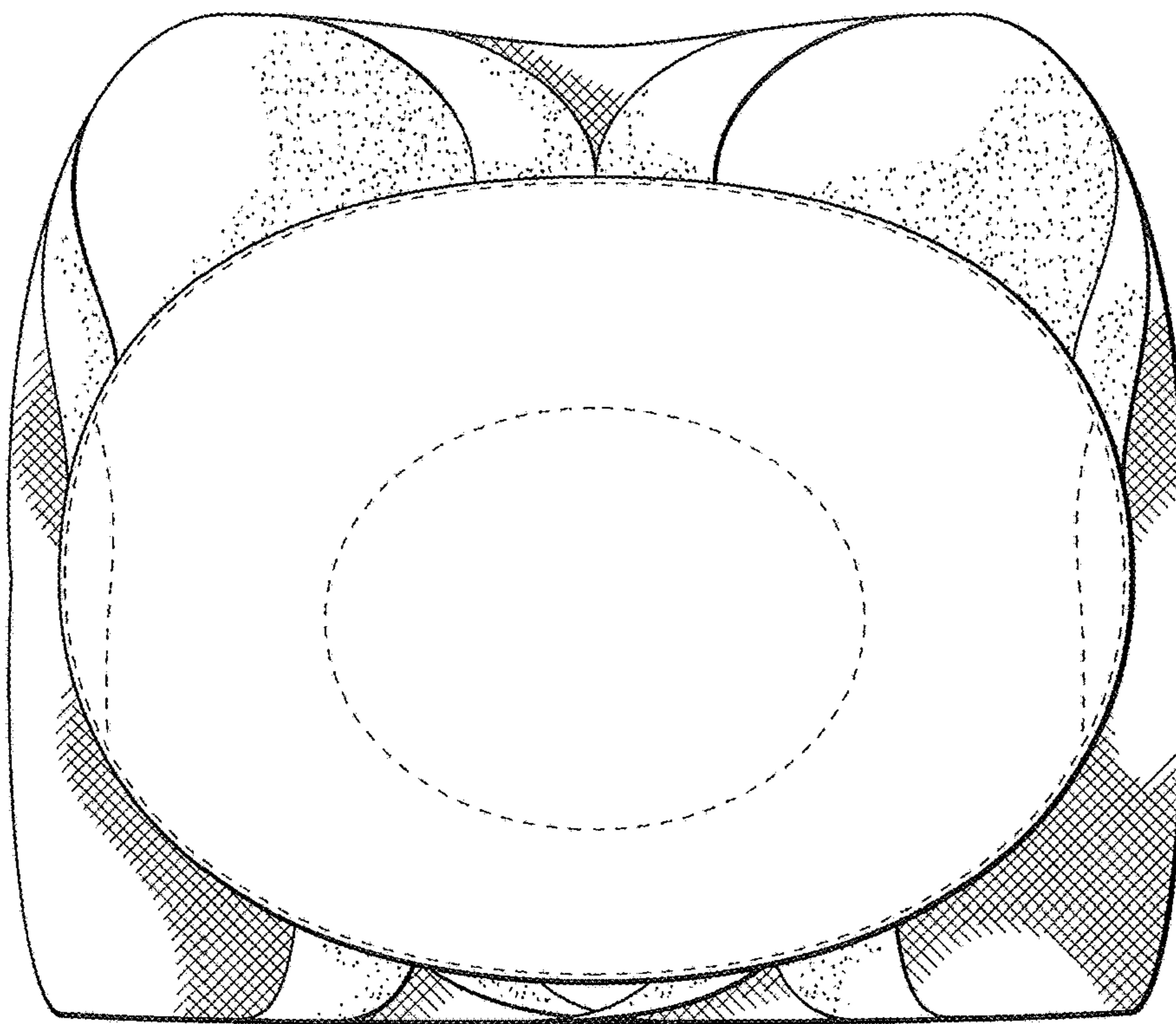
