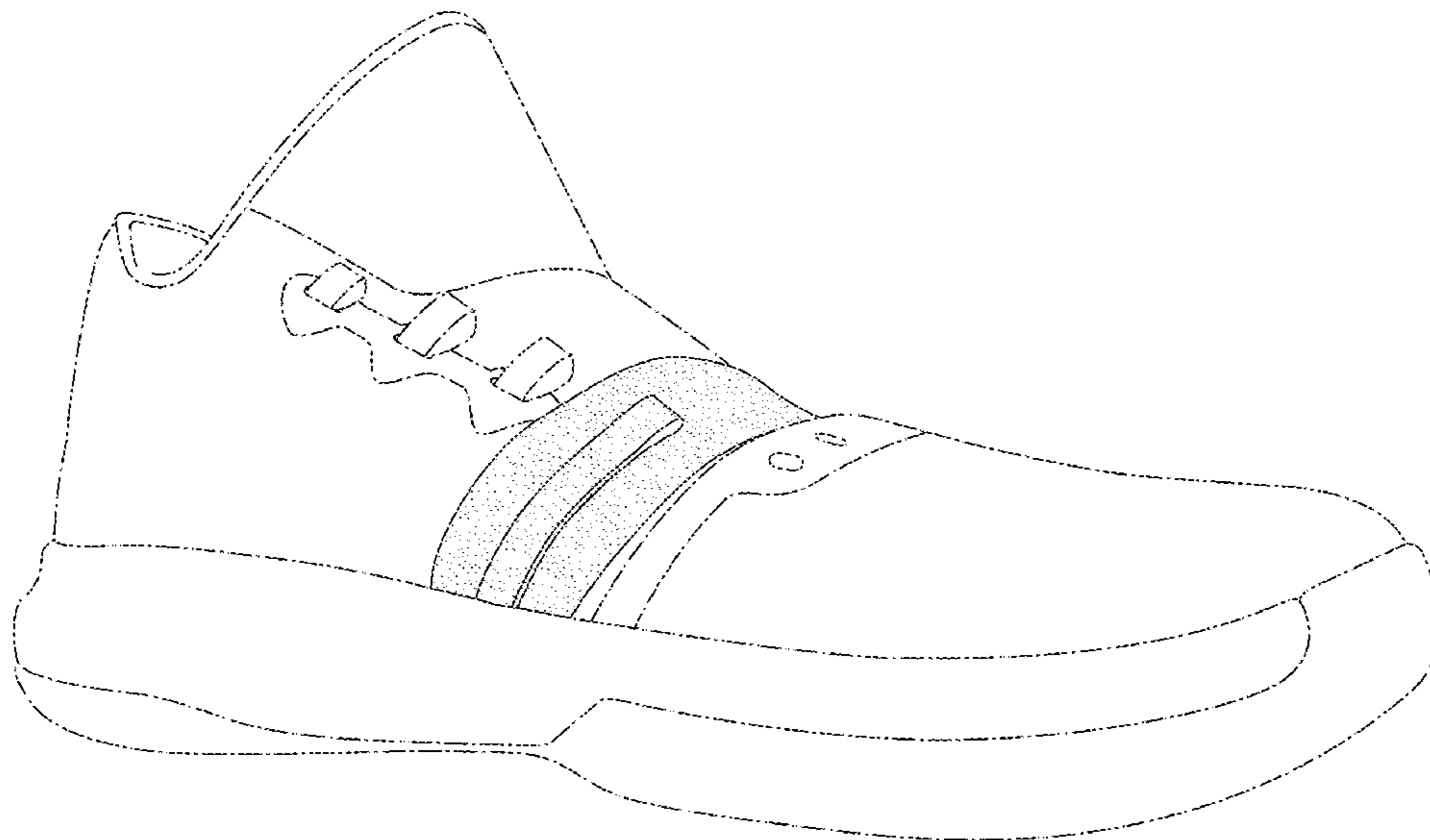
(57) **CLAIM**

The ornamental design for a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe upper showing my new design;  
FIG. 2 is a side view thereof;  
FIG. 3 is an opposite side view thereof; and,  
FIG. 4 is a top view thereof.  
The unshaded region that is demarcated by solid lines forms no part of the claimed design. The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design.

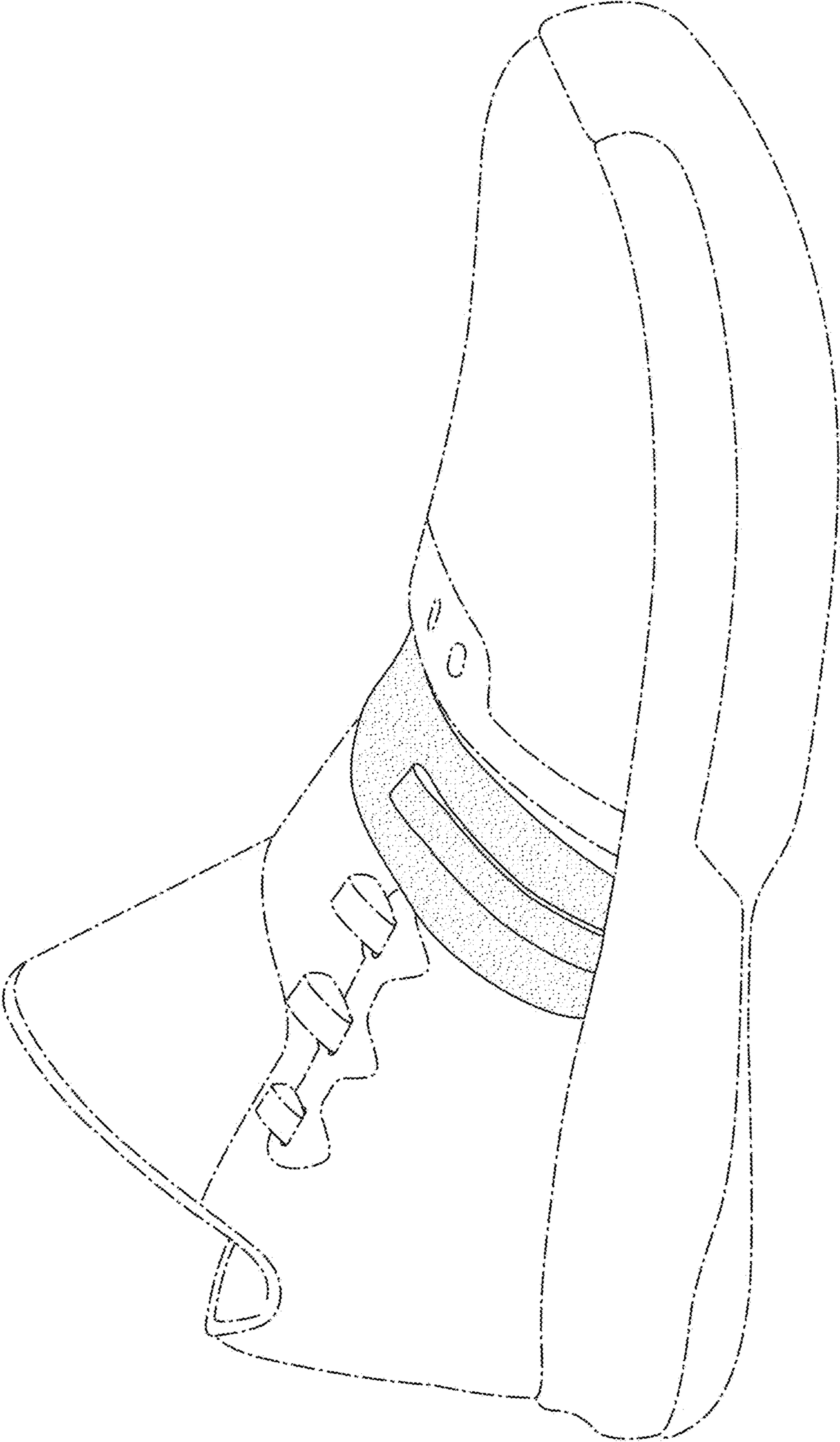

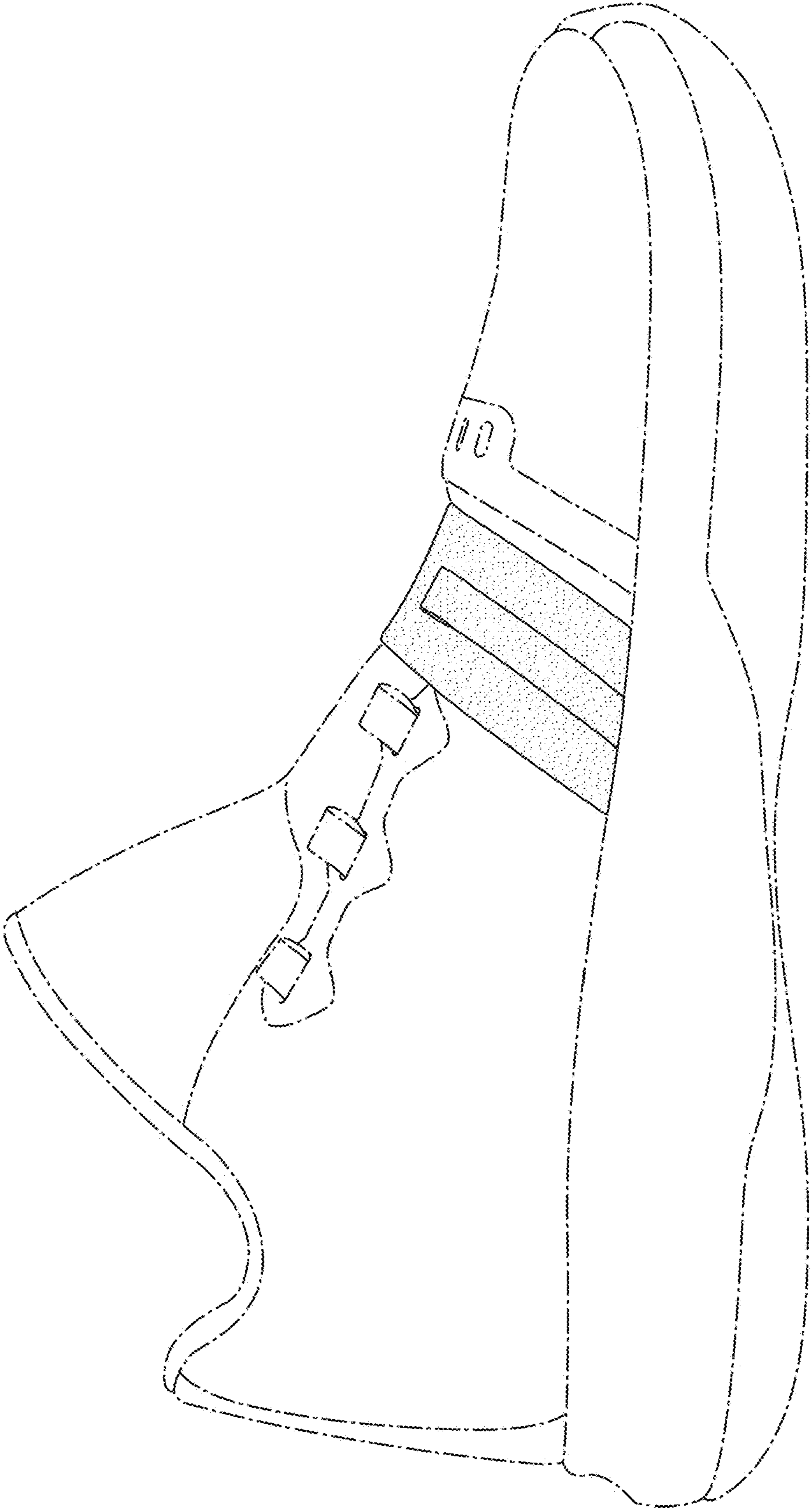

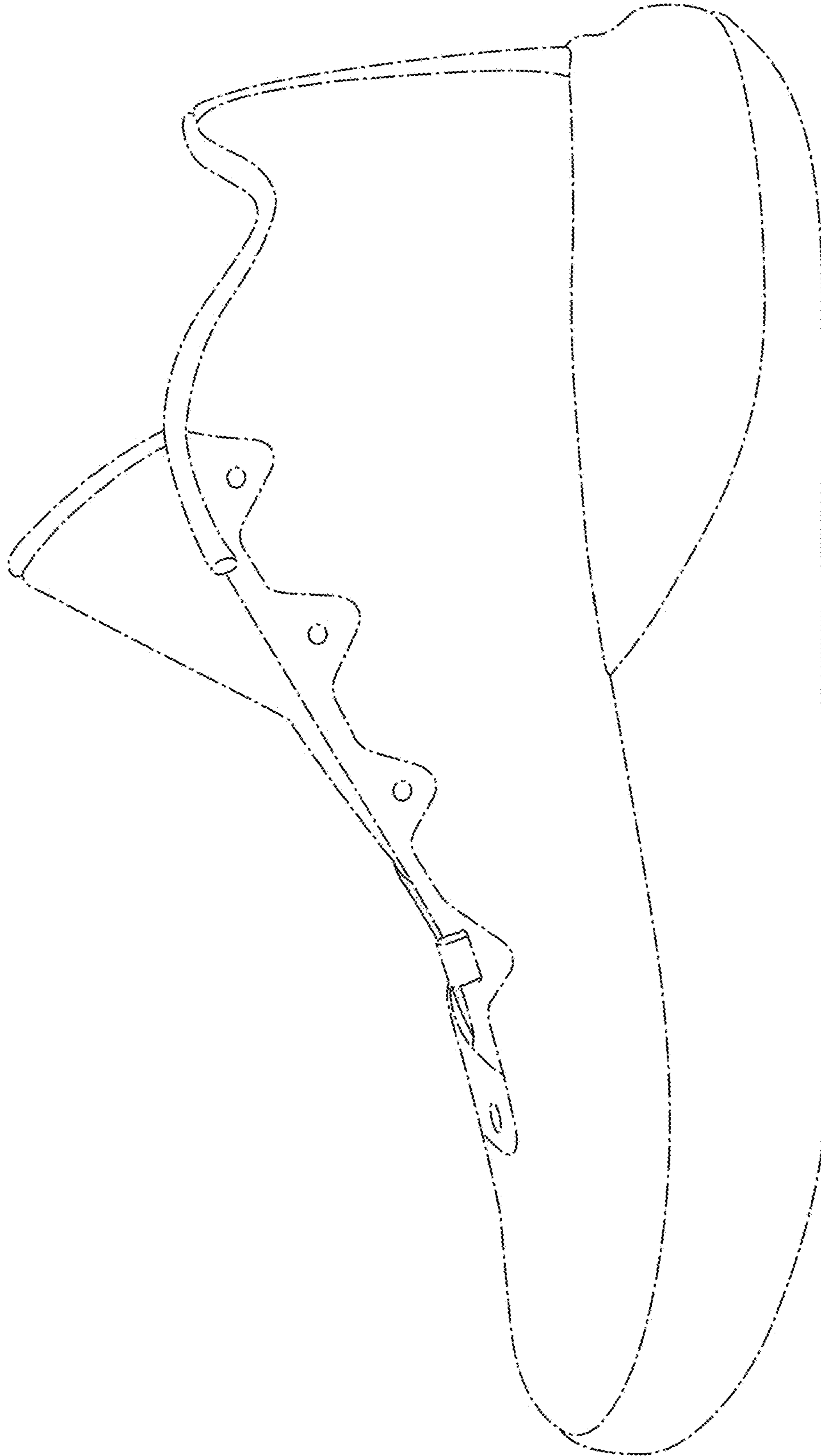

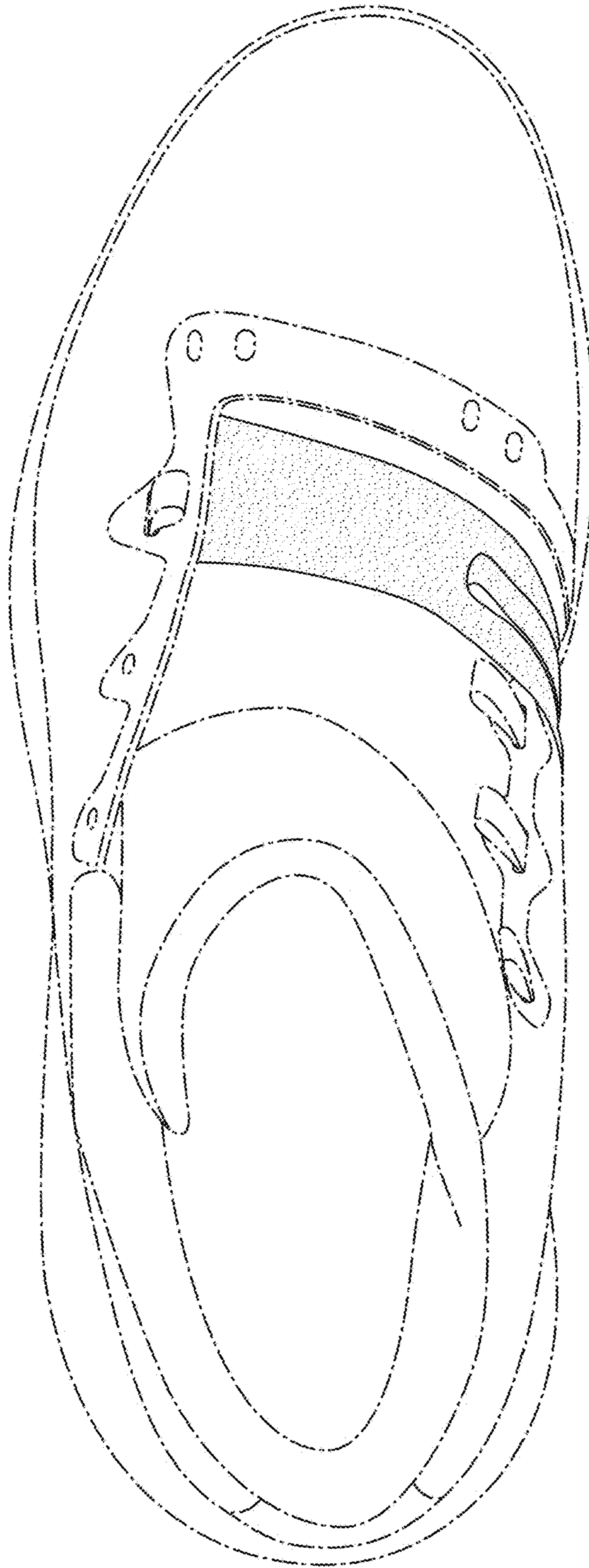
