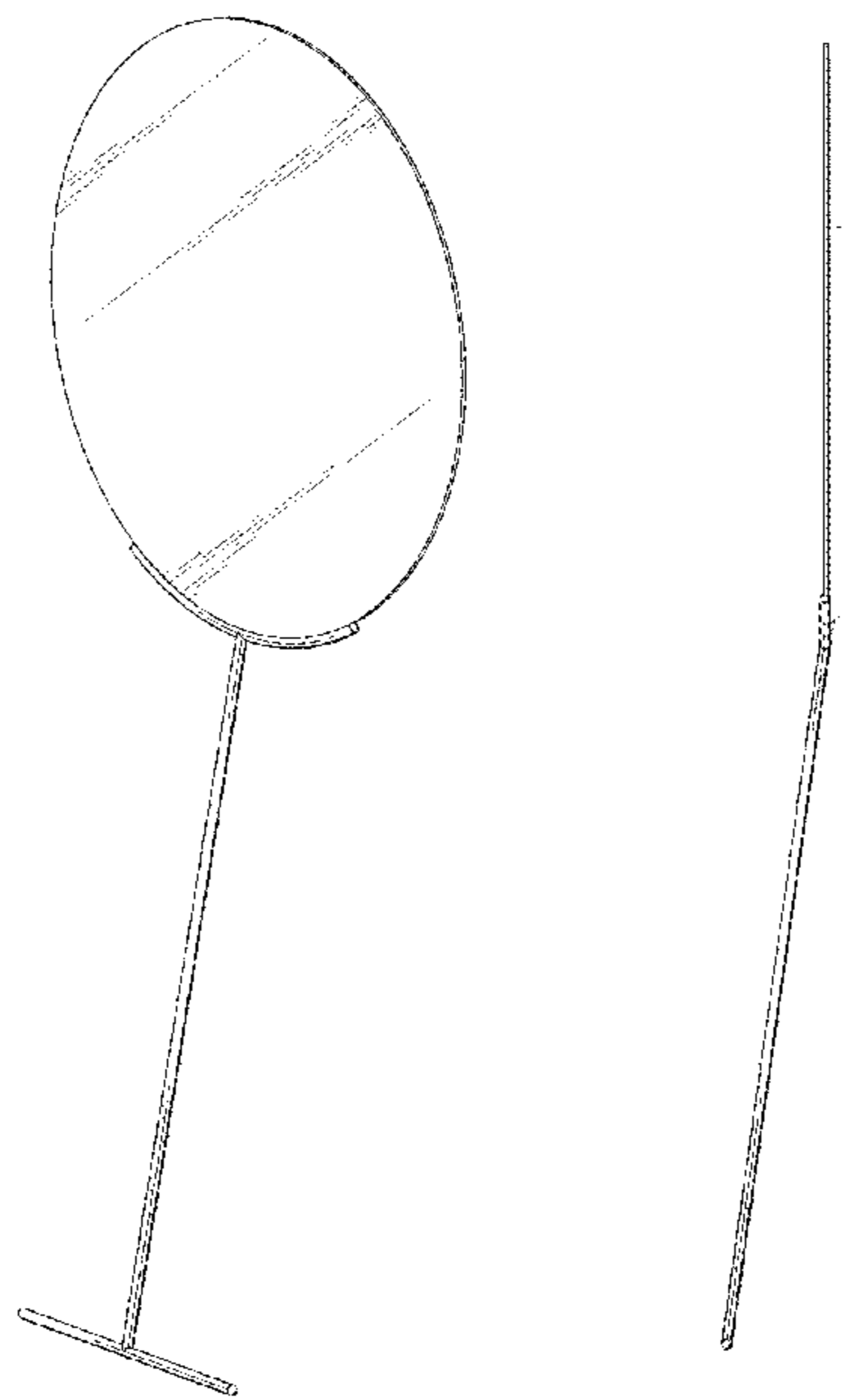
(57) **CLAIM**

I claim the ornamental design for a leaning mirror, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a leaning mirror of Applicant's design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a rear elevational view thereof;  
 FIG. 4 is a first side elevational view thereof, the second side elevational view opposite the first side elevational view and being a mirror image thereof;  
 FIG. 5 is a top plan view thereof; and,

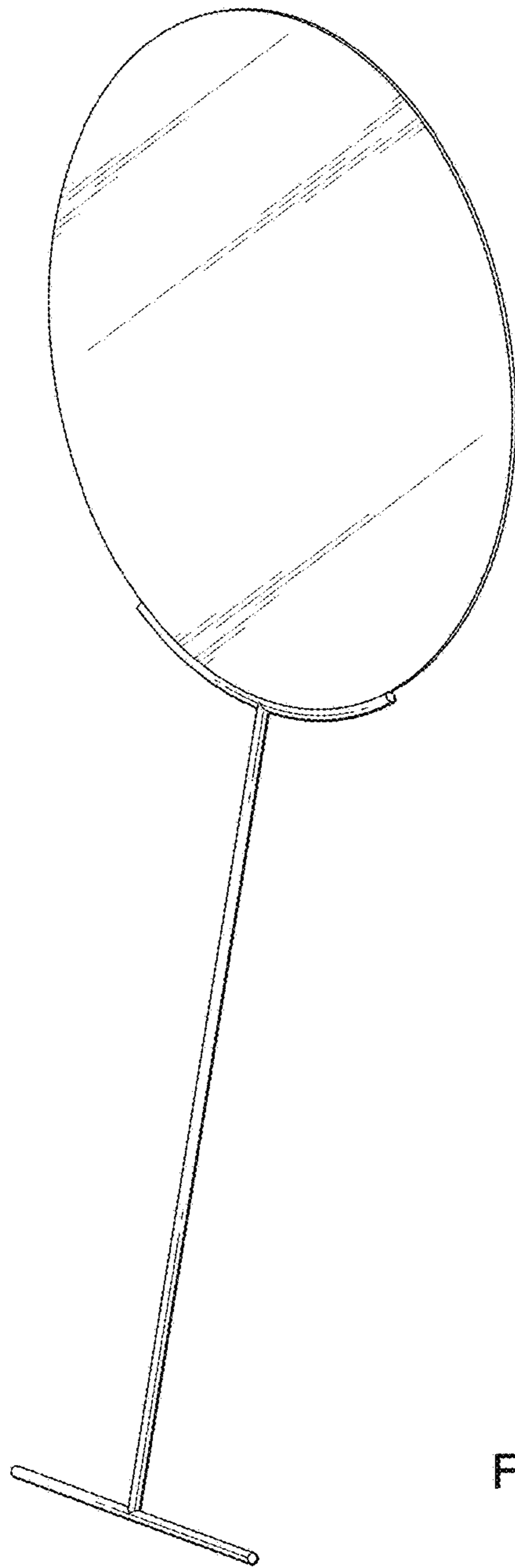

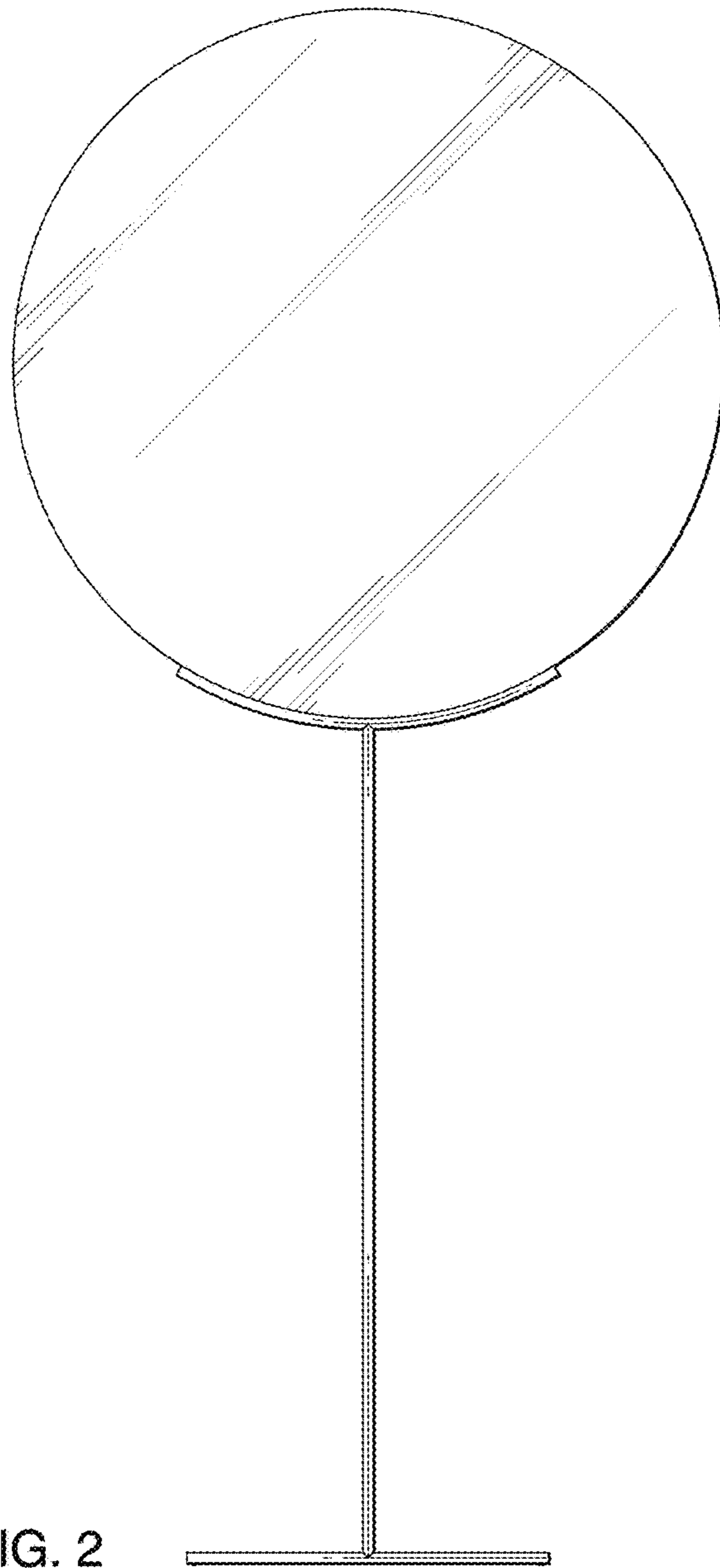

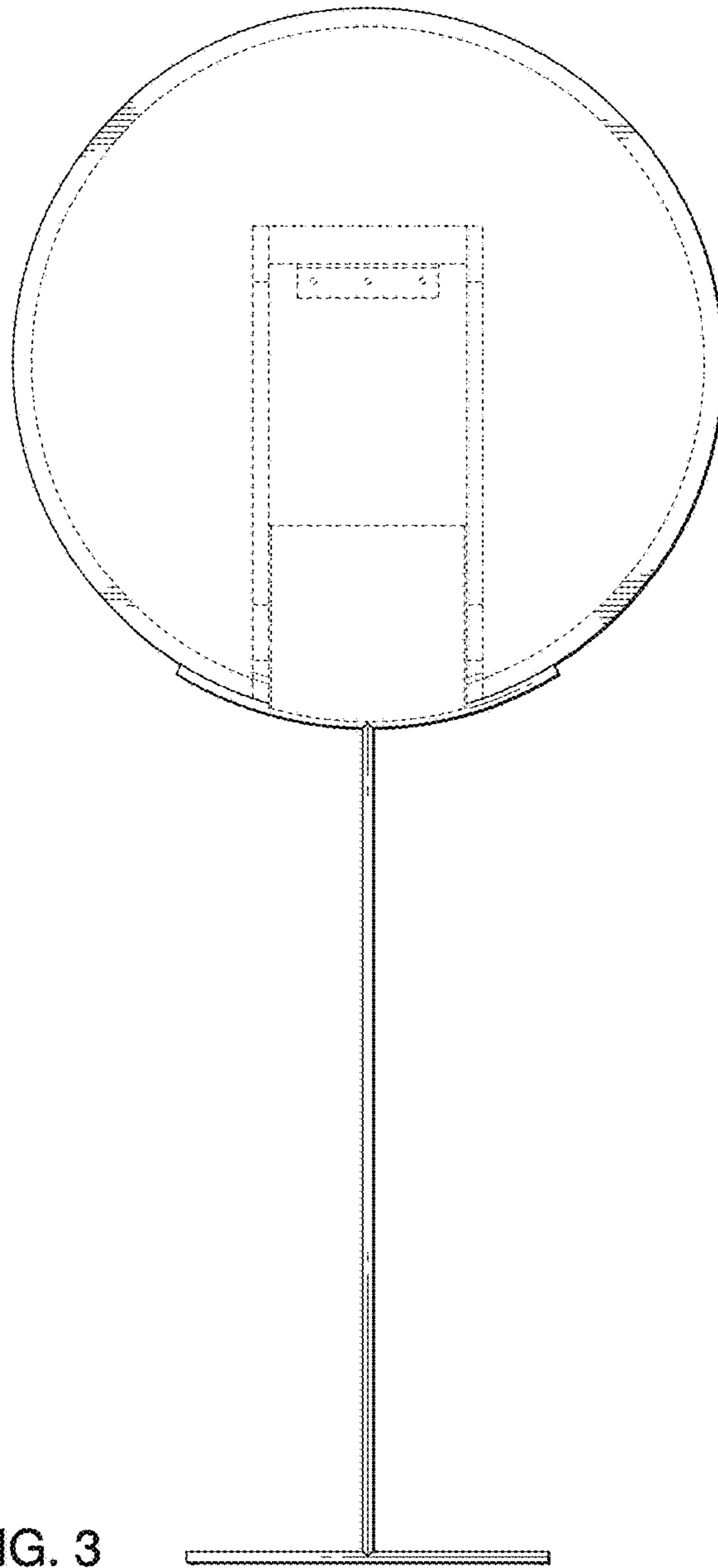

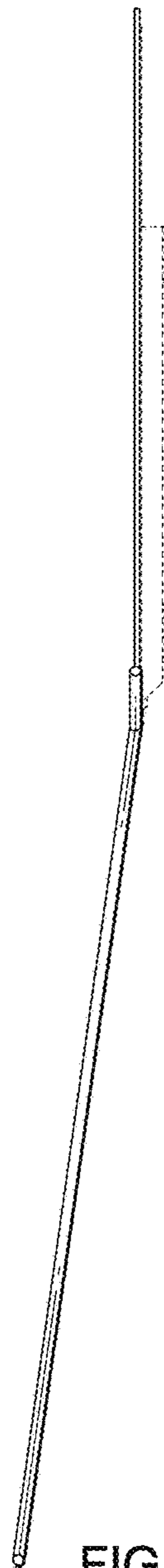

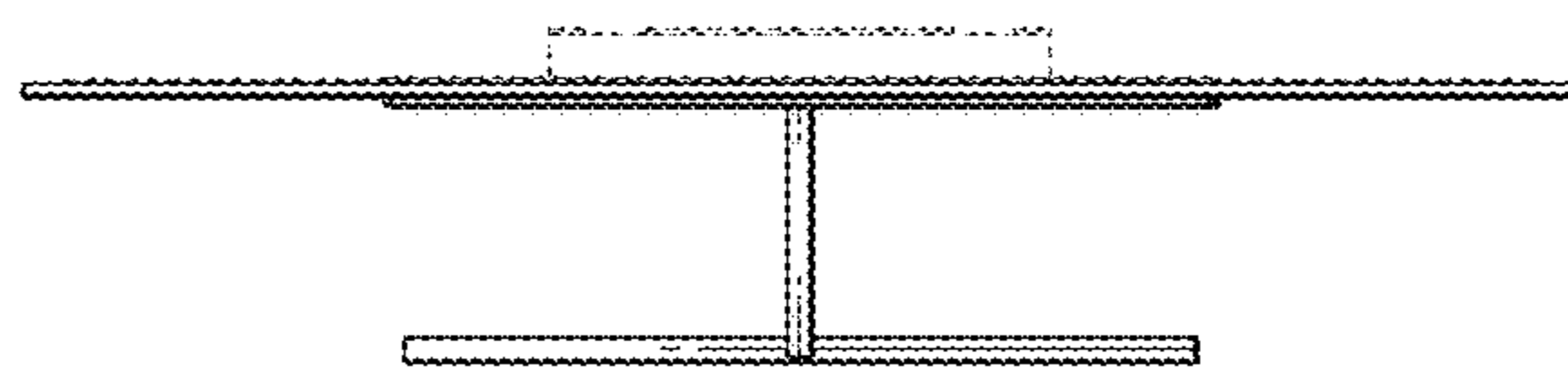

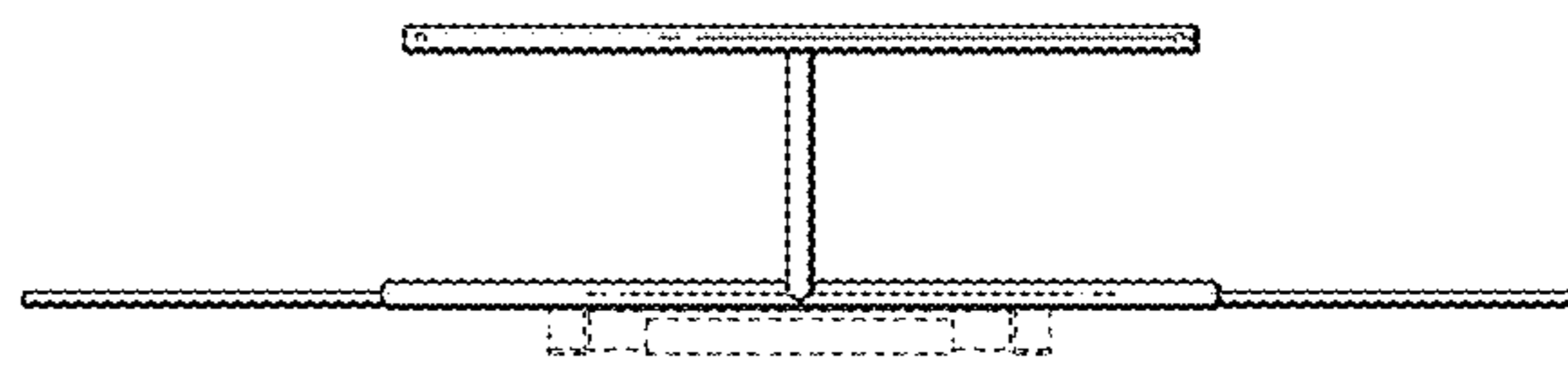
