DESCRIPTION

FIG. 1 is a ¾ front perspective view of a chair showing my new design;
FIG. 2 is ¾ rear perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a left side elevation view thereof; and,
FIG. 6 is a right side elevation view thereof.

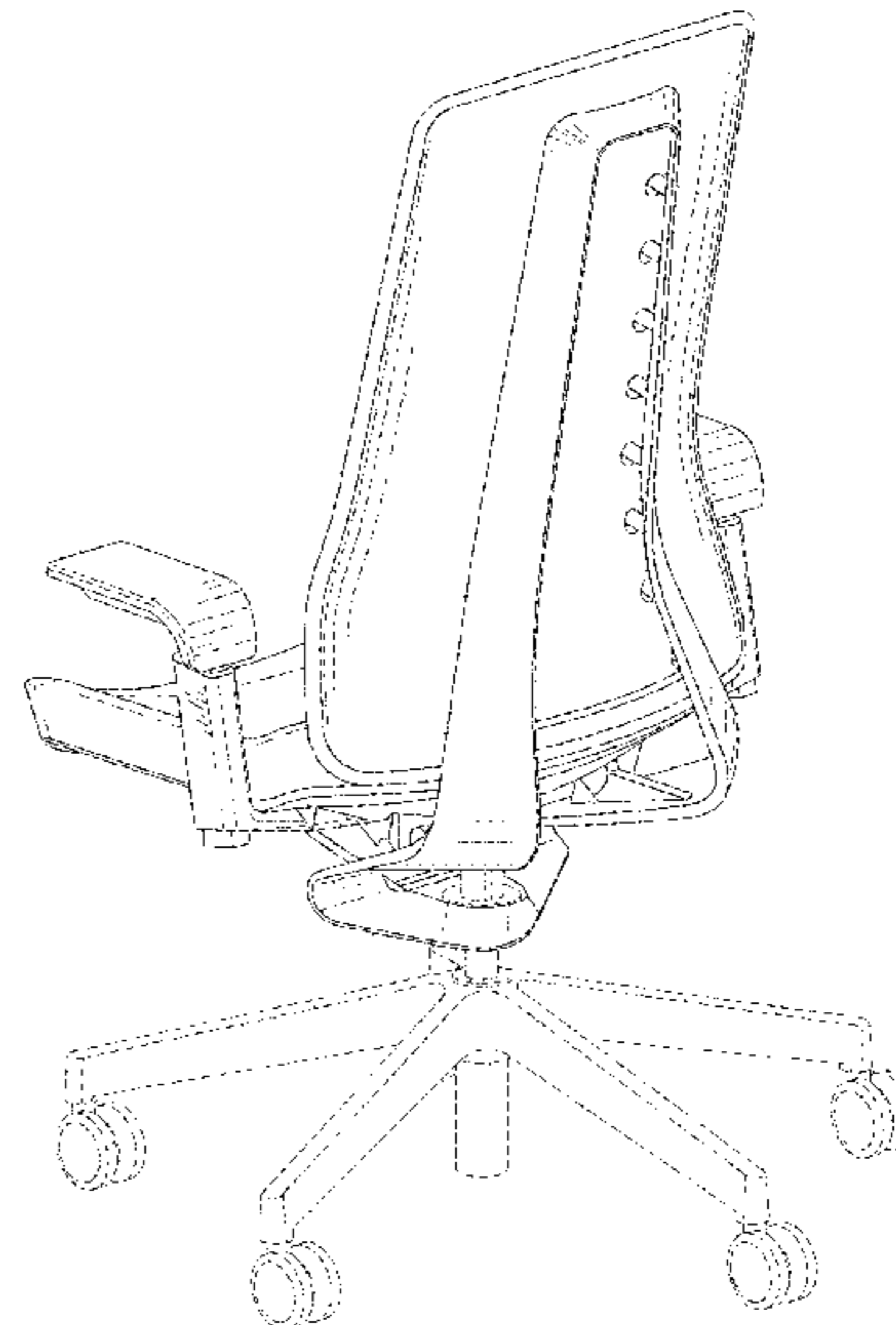
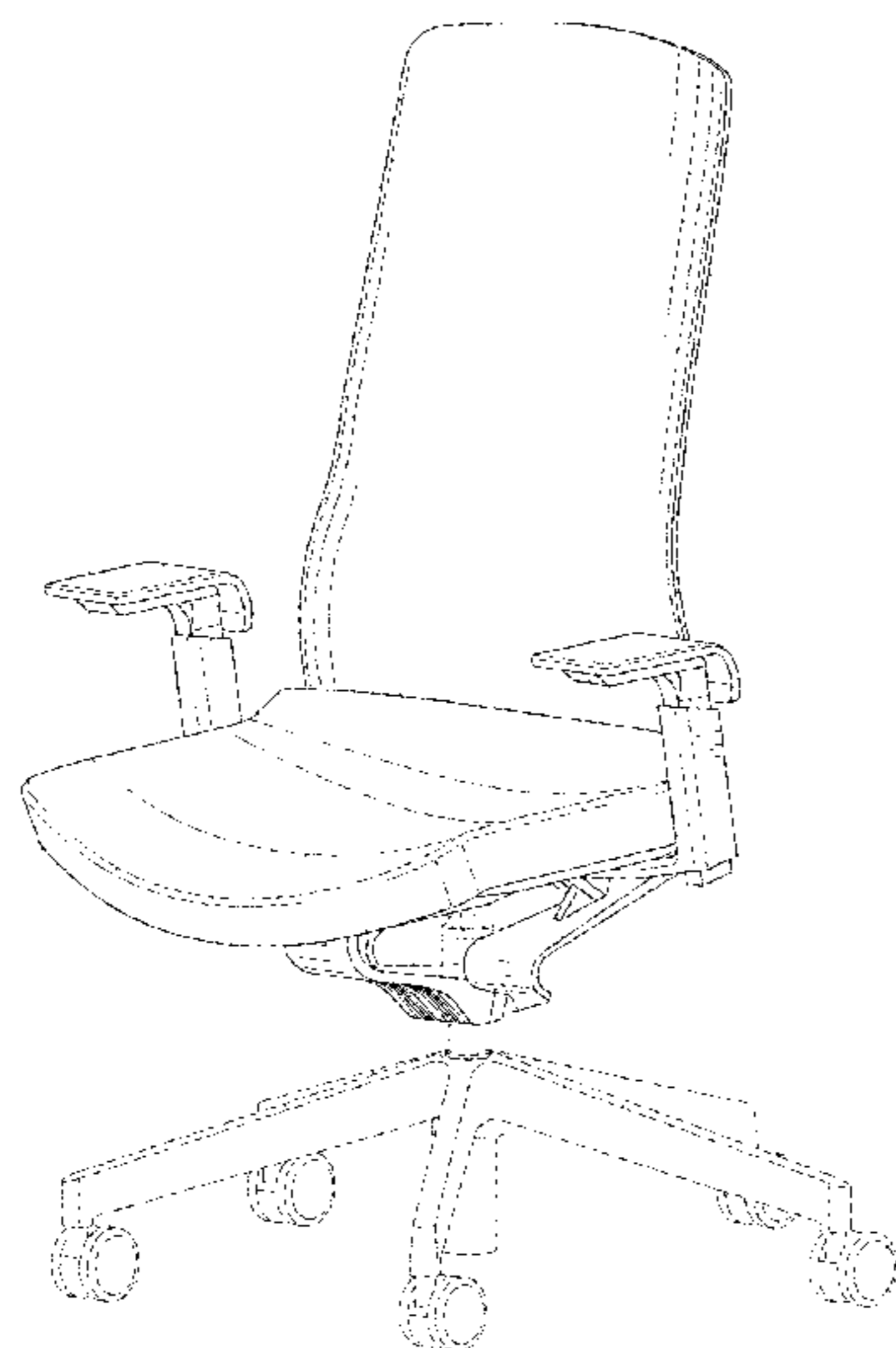

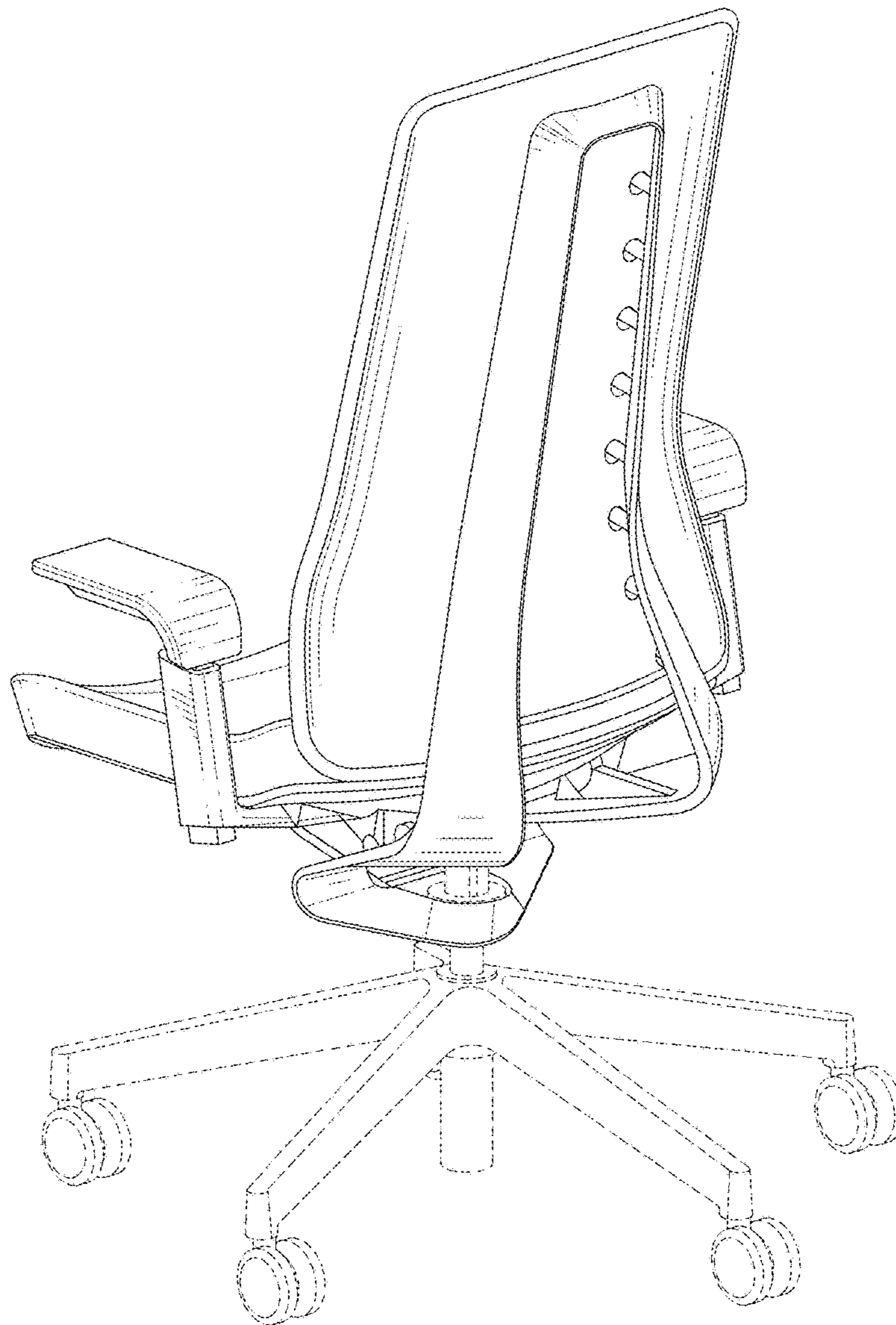

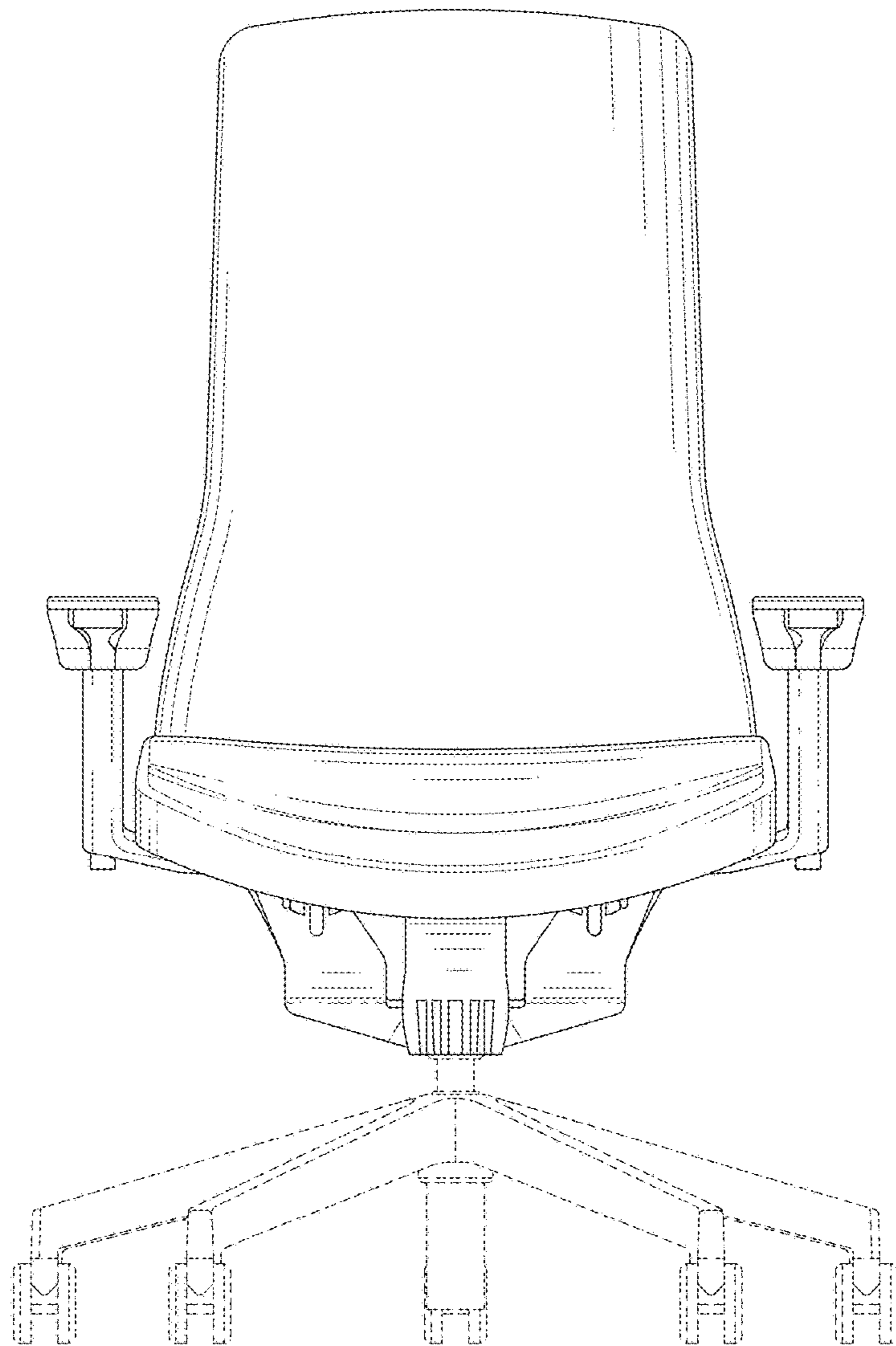

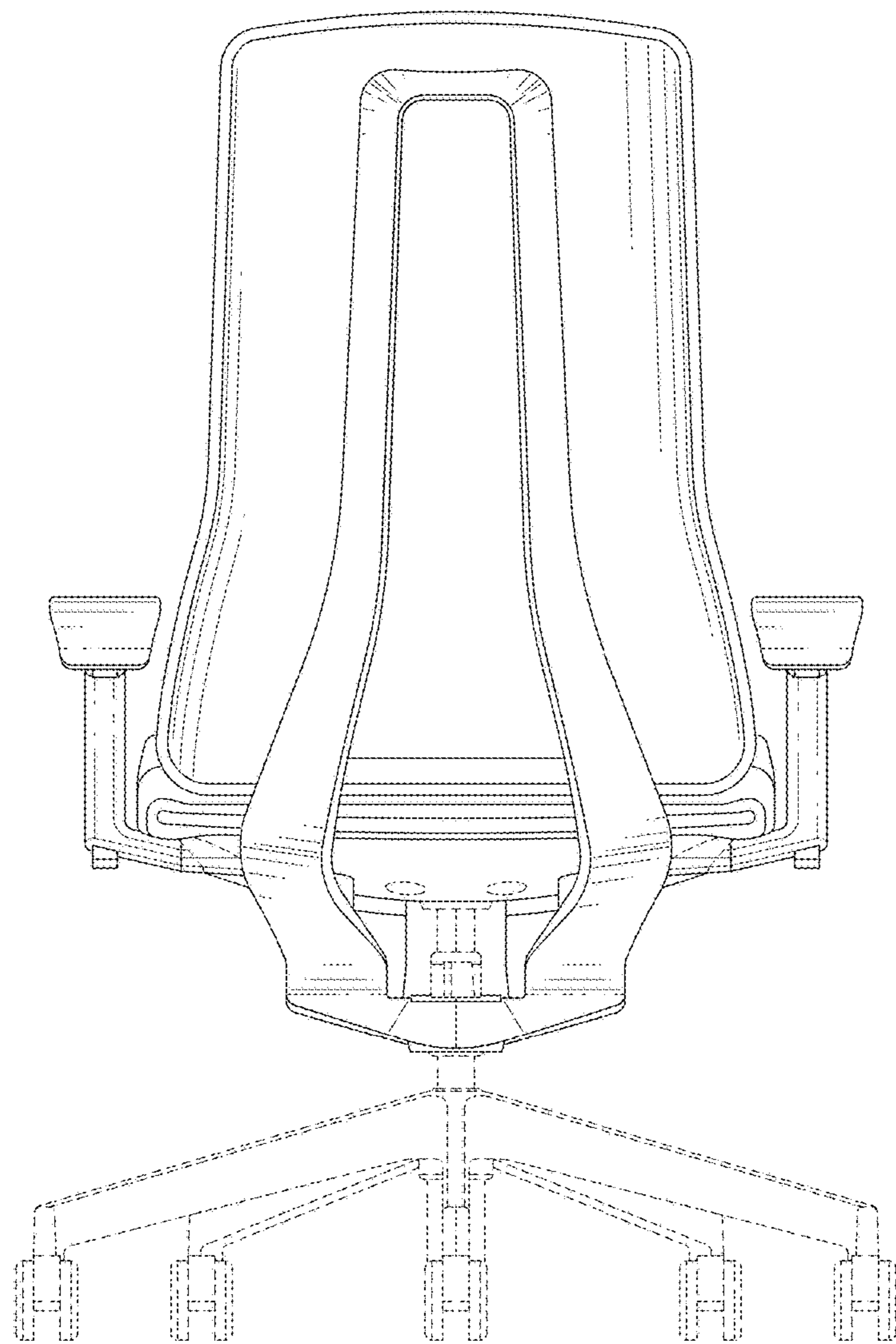

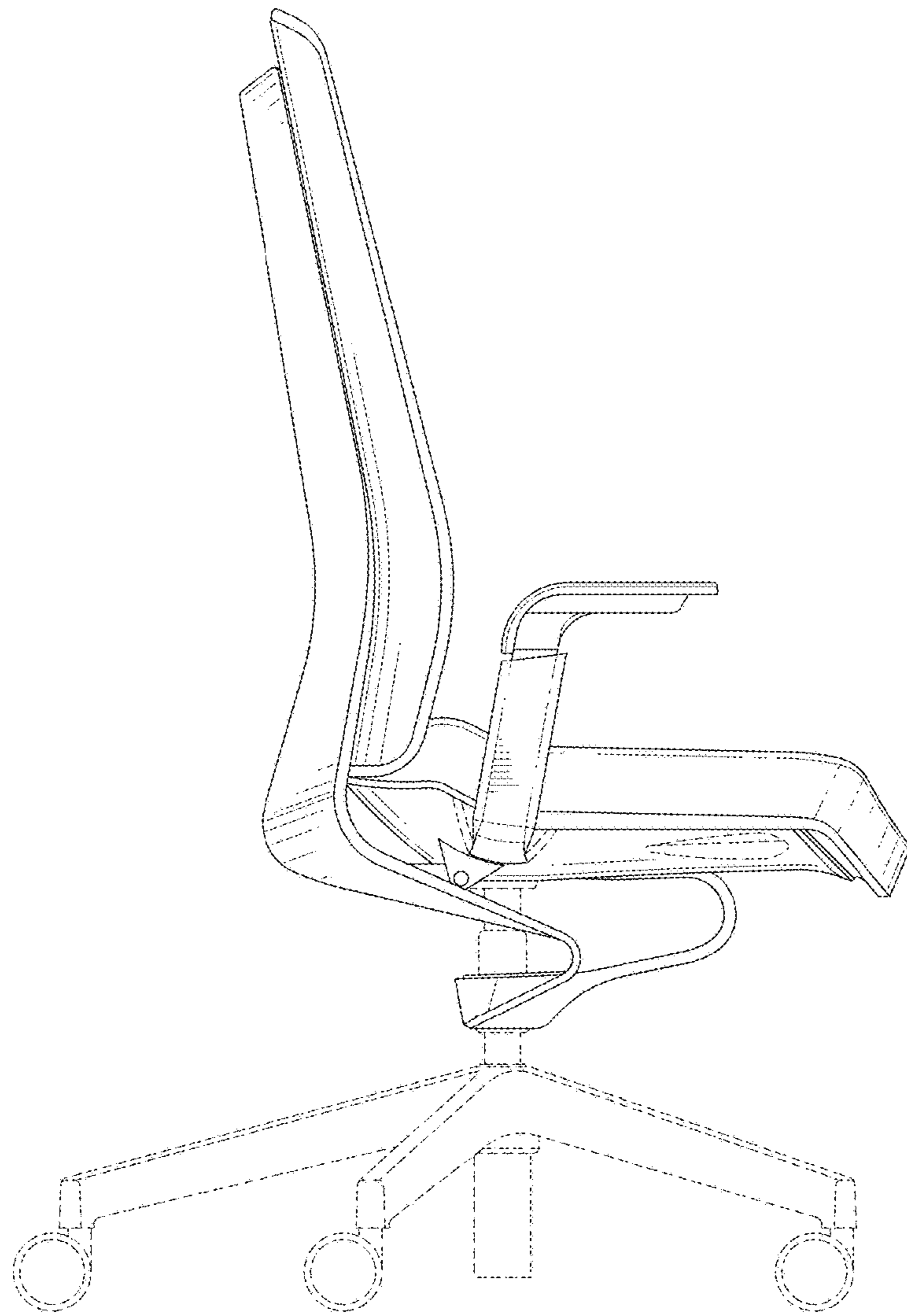

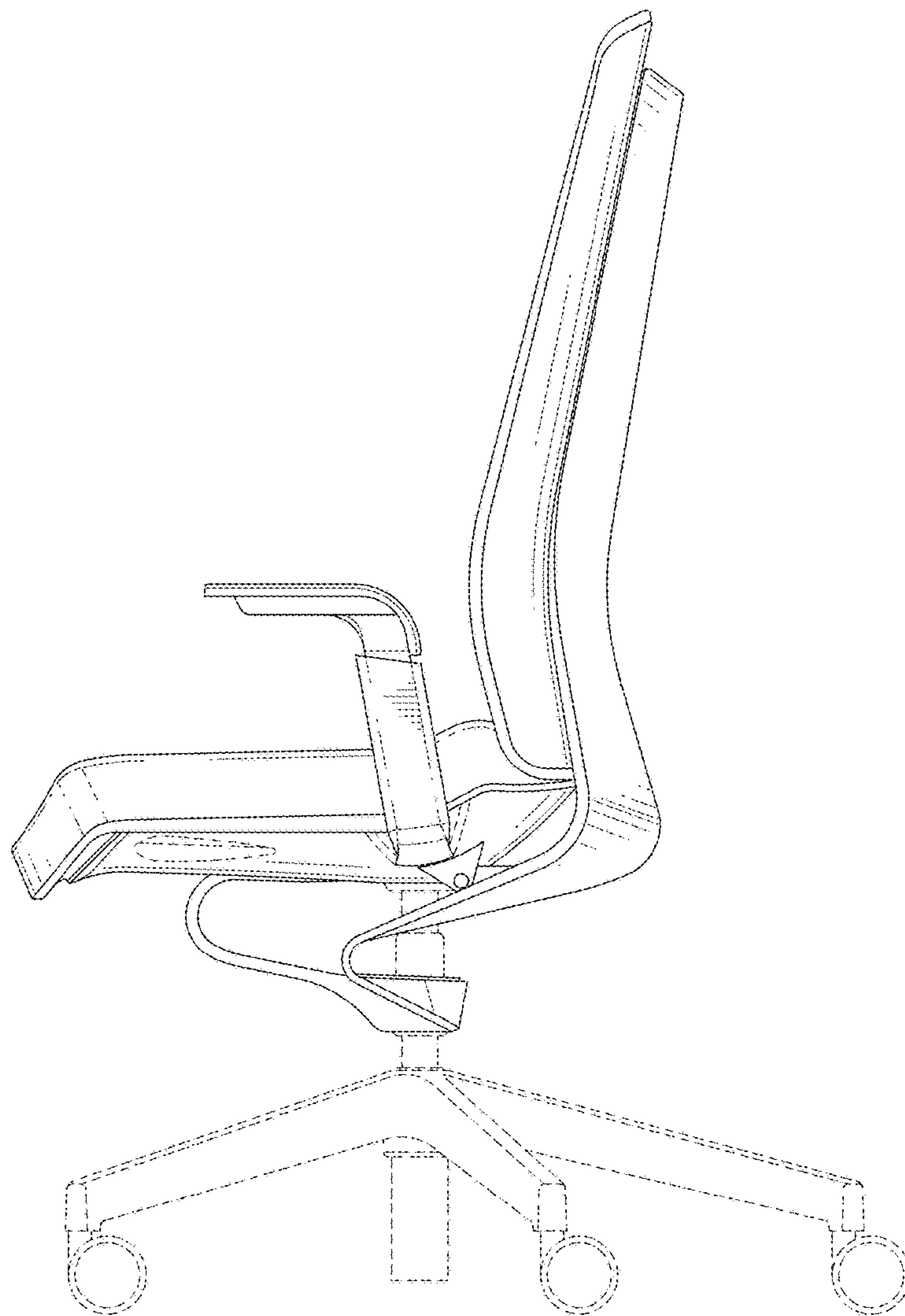
