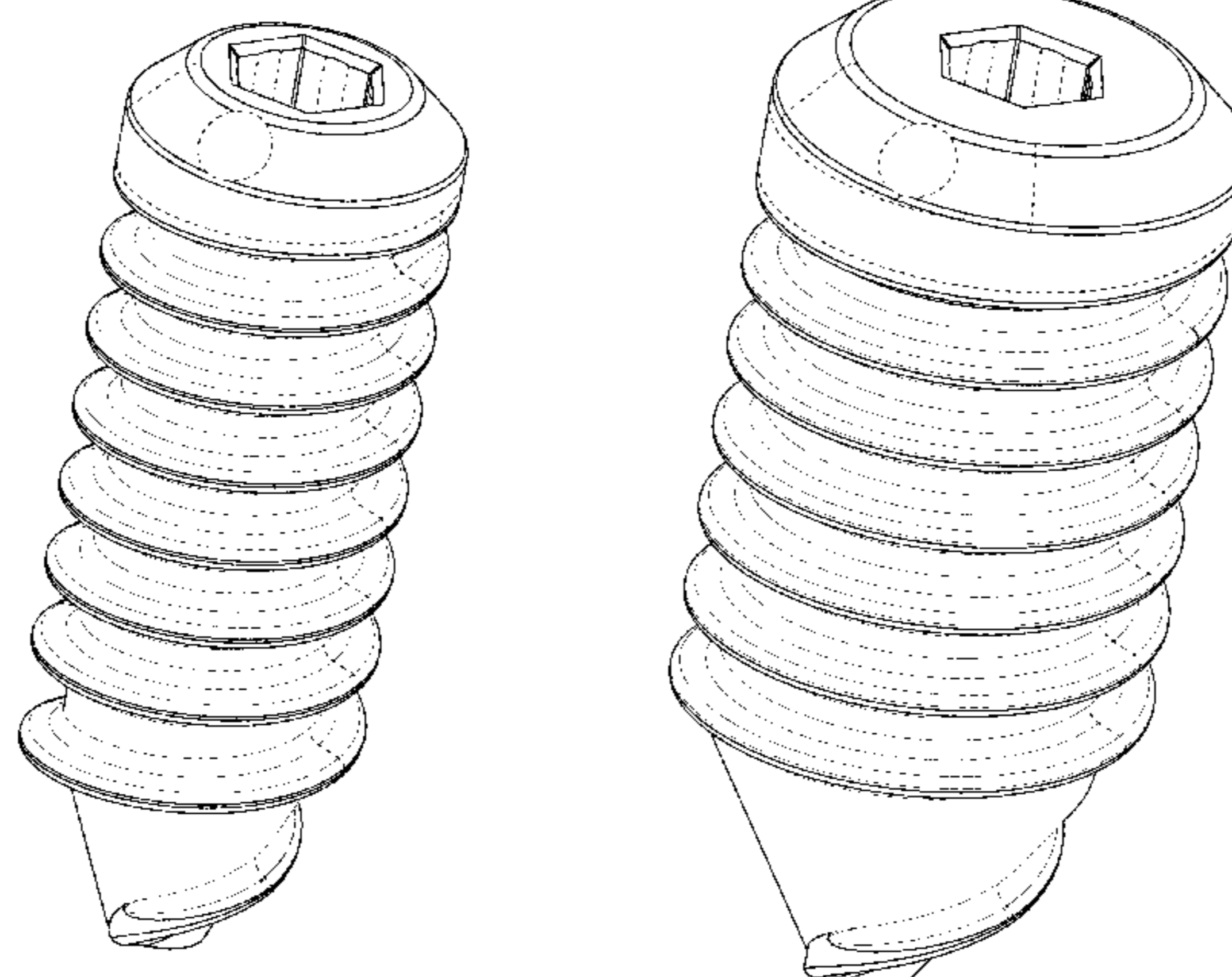
(57) **CLAIM**

The ornamental design for a screw, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of the first embodiment of the screw showing a design according to the present disclosure. FIG. 2 is a front view of the design of FIG. 1. FIG. 3 is a back view of the design of FIG. 1. FIG. 4 is a left side view of the design of FIG. 1. FIG. 5 is a right side view of the design of FIG. 1. FIG. 6 is a top view of the design of FIG. 1. FIG. 7 is a bottom view of the design of FIG. 1. FIG. 8 is an isometric view of the second embodiment of the screw showing a design according to the present disclosure. FIG. 9 is a front view of the design of FIG. 8. FIG. 10 is a back view of the design of FIG. 8. FIG. 11 is a left side view of the design of FIG. 8. FIG. 12 is a right side view of the design of FIG. 8. FIG. 13 is a top view of the design of FIG. 8; and, FIG. 14 is a bottom view of the design of FIG. 8. The shading lines shown in the drawings represent the approximate three-dimensional contour of the presently claimed design and form no part of the claimed design. The broken lines in the drawings illustrate portions of the screw and form no part of the claimed design.

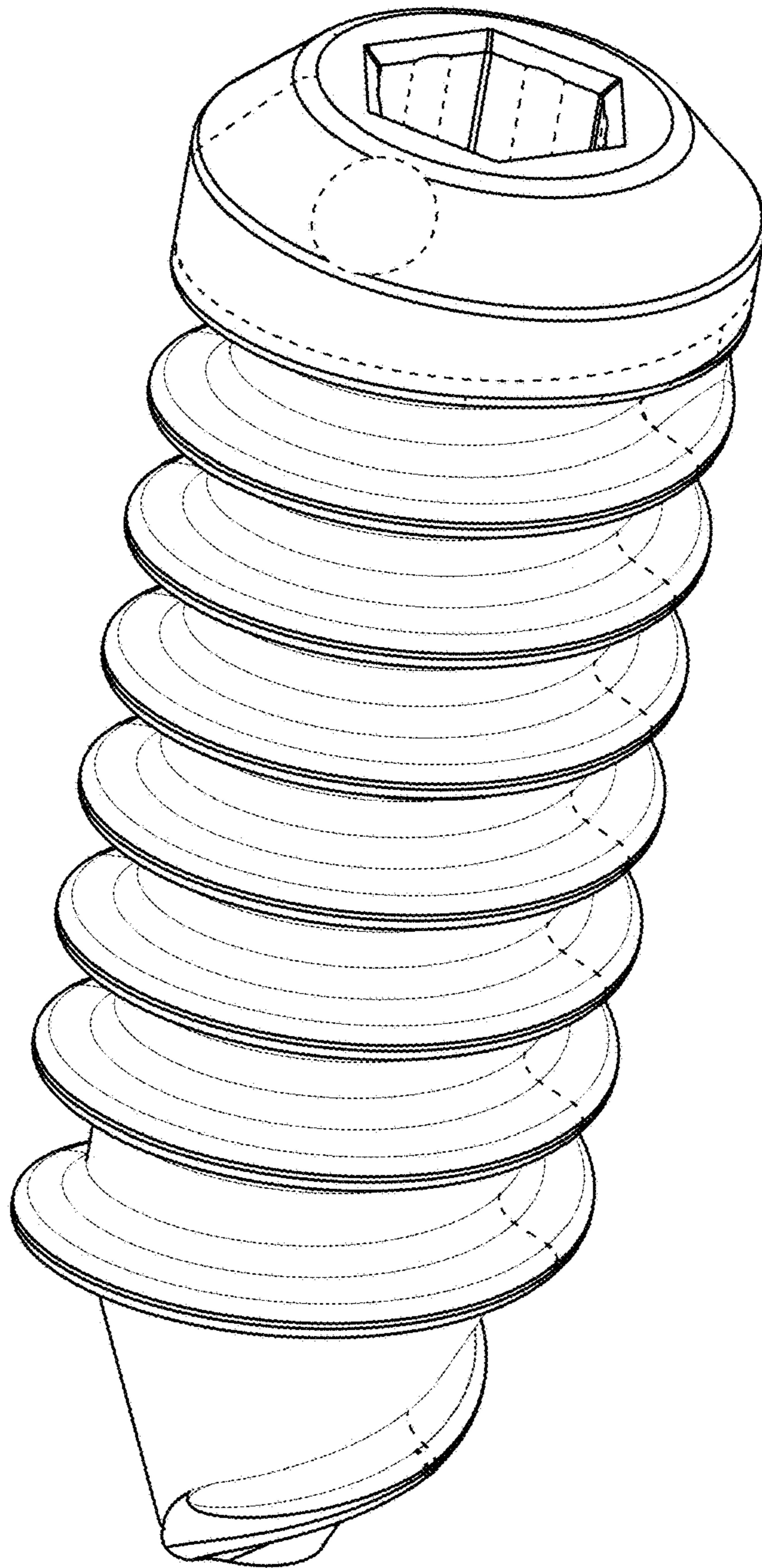

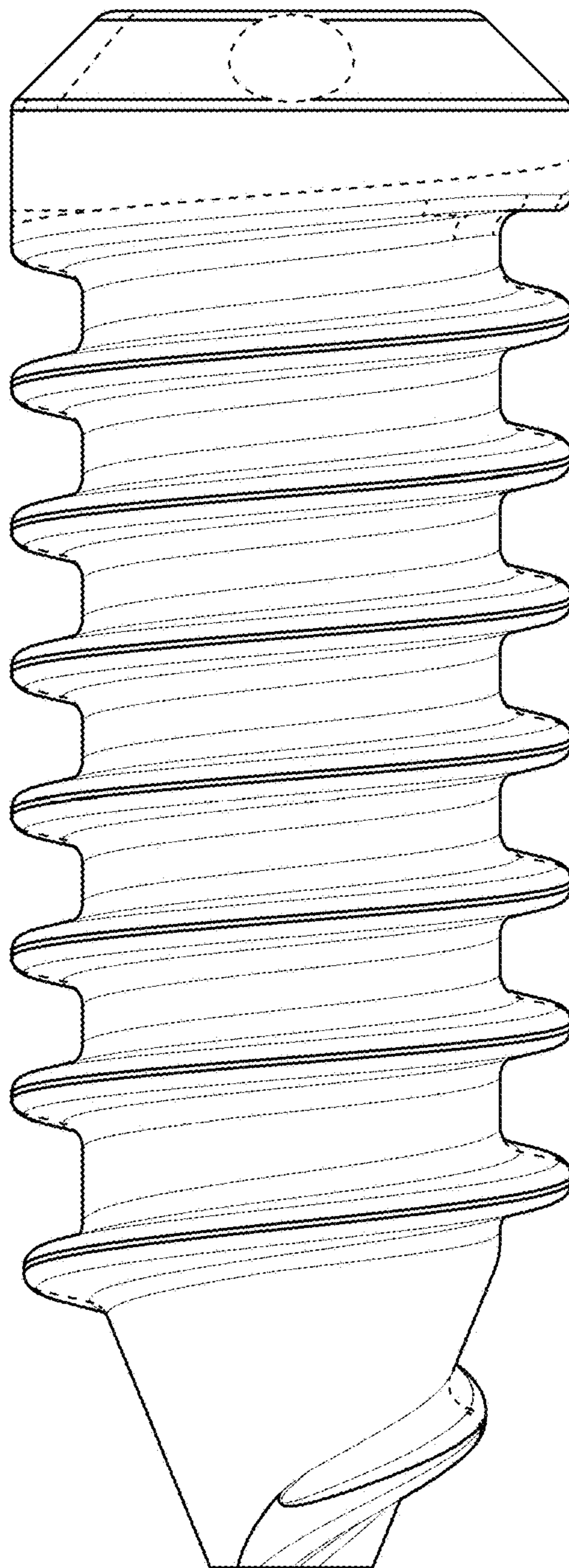

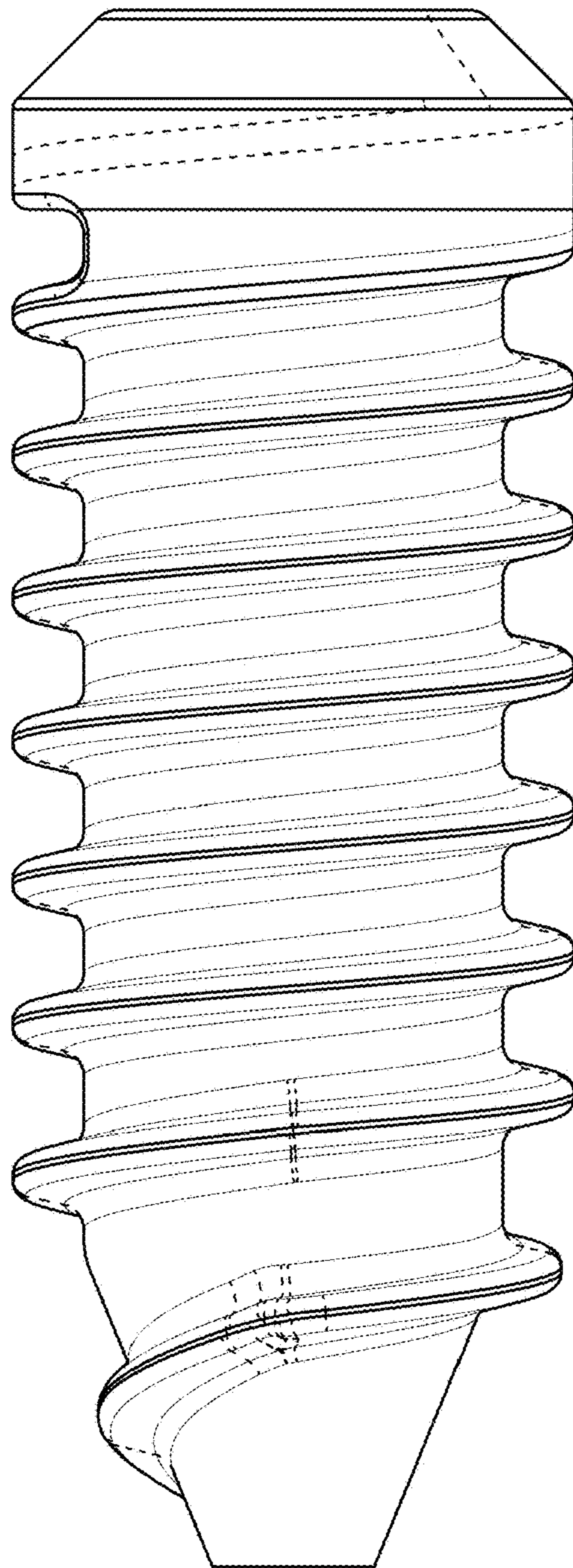

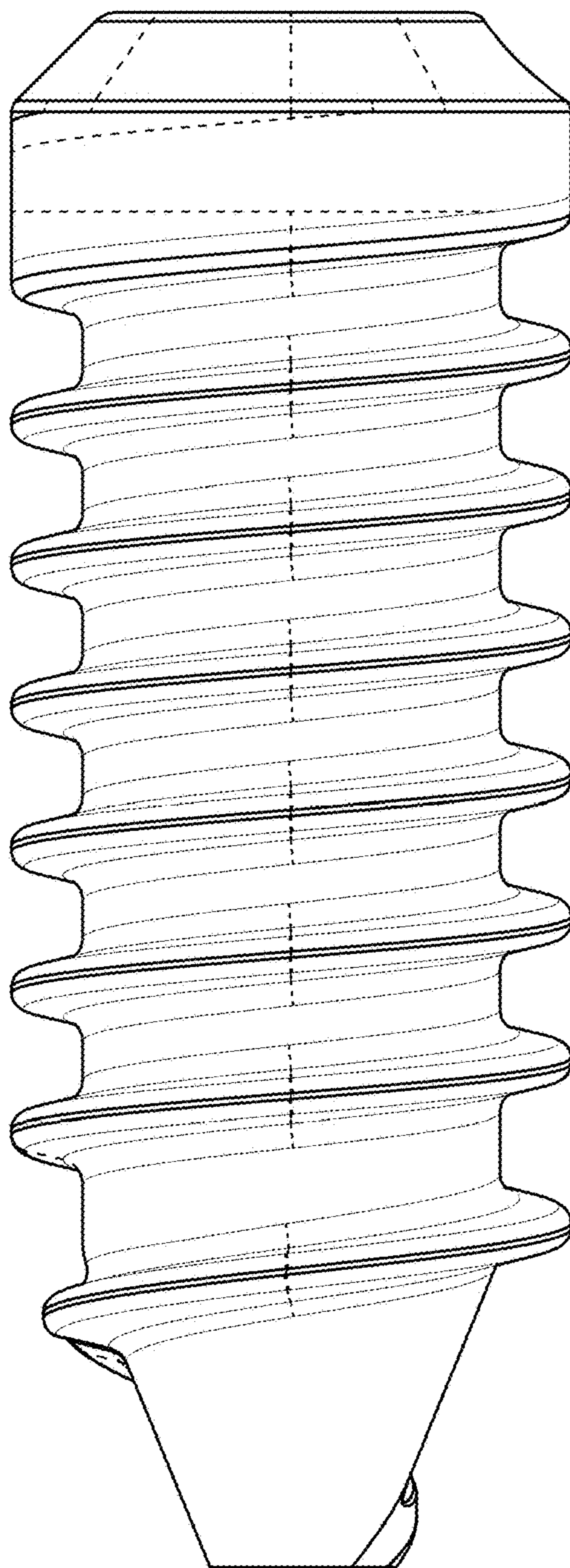

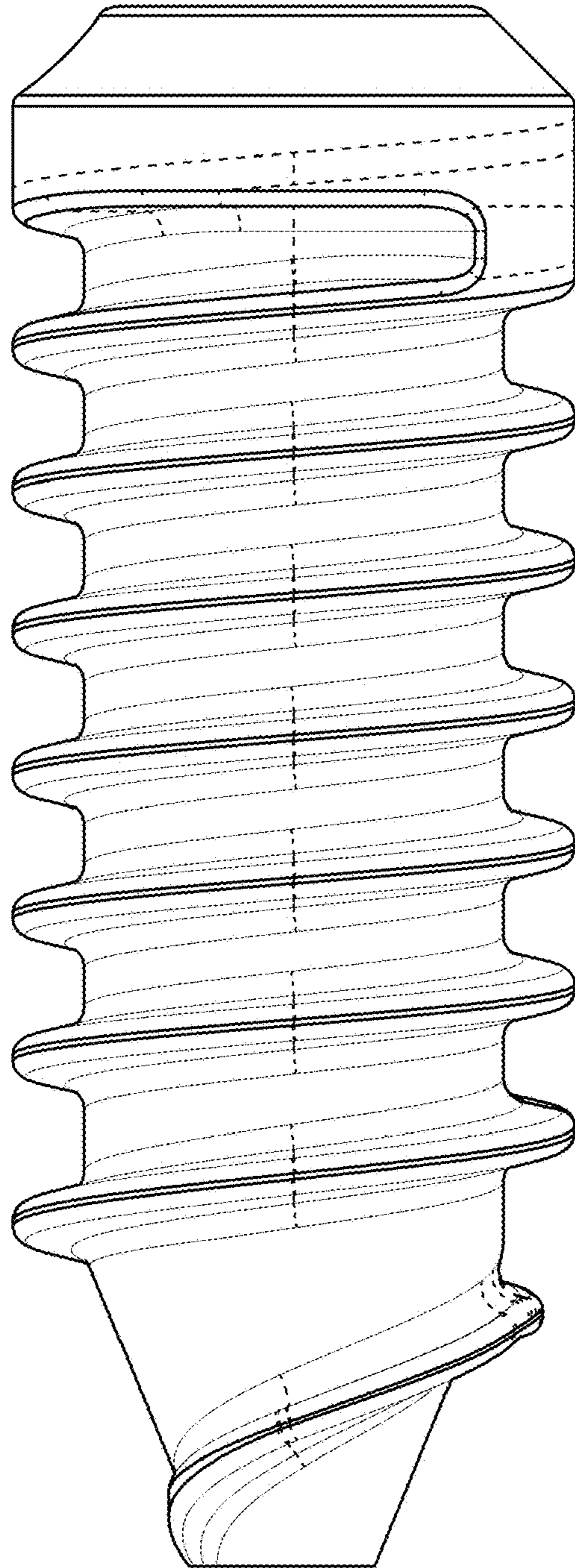

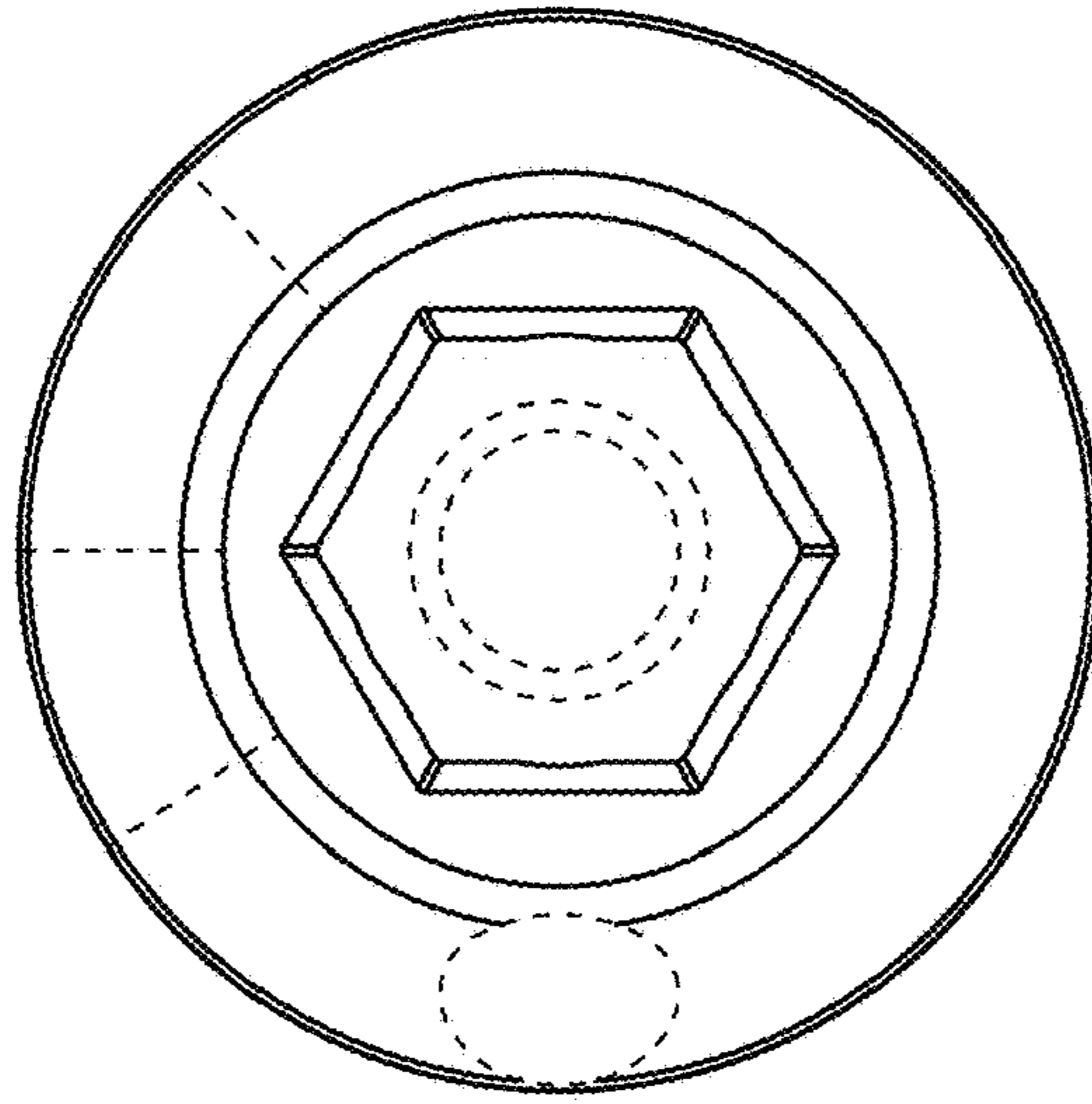

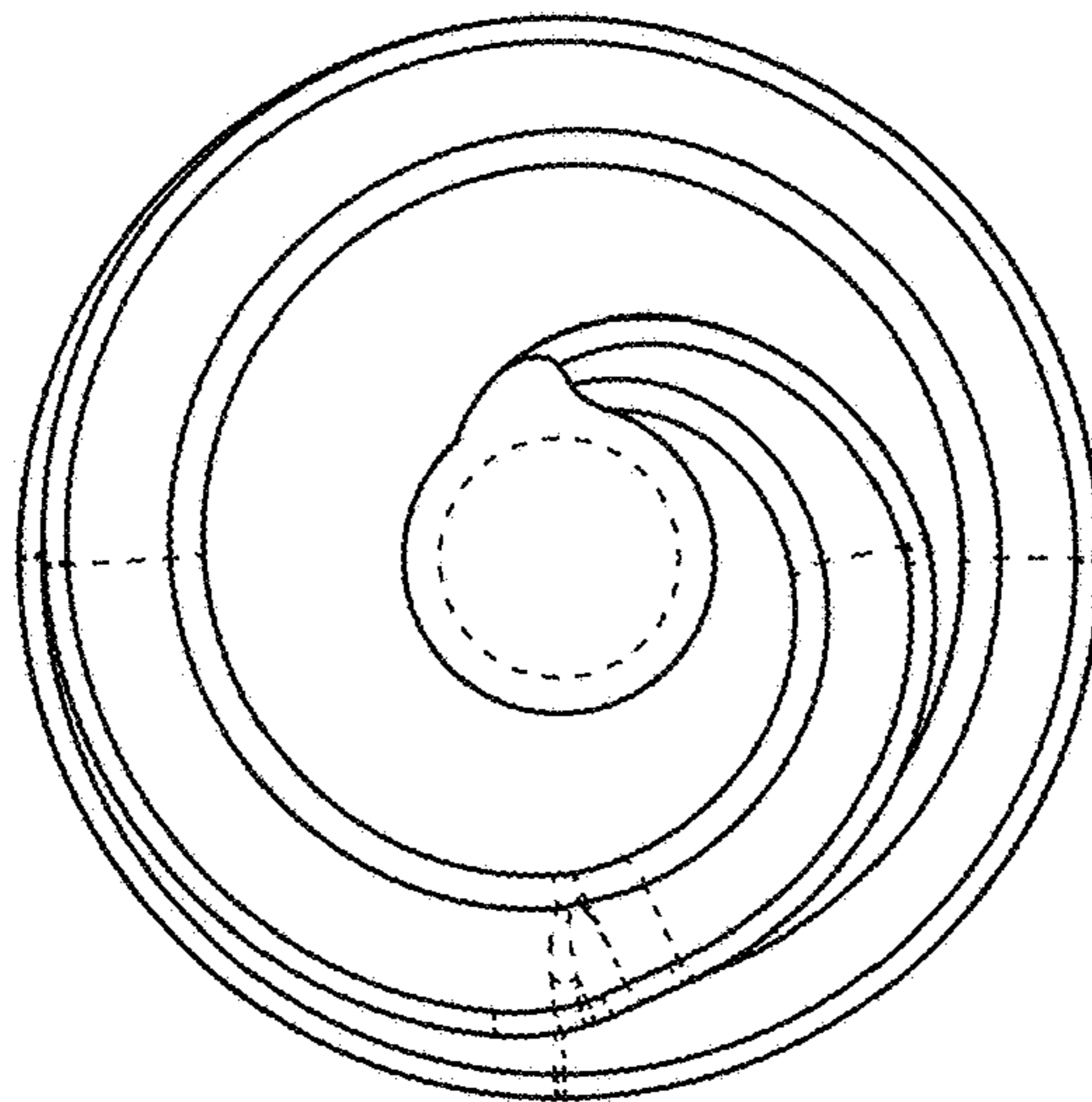

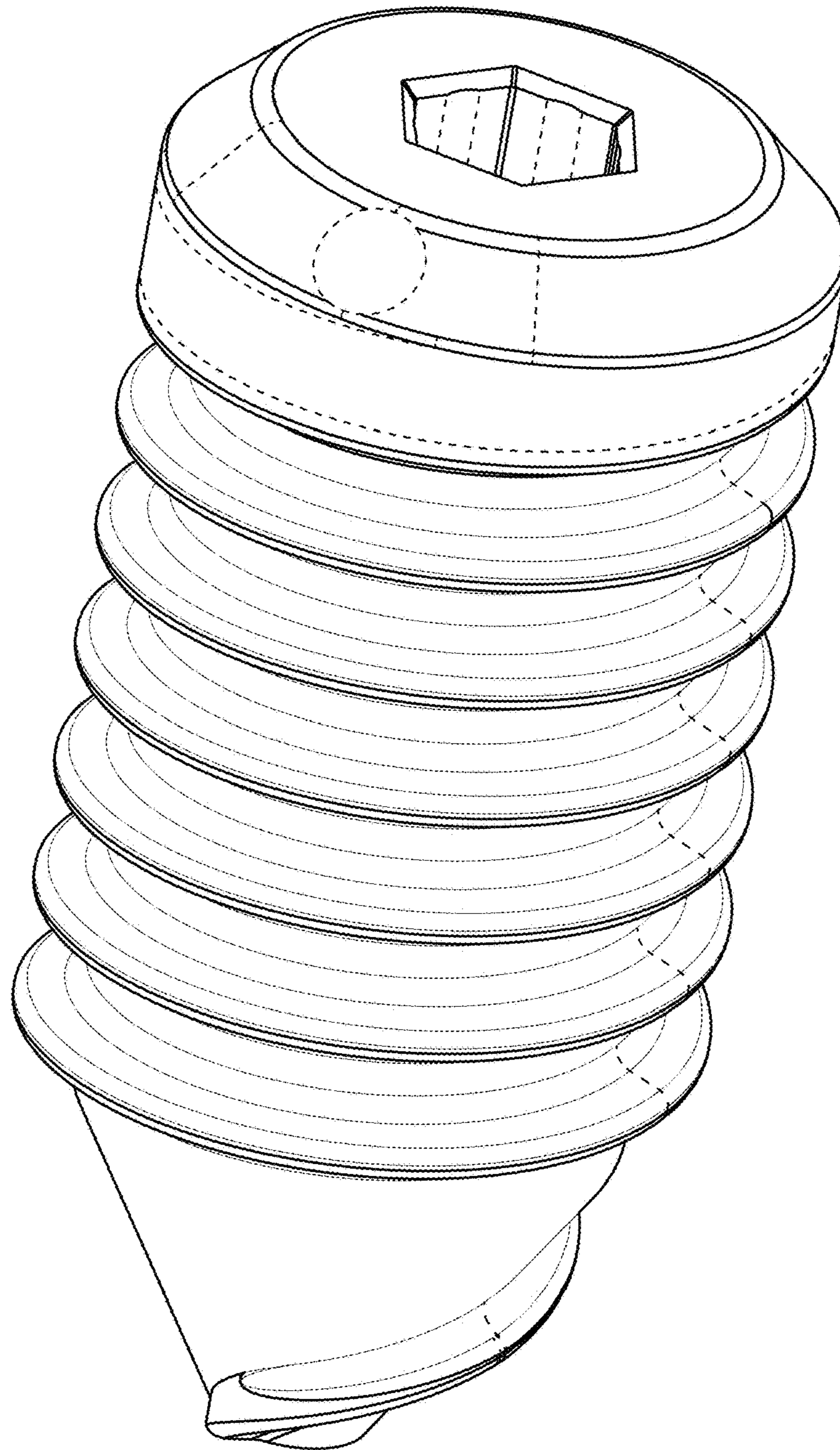

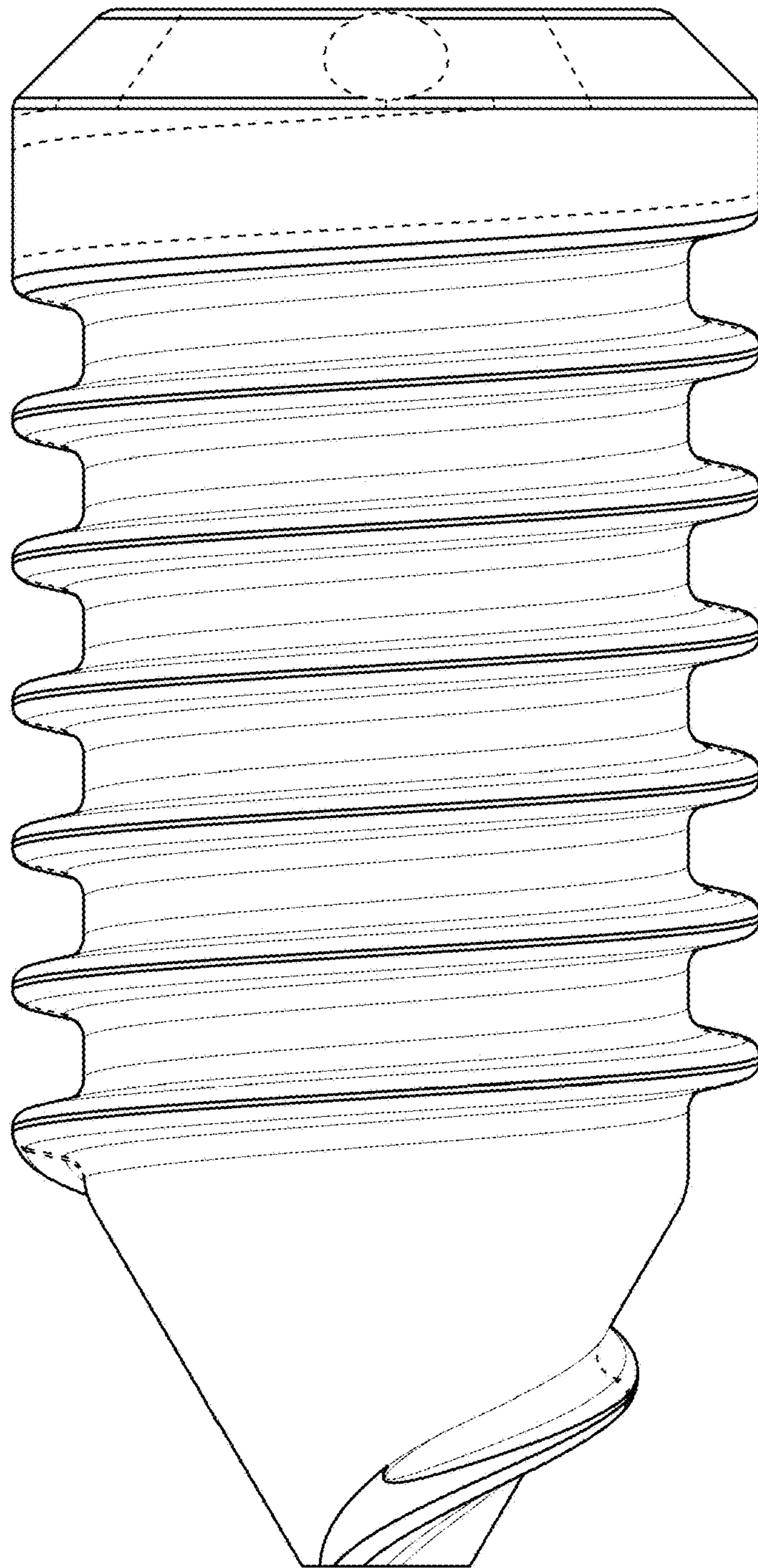

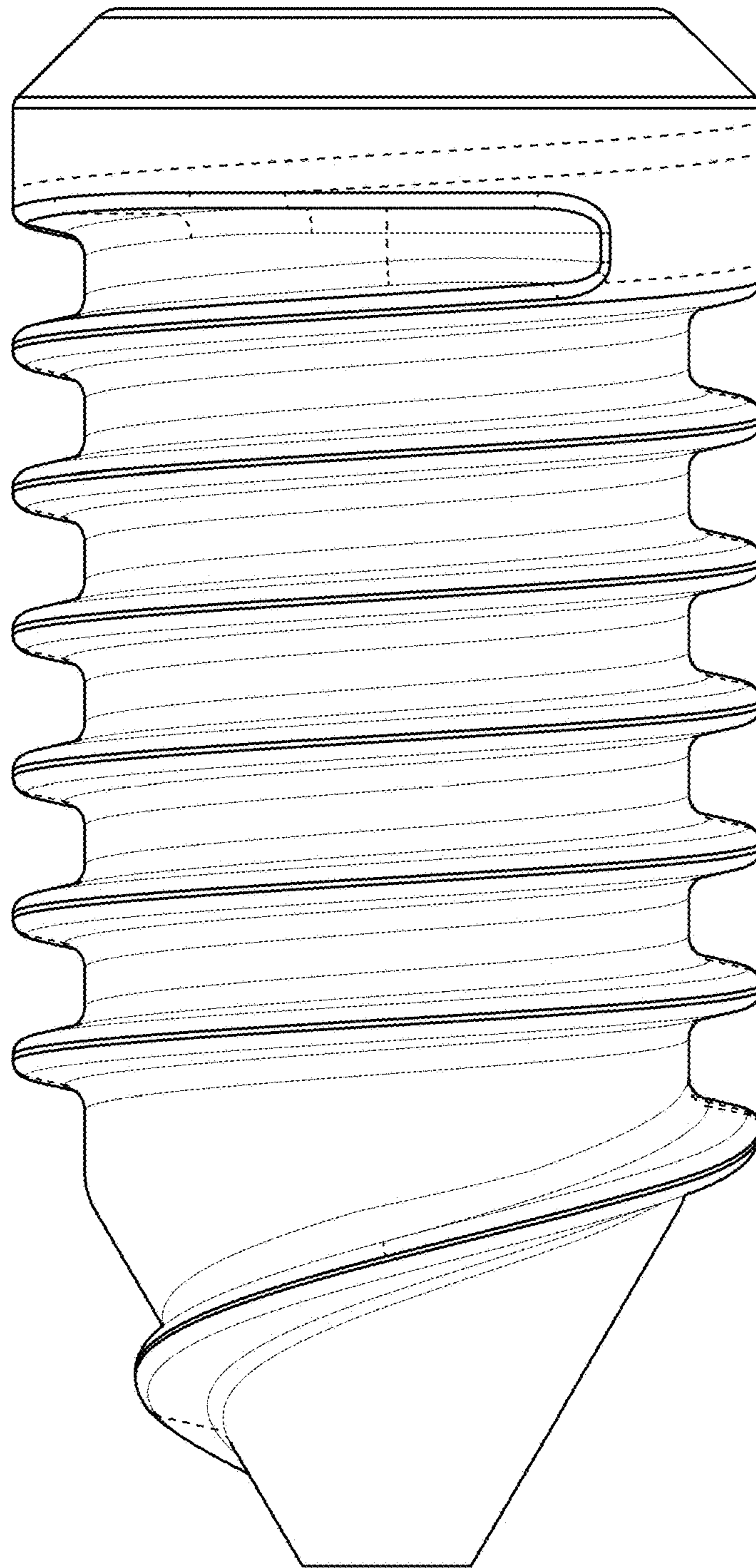

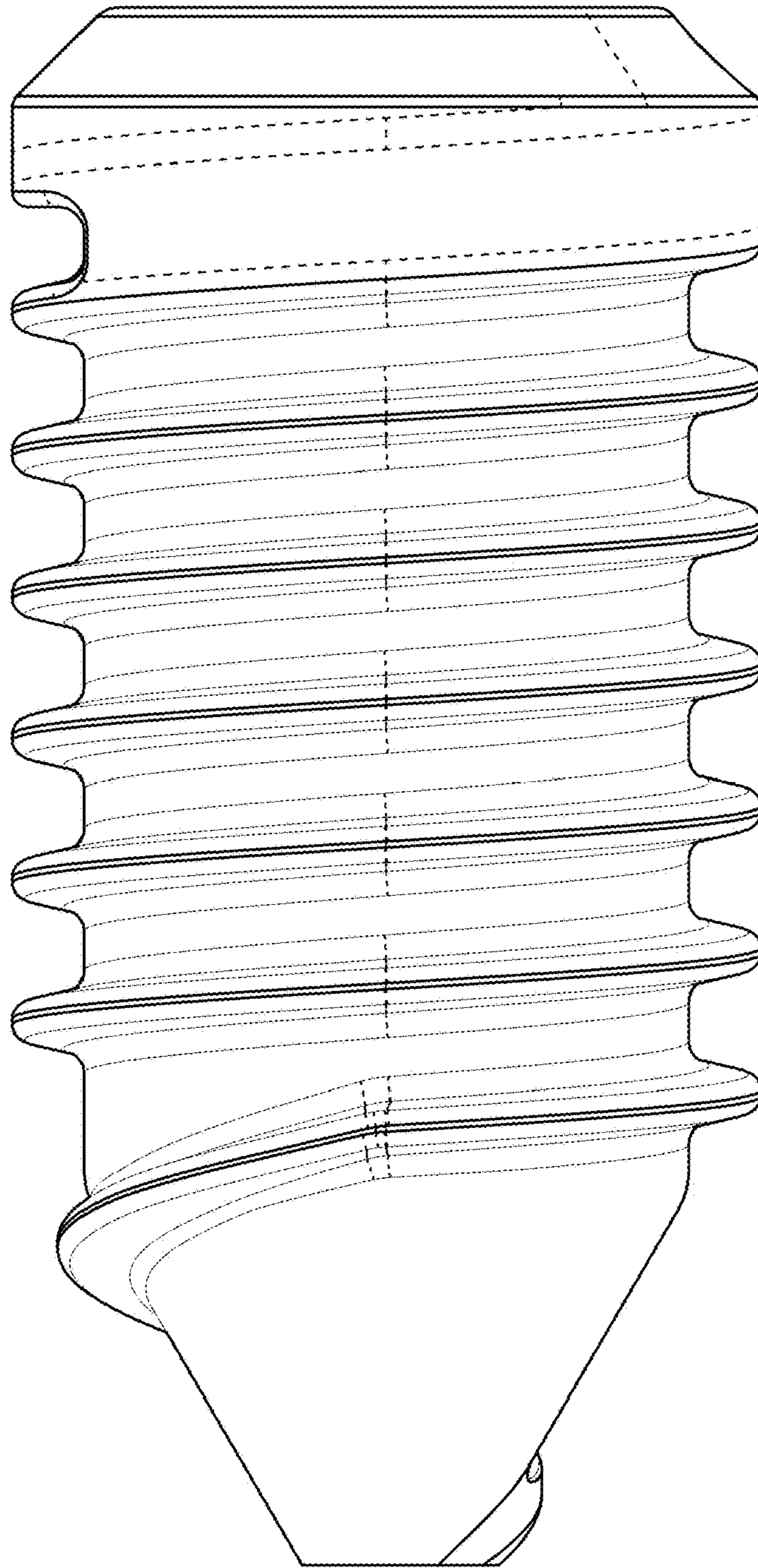

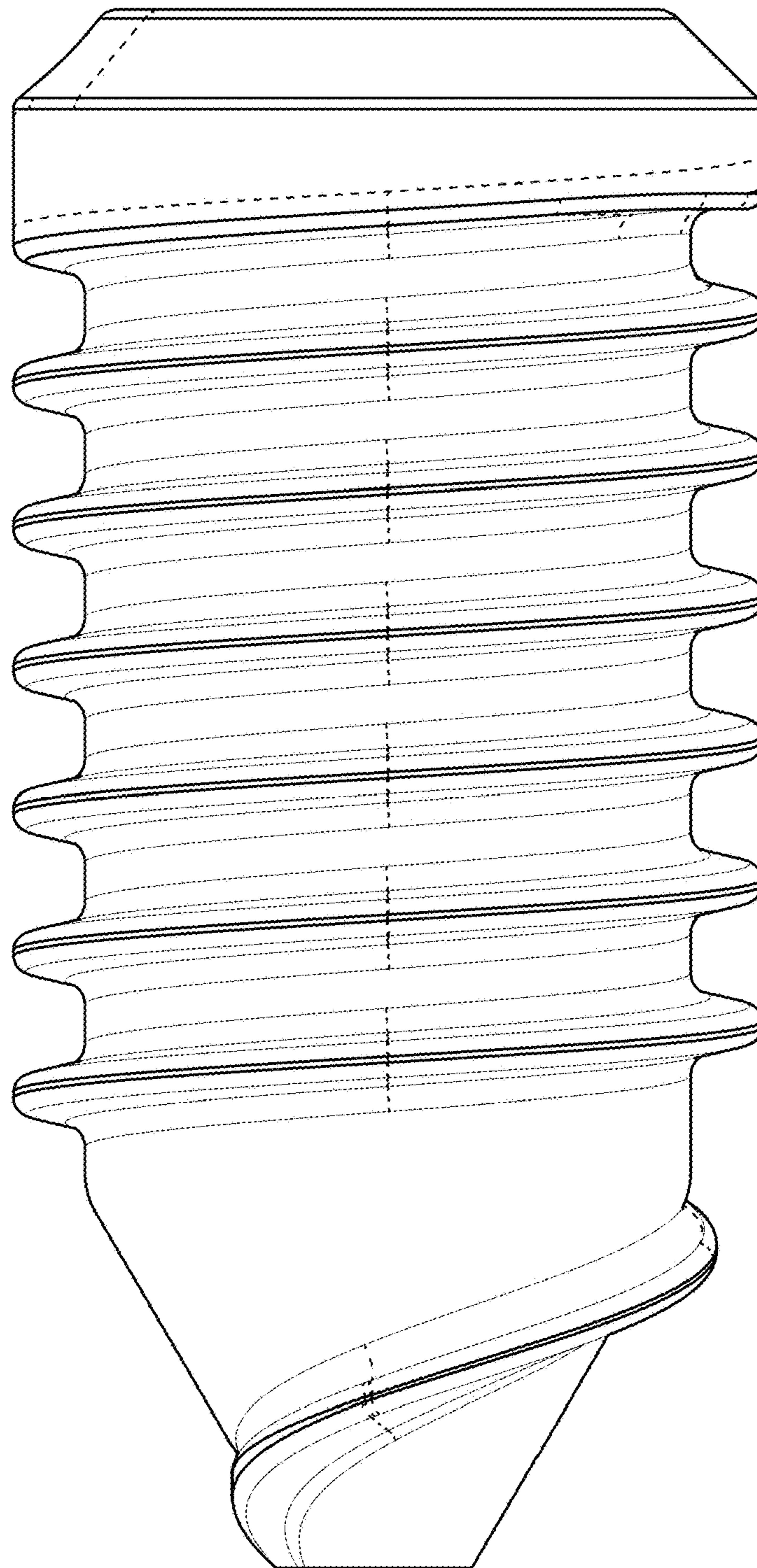

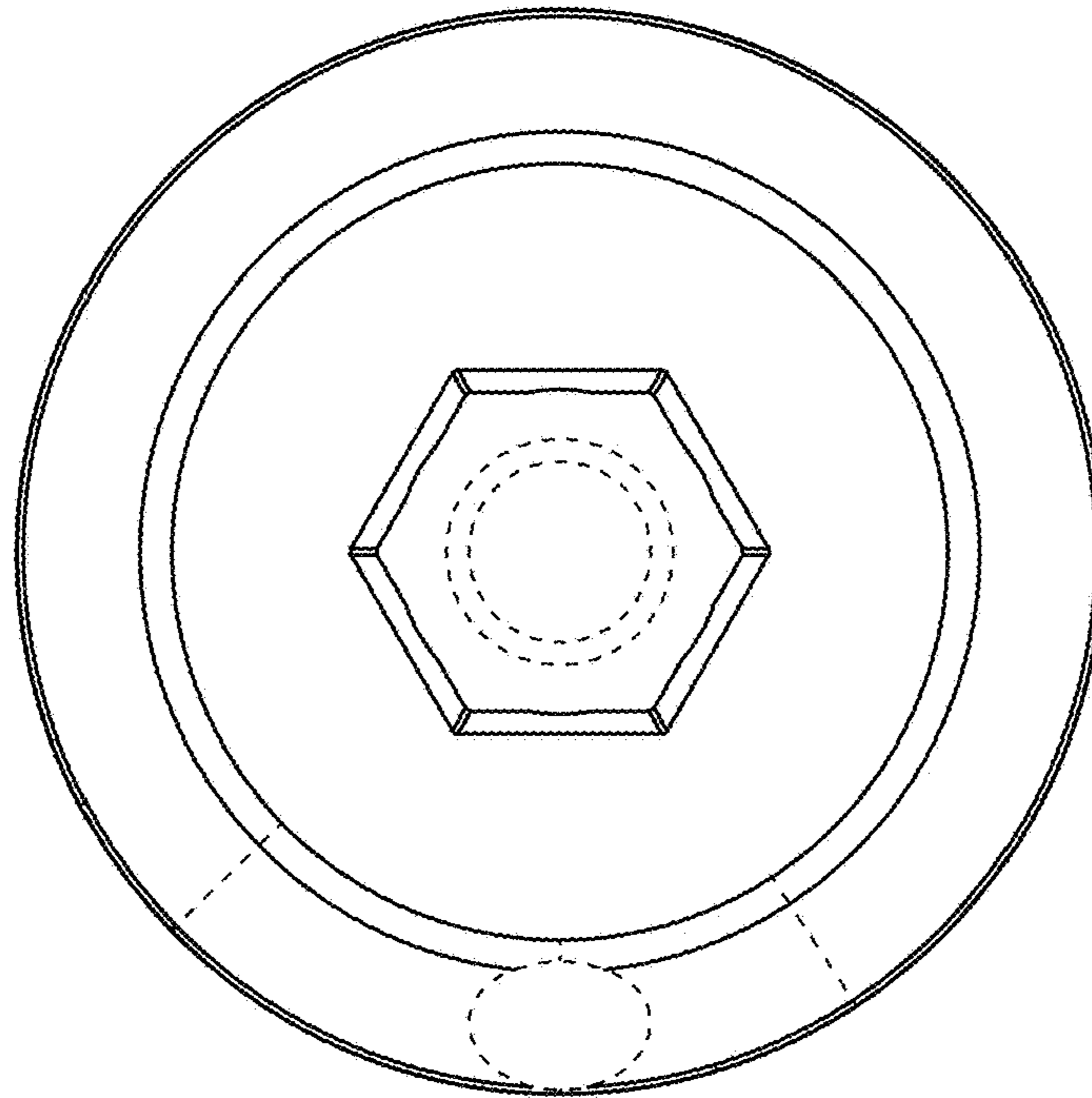

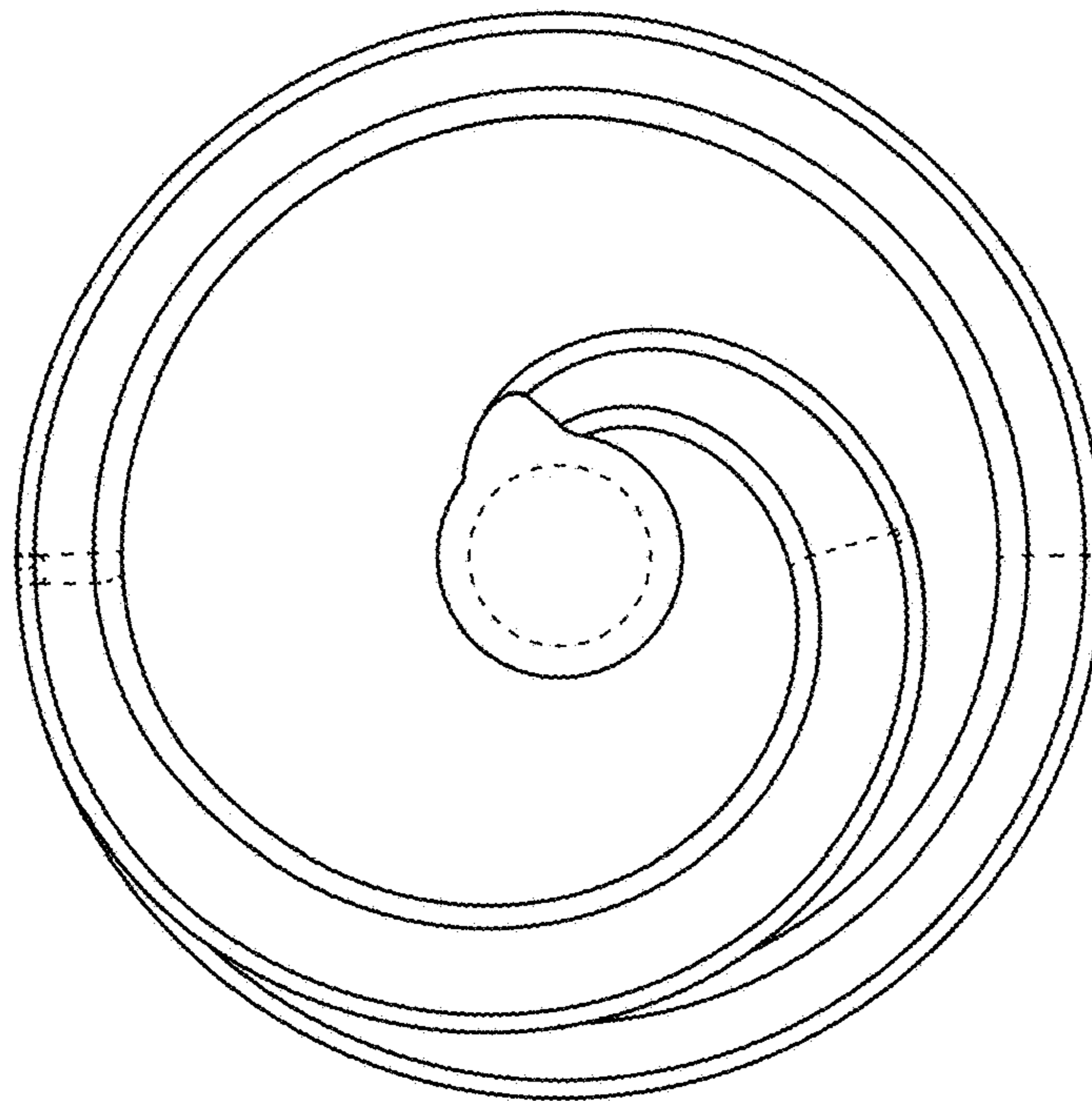
