FIG. 3 is an additional perspective view thereof;

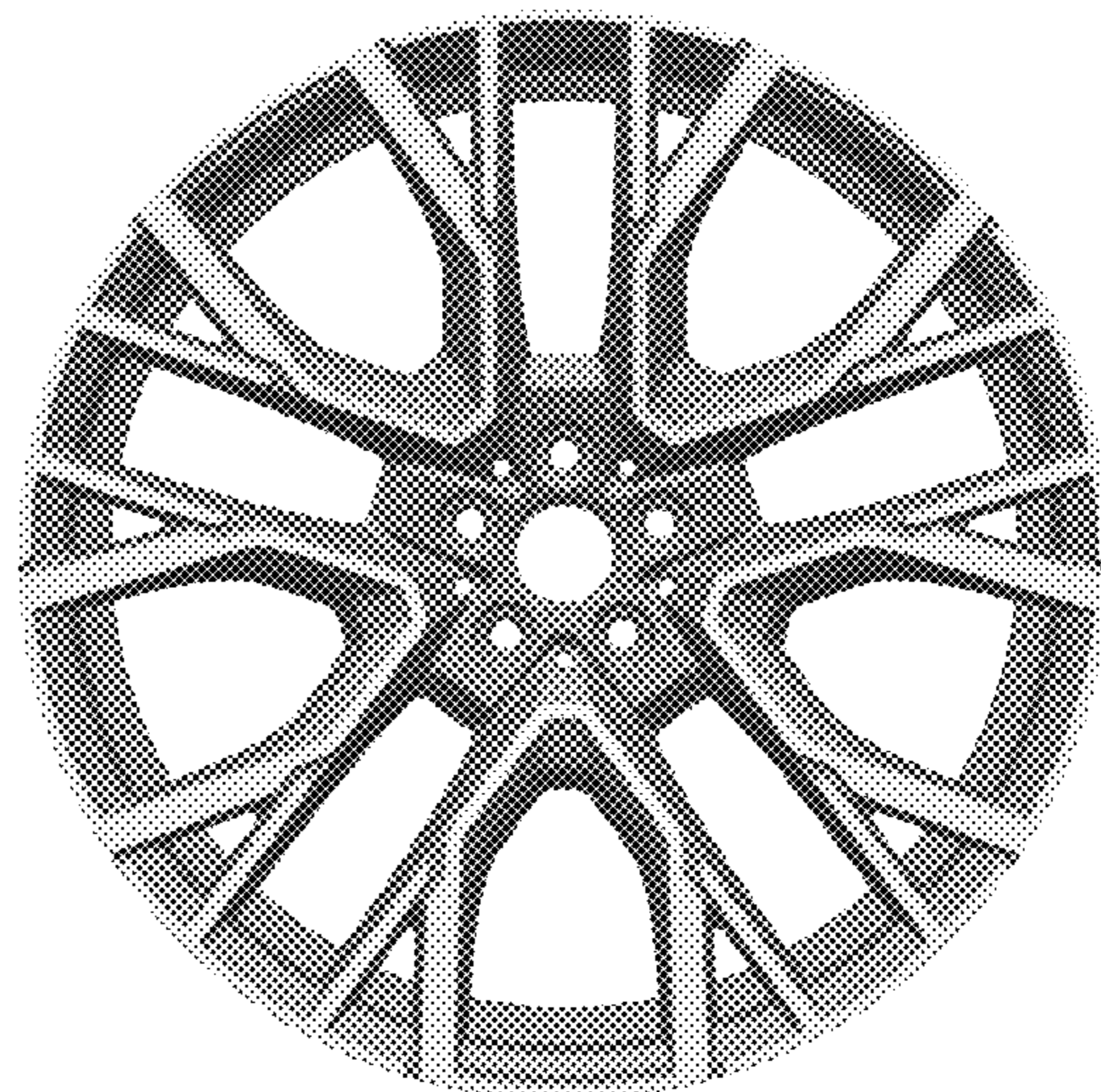
FIG. 4 is a front view thereof;

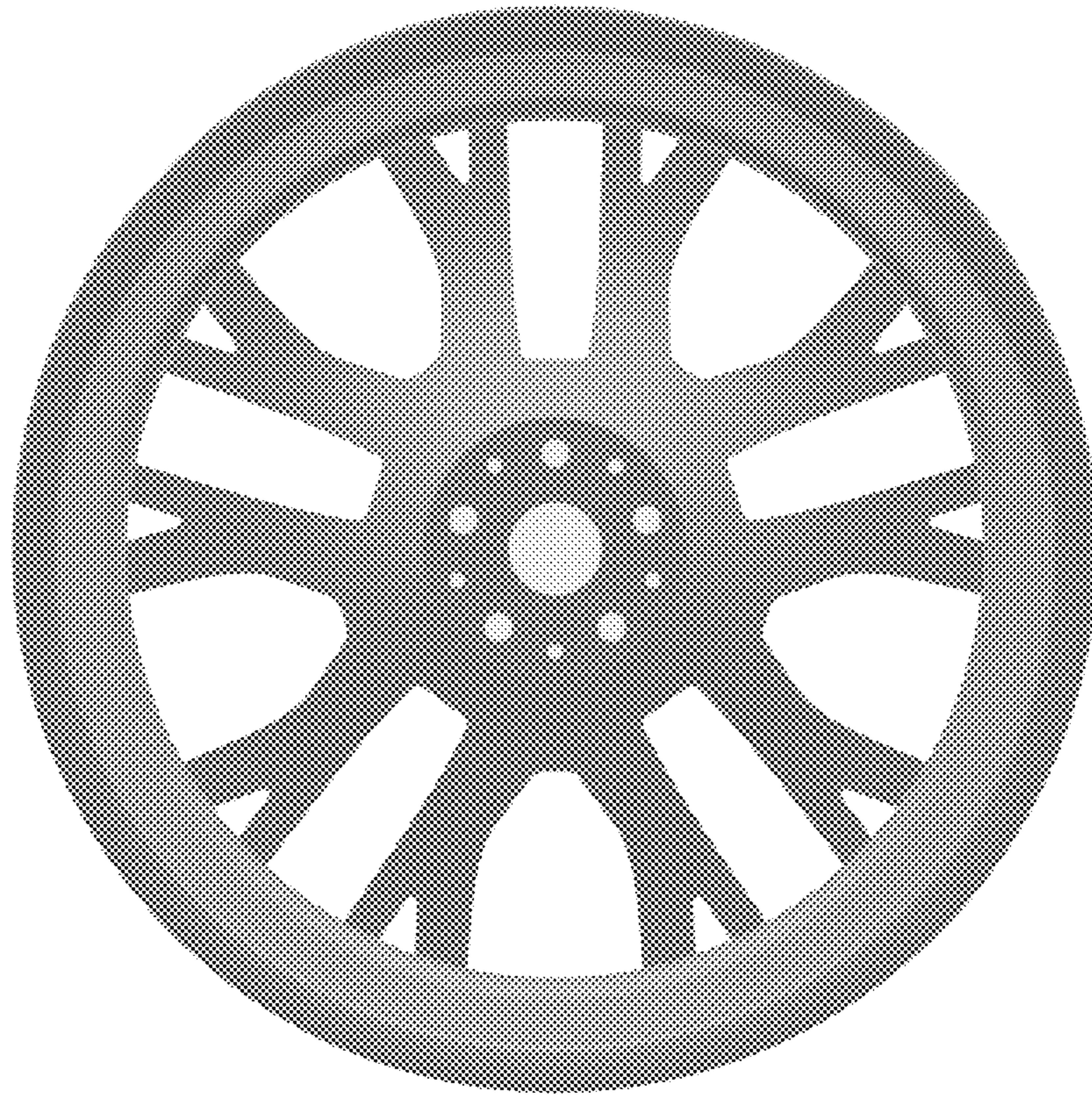

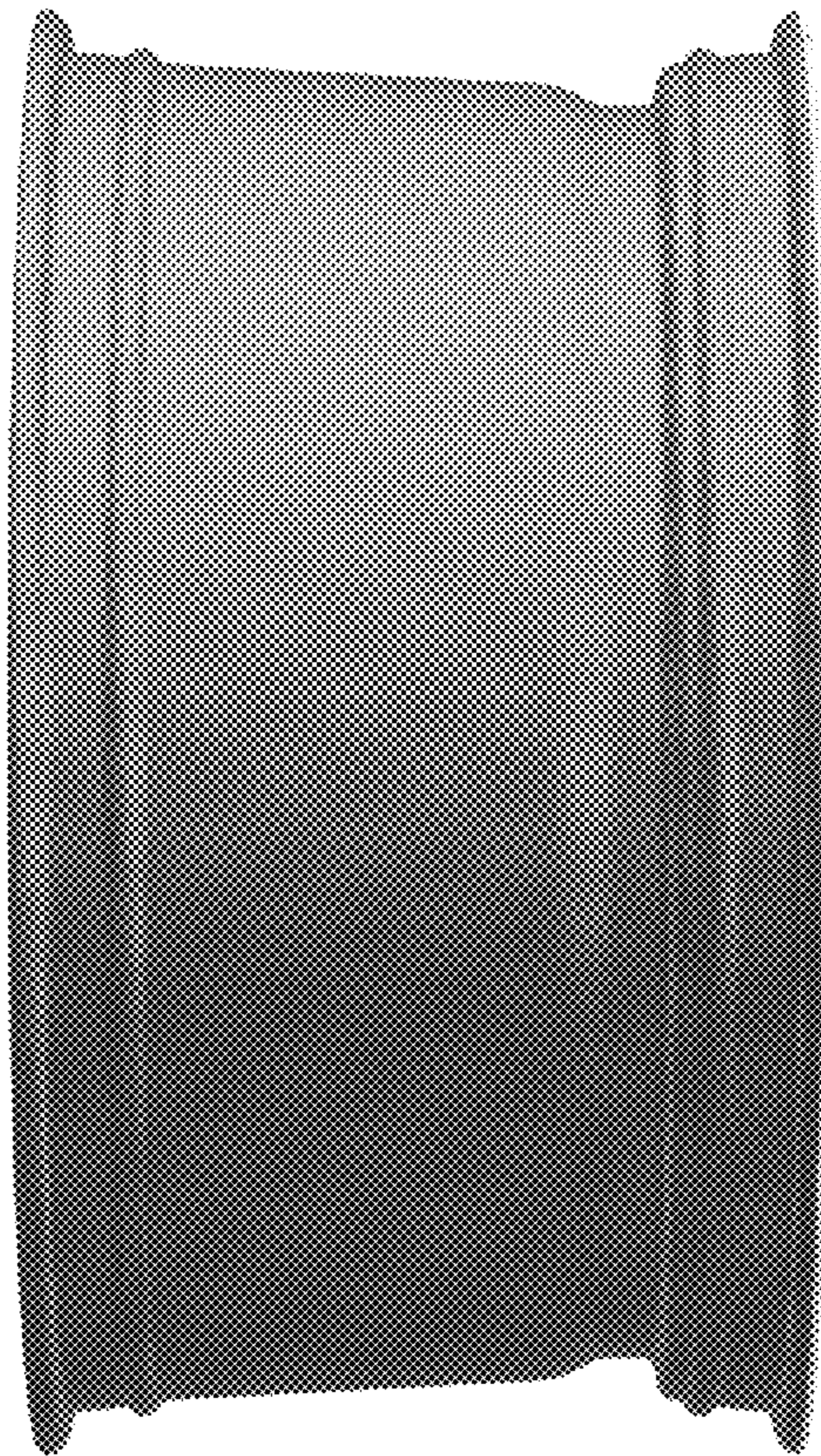
