The ornamental design for an earpiece, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of an earpiece showing our new design;
 FIG. 2 is a rear left perspective view thereof;
 FIG. 3 is a left side elevational view thereof;
 FIG. 4 is a right side elevational view thereof;
 FIG. 5 is a front side elevational view thereof;
 FIG. 6 is a rear side elevational view thereof;
 FIG. 7 is a top plan view thereof;
 FIG. 8 is a bottom plan view thereof;
 FIG. 9 is a cross-sectional view thereof taken at line 9-9 of FIG. 3; and
 FIG. 10 is a cross-sectional view thereof taken at line 10-10 of FIG. 4.
 FIG. 11 is a front right perspective view of an example audio device for an earpiece shown in broken lines;
 FIG. 12 is a front left perspective view thereof;
 FIG. 13 is a rear right perspective view thereof; and
 FIG. 14 is a rear left perspective view thereof.
 FIG. 15 is a front right perspective view of the earpiece with the example audio device attached thereto, drawn in broken lines;
 FIG. 16 is a front left perspective view thereof;
 FIG. 17 is a rear right perspective view thereof; and
 FIG. 18 is a rear left perspective view thereof.
 The broken lines in the drawings illustrate environmental features and form no part of the claimed design.

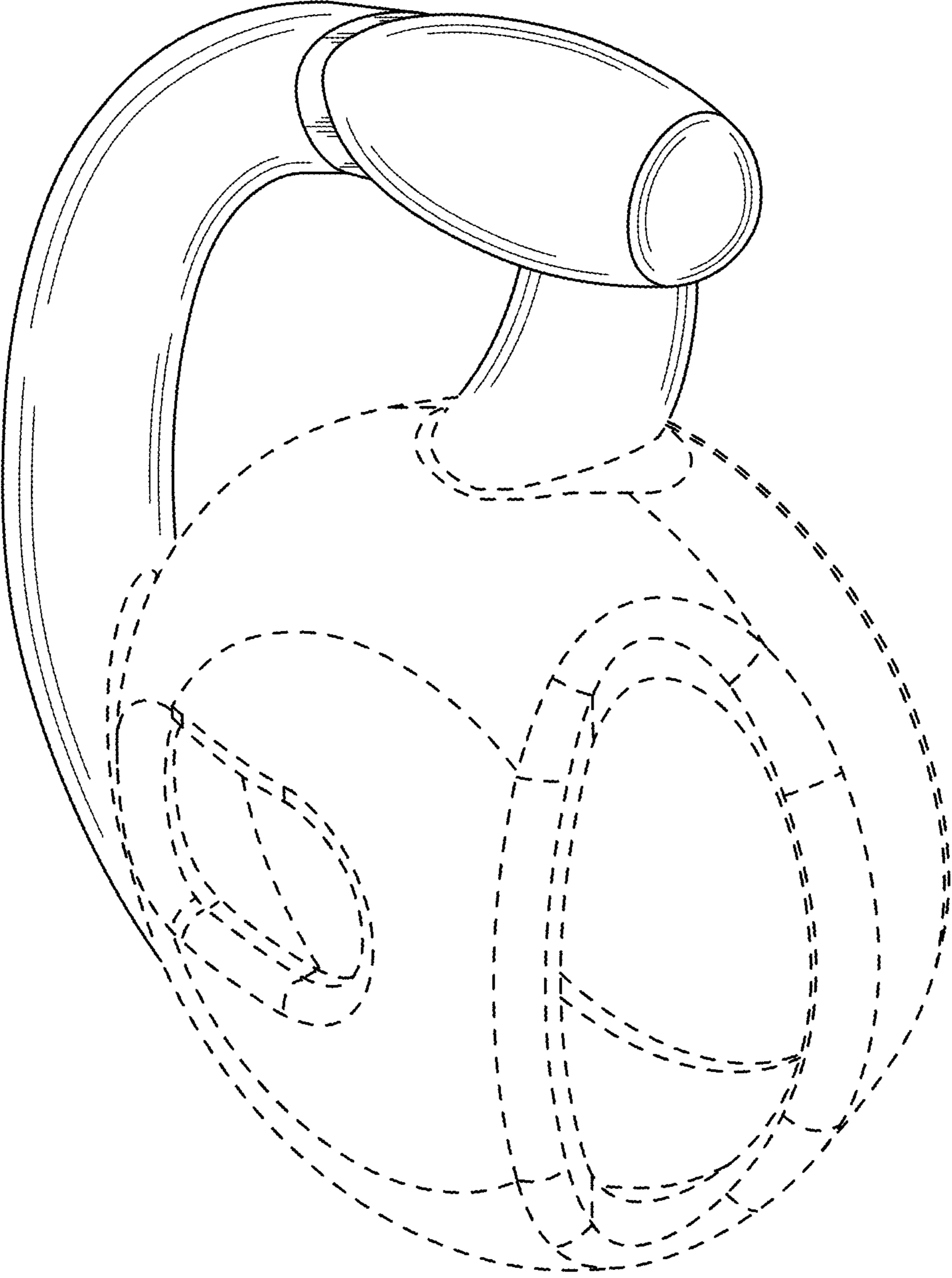

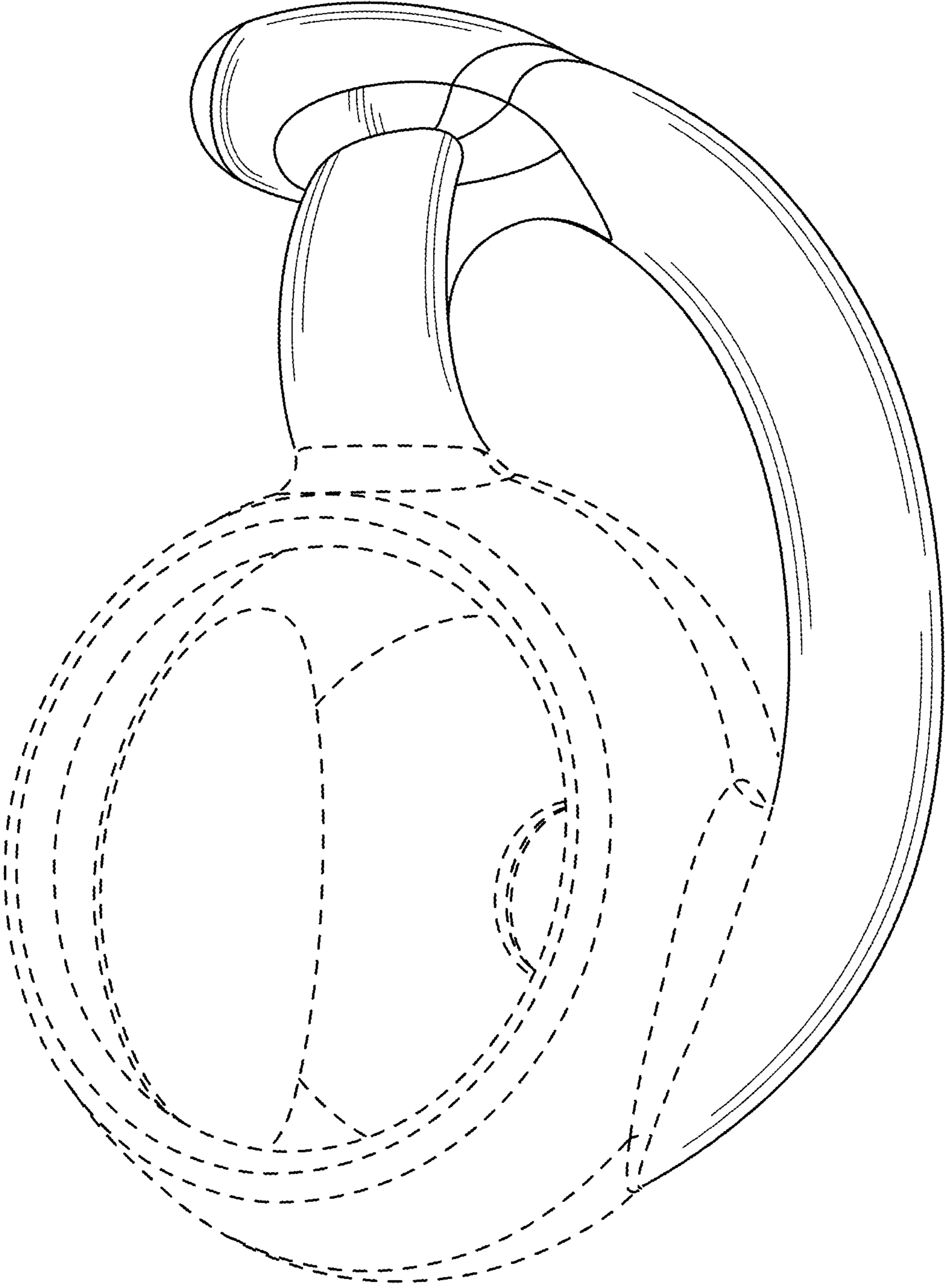
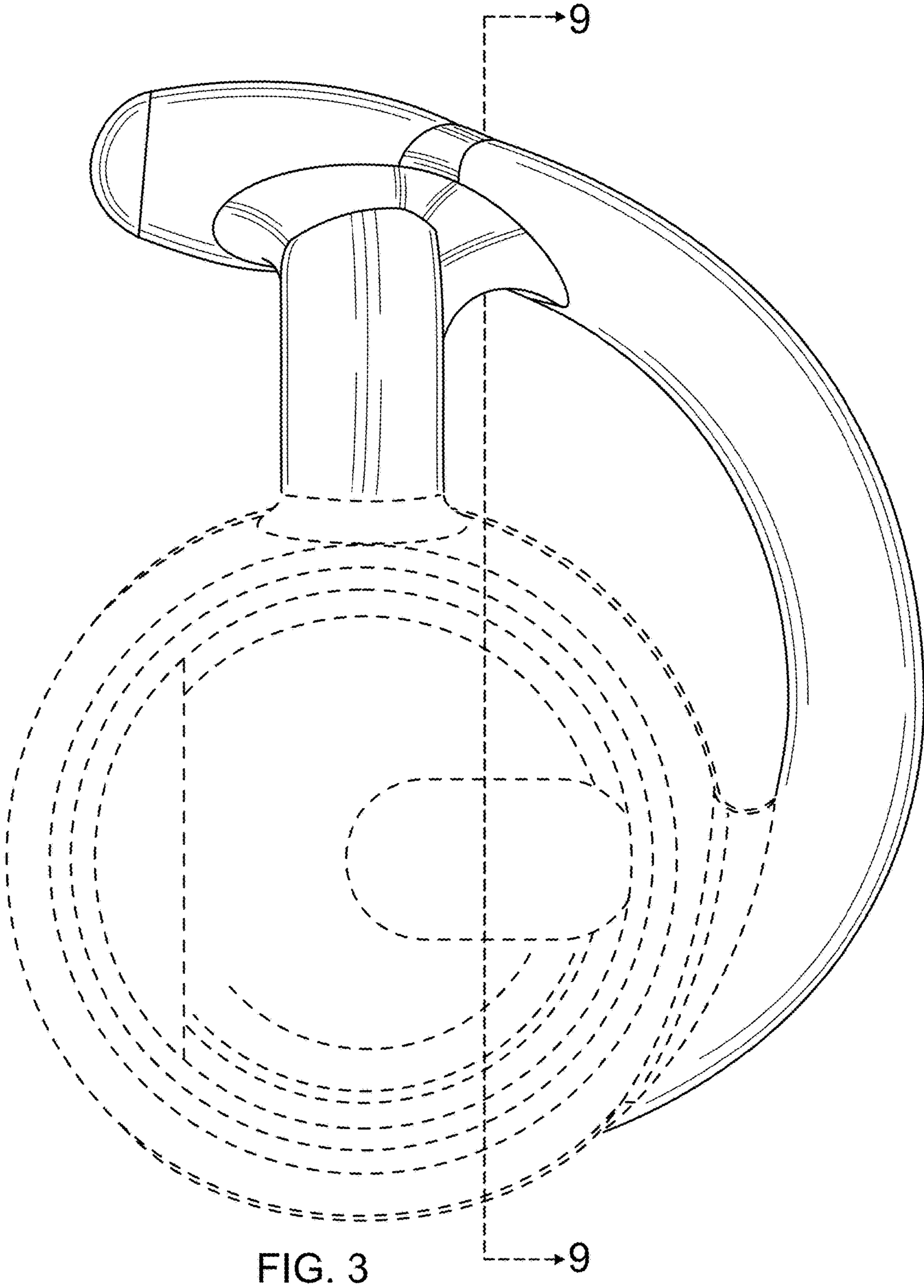

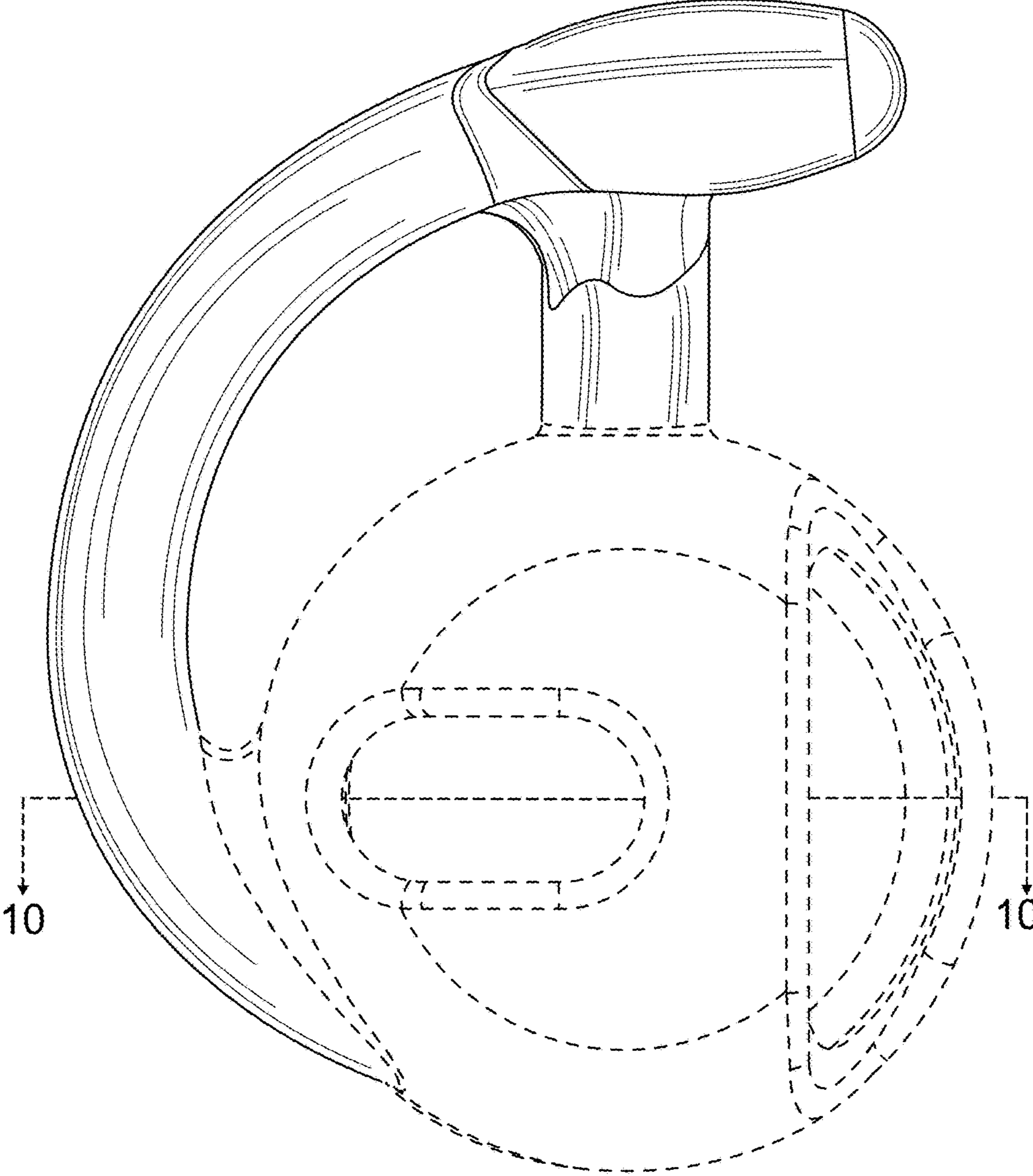

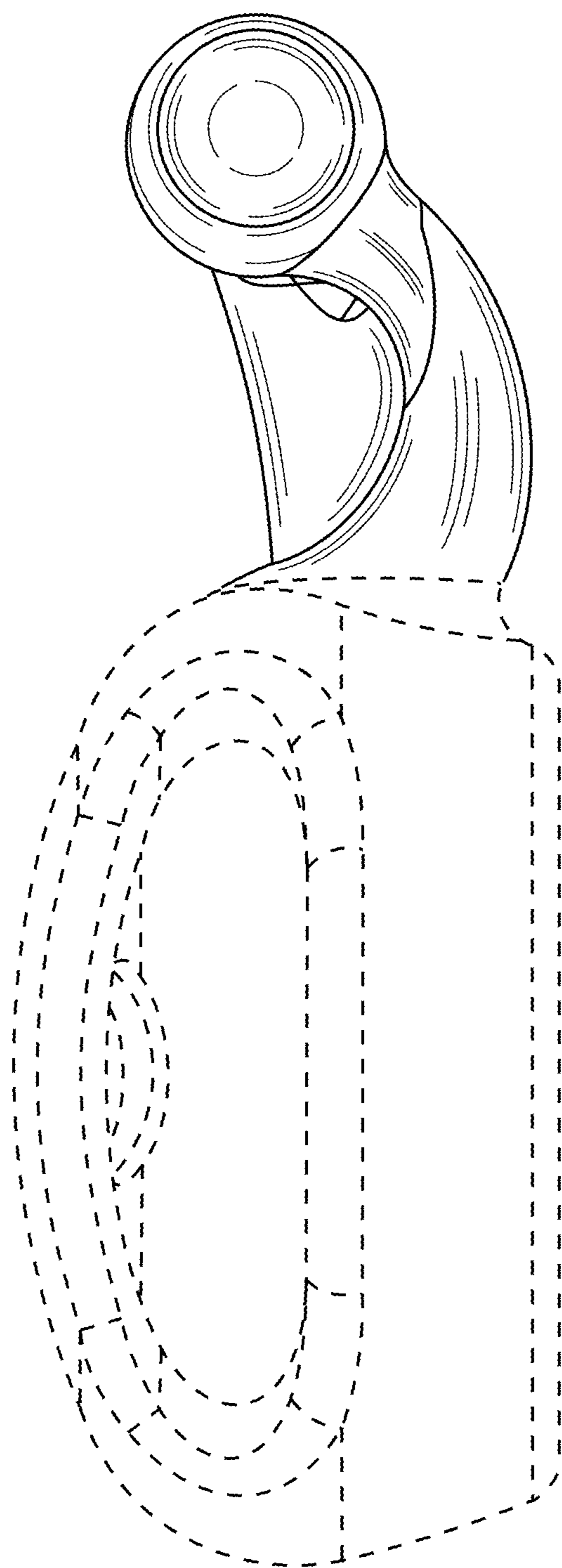

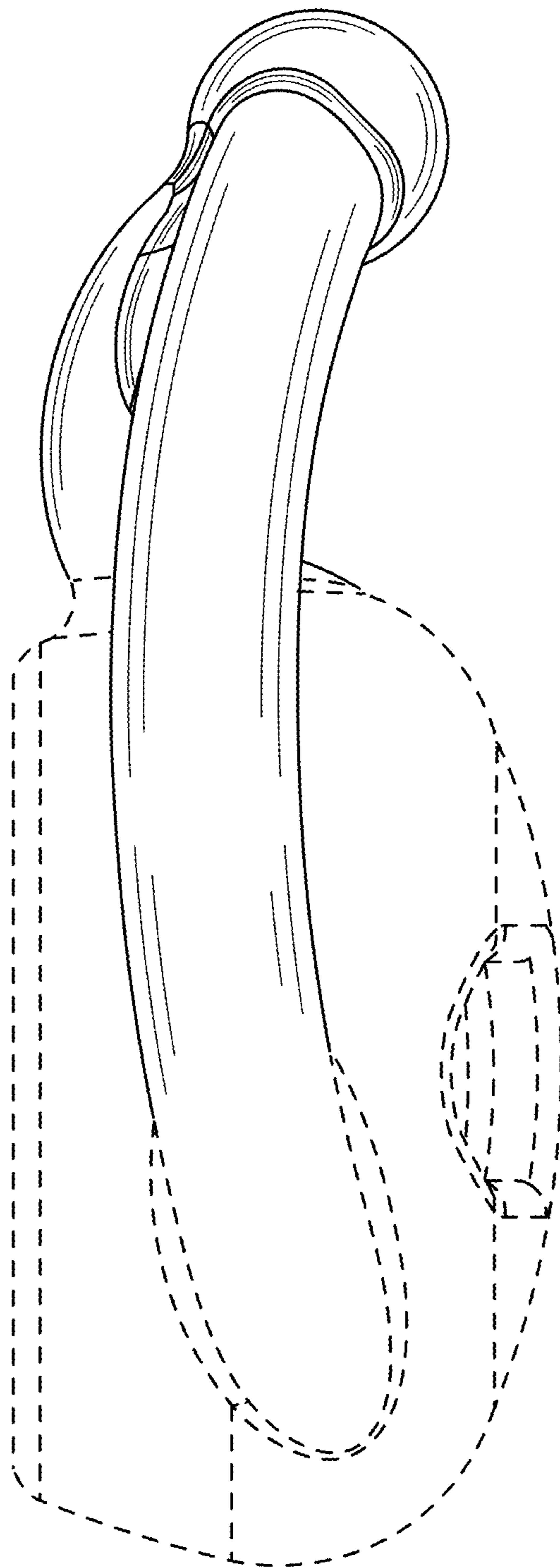

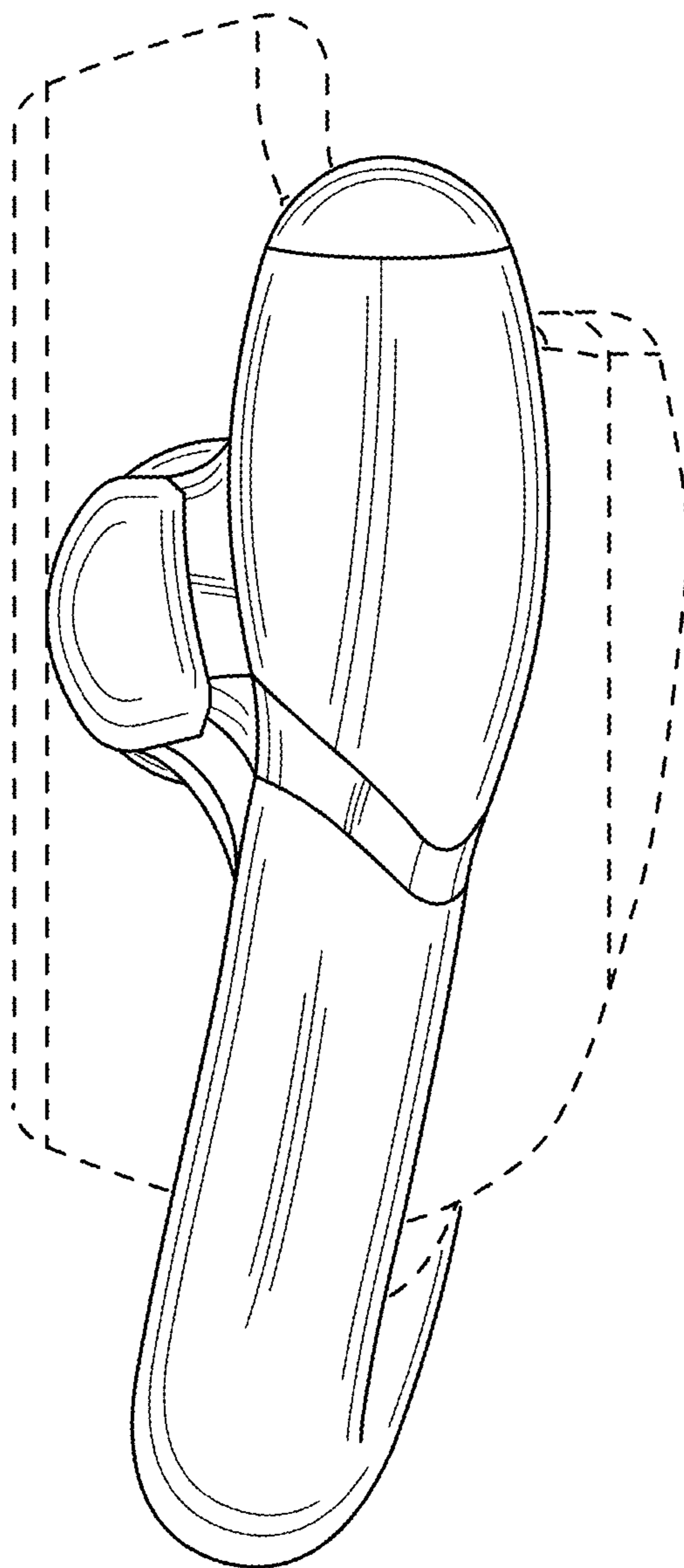

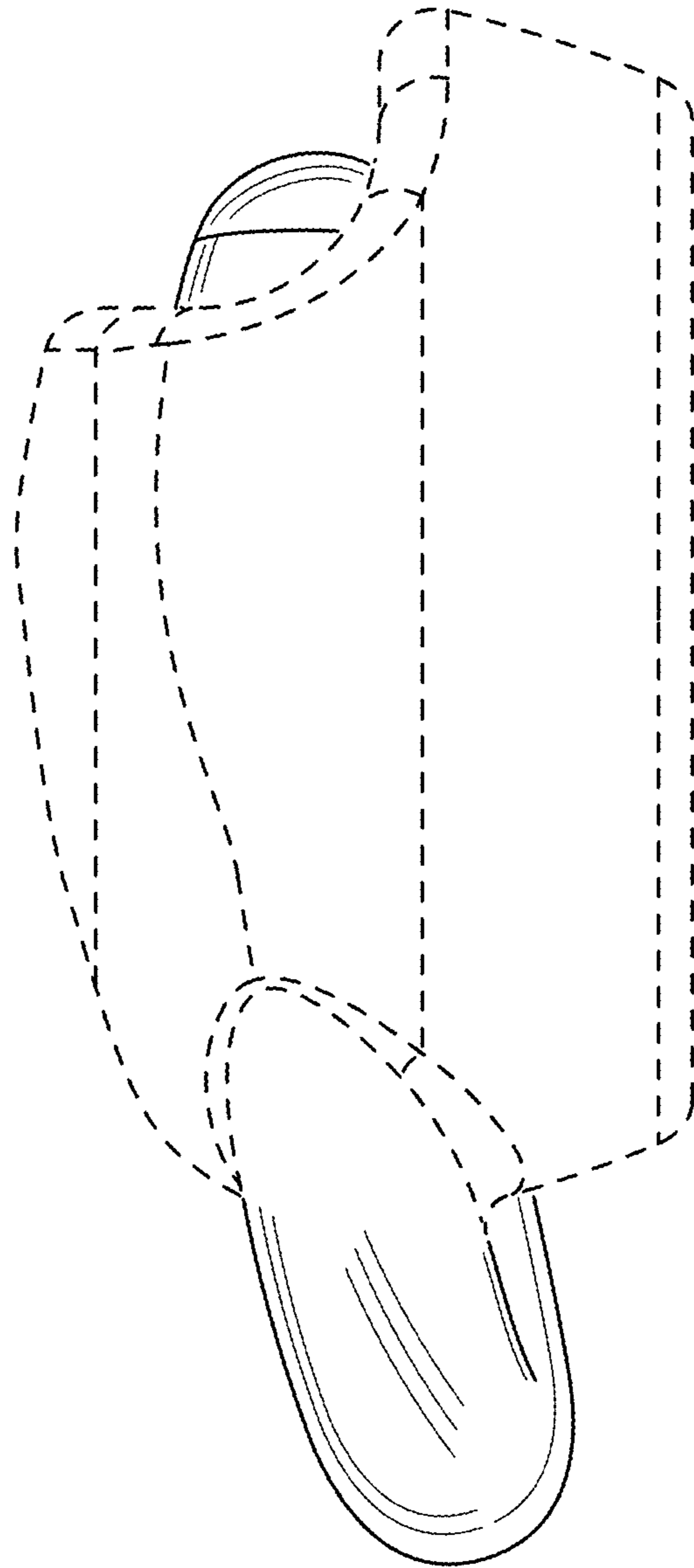

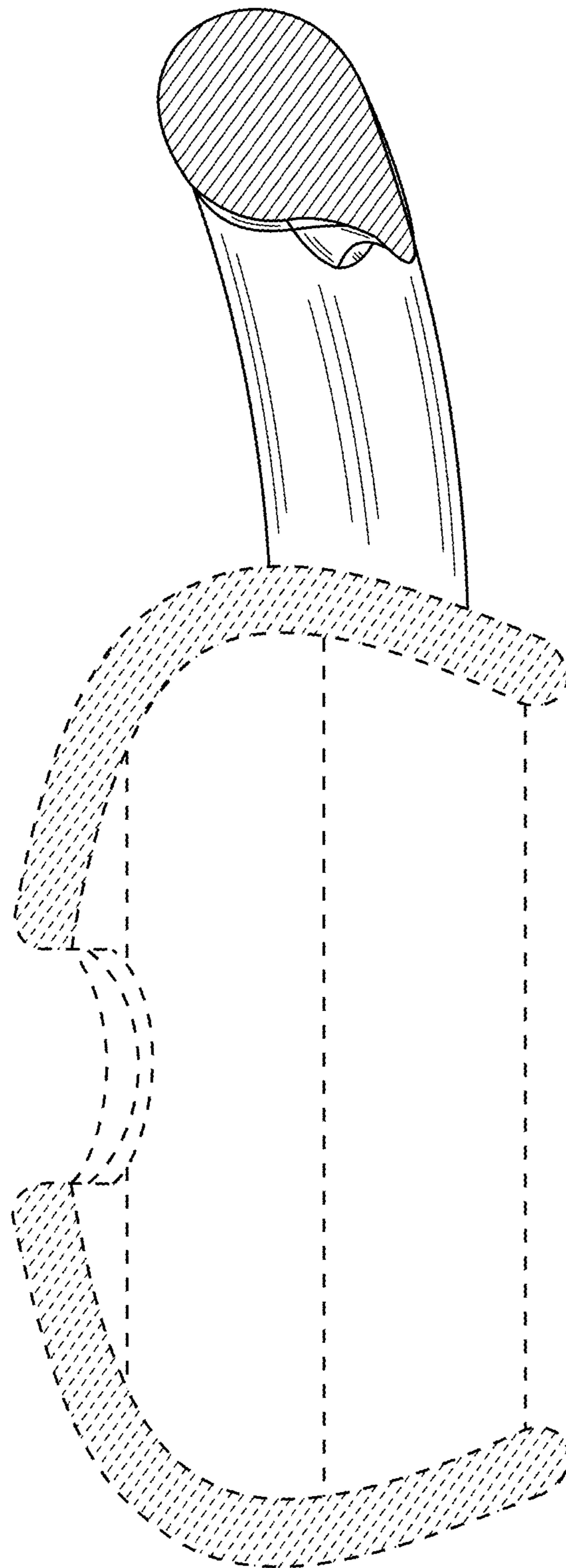

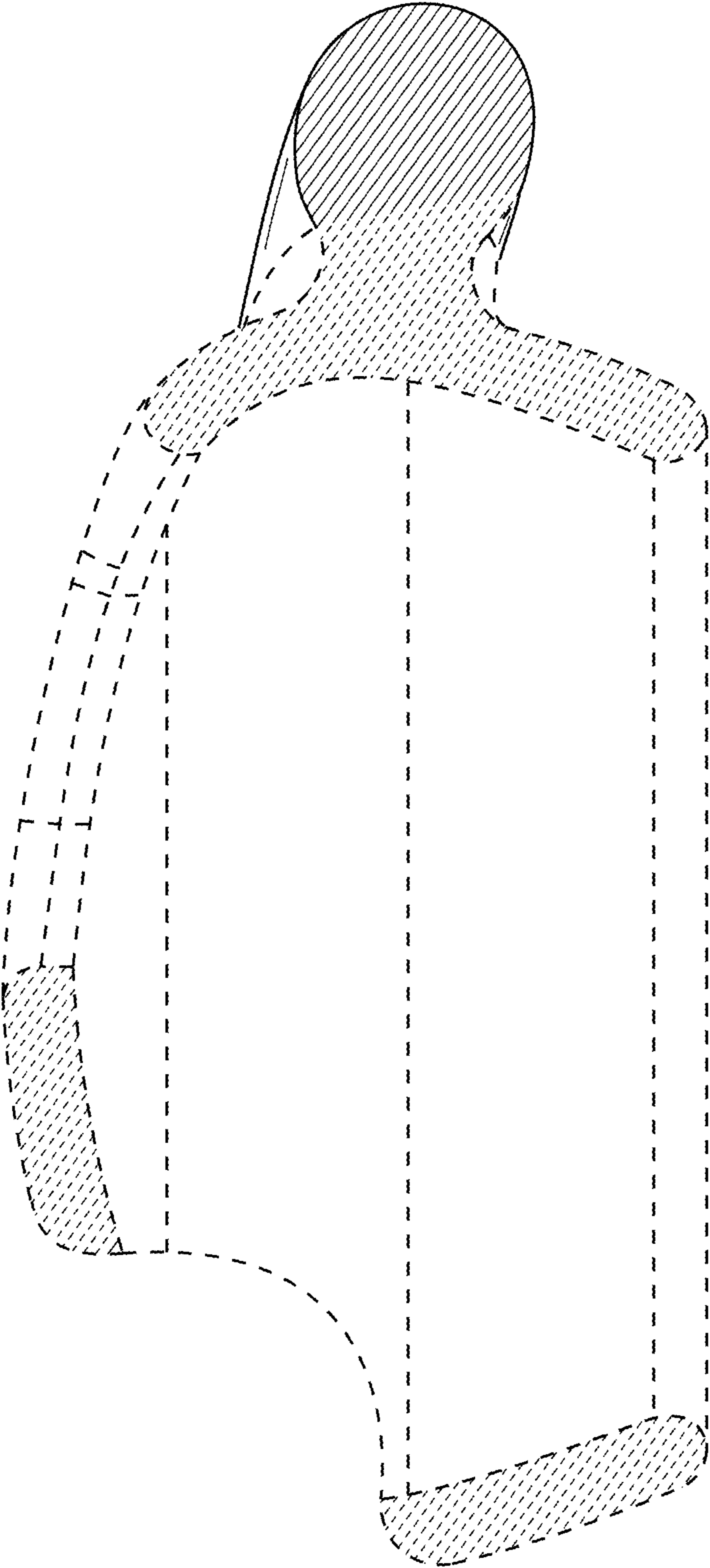

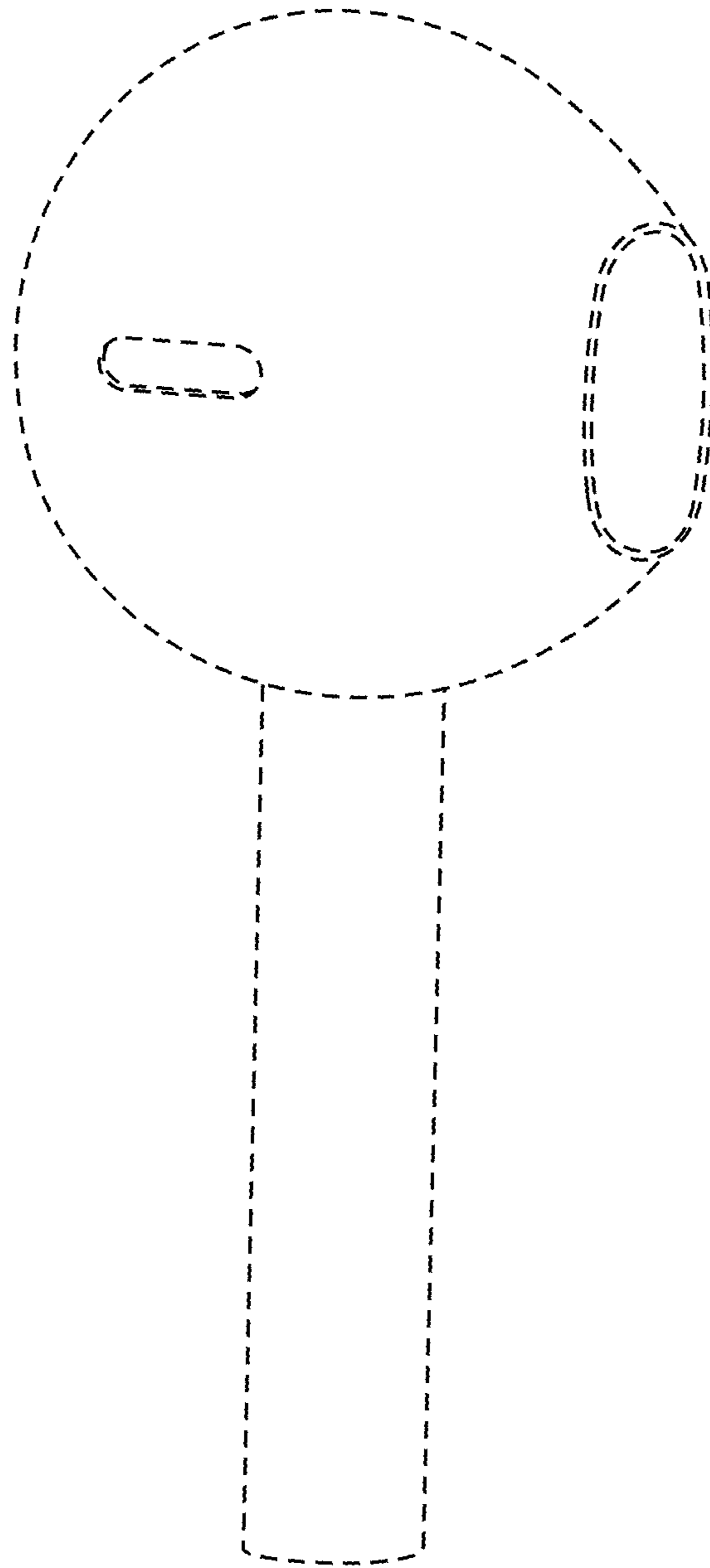

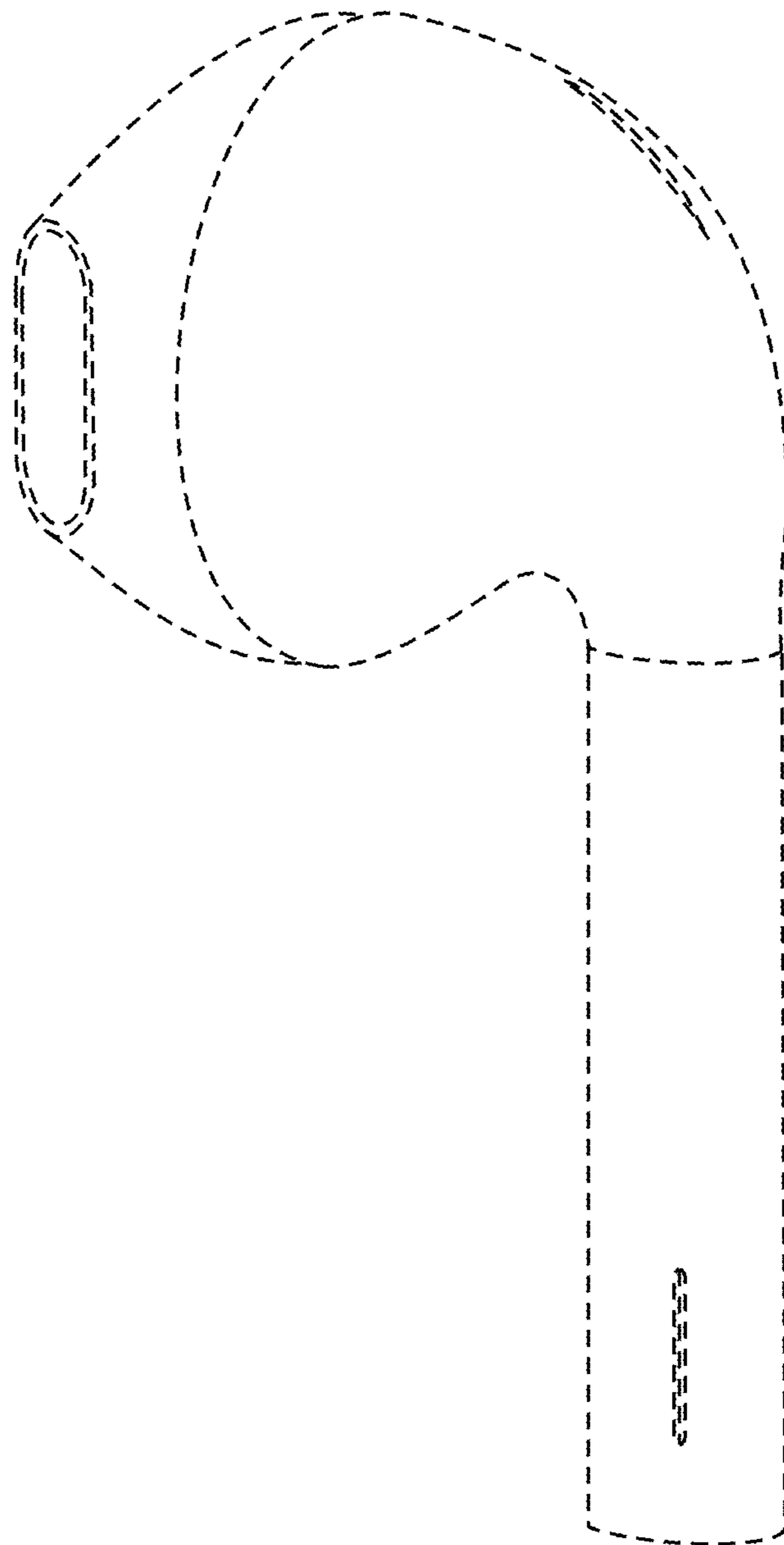

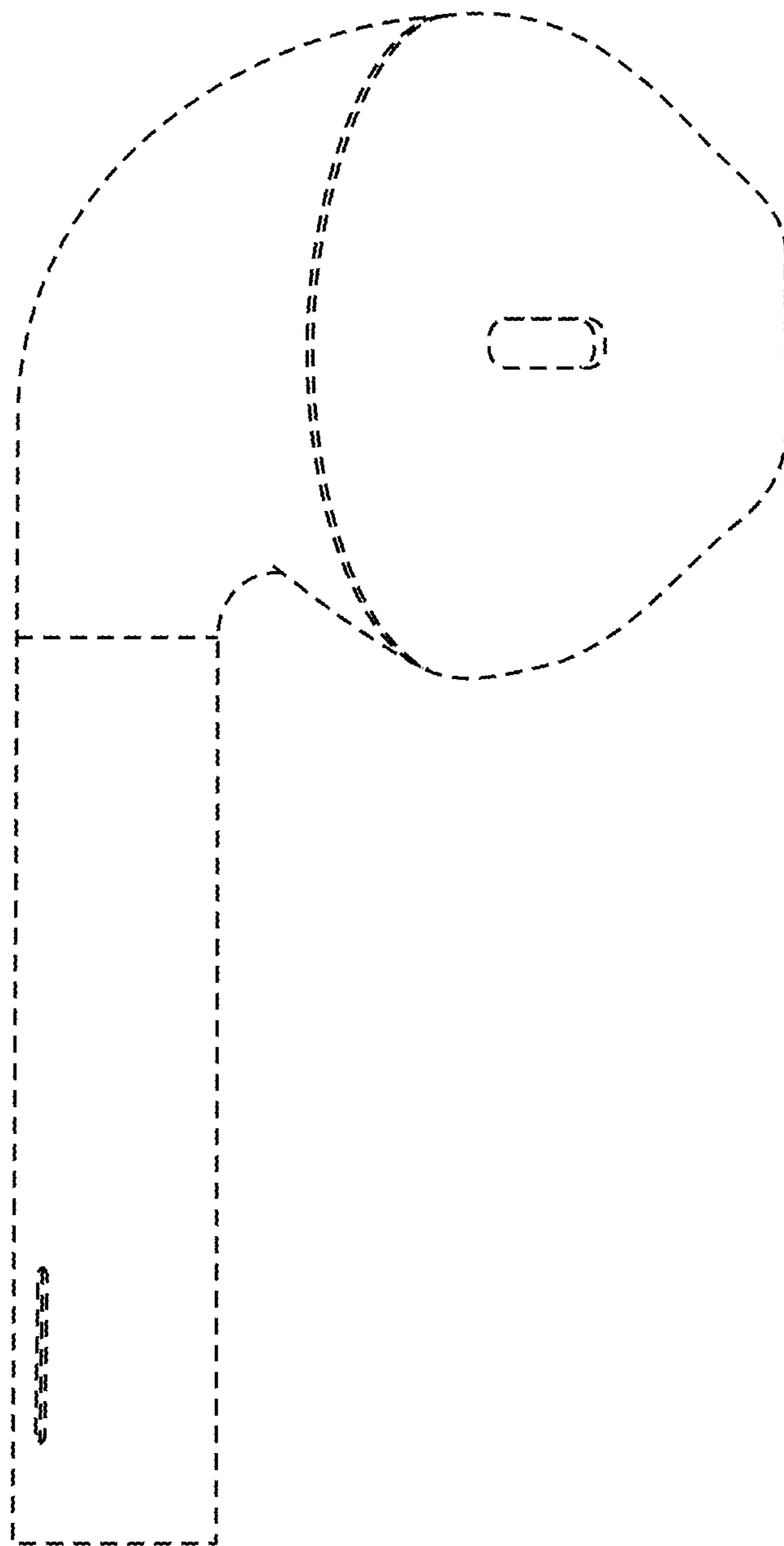

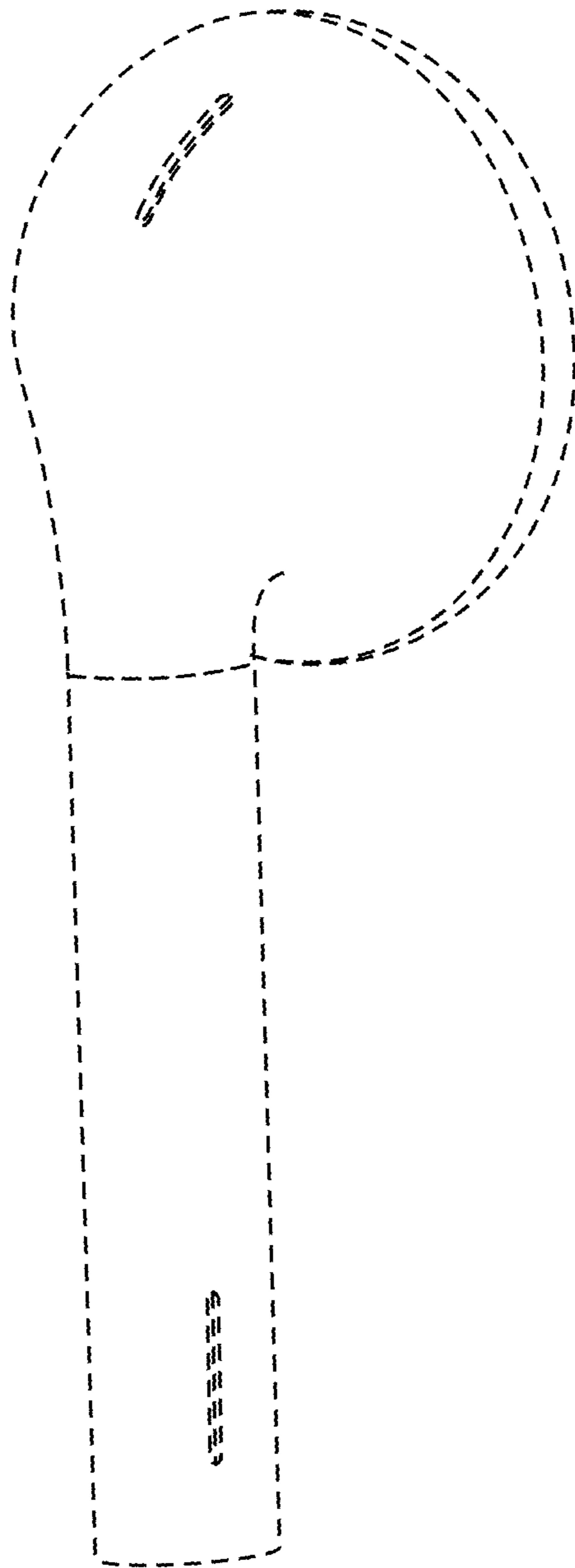

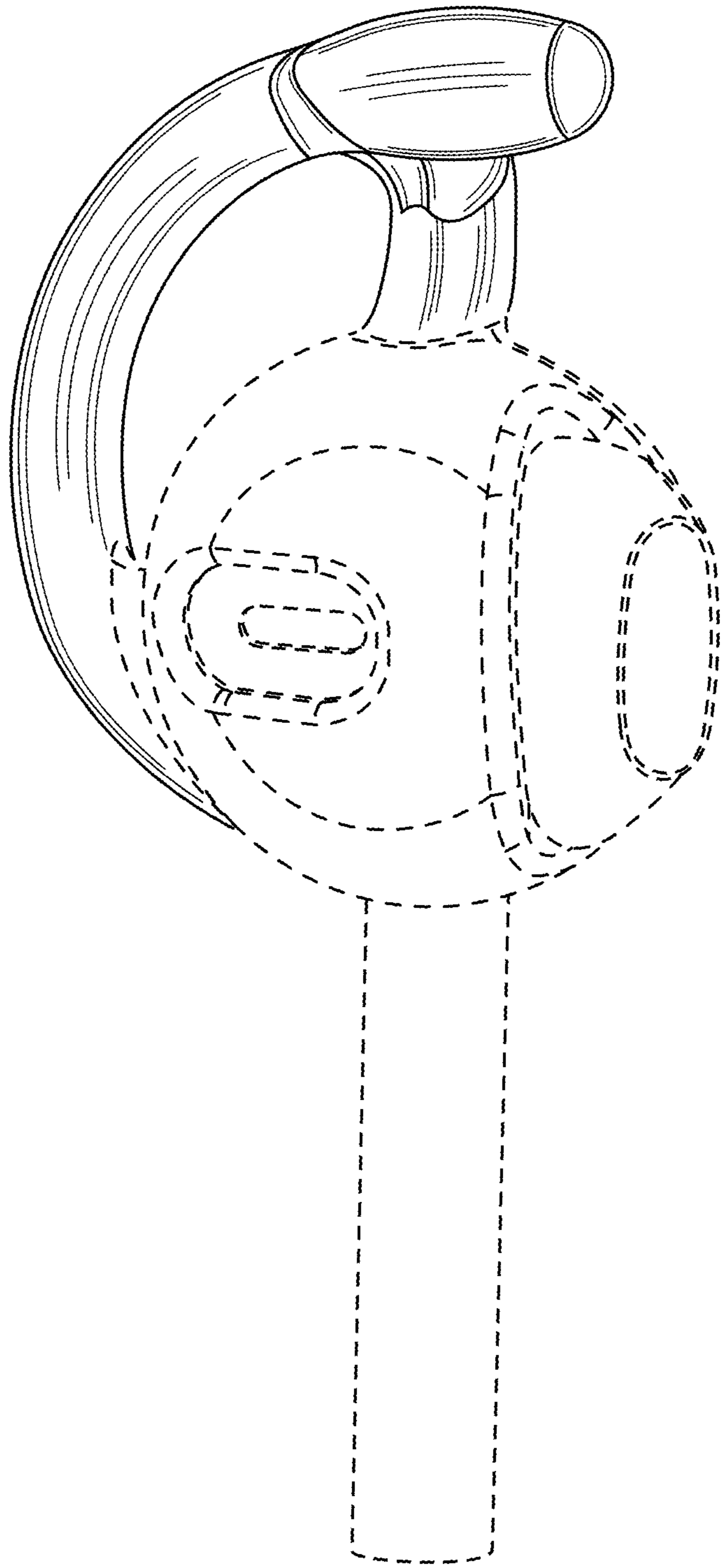

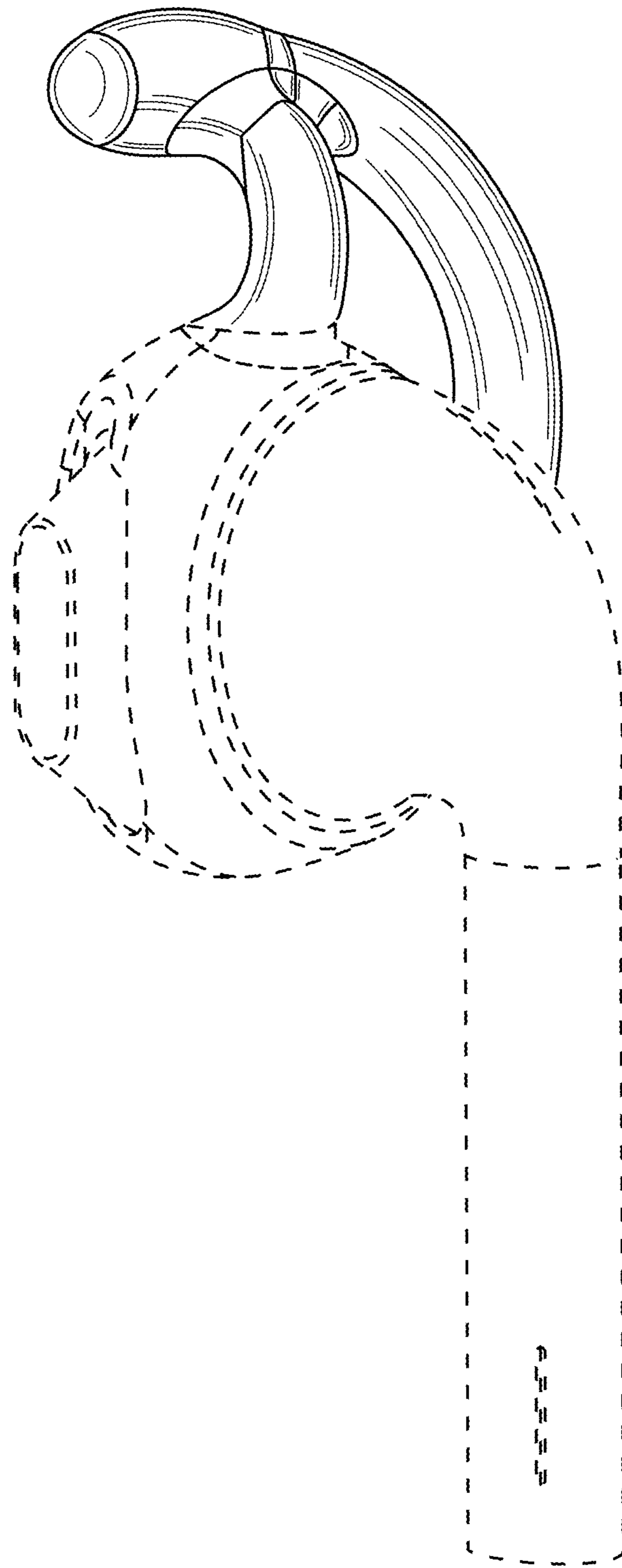

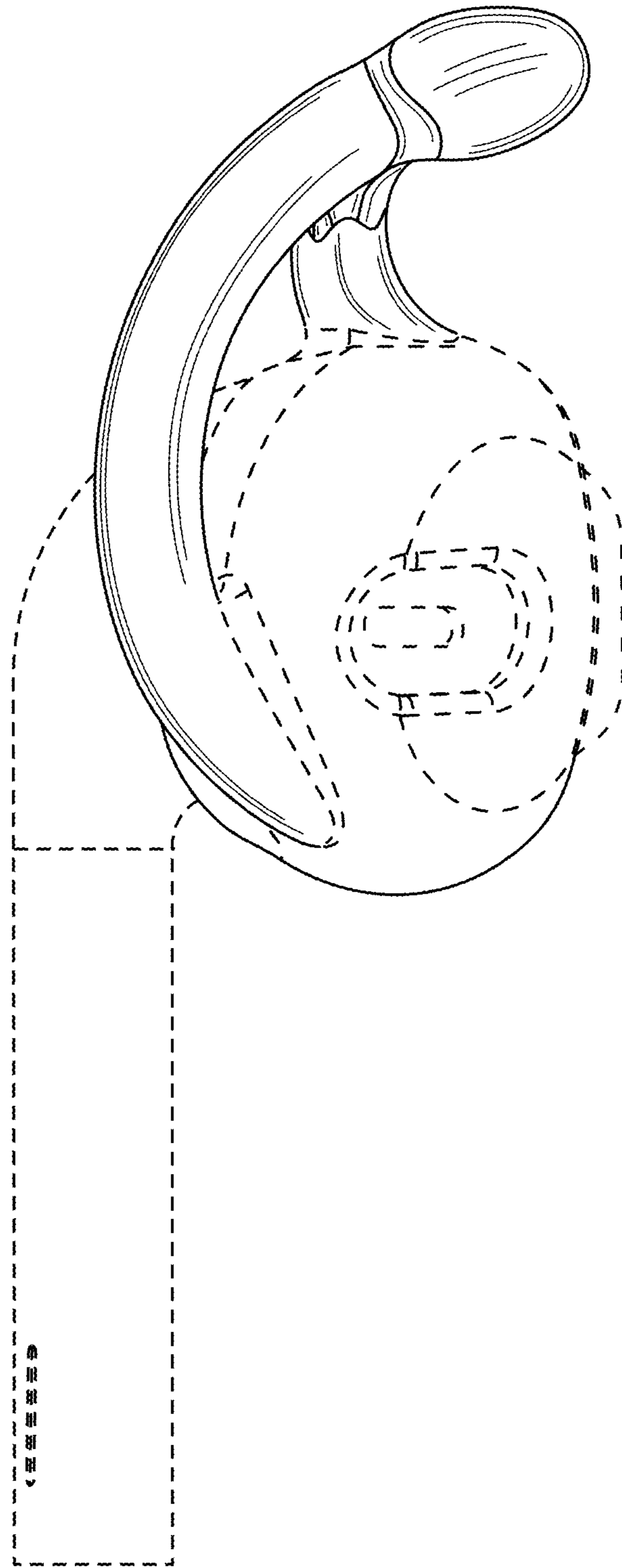

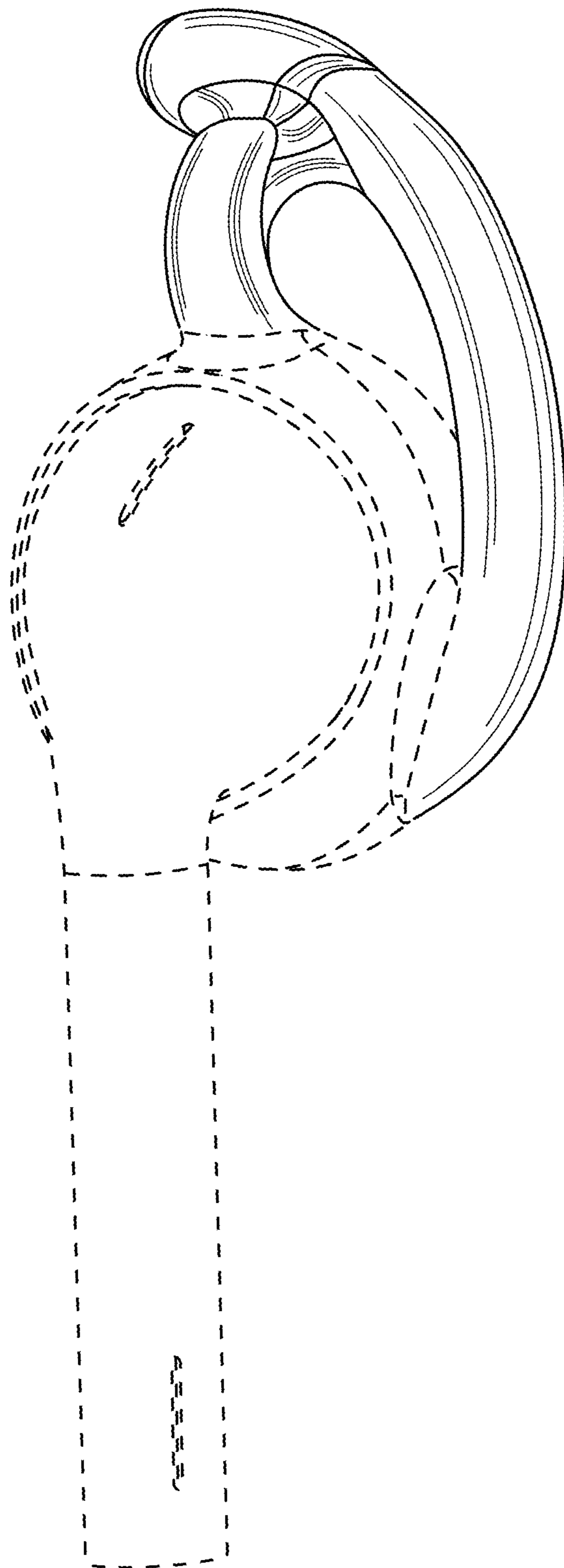
