FIG. 7 is the rear view thereof;

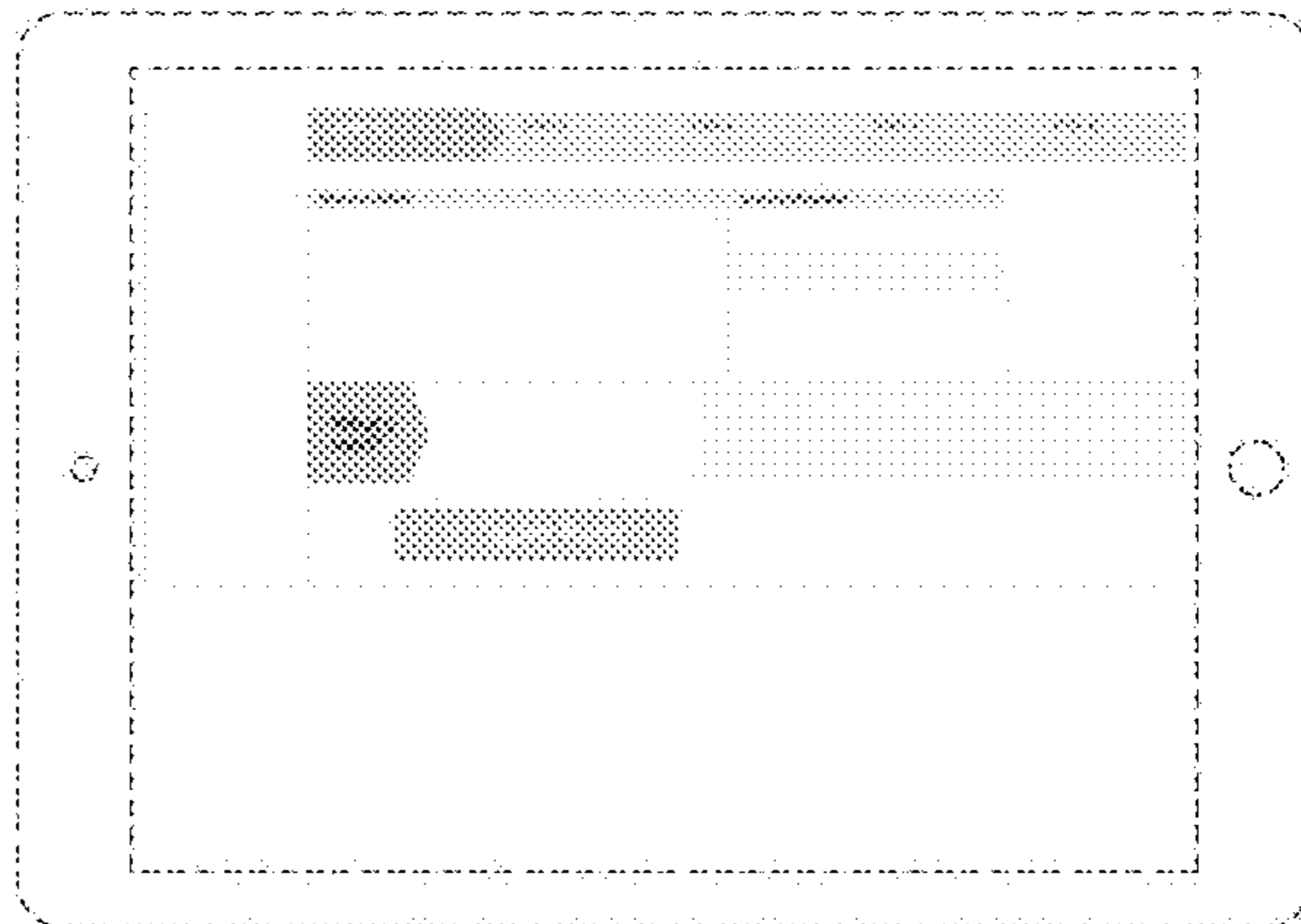
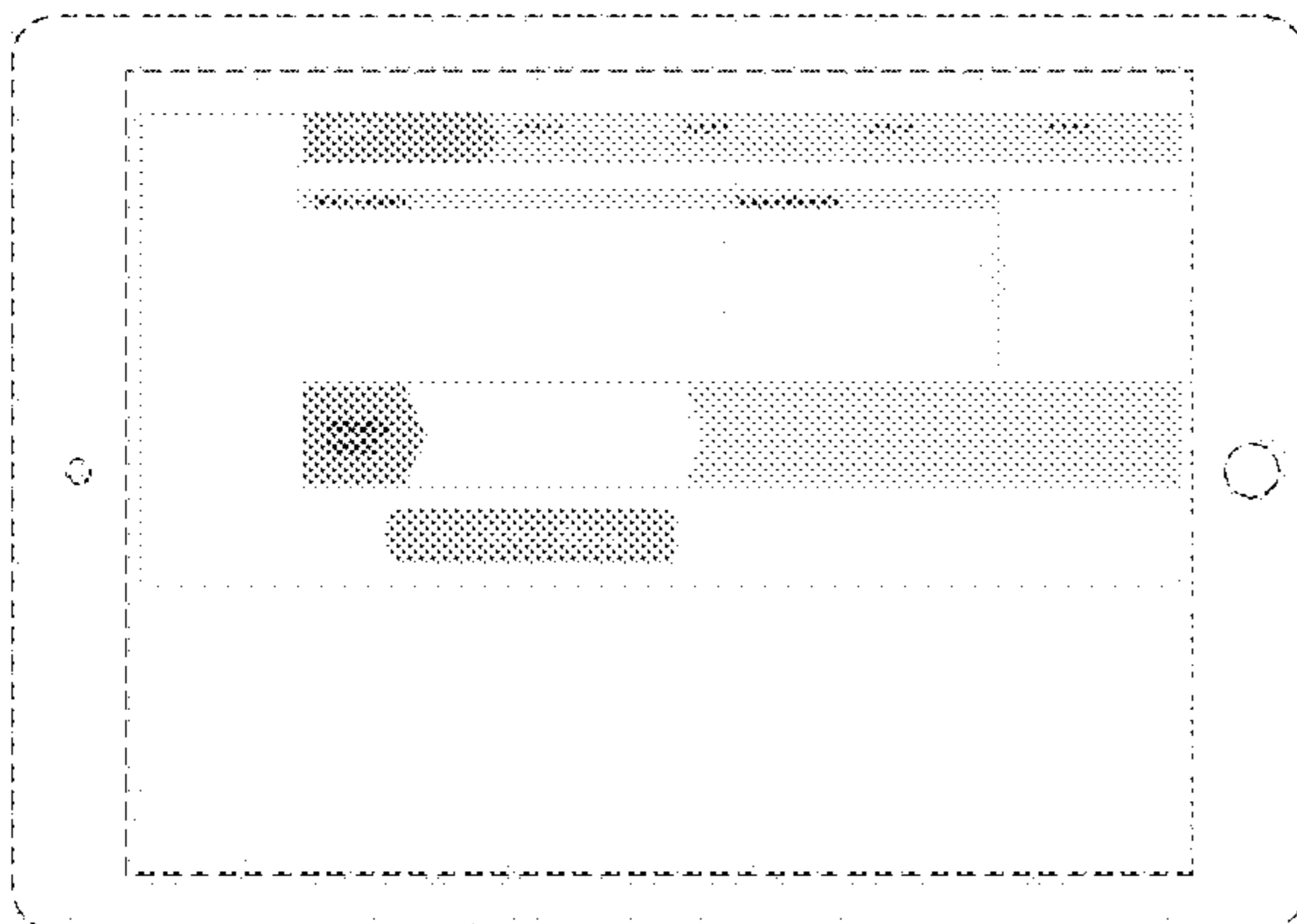
FIG. 8 is the left side view thereof; and,

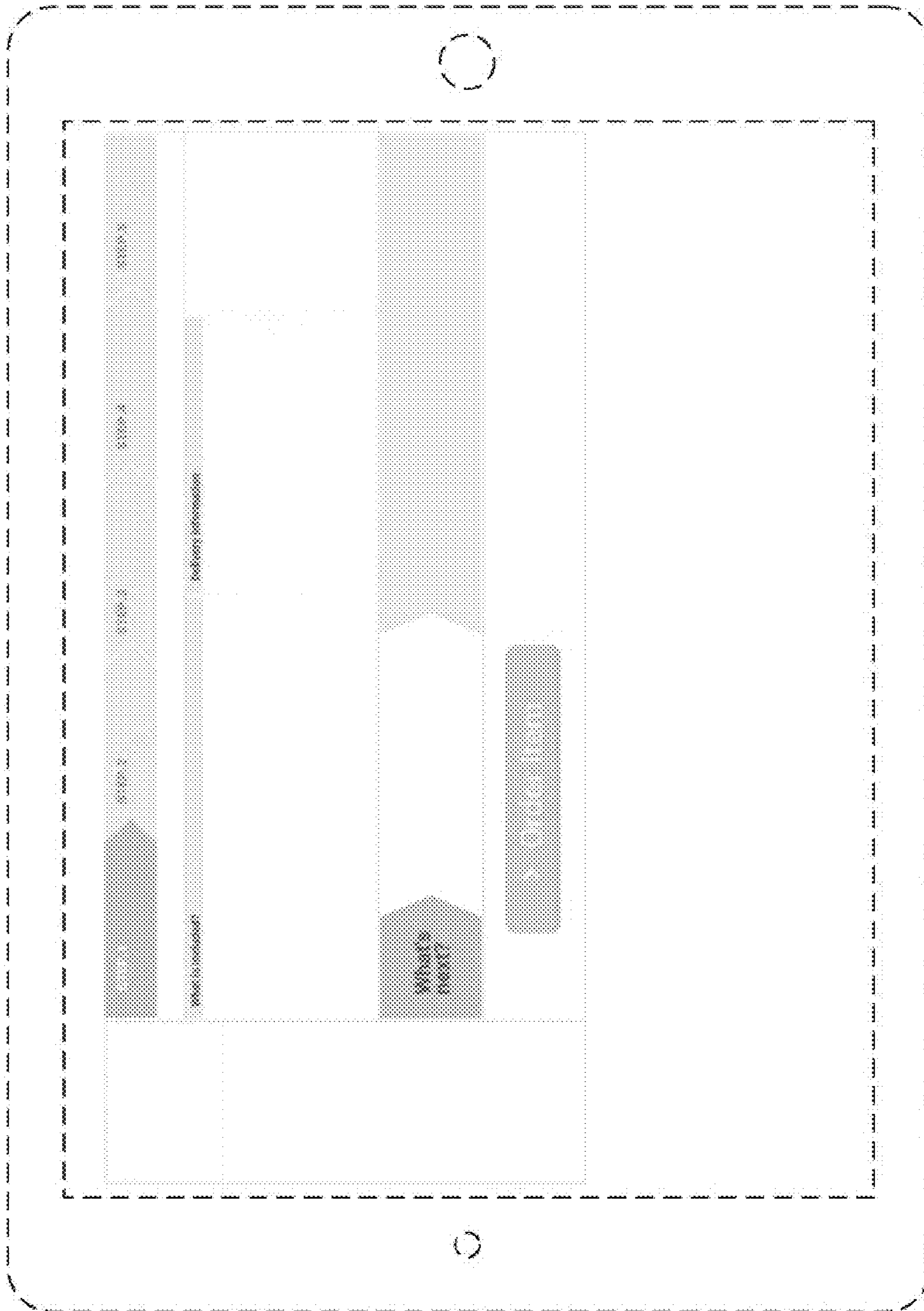

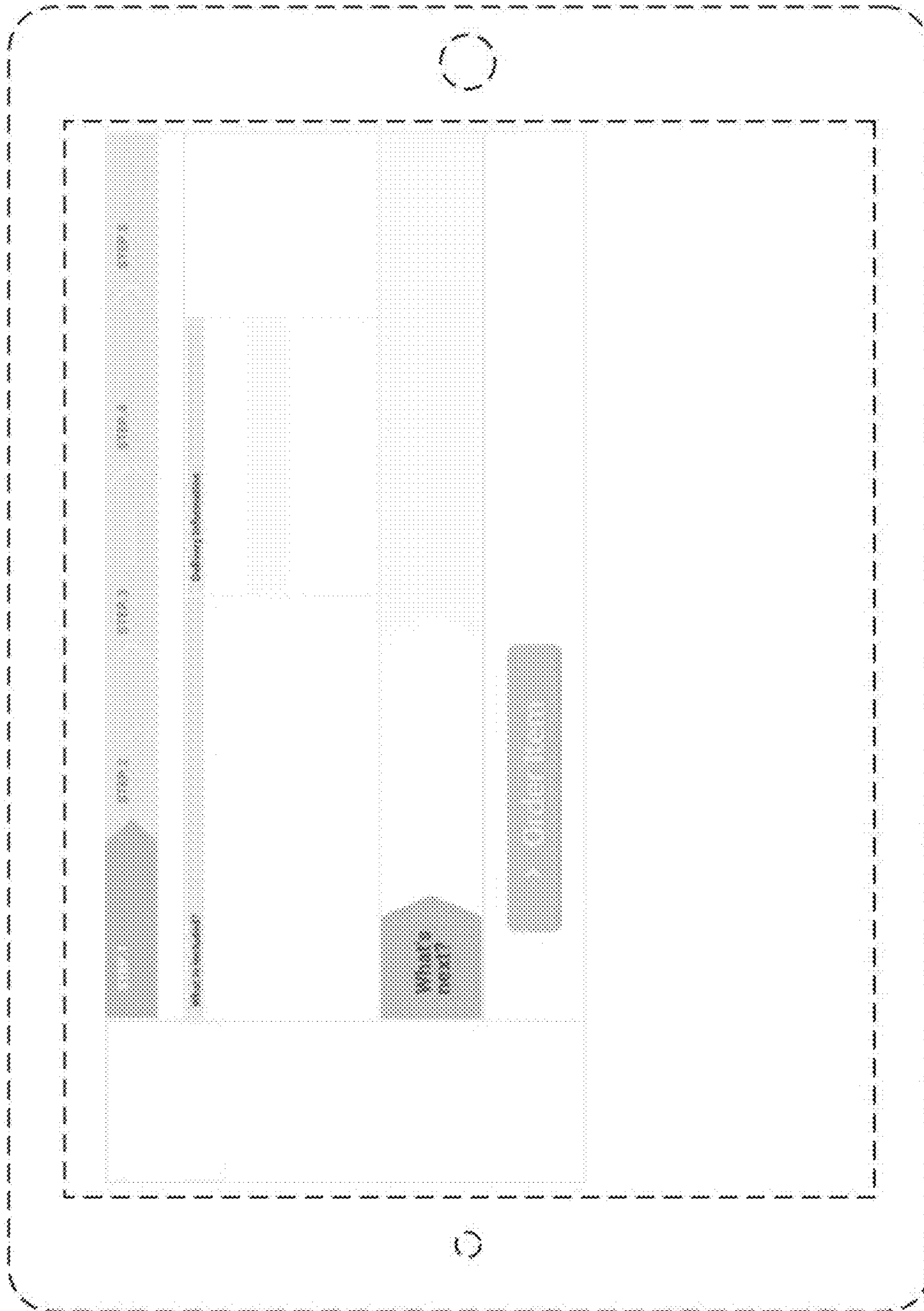

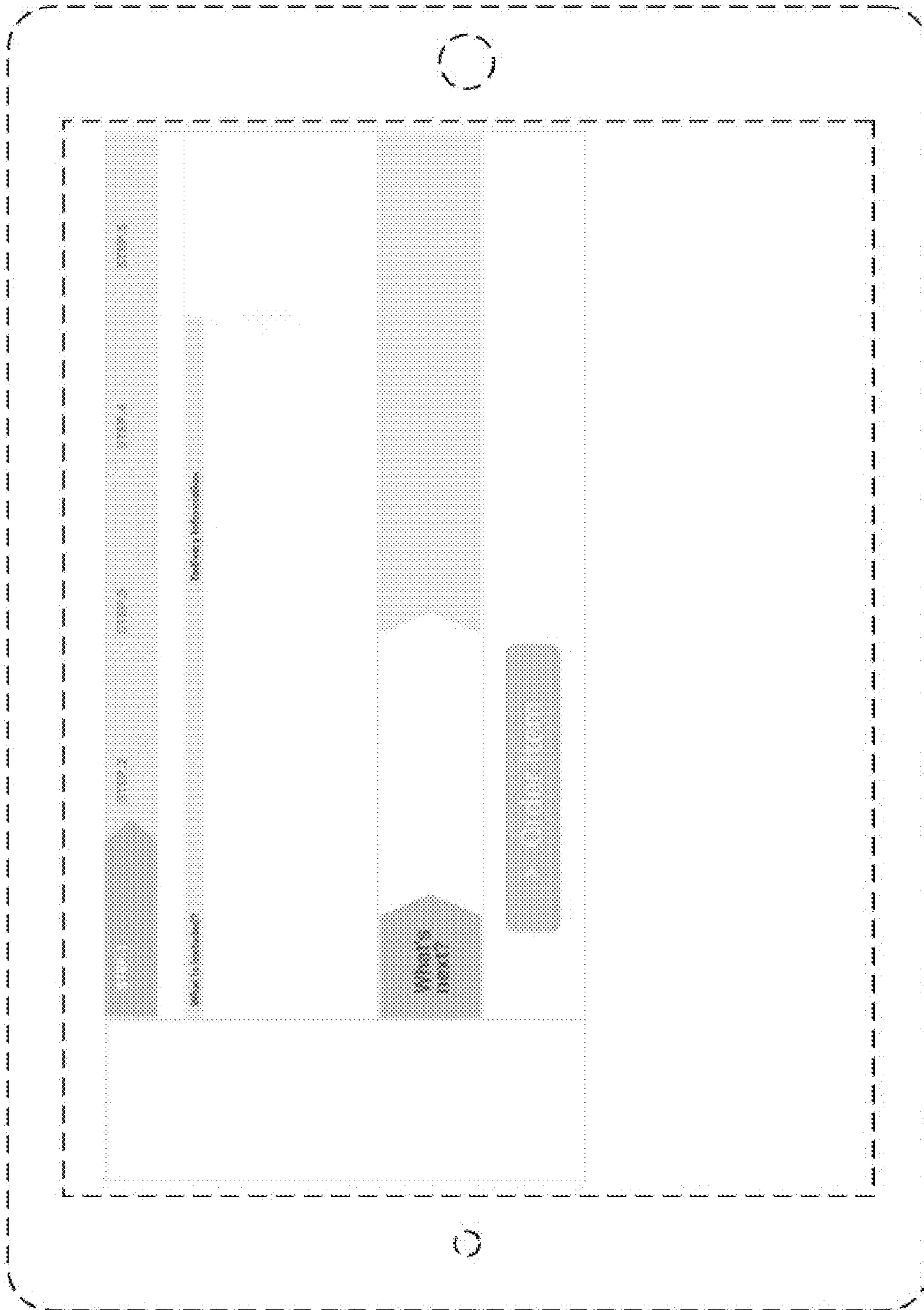

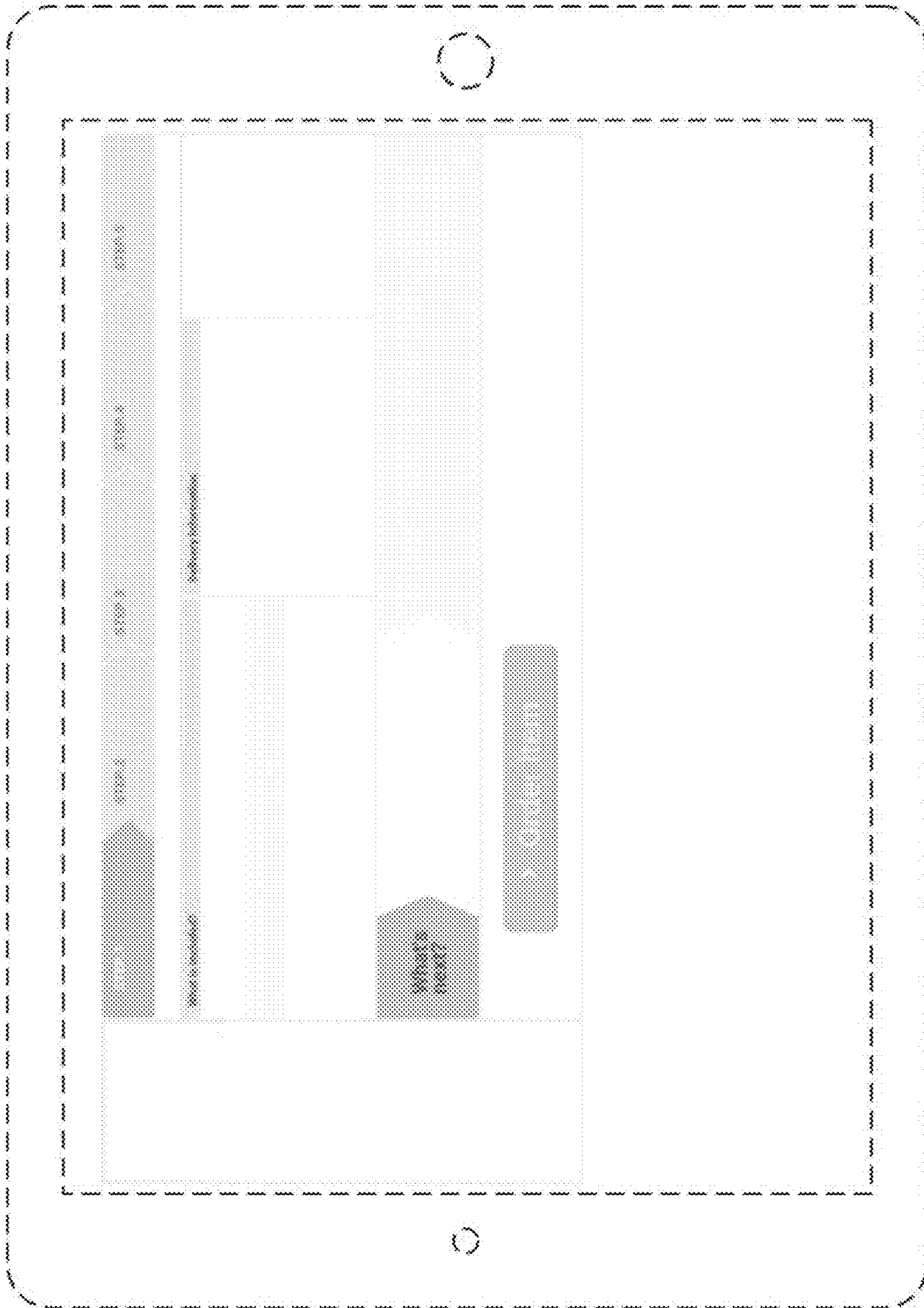

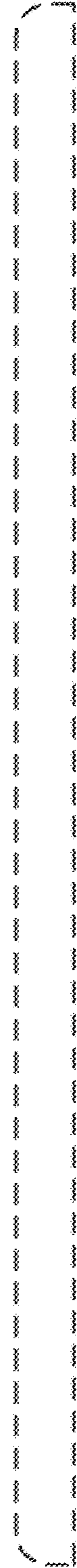

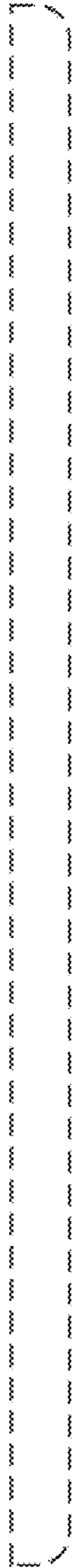
