DESCRIPTION

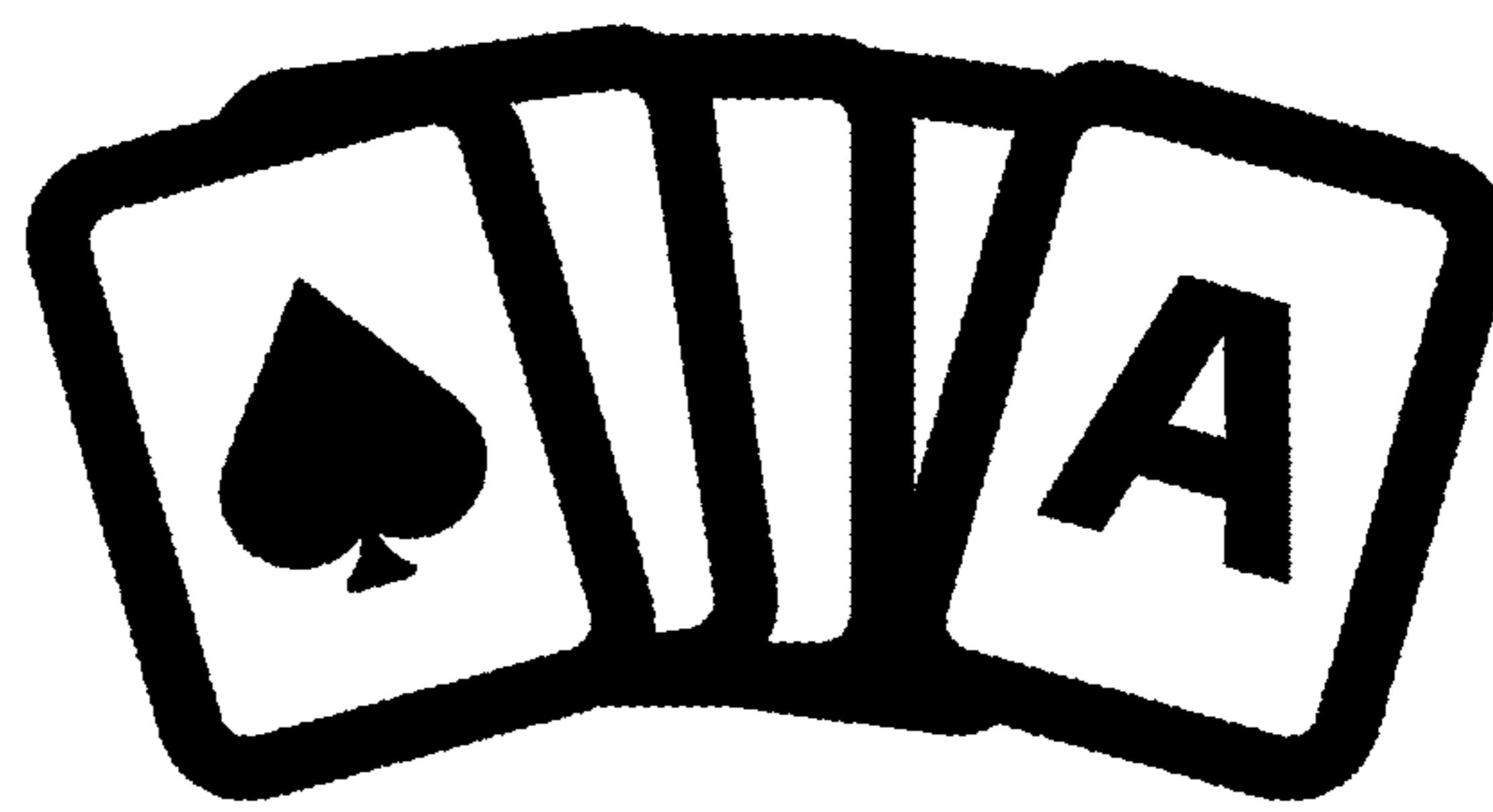
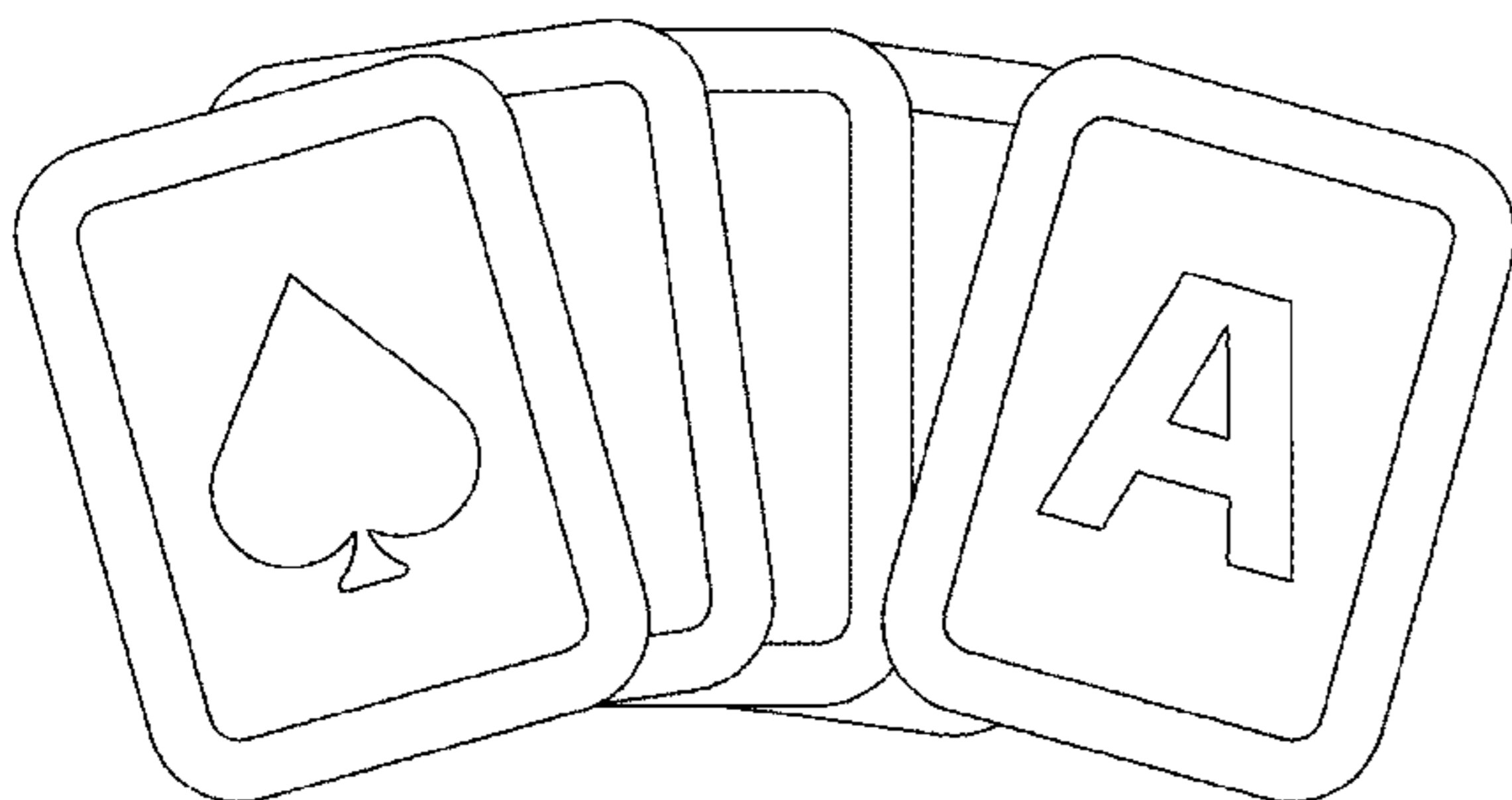
FIG. 1 is a front view of the display screen or portion thereof with icon.

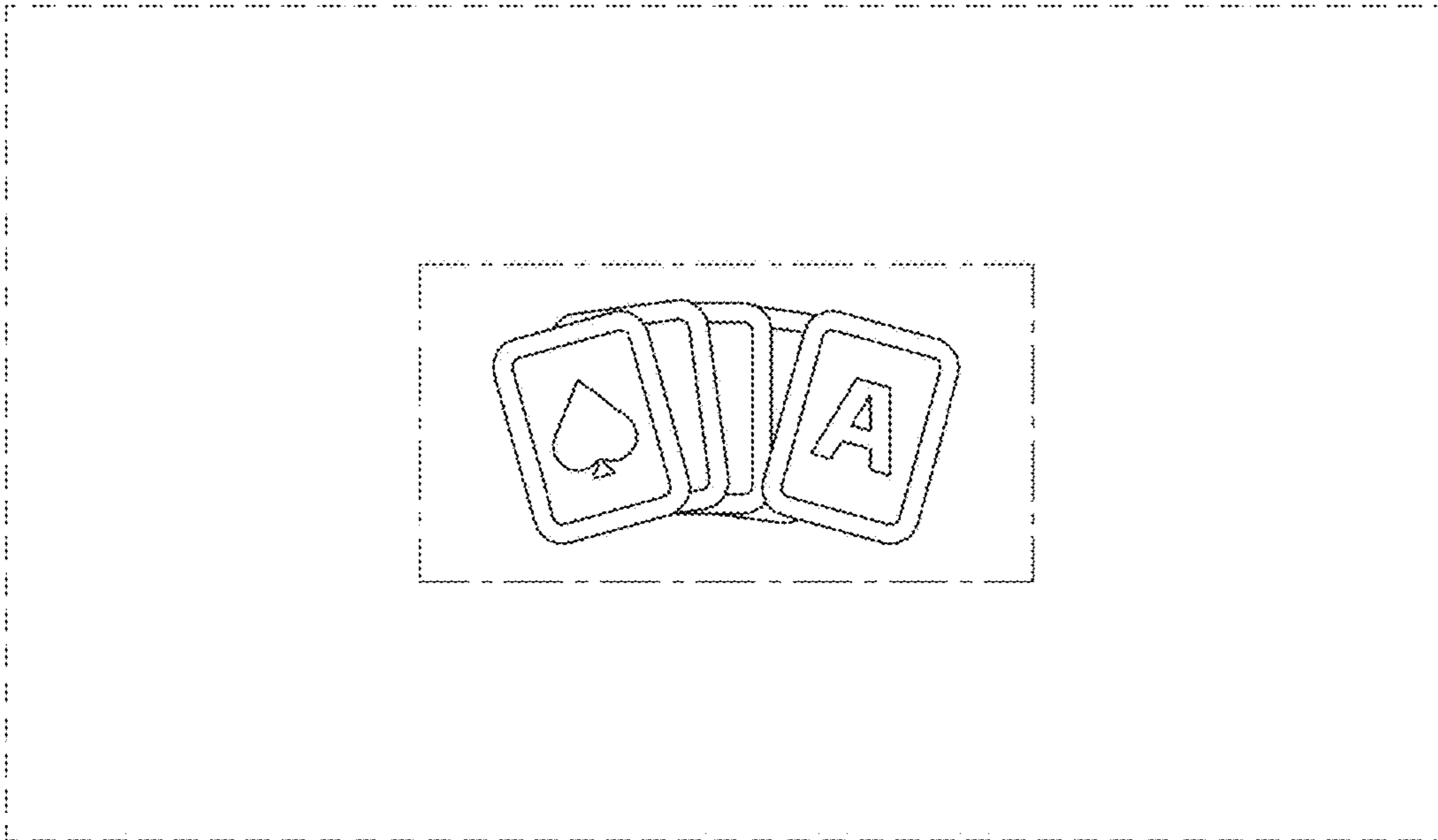

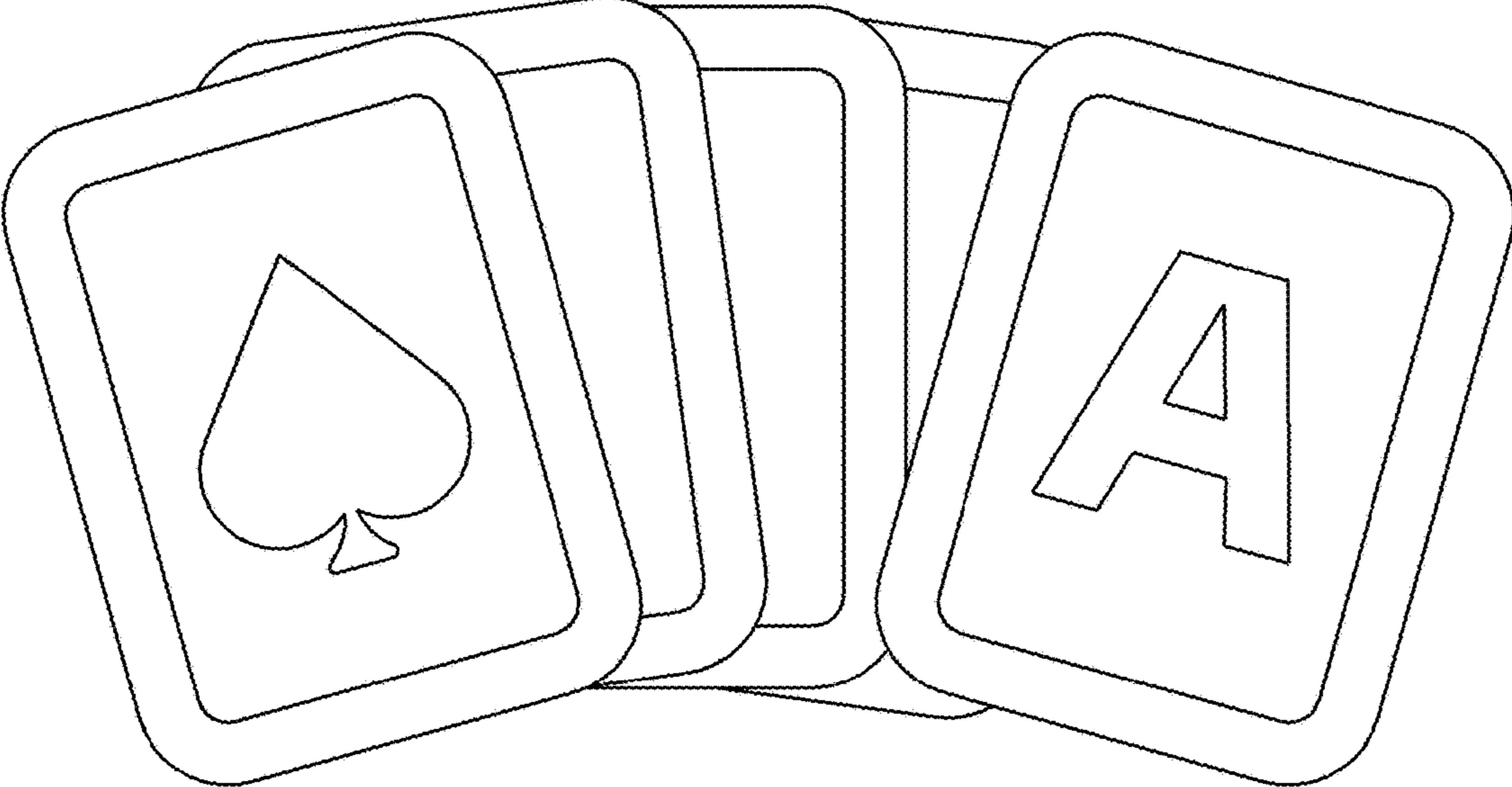
