DESCRIPTION

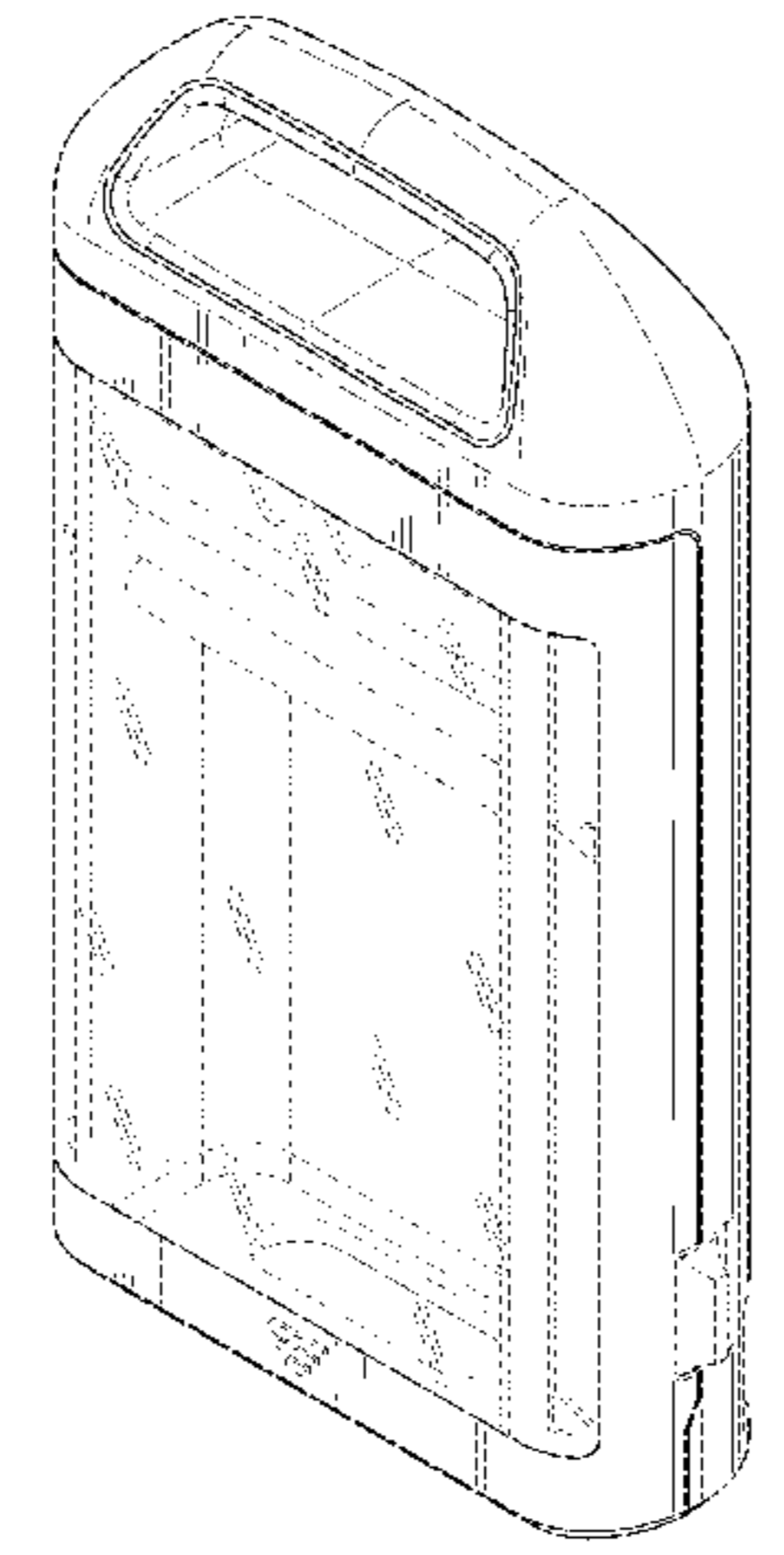

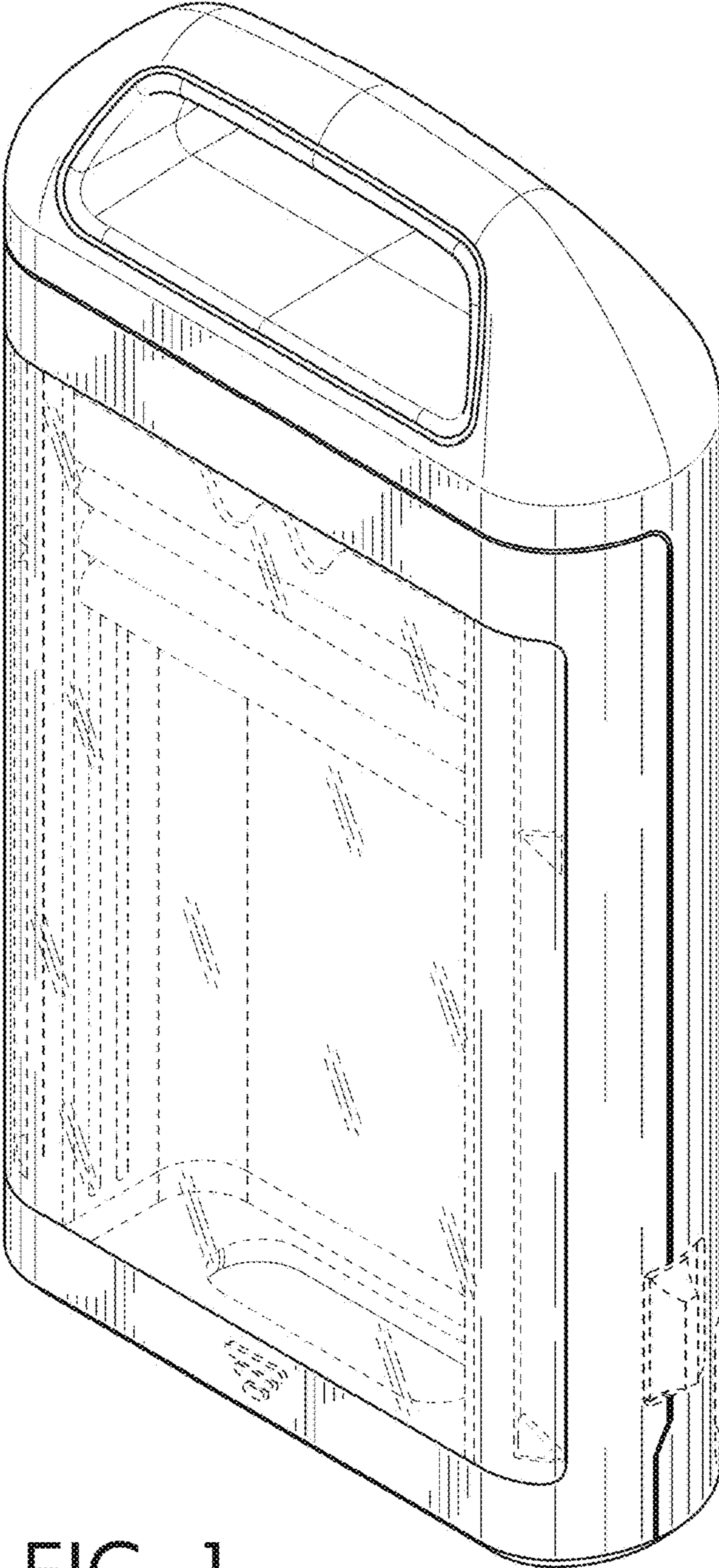

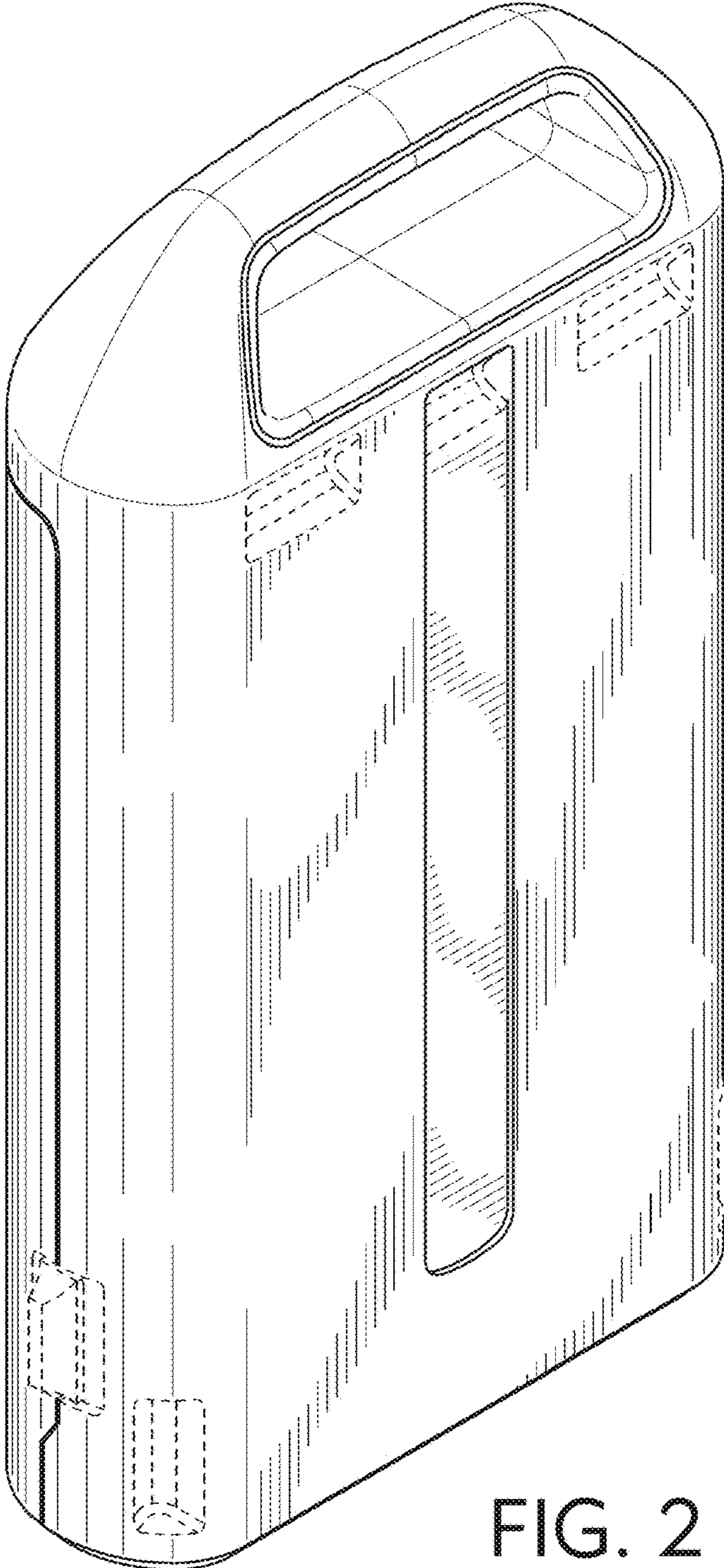

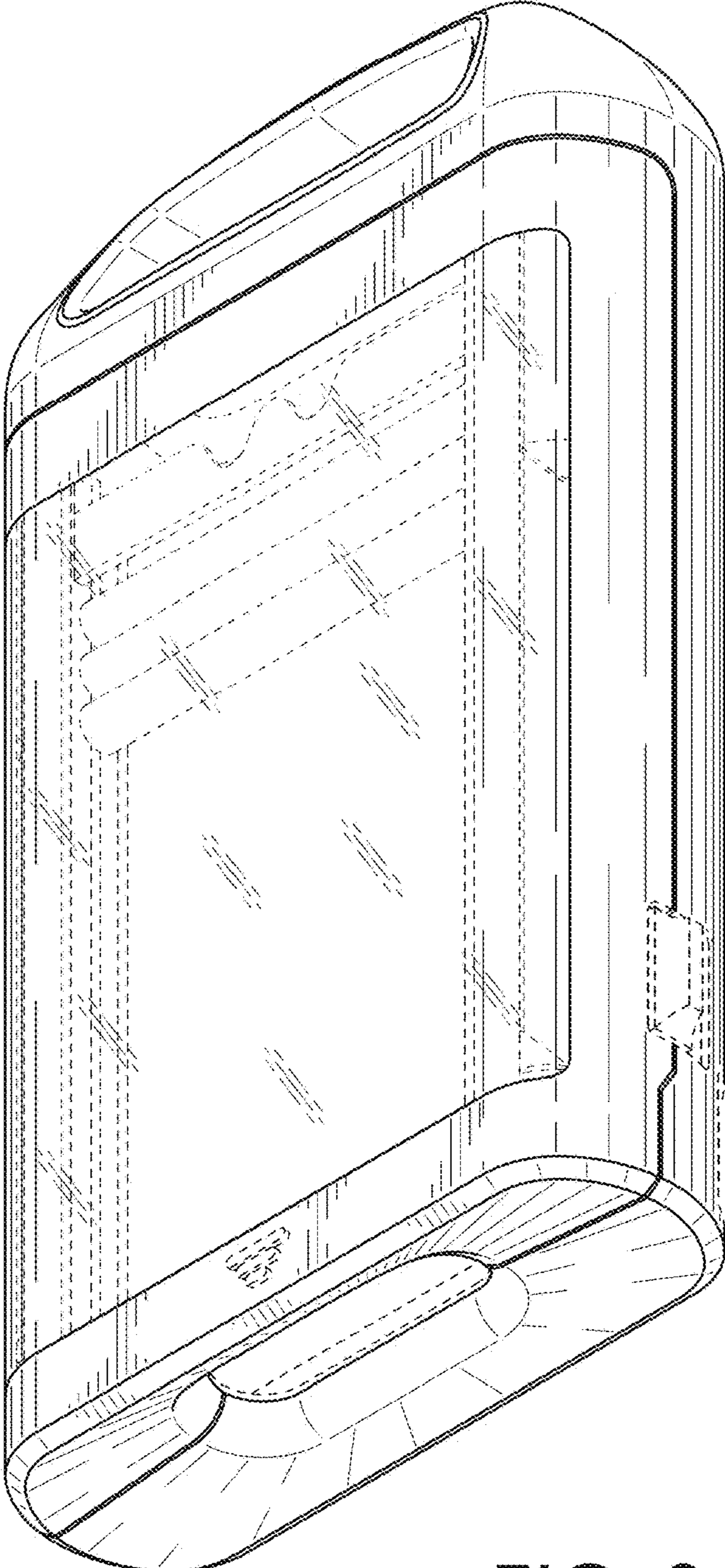

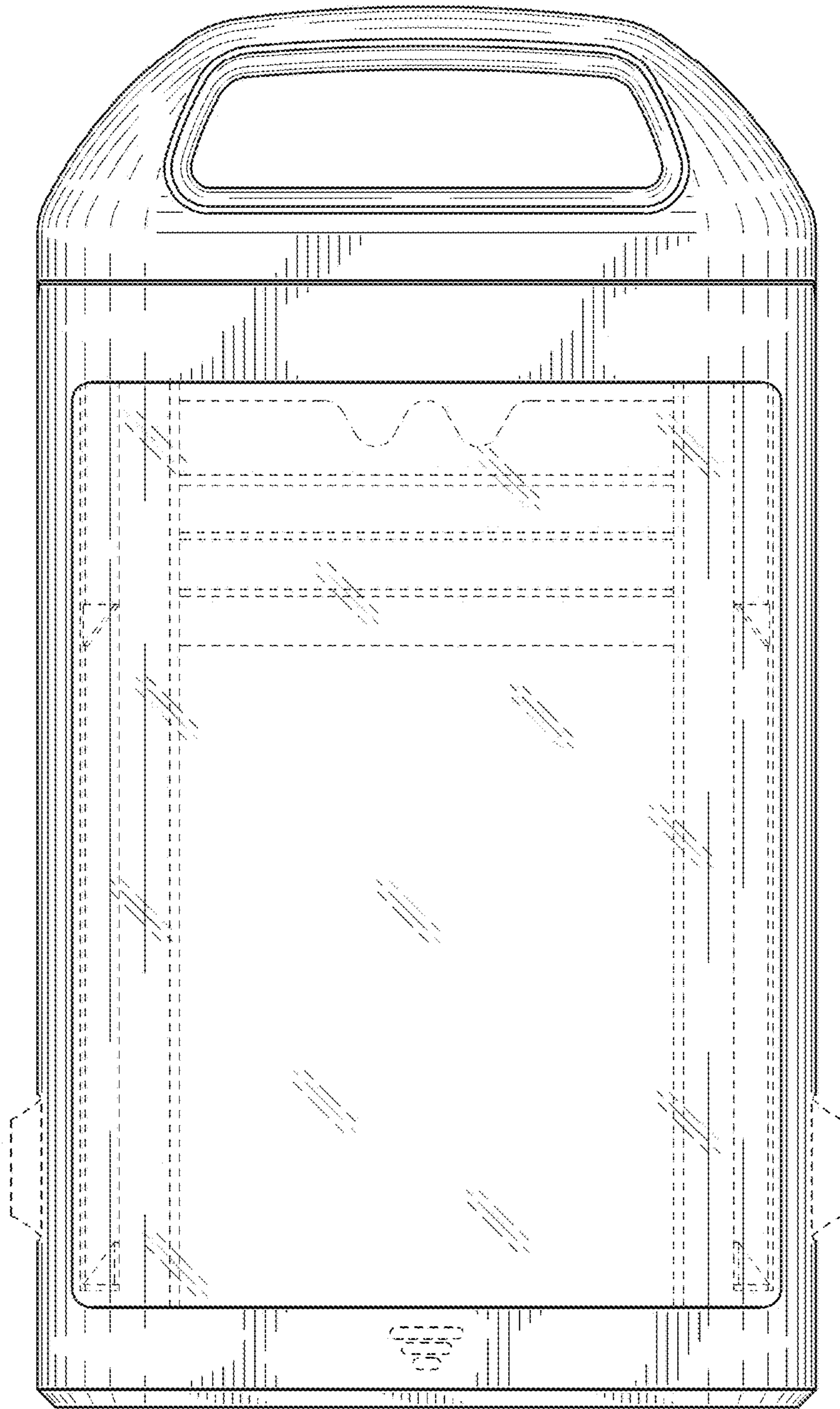

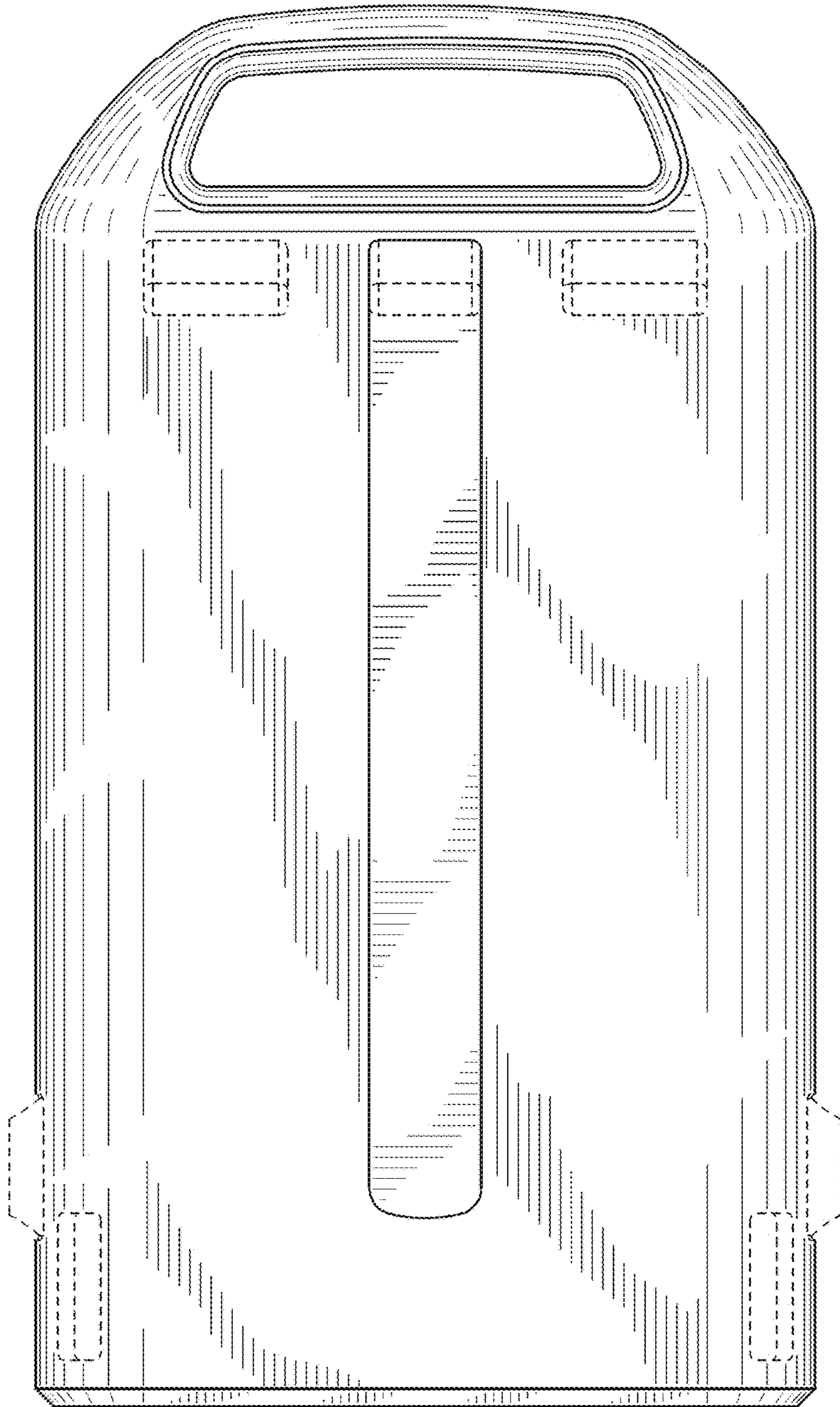

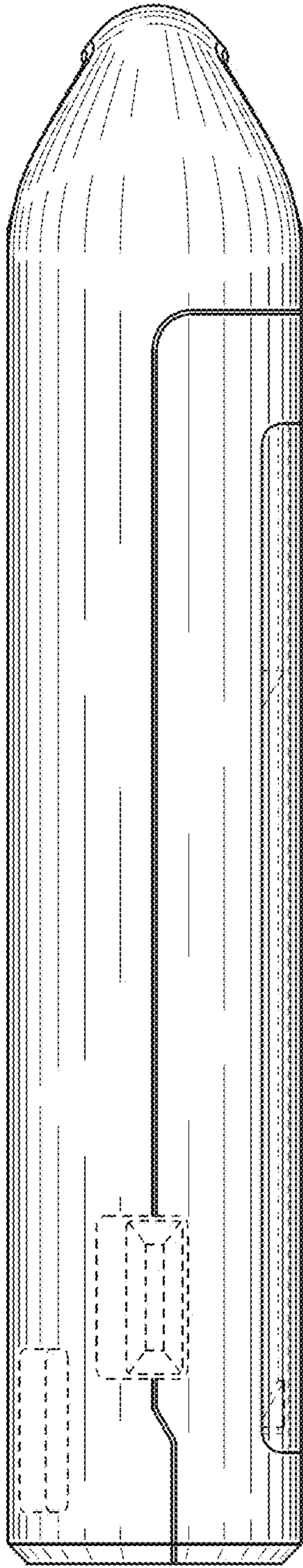

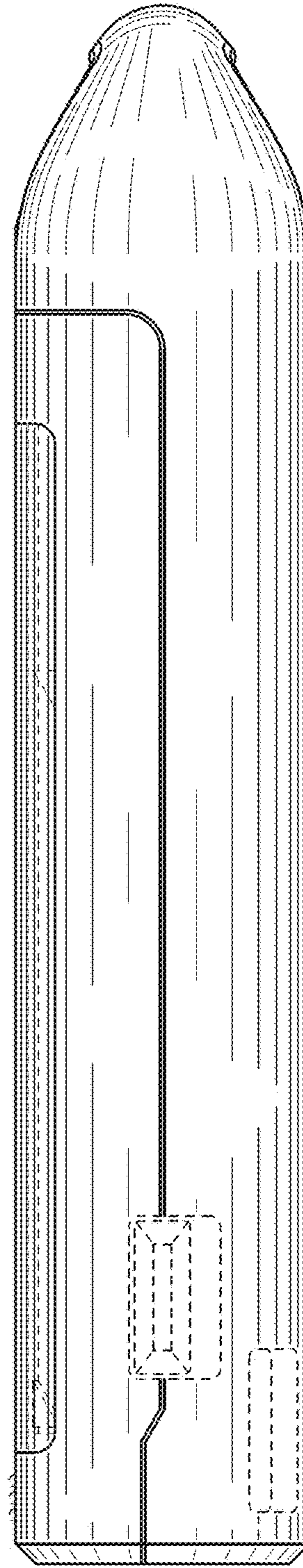

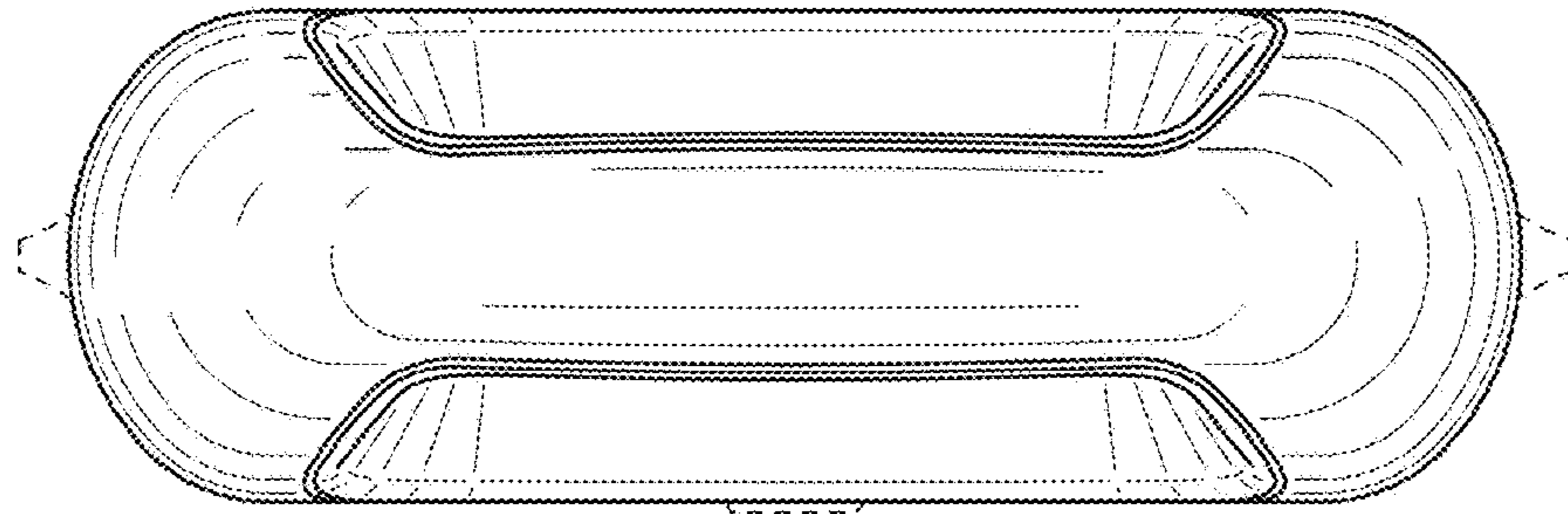

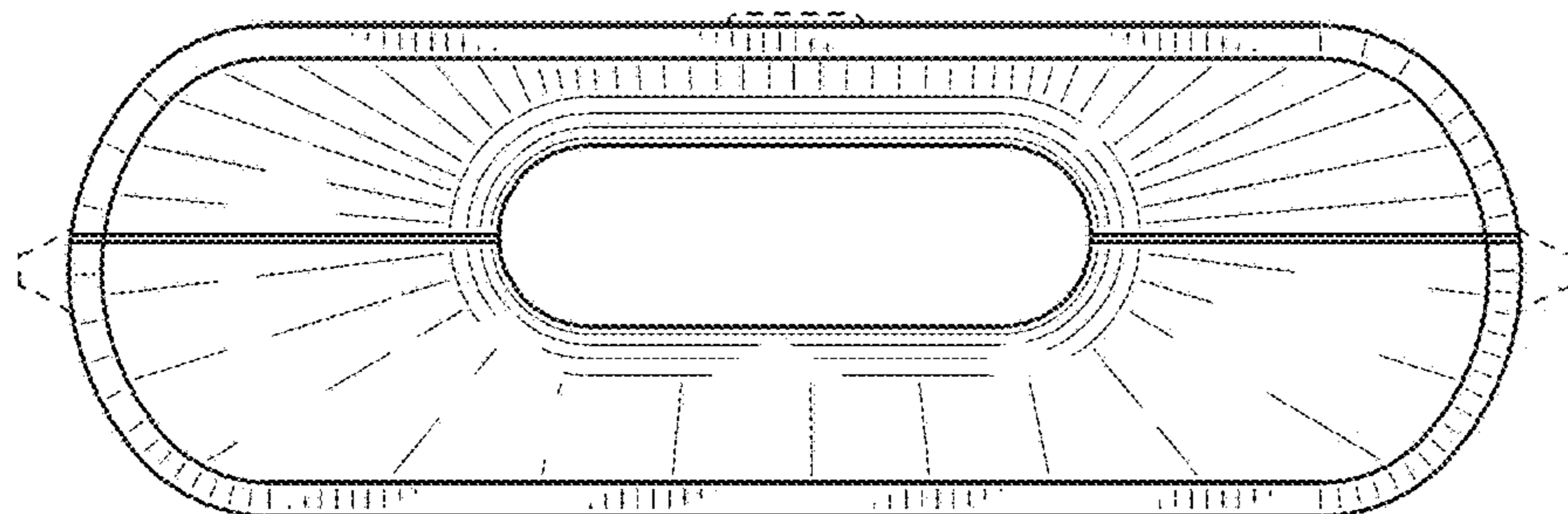
