The ornamental designs for a refrigerator drawer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a refrigerator drawer, showing our new design;

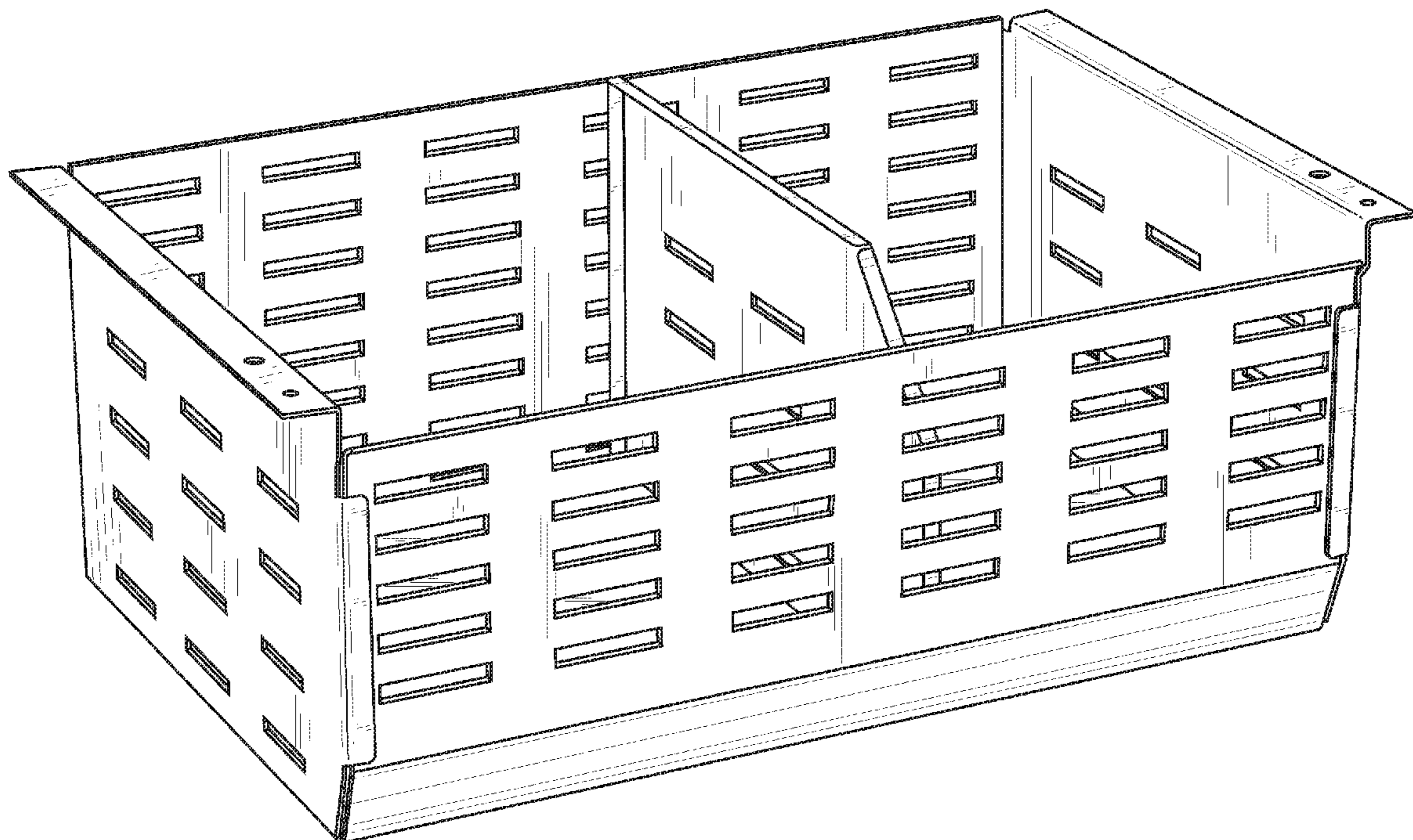
FIG. 2 is a front elevation view of the refrigerator drawer of FIG. 1;

FIG. 3 is a top plan view of the refrigerator drawer of FIG. 1, the bottom view is disclaimed;

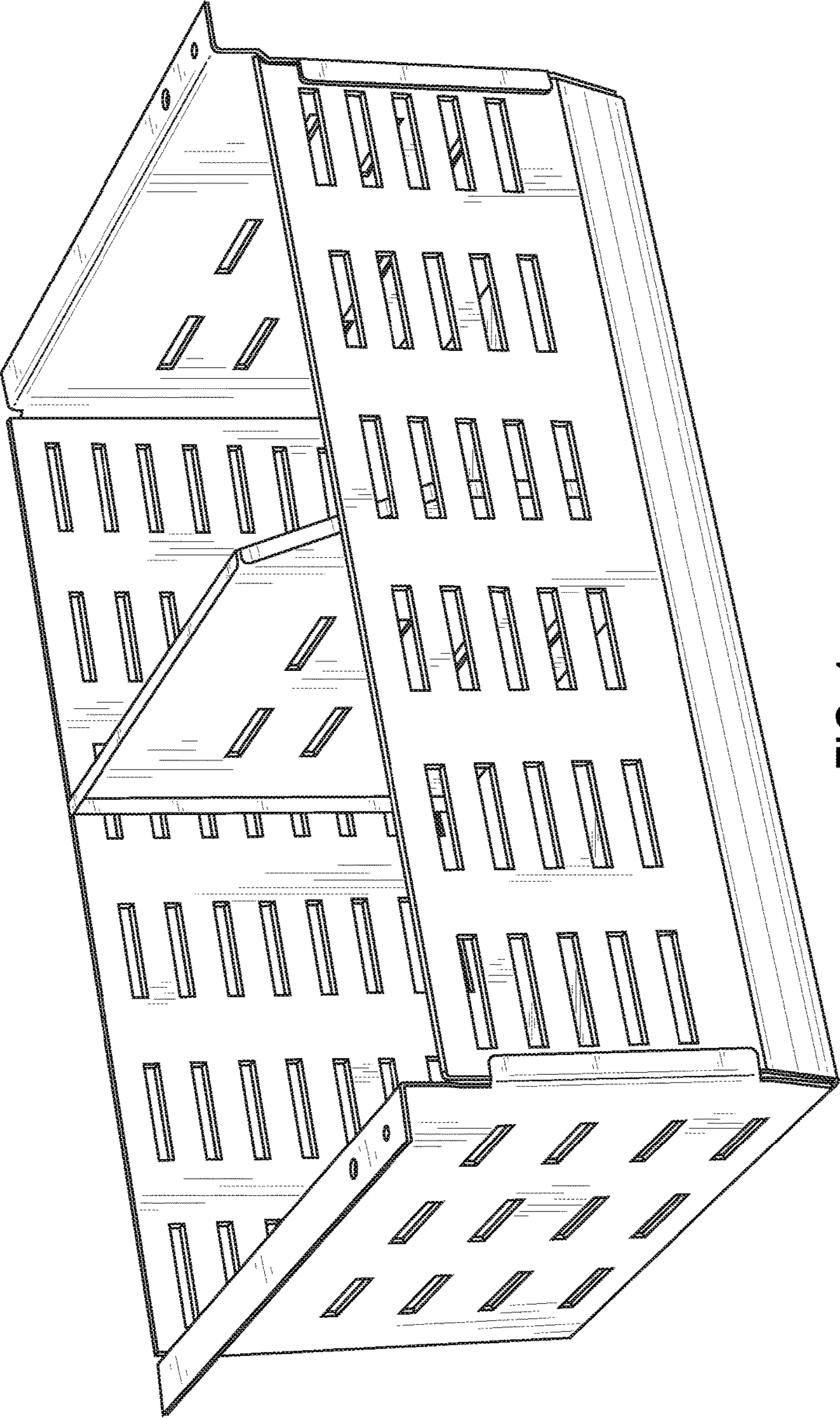

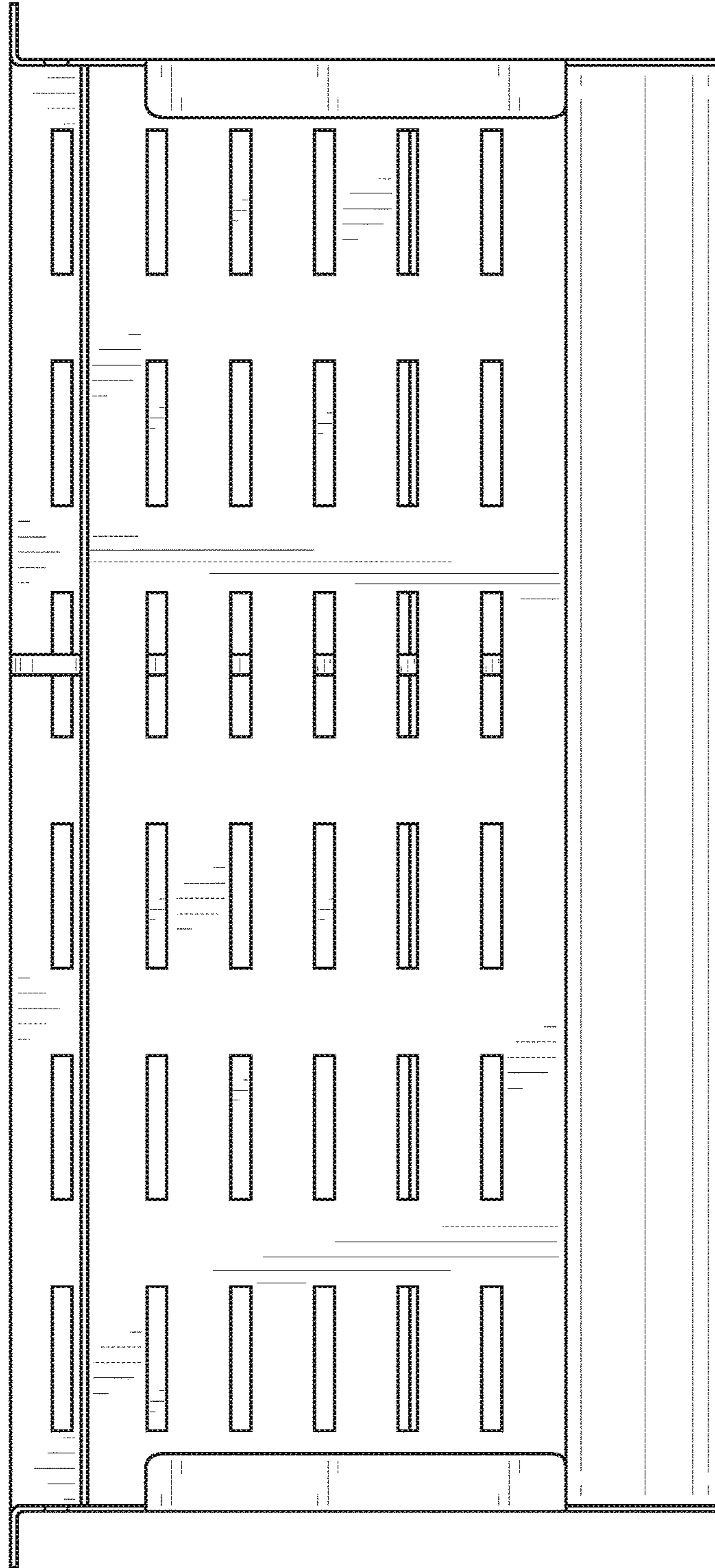

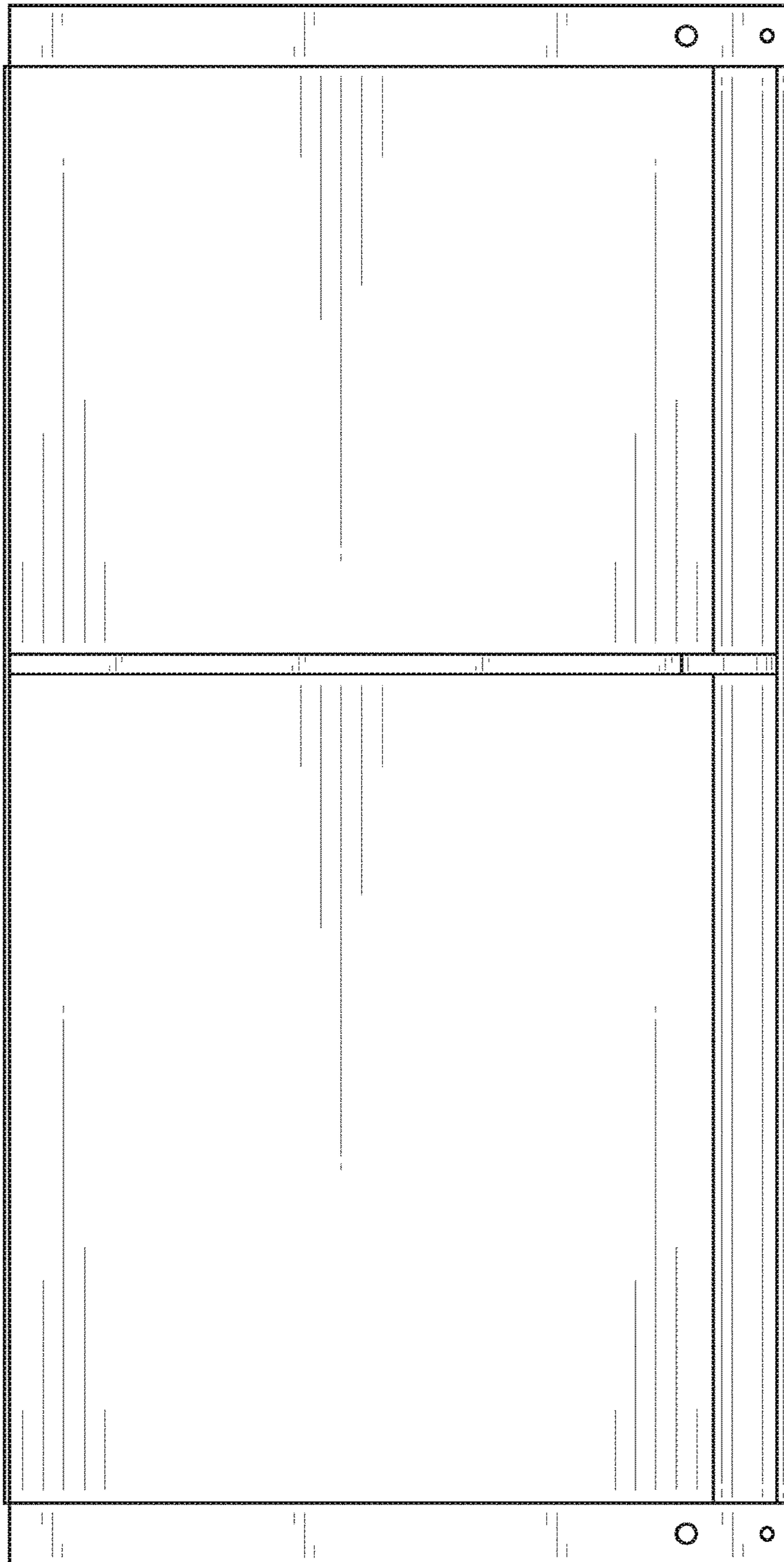

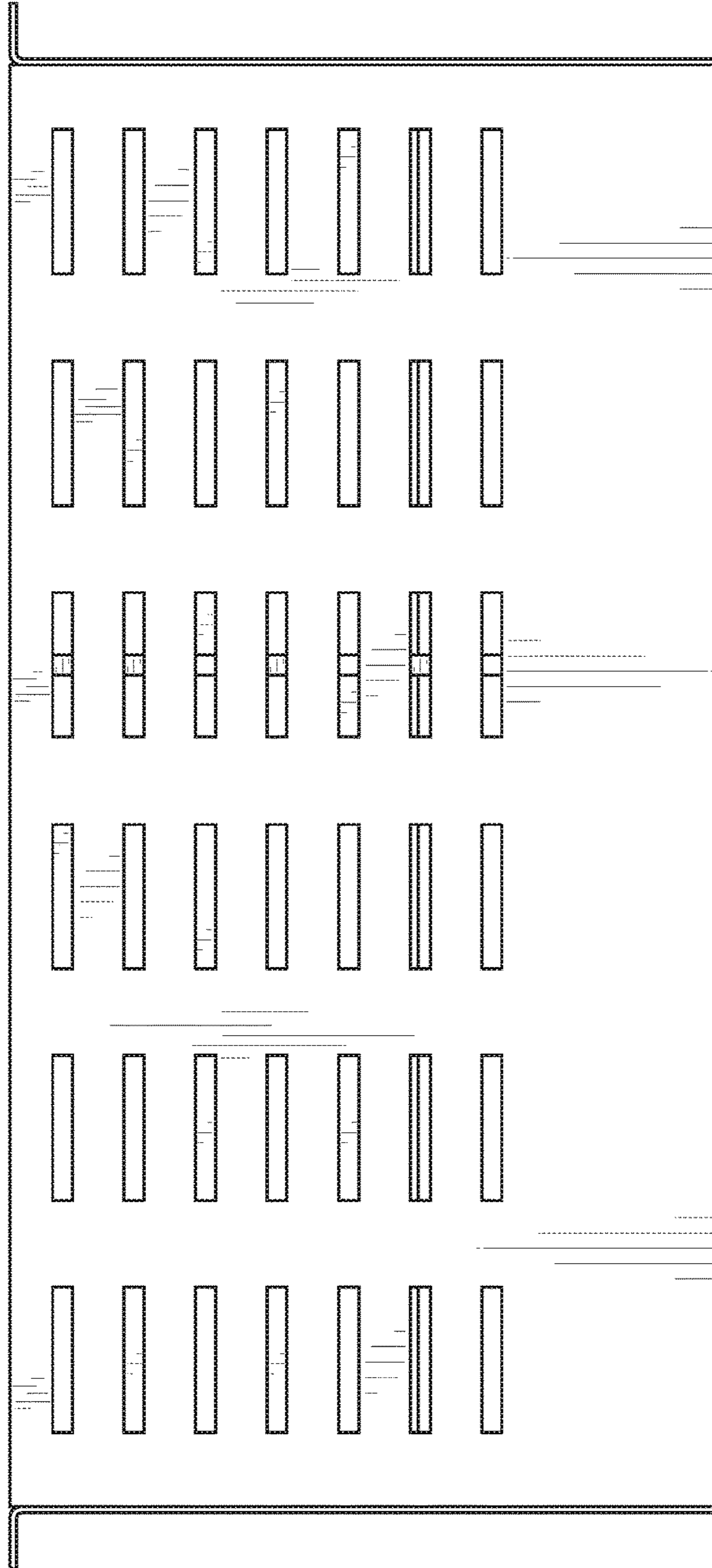

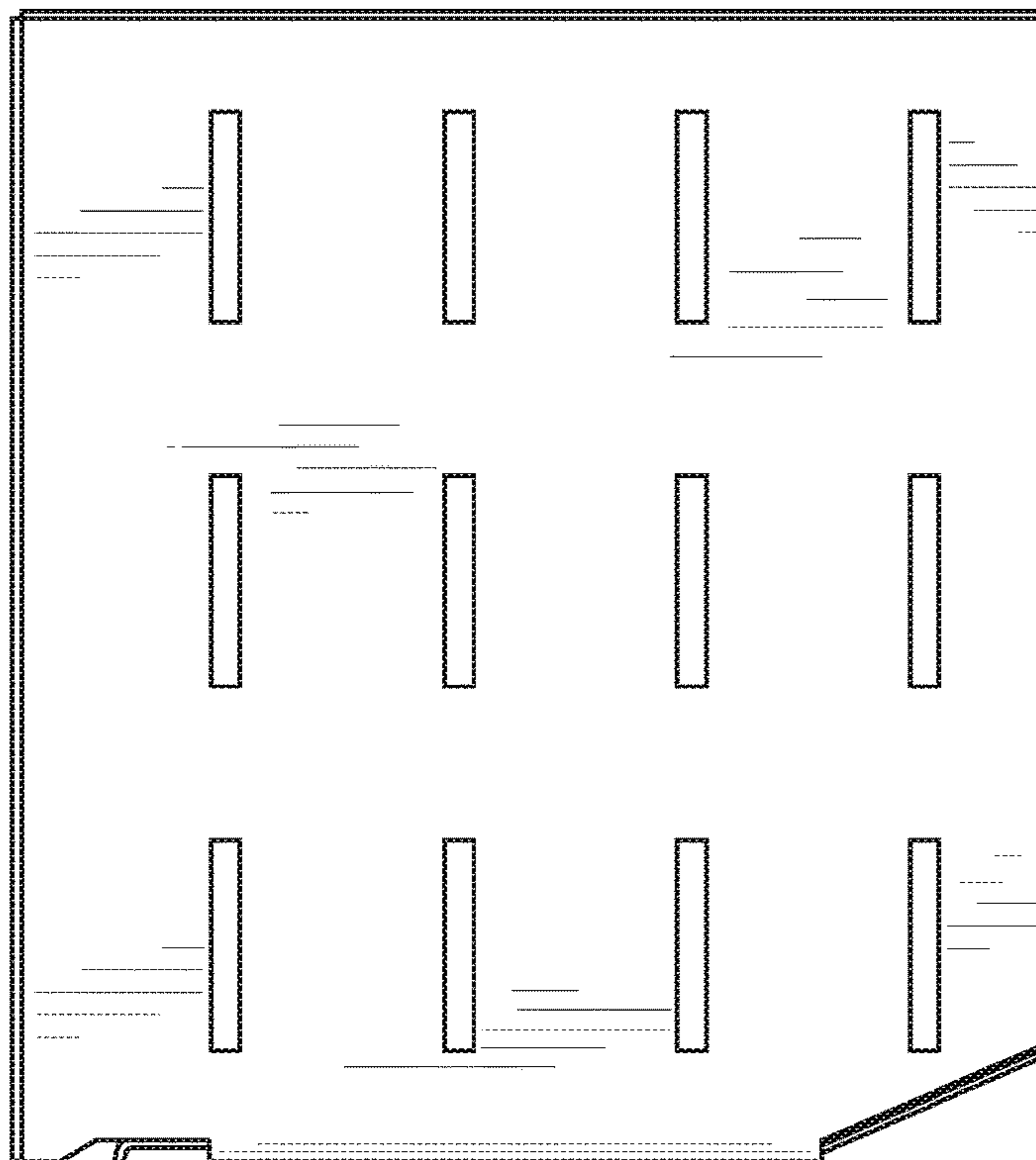
