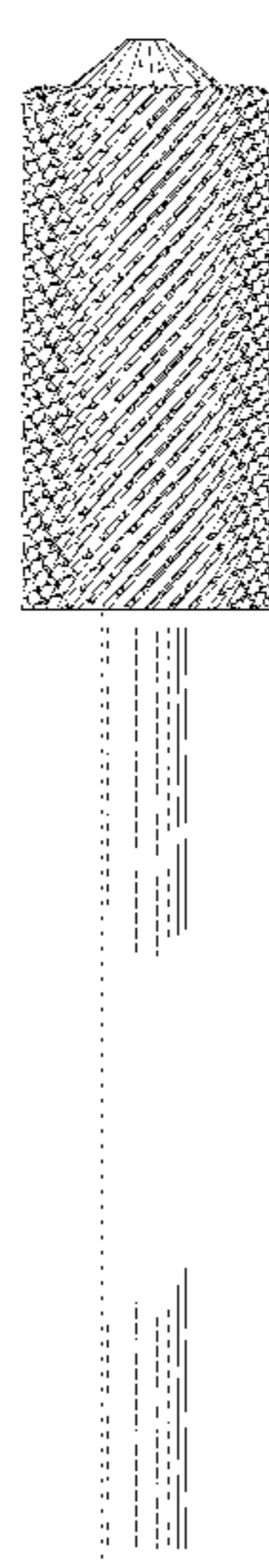

described.

DESCRIPTION
FIG. 1 is a front elevational view of a grinder bistrigue,
showing our new design; the rear, left side and right side
elevational views are a mirror view of FIG. 1;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is an enlarged view of a part of FIG. 1;
FIG. 5 is an enlarged view of FIG. 2; and,
FIG. 6 is an enlarged view of FIG. 3.

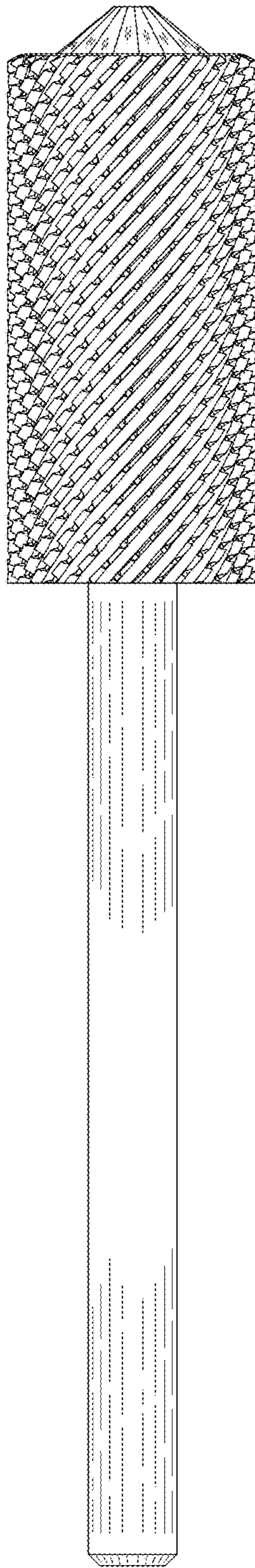

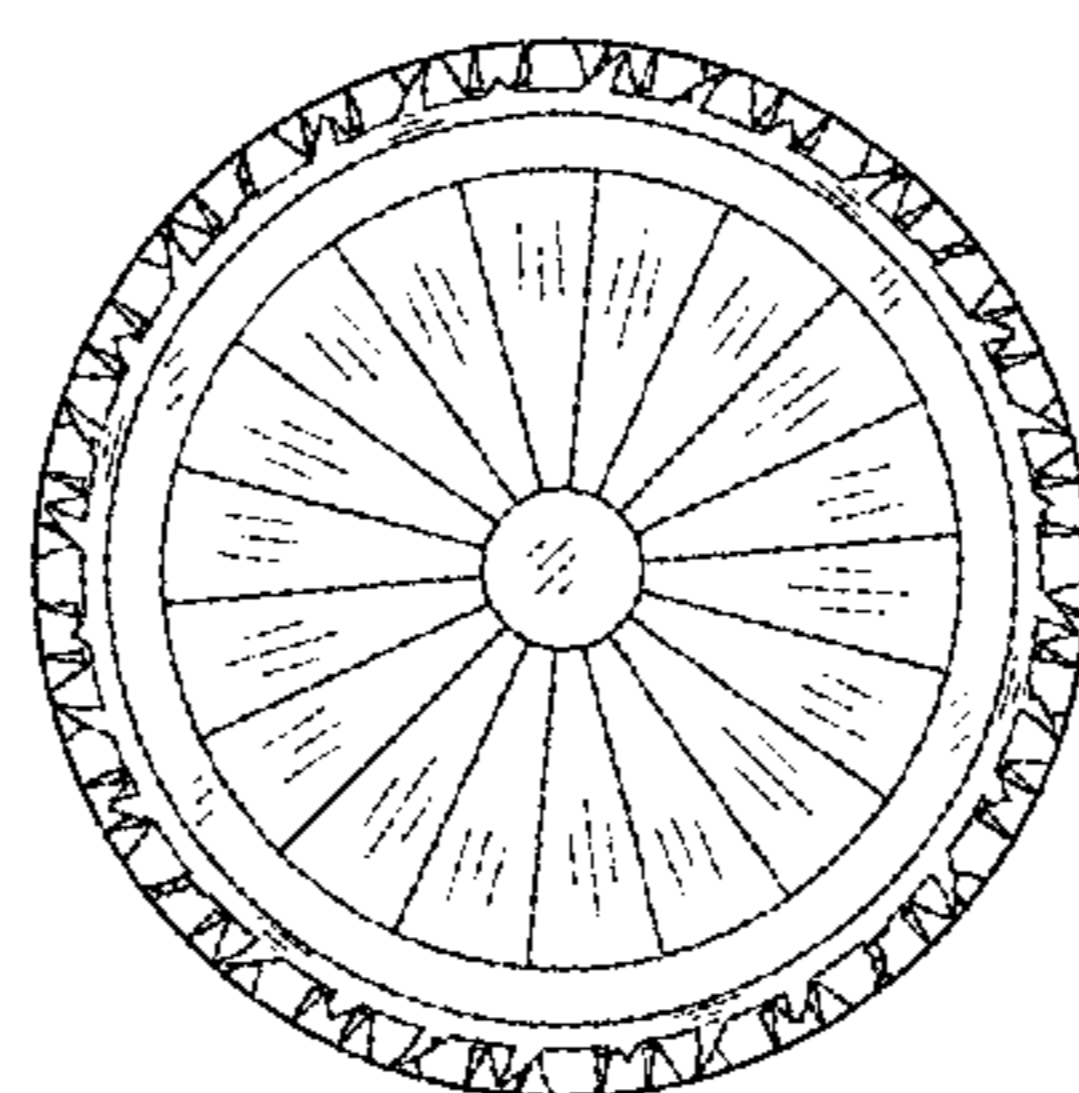

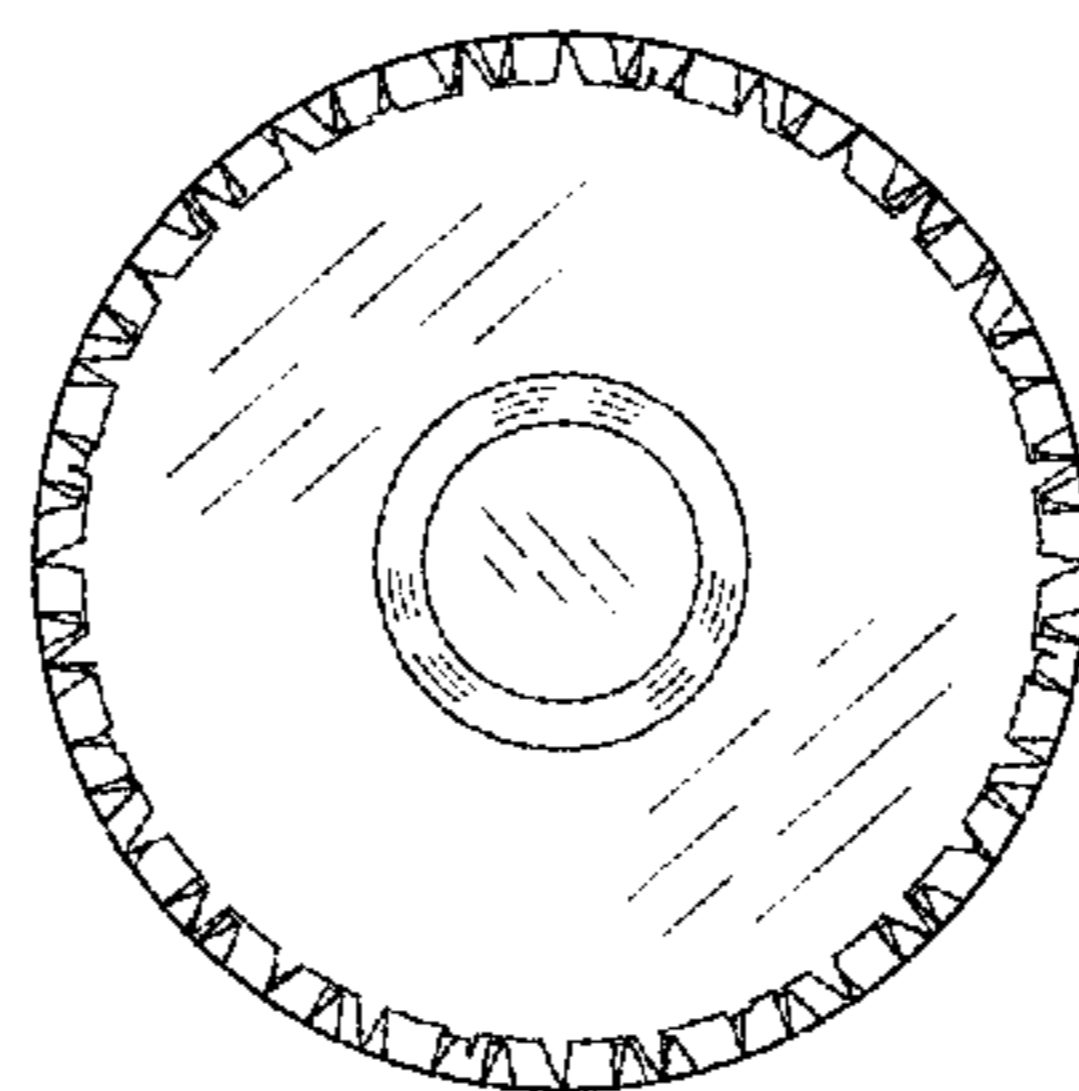

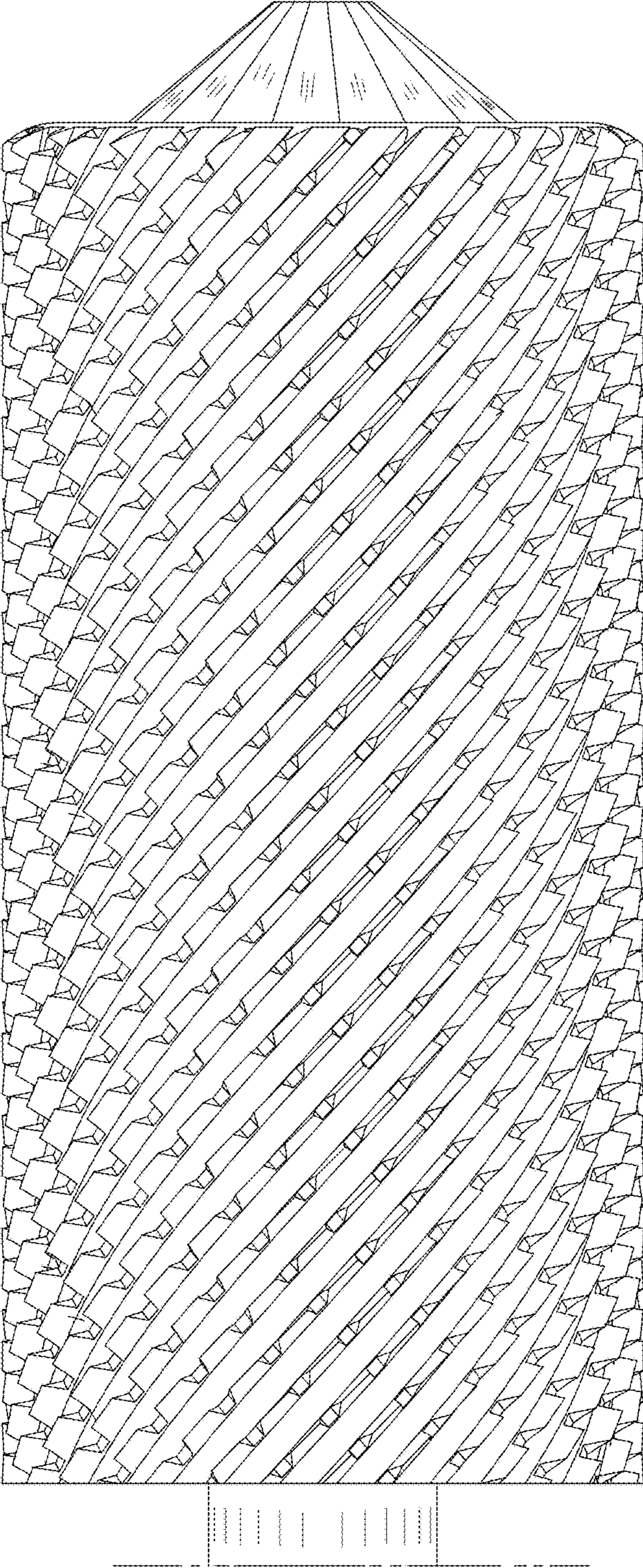

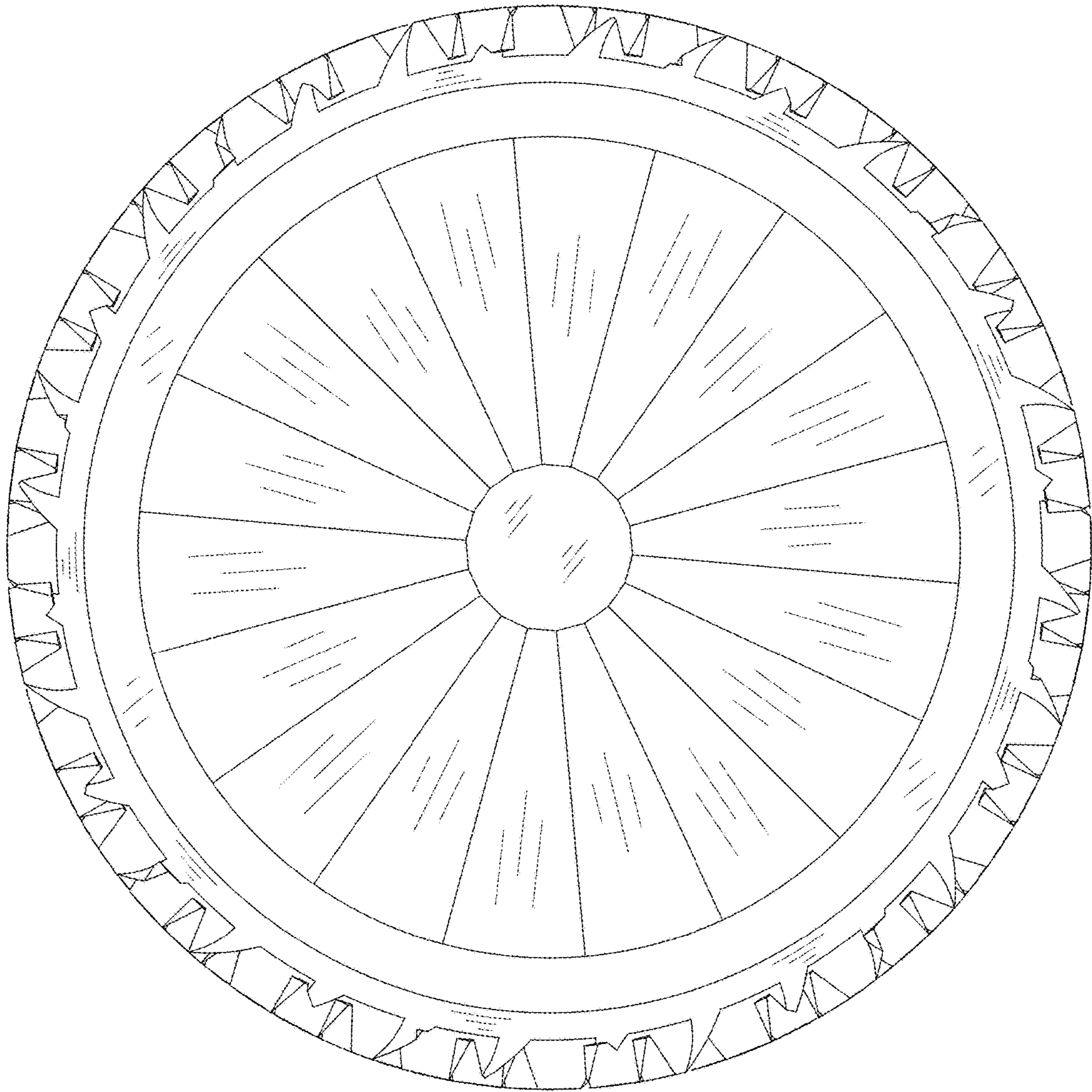

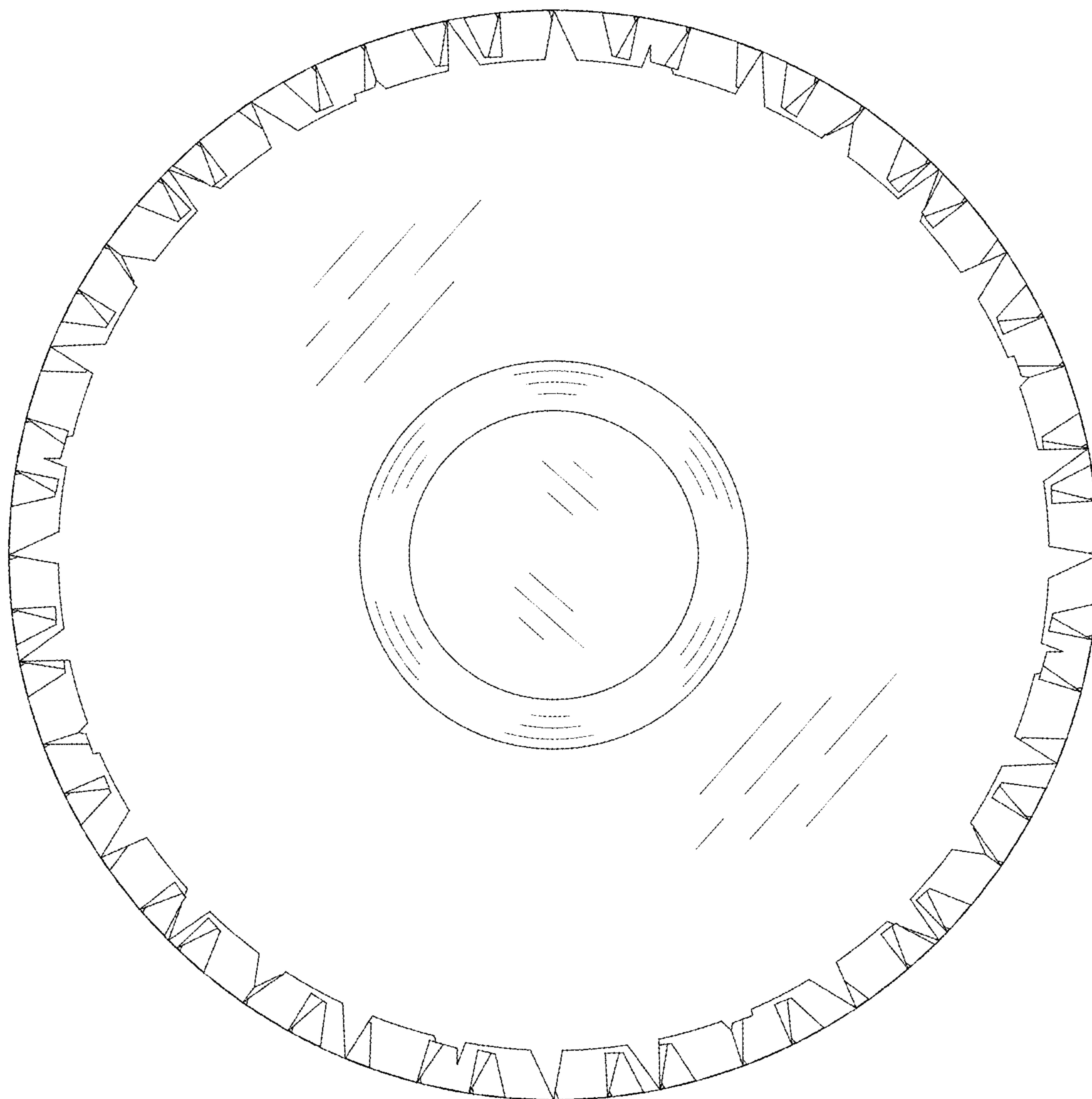
