(57) **CLAIM**

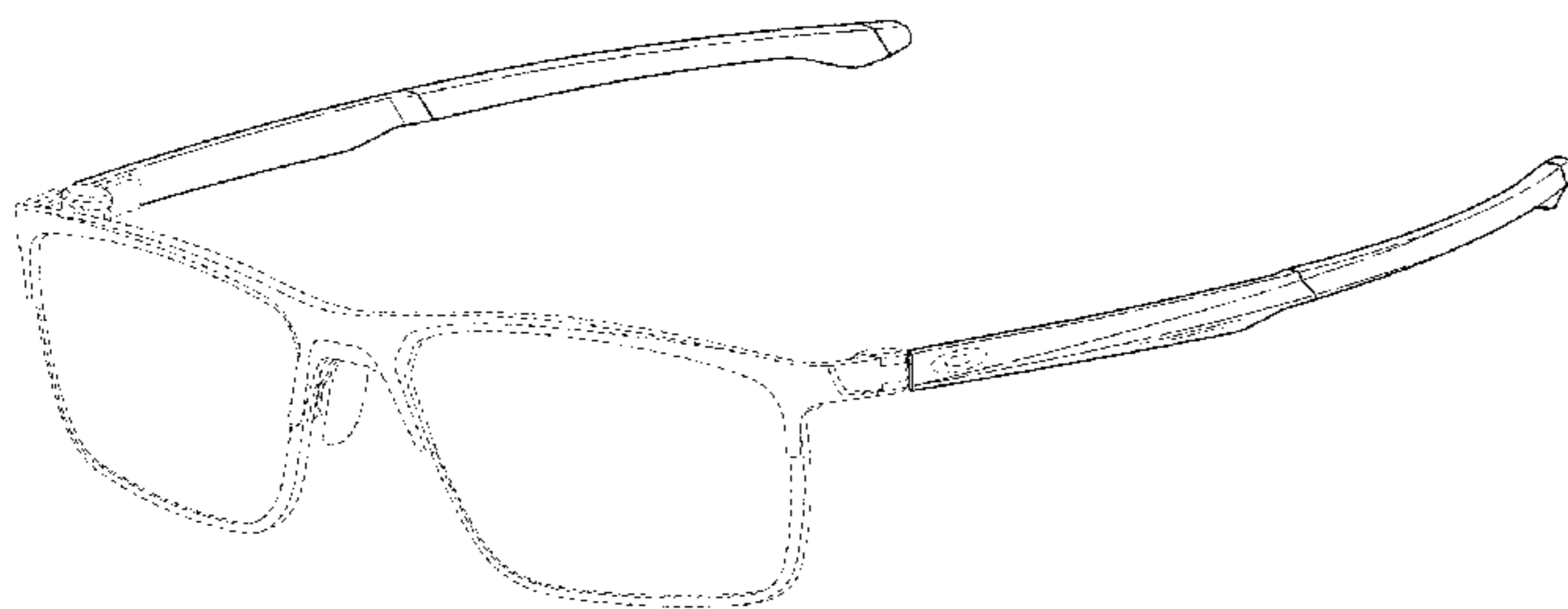
The ornamental design for eyeglasses, as shown and described.

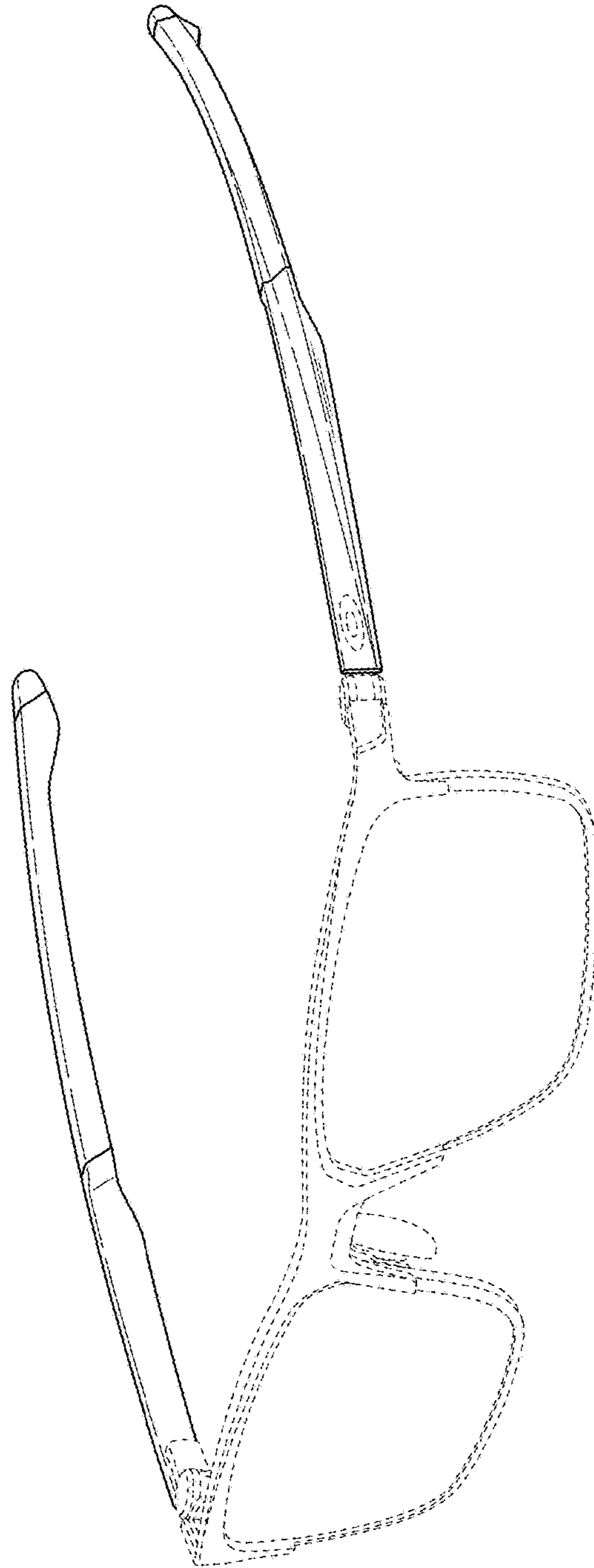

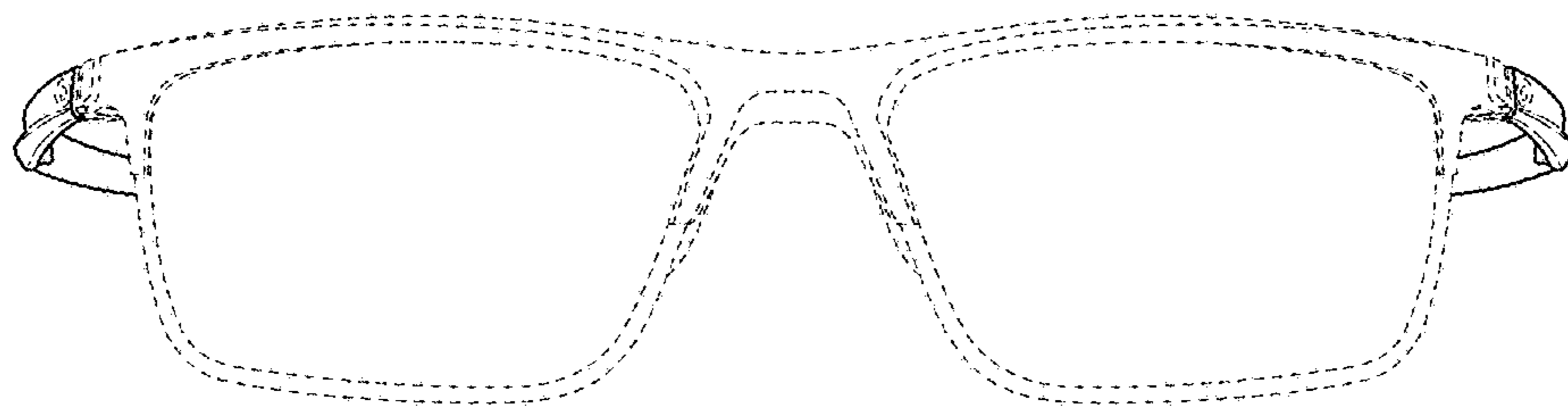

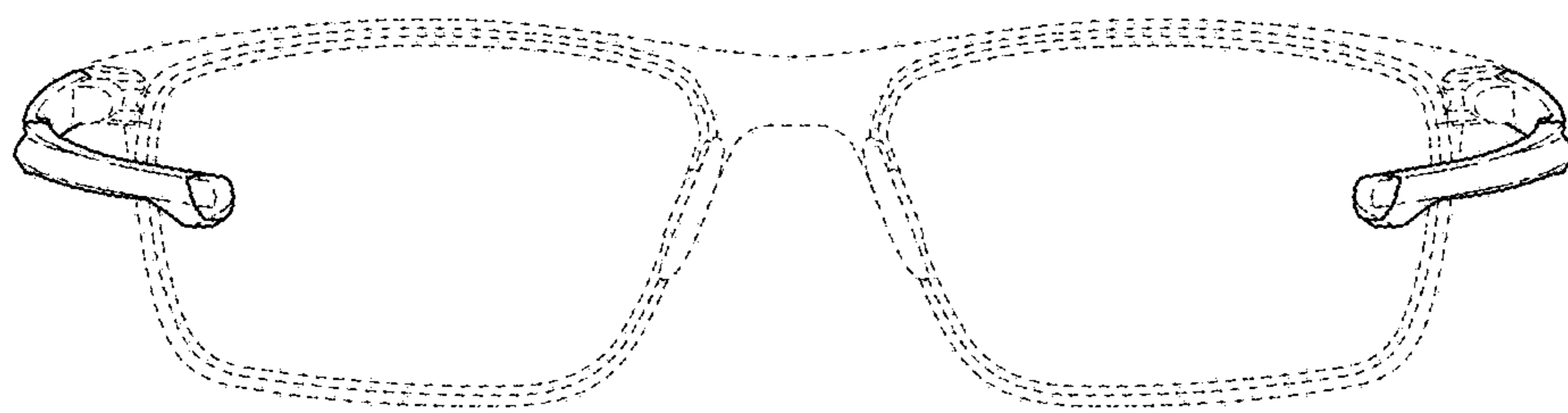

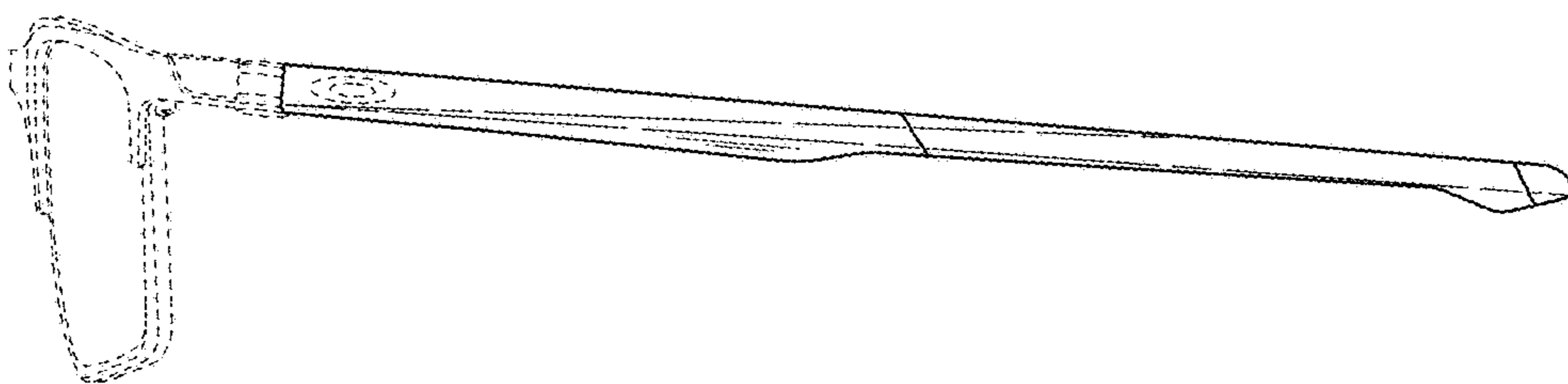
