DESCRIPTION

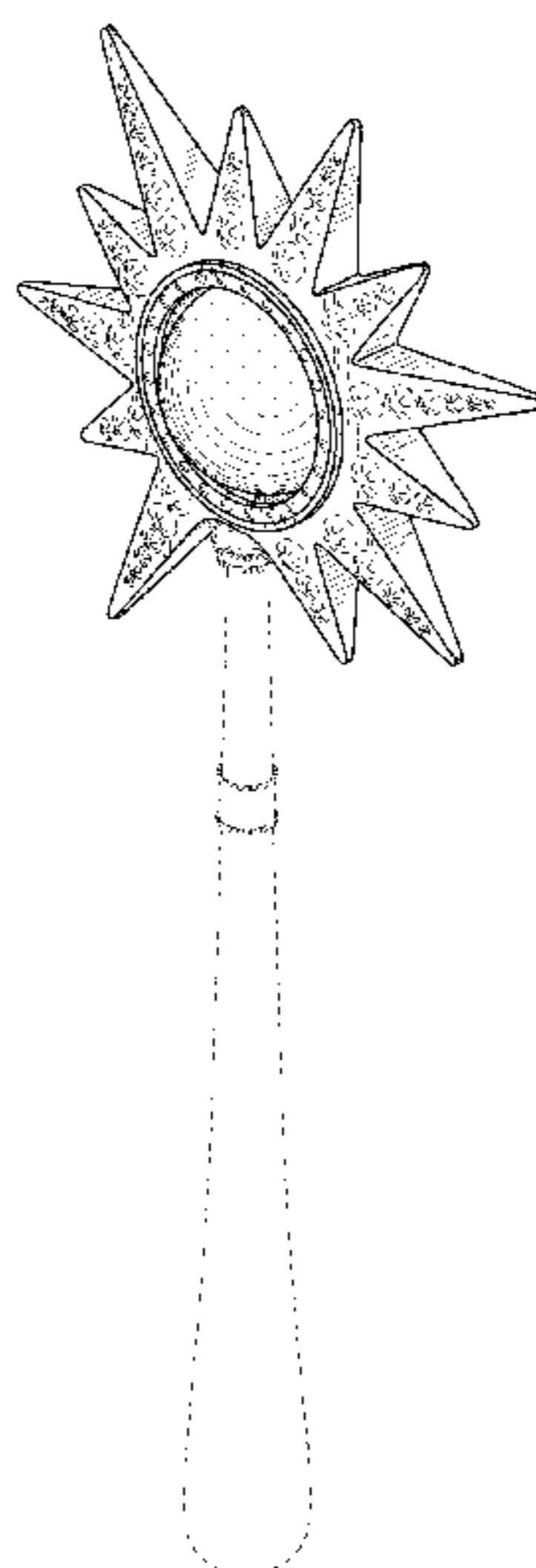
FIG. 1 is a perspective view of a wand with chiming sphere showing my new design.

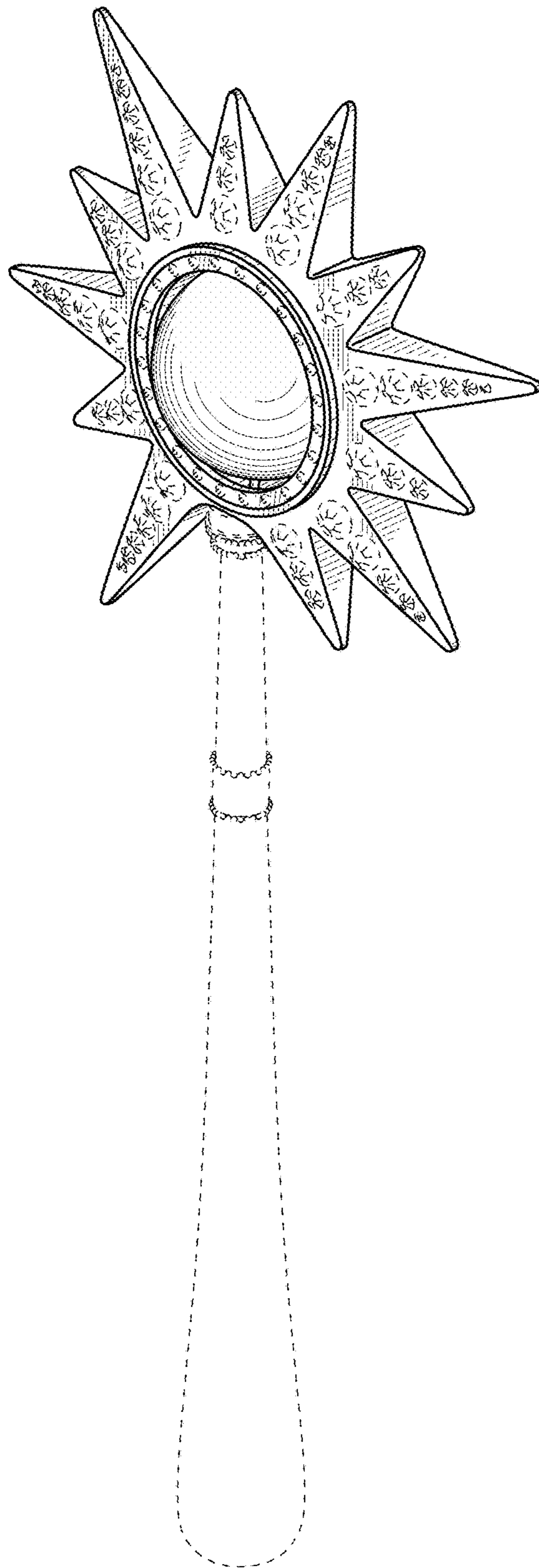

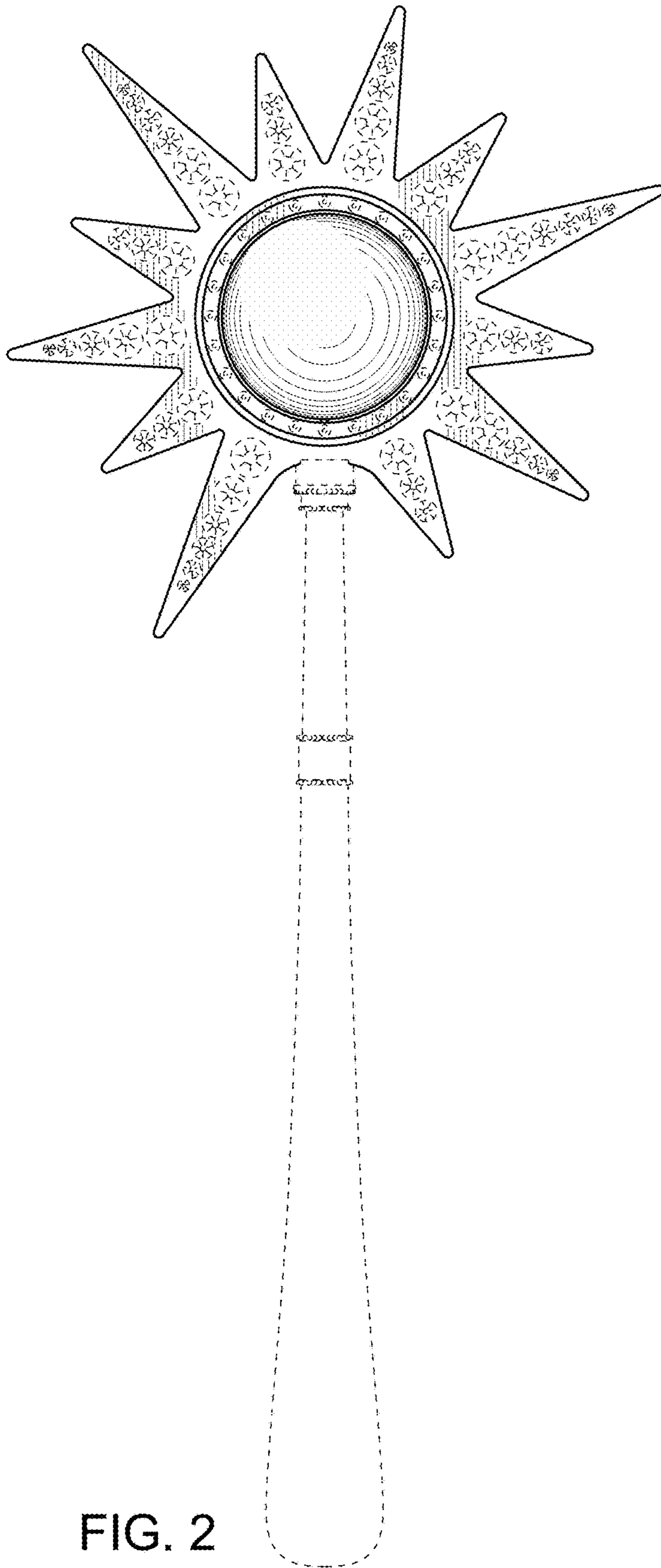

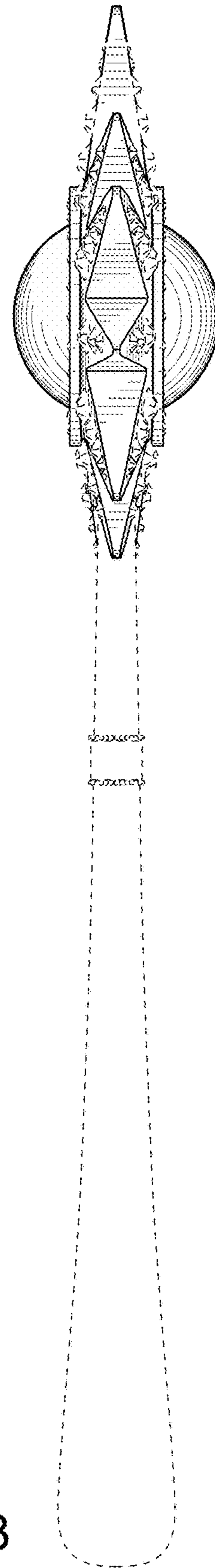
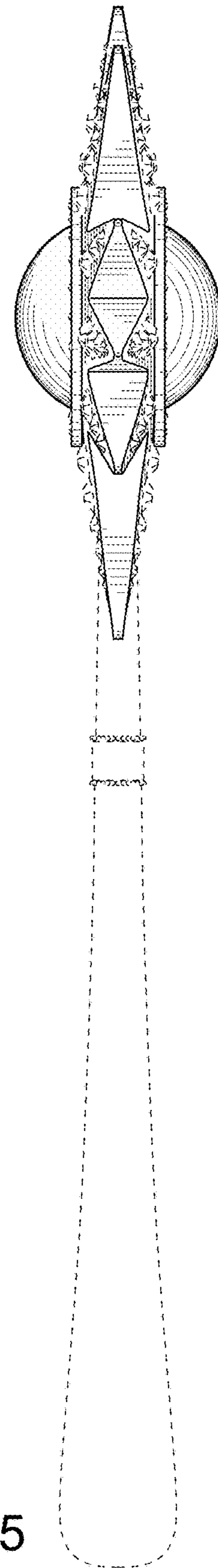
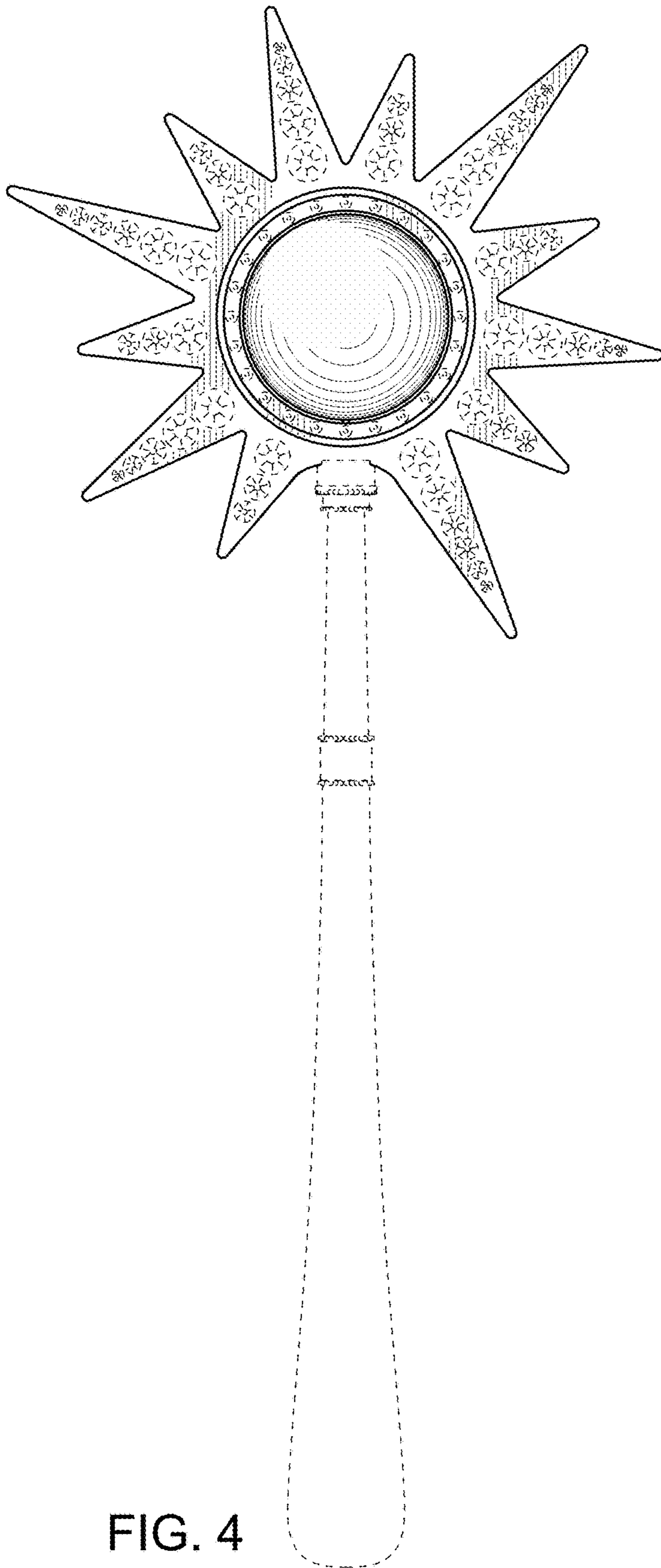

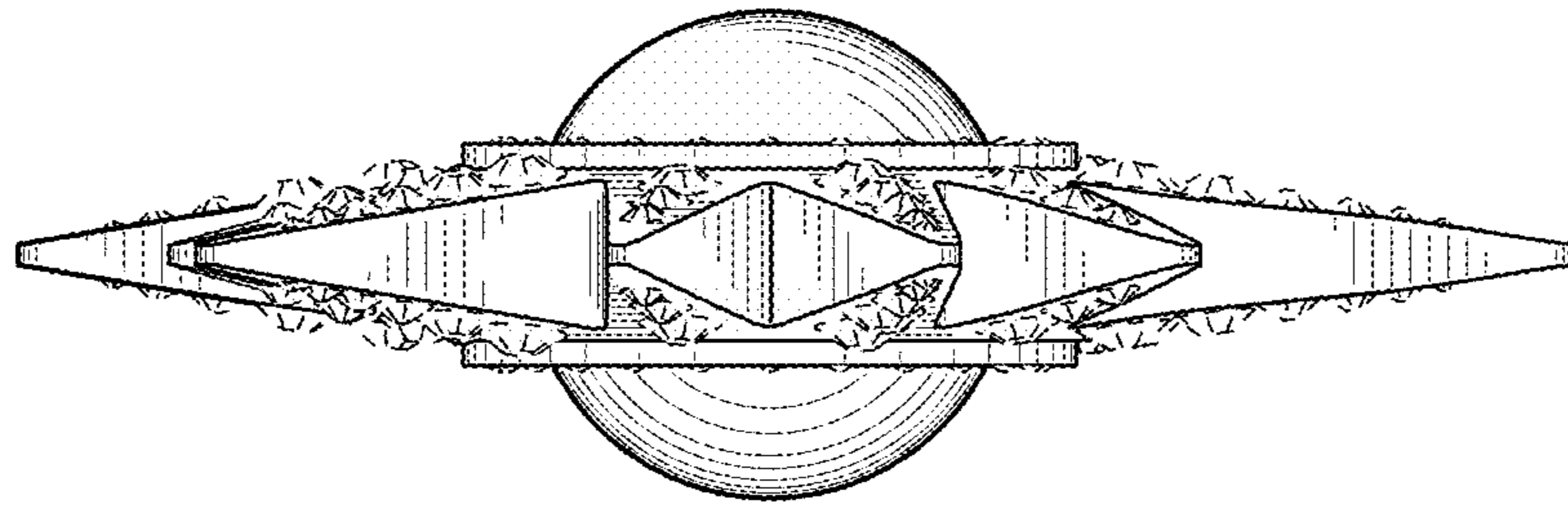

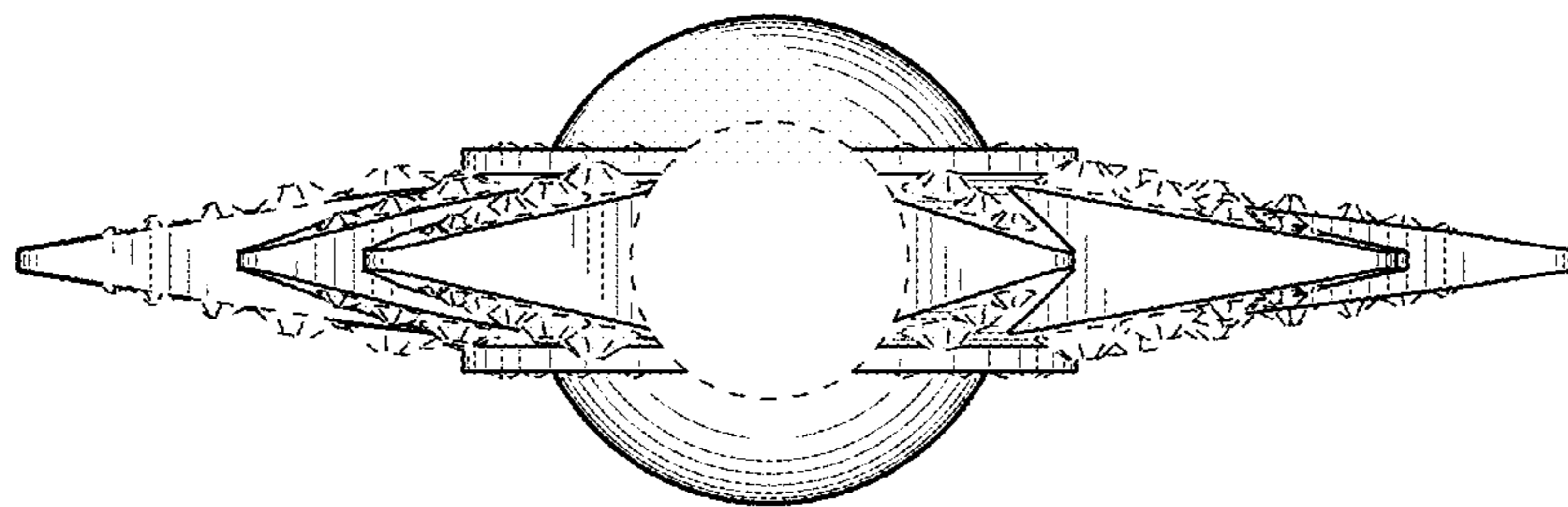
