The ornamental design for a doll's head, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a doll's head;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a perspective view thereof.
The broken lines in FIGS. 1 and 7 represent portions of the doll's head that form no part of the claimed design.

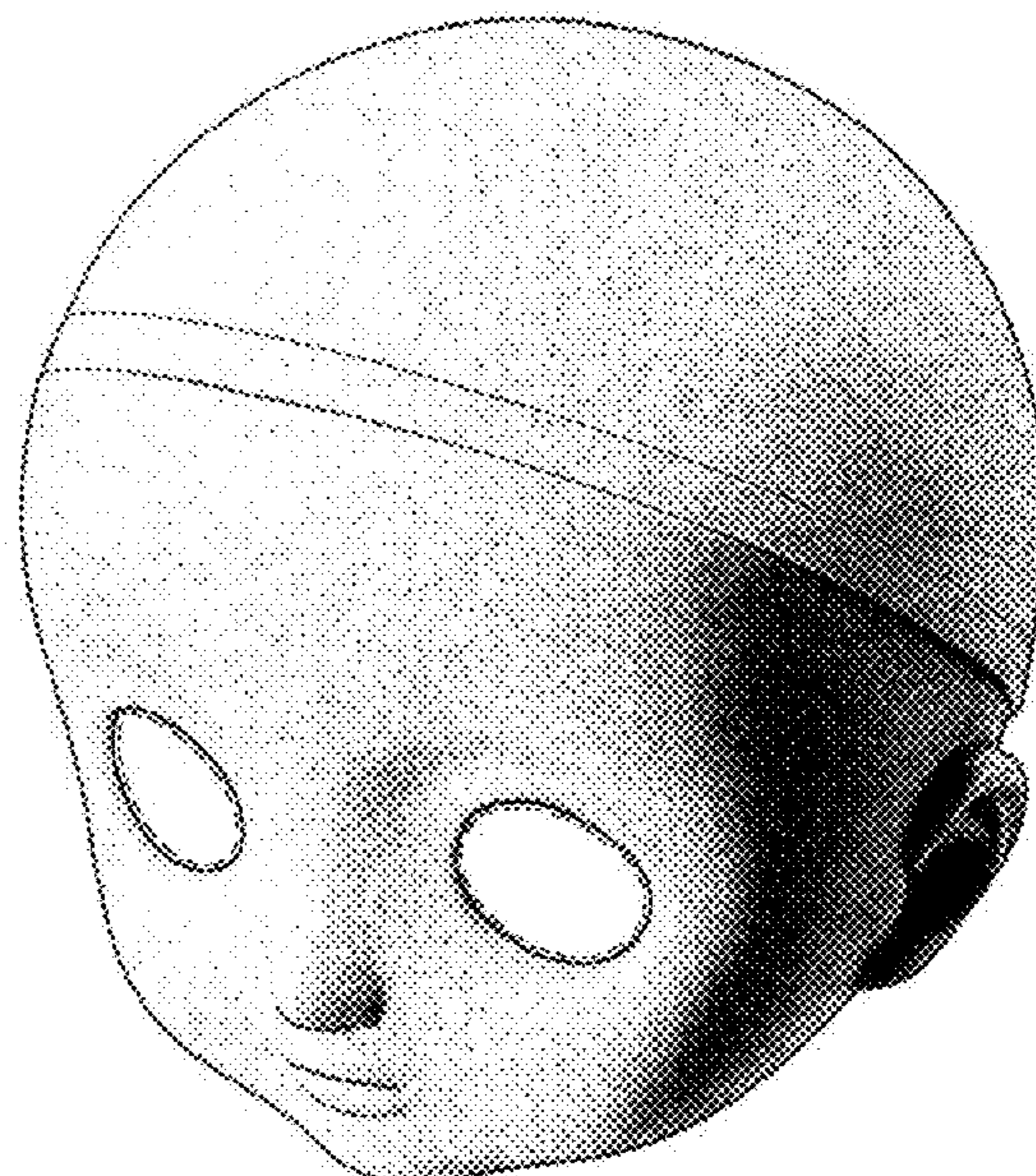
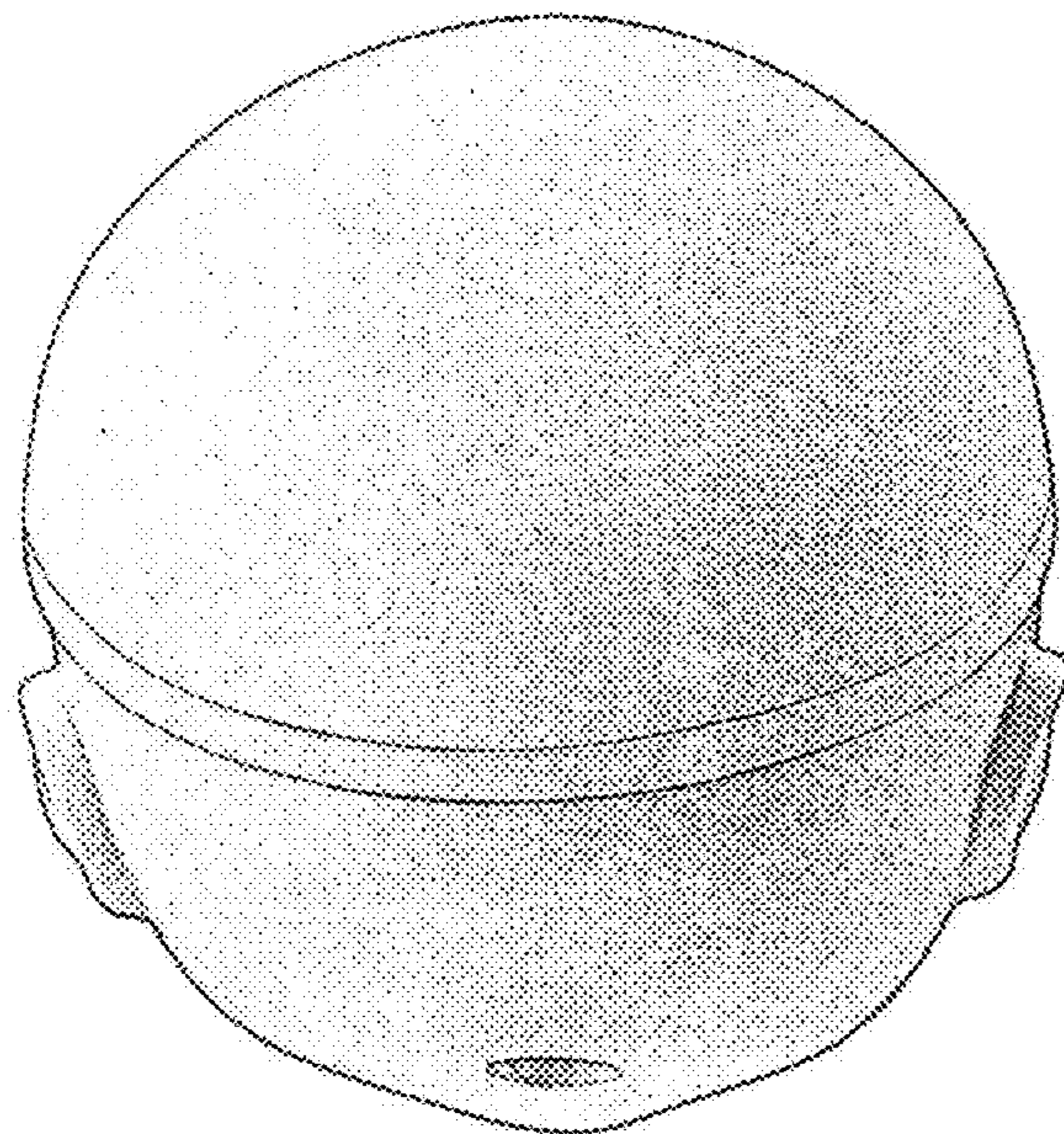

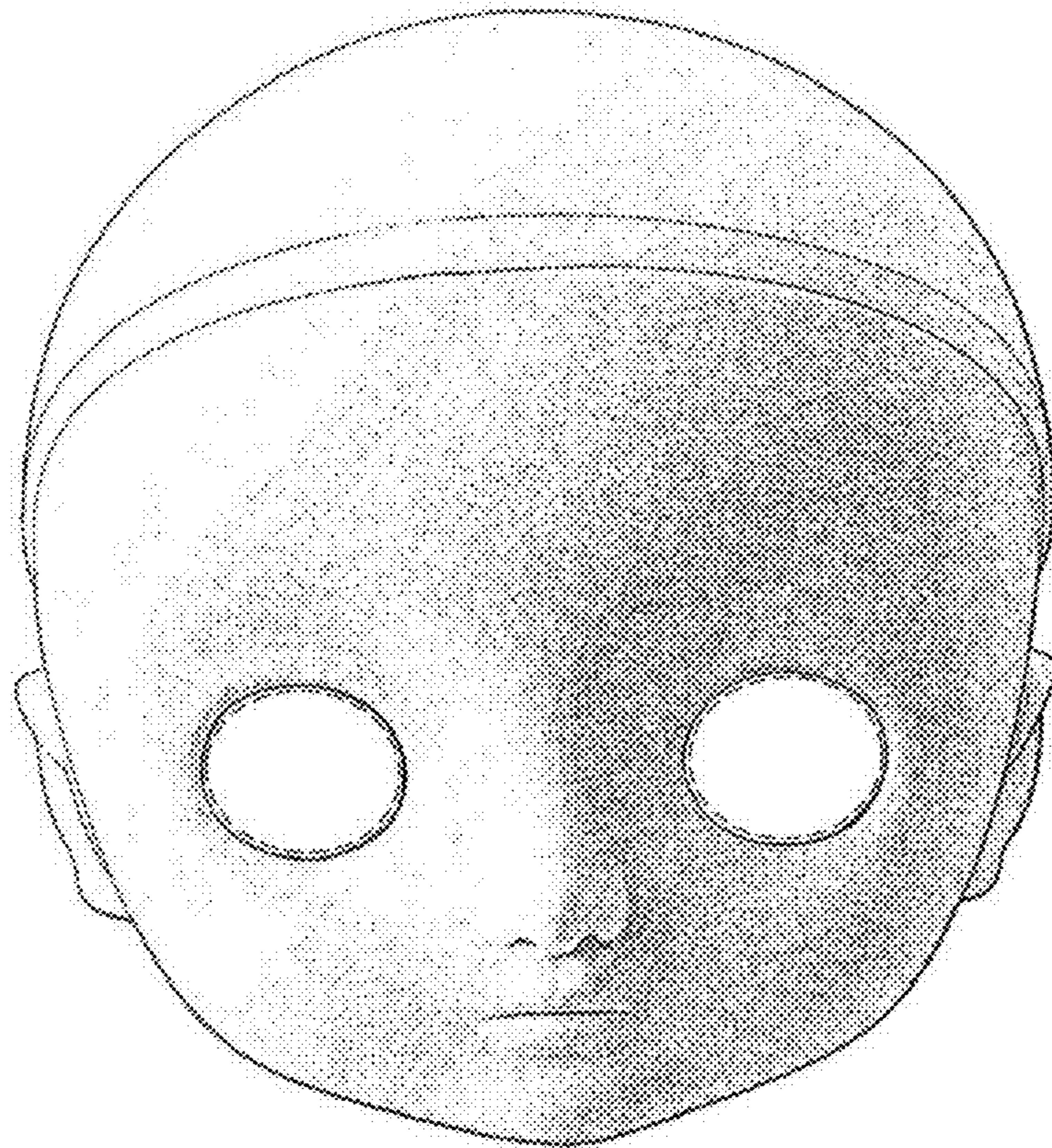
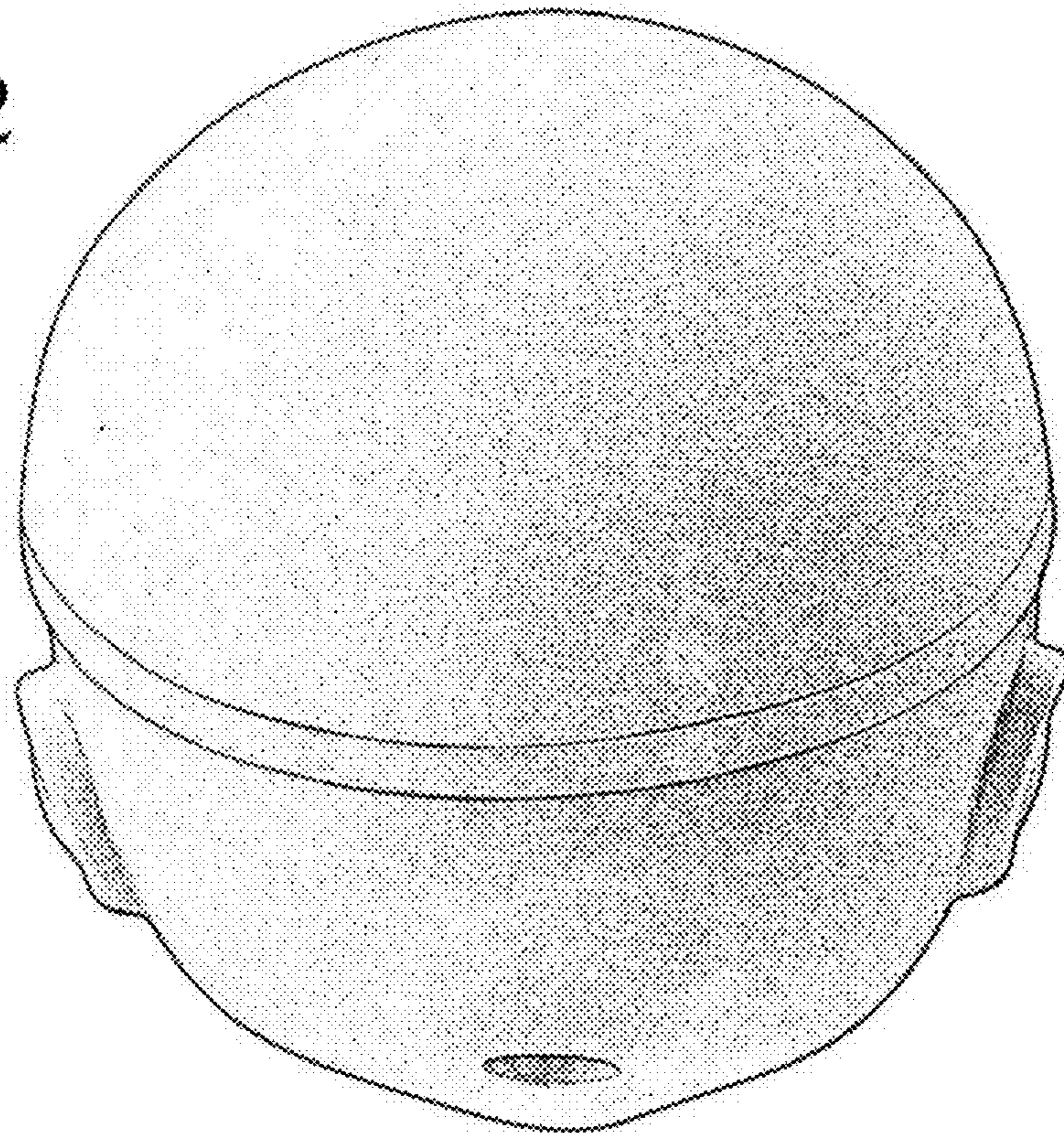

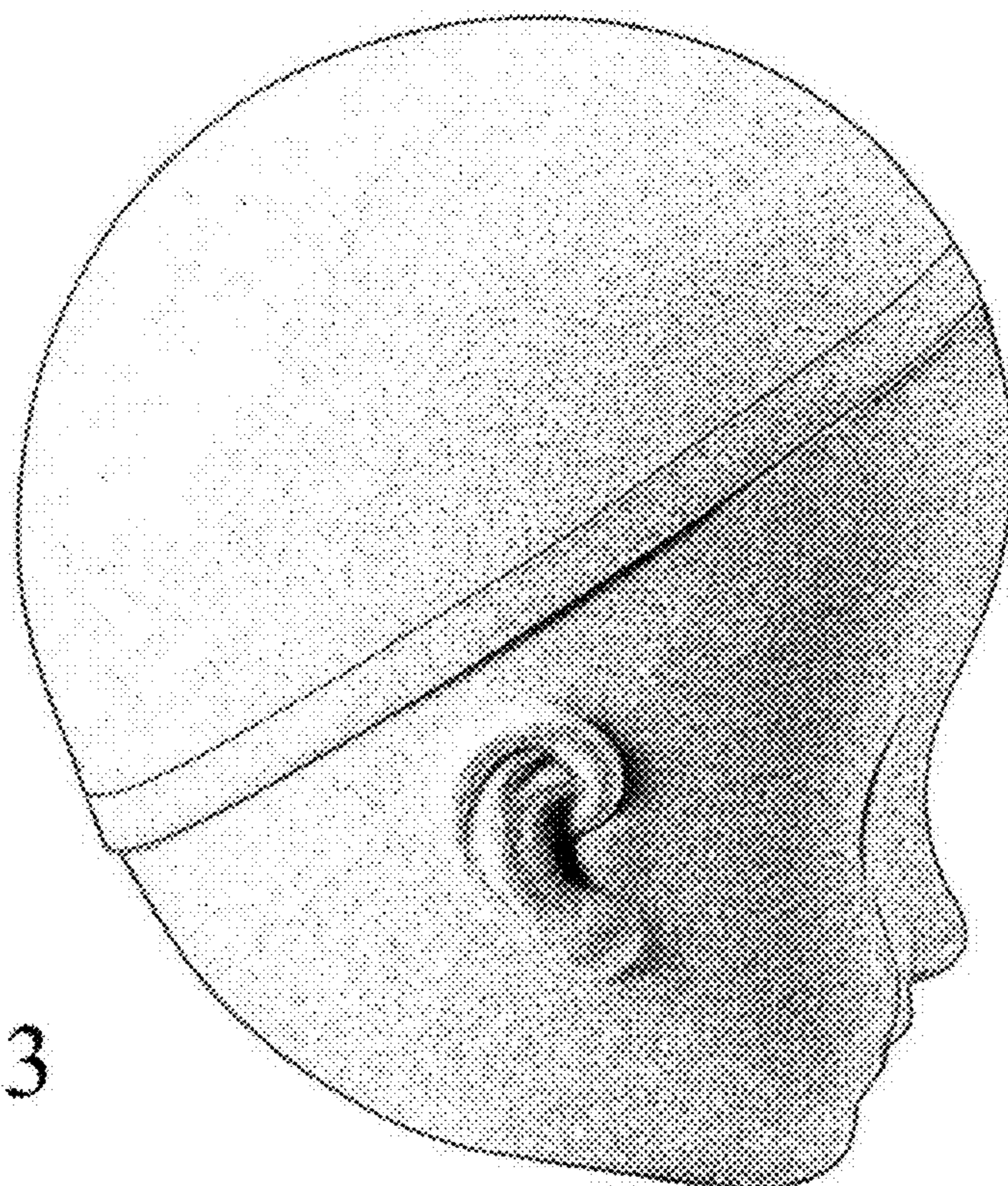

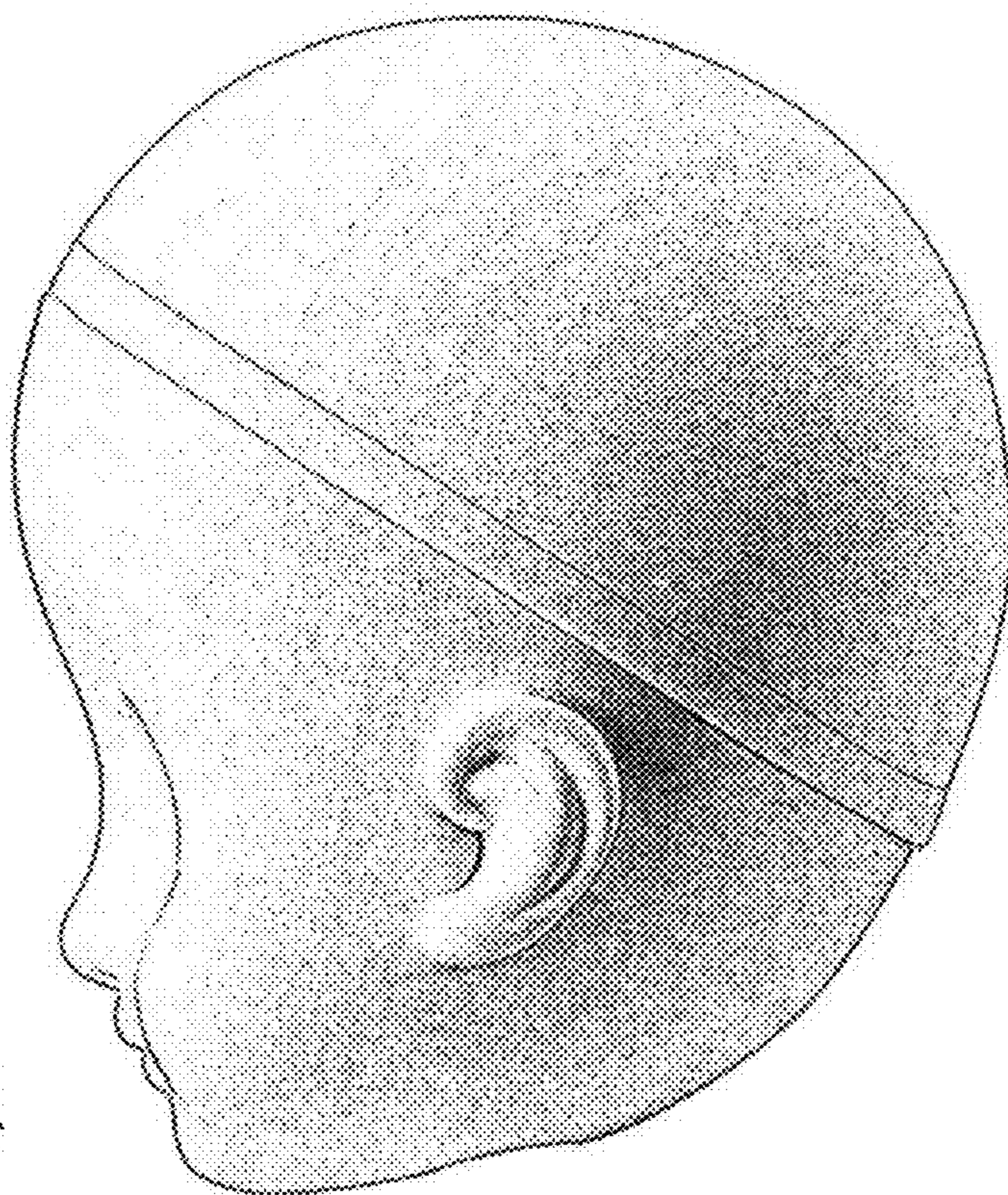

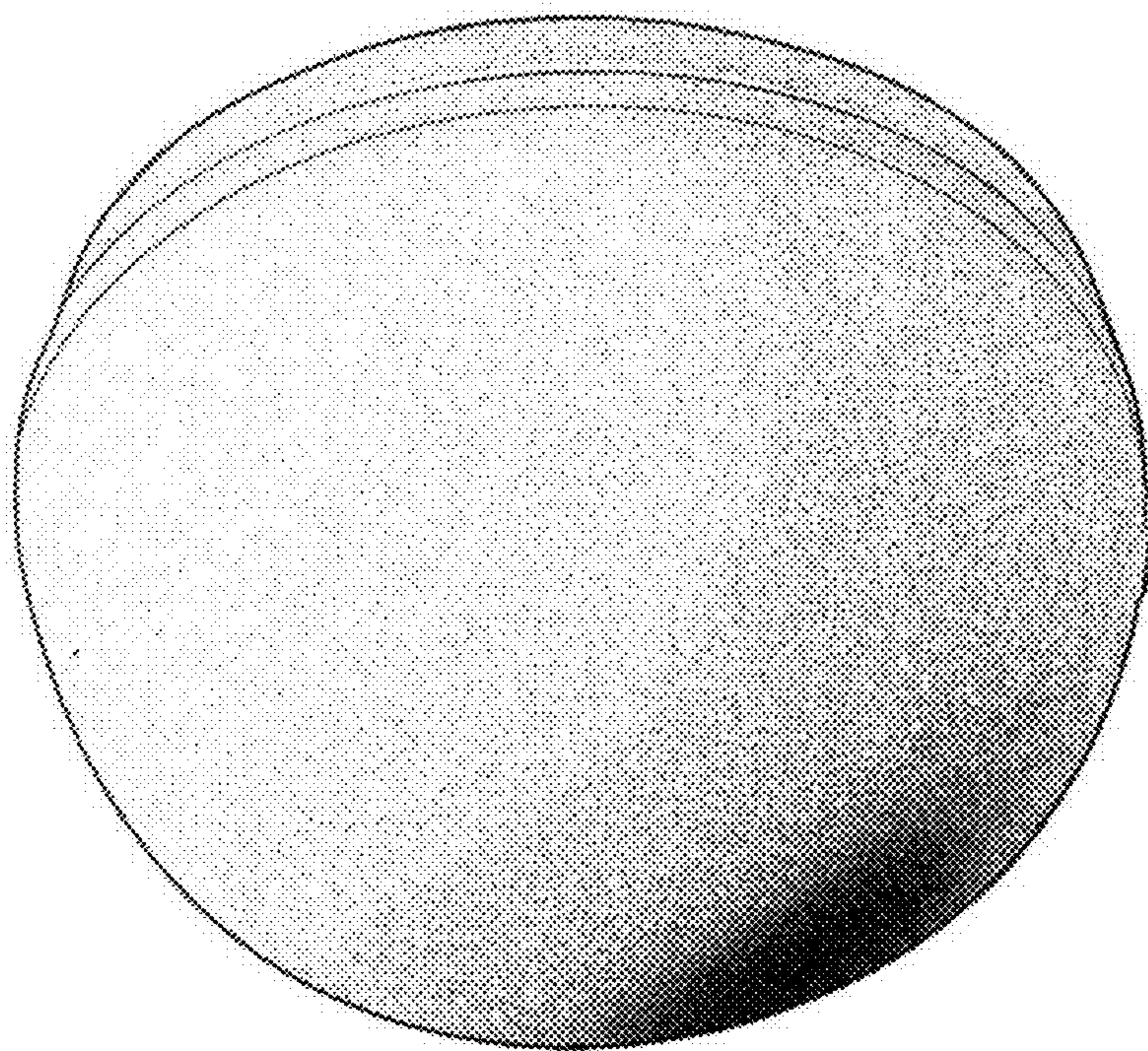

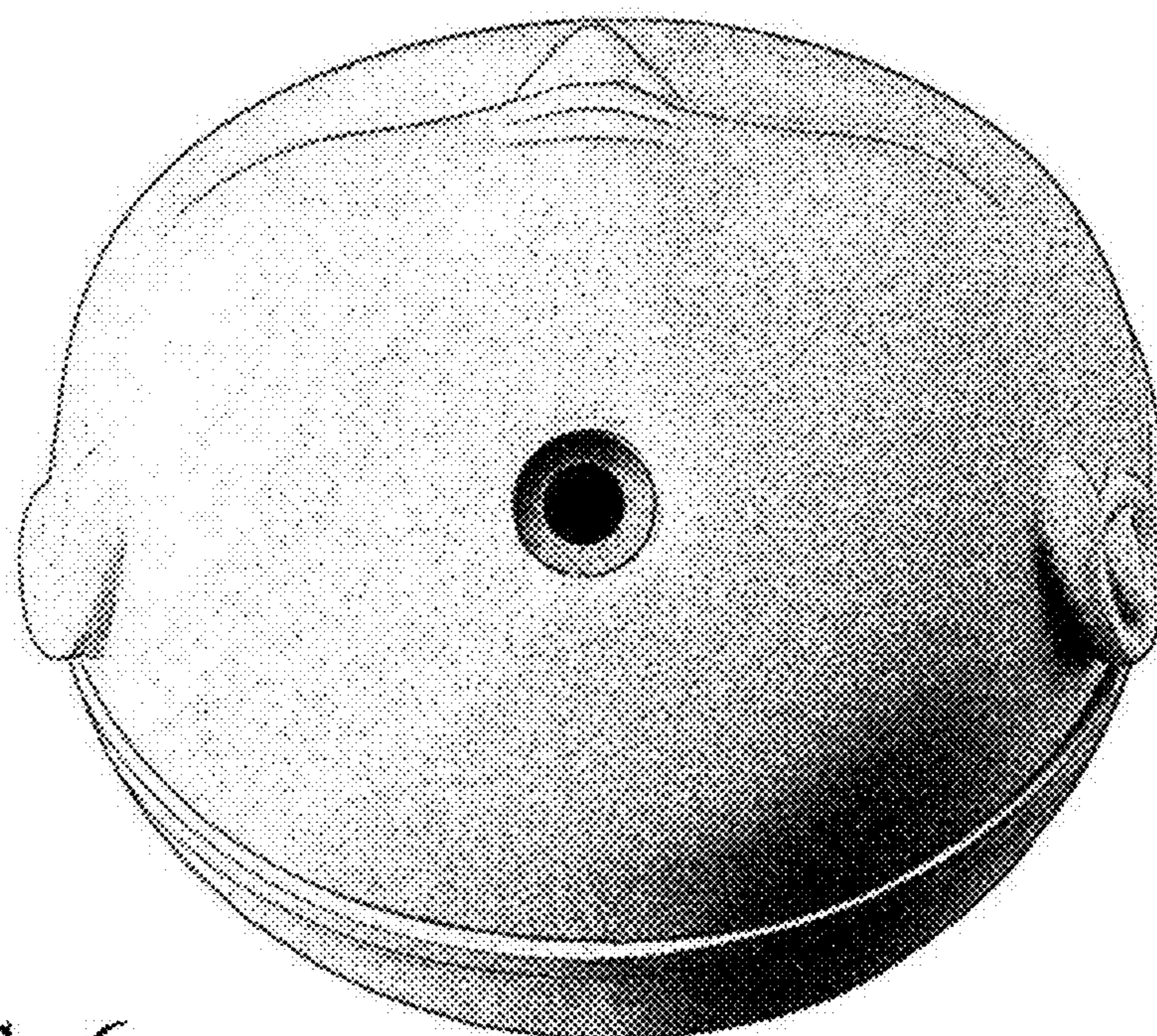

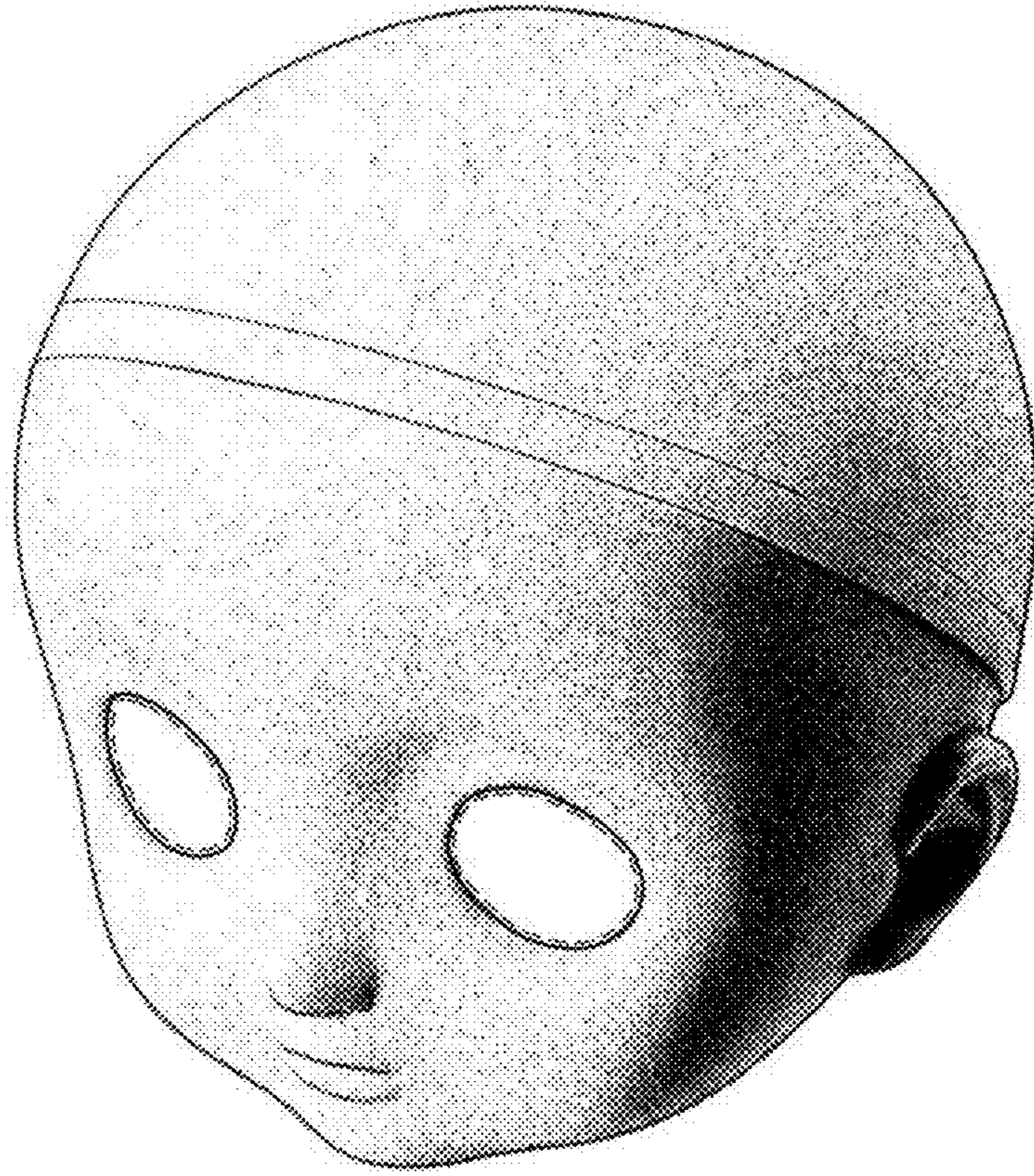
