The ornamental design for a golf ball, as shown and described.

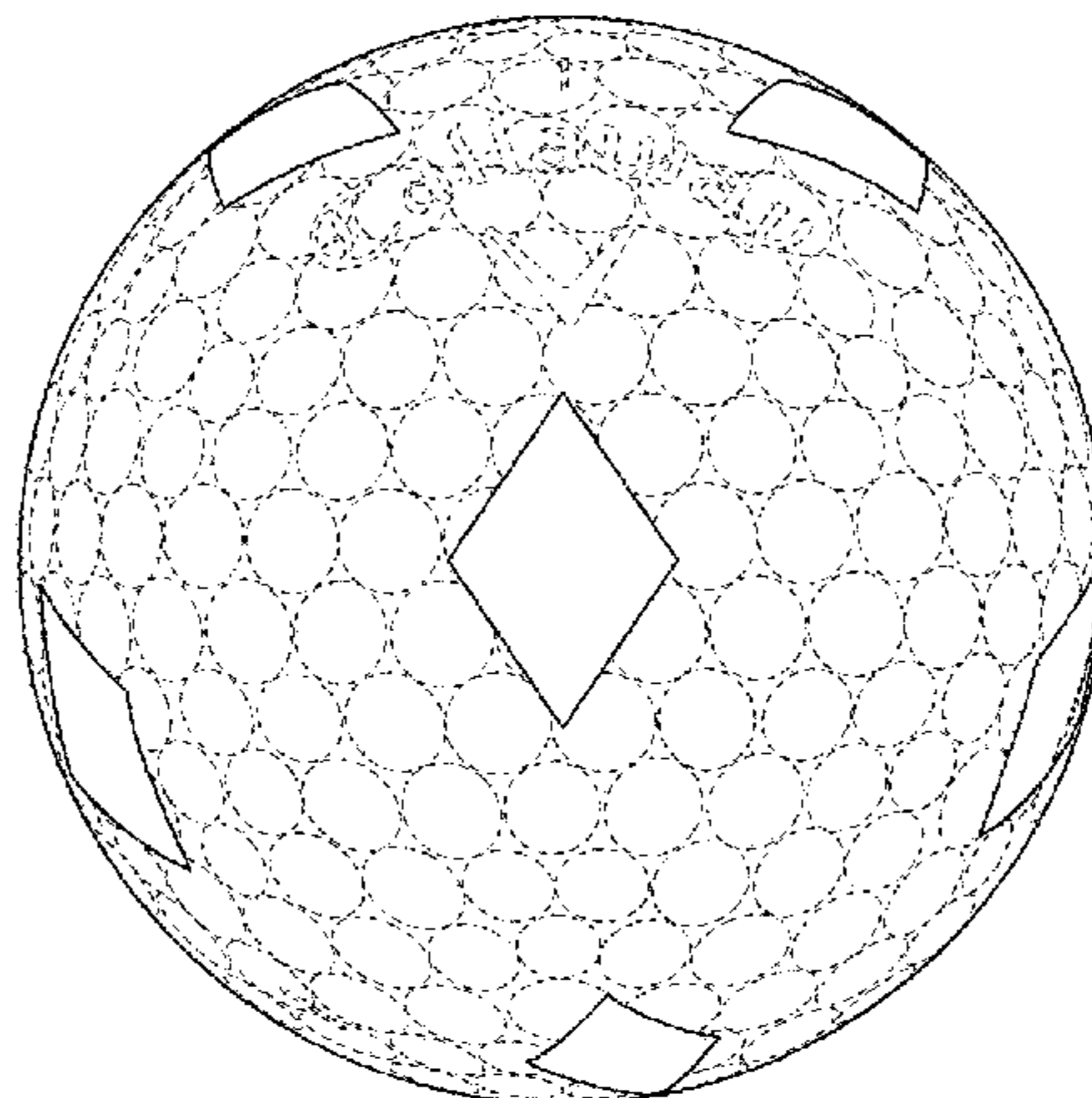
**DESCRIPTION**

FIG. 1 is a top plan view of a golf ball showing our new design;  
 FIG. 2 is bottom plan view thereof;  
 FIG. 3 is a front elevation view thereof;  
 FIG. 4 is a rear elevation view thereof;  
 FIG. 5 is a side elevation view thereof; and,  
 FIG. 6 is an opposing side elevation view thereof.  
 The broken lines depict portions of a golf ball which form no part of the claimed design.

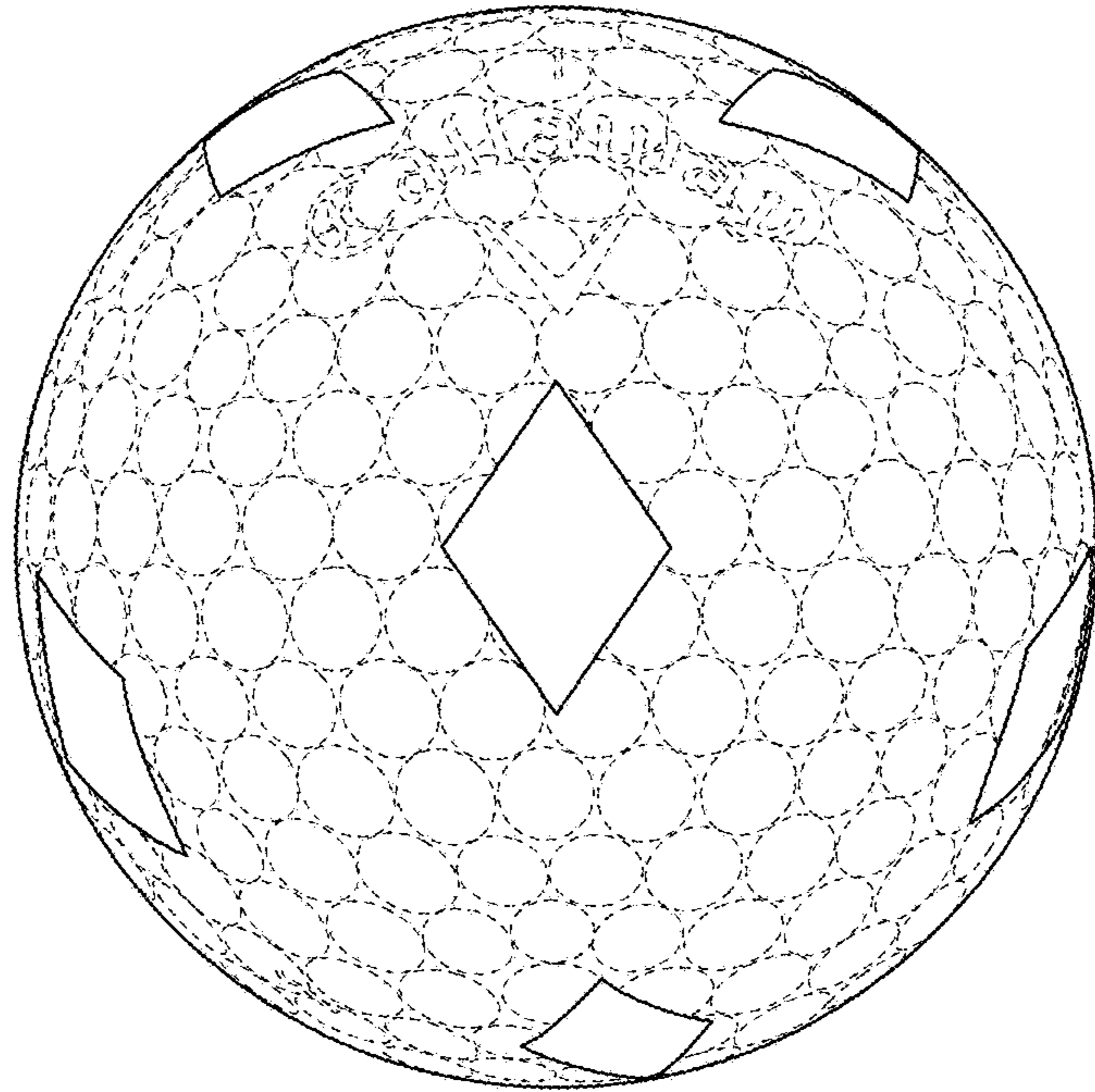

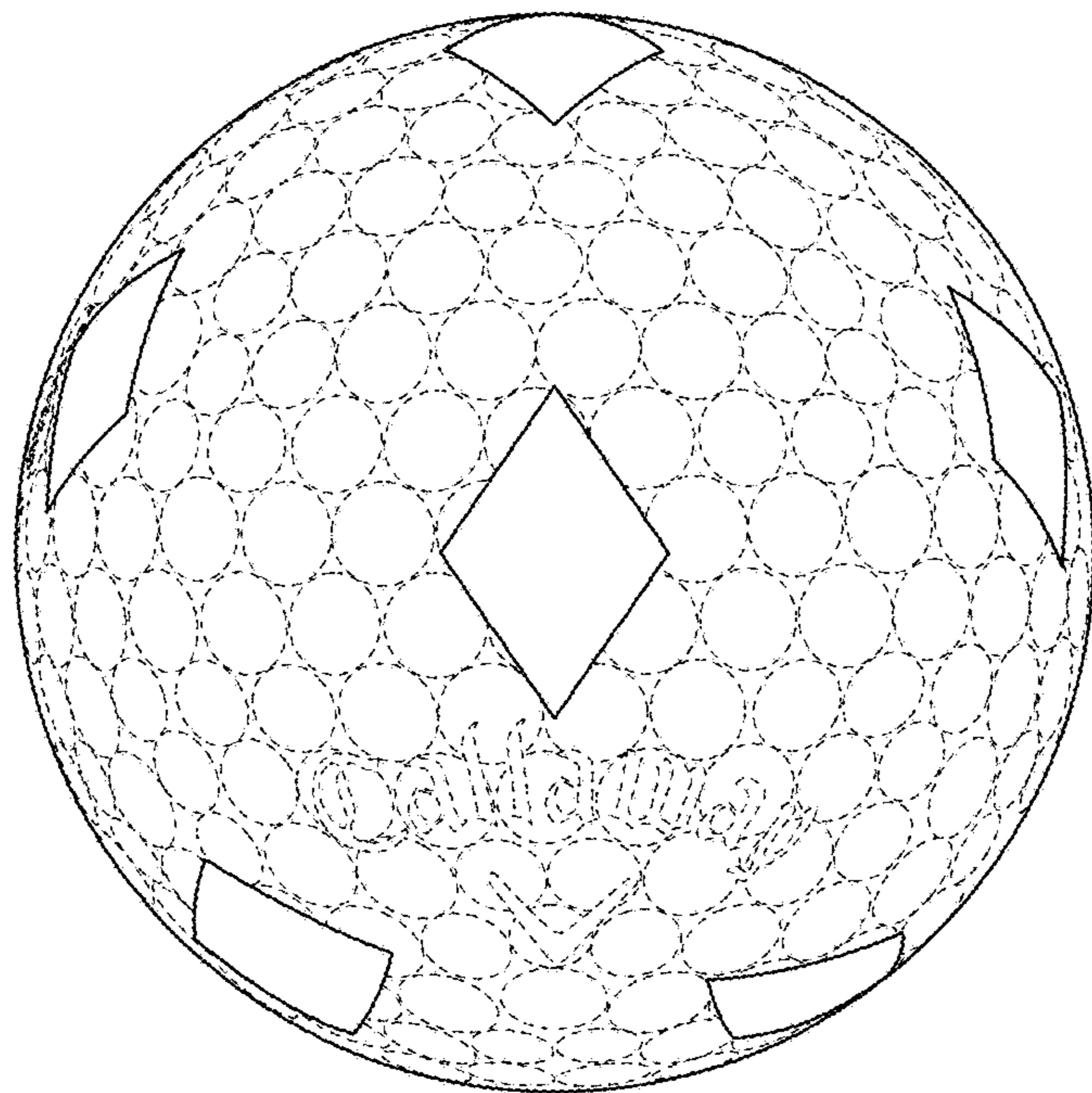

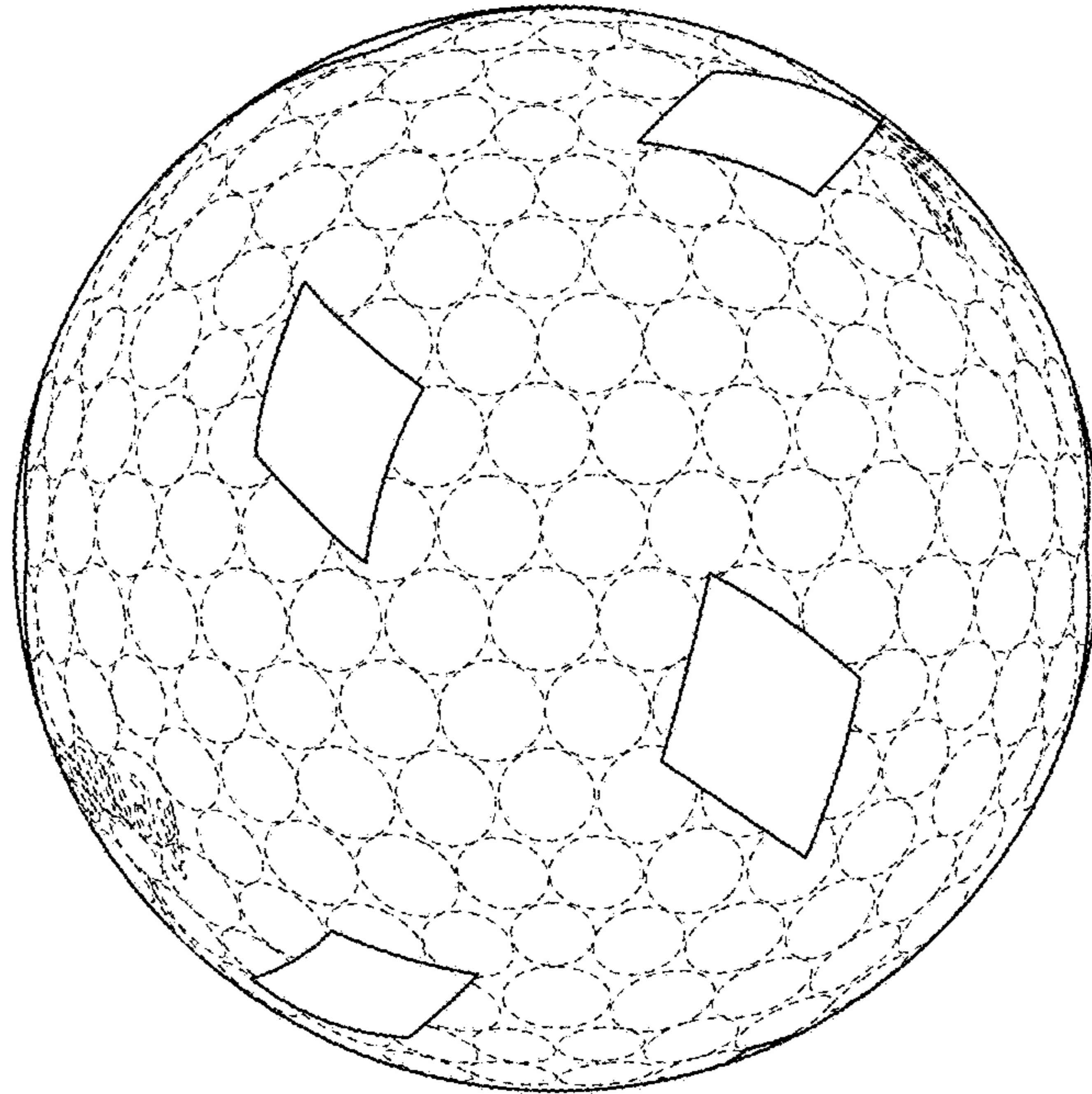

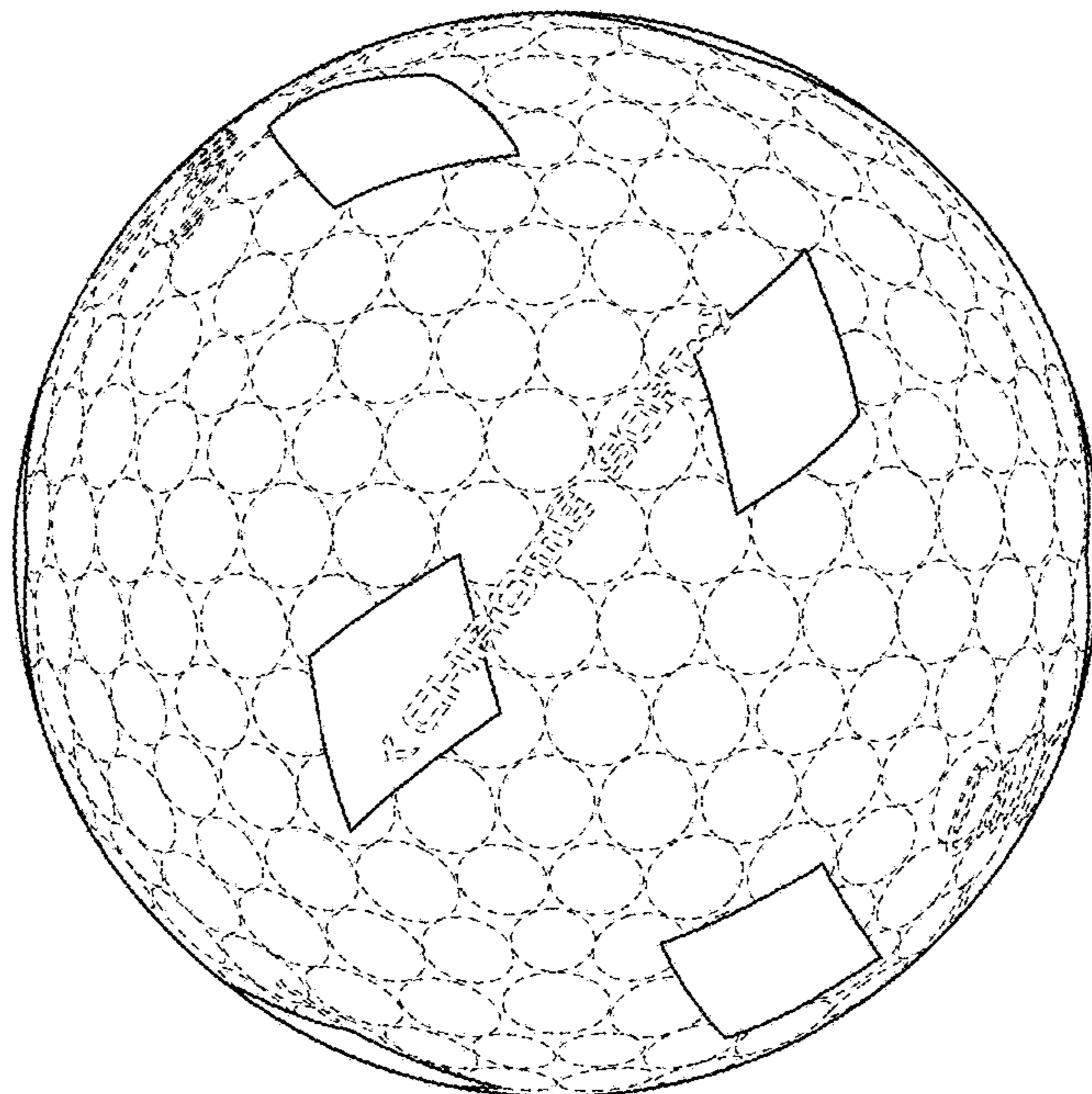

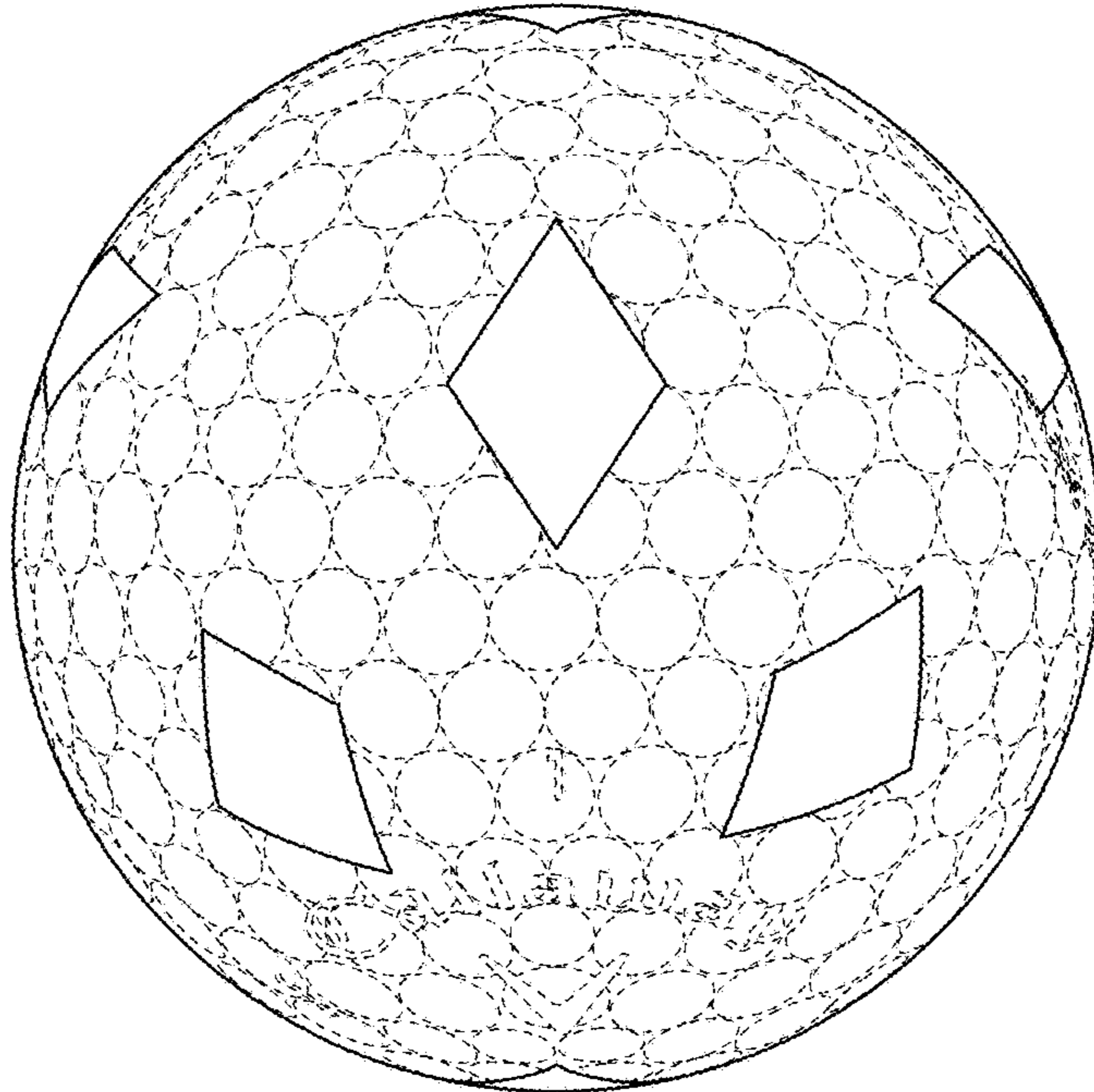

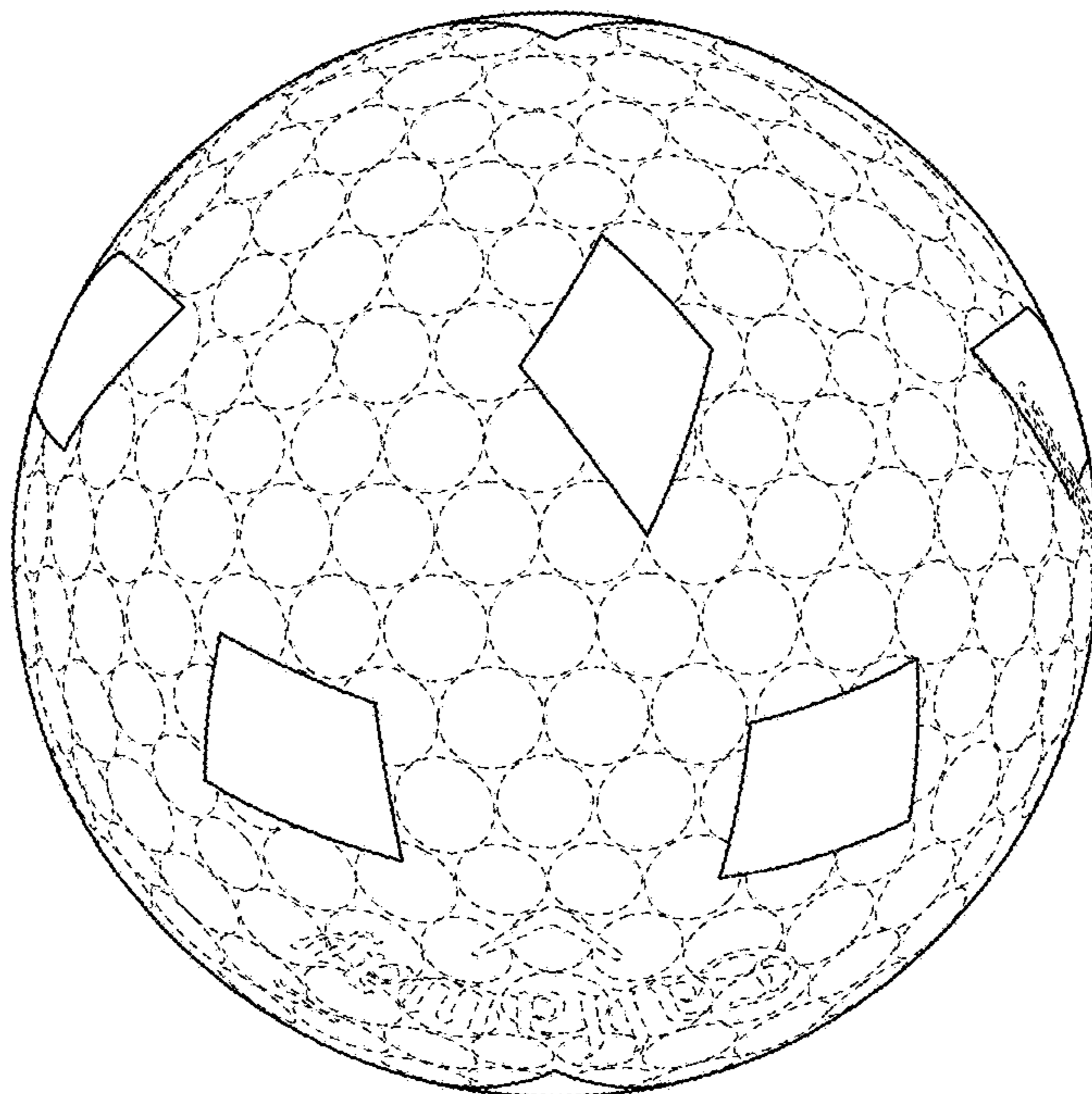
