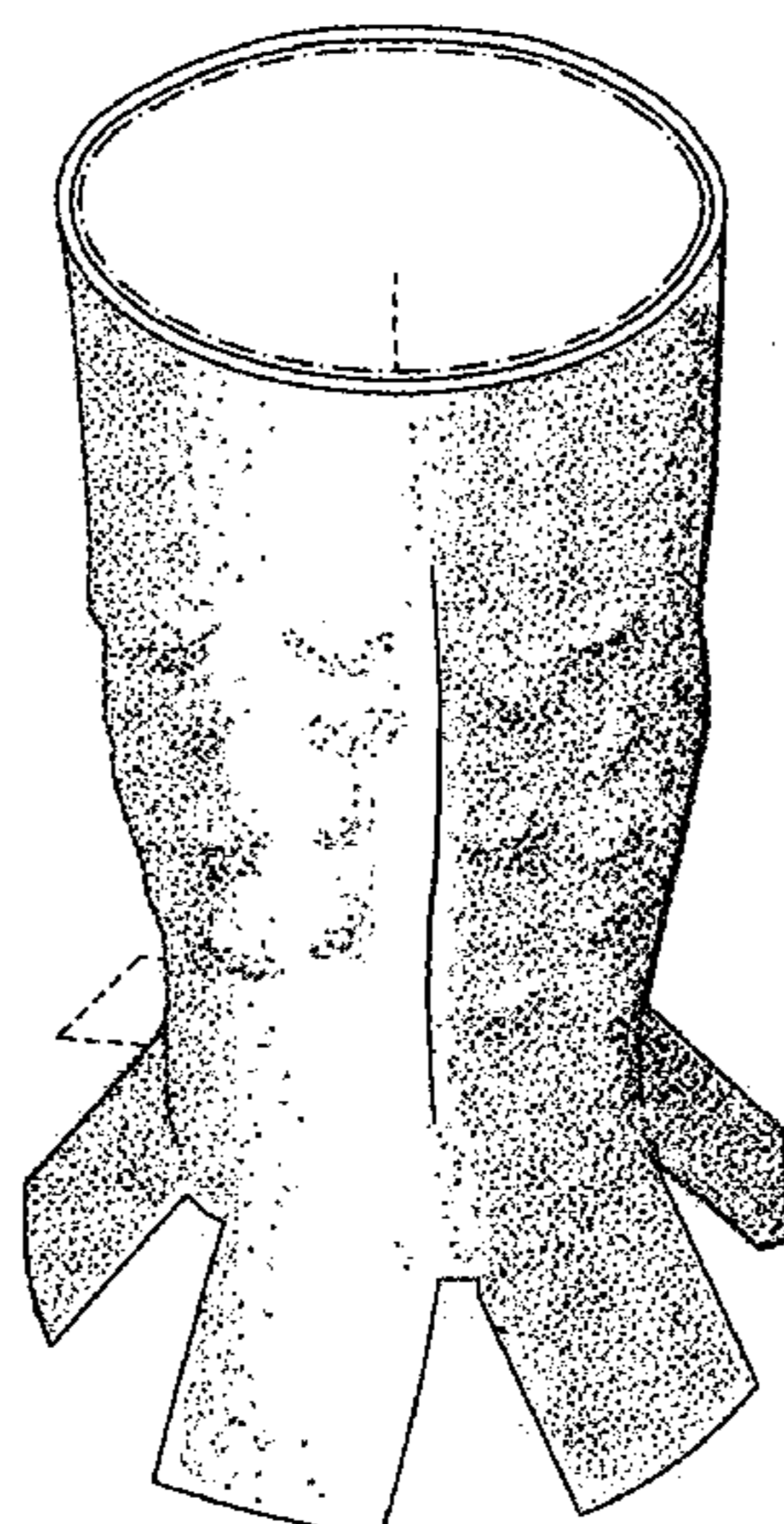
The sole FIGURE is a perspective view of a shotgun wad
