(57) **CLAIM**

The ornamental design for a shower or tub surround kit, substantially as shown in the attached drawings.

DESCRIPTION

FIG. 1 is a perspective view of the shower or tub surround kit design;

FIG. 2 is an exploded perspective view of the design corresponding to FIG. 1, with the components separated for completeness of illustration;

FIG. 3 is a perspective view of an edging component of the shower or tub surround shown removed from the kit corresponding to FIG. 1 for clarity of disclosure;

FIG. 4 is a top view of the edging component shown in FIG. 3;

FIG. 5 is a bottom view of the edging component shown in FIG. 3;

FIG. 6 is a right side view of the edging component shown in FIG. 3;

FIG. 7 is a left side view of the edging component shown in FIG. 3;

FIG. 8 is a front view of the edging component shown in FIG. 3;

FIG. 9 is a back view of the edging component shown in FIG. 3;

FIG. 10 is a perspective view of a corner-side component of the shower or tub surround shown removed from the kit corresponding to FIG. 1 for clarity of disclosure;

FIG. 13 is a right side view of the corner-side component shown in FIG. 10;

FIG. 19 is a bottom view of the corner component shown in FIG. 17;

FIG. 20 is a right side view of the corner component shown in FIG. 17;

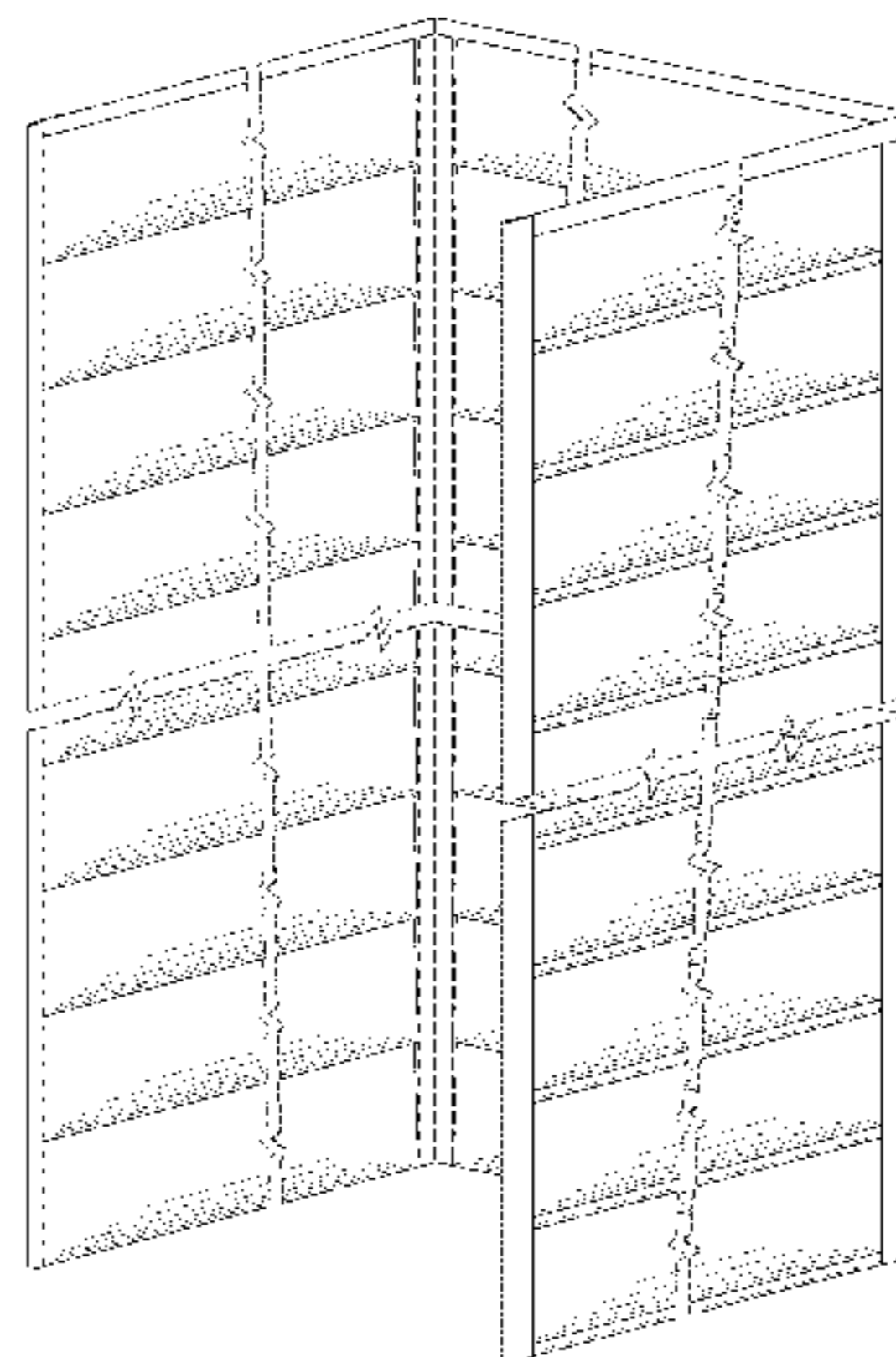


FIG. 23 is a back view of the corner component shown in FIG. 17;

 FIG. 32 is an exploded perspective view of the corner-side component assembled to the corner component as shown in FIG. 31, with the components separated for completeness of illustration;
 FIG. 33 is a perspective view of the shower or tub surround kit design shown as it may be installed on a bathtub, wherein the bathtub, handle, and faucet are shown in dashed lines to indicate environment and do not form a part of the design;
 and,
 FIG. 34 is a perspective view of the shower or tub surround kit design shown as it may be installed on a shower, wherein the shower pan, handle, and shower head are shown in dashed lines to indicate environment and do not form a part of the design.

The claim is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design.

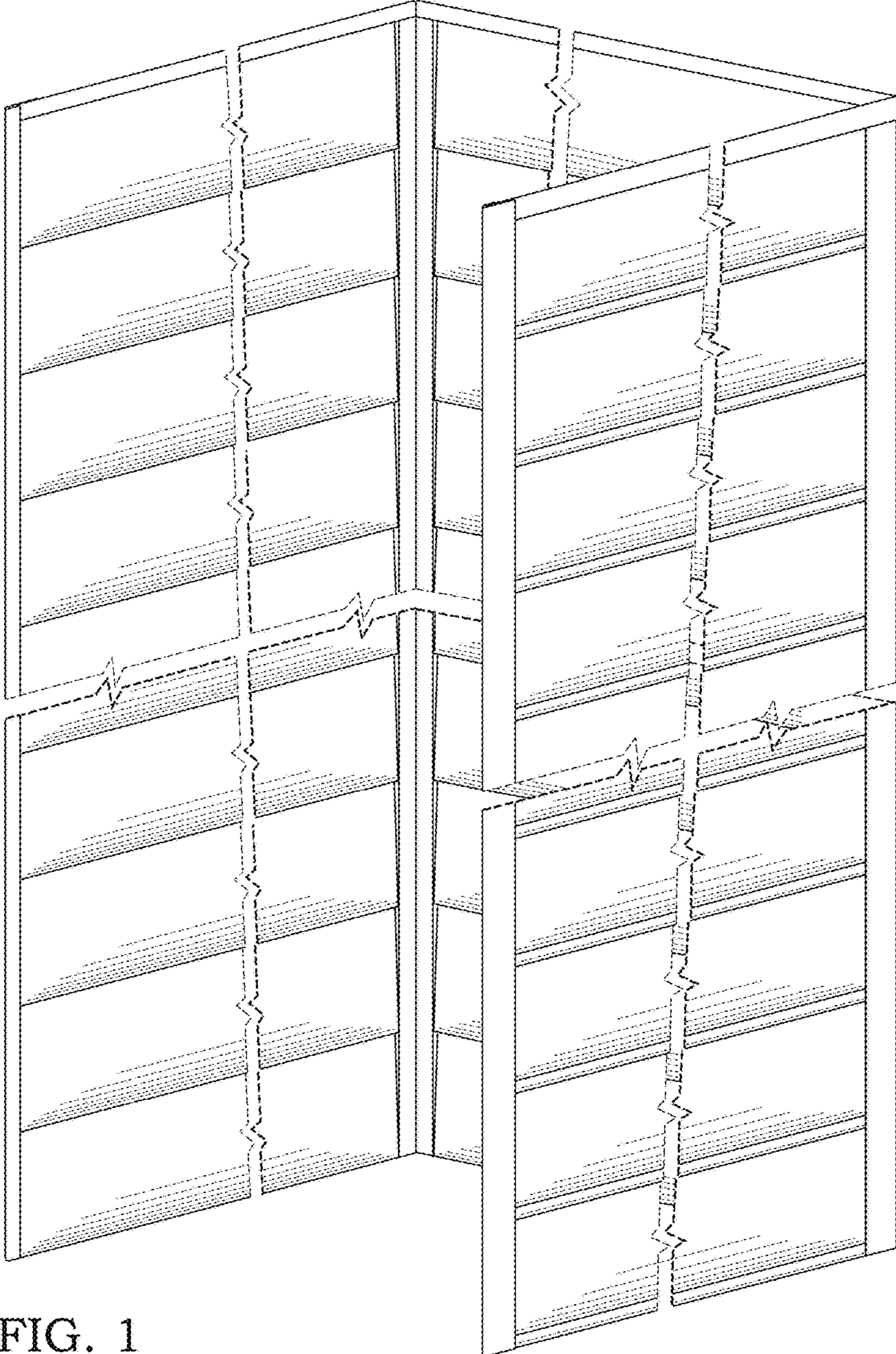

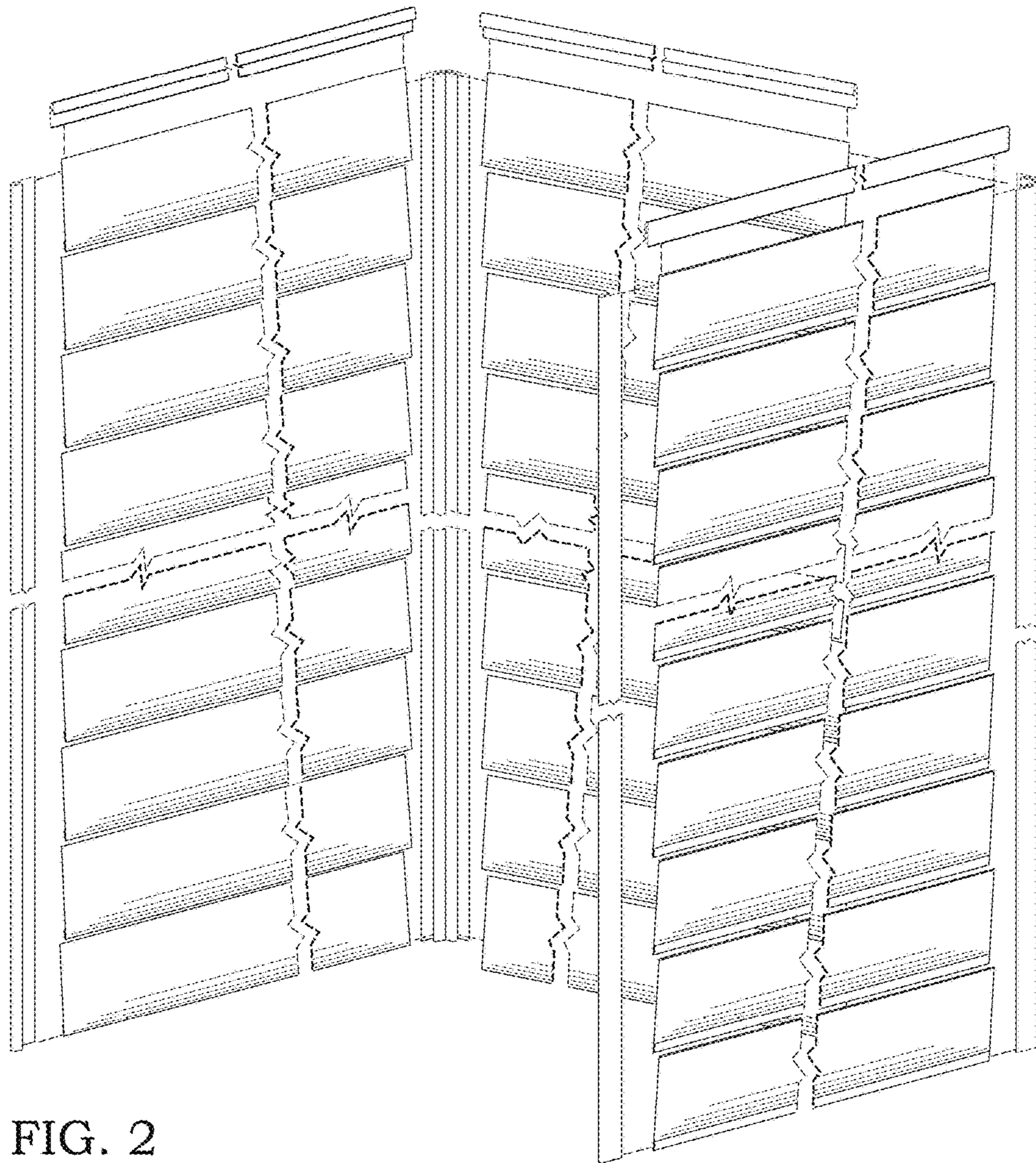

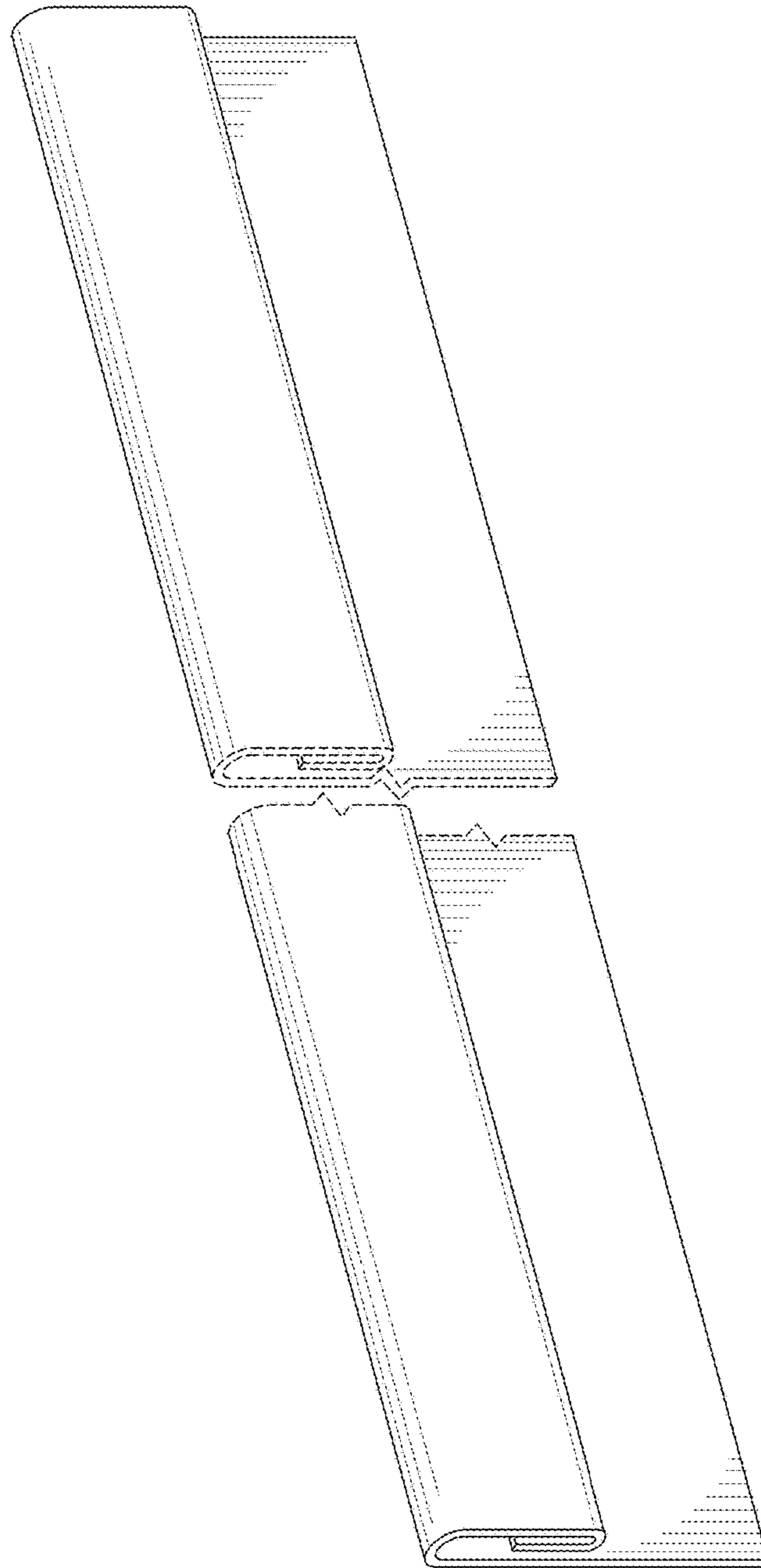

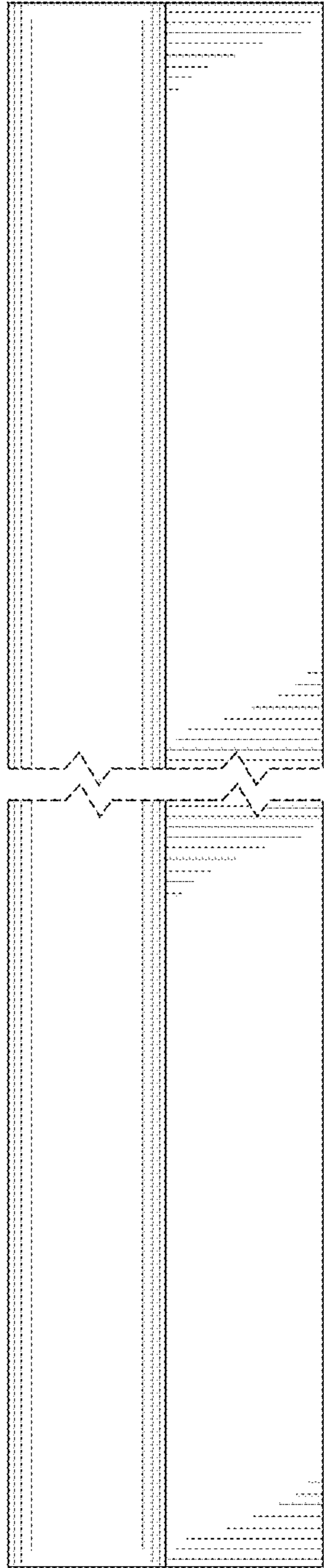

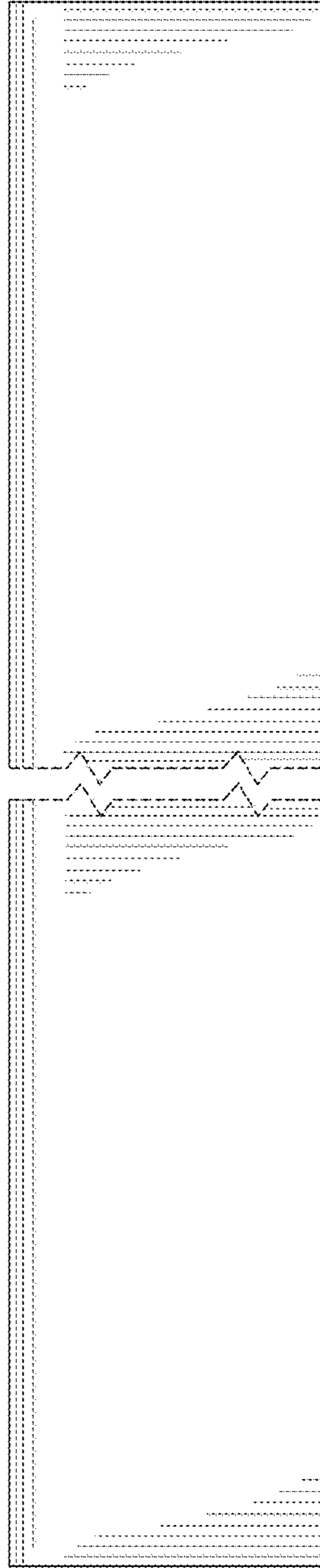

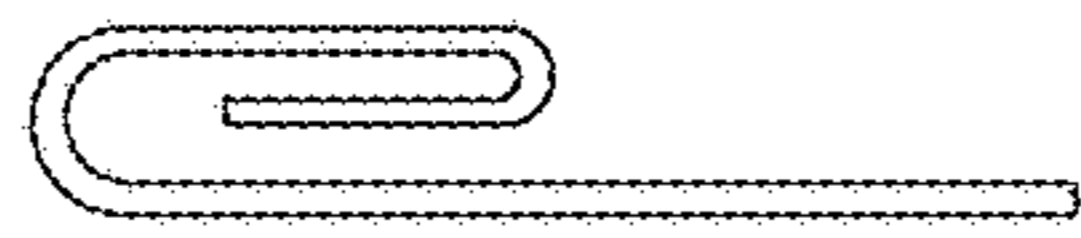

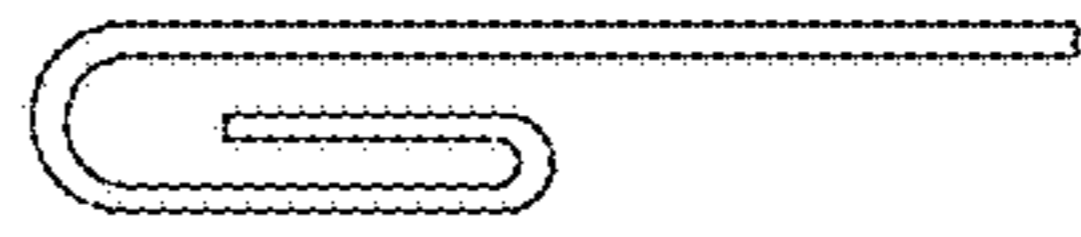

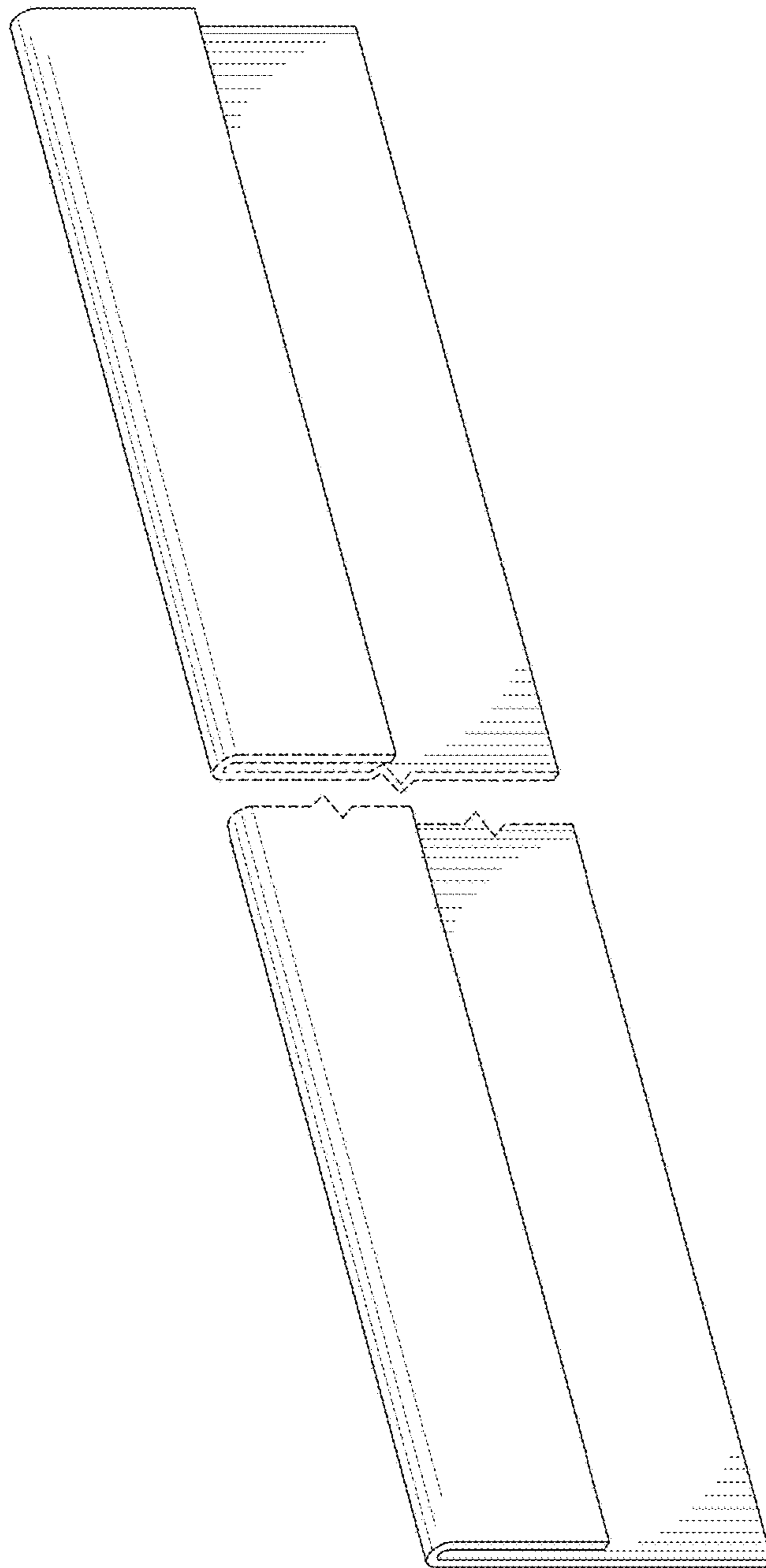

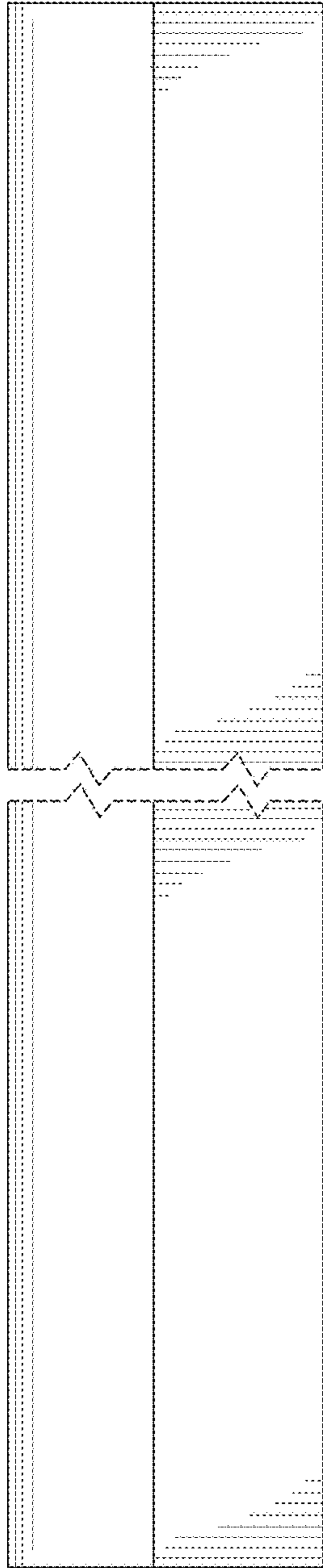

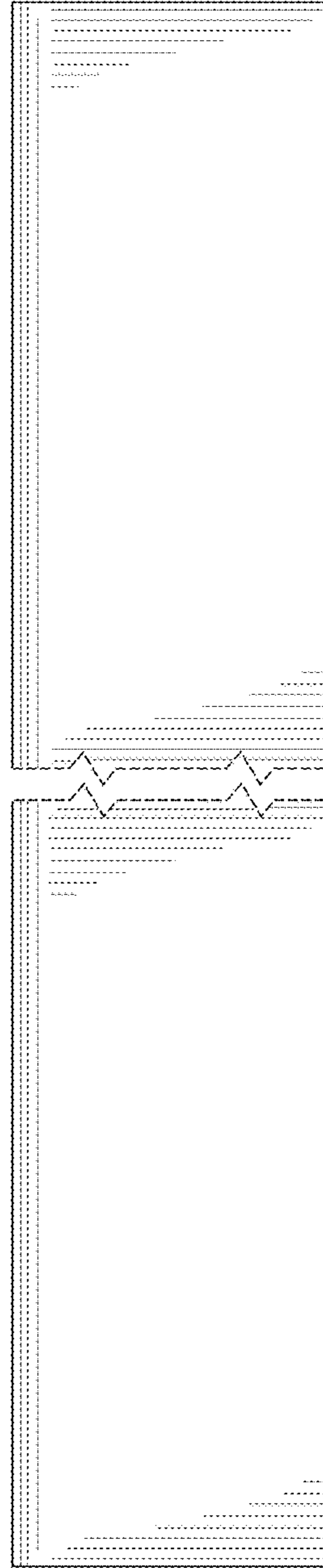

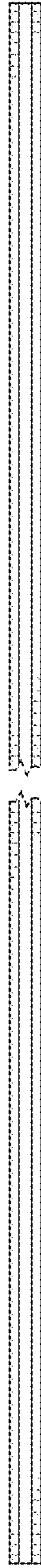

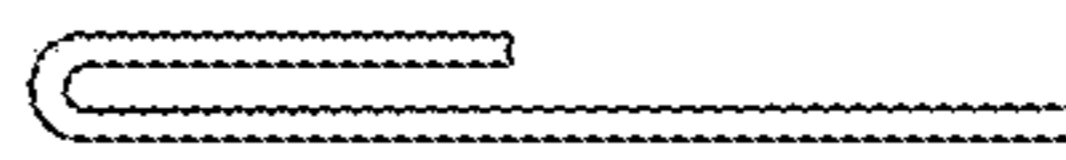

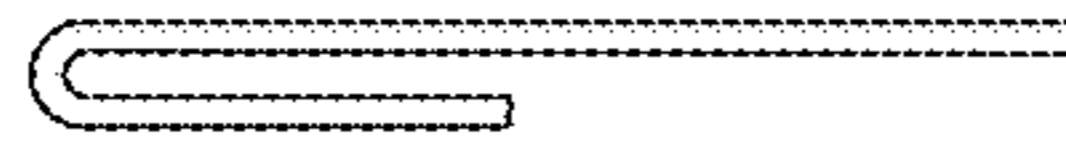

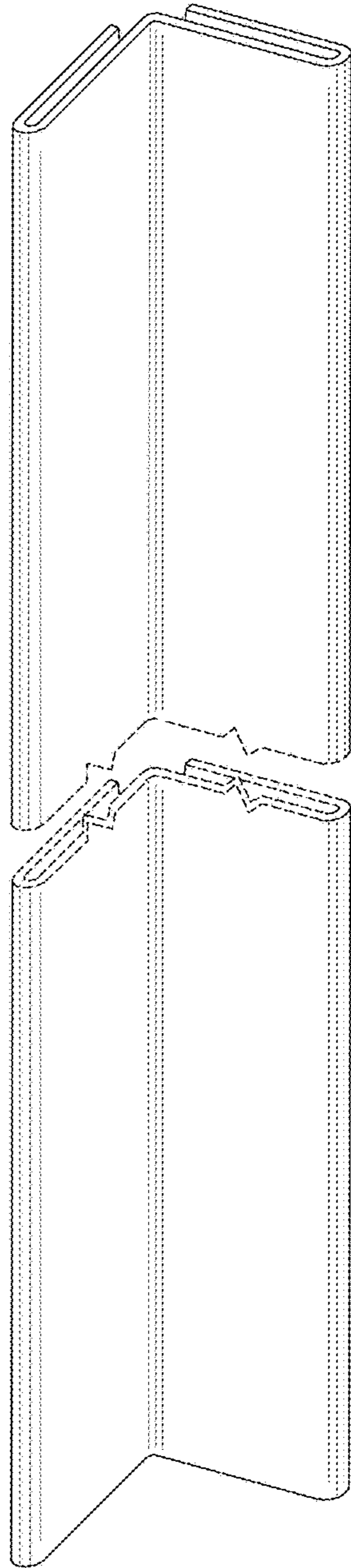

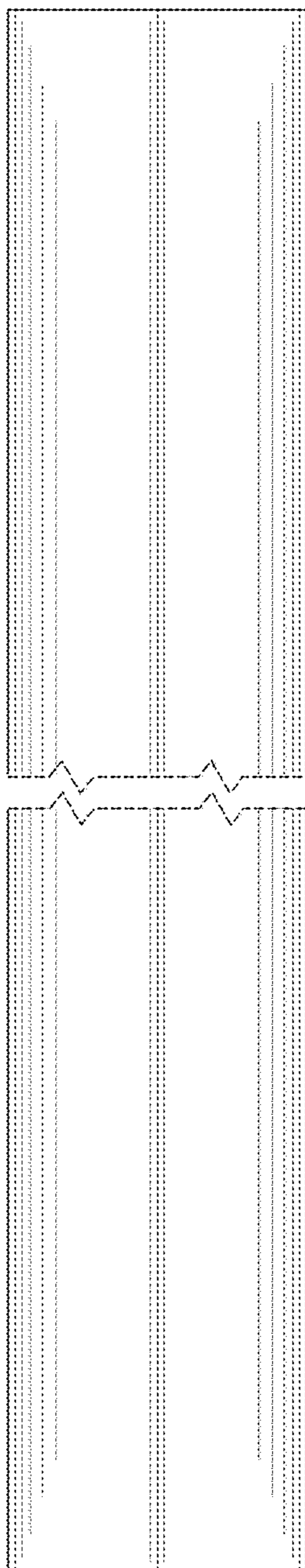

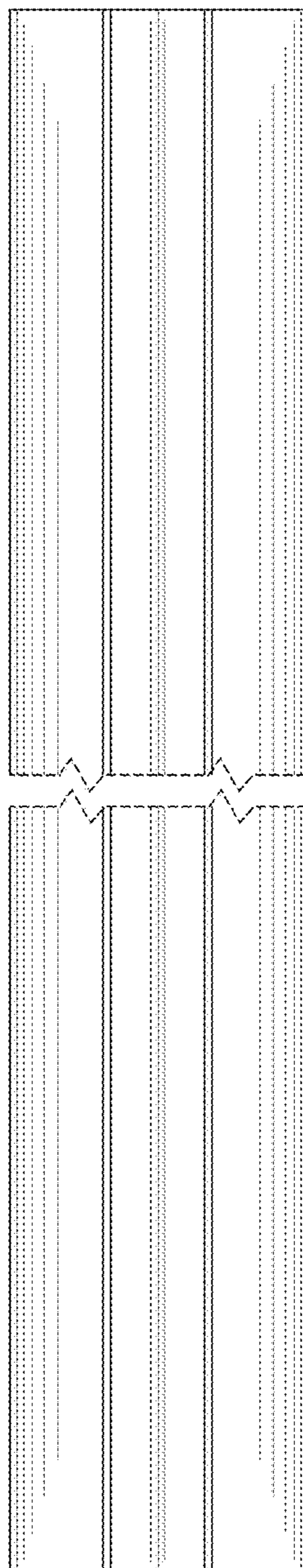

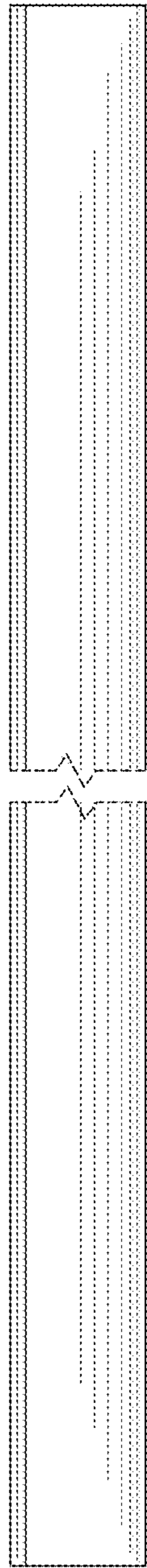

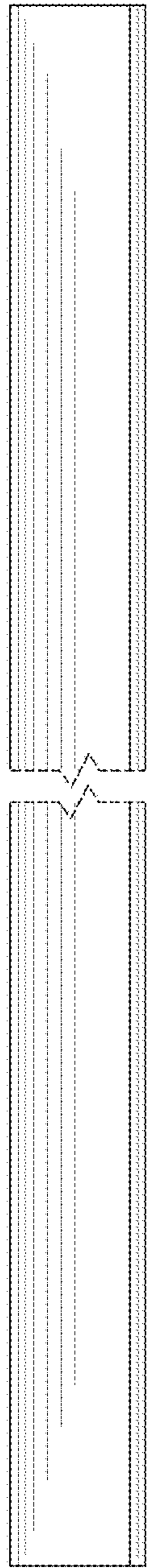

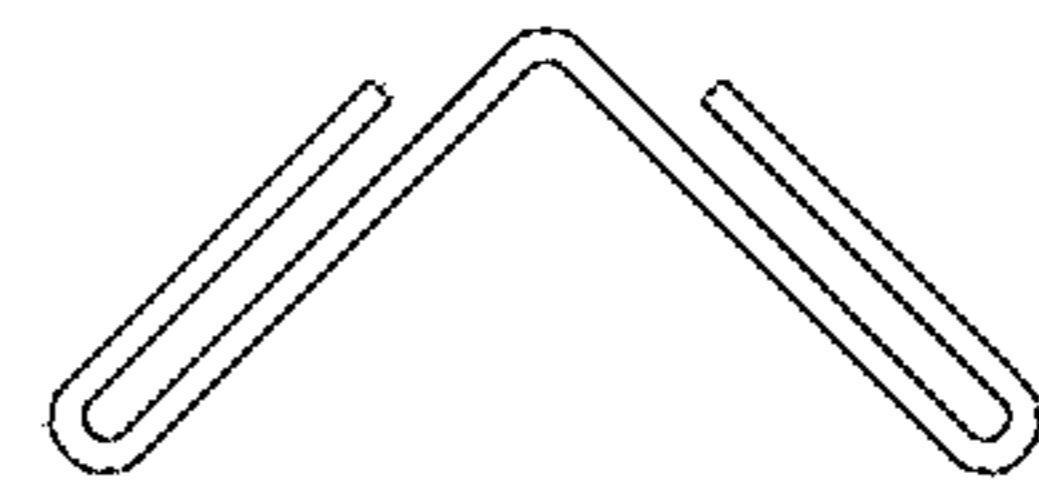

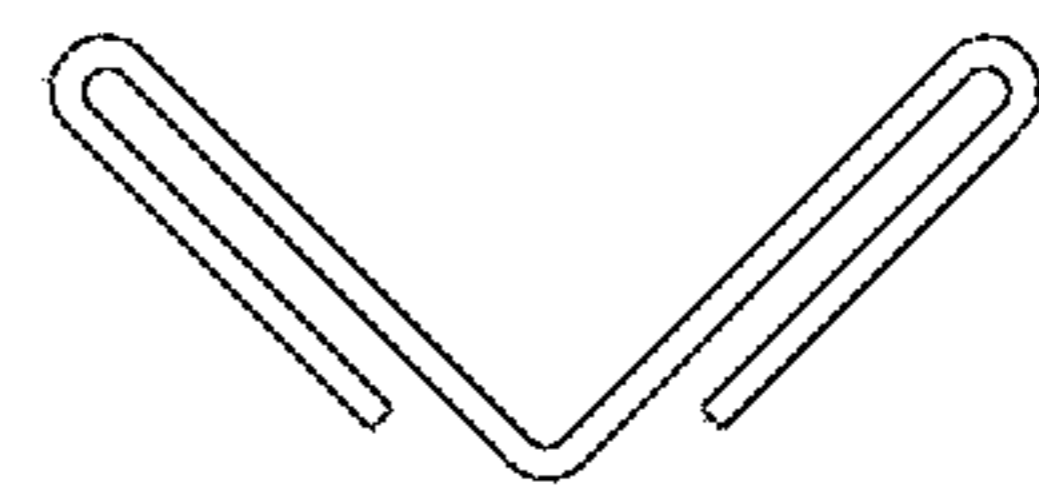

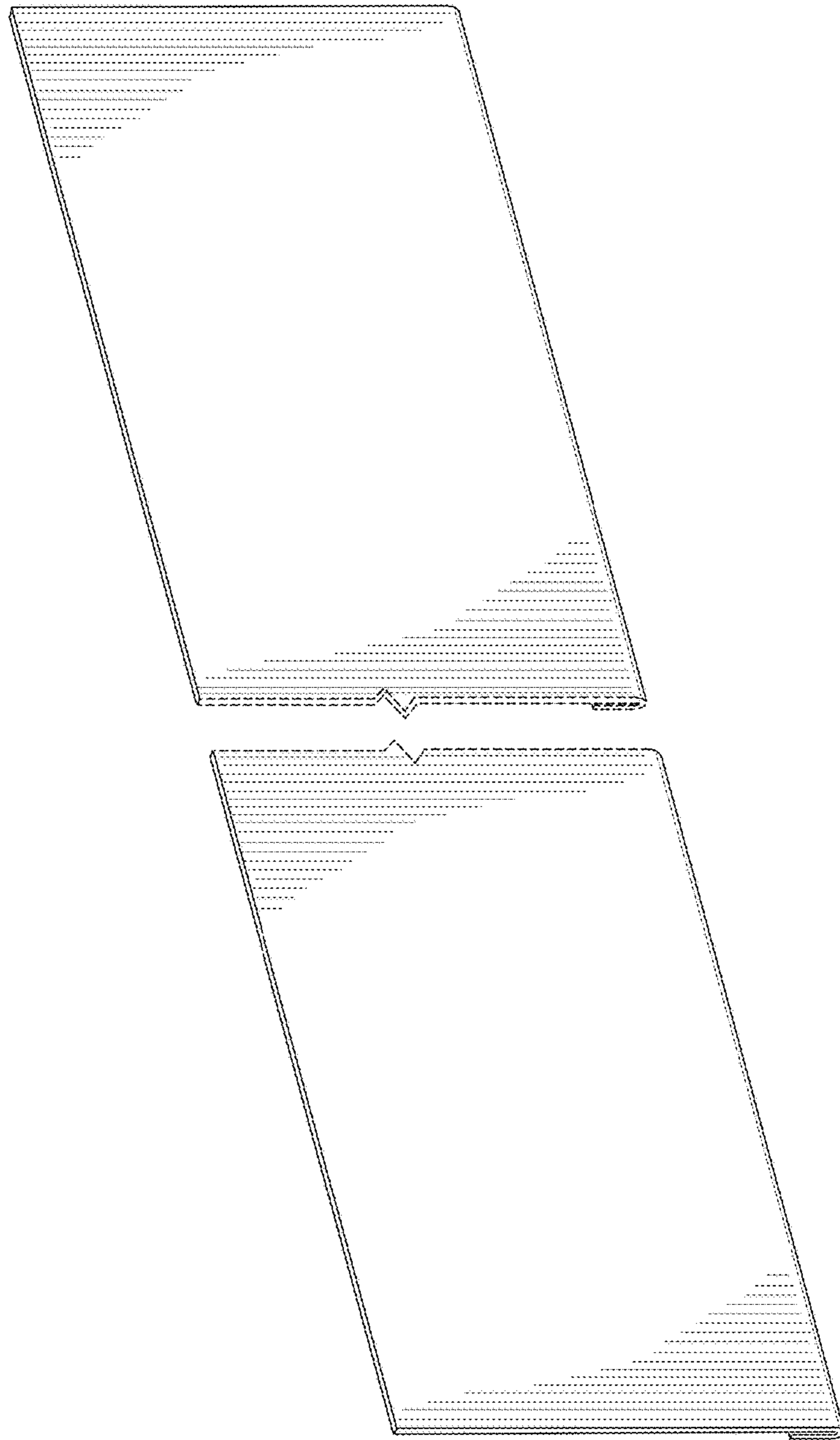

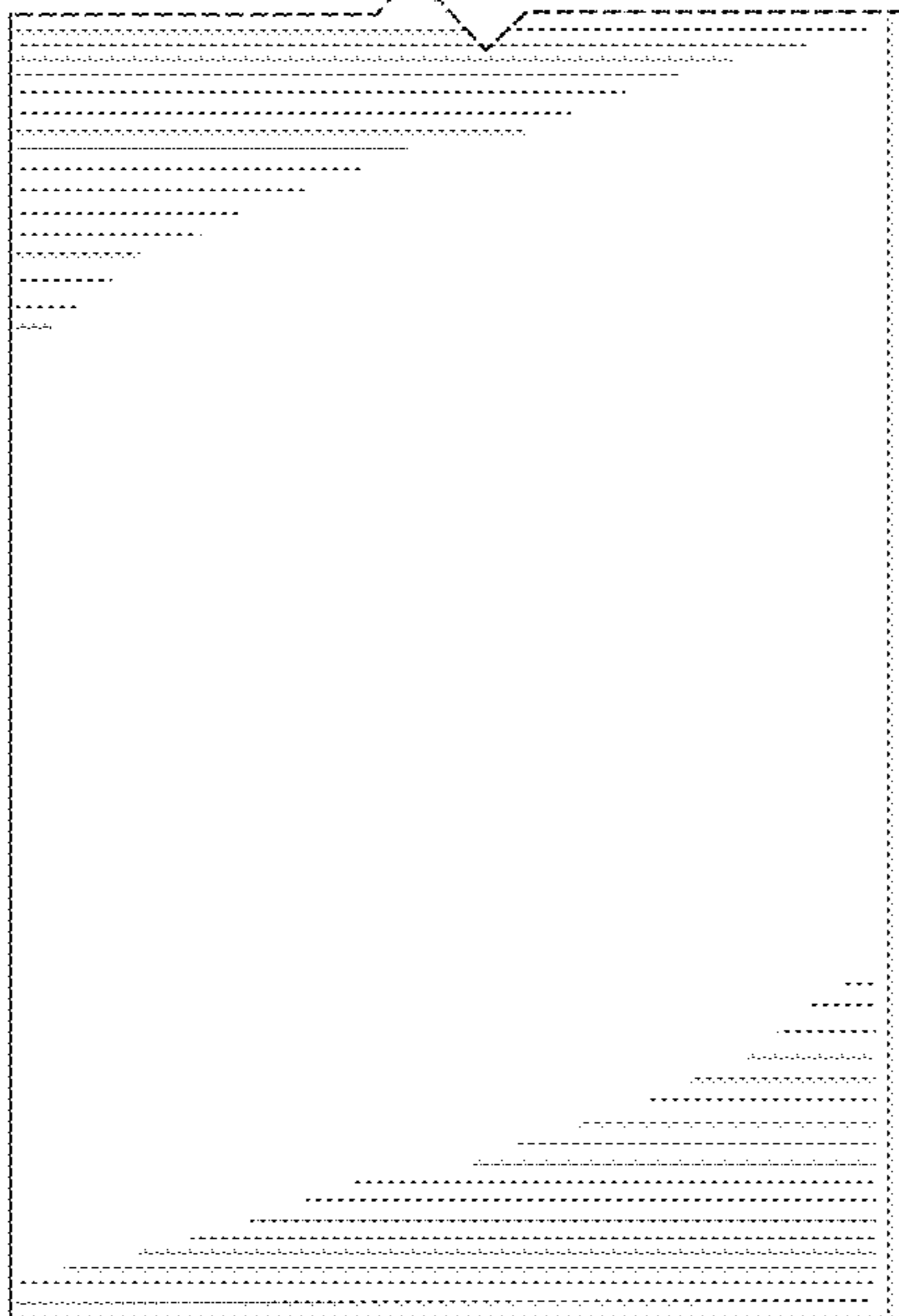
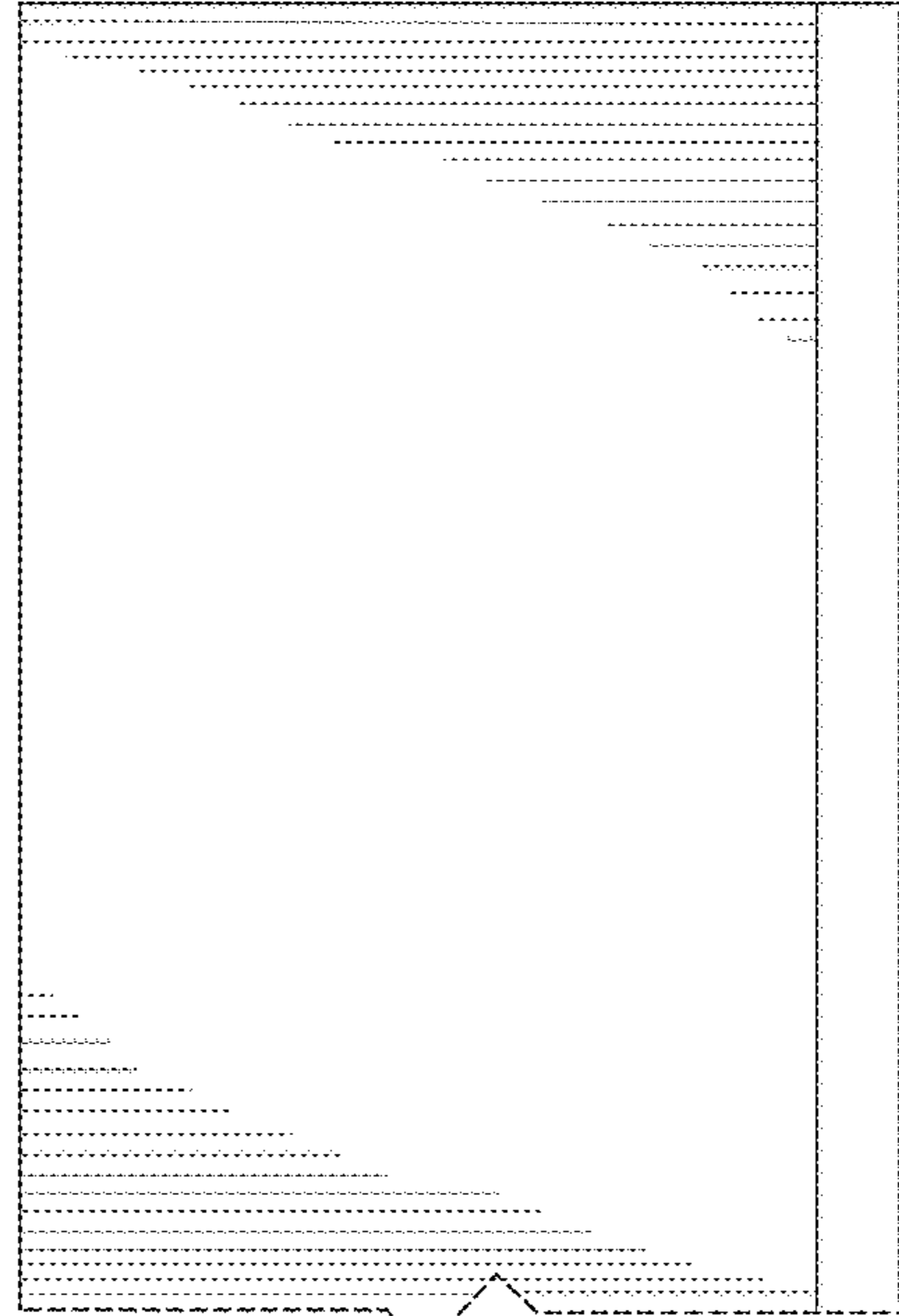
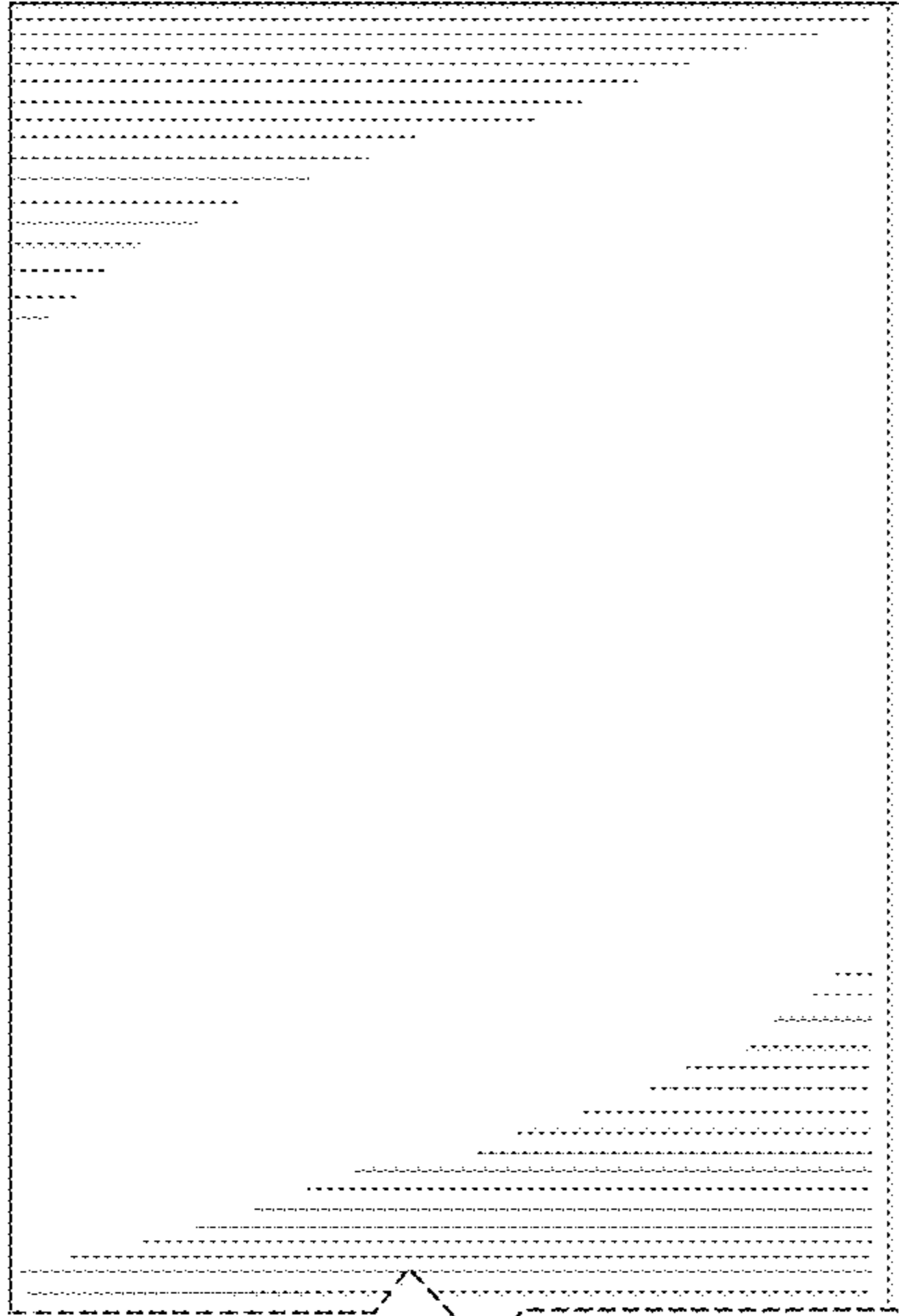

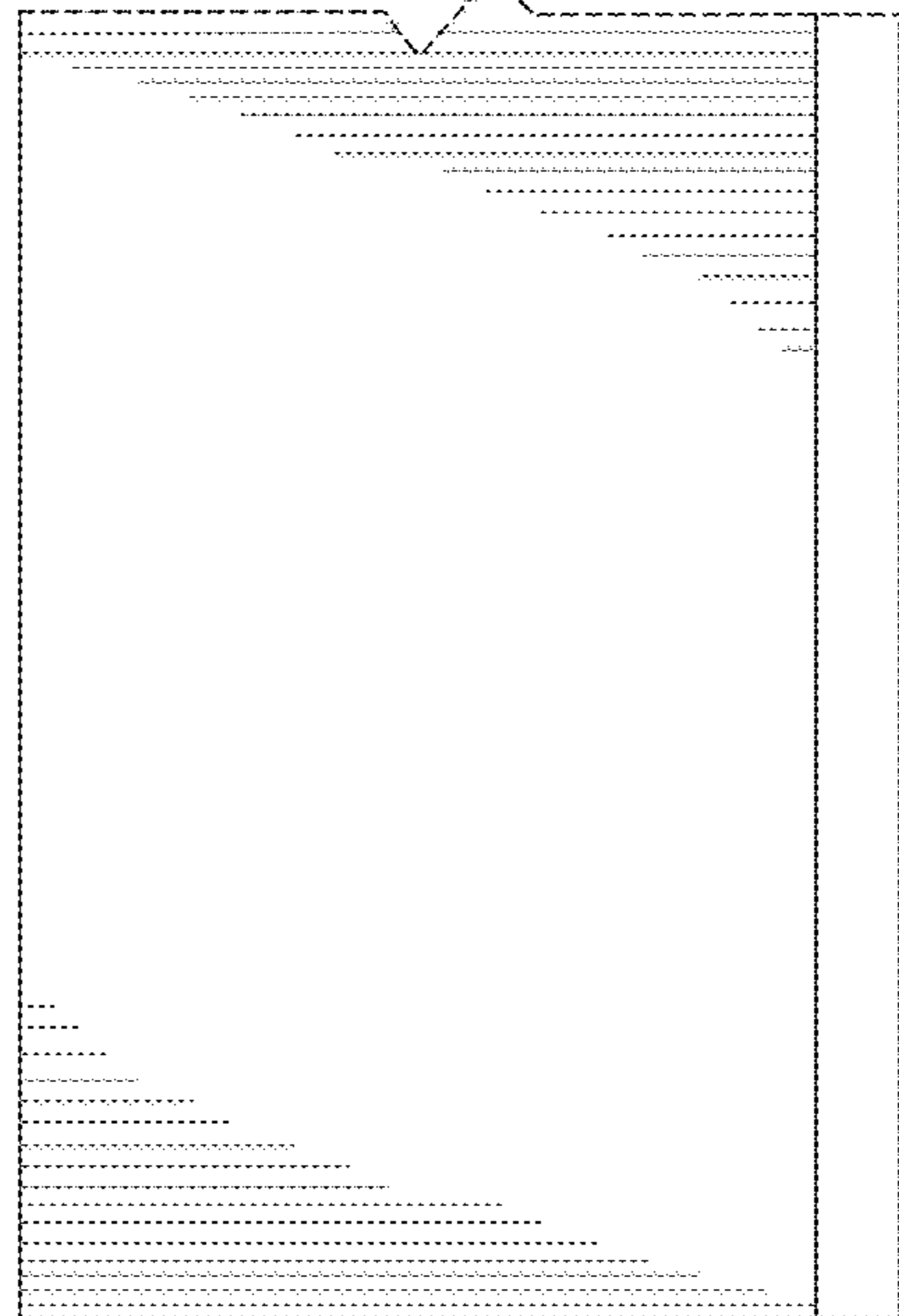

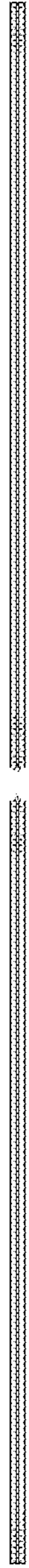

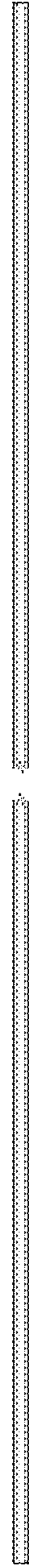

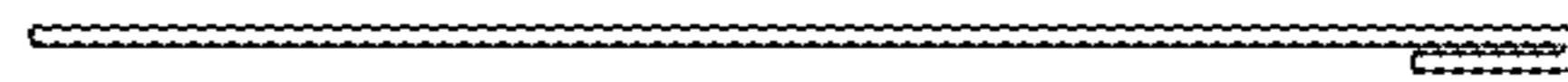

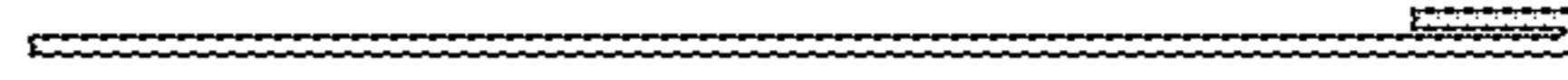

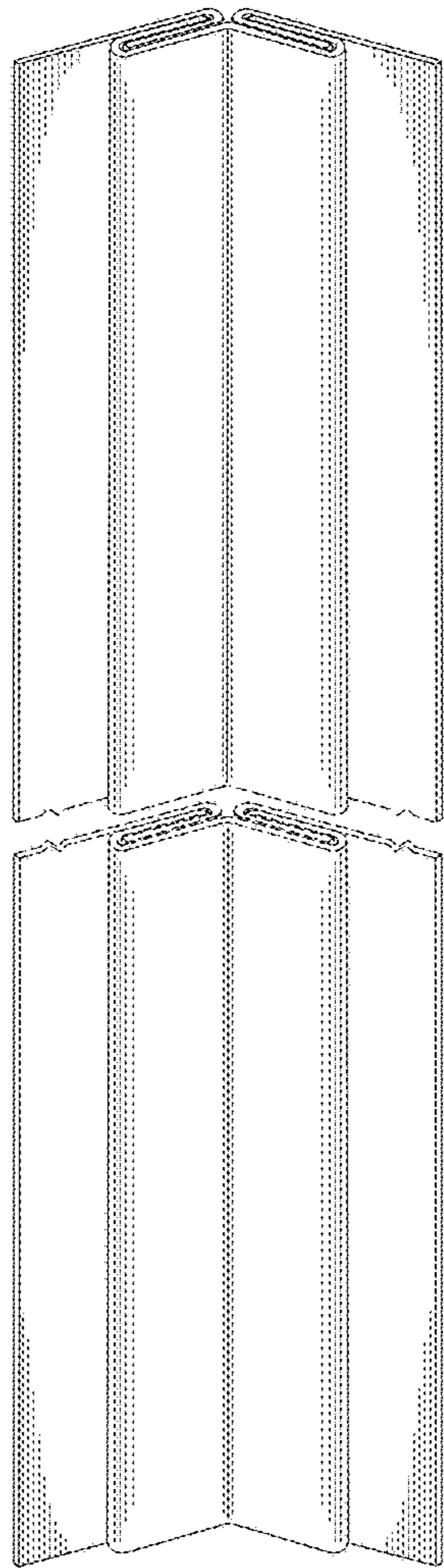

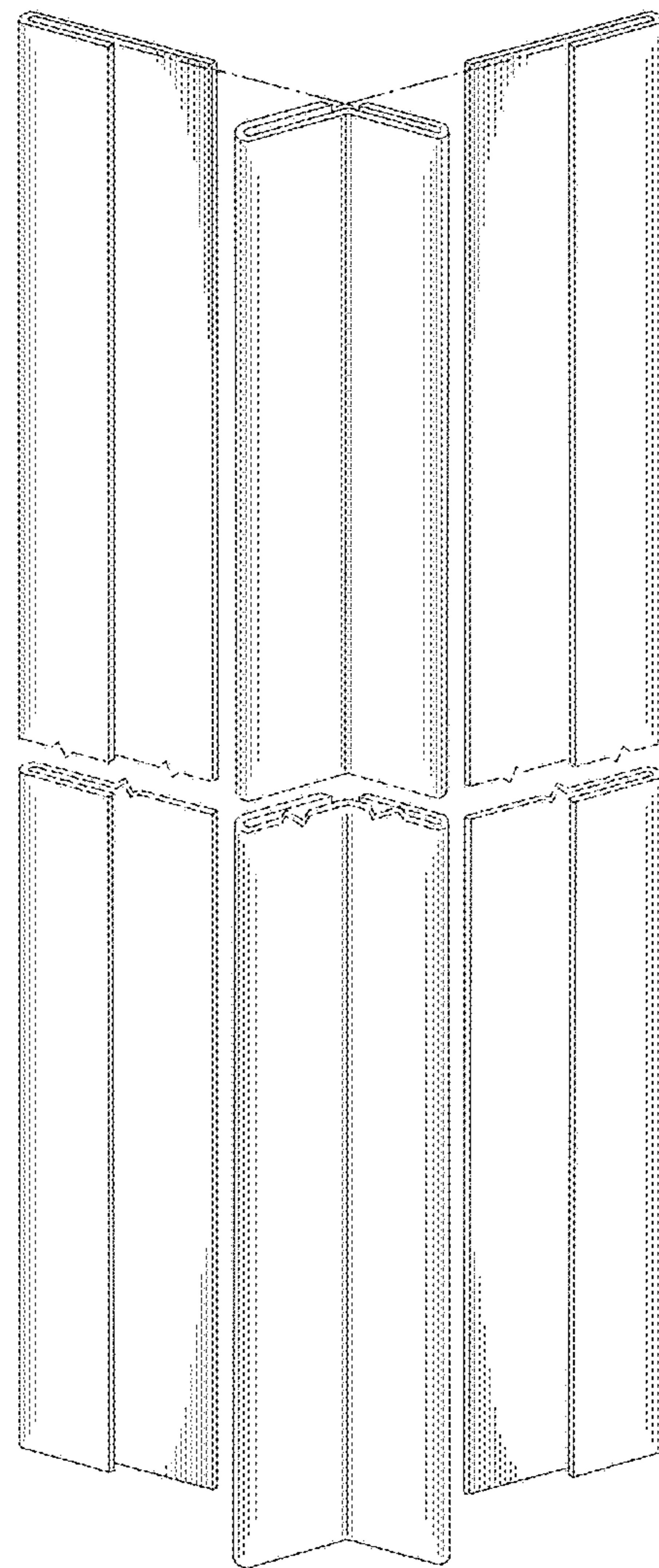

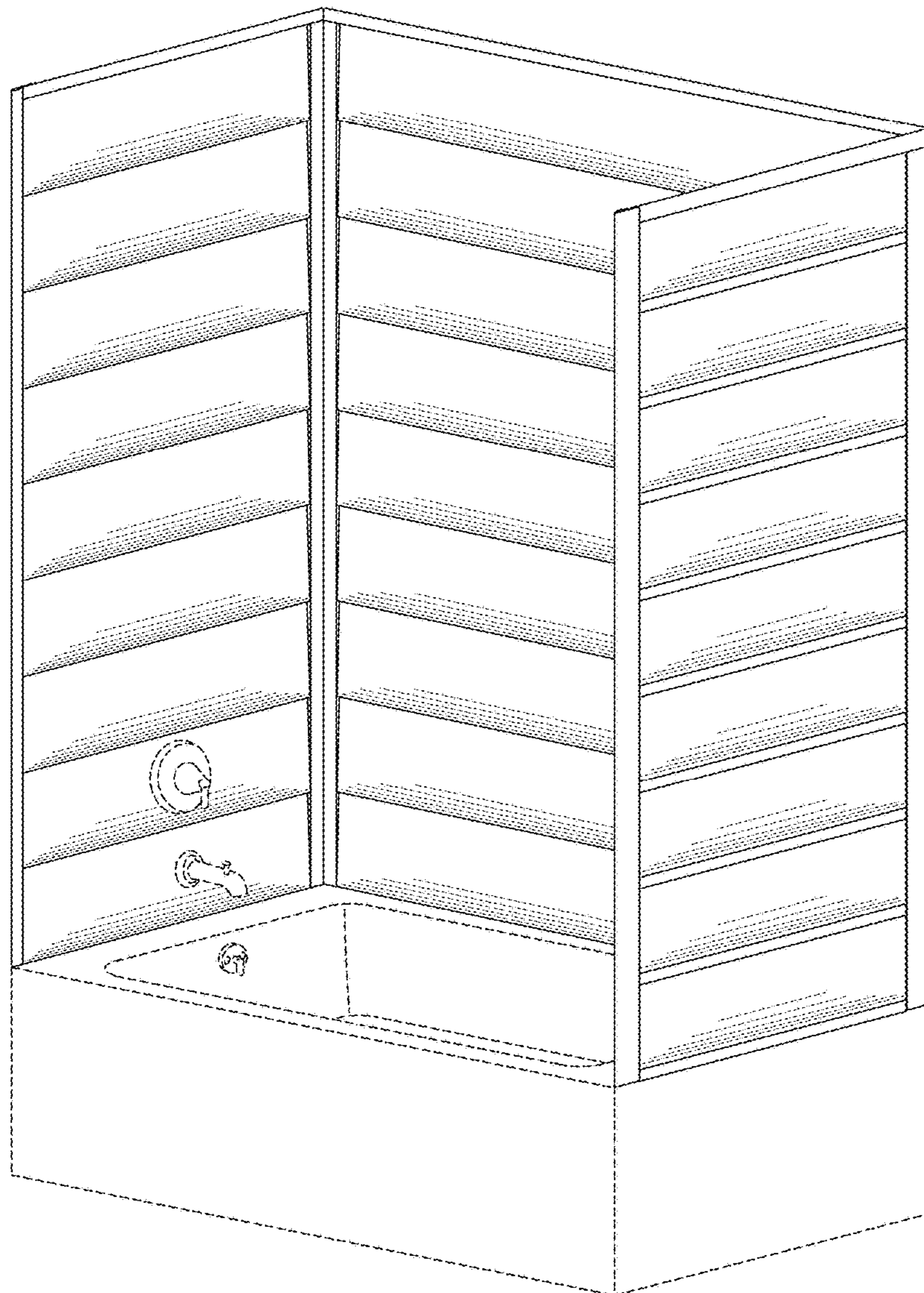

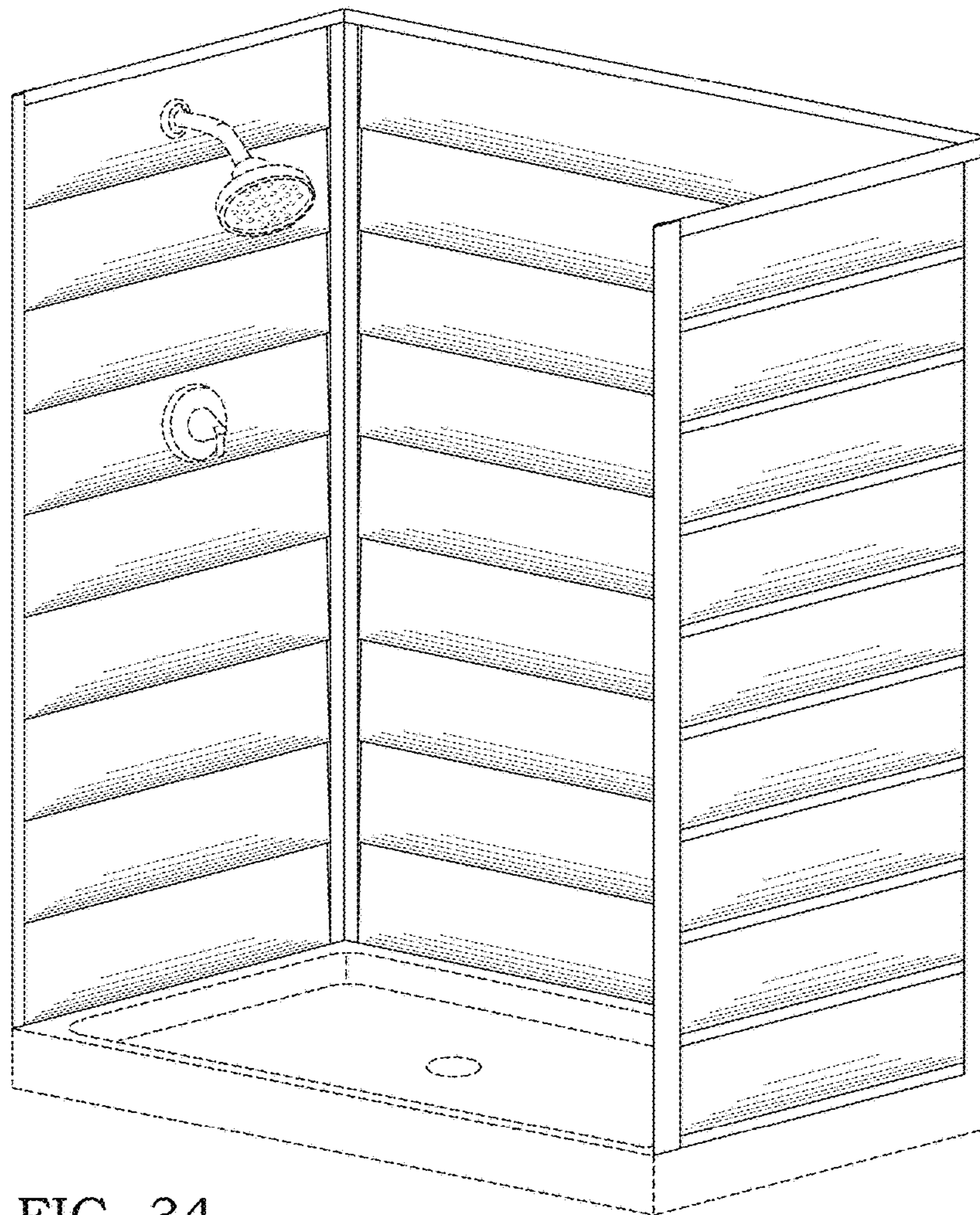
