(57) **CLAIM**

The ornamental design for outdoor unit for air-conditioner, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an outdoor unit for air-conditioner showing our new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a plan view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a left side view thereof; FIG. 7 is a right side view thereof; and, FIG. 8 is a cross-sectional view thereof along the line 8-8 in FIG. 2.

The broken lines depict portions of the outdoor unit for air-conditioner that form no part of claimed design.

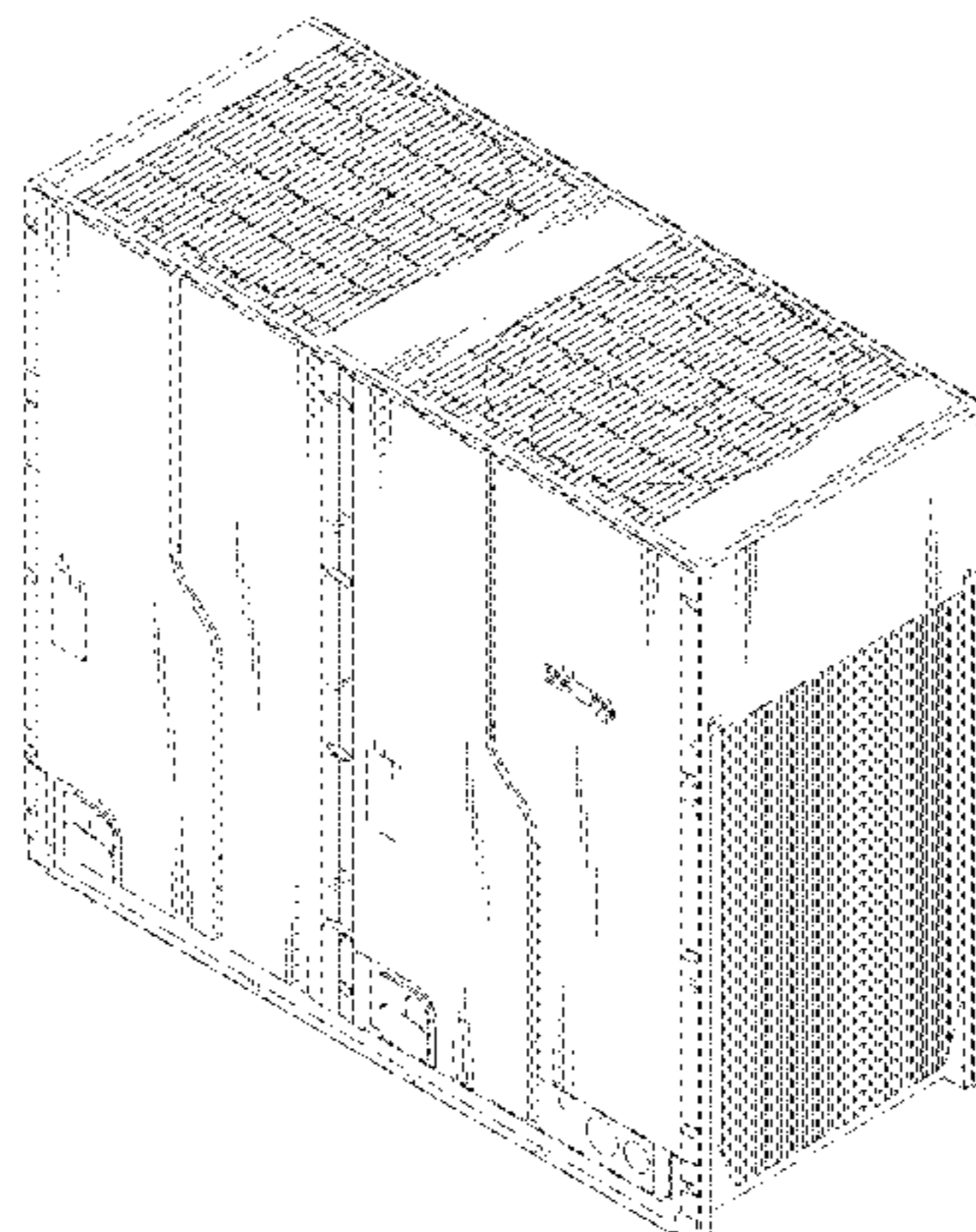

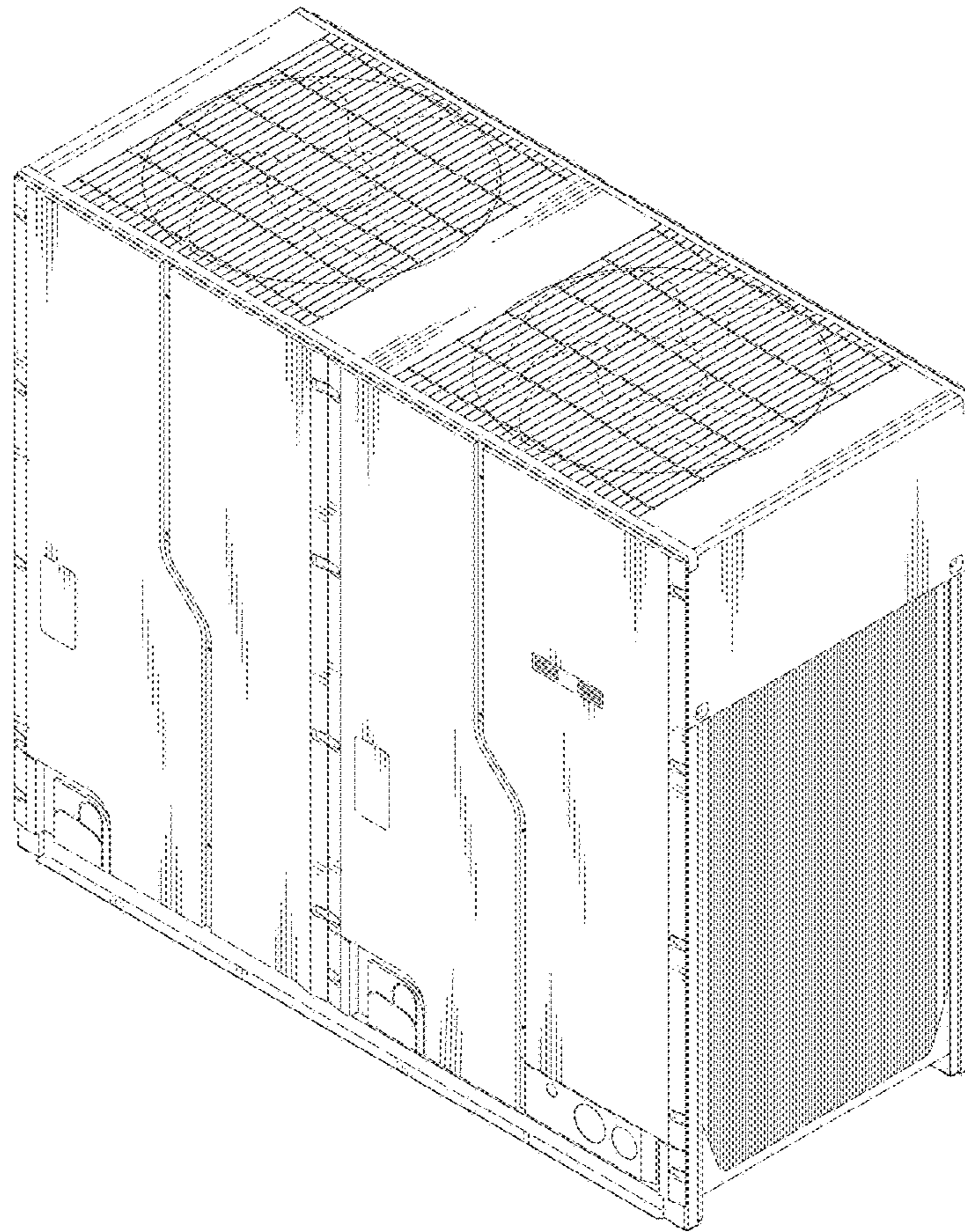

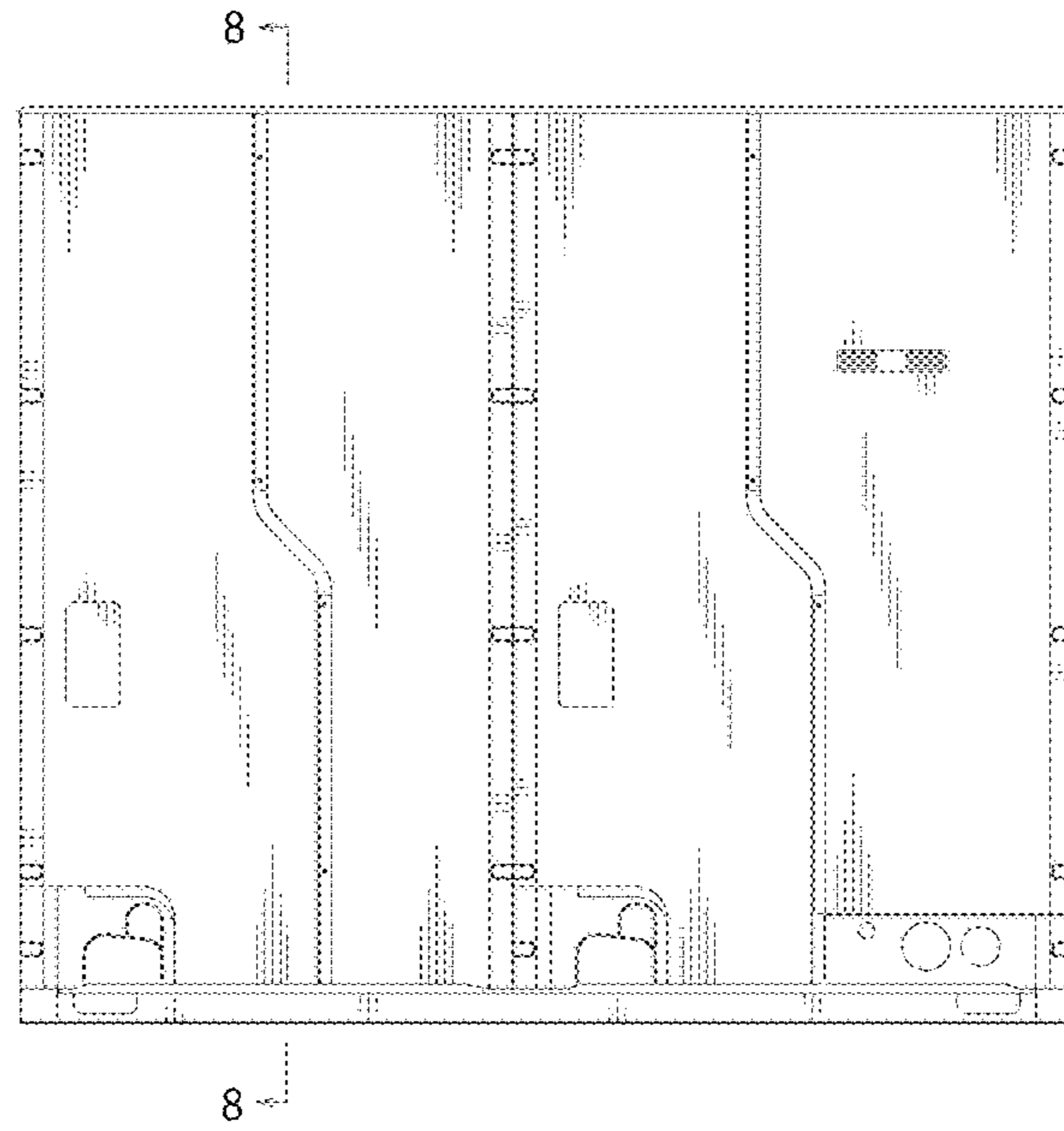

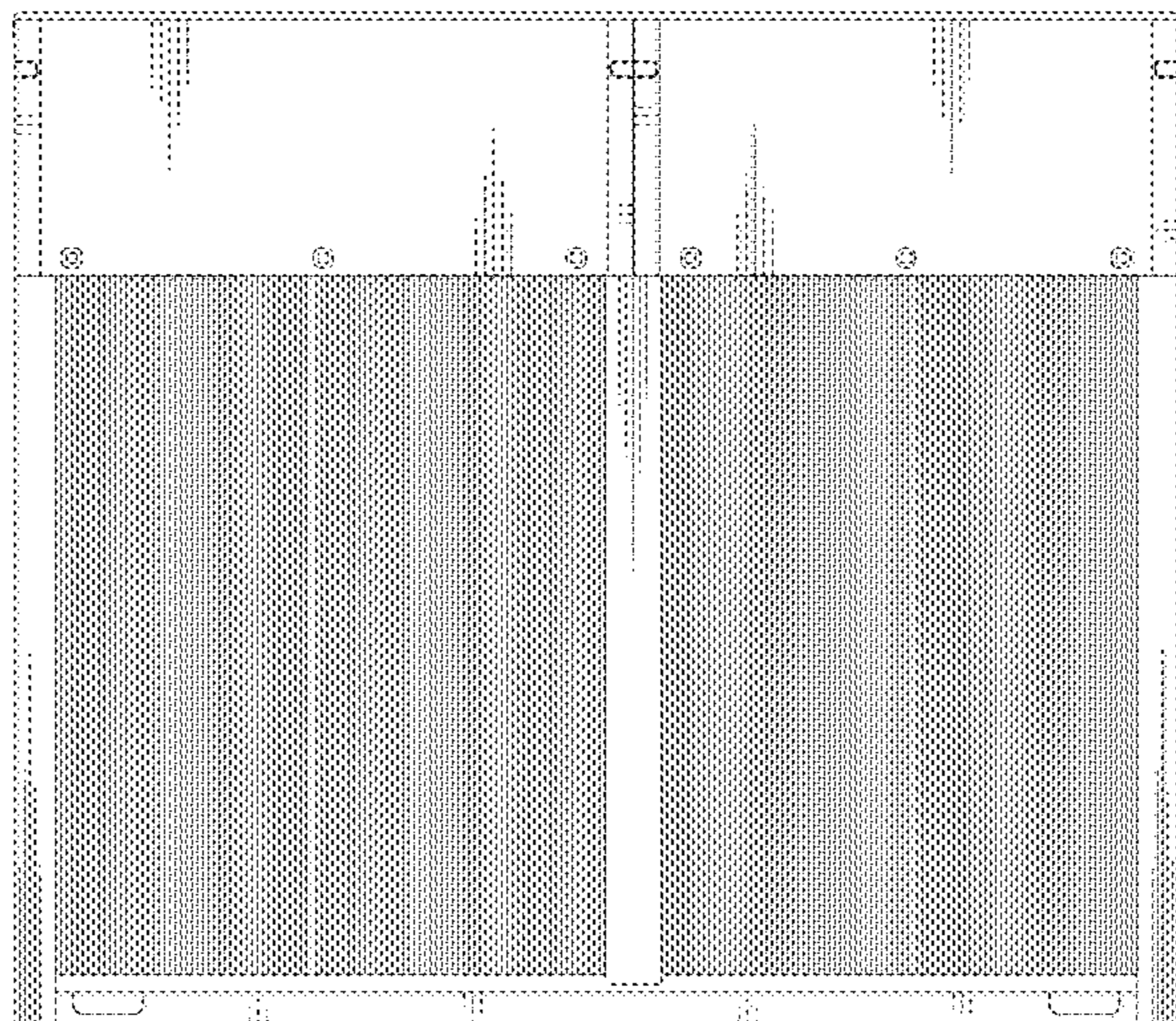

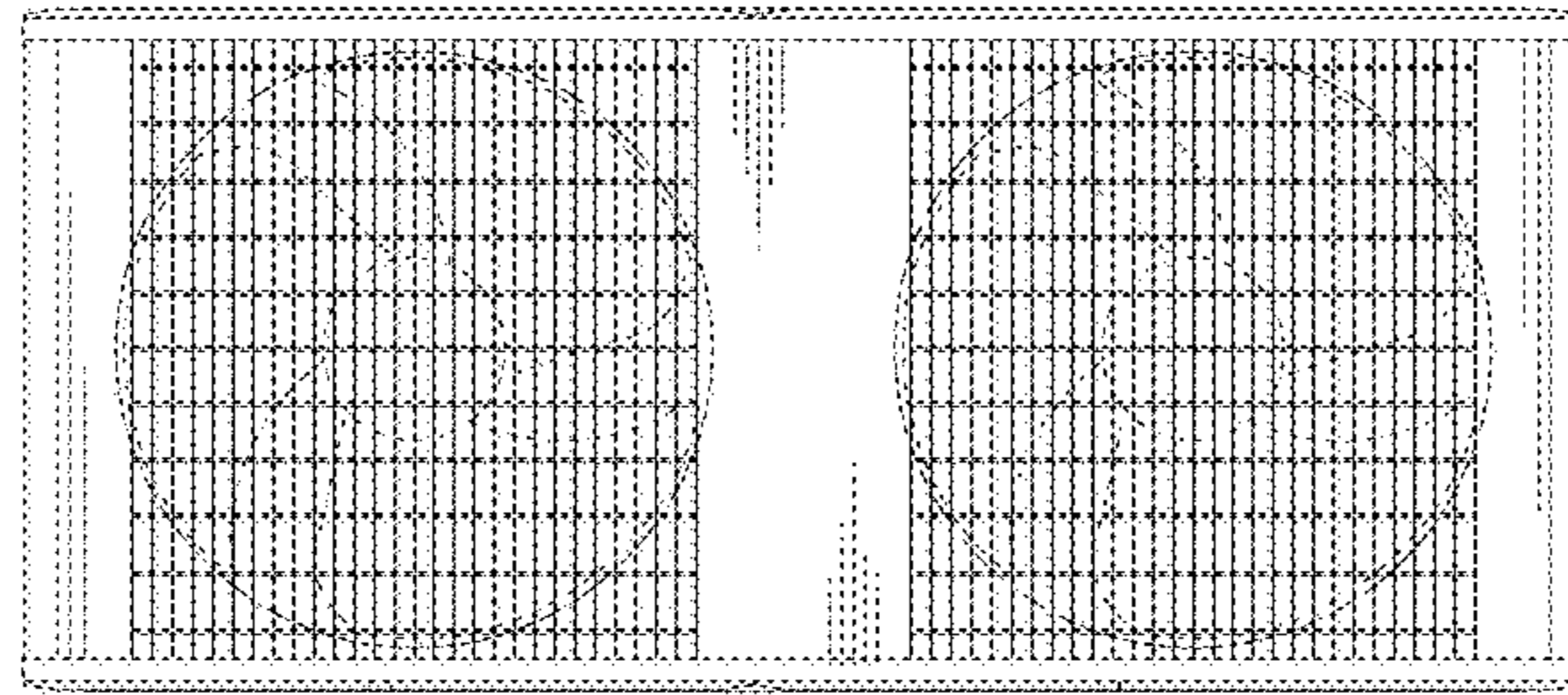

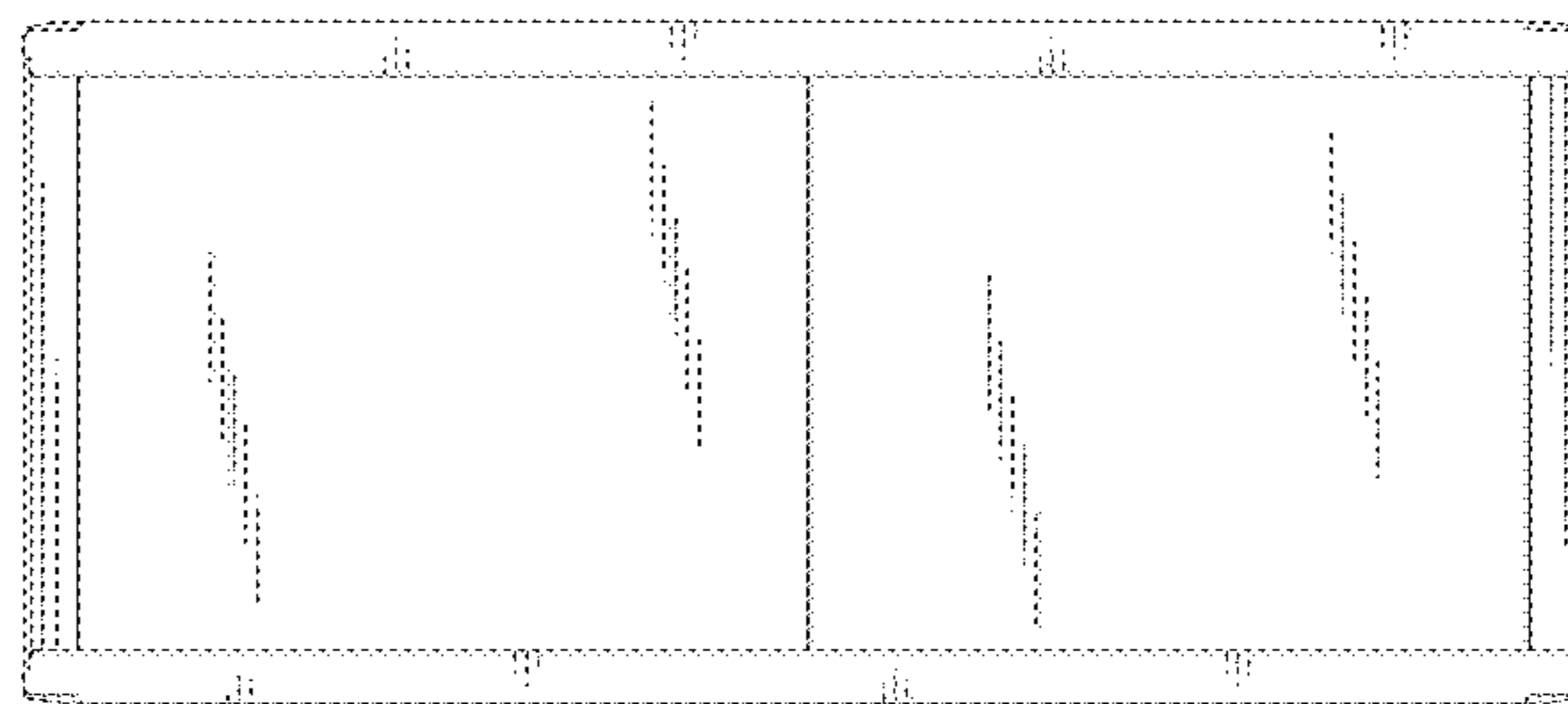

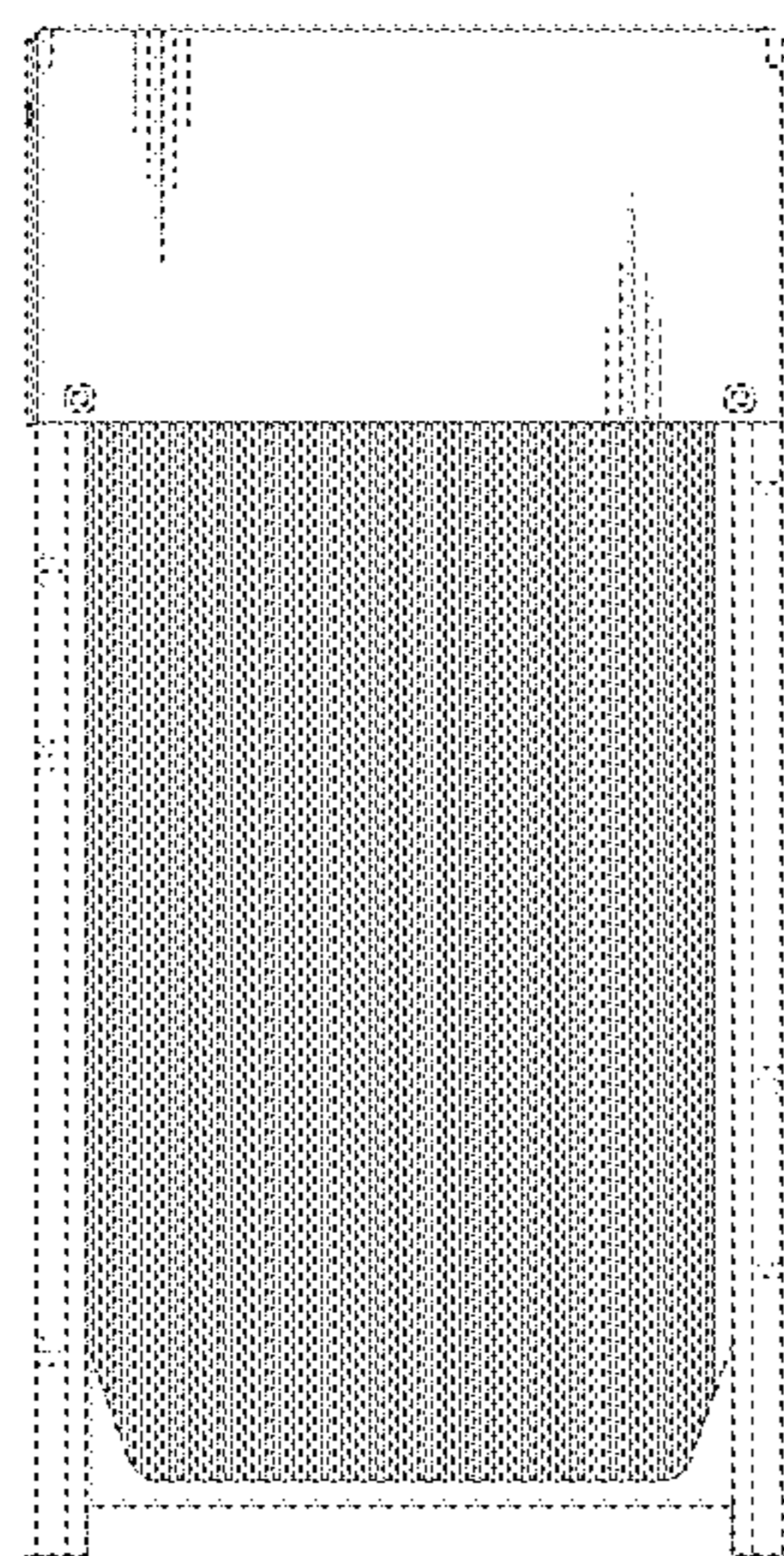

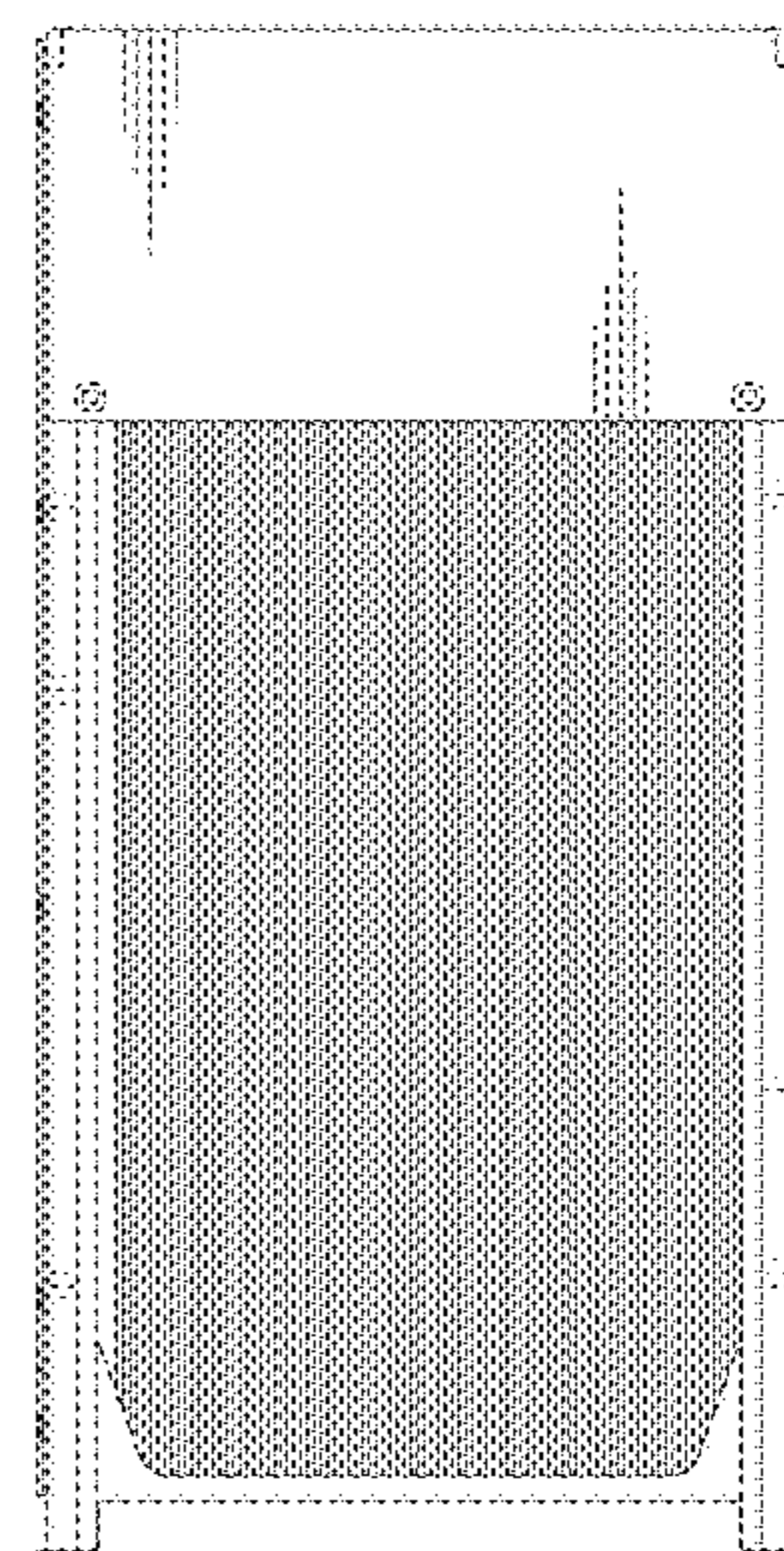
