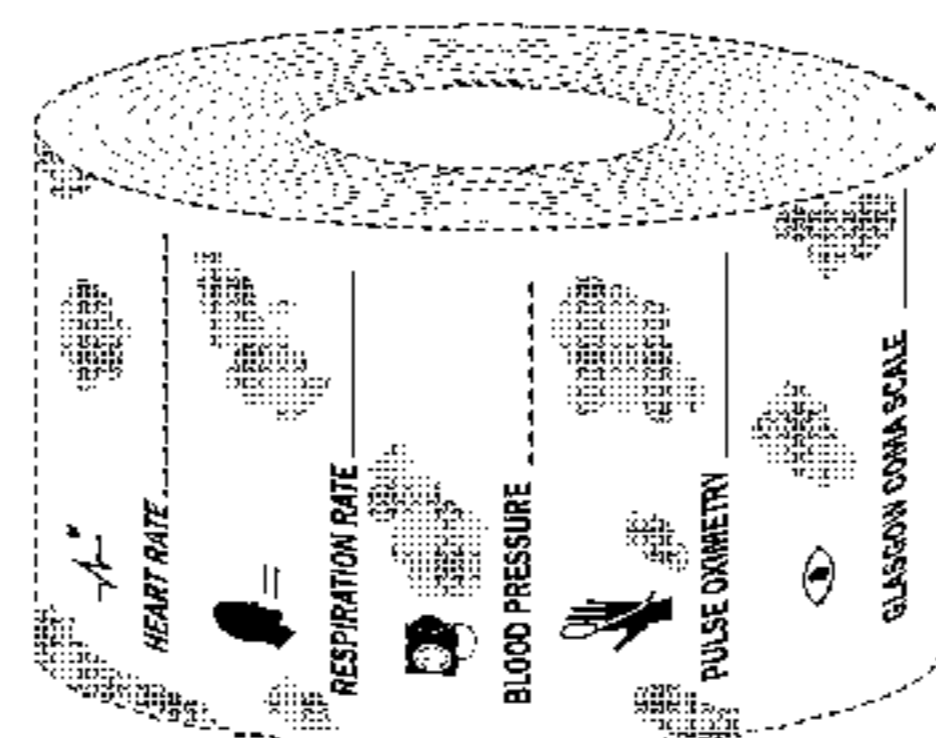
(57) **CLAIM**

The ornamental design for athletic tape, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the athletic tape showing the new design;
FIG. 2 is a top plan view of the athletic tape;
FIG. 3 is a bottom plan view of the athletic tape;
FIG. 4 is a front elevation view of the athletic tape, the back elevation view being identical; and,
FIG. 5 is a left elevation view of the athletic tape, the right elevation view being identical.
In the drawings, the broken lines show portions of athletic tape that form no part of the claim.

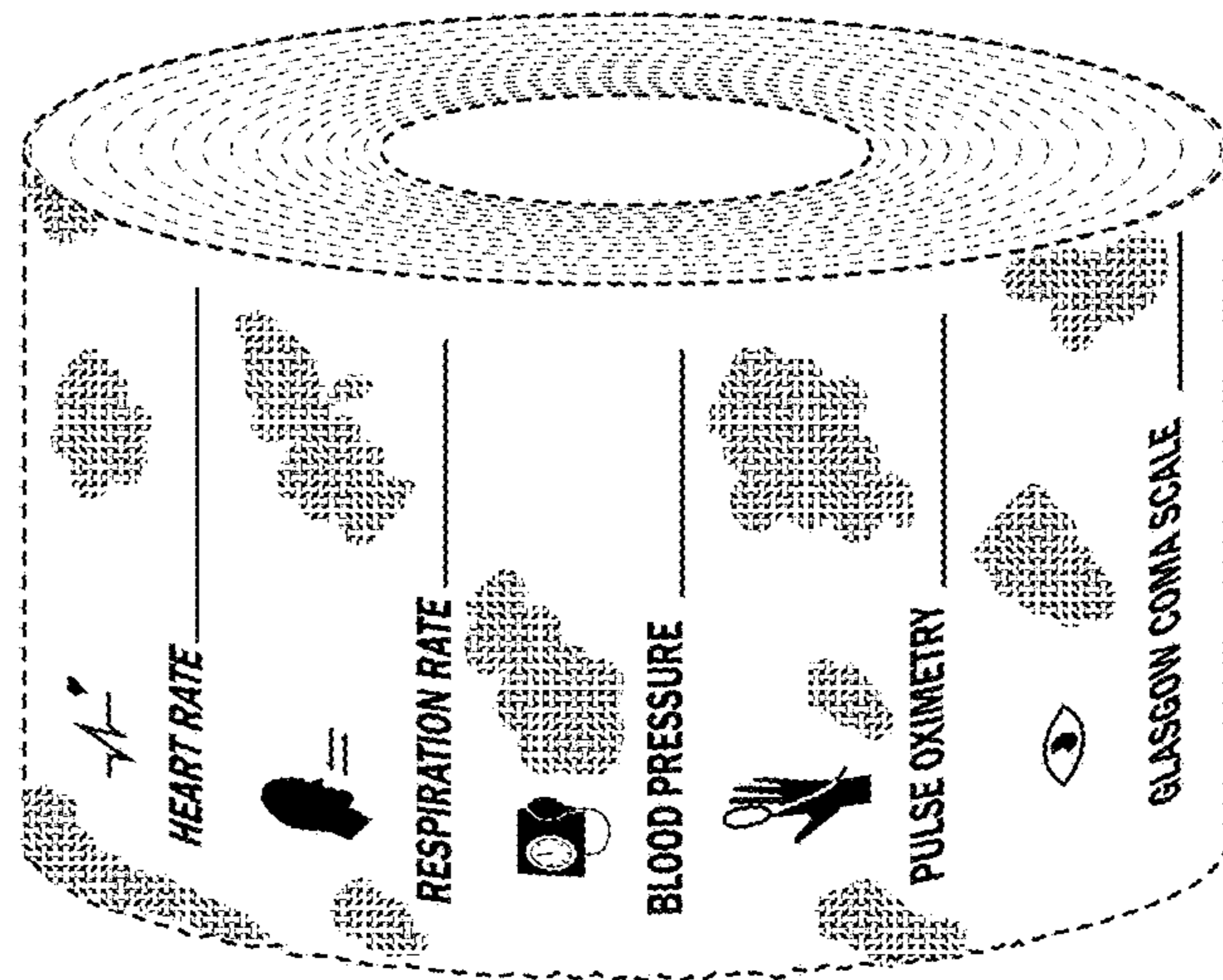

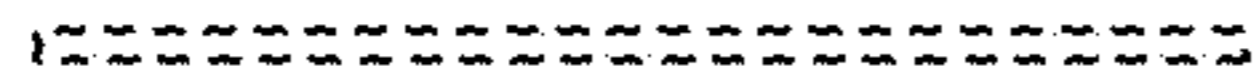

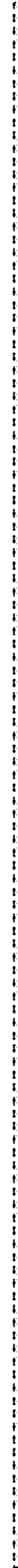
