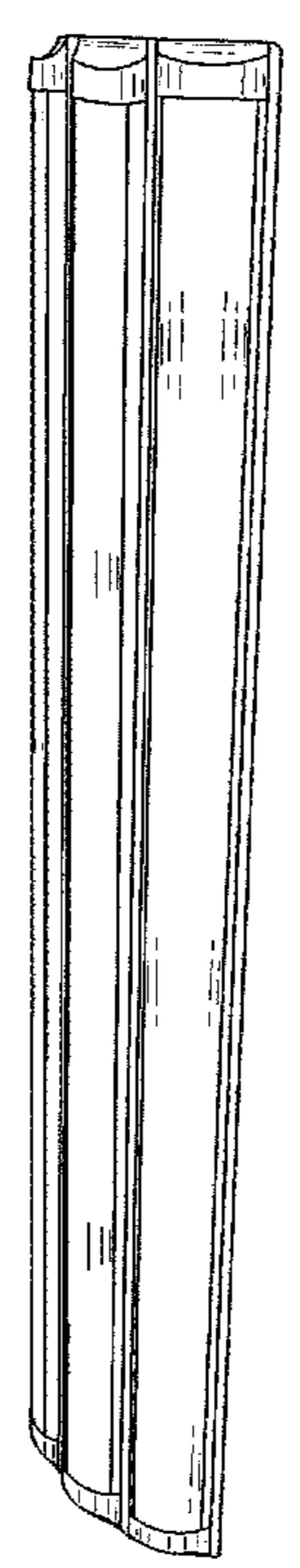

(57) **CLAIM**  
The ornamental design for a lighting fixture, as shown and described.

**DESCRIPTION**  
FIG. 1 is an upright perspective front view of a design of a lighting fixture,  
FIG. 2 is a top view of the lighting fixture of FIG. 1 in a lying down position,  
FIG. 3 is a bottom view of the lighting fixture of FIG. 2;  
FIG. 4 is a bottom side view of the lighting fixture of FIG. 2 as facing upwardly;  
FIG. 5 is a top side view of the lighting fixture of FIG. 2 as facing downwardly;  
FIG. 6 is a left side view of the lighting fixture of FIG. 2; and,  
FIG. 7 is a right side view of the lighting fixture of FIG. 2.

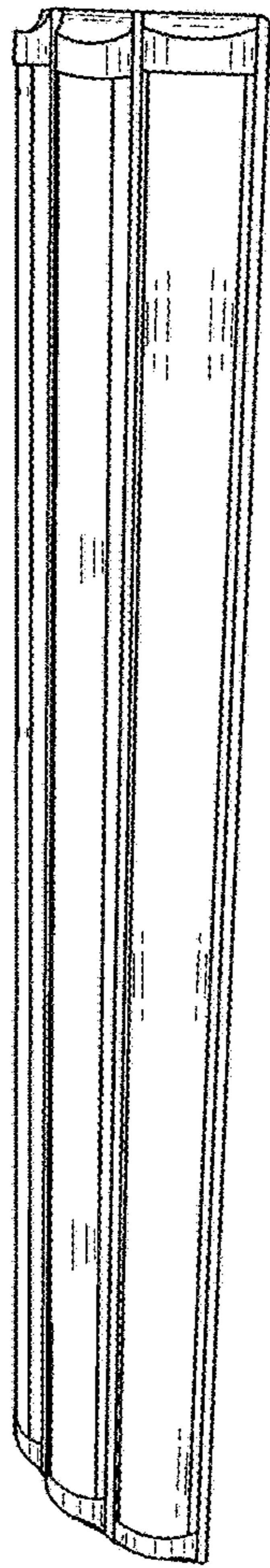

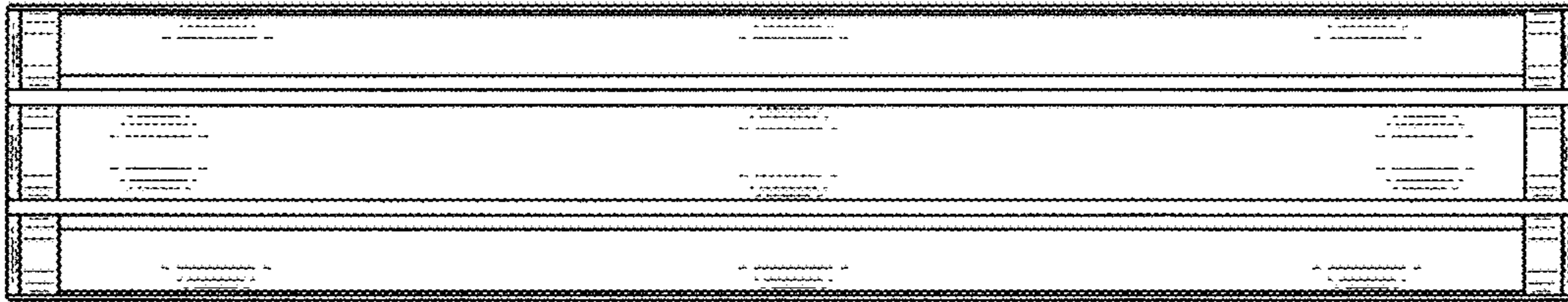

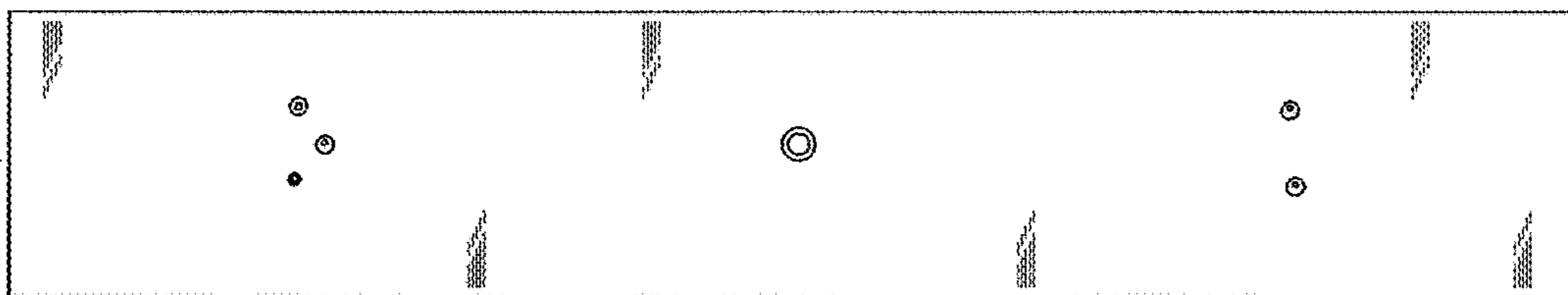

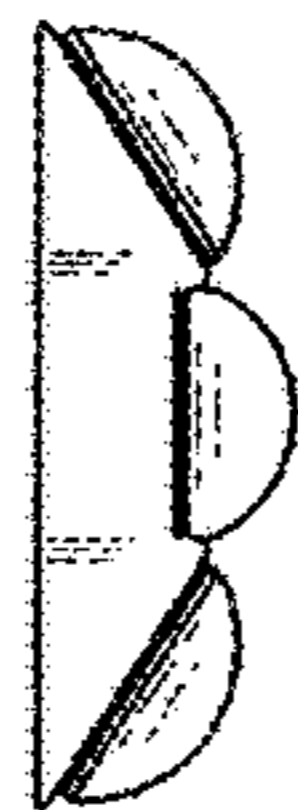
