FIG. 2.3 is a right side elevation view thereof;

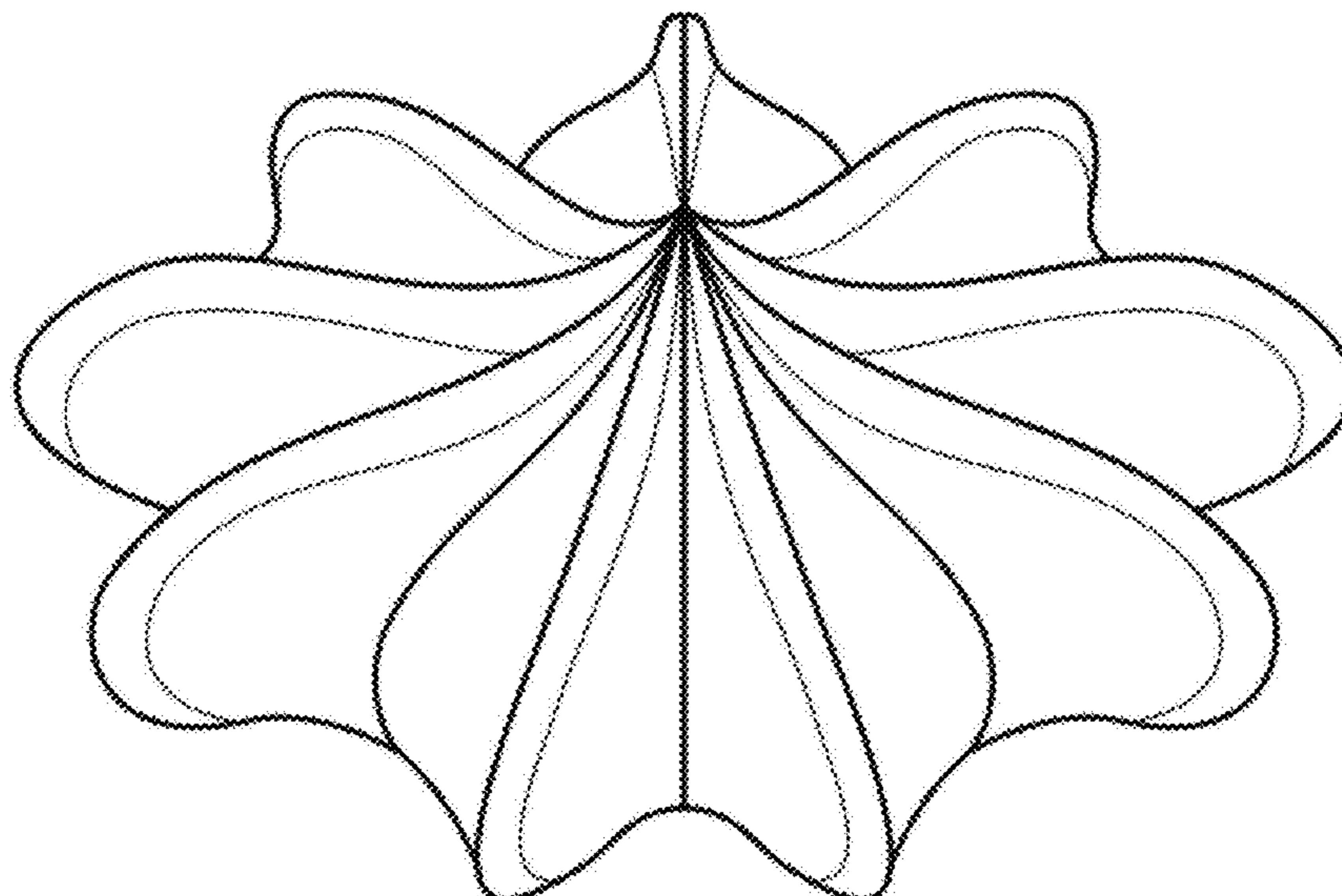
FIG. 2.4 is a left side elevation view thereof;

FIG. 2.5 is a top plan view thereof;

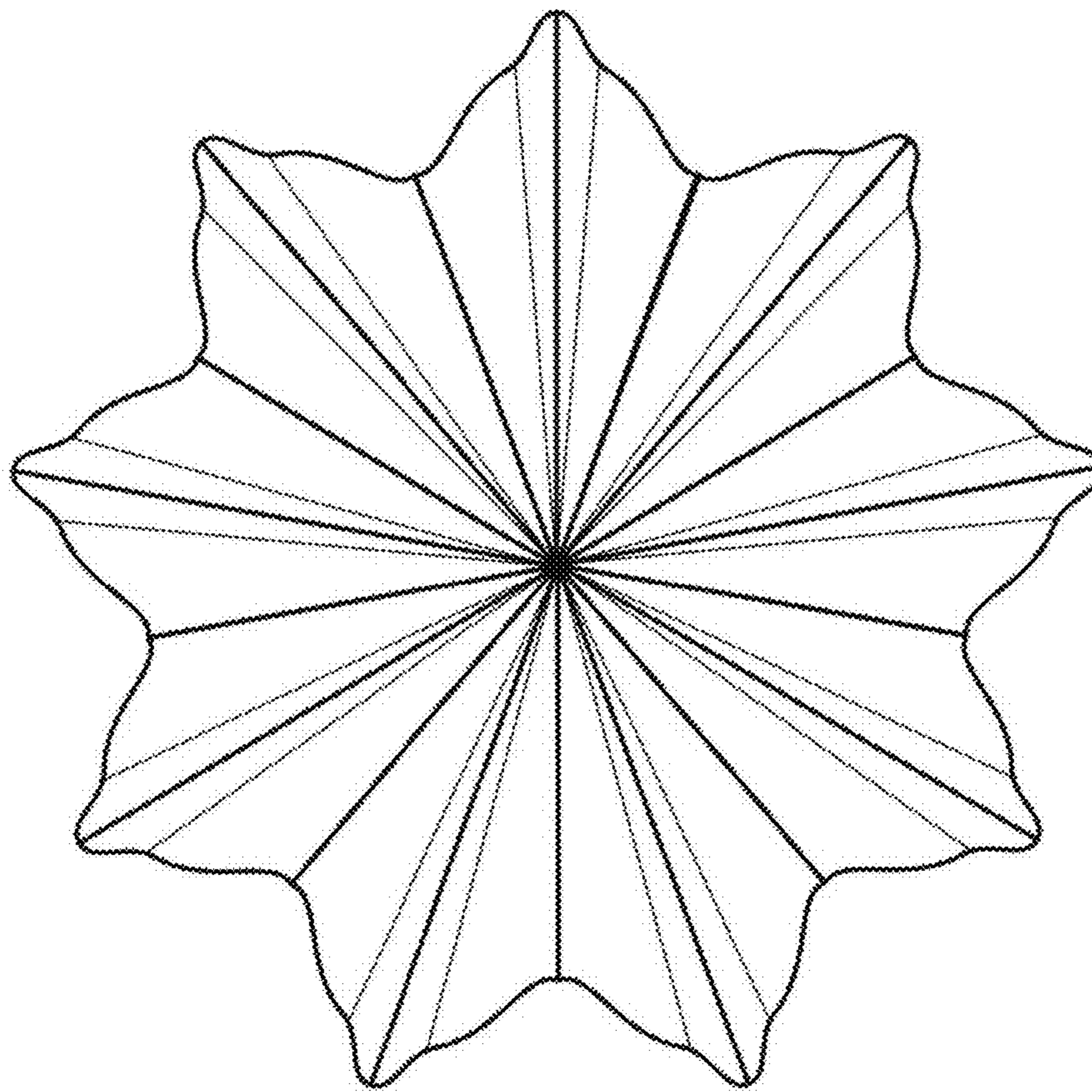
FIG. 2.6 is a bottom plan view thereof; and

FIG. 2.7 is a front, right perspective view thereof.

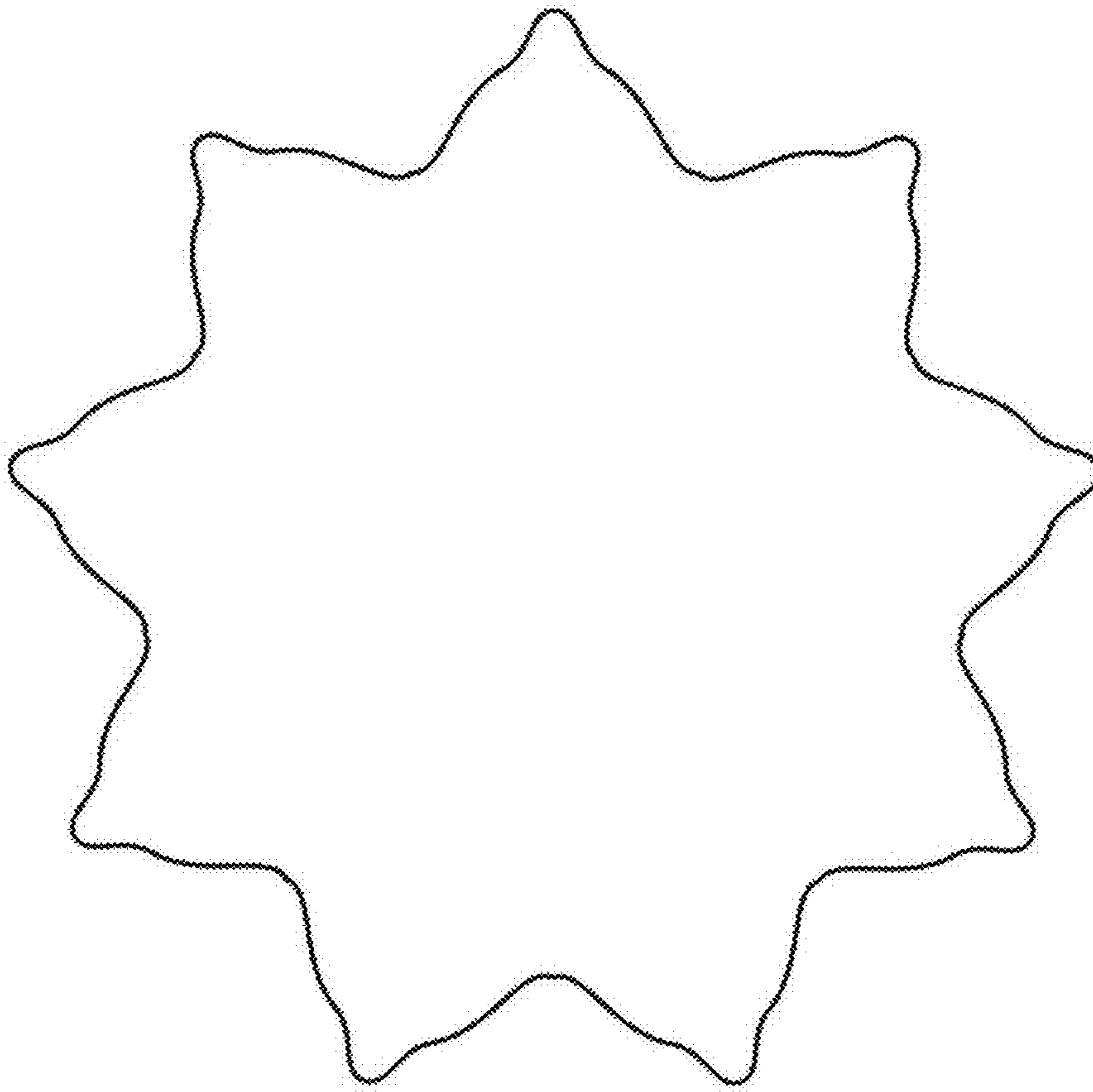

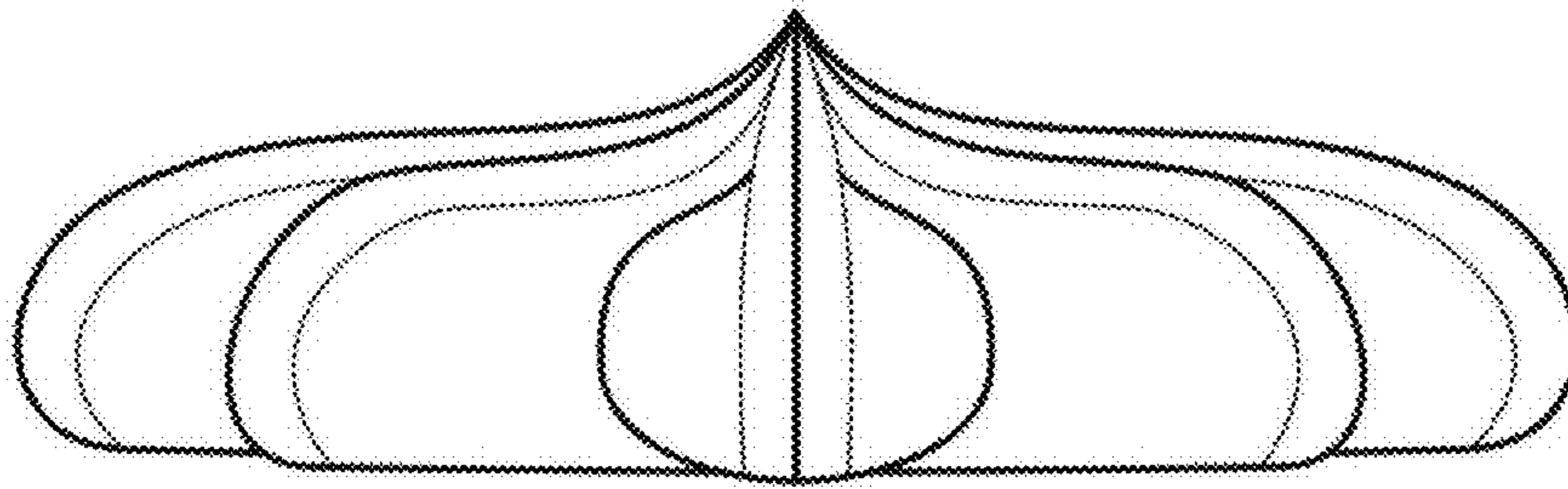

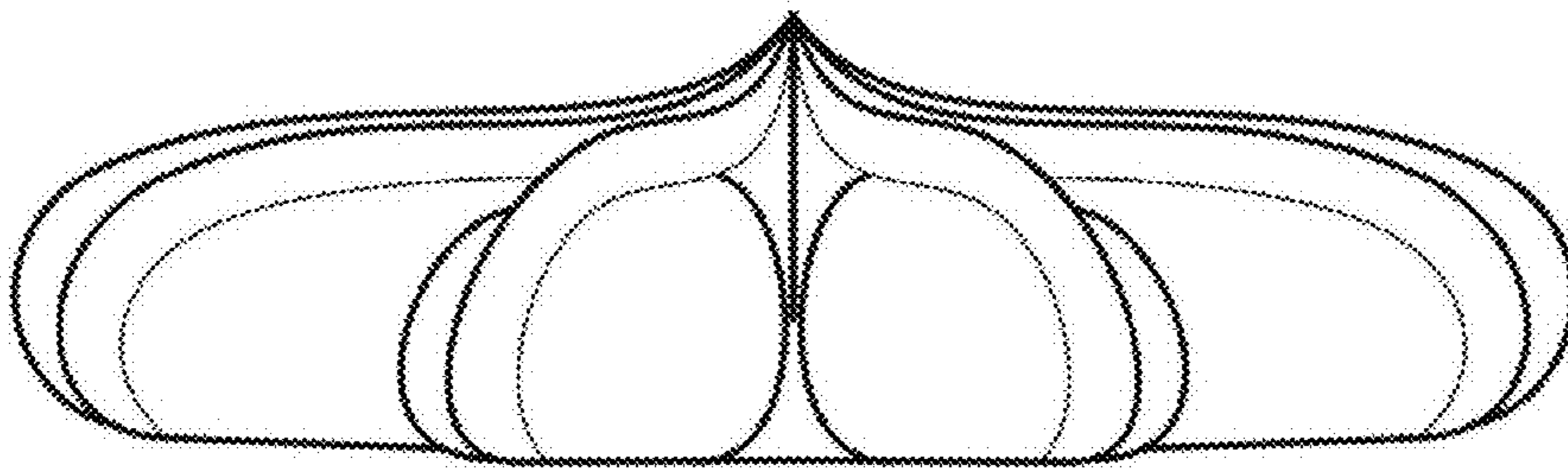

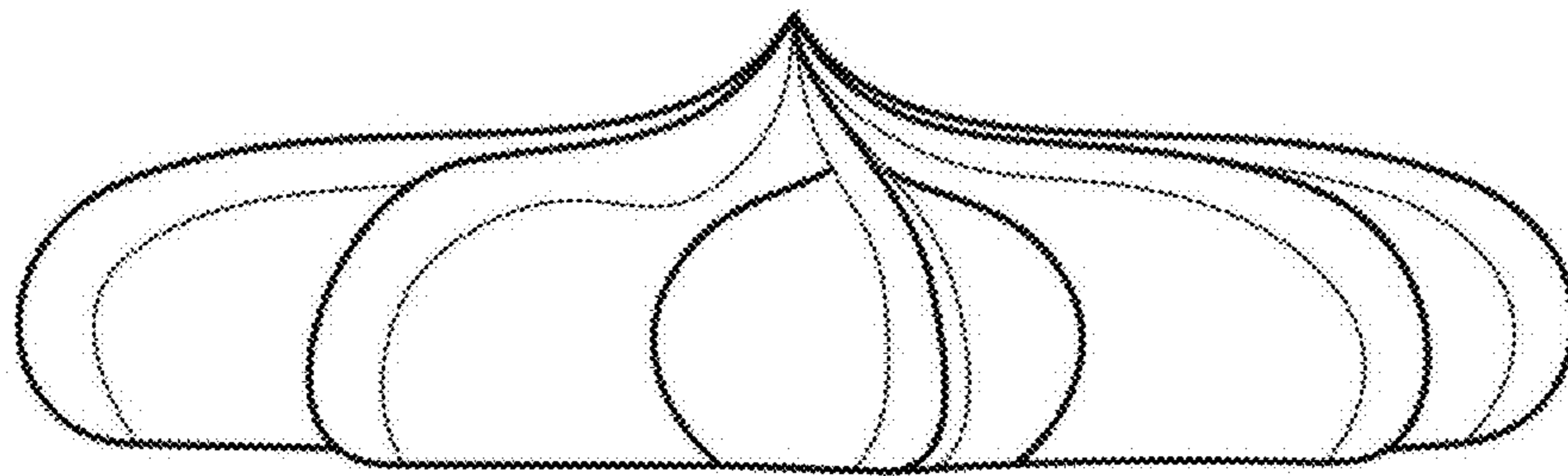

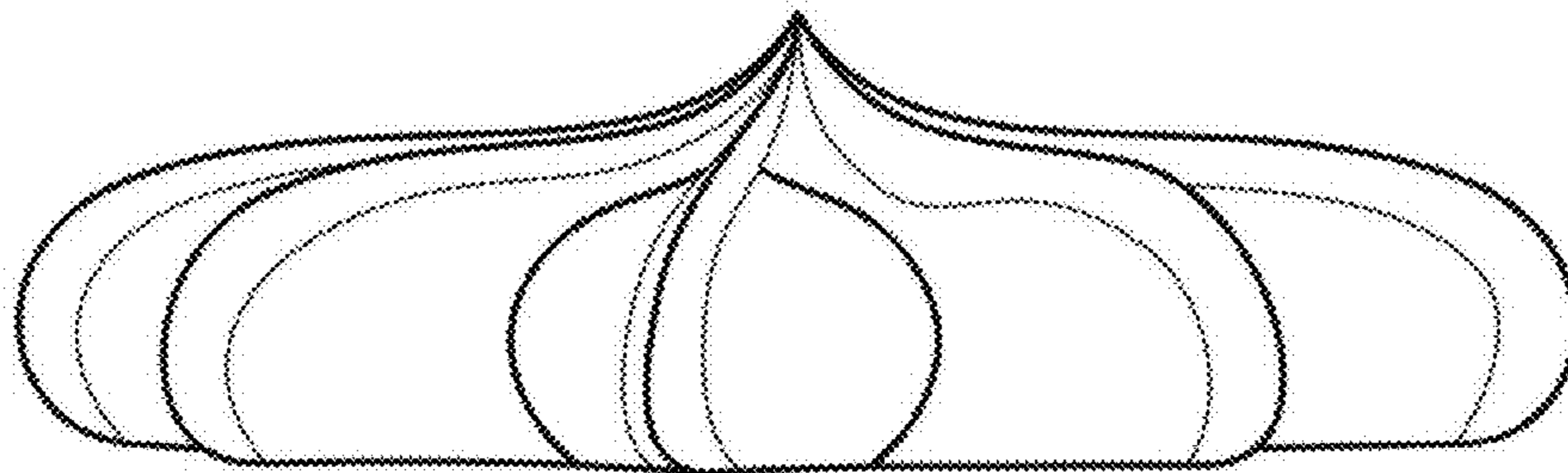

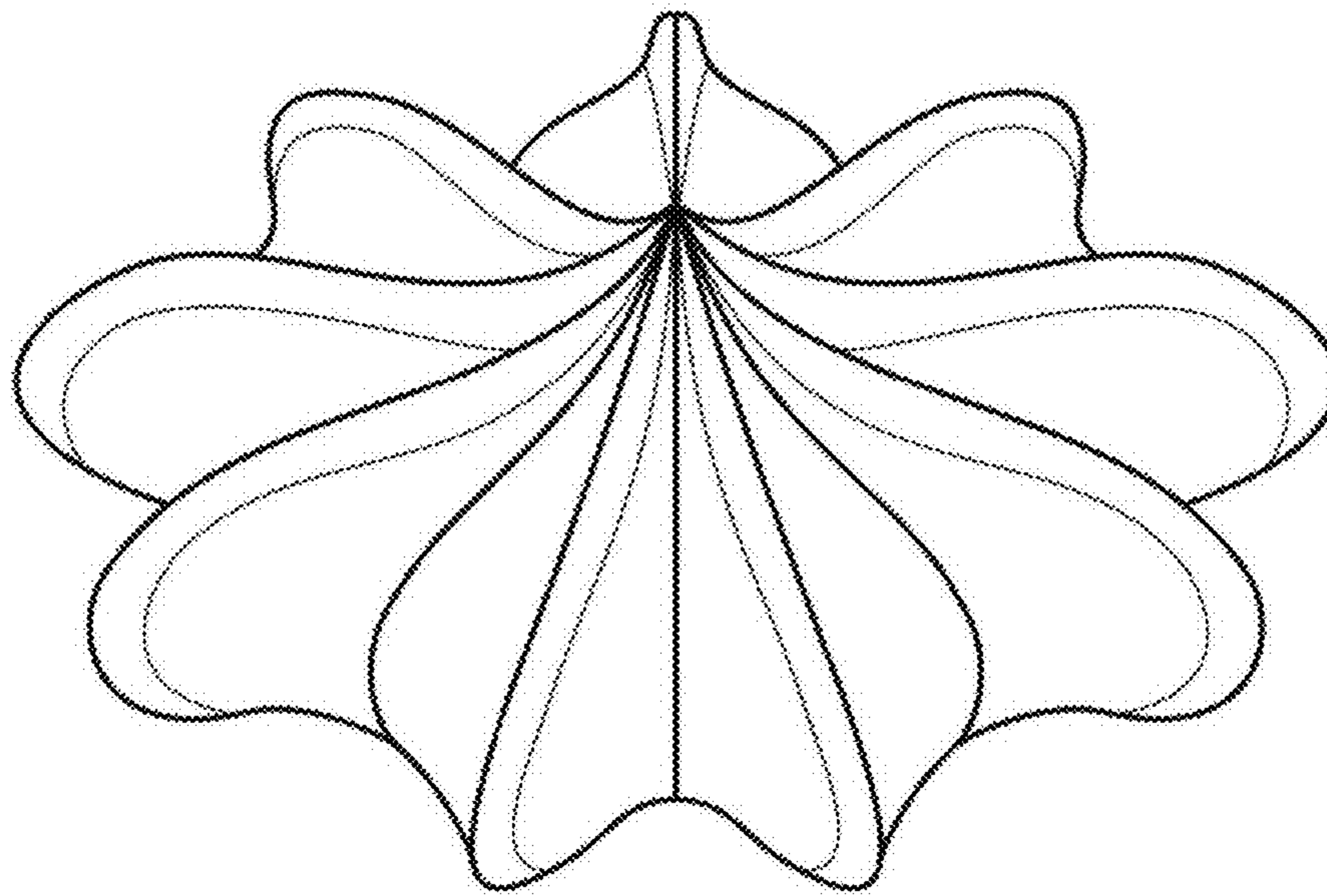
