FIG. 8 is another perspective view thereof; and,

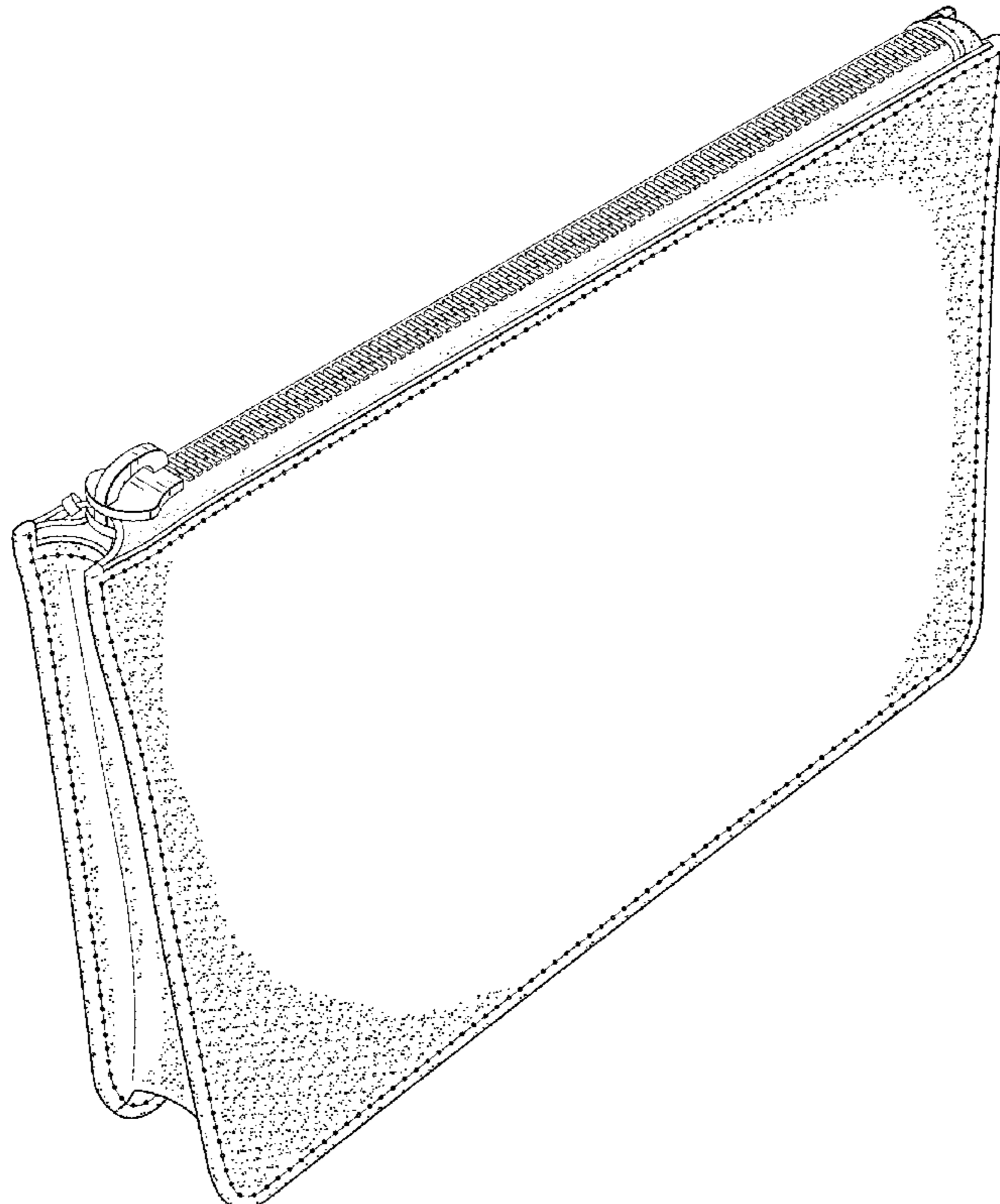

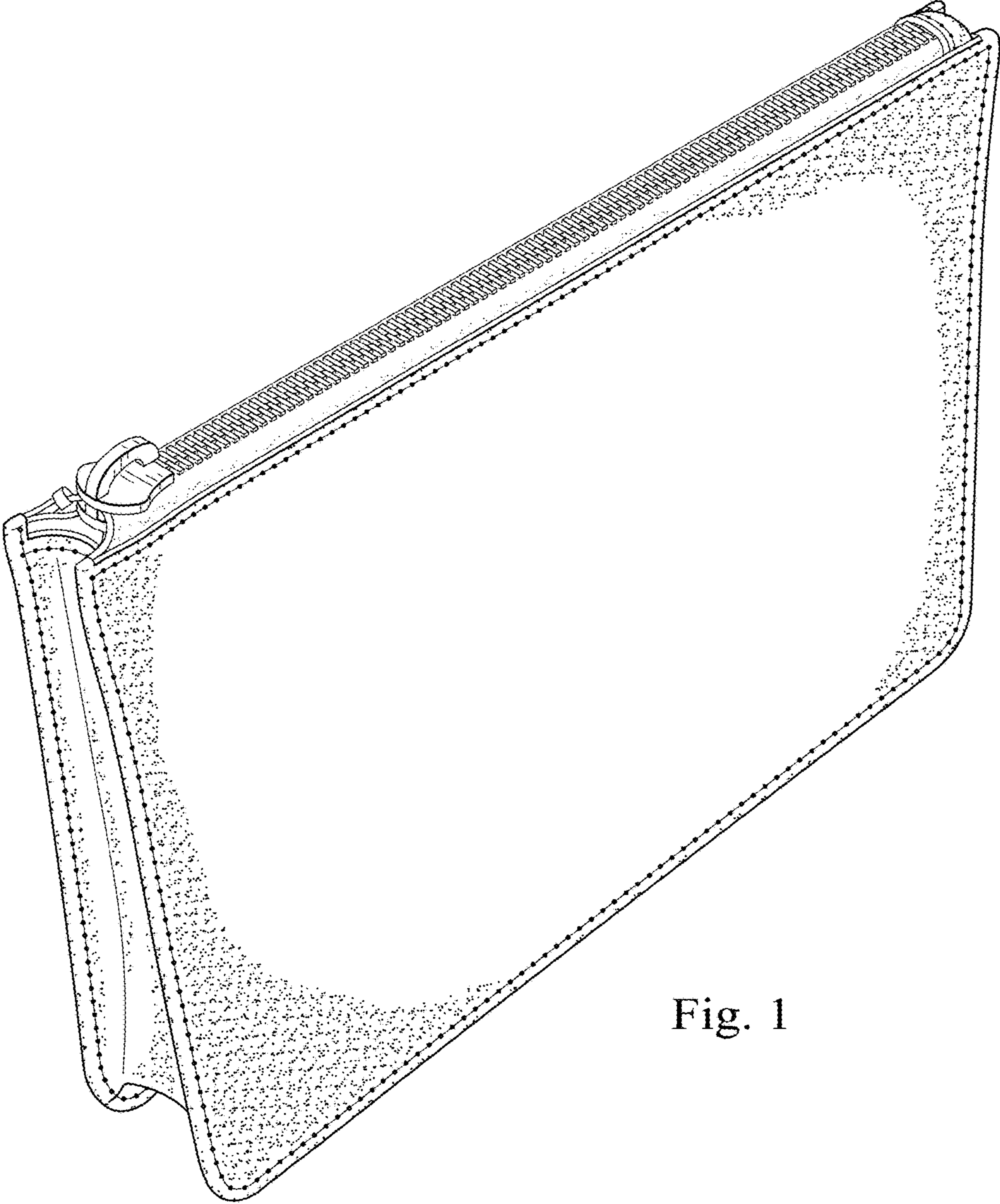

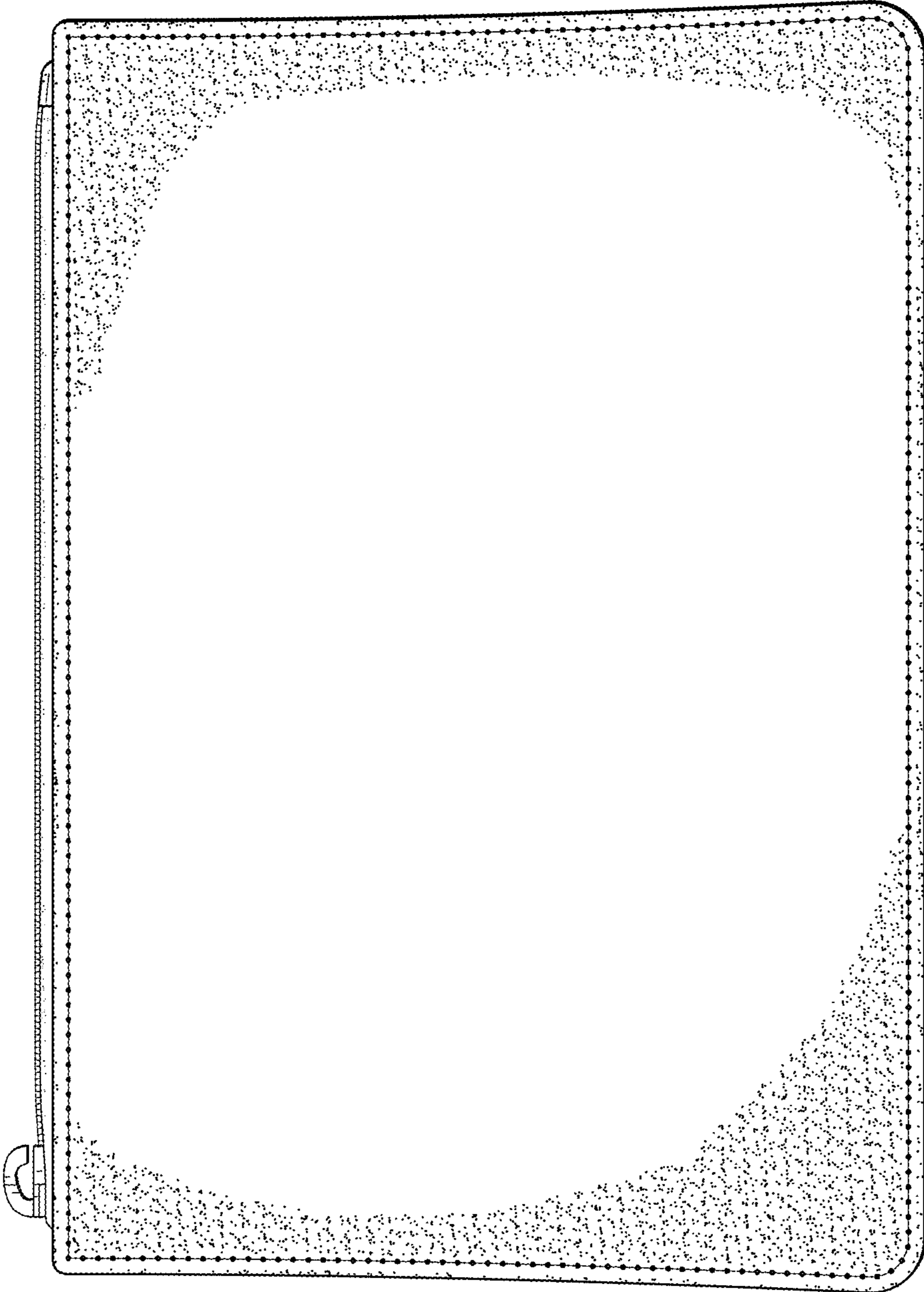

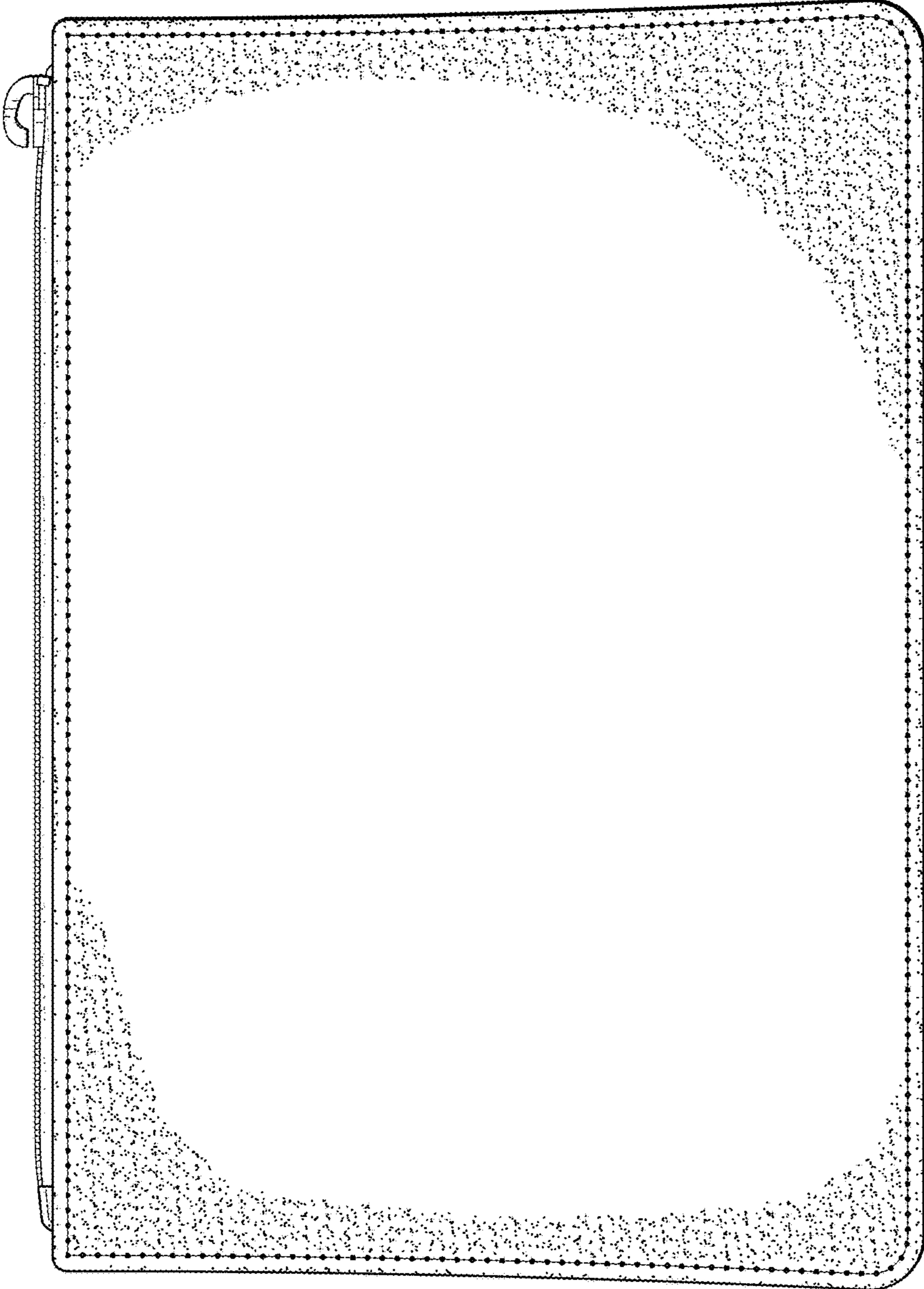

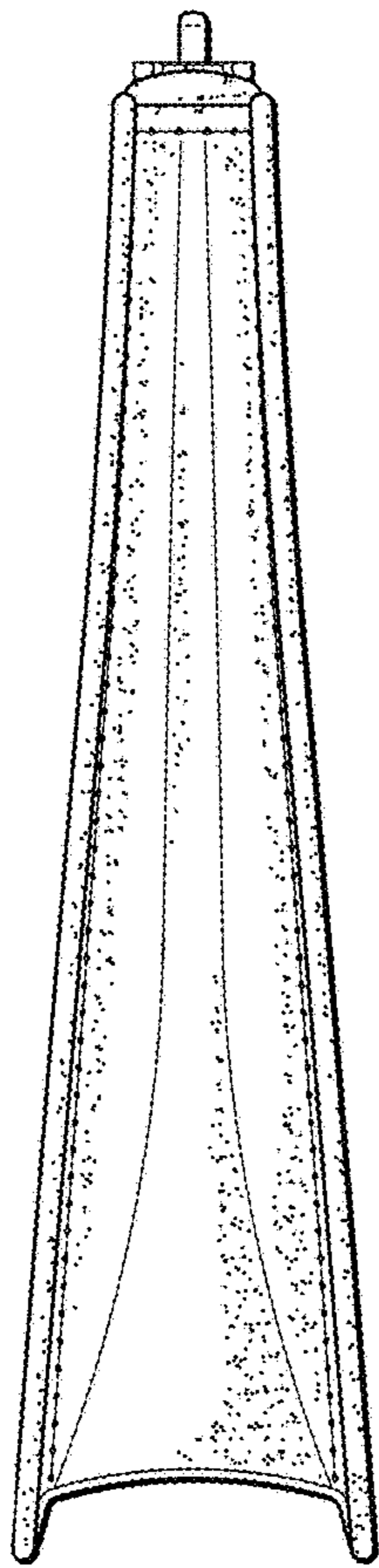

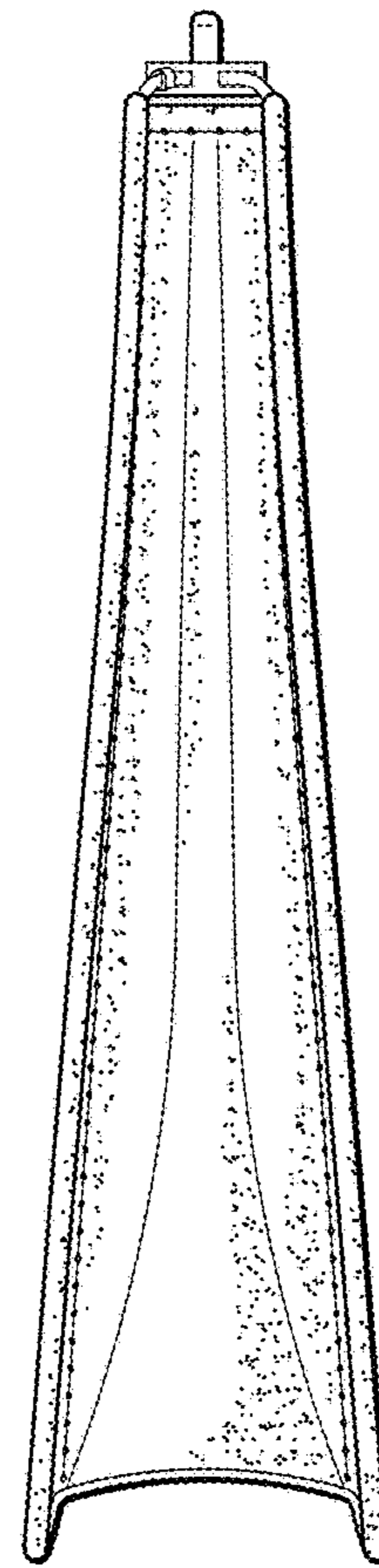

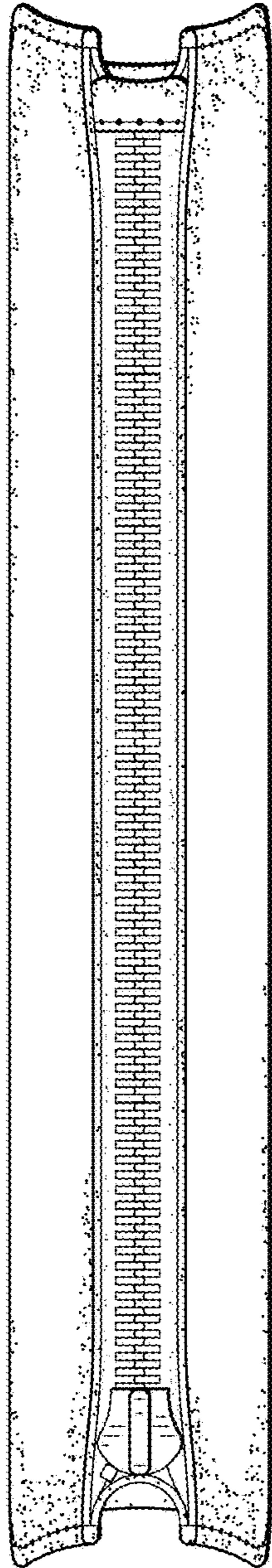

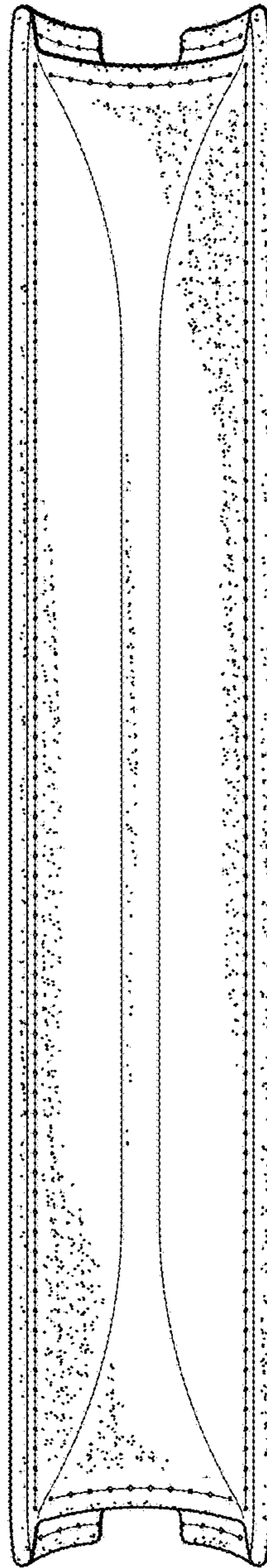

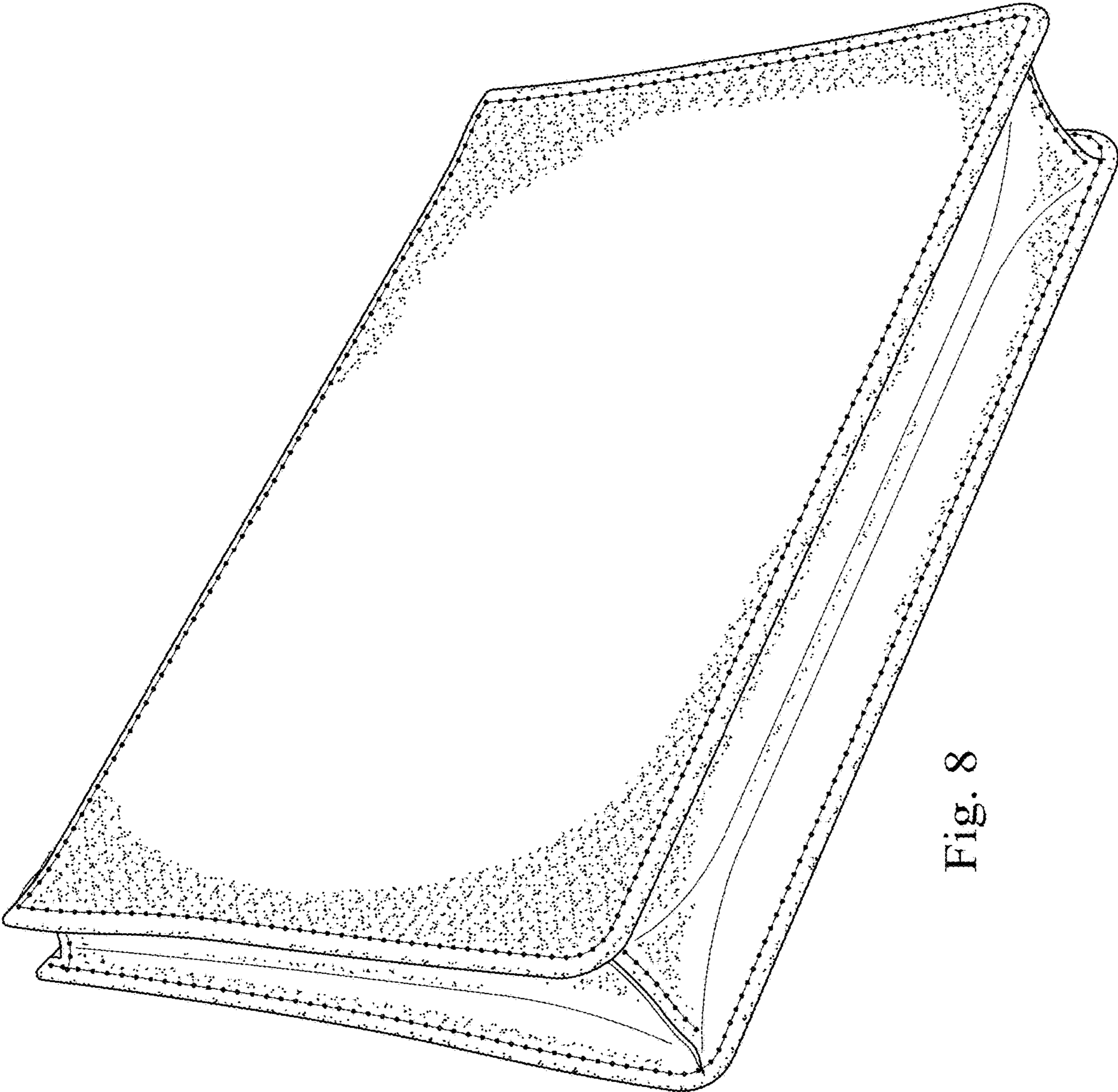

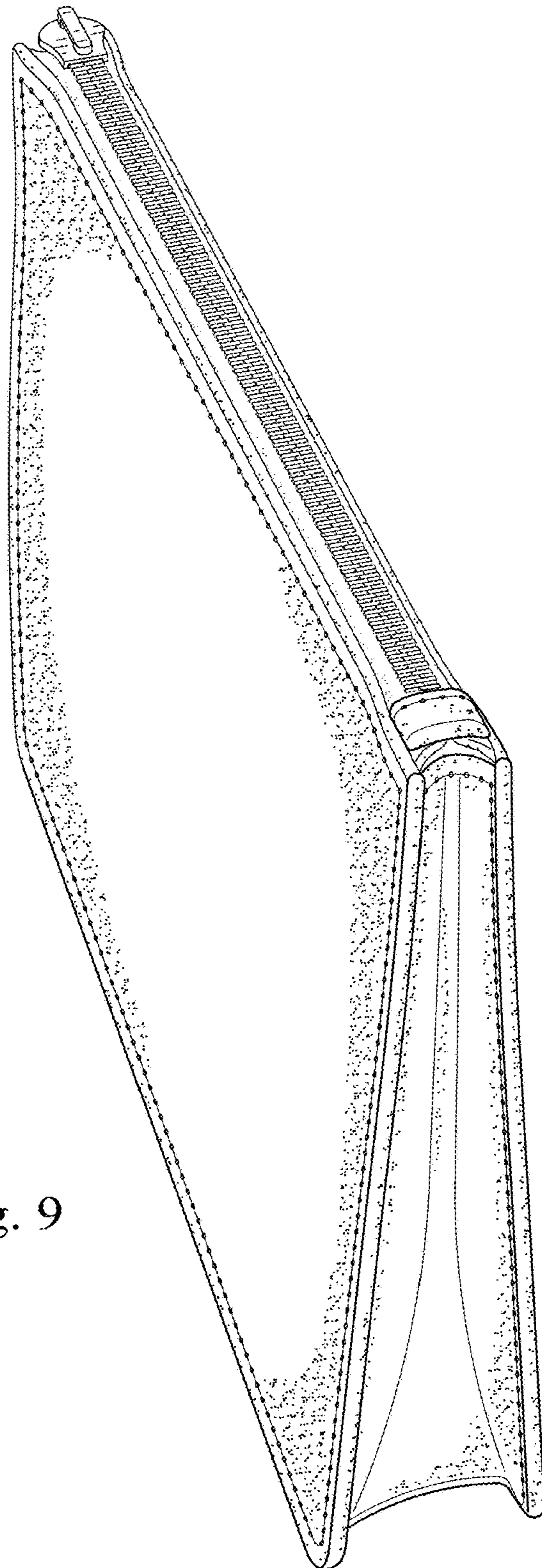
