DESCRIPTION

FIG. 19 is a right side view thereof;

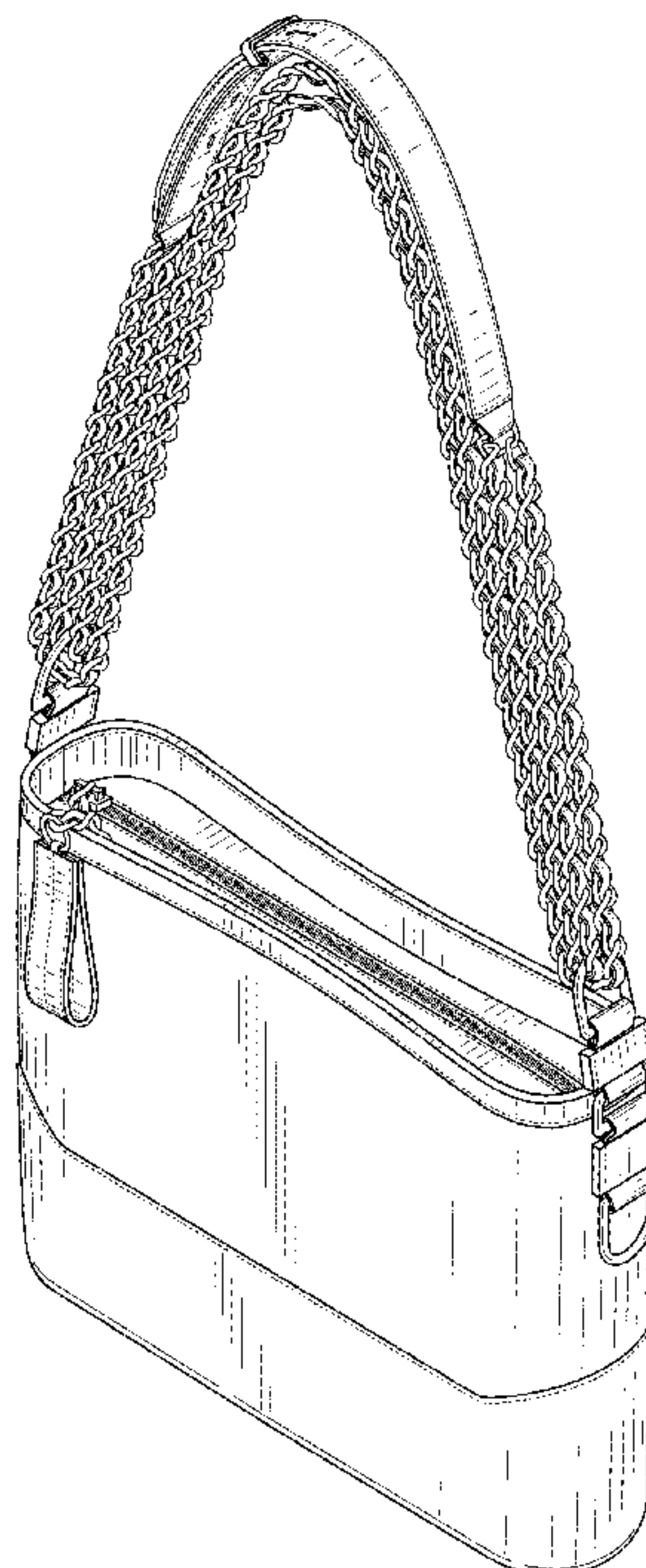
FIG. 20 is a top view thereof; and,

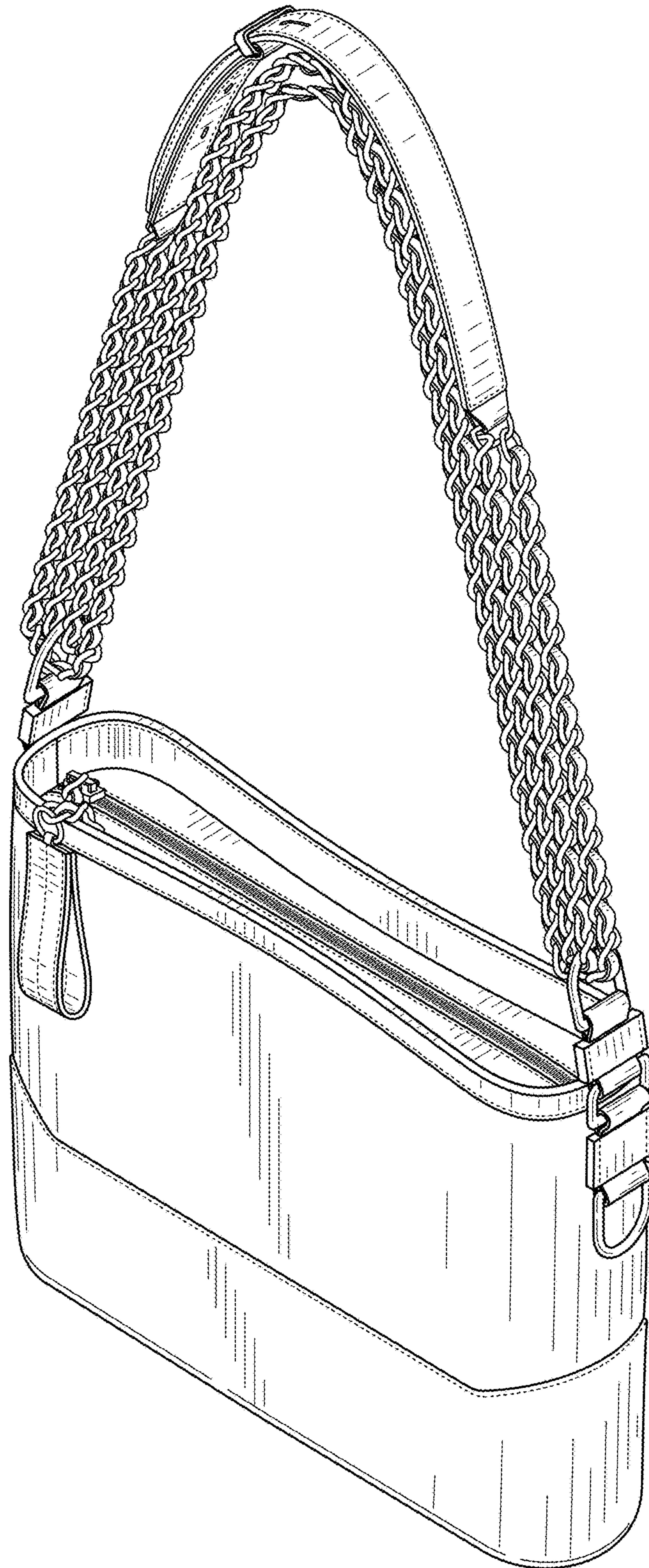

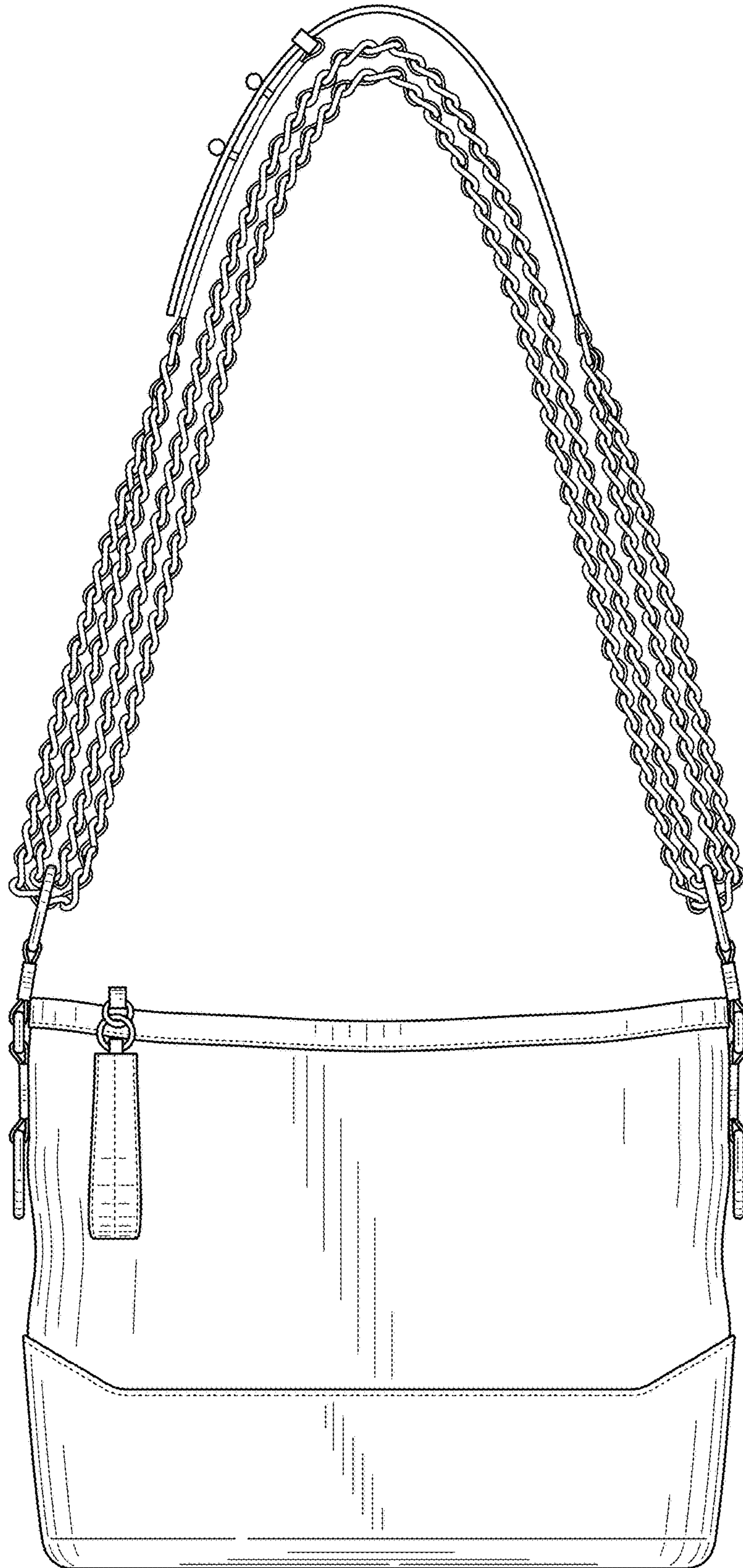

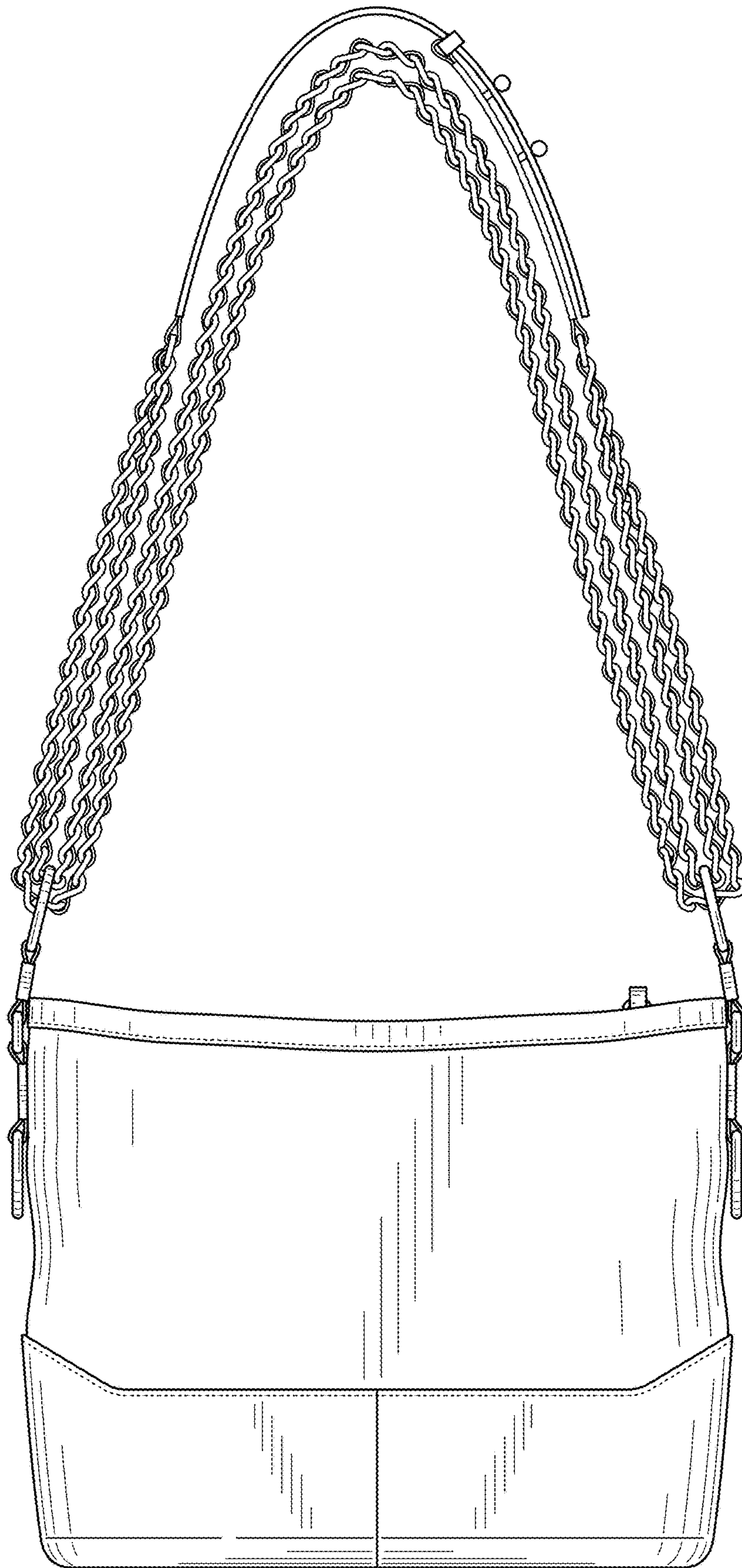

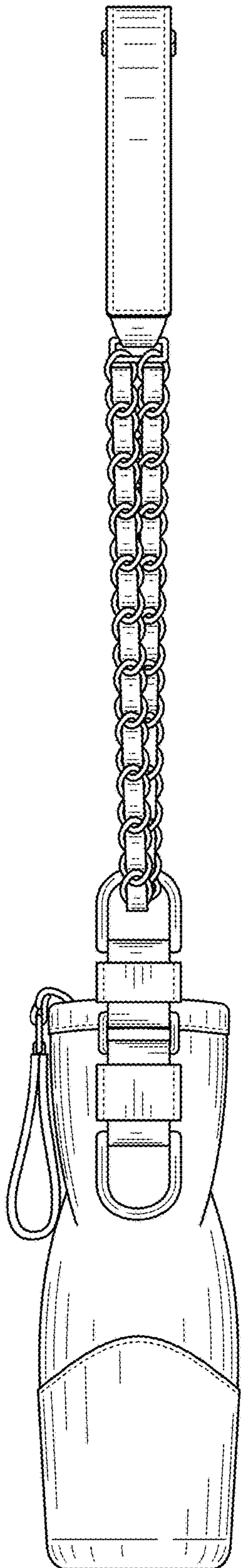

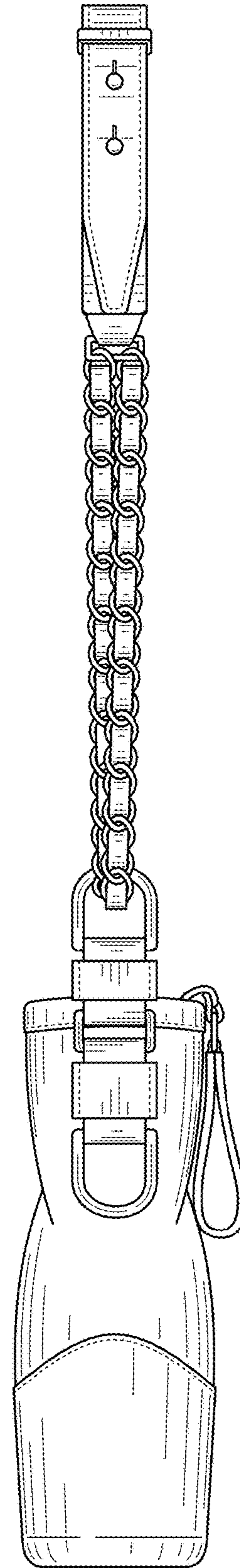

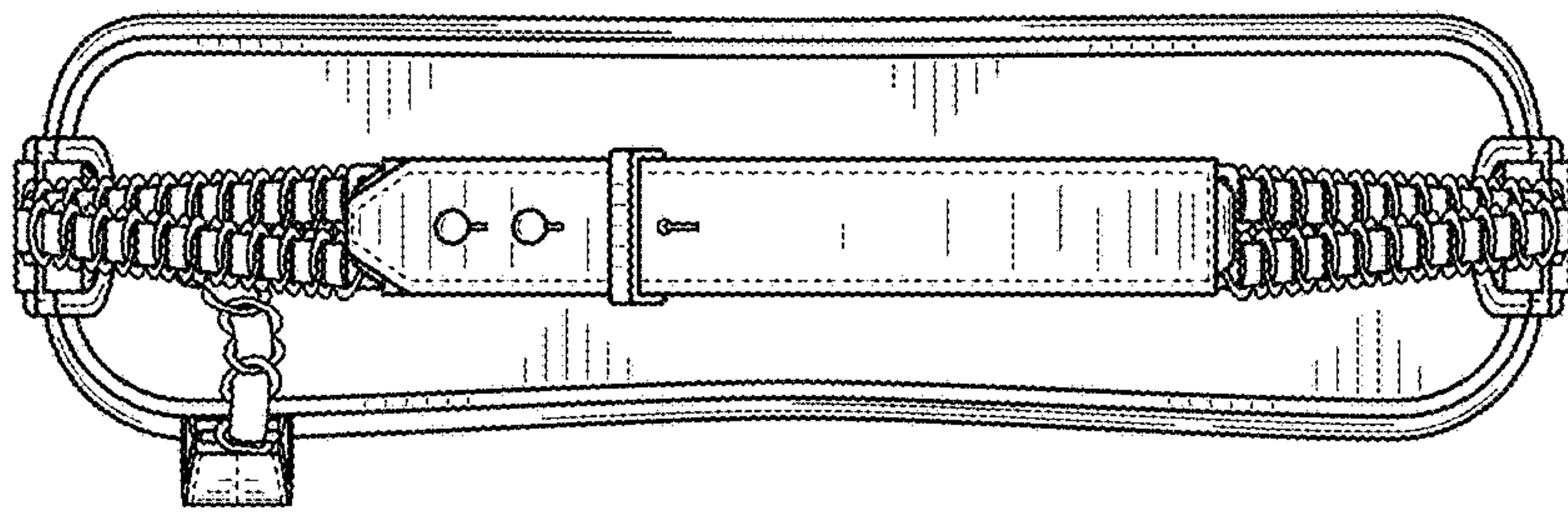

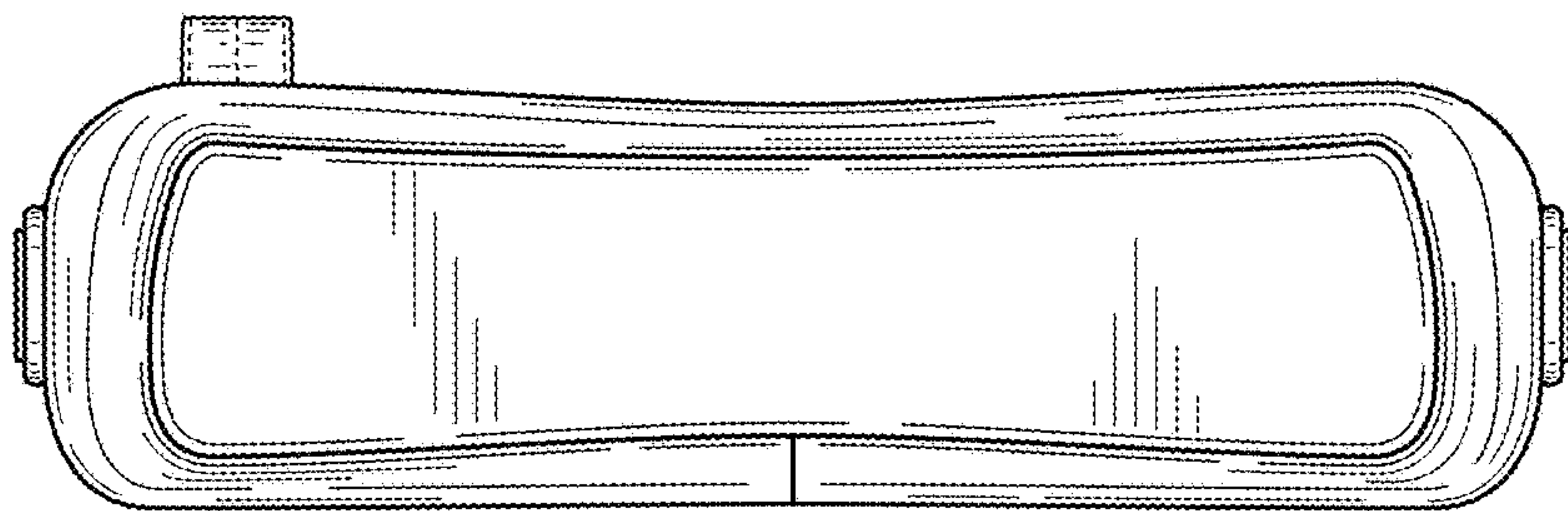

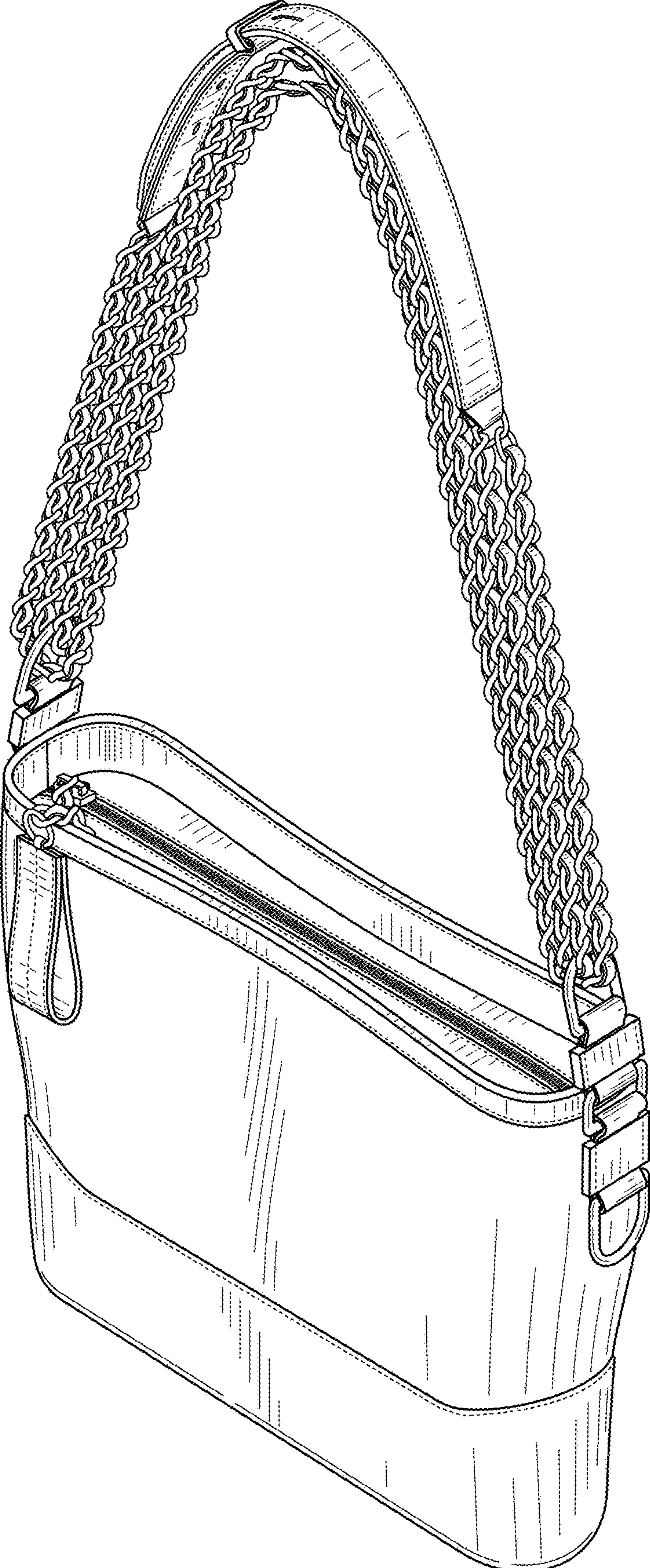

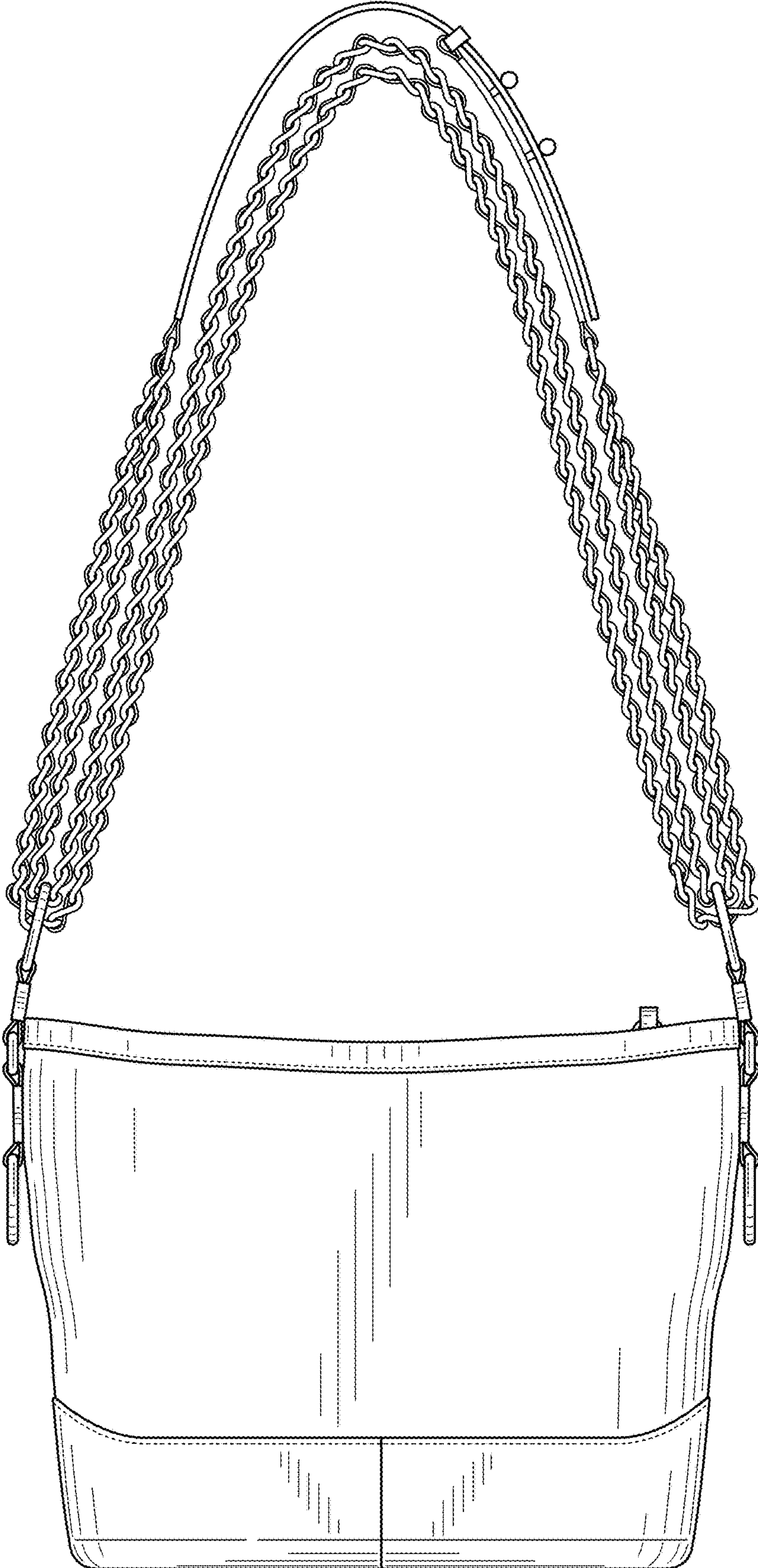

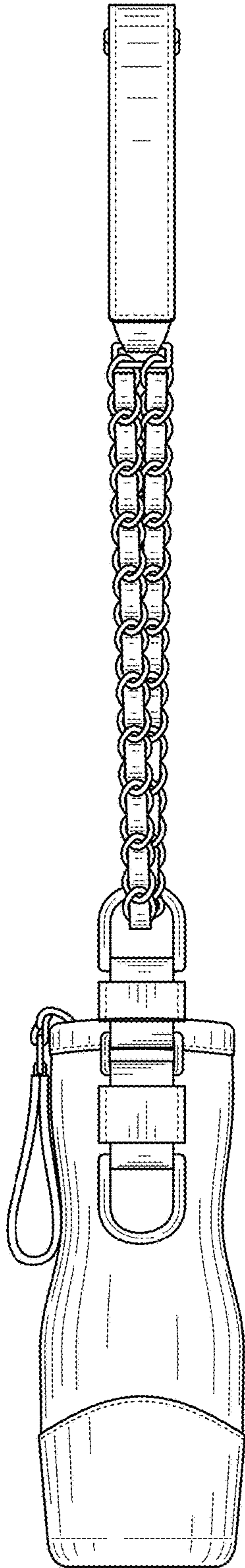

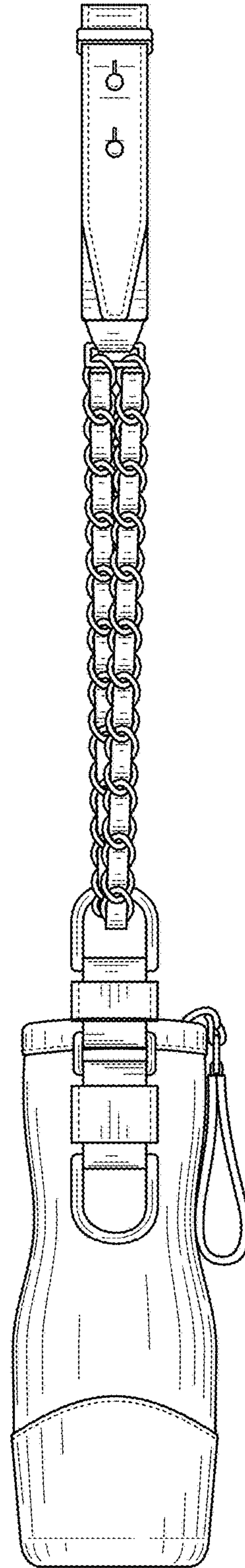

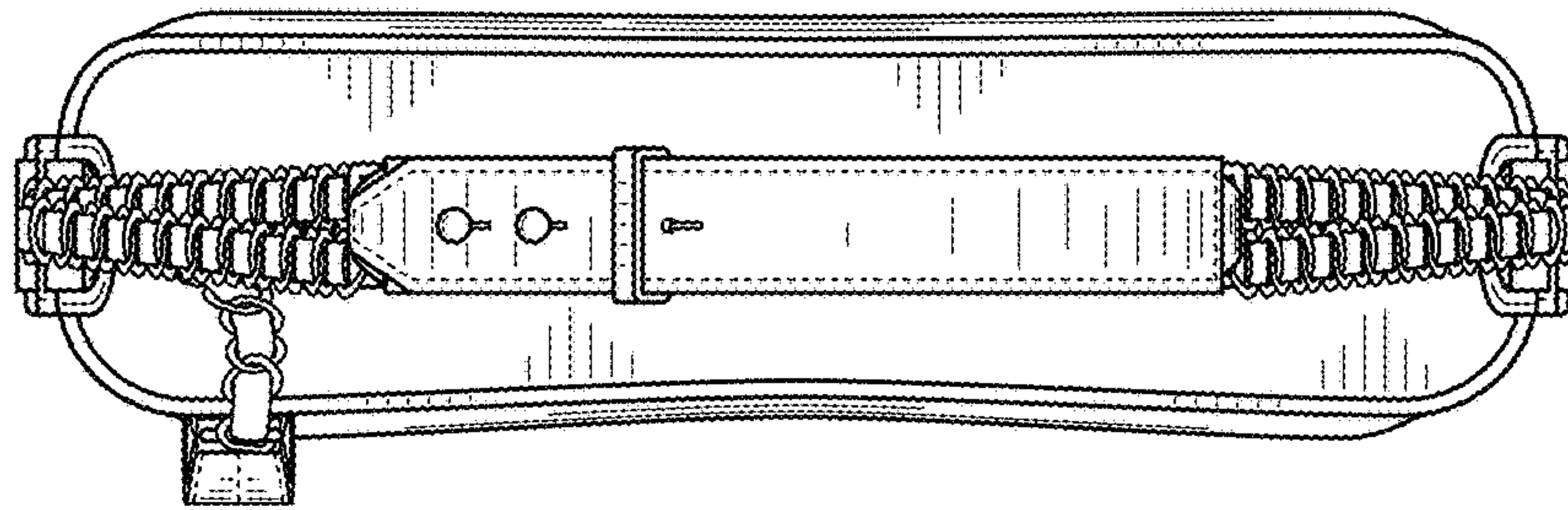

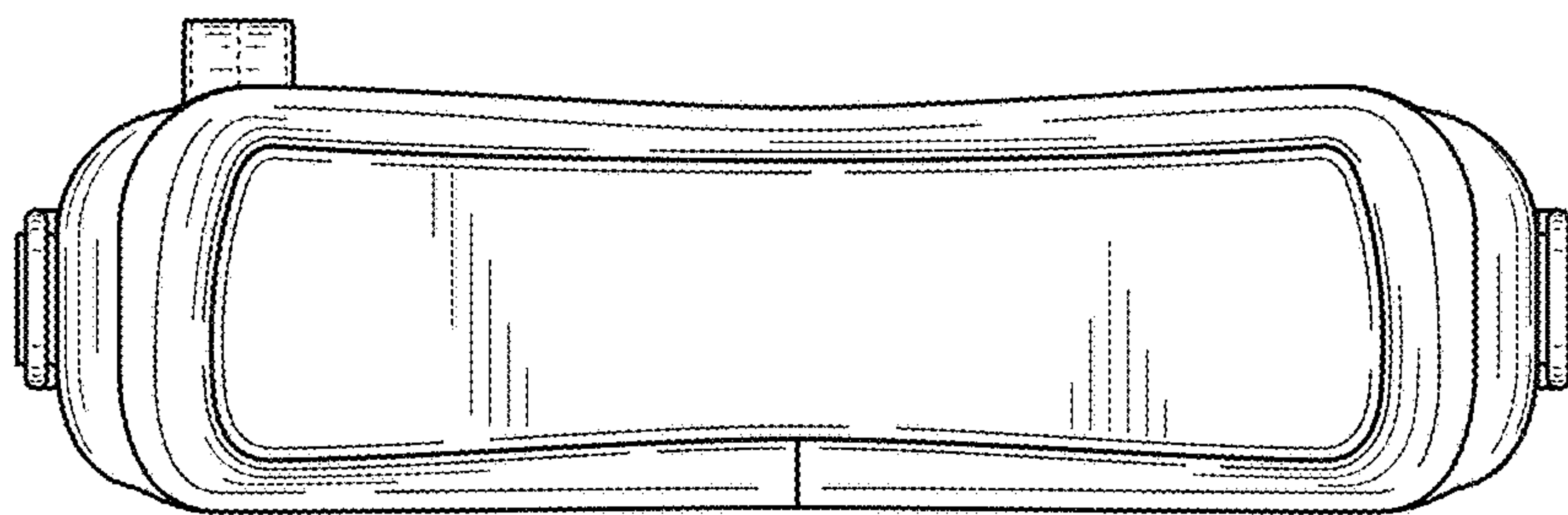

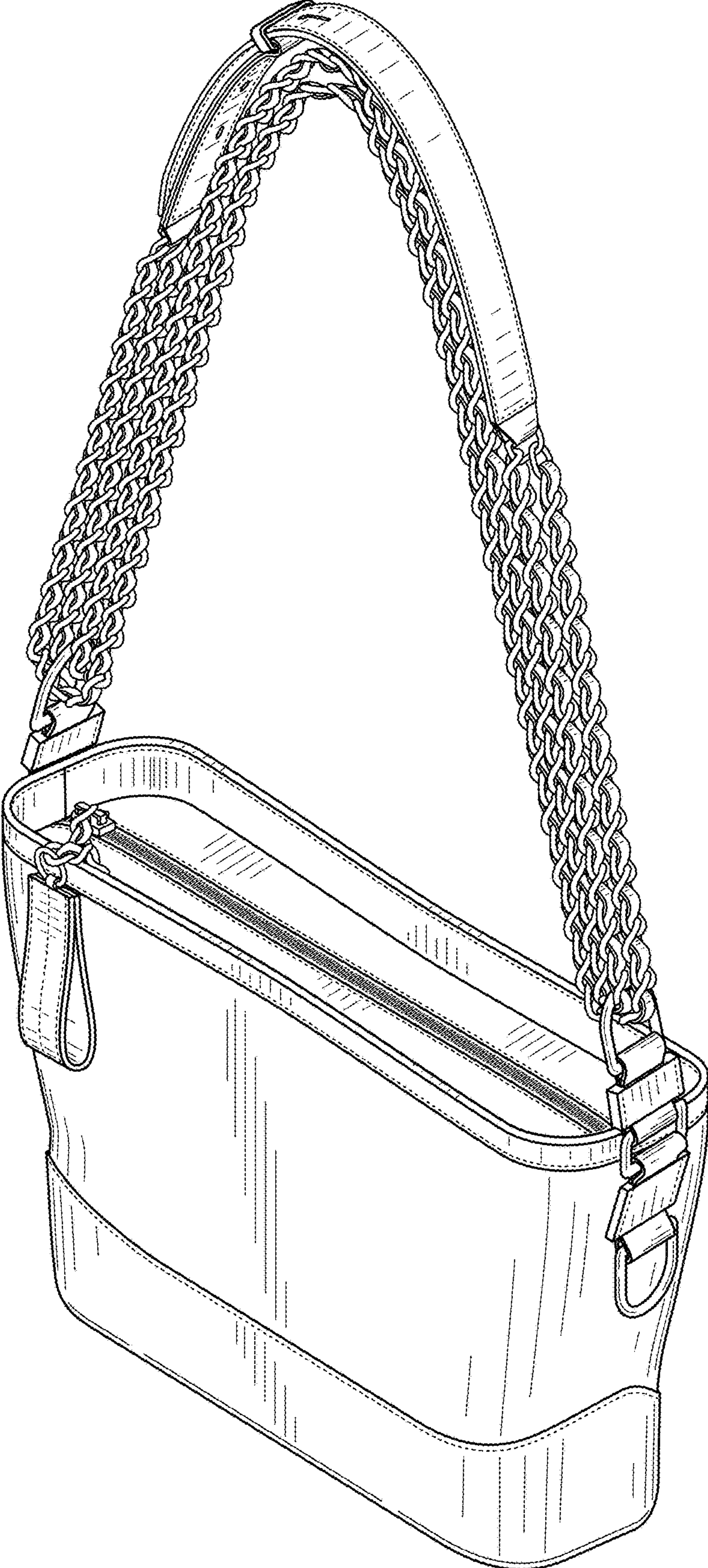

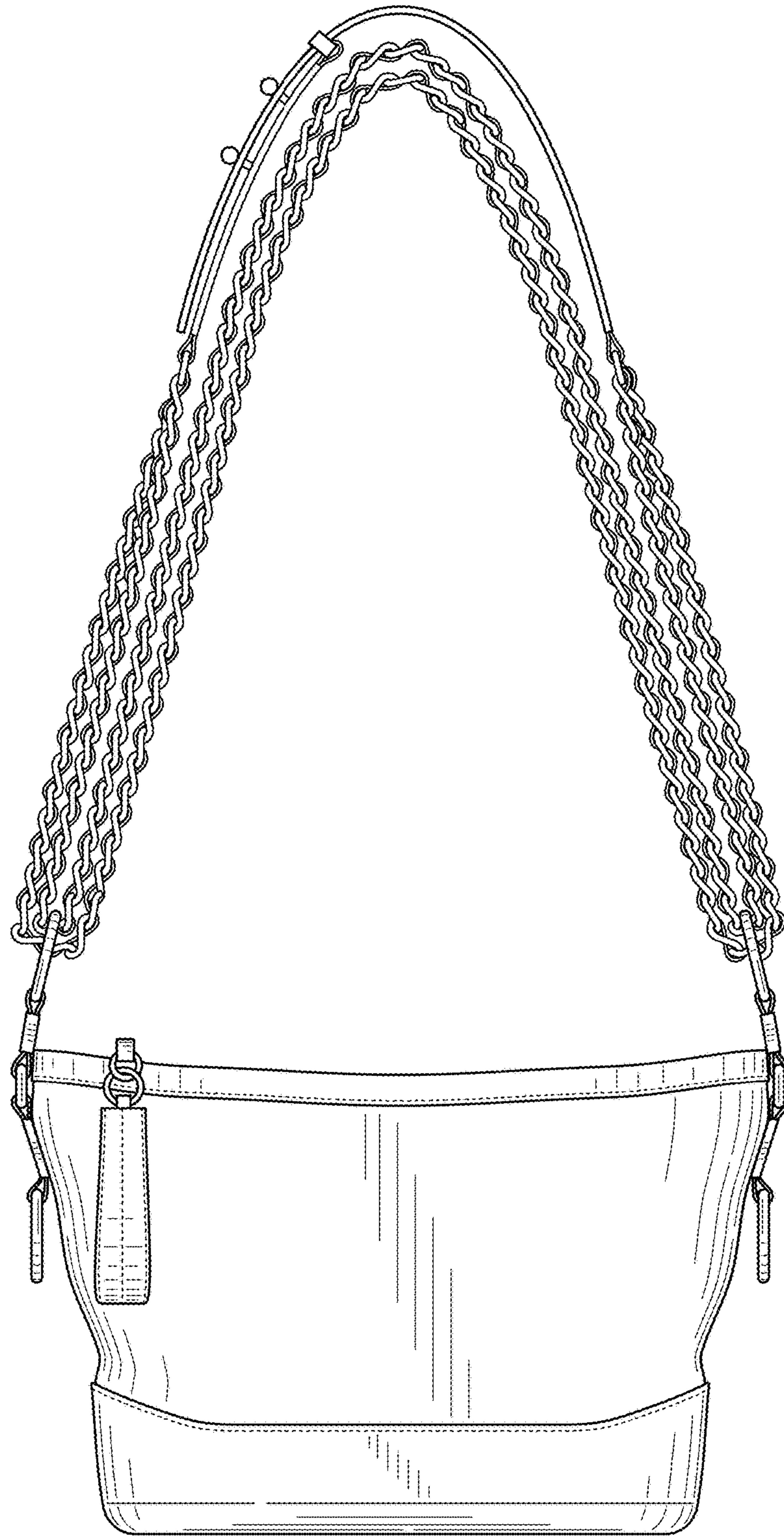

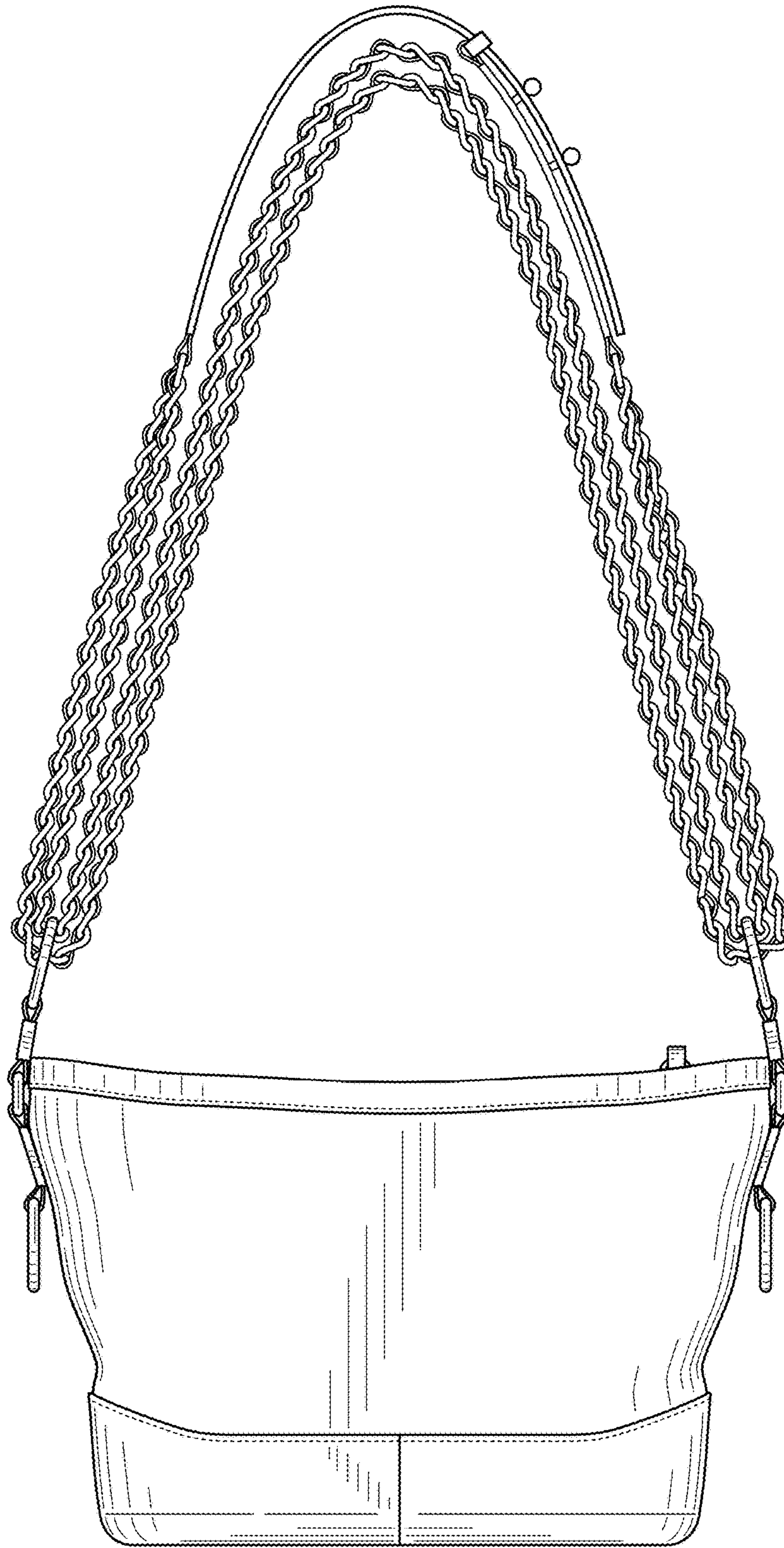

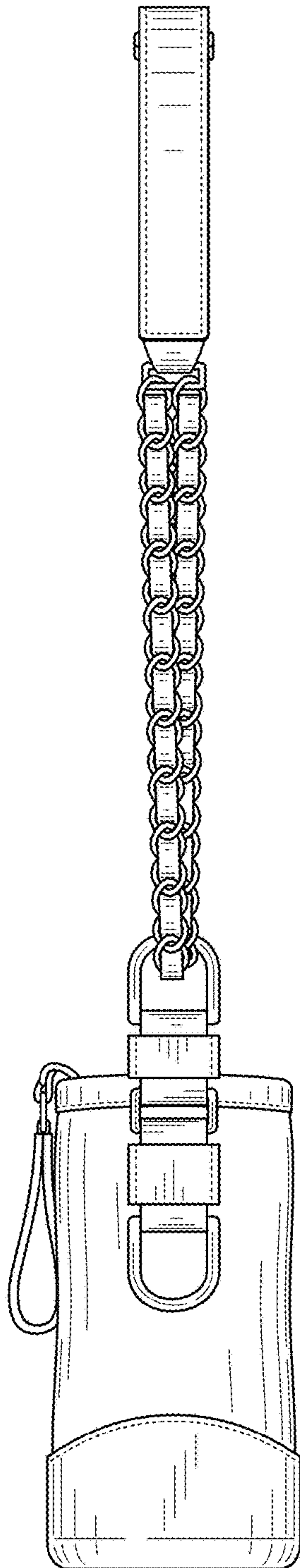

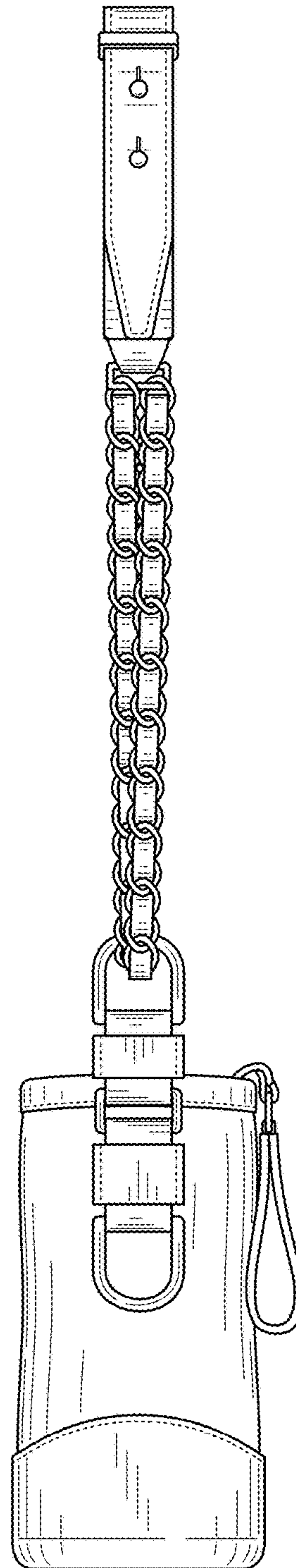

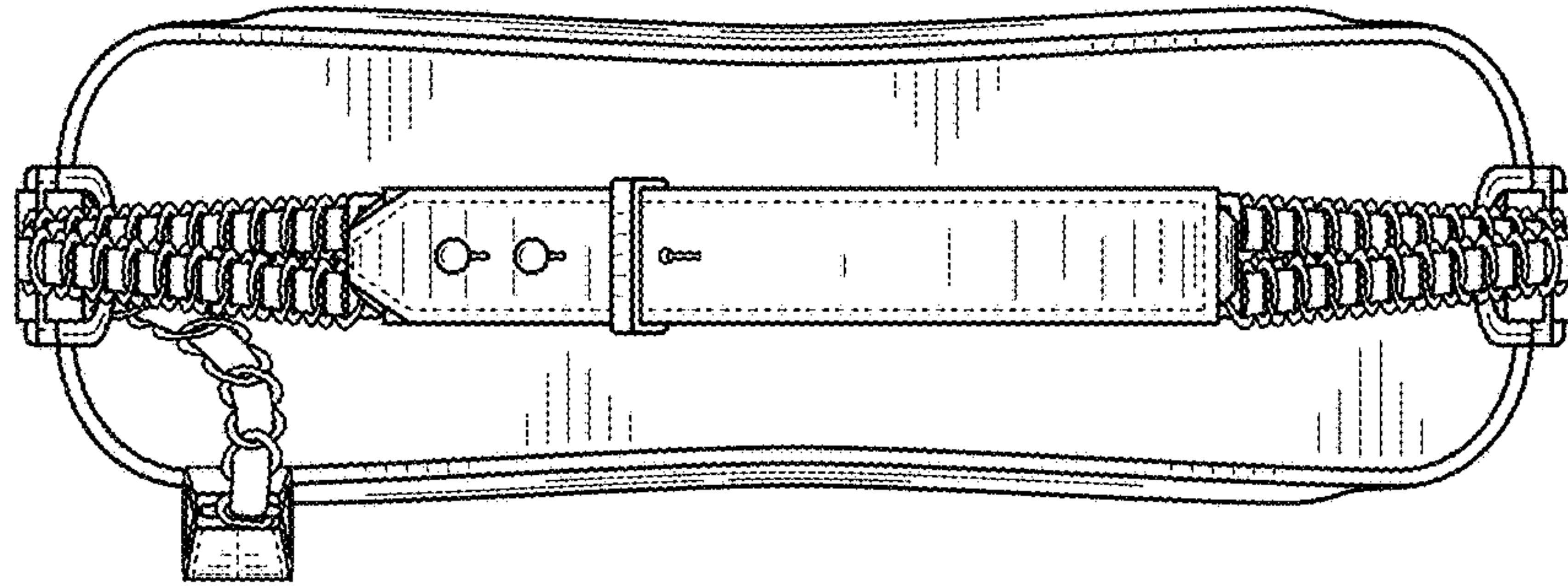

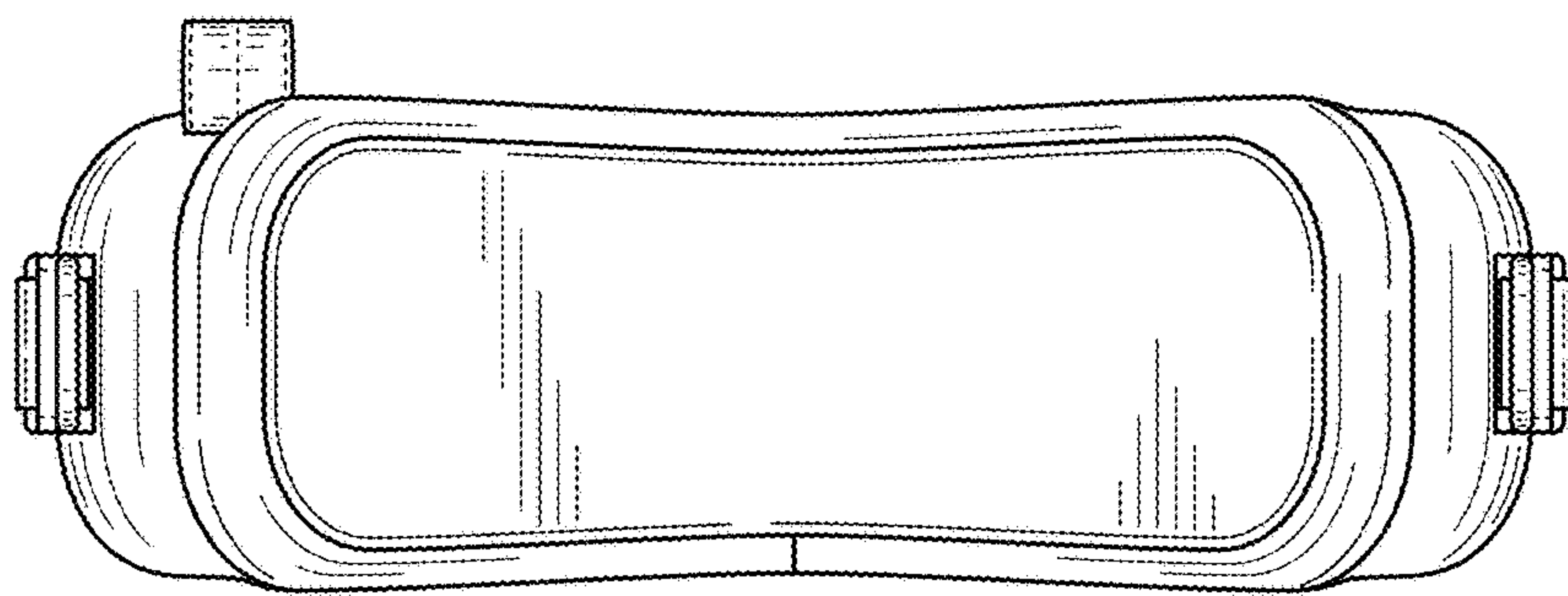
