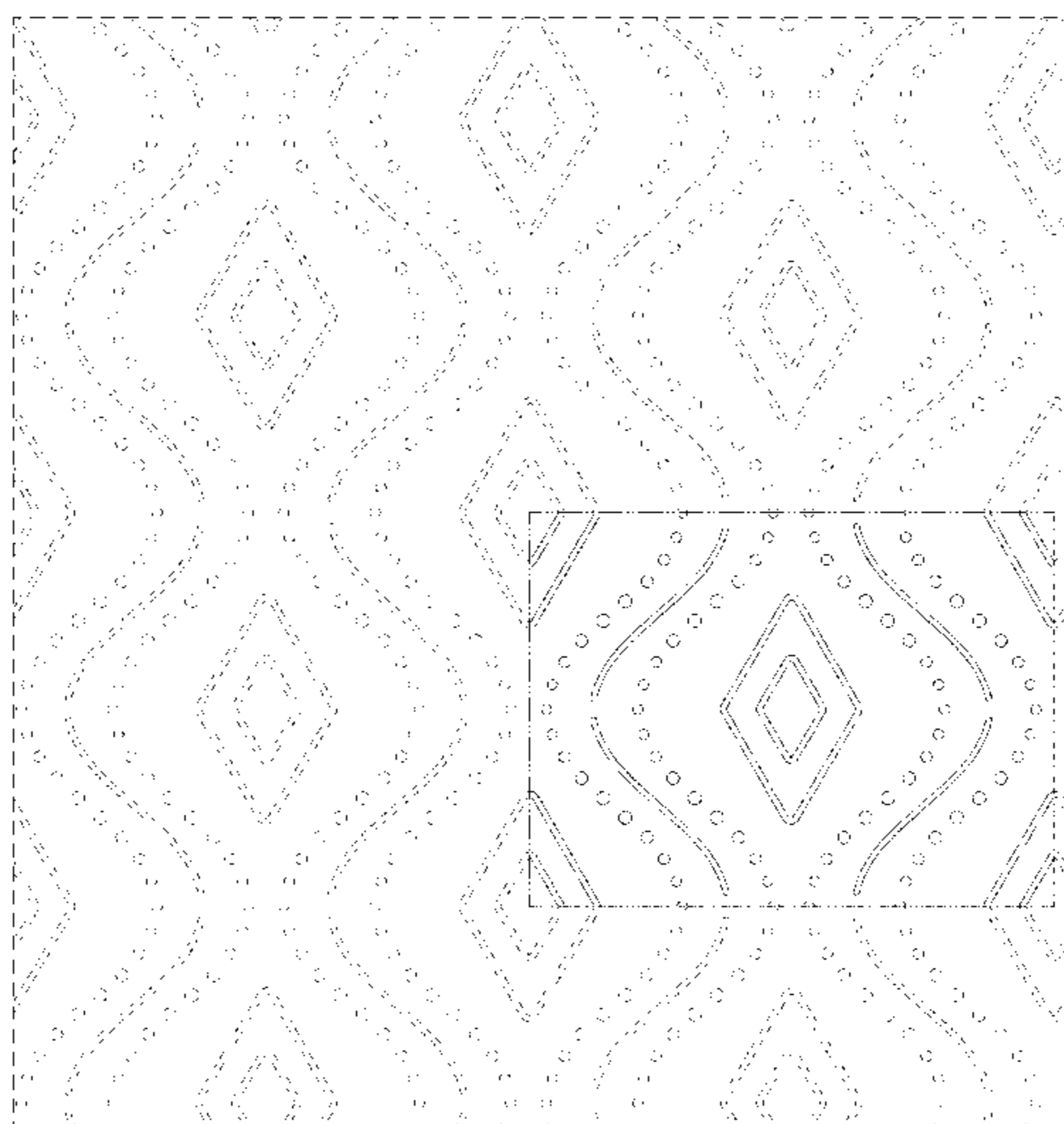
FIG. 1 is a perspective view of a paper product showing my new ornamental design;

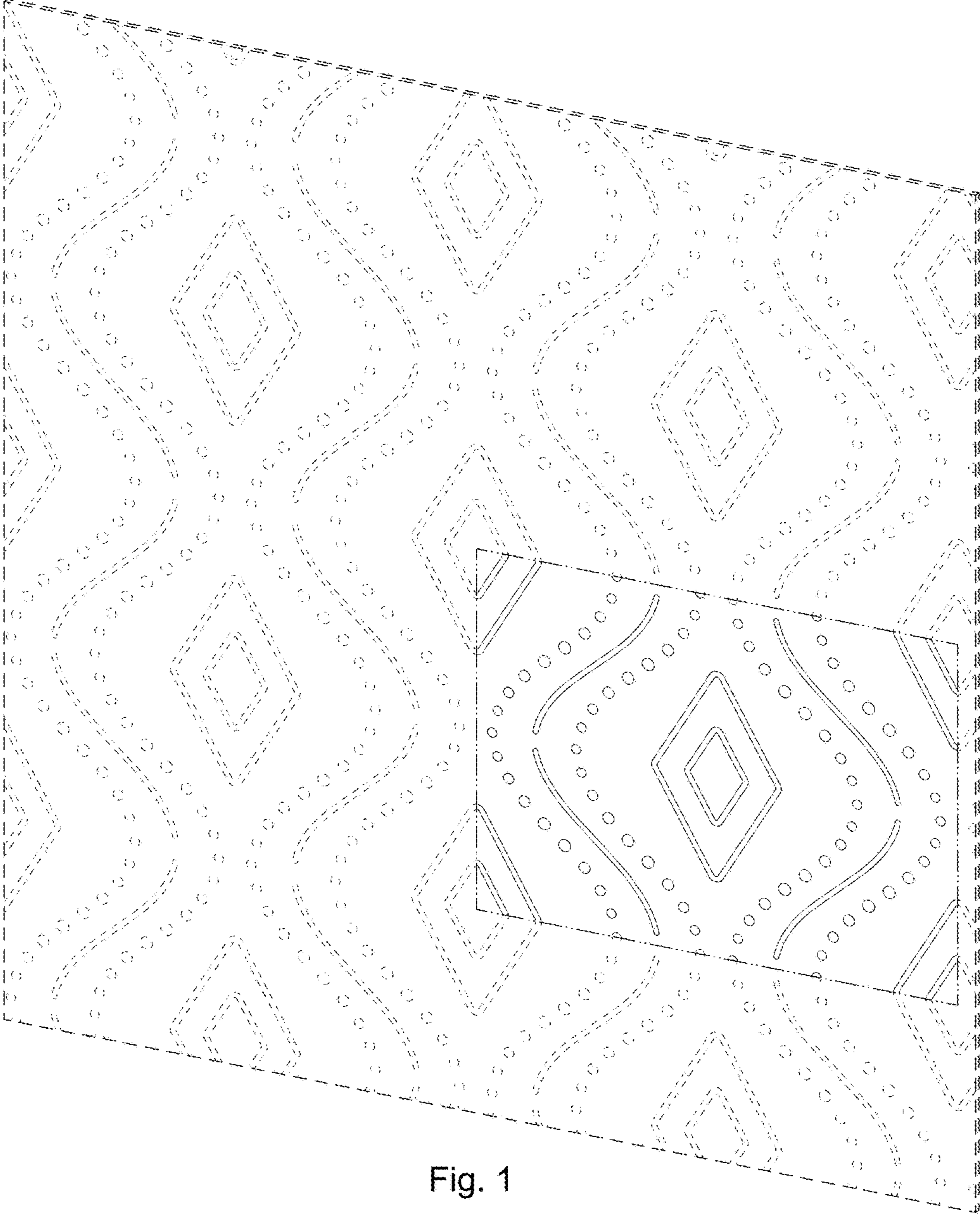

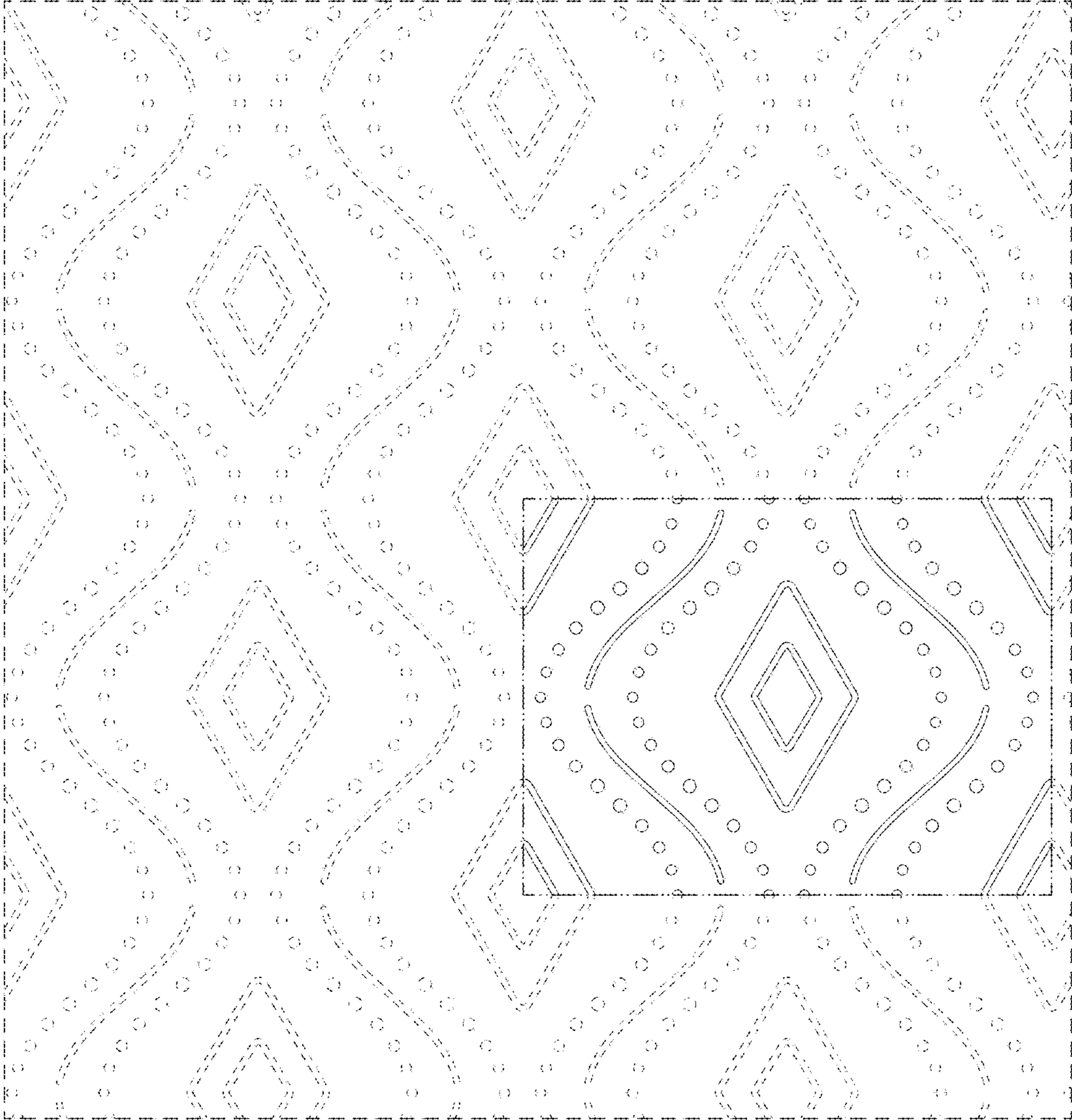

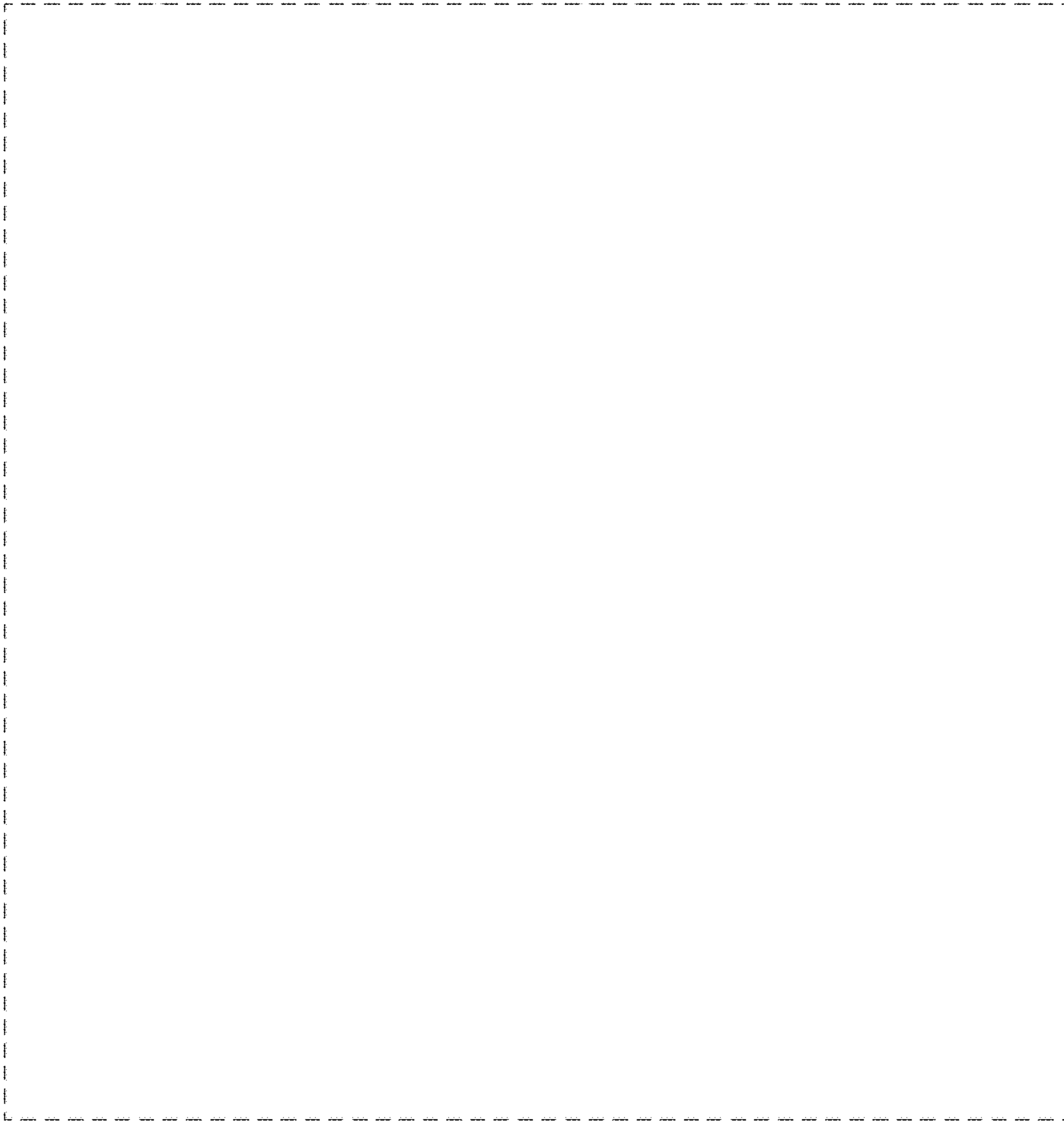

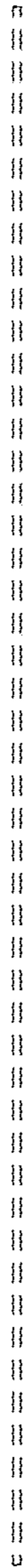

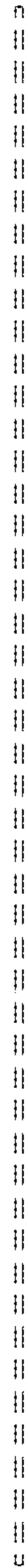

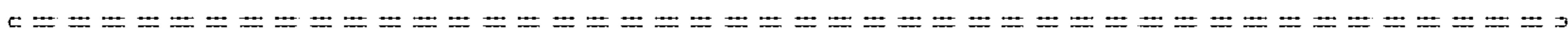

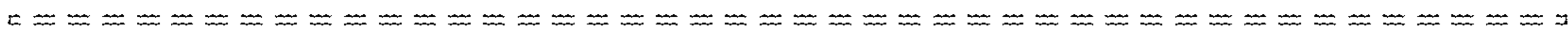
