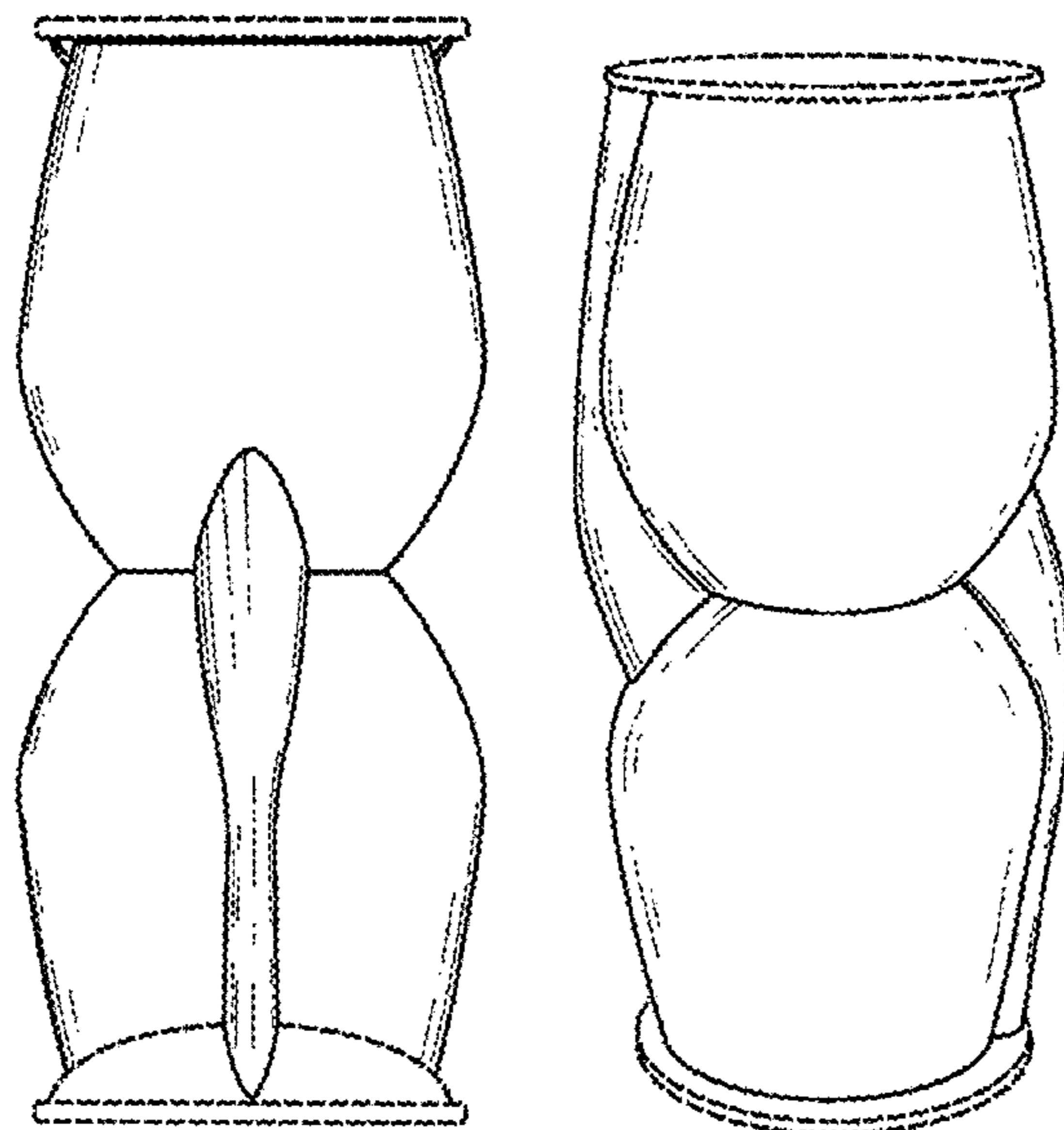
(57) **CLAIM**

The ornamental design for a stemmed glass set, as shown and described.

DESCRIPTION

FIG. 1 is a left perspective view of a first embodiment of a stemmed glass set showing my new design;
 FIG. 2 is a top view thereof;
 FIG. 3 is a bottom view thereof;
 FIG. 4 is a right side view thereof, the left side view being a mirror image thereof;
 FIG. 5 is a front view thereof;
 FIG. 6 is a rear view thereof;
 FIG. 7 is left perspective view of a second embodiment of a stemmed glass set;
 FIG. 8 is a right side view thereof, the left side view being a mirror image thereof;
 FIG. 9 is a front view thereof; and,
 FIG. 10 is a rear view thereof.
 The broken lines in the drawings depict portions of the stemmed glass set that form no part of the claimed design.

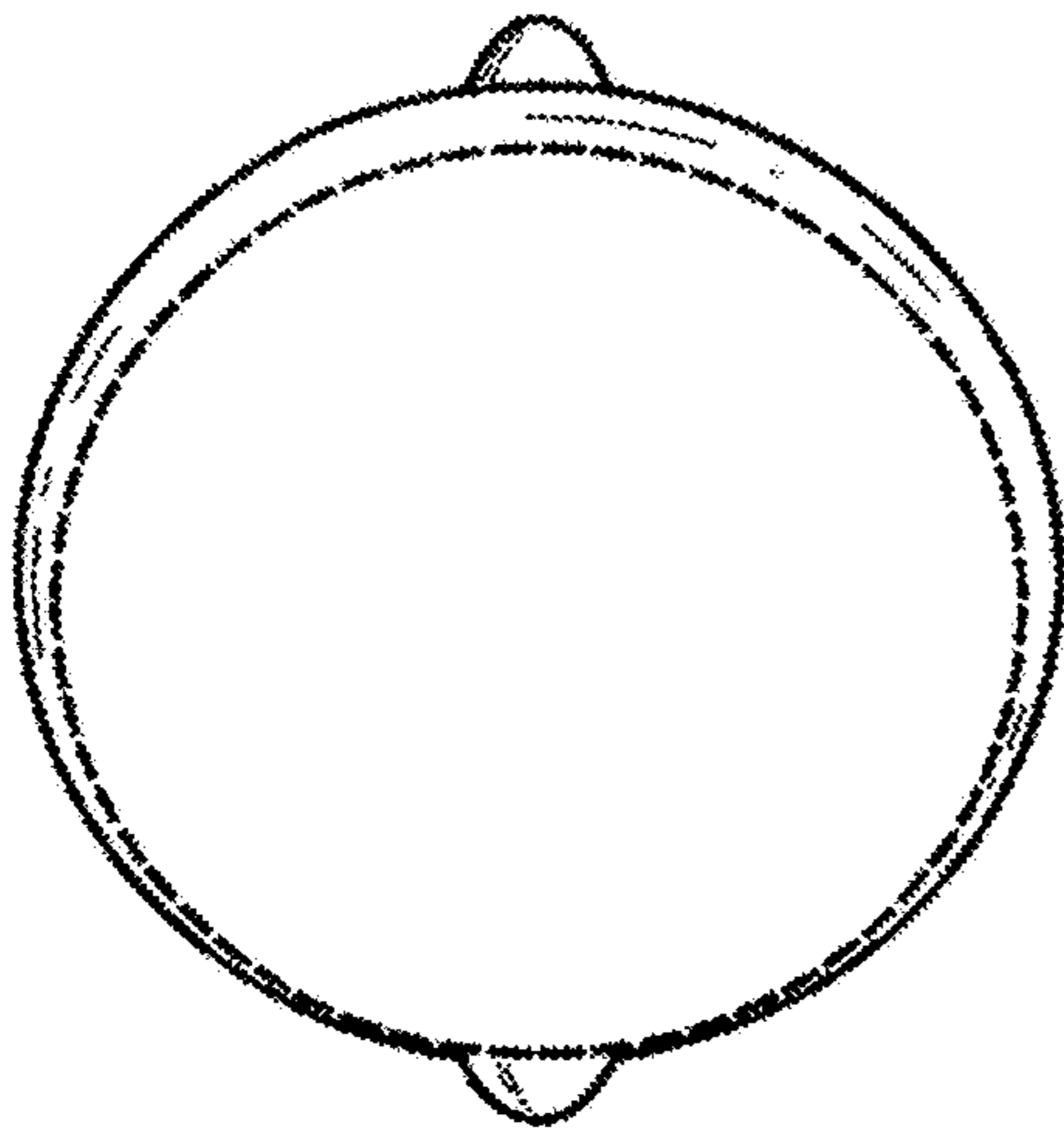

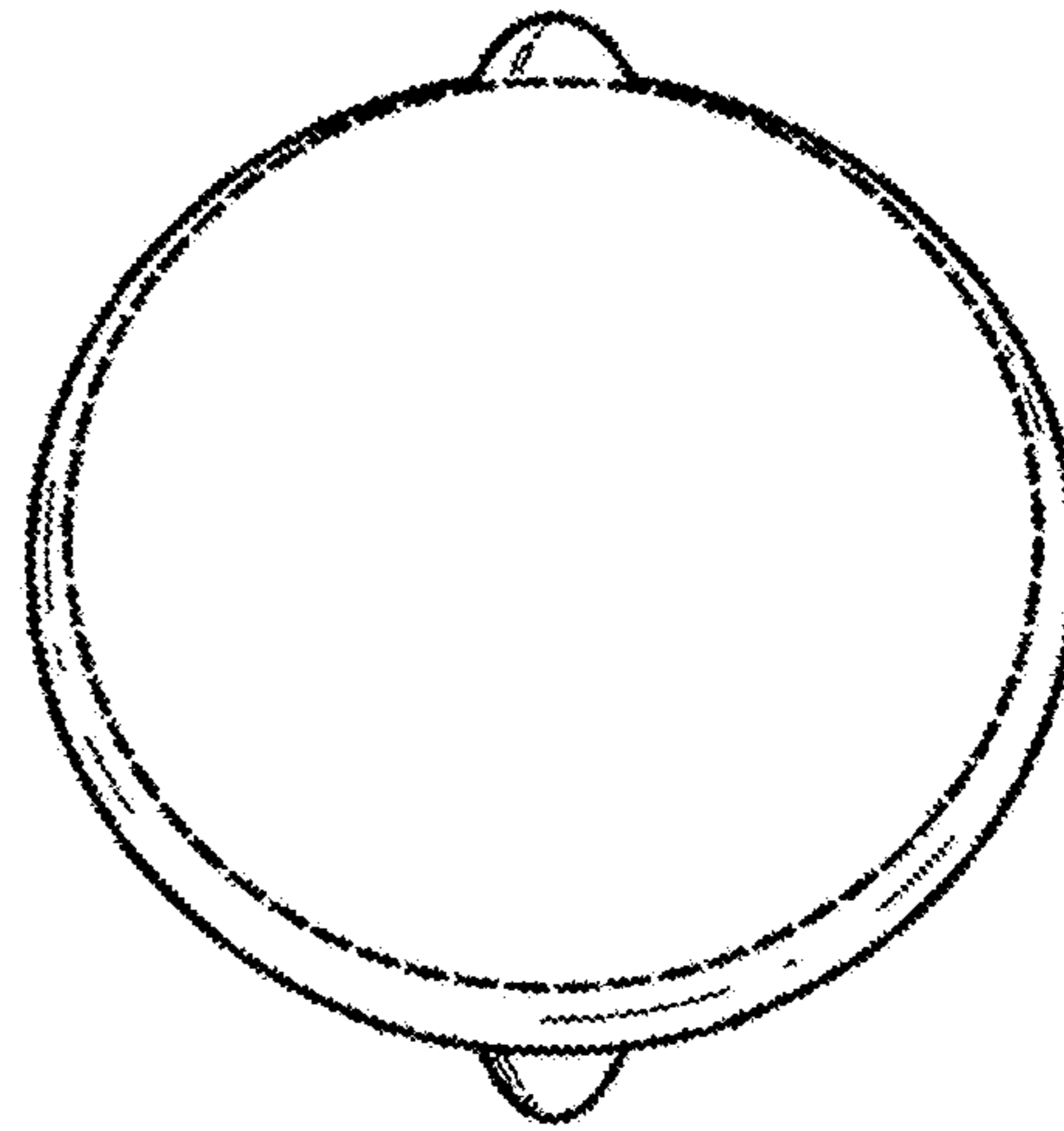

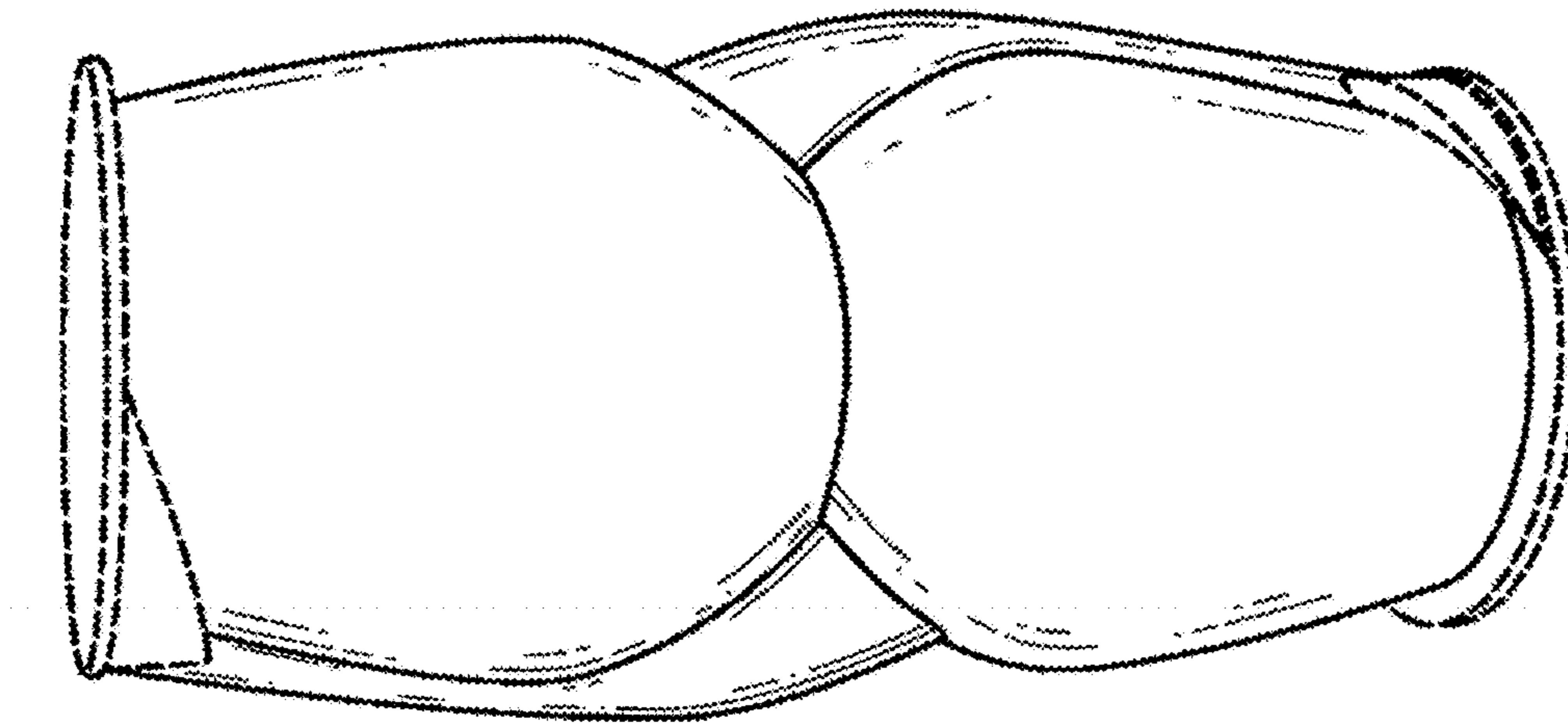

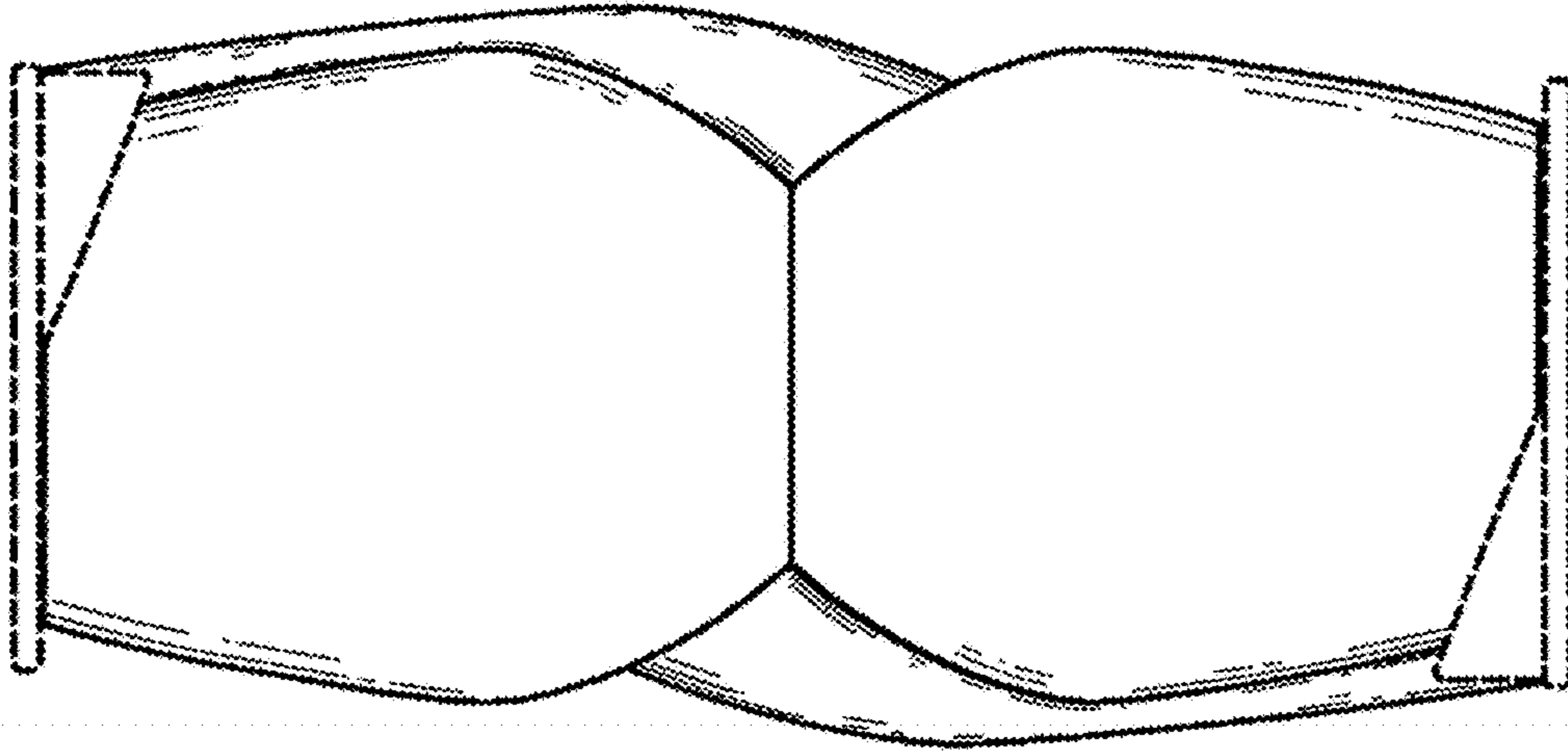

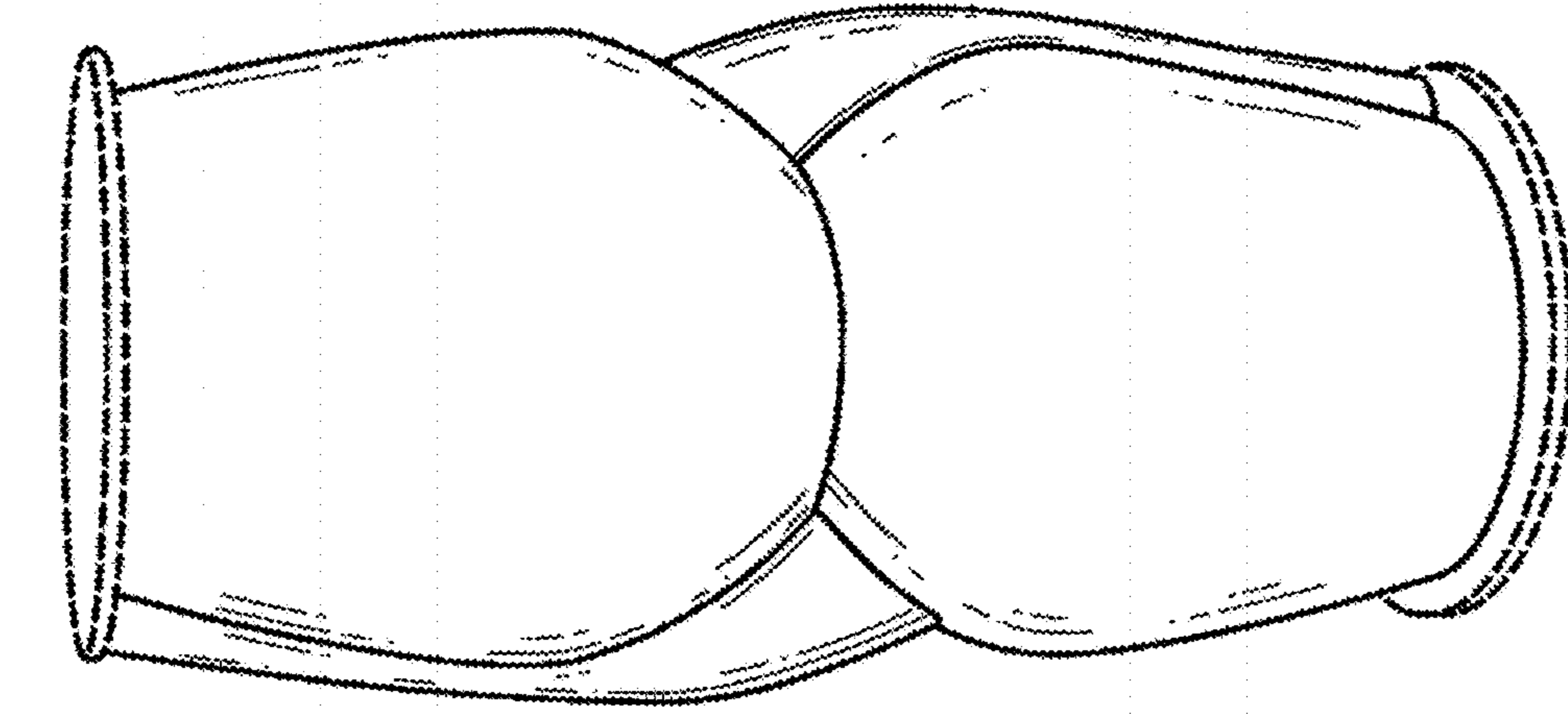

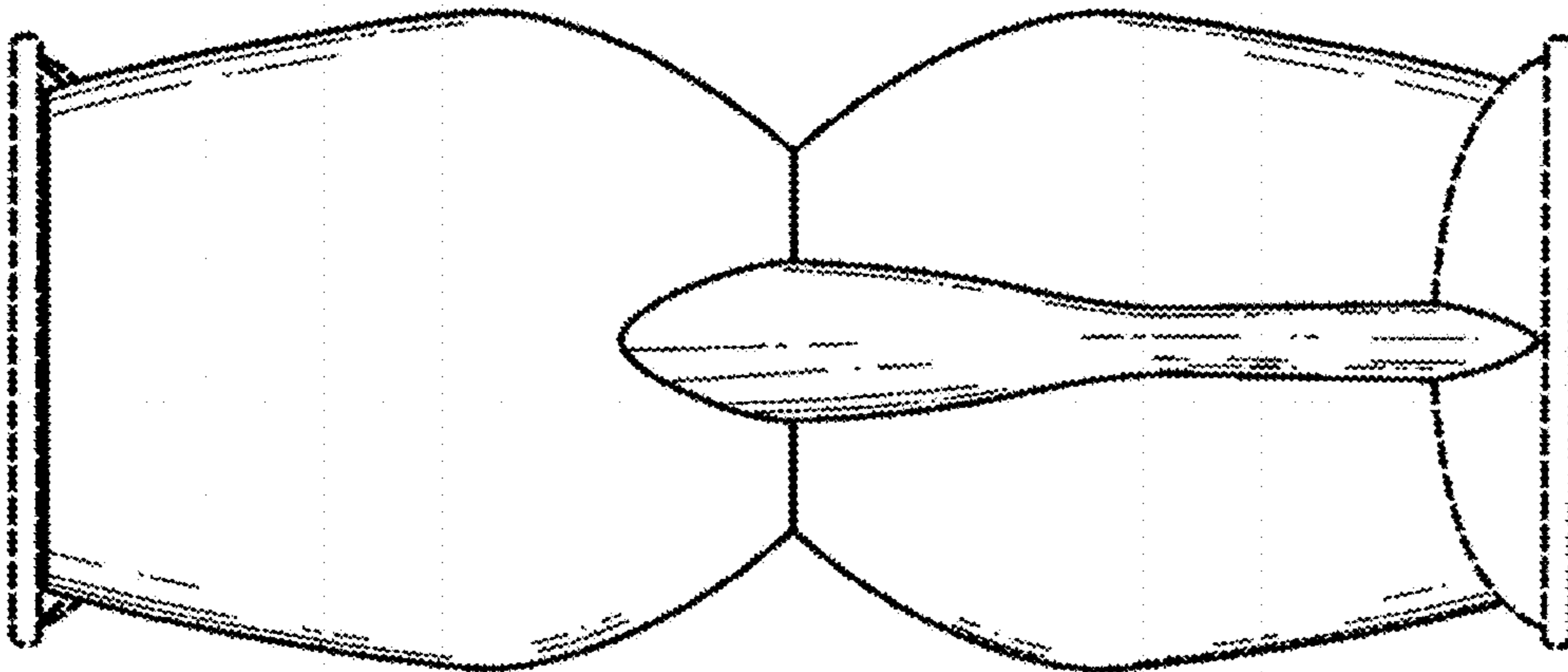

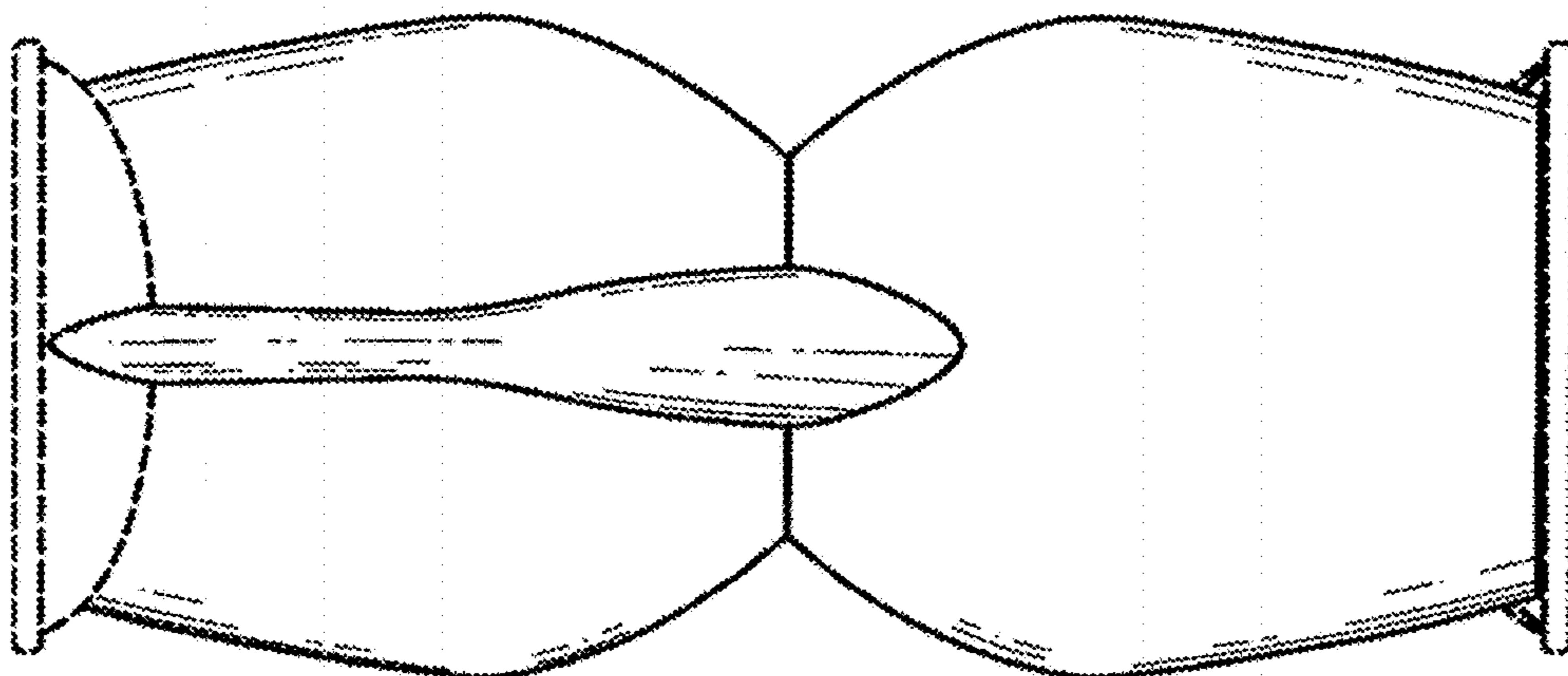

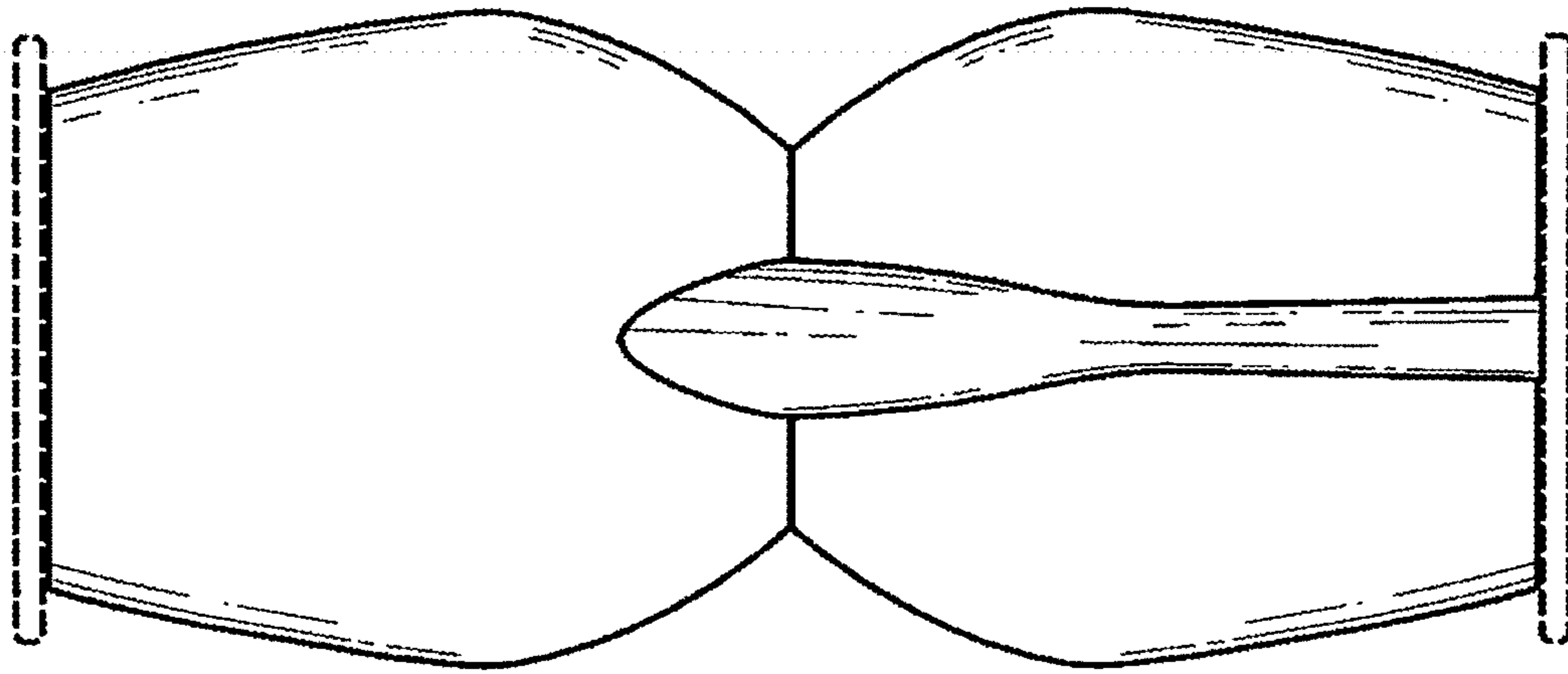

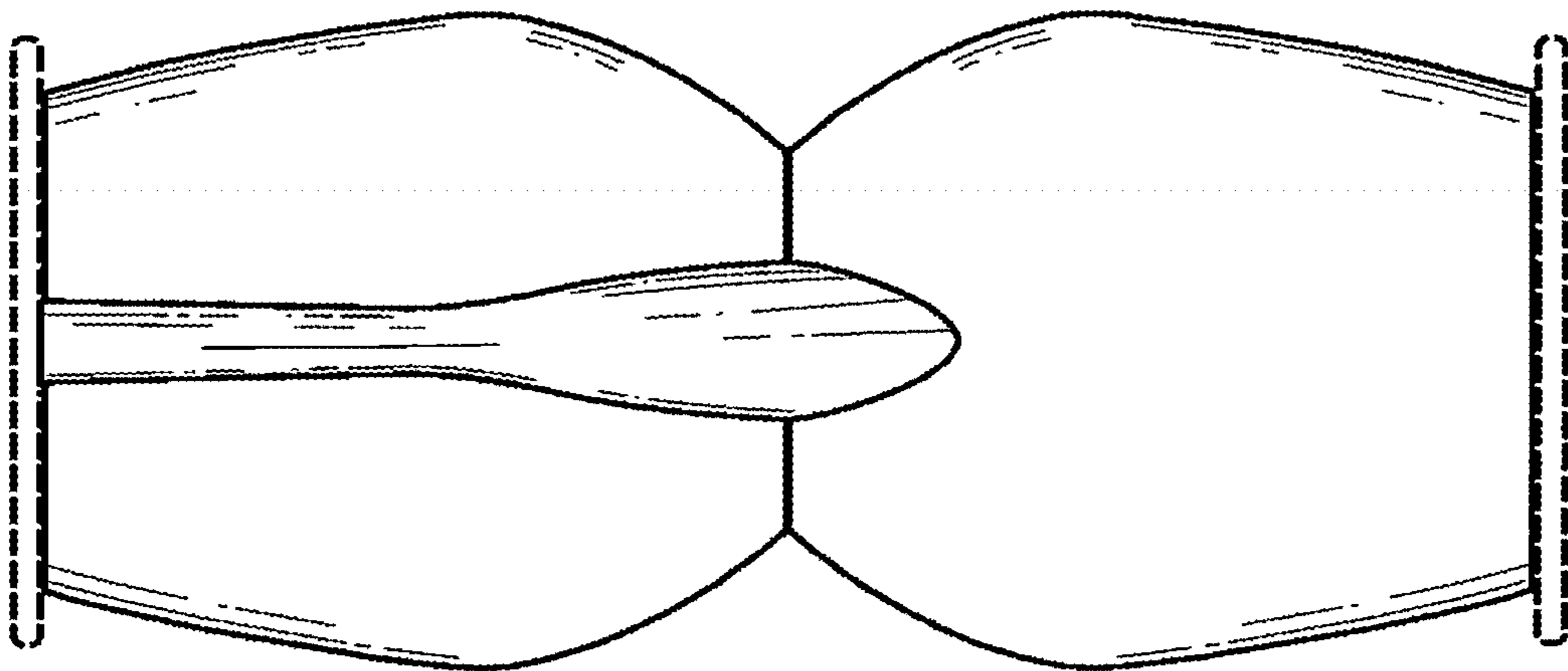

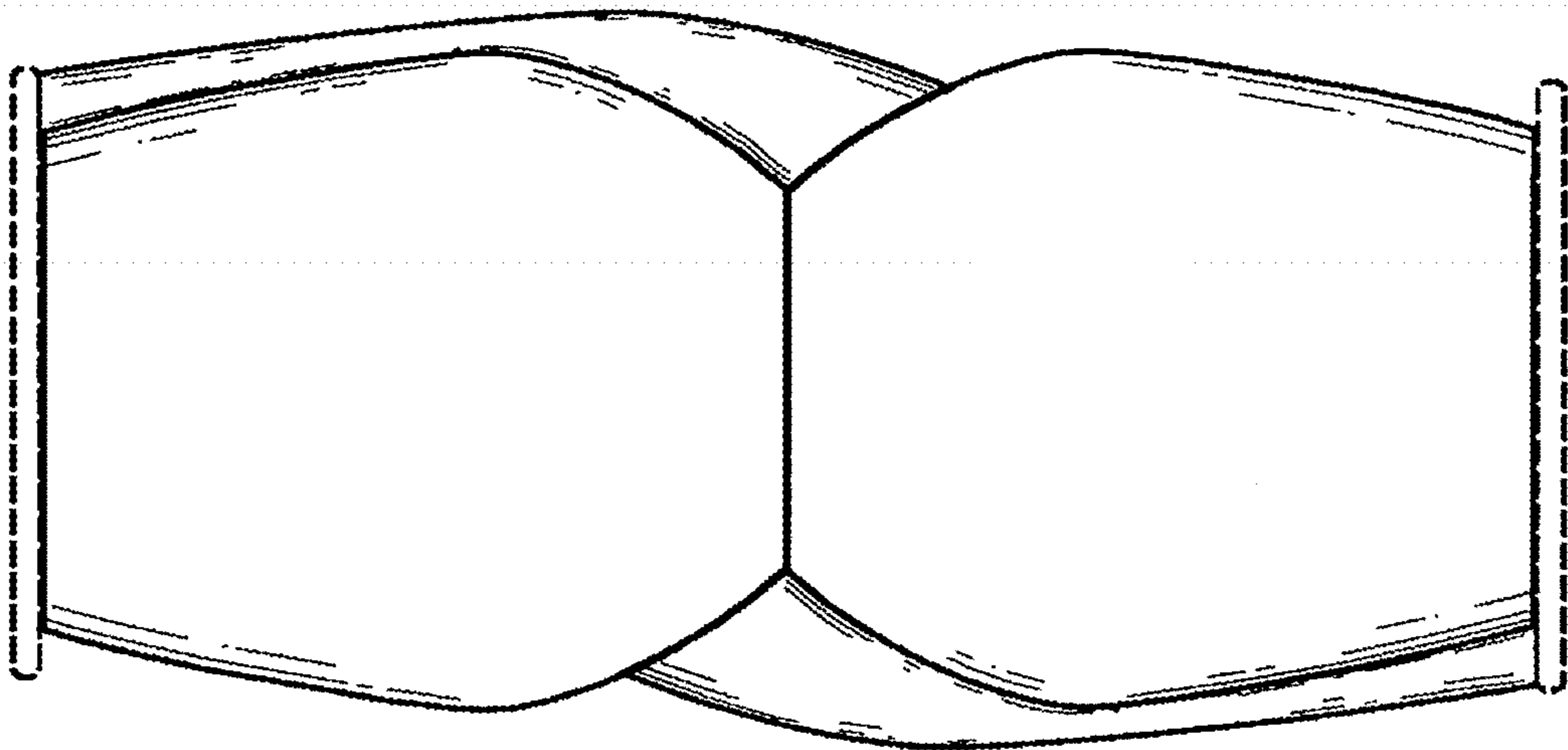
