FIG. 2 is a bottom perspective view of the drinkware;

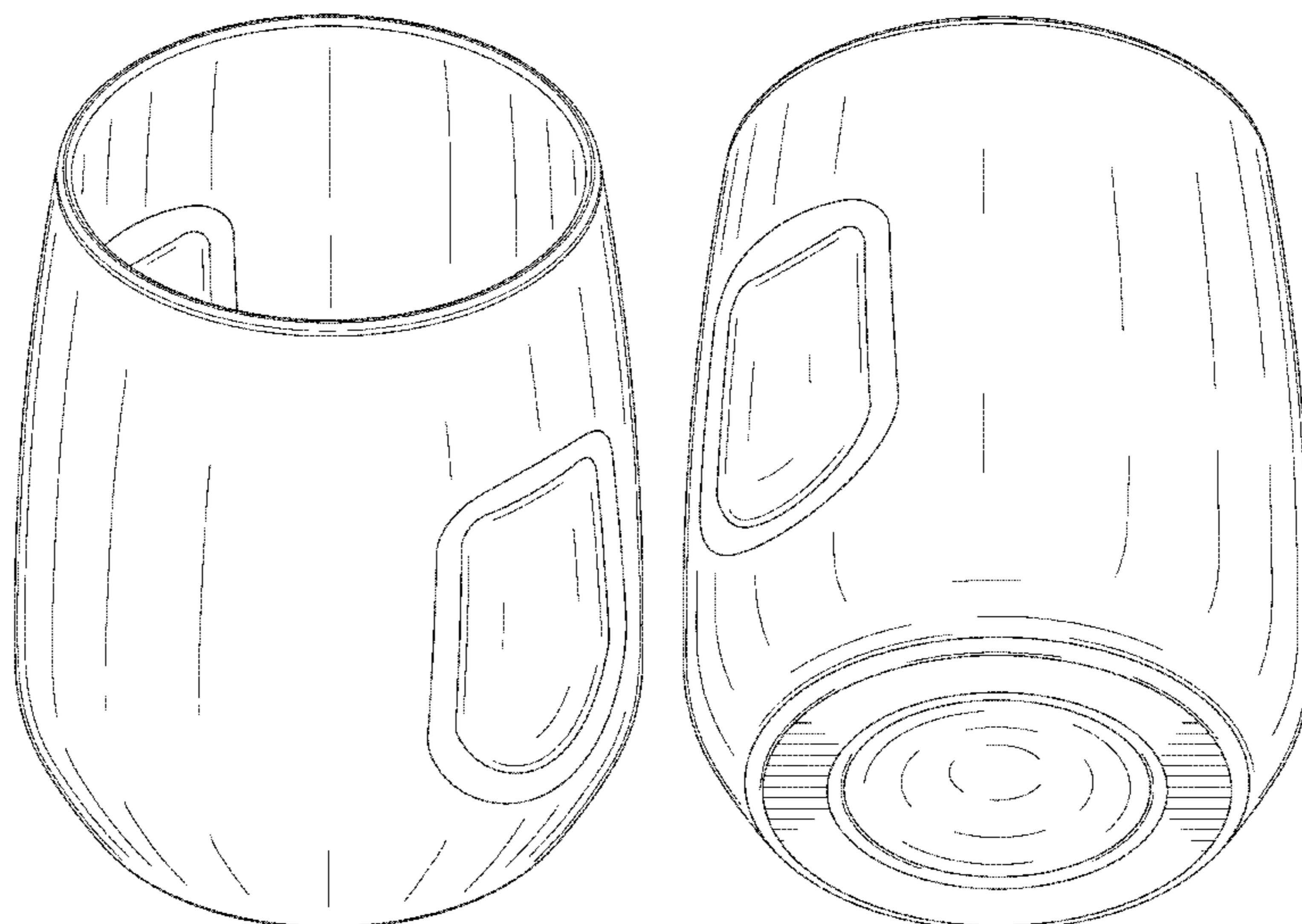
FIG. 3 is top view of the drinkware;

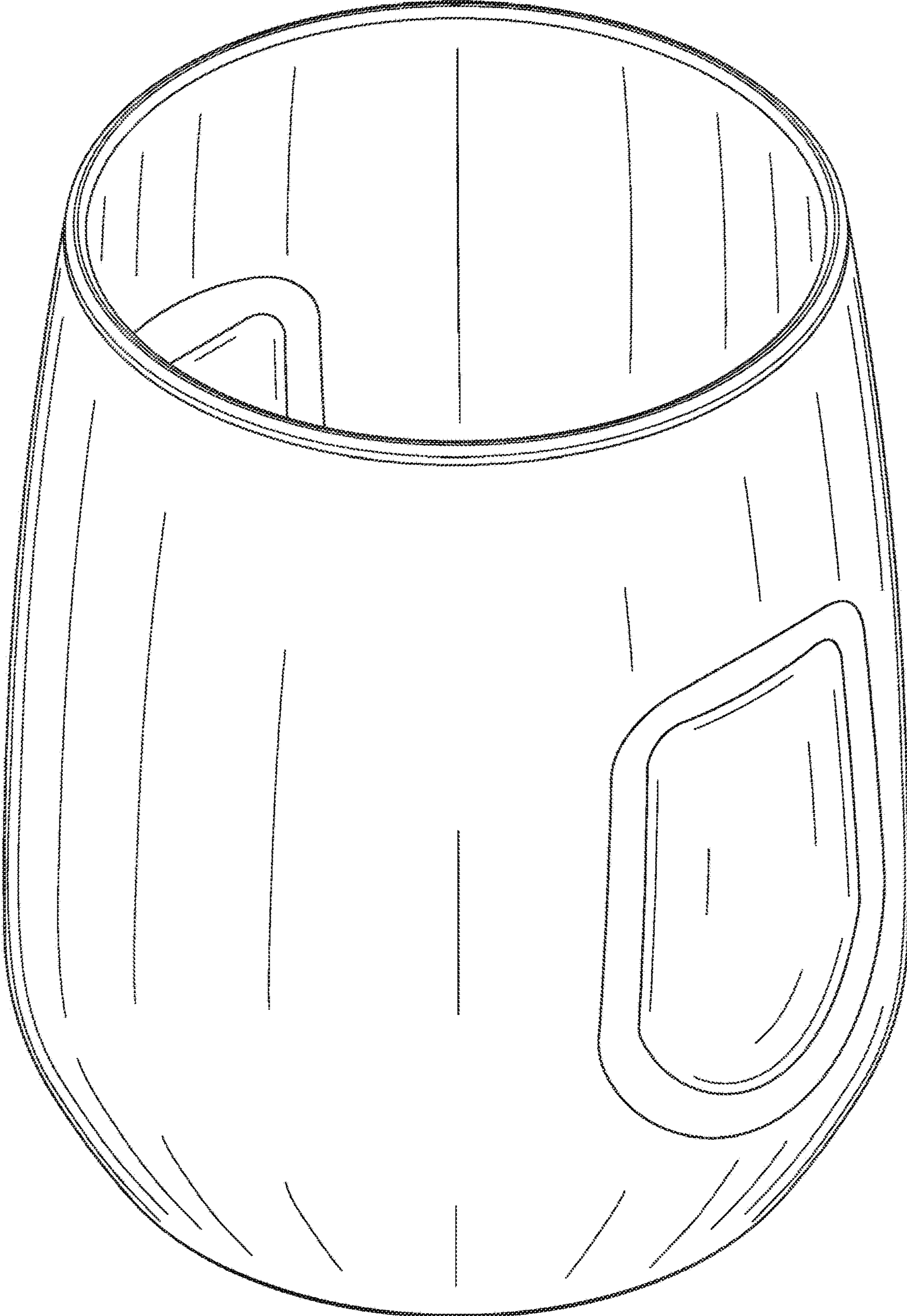

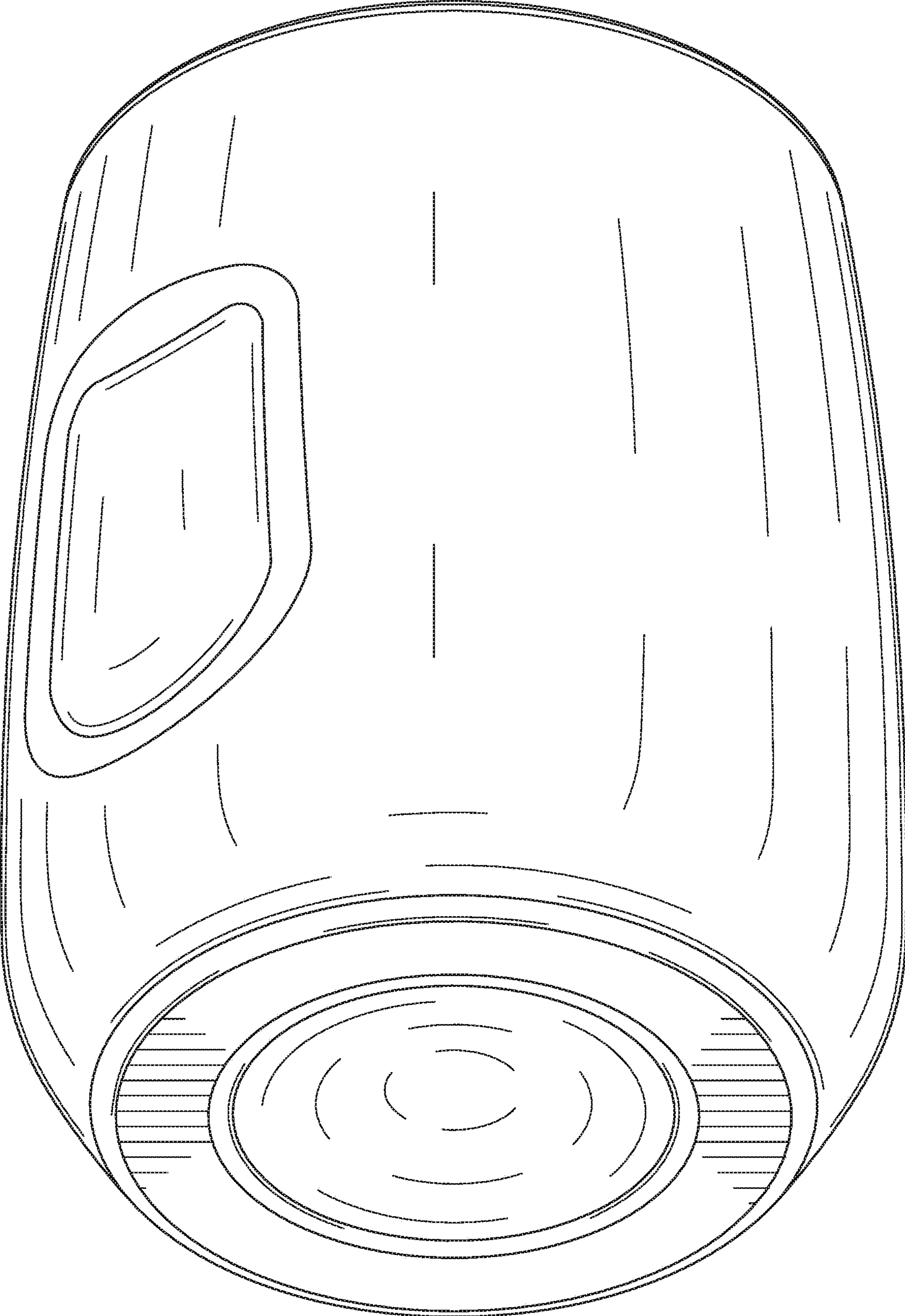

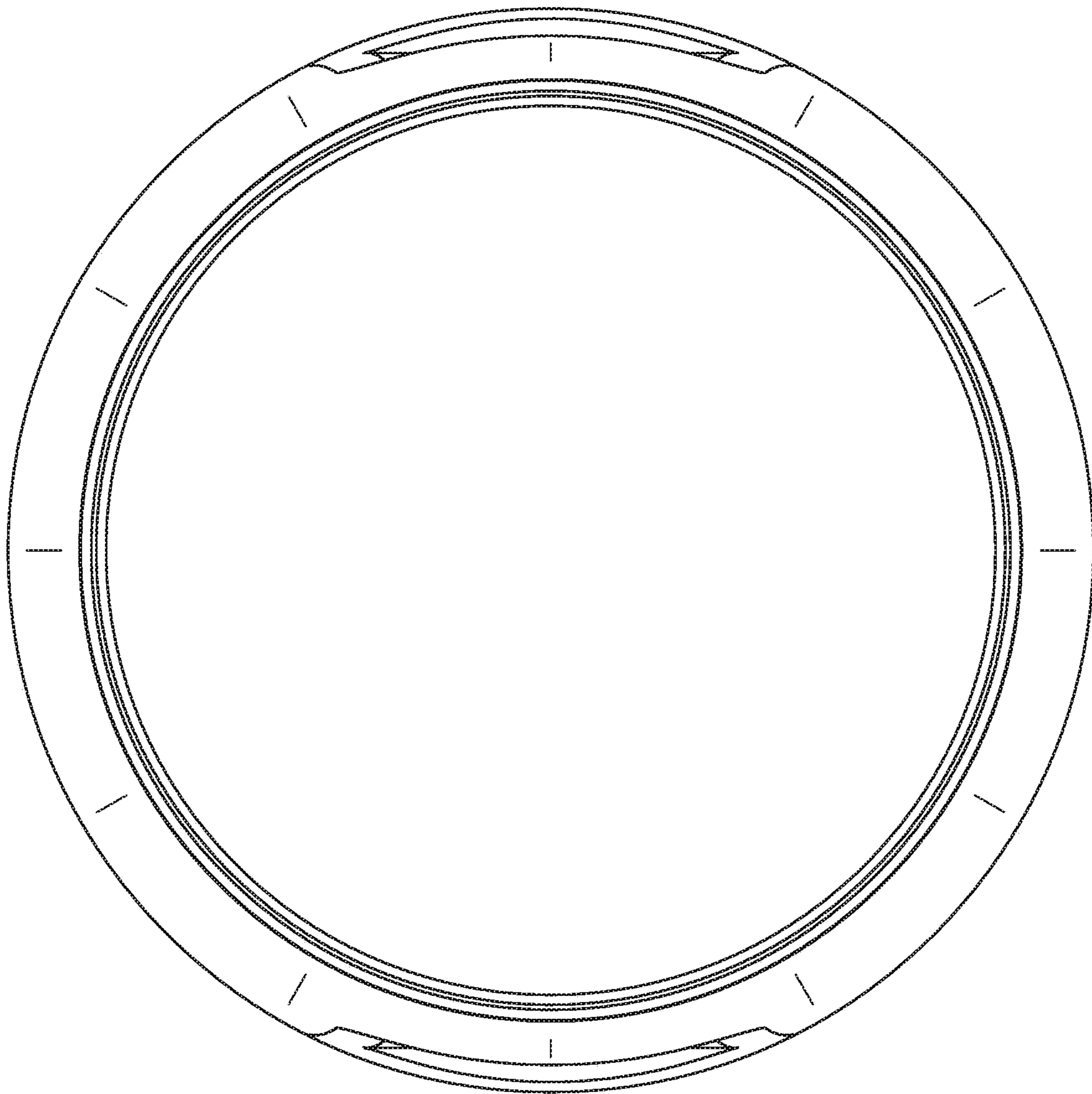

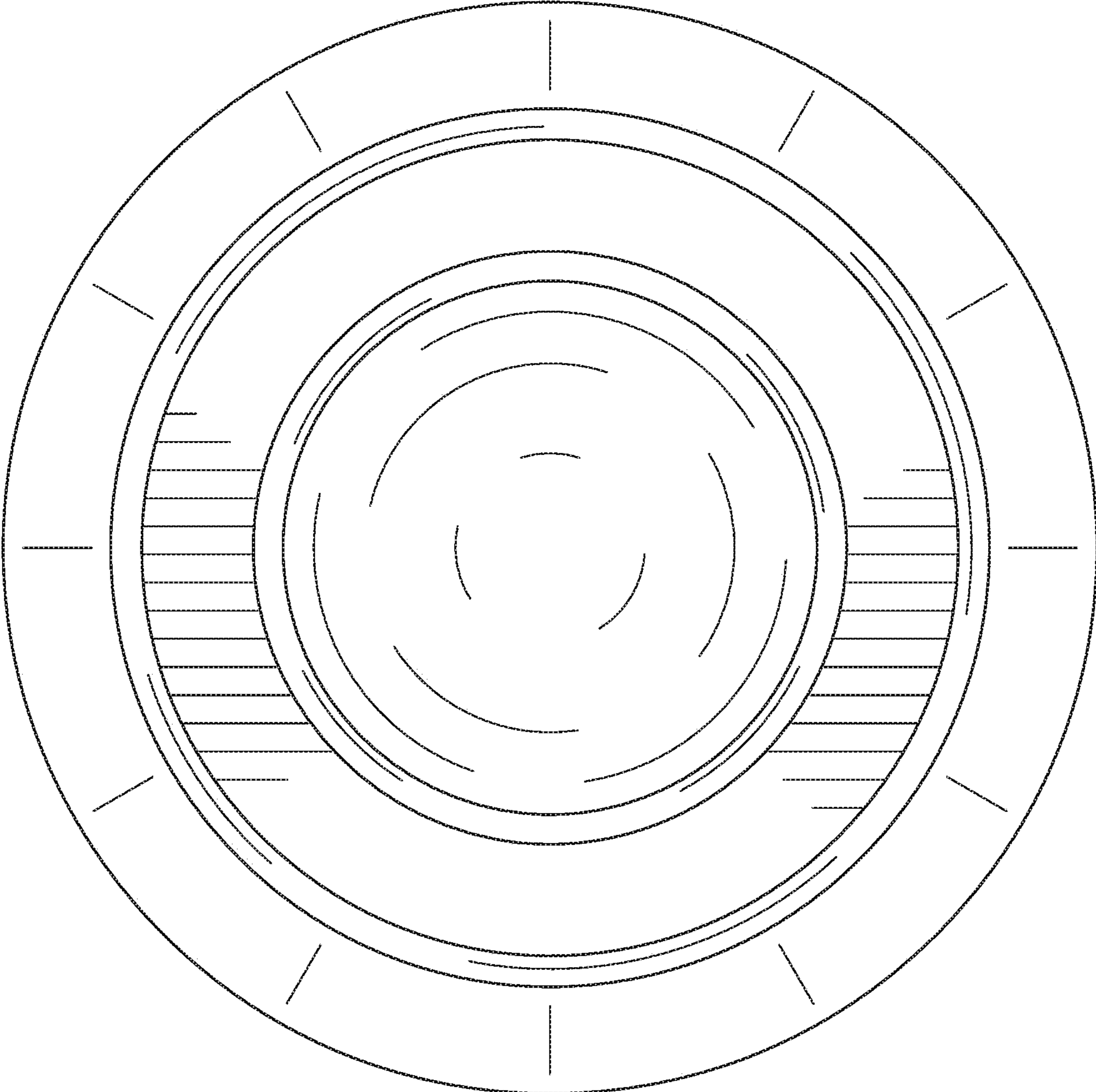

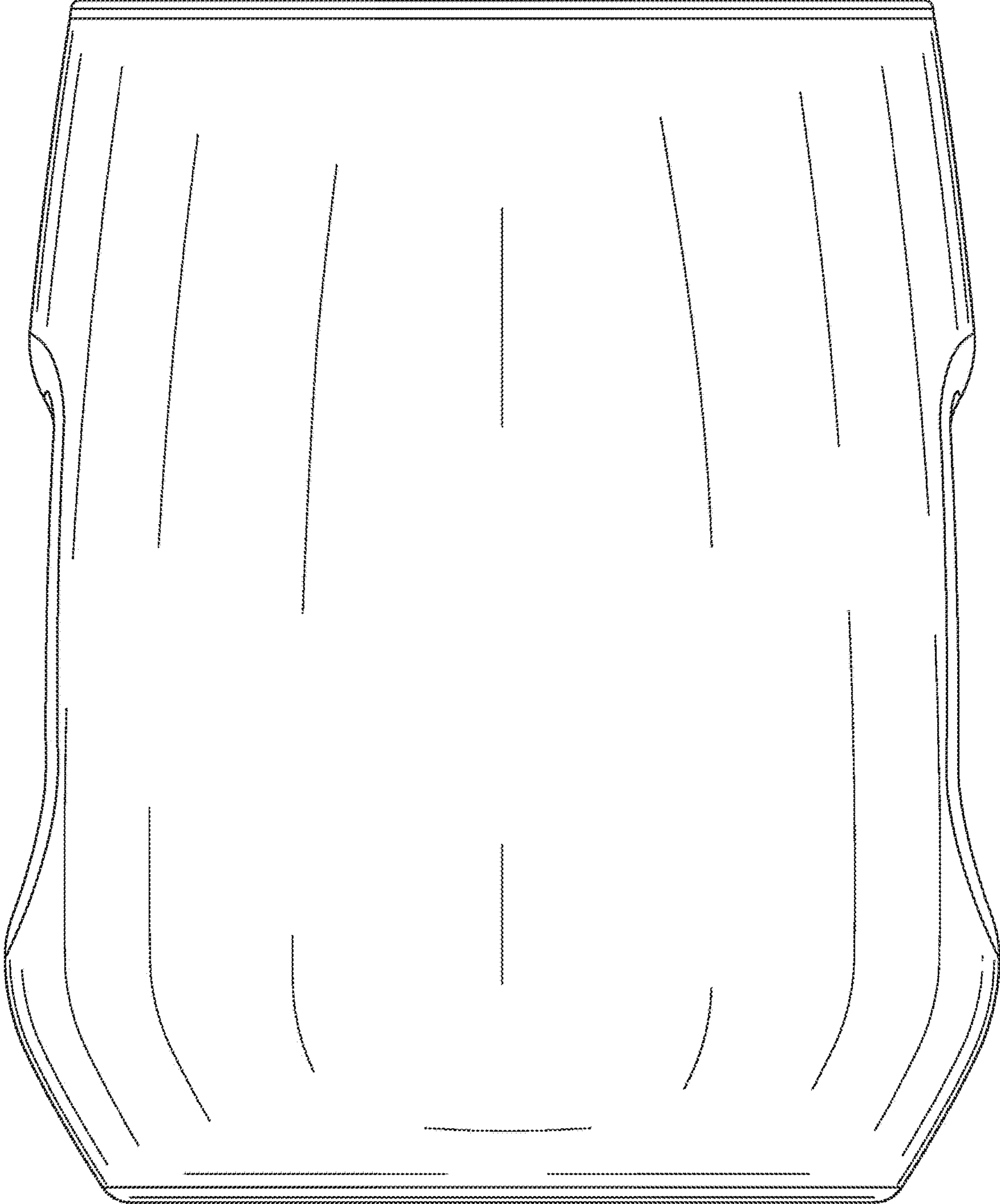

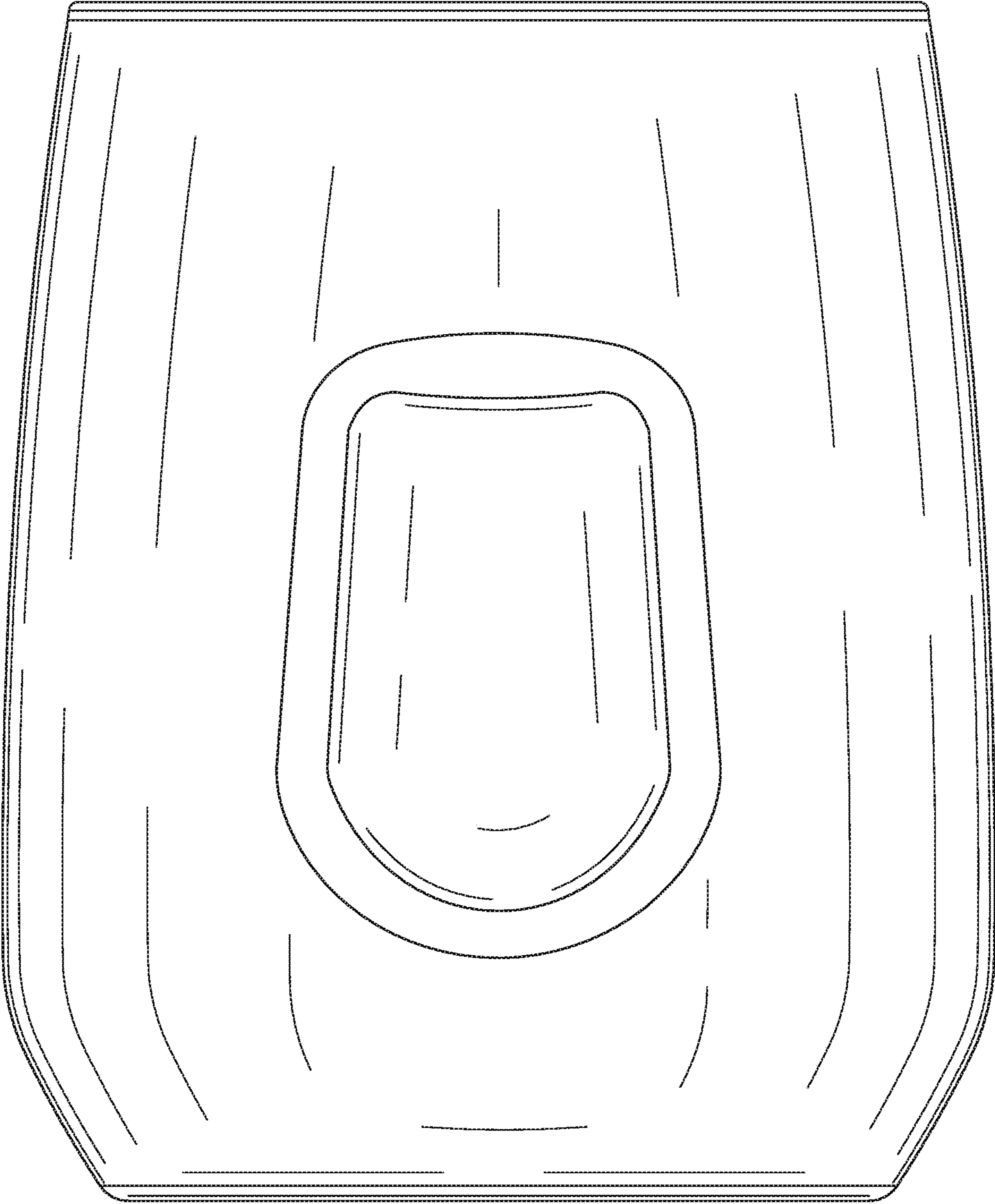
