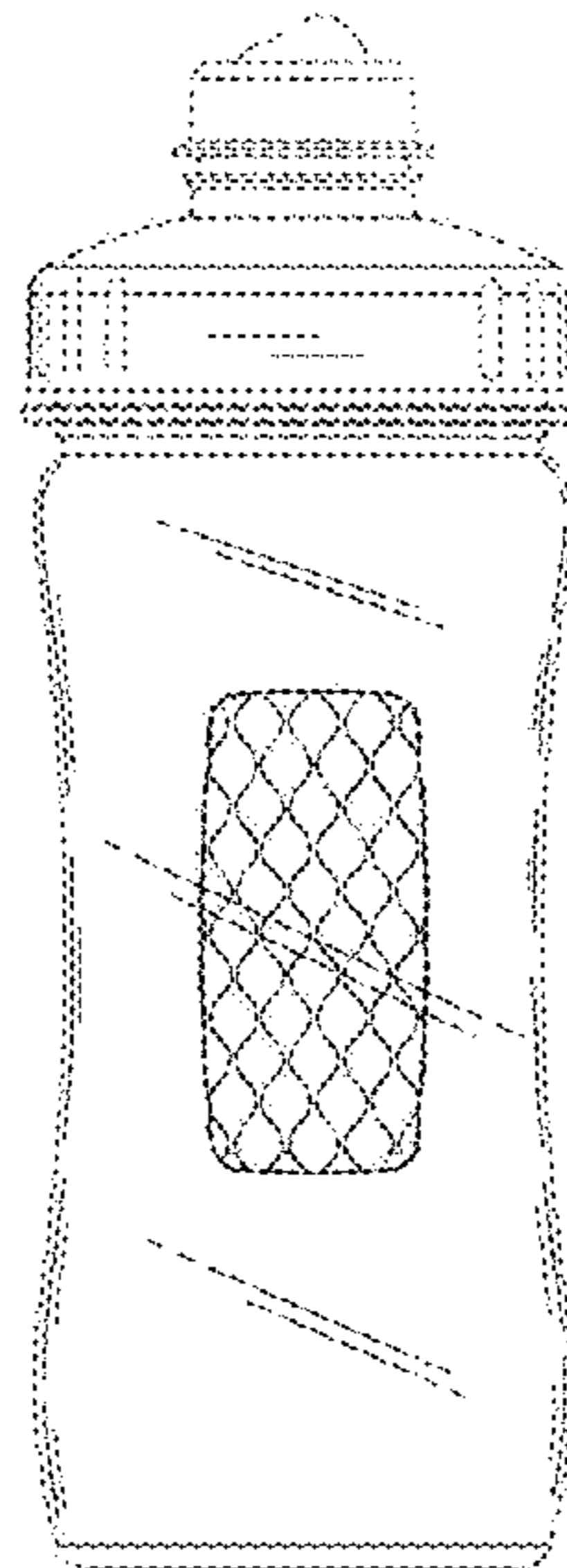
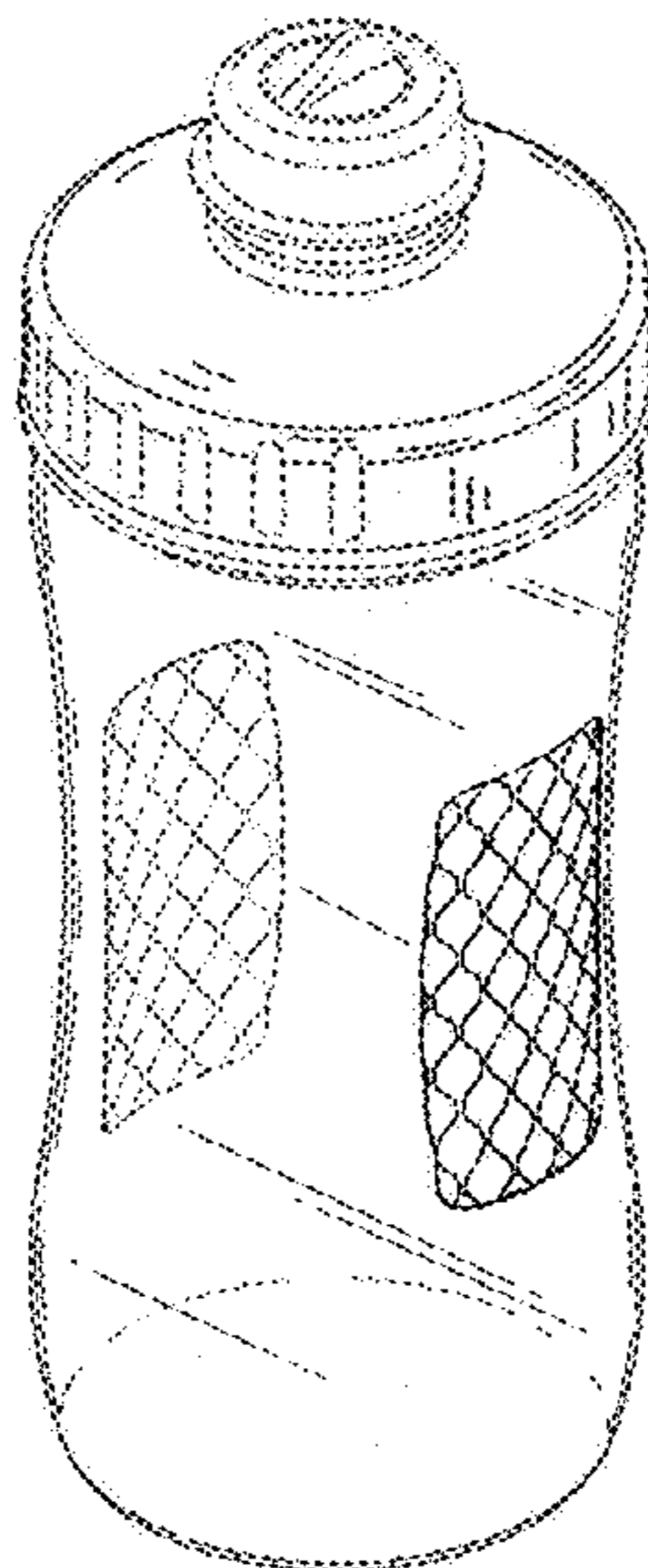
The ornamental design for a mixer bottle for drinking liquids, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a mixer bottle for drinking liquids showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is an enlarged top view thereof; FIG. 7 is an enlarged bottom plan view thereof; and, FIG. 8 is a rear elevational view thereof with a tether attached.

The broken lines in the figures depict portions of the mixer bottle for drinking liquids that form no part of the claimed design.

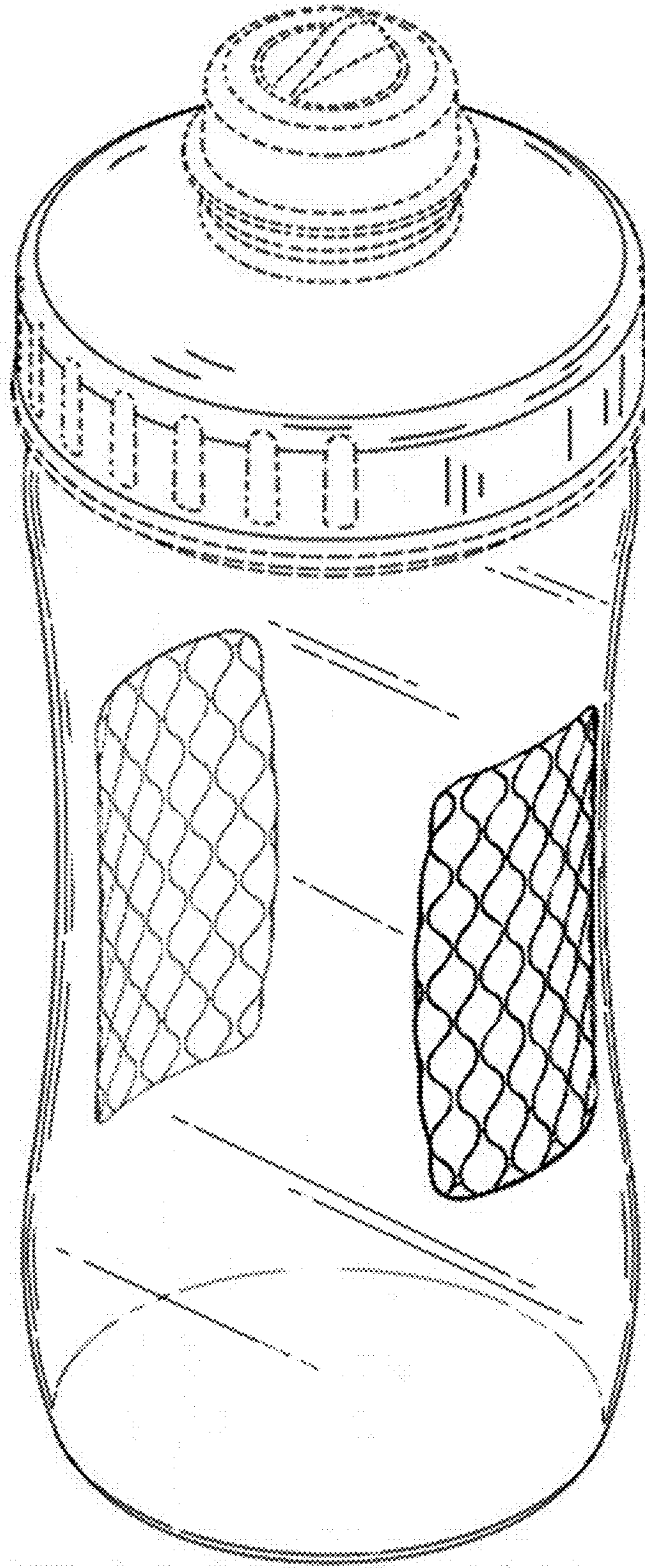

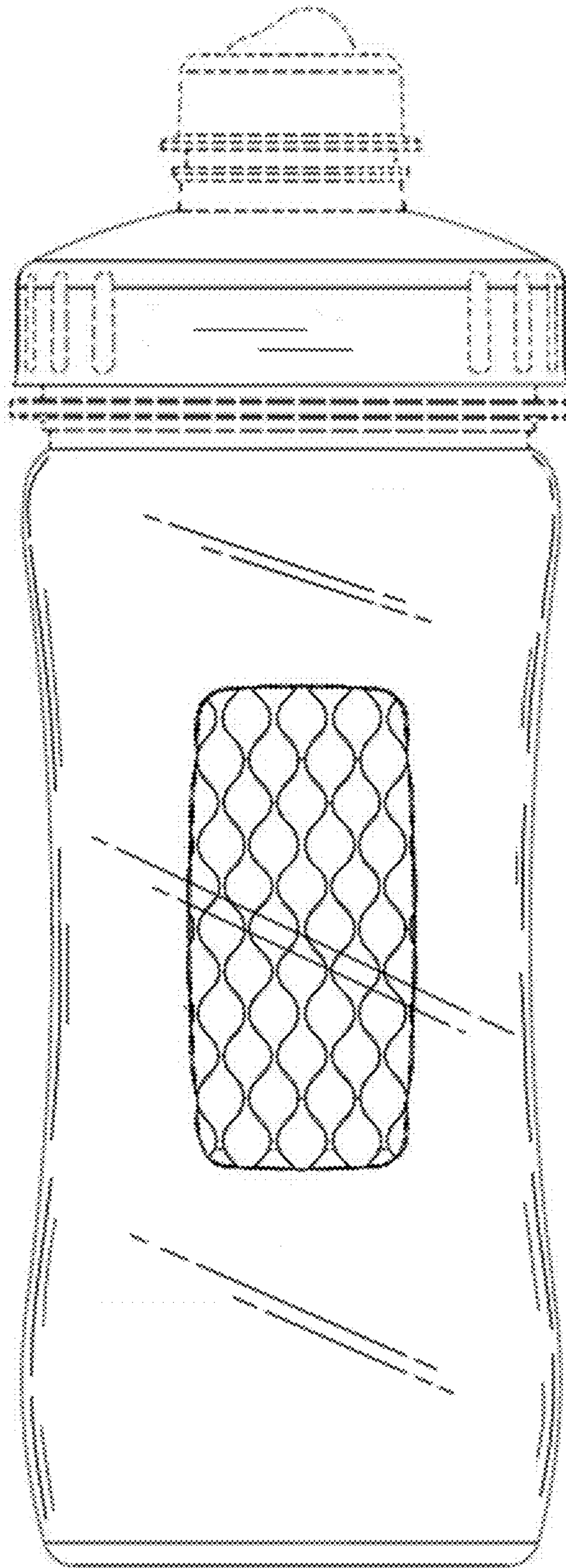

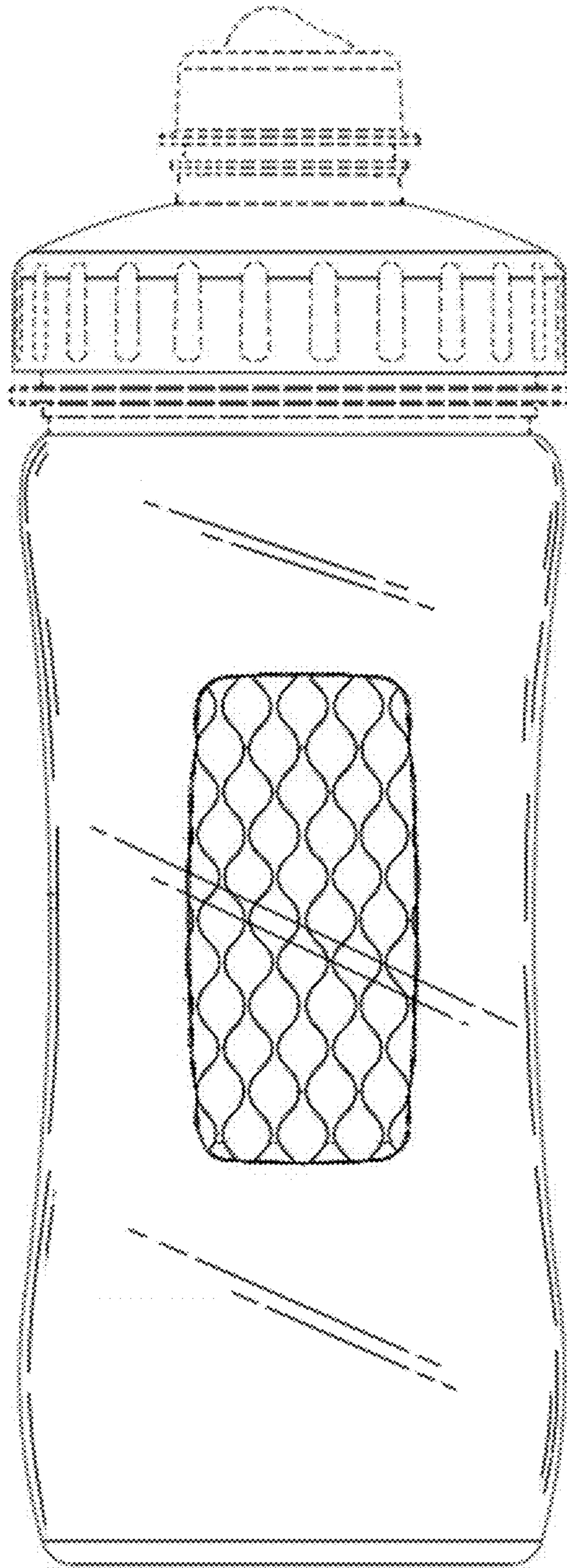

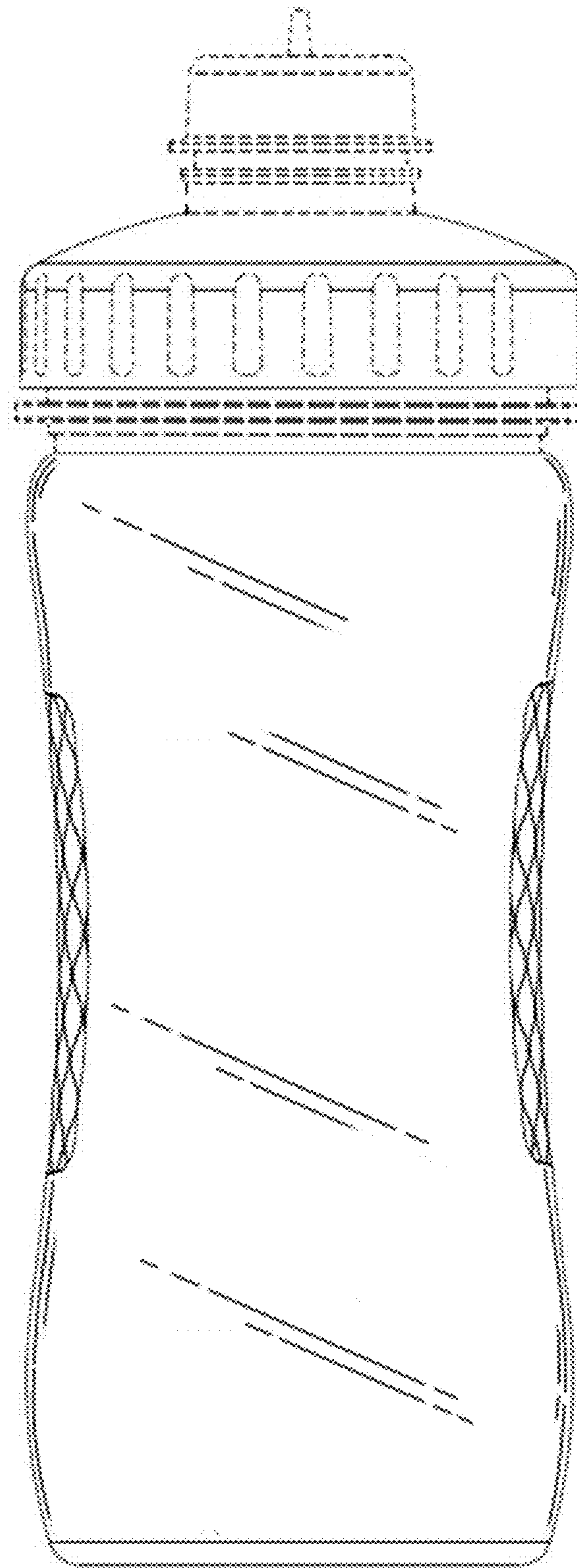

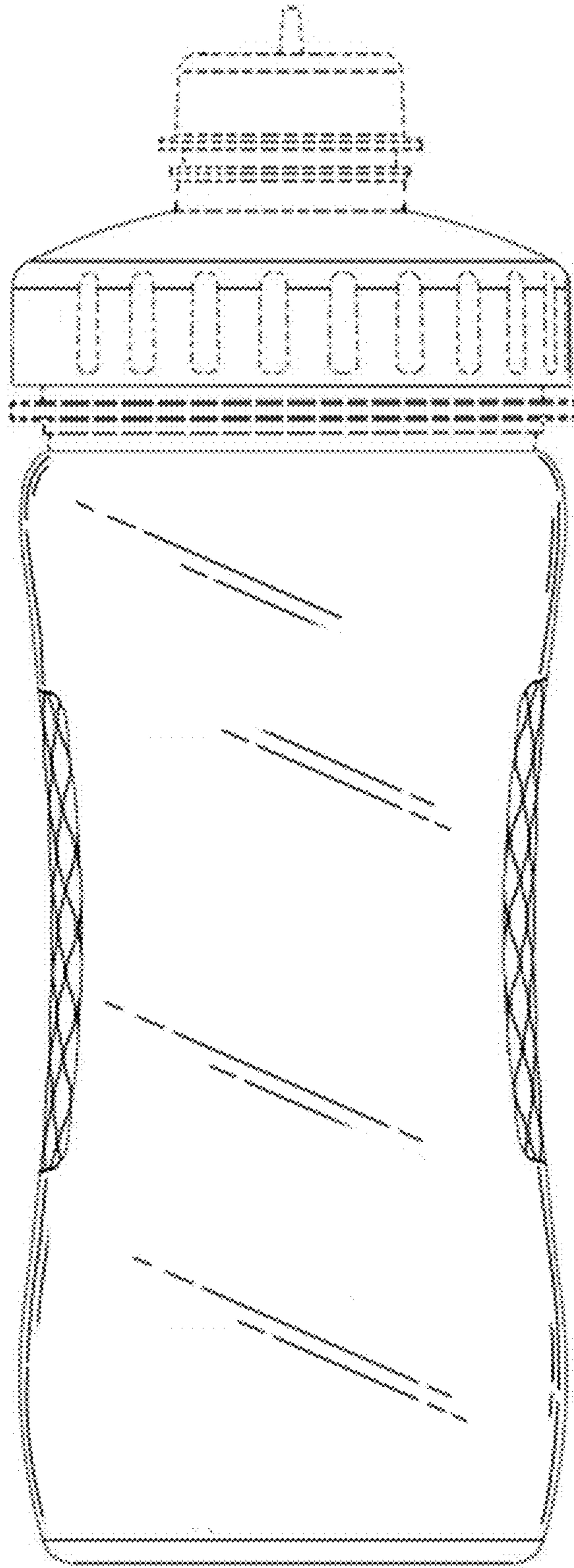

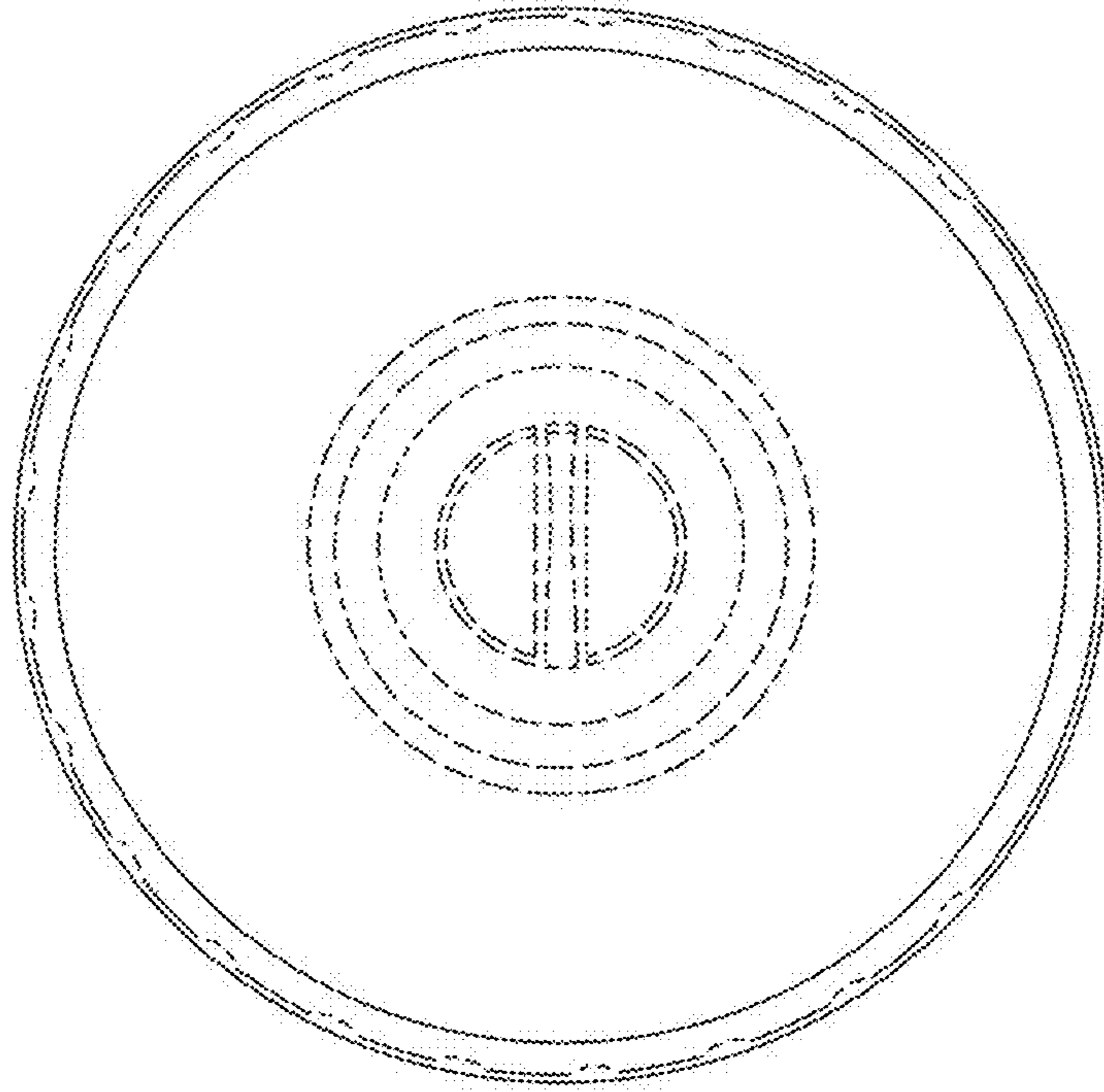

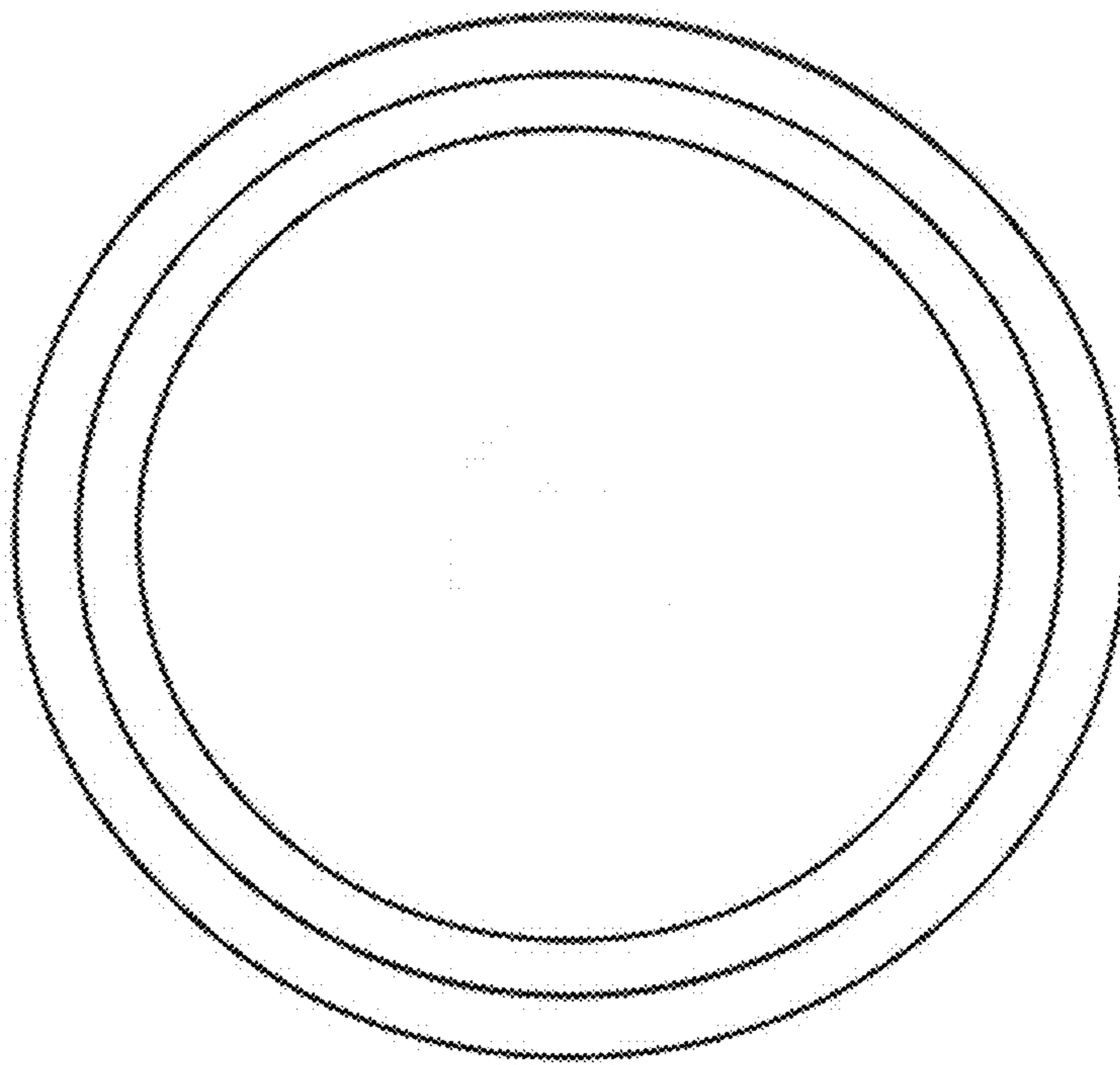

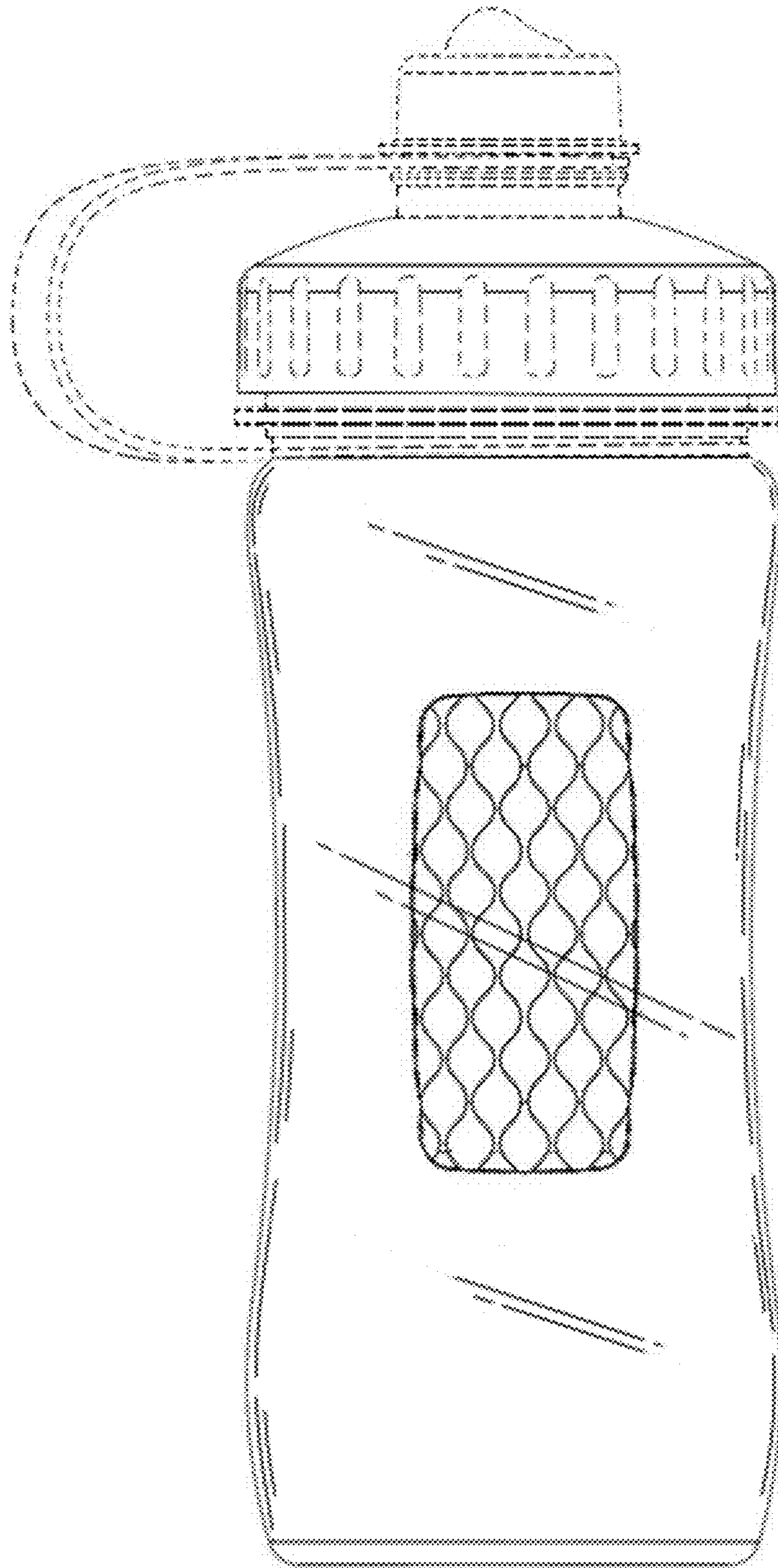
