(57) **CLAIM**

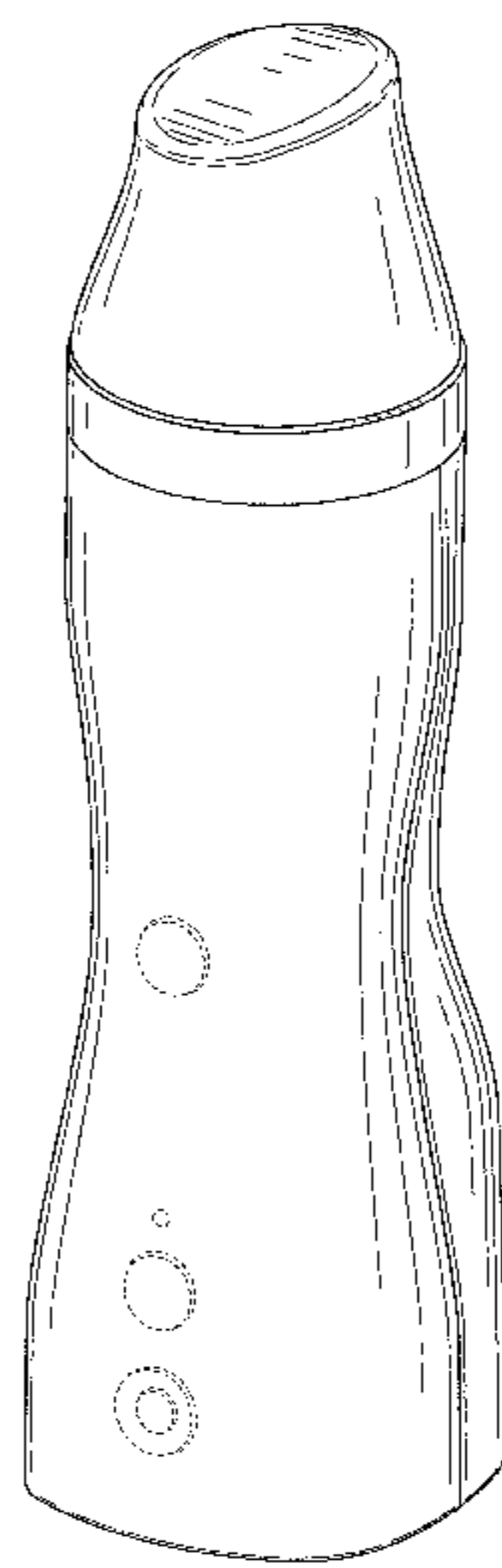
The ornamental design for a butter container, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a butter container, showing my new design;  
FIG. 2 is a front elevation view thereof.  
FIG. 3 is a rear elevation view thereof.  
FIG. 4 is a right side elevation view thereof.  
FIG. 5 is a left side elevation view thereof.  
FIG. 6 is a top plan view thereof; and,

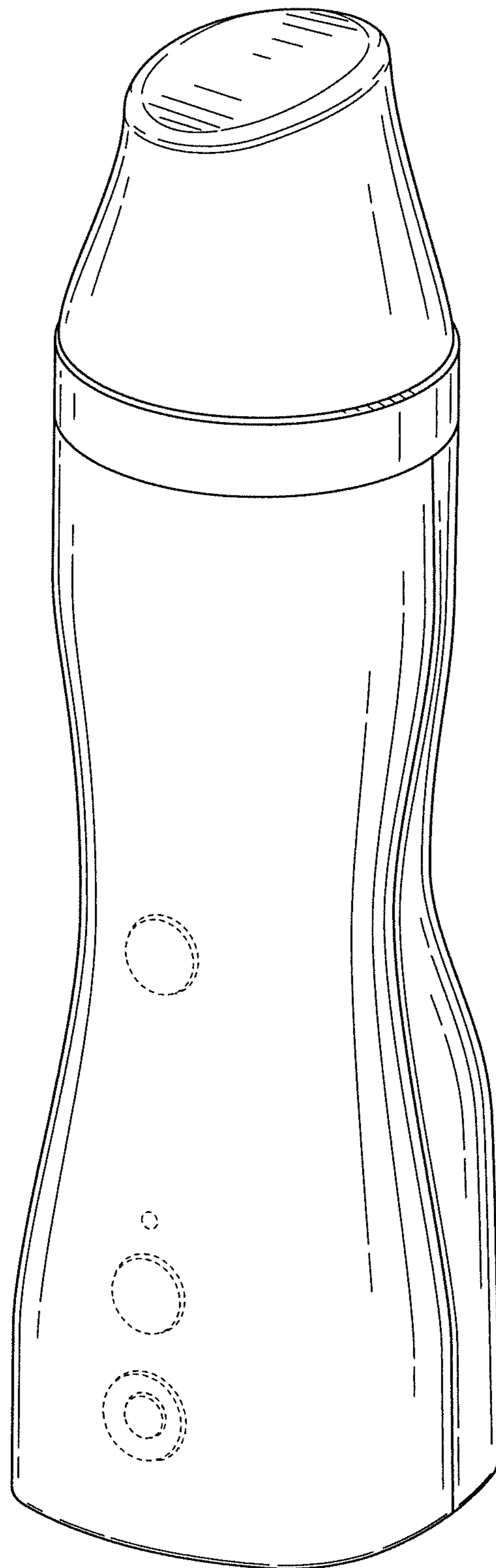

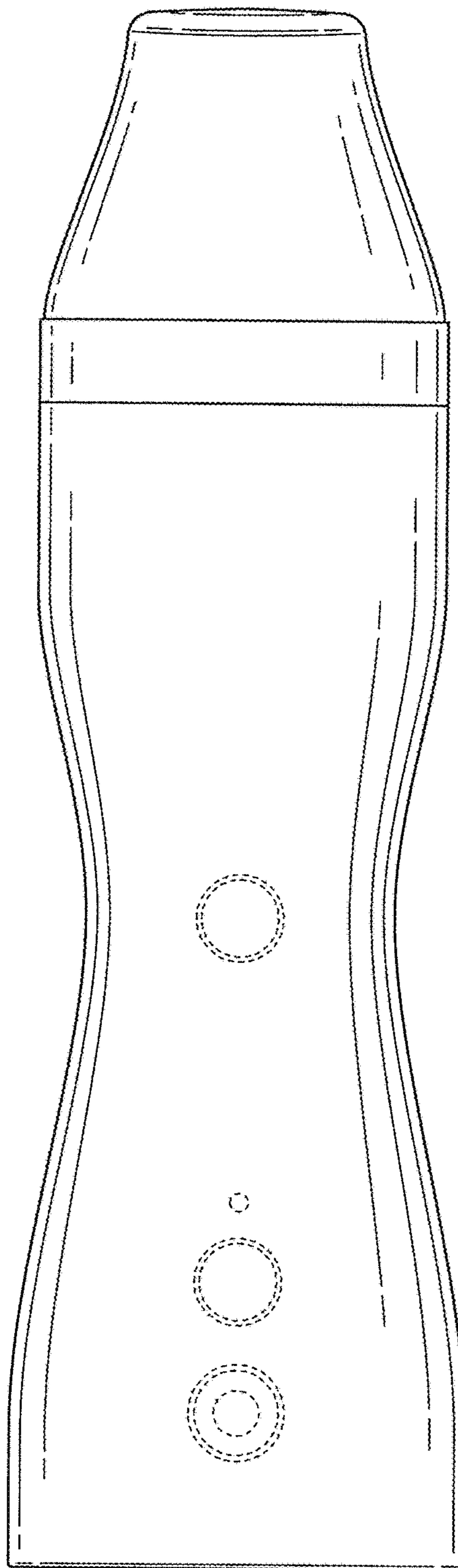

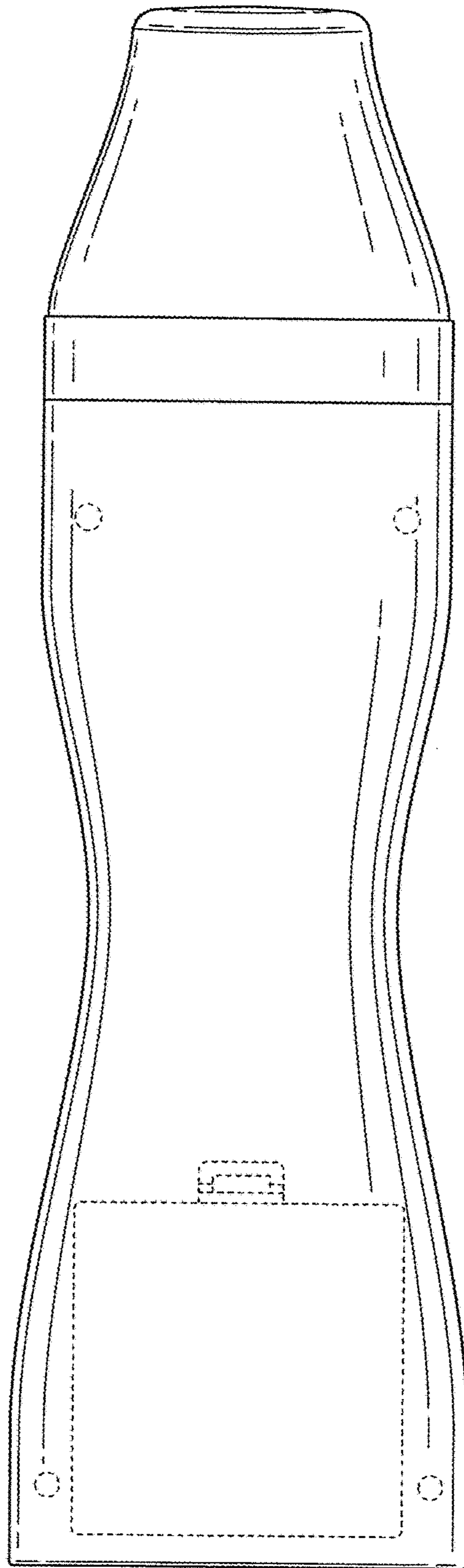

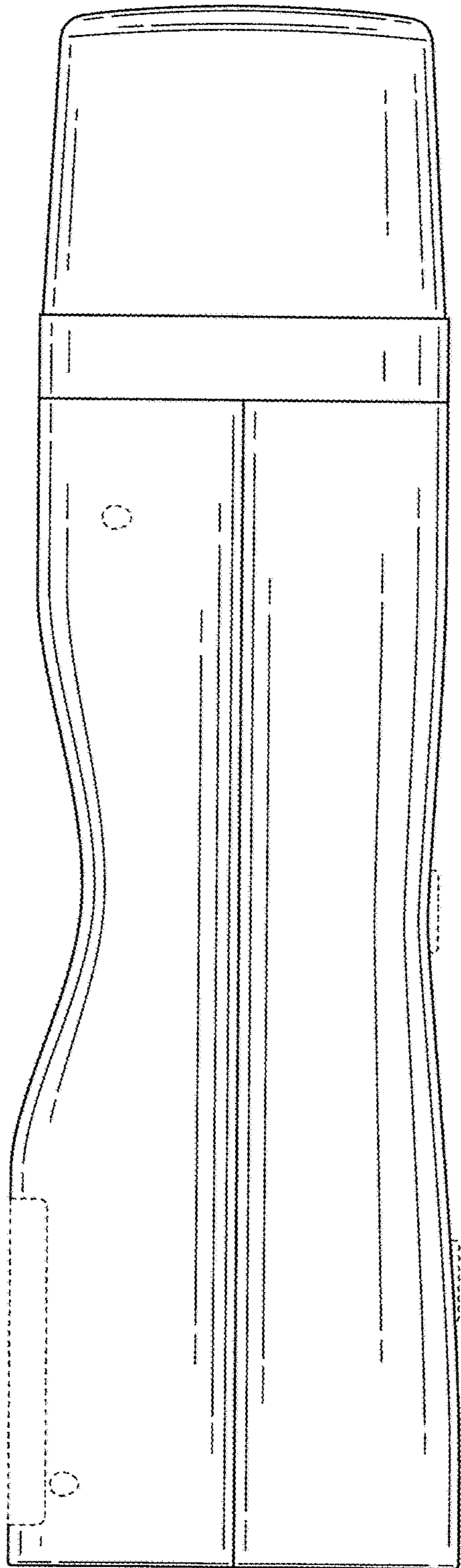
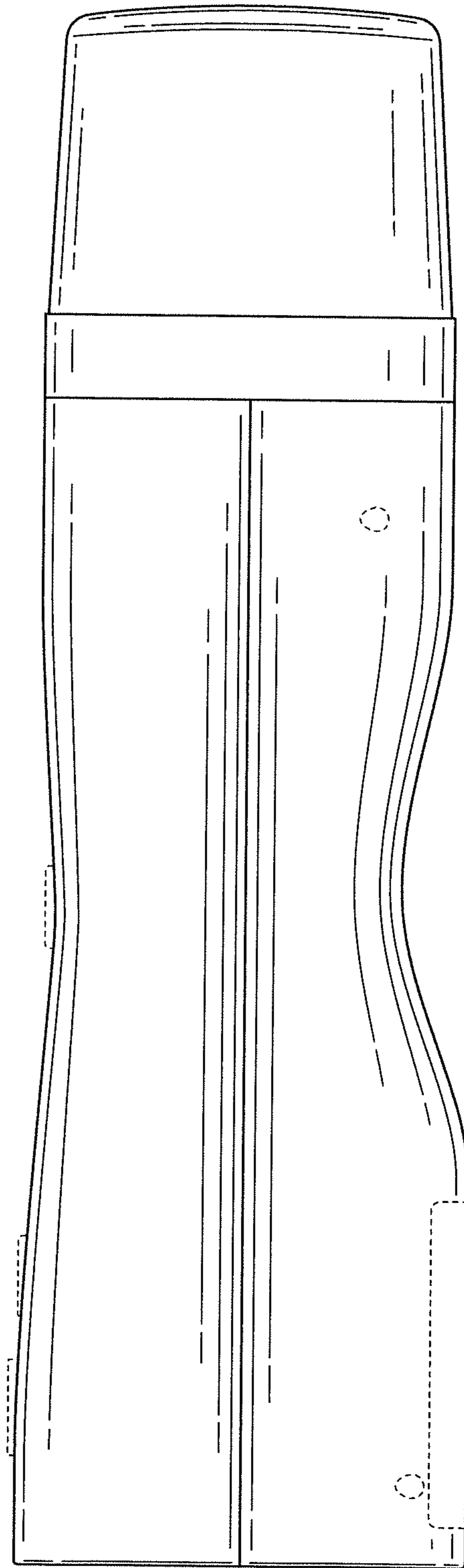

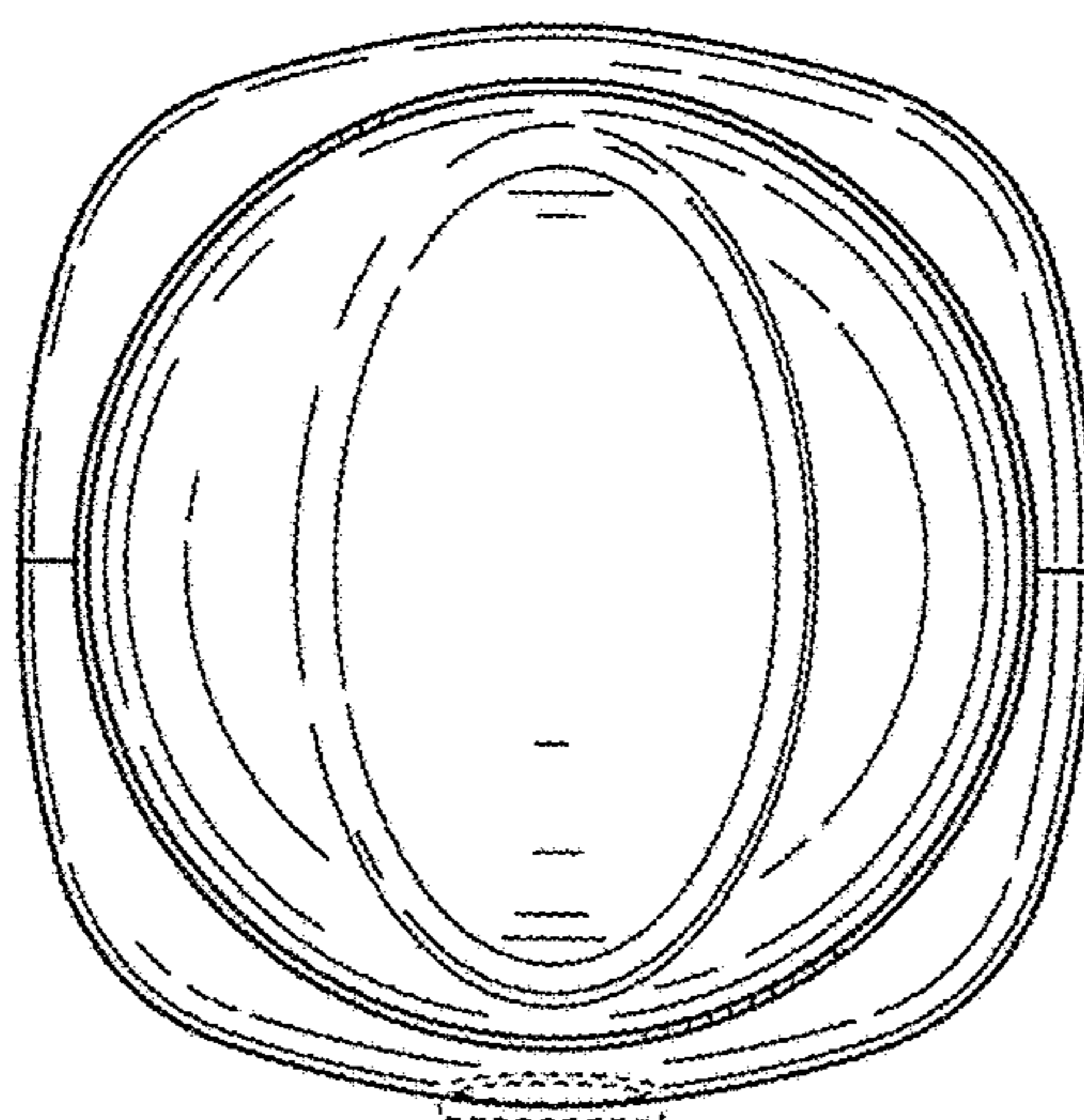

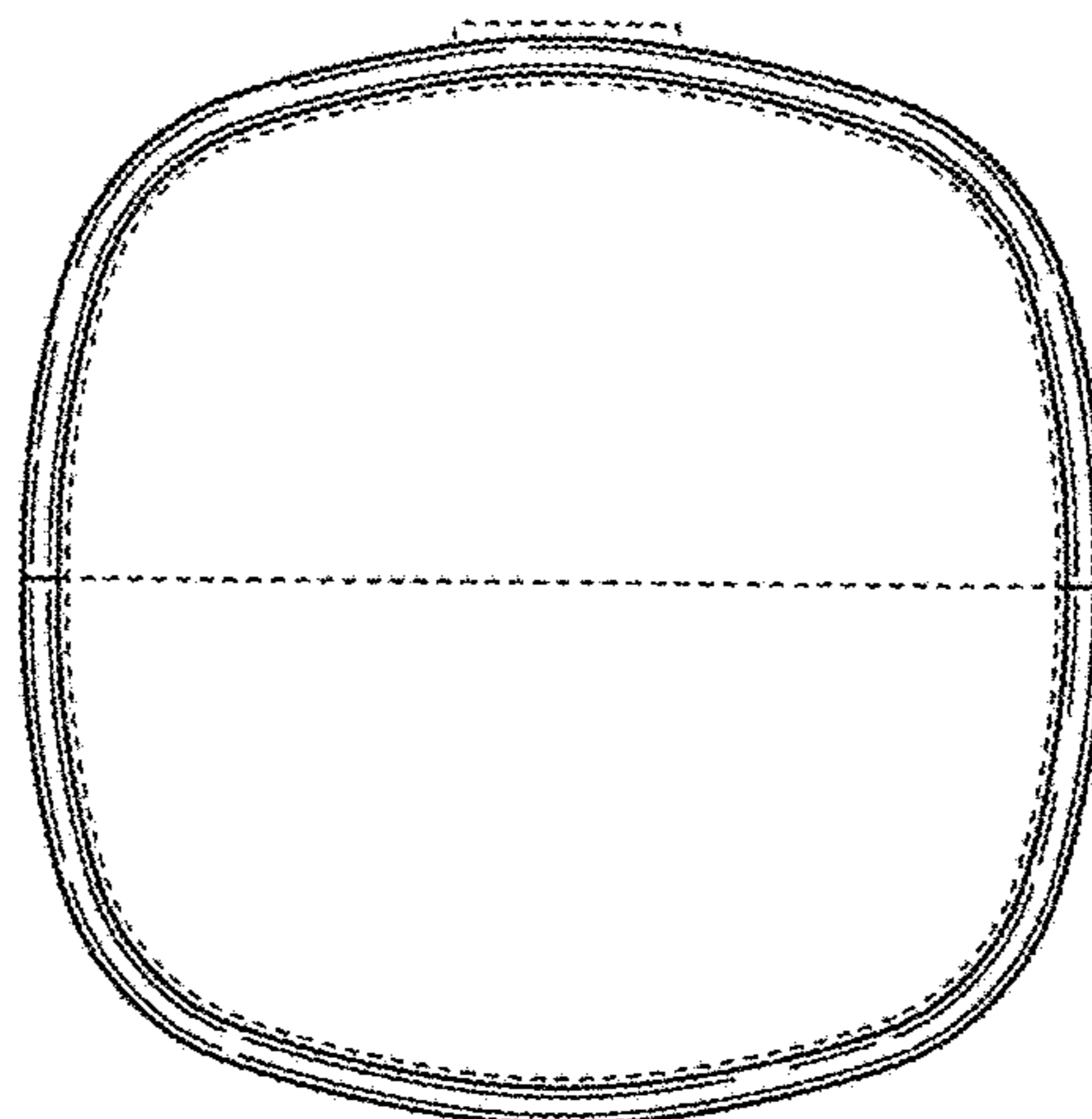
