DESCRIPTION

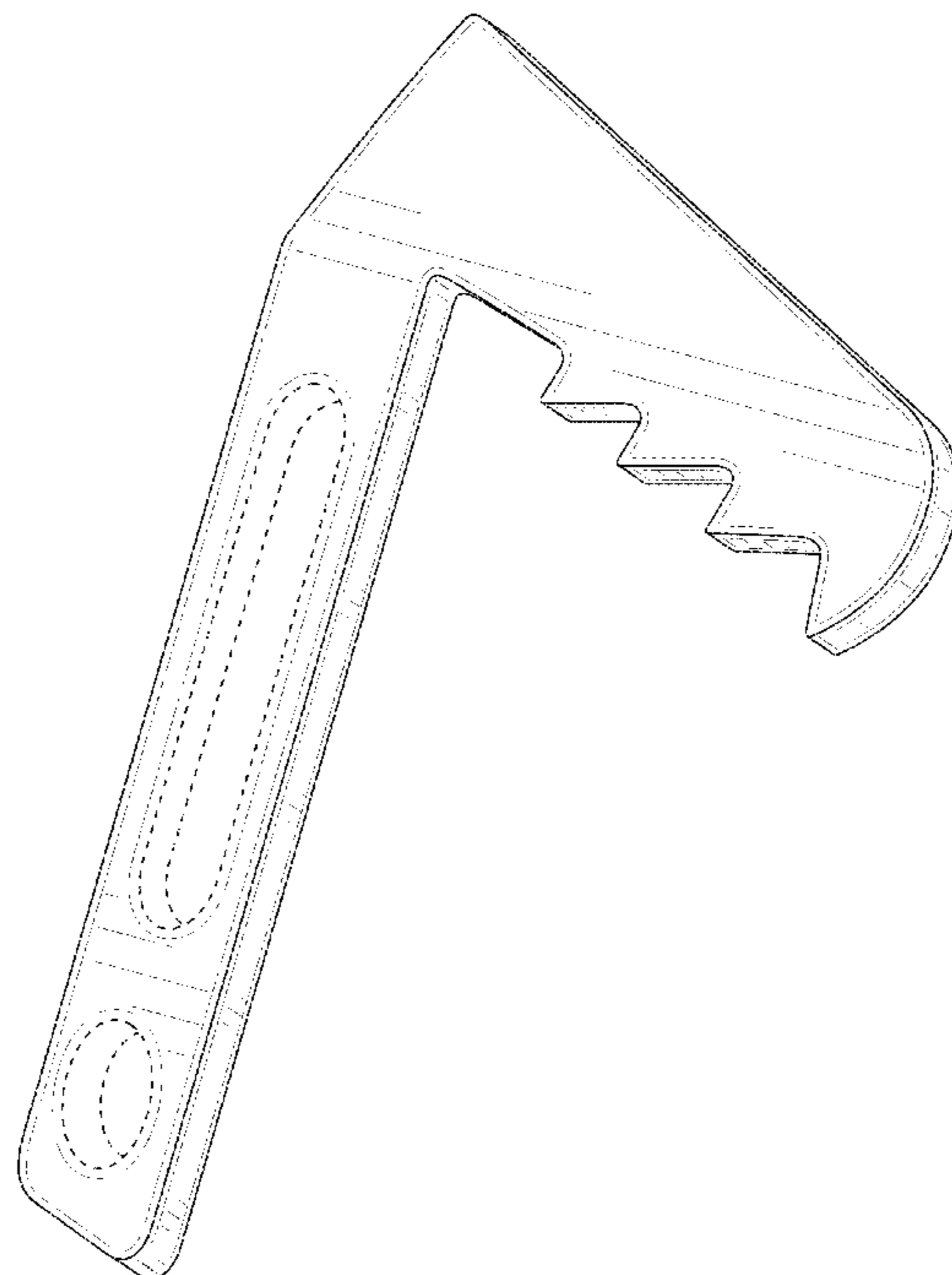

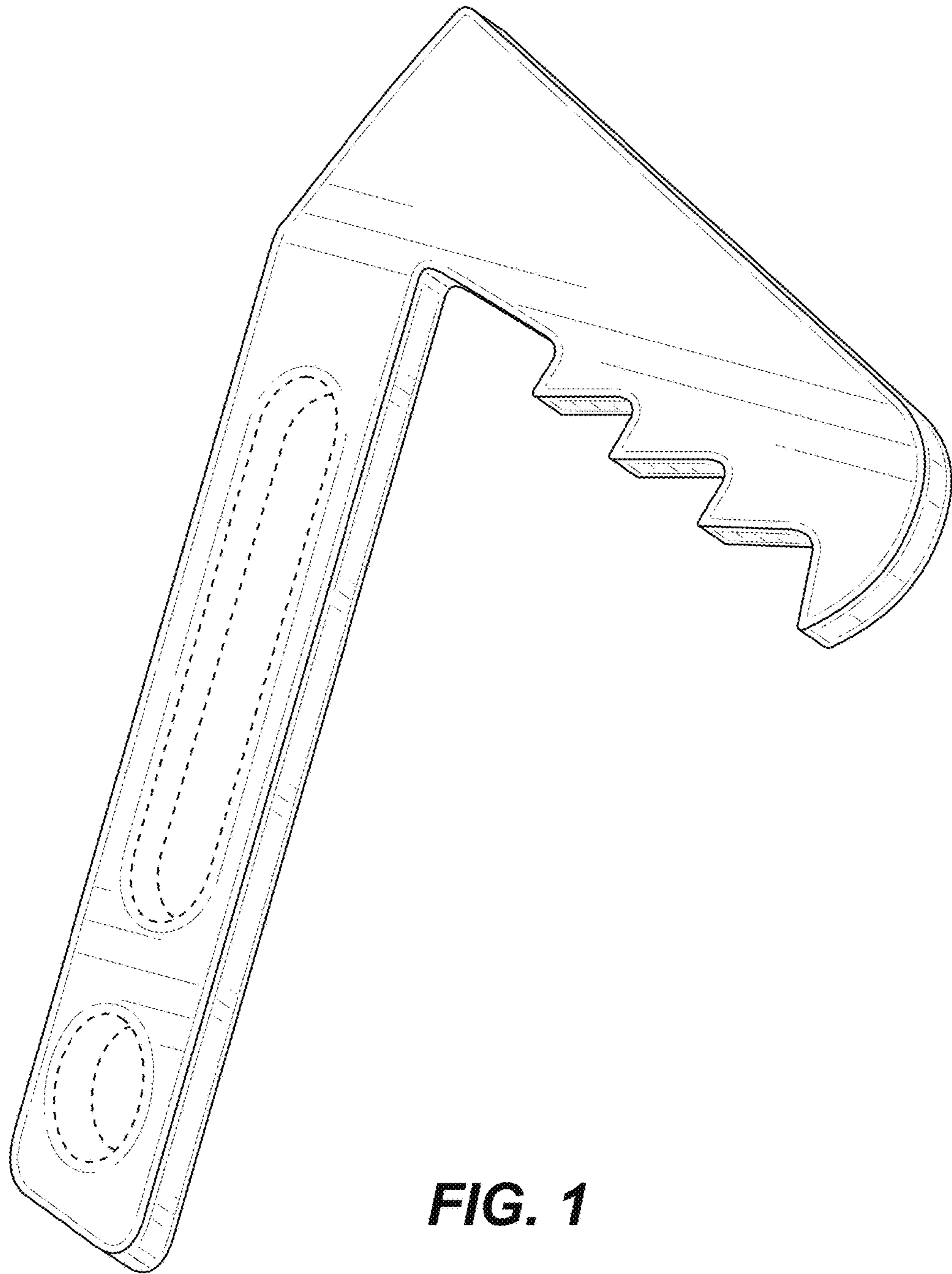

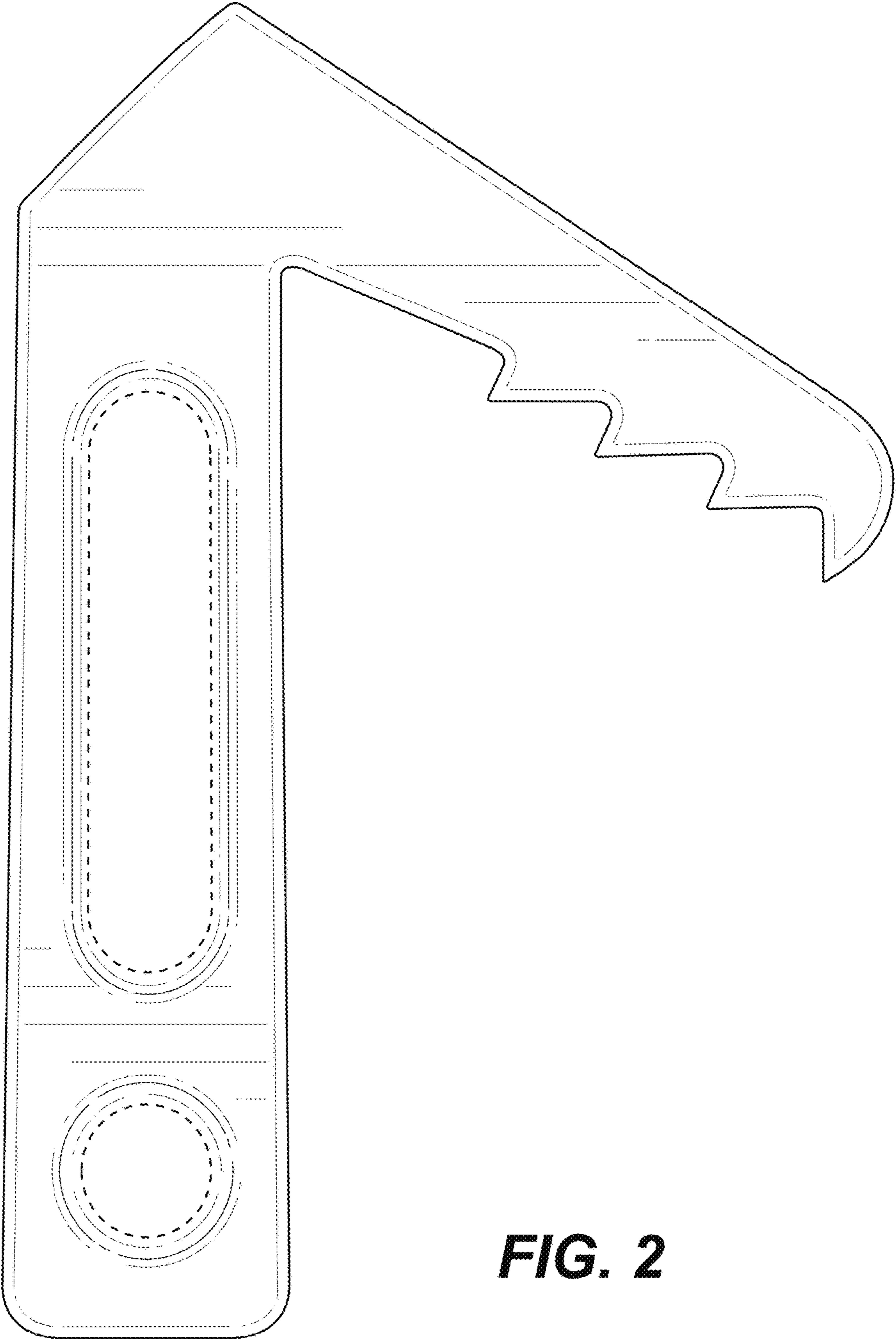

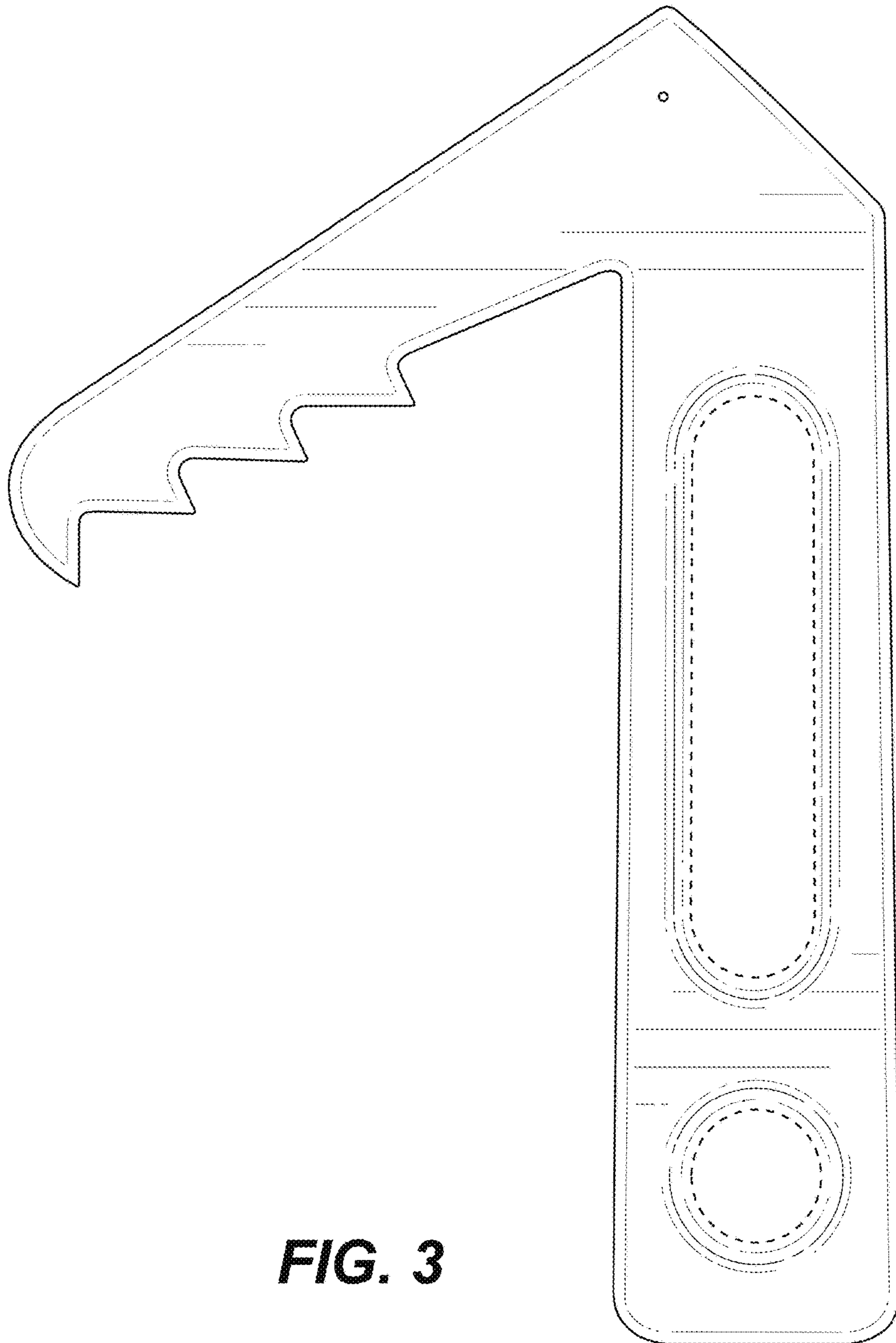

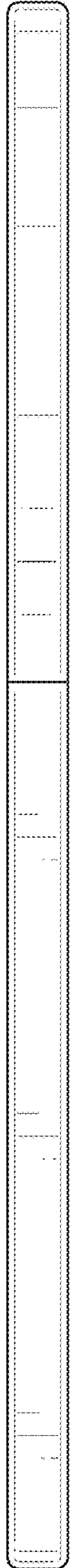

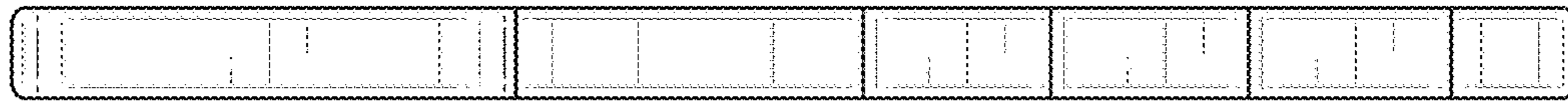
